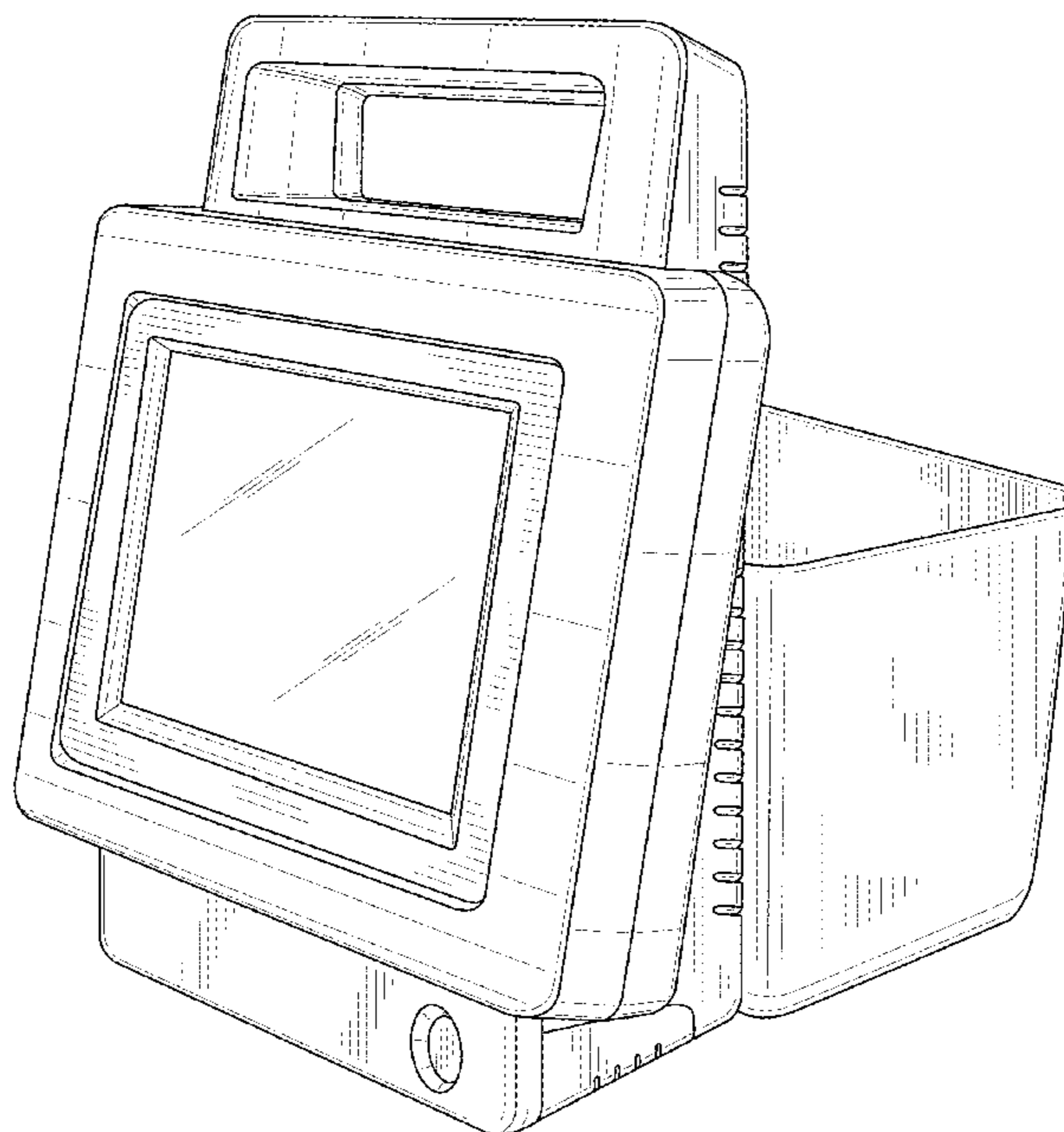
(57) **CLAIM**

The ornamental design for a body mass index meter with detachable bin, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front left perspective view of a body mass index meter with detachable bin, showing the new design;
FIG. 2 is a front view thereof;
FIG. 3 is a back view thereof;
FIG. 4 is a right side view thereof;

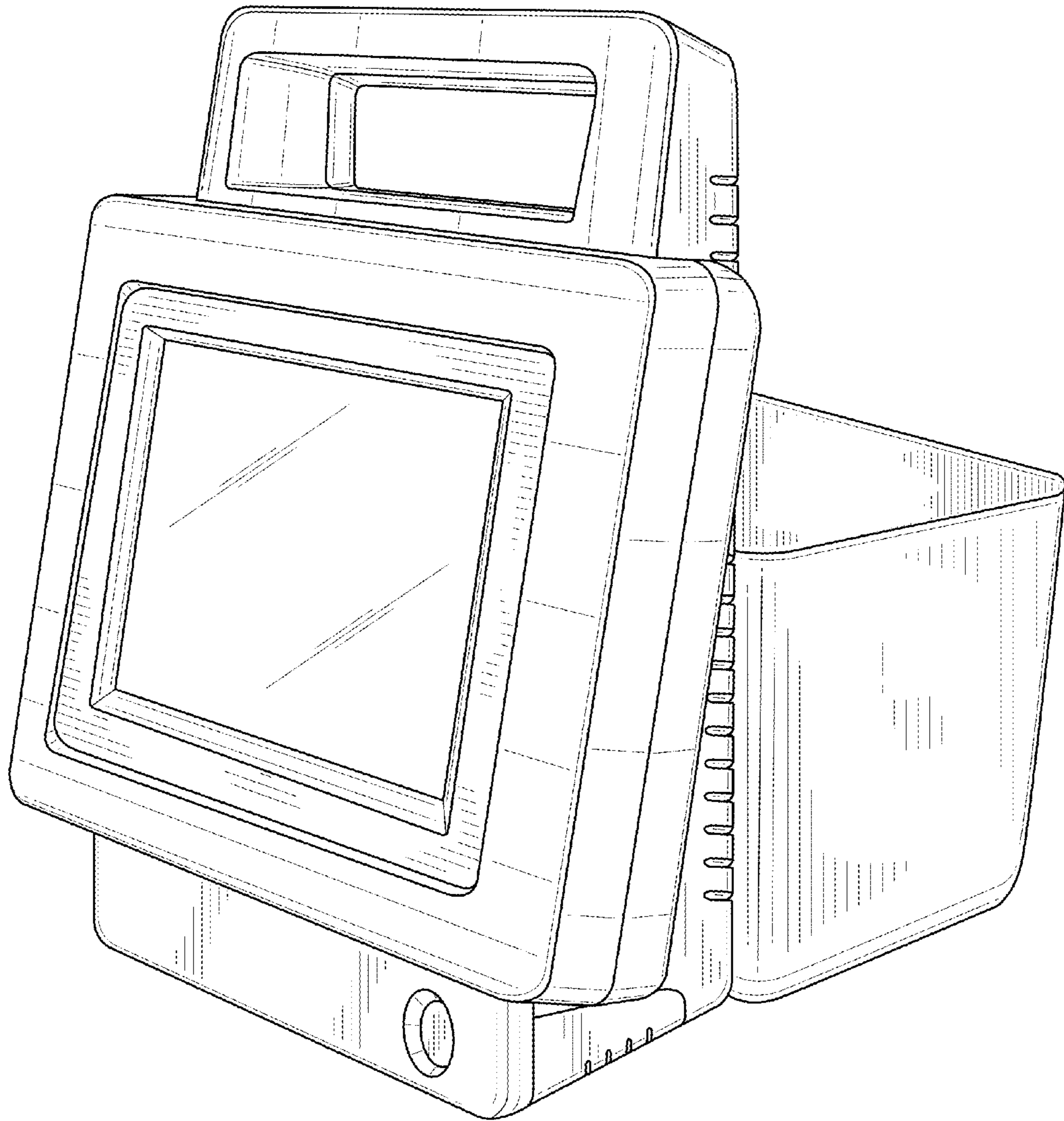

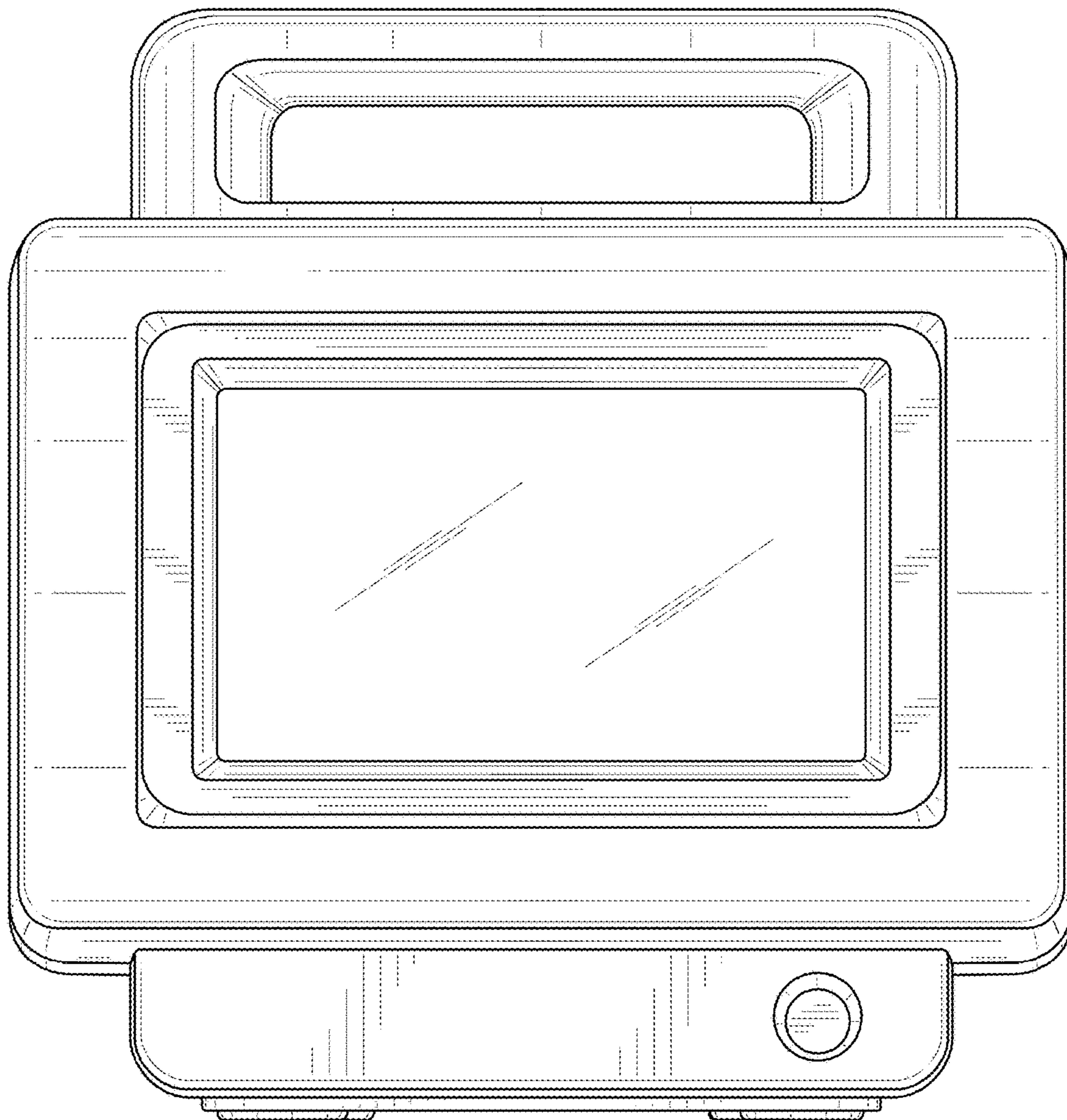

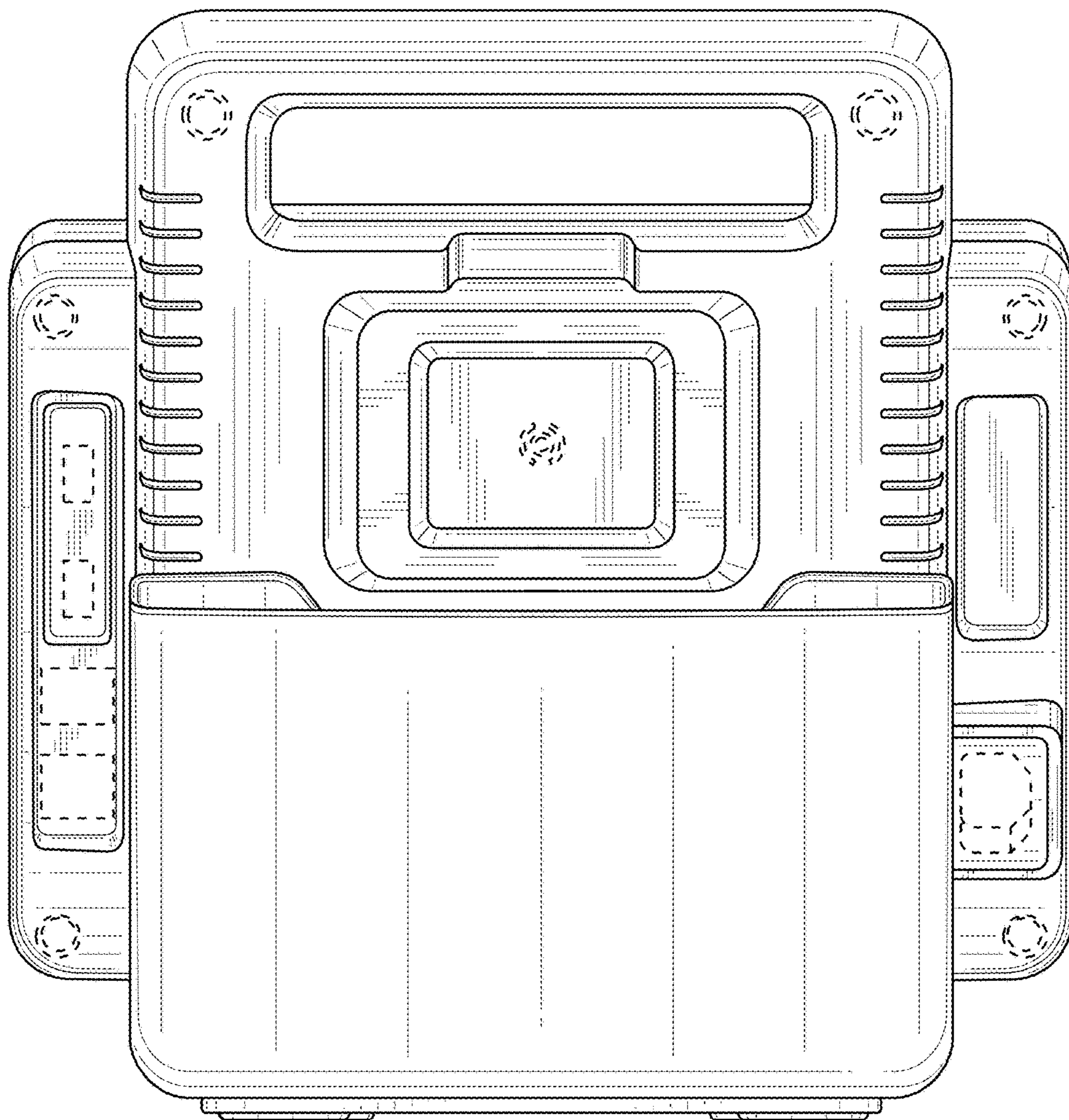

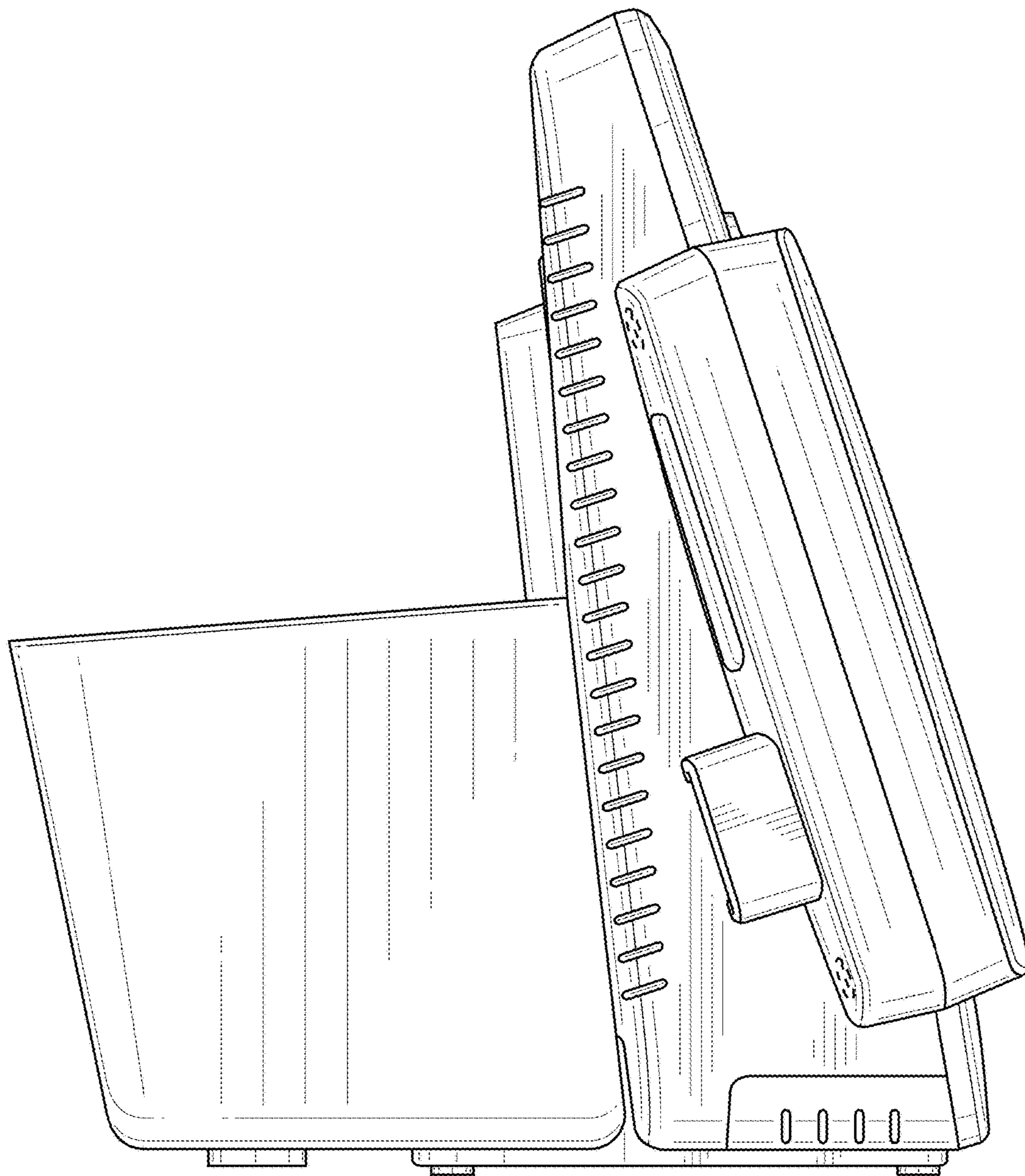

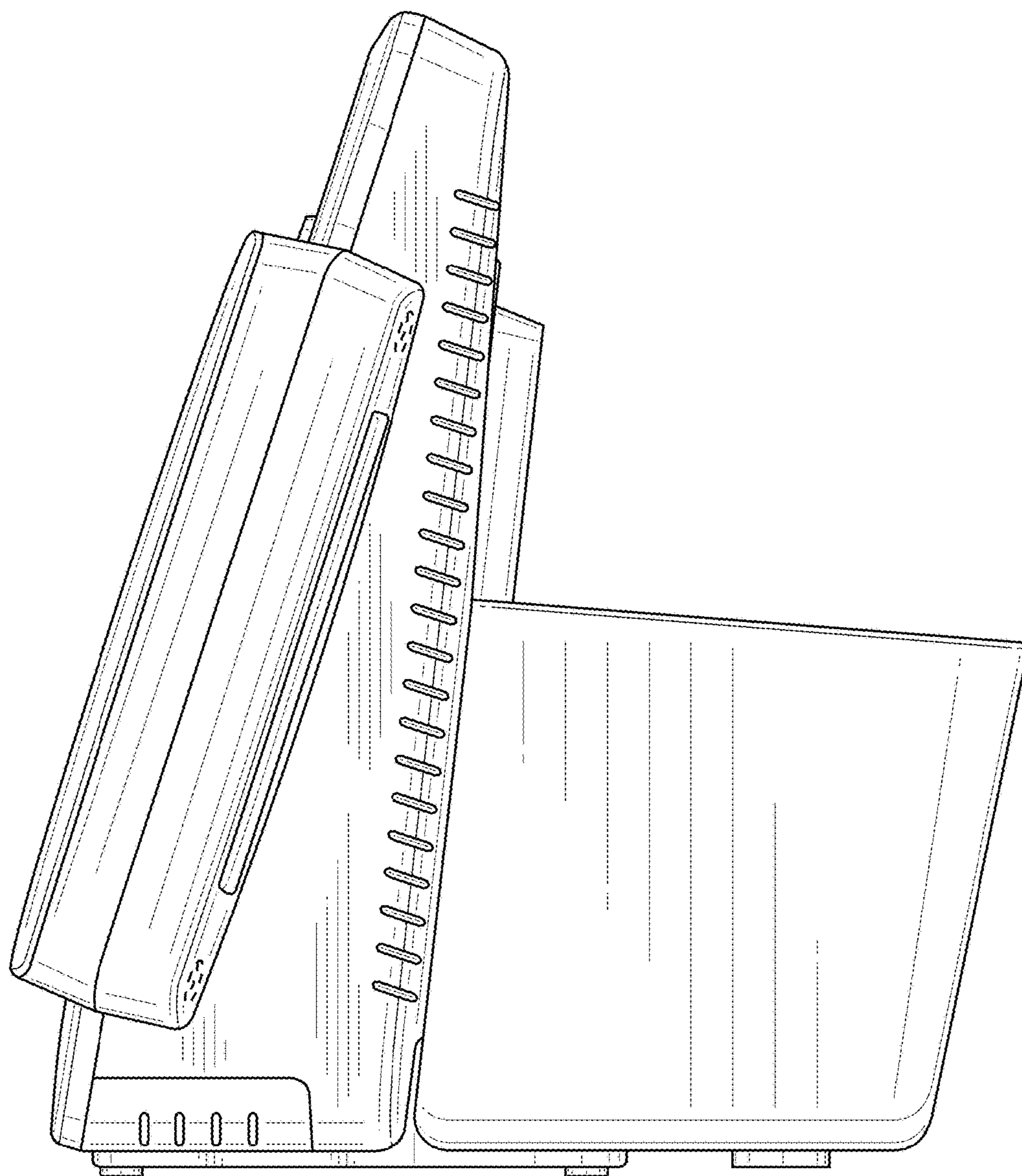

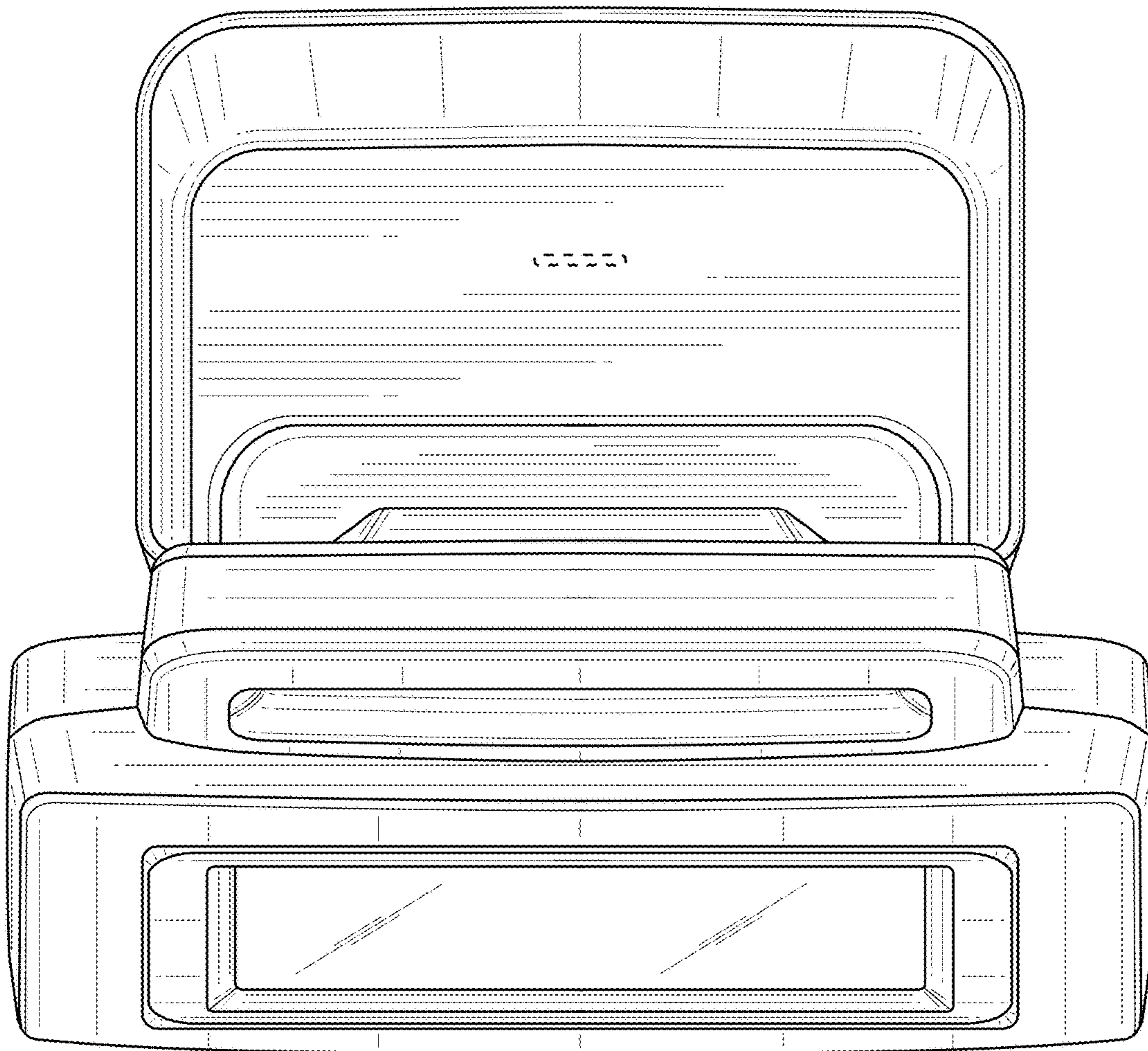

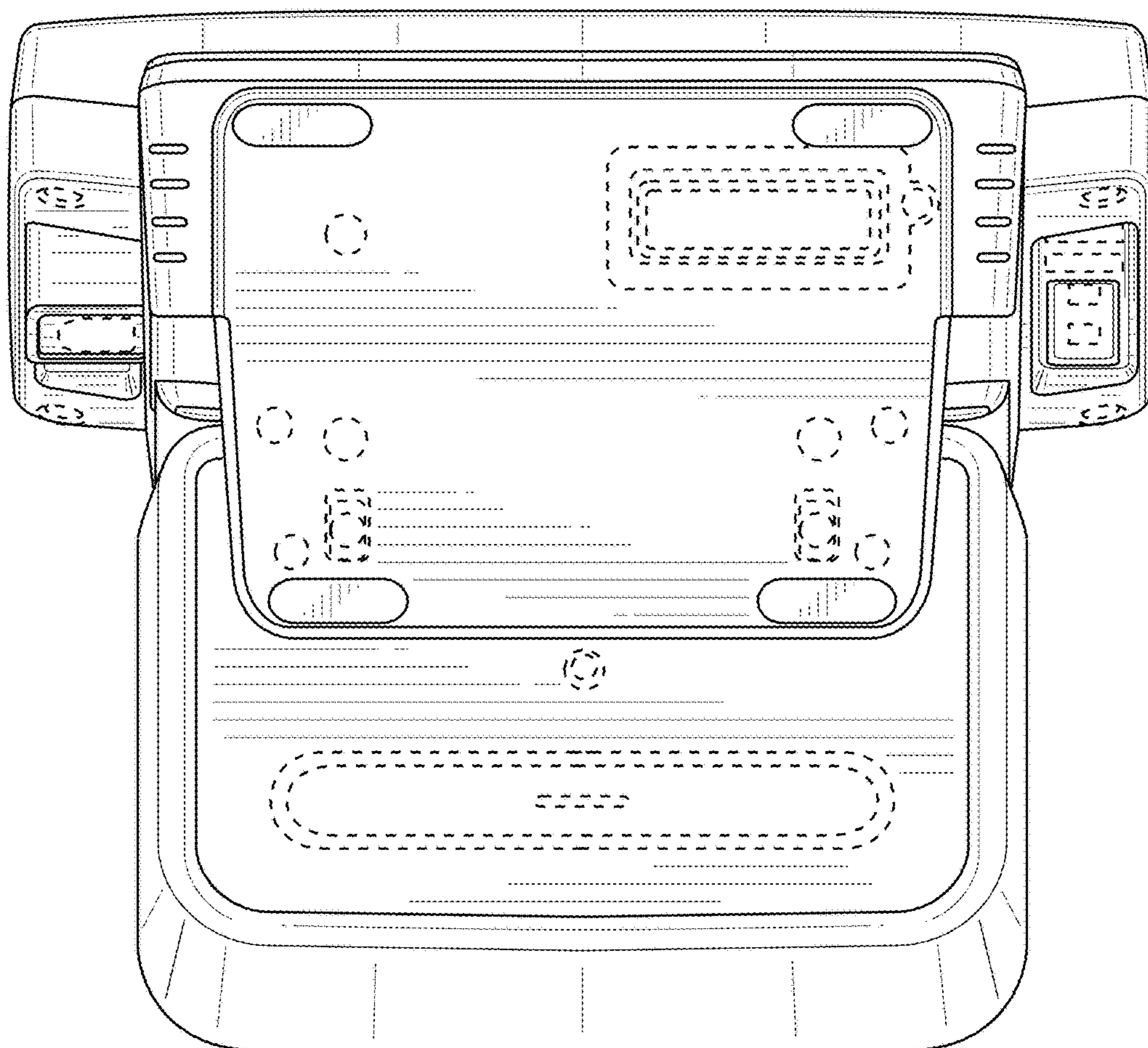

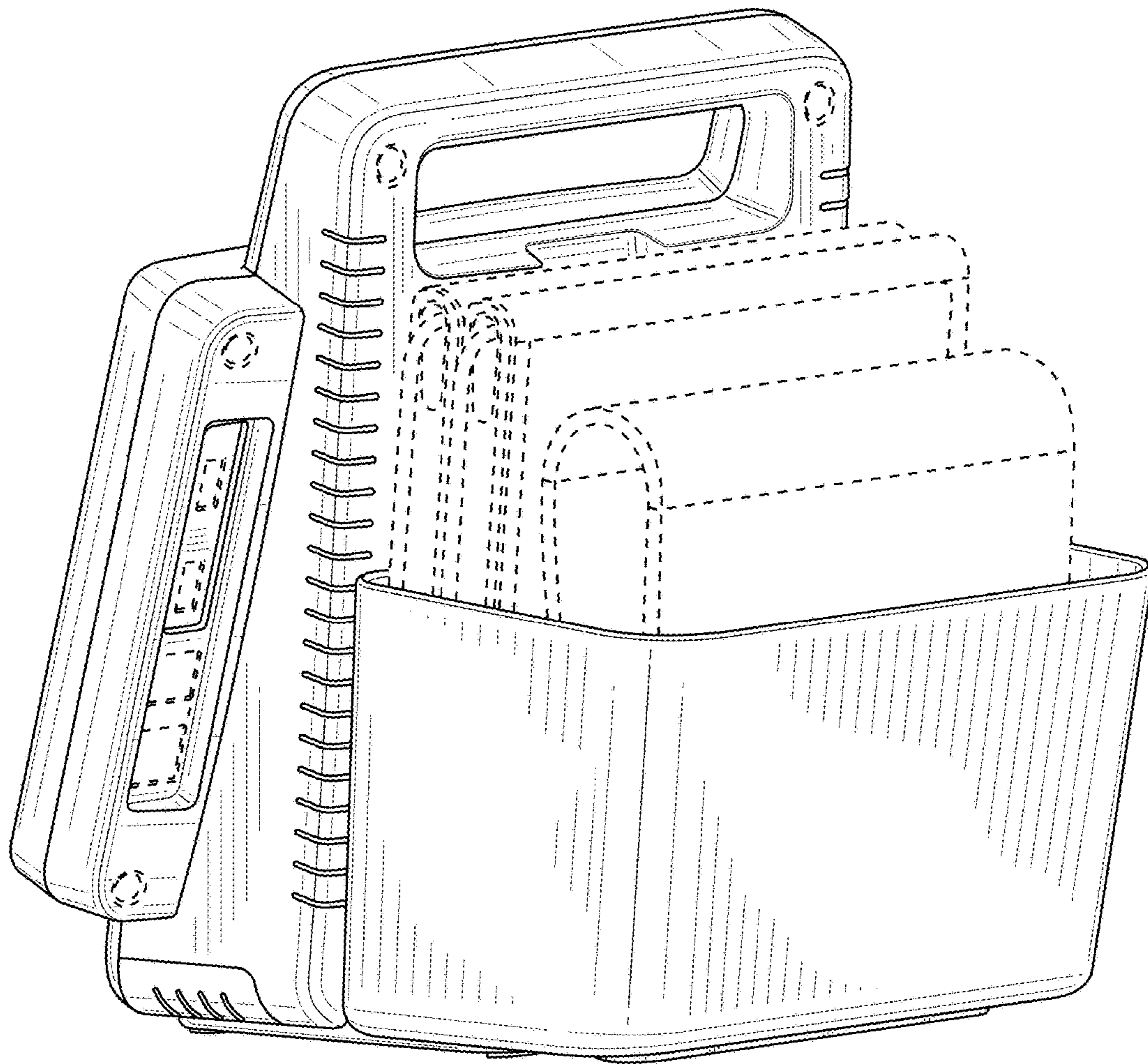

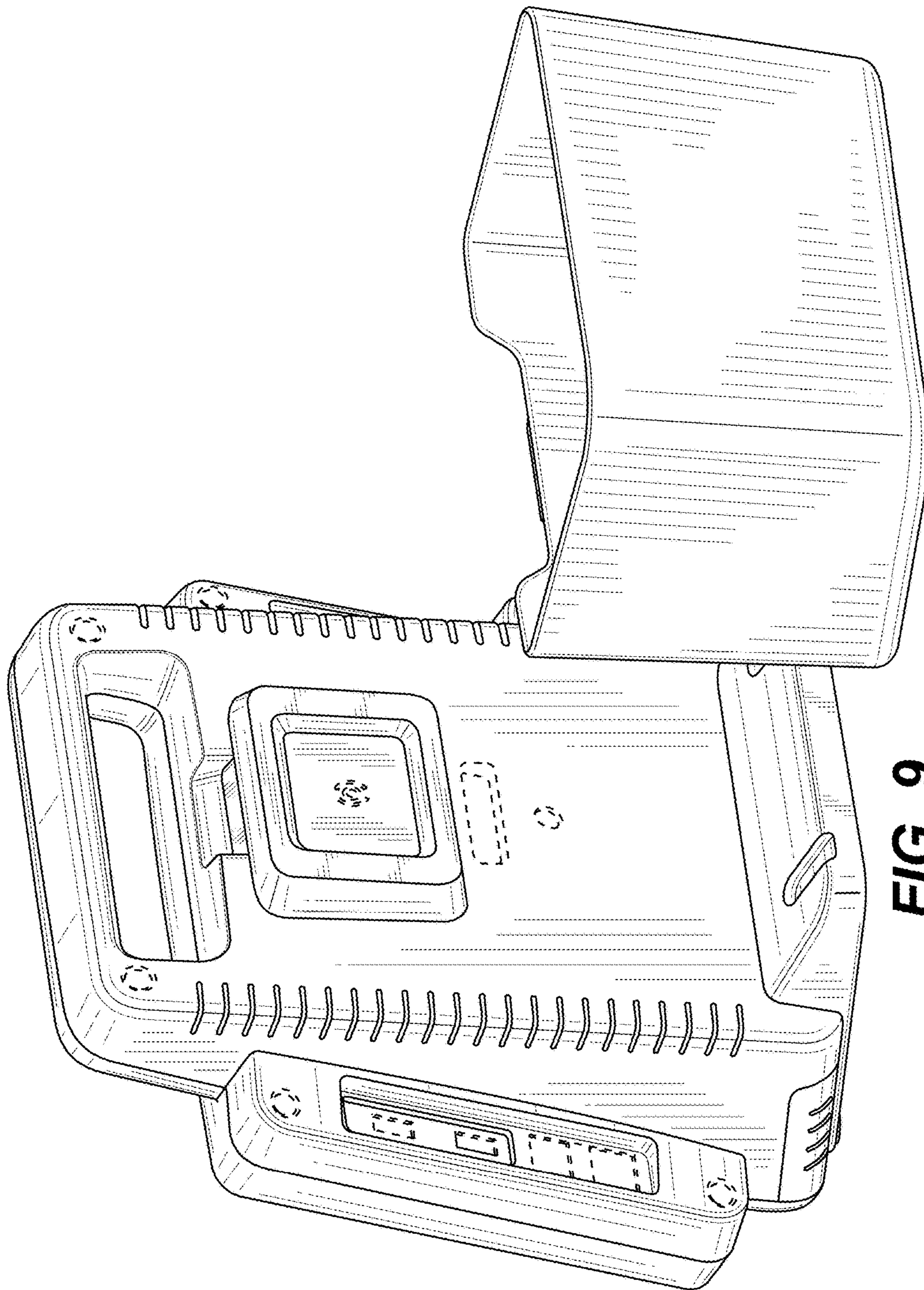
