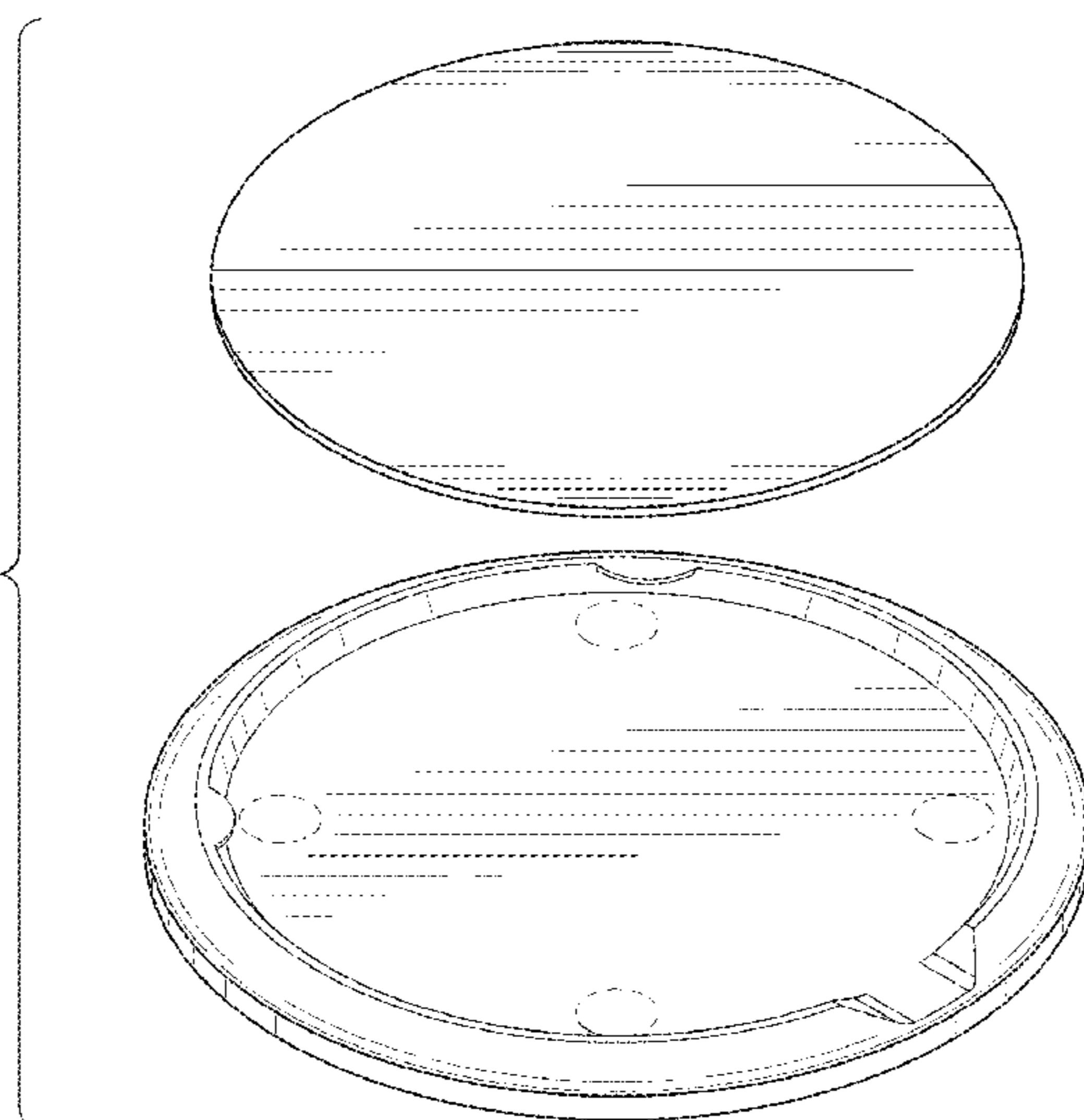
(57) **CLAIM**

The ornamental design for a fluid collection stand, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a fluid collection stand illustrating my new design in a first configuration without the disc element portion;
FIG. 2 is a bottom perspective view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a first quarter side elevation view thereof;
FIG. 6 is a second quarter side elevation view thereof;
FIG. 7 is a third quarter side elevation view thereof;
FIG. 8 is a fourth quarter side elevation view thereof;
FIG. 9 is an exploded top perspective view showing the manner of assembly of a second configuration of the fluid collection stand of FIG. 1 where a disc element portion is inserted into the top of the stand;
FIG. 10 is a top perspective view thereof;
FIG. 11 is a top plan view of the disc element portion; and,
FIG. 12 is a side elevation view thereof.
The broken lines in FIGS. 1, 3, and 9 depict portions of the fluid collection stand that form no part of the claimed design.

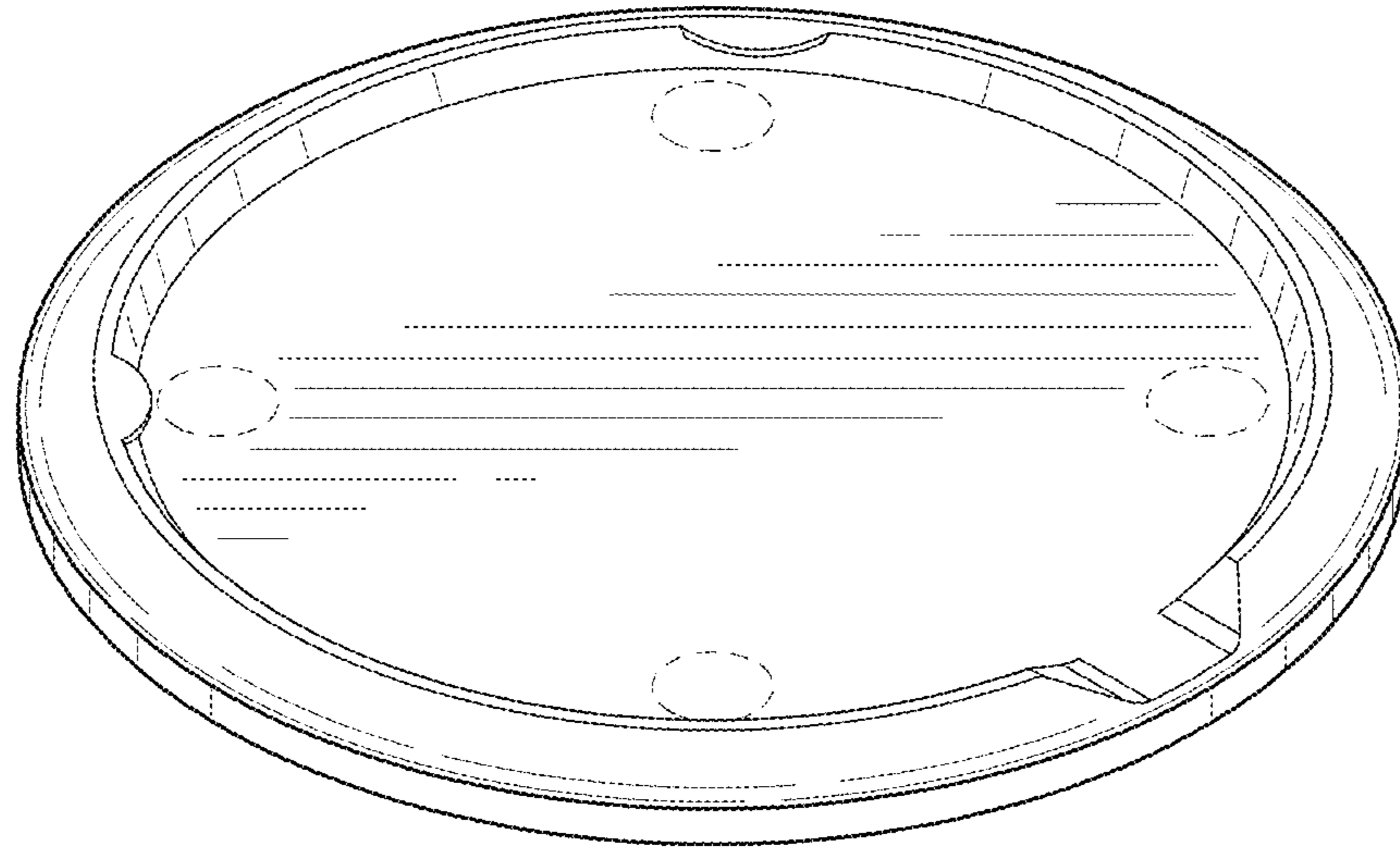

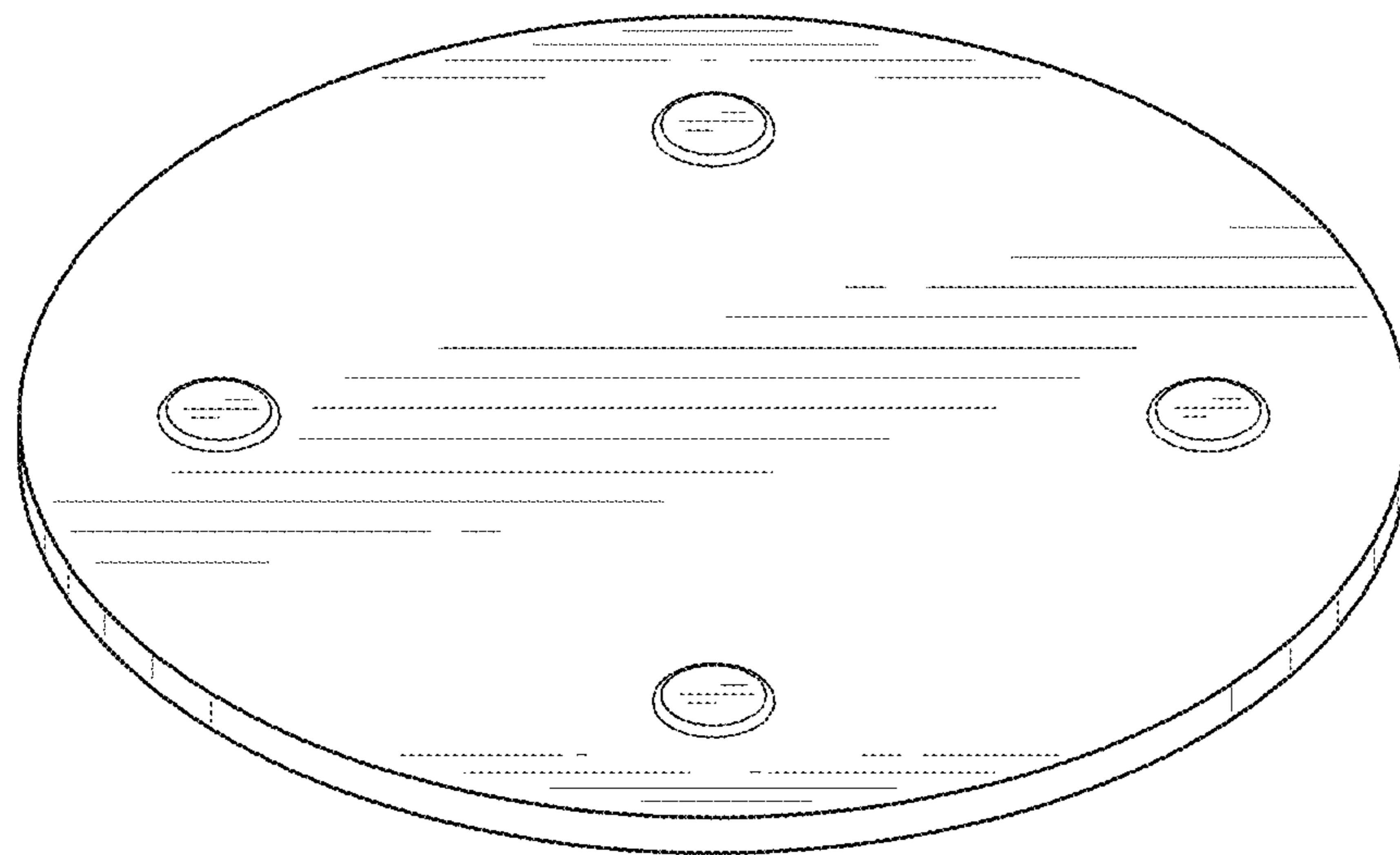

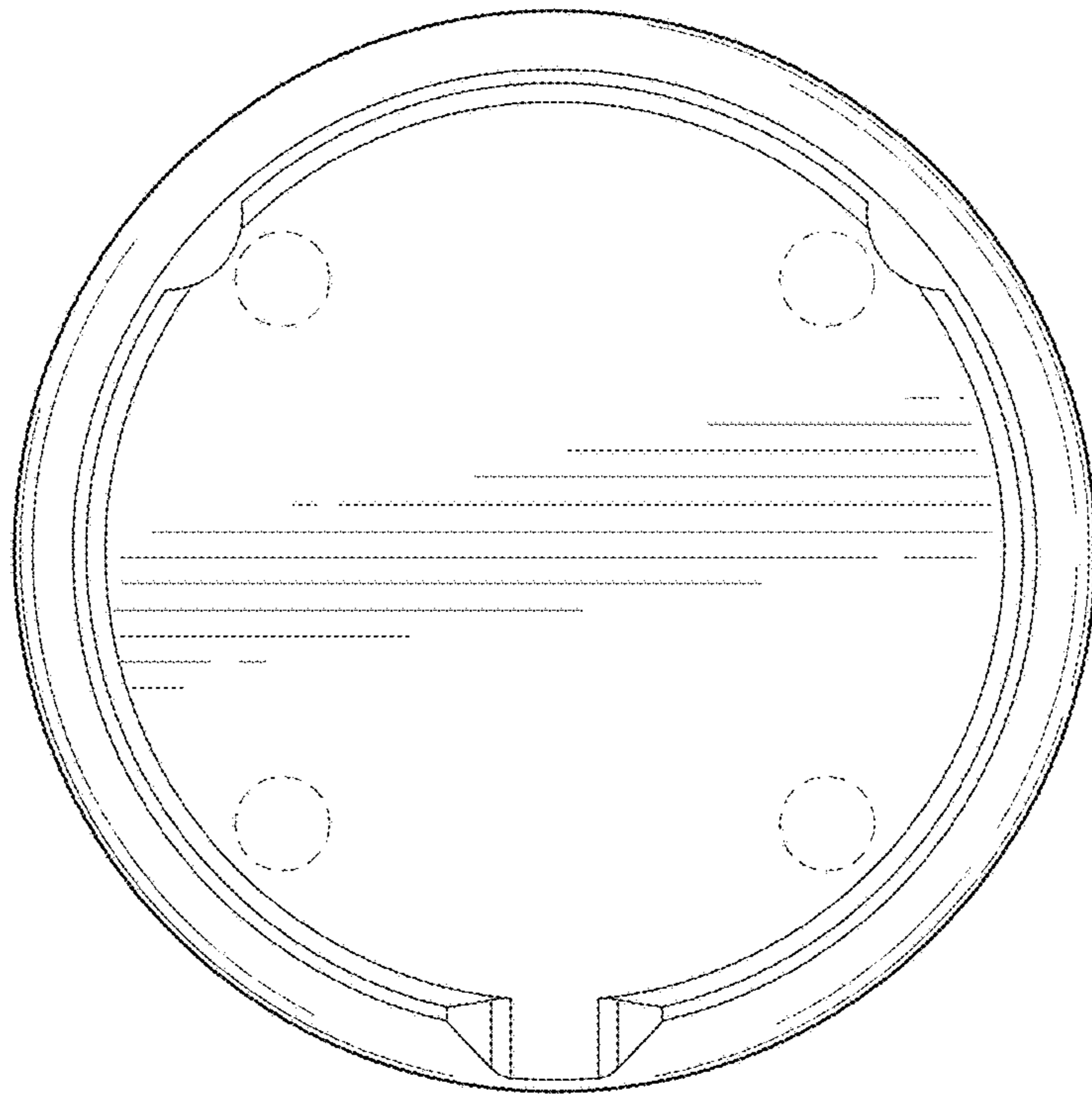

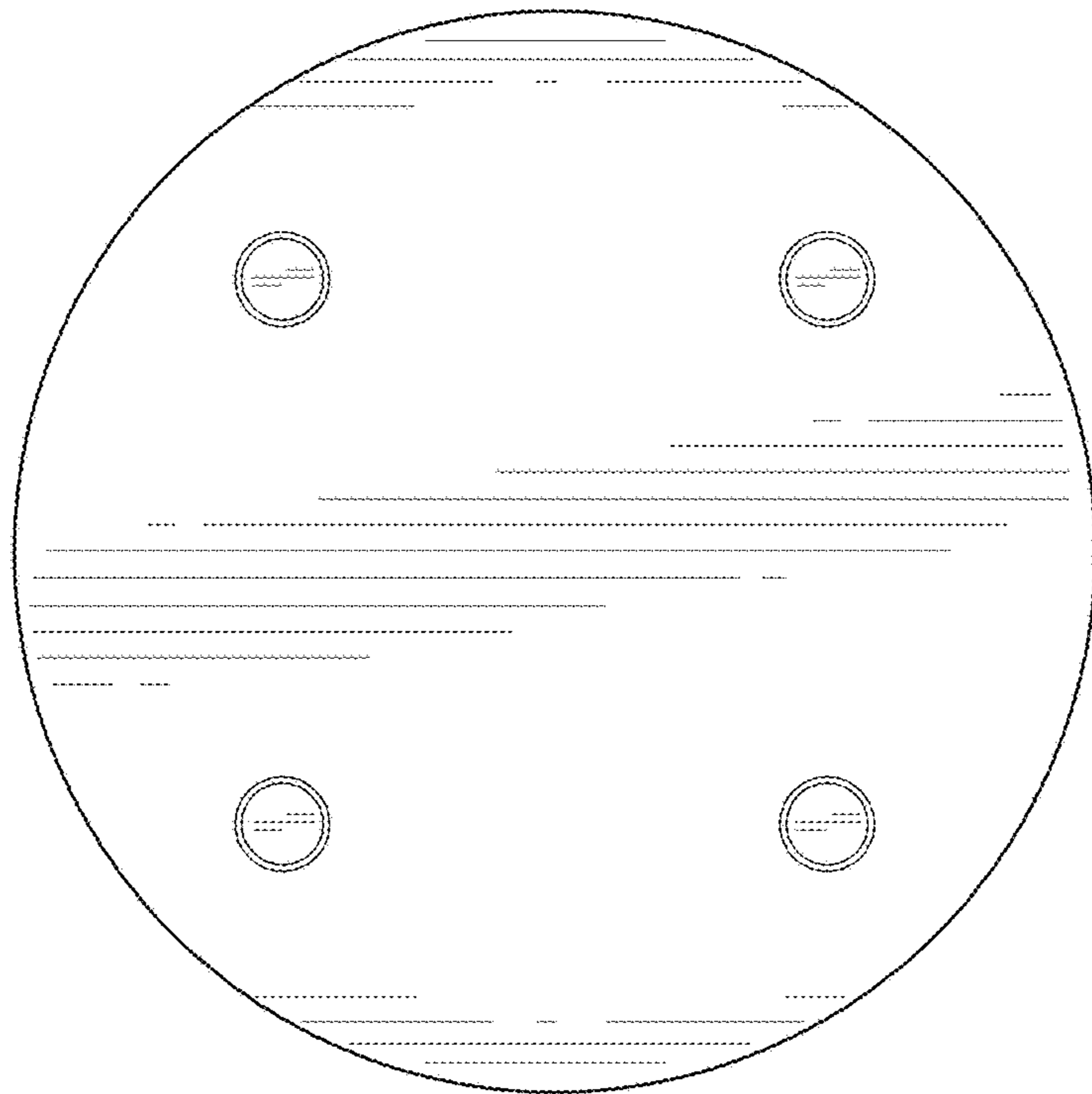

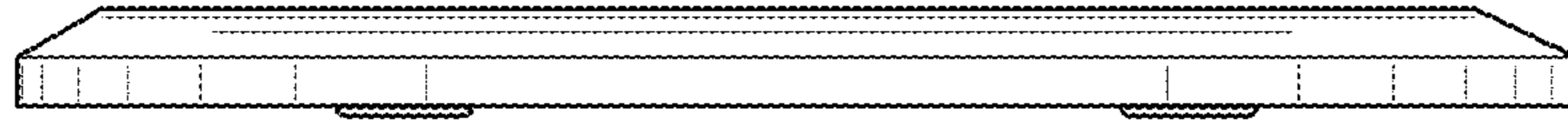

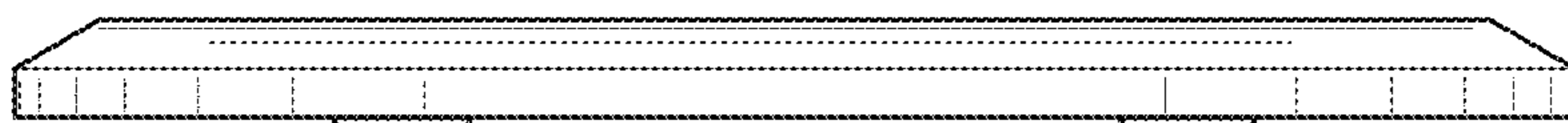

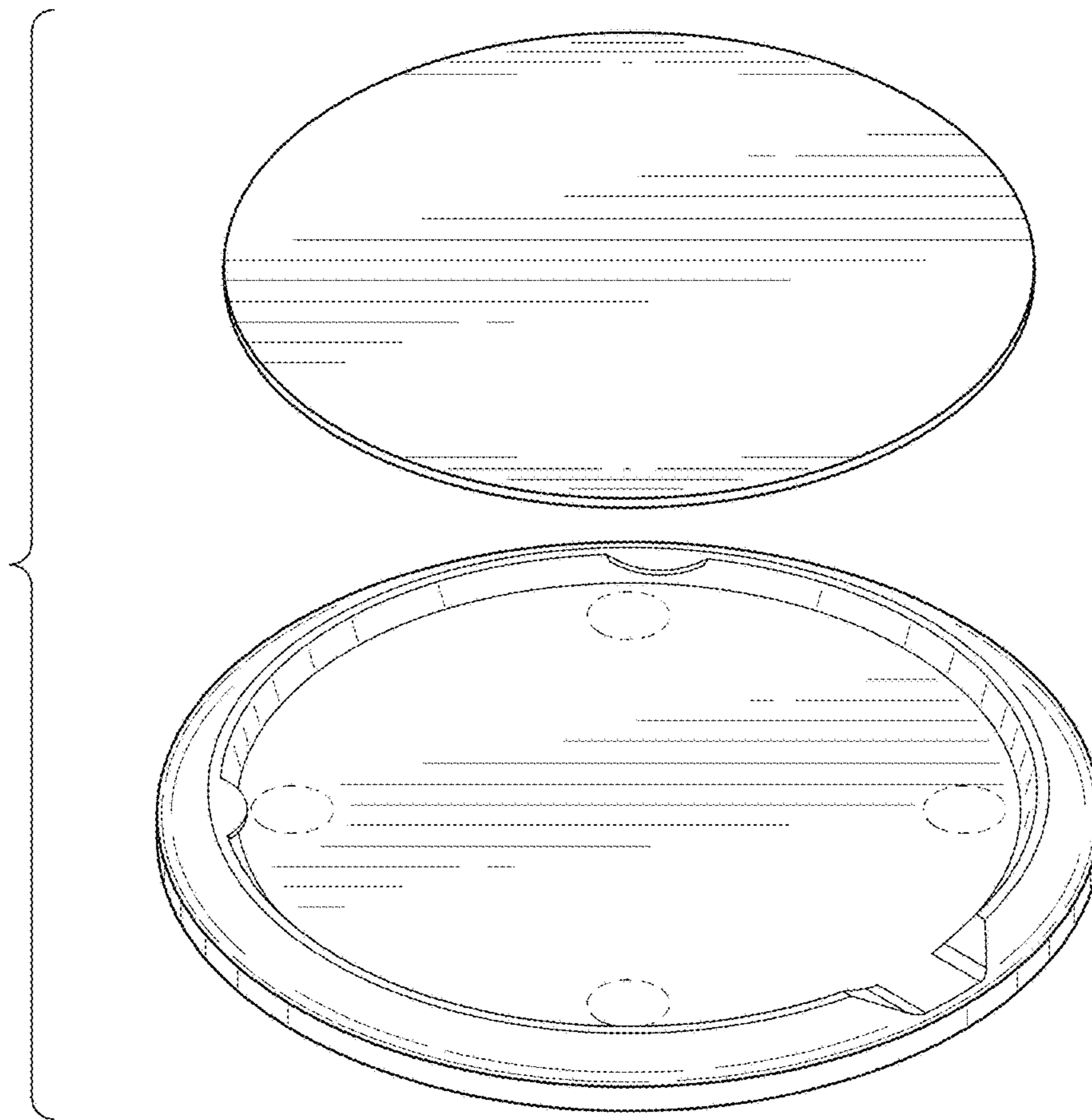

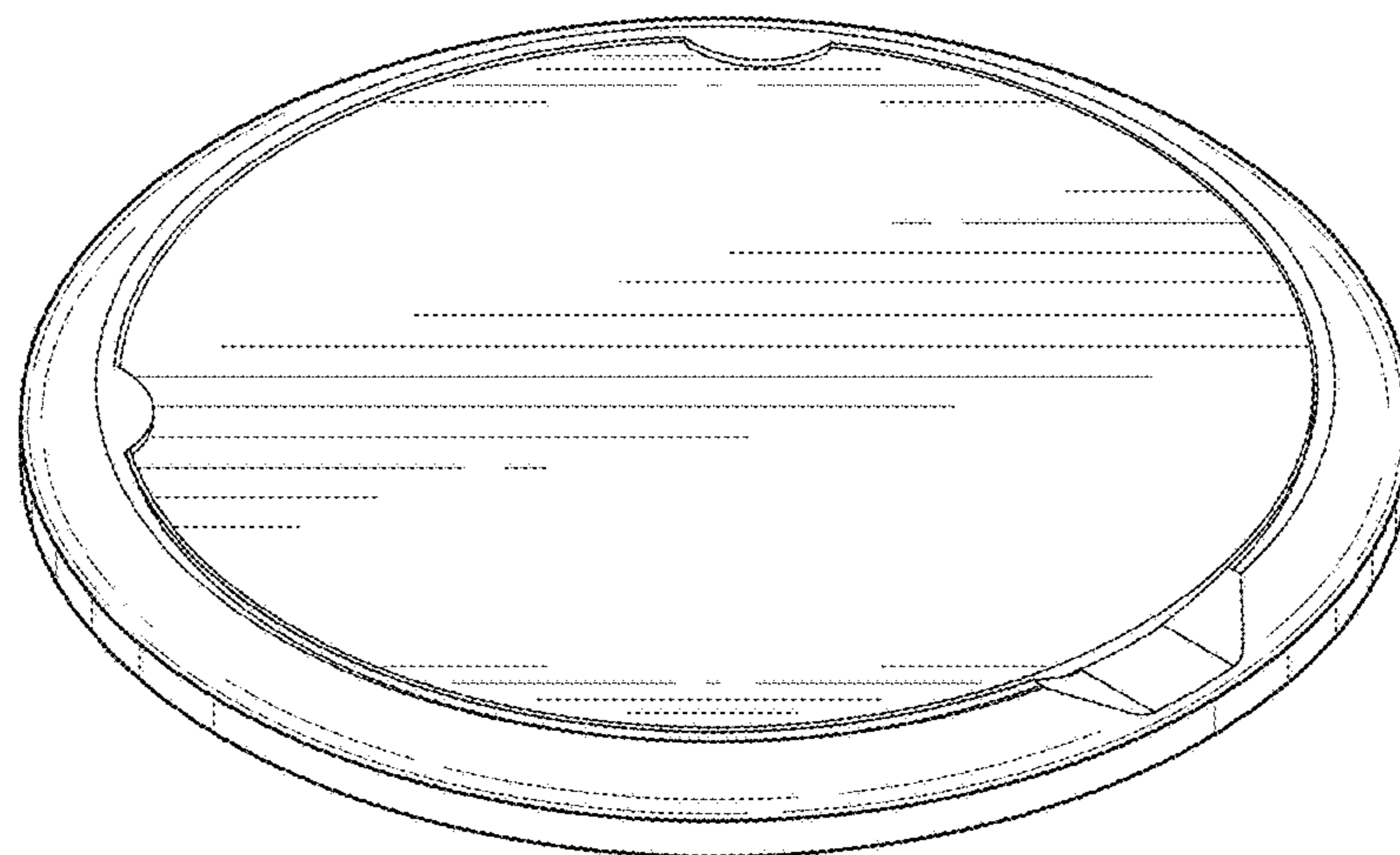

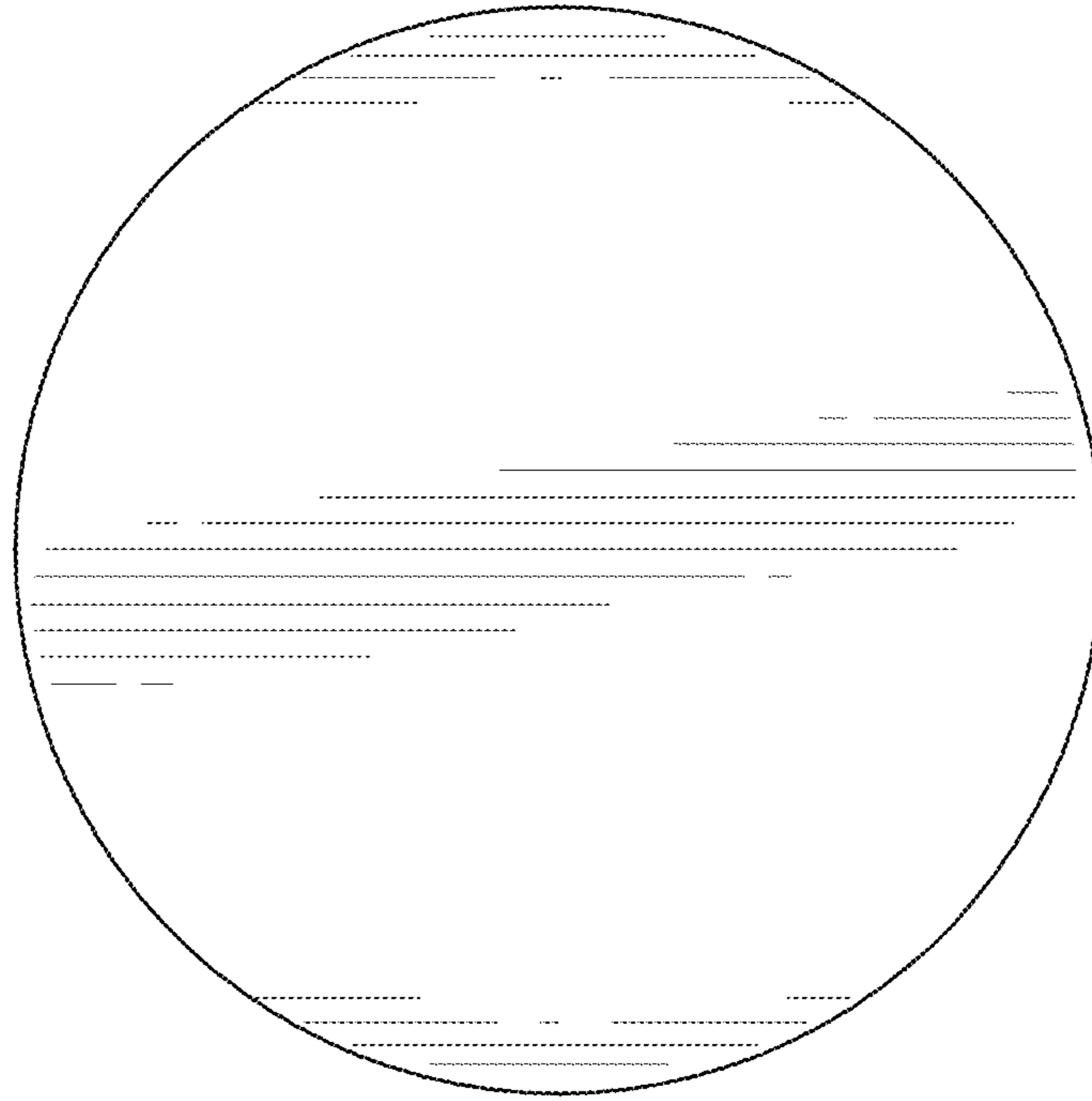

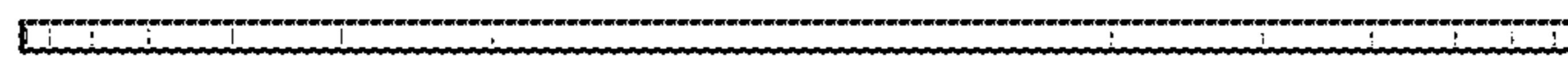
