(57) **CLAIM**

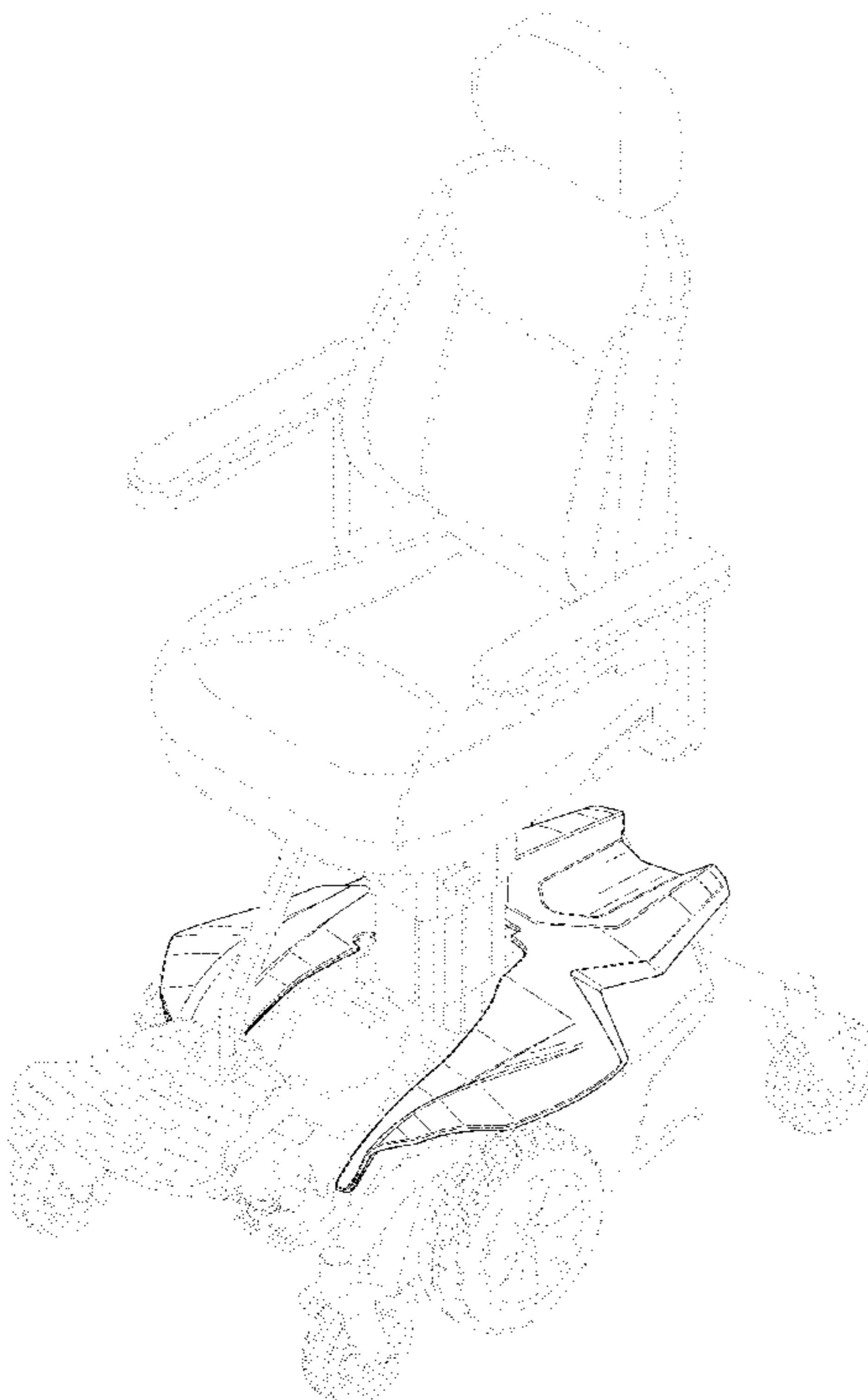
The ornamental design for a chassis cover, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, left perspective view of a chassis cover showing our new design;
FIG. 2 is a rear, top, right perspective view of the chassis cover shown in FIG. 1;
FIG. 3 a front elevational view of the chassis cover shown in FIG. 1;
FIG. 4 is a rear elevational view of the chassis cover shown in FIG. 1;
FIG. 5 is a right-side elevational view of the chassis cover shown in FIG. 1;
FIG. 6 is a left-side elevational view of the chassis cover shown in FIG. 1;
FIG. 7 is a top plan view of the chassis cover shown in FIG. 1; and,

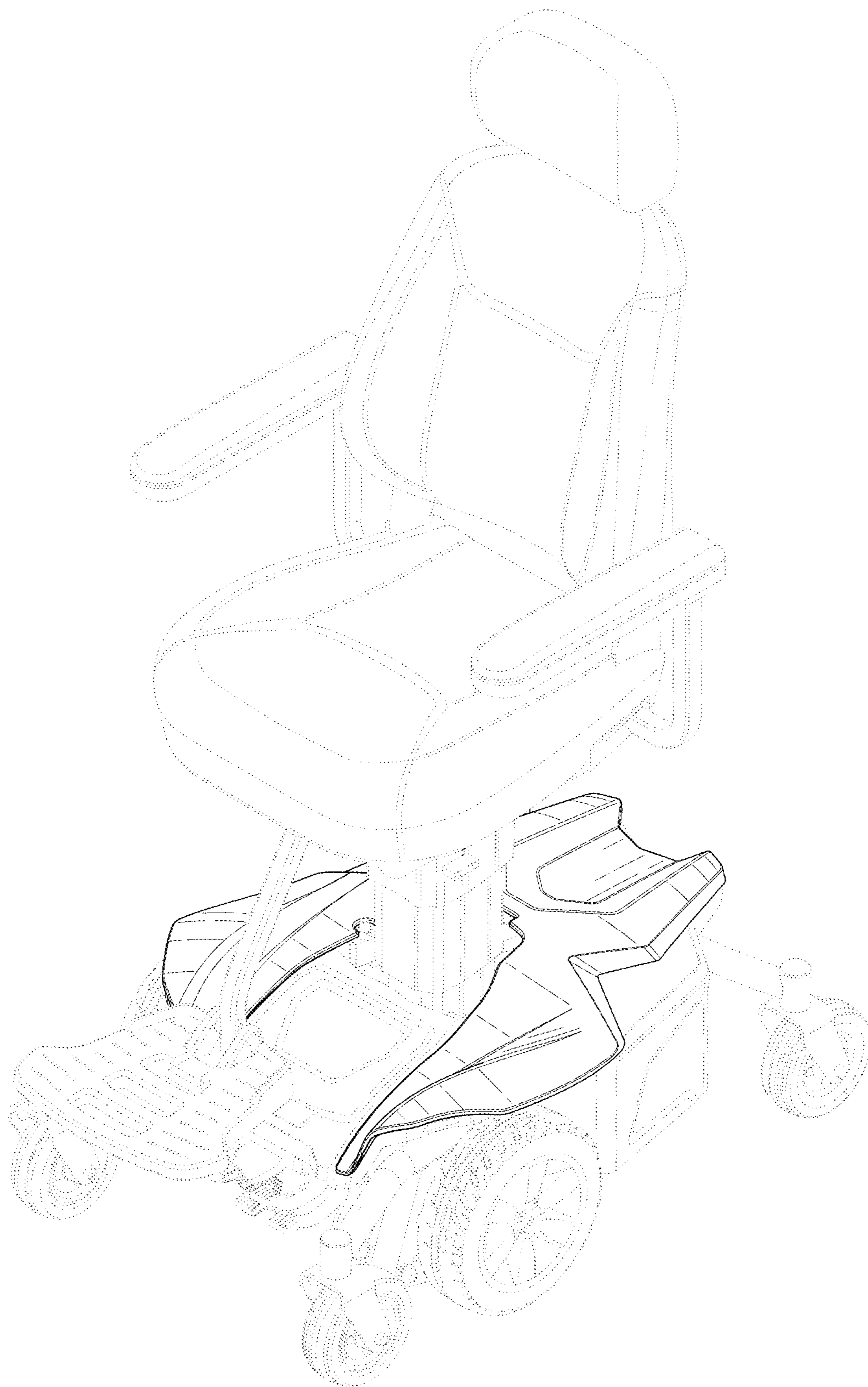

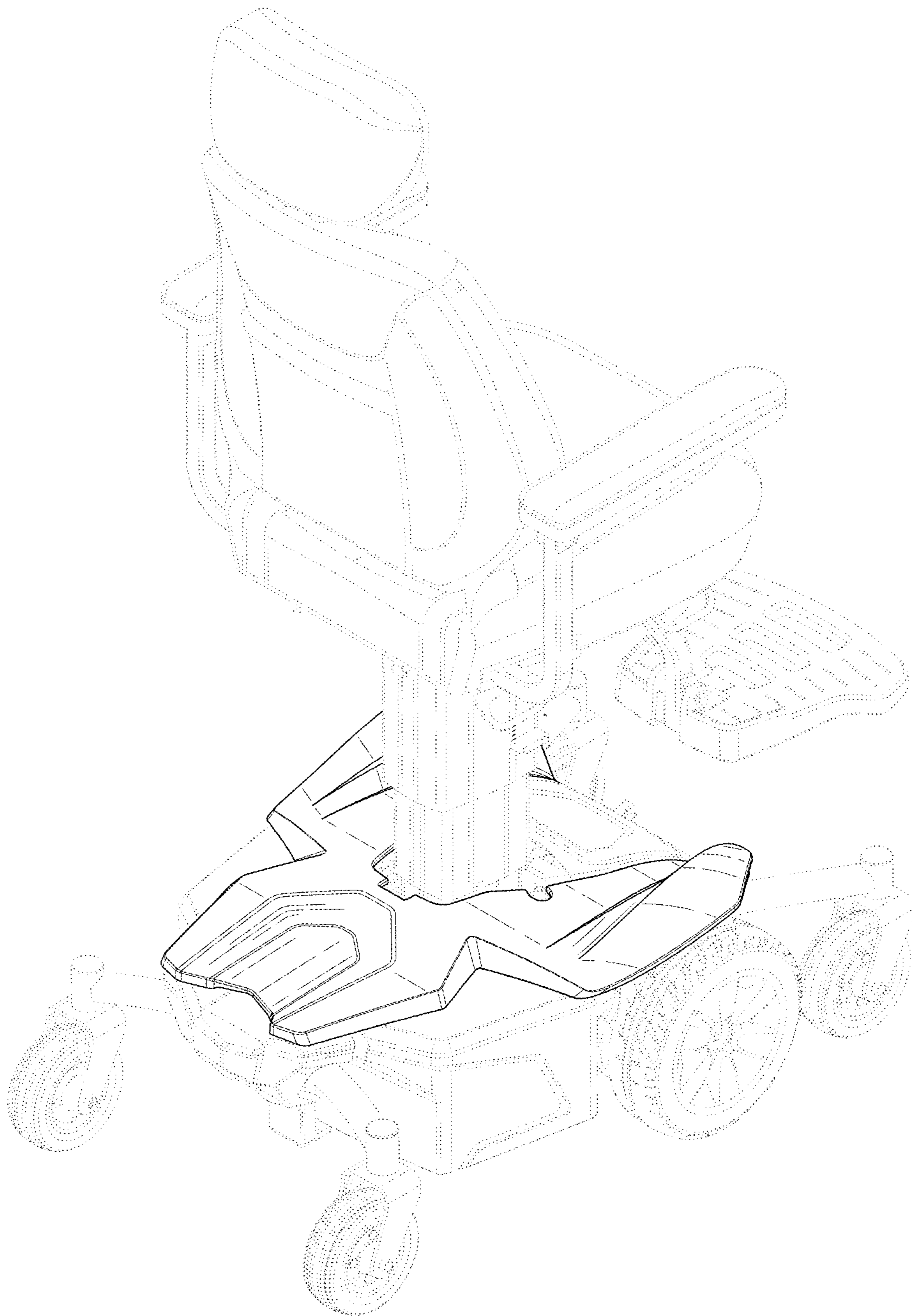

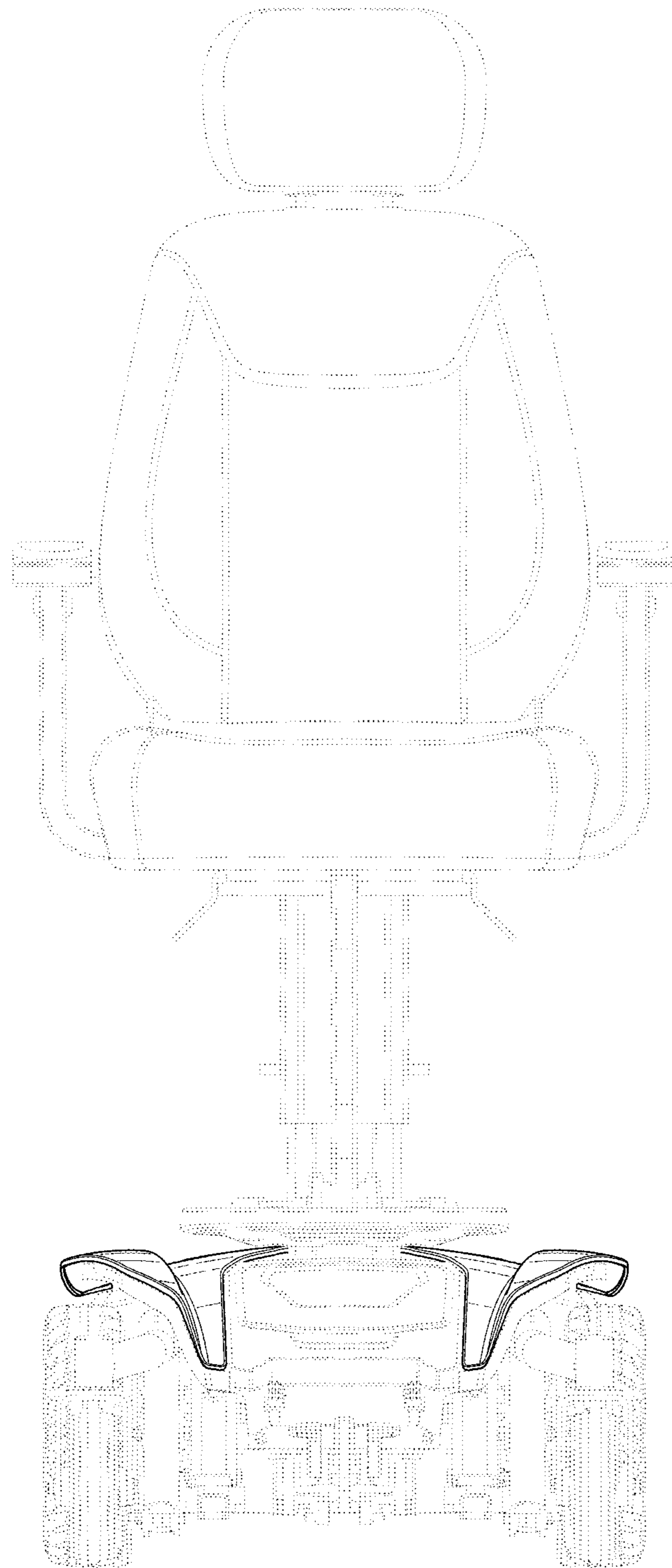

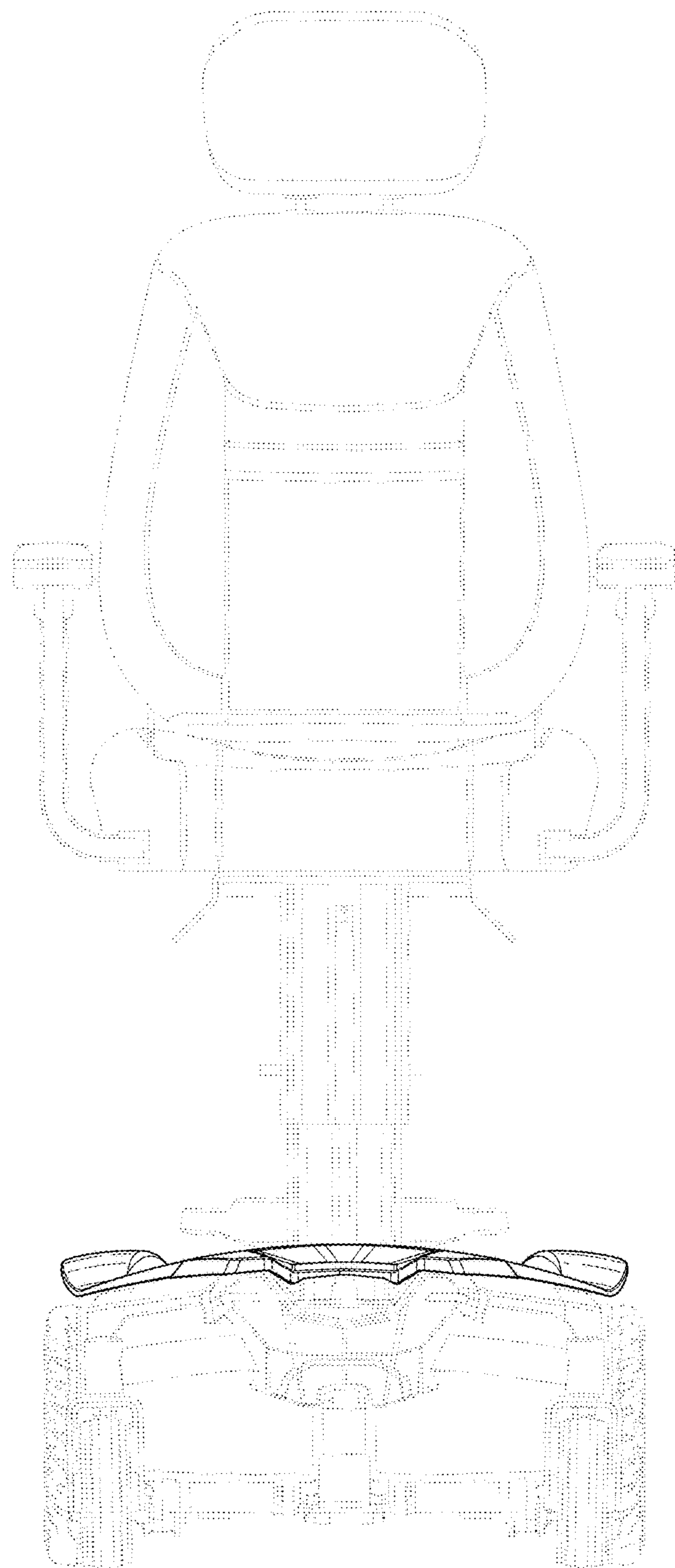

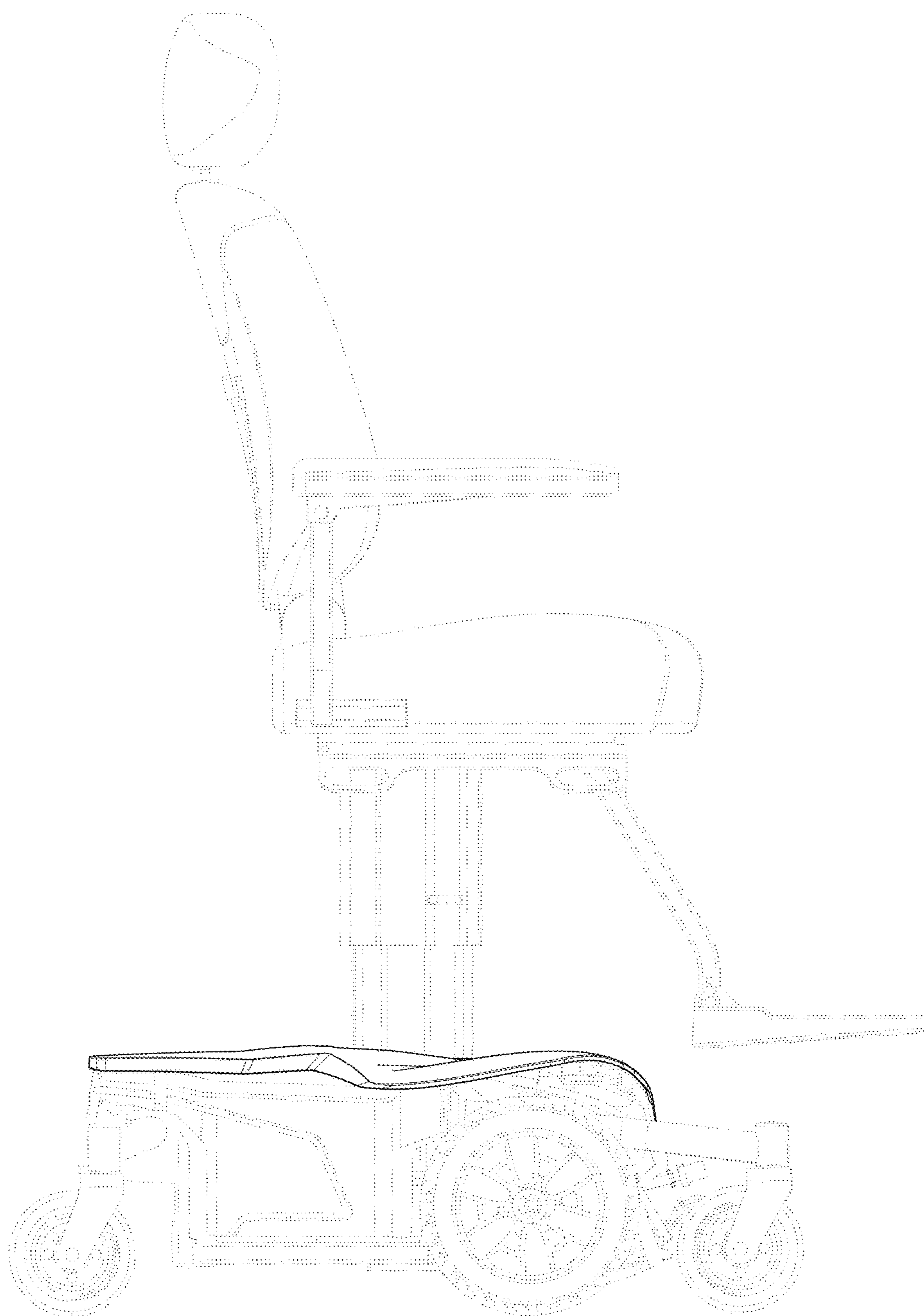

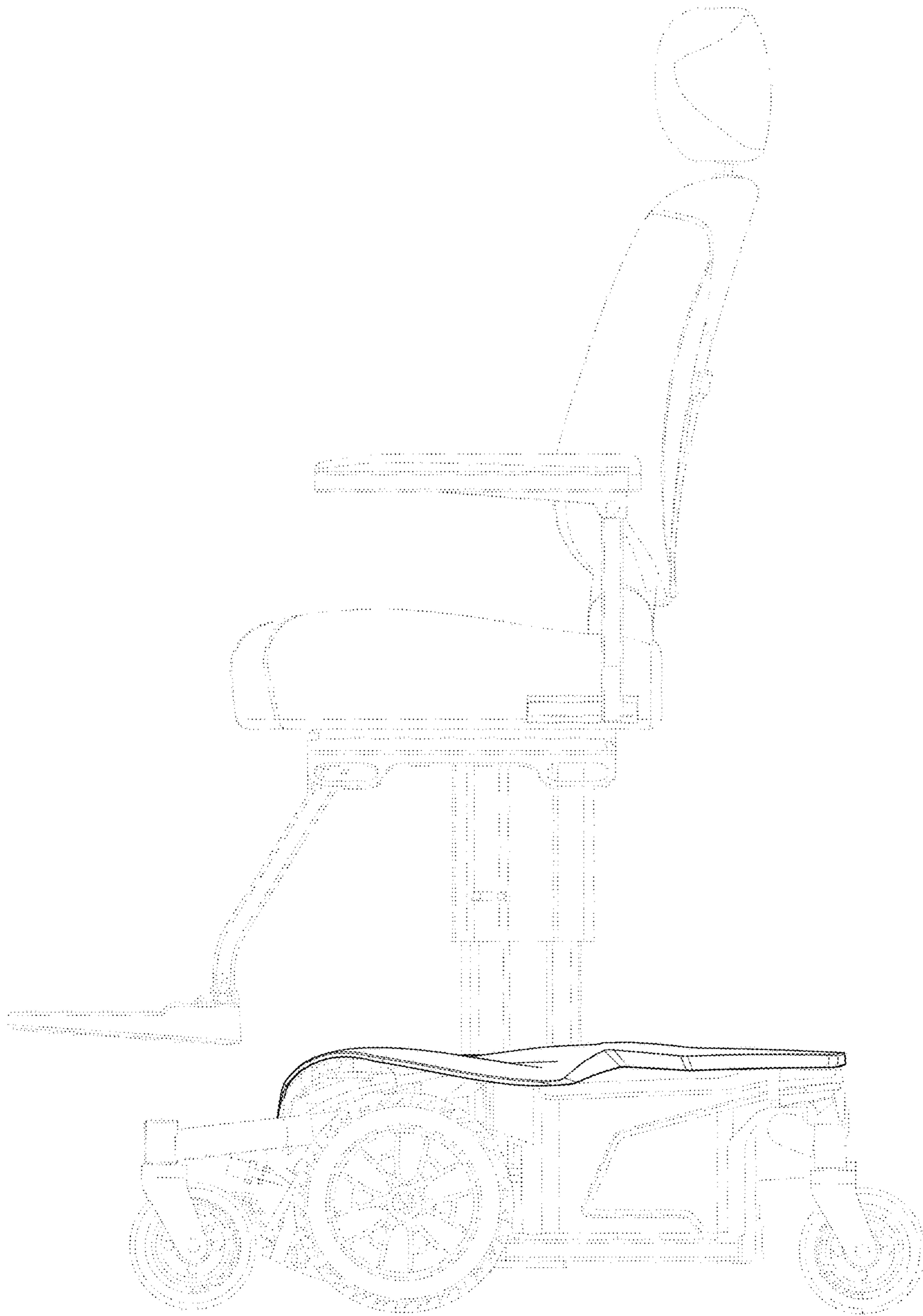

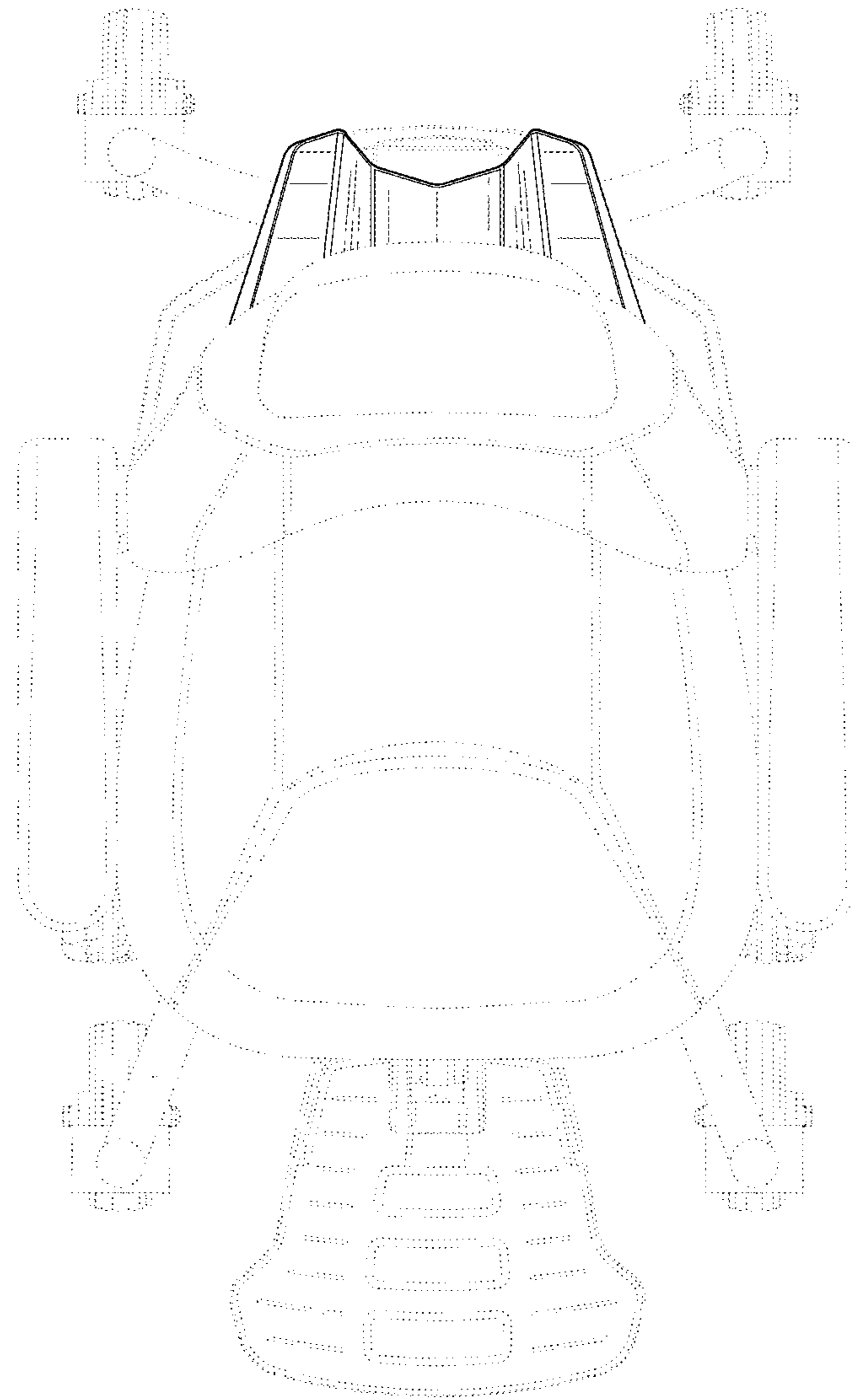

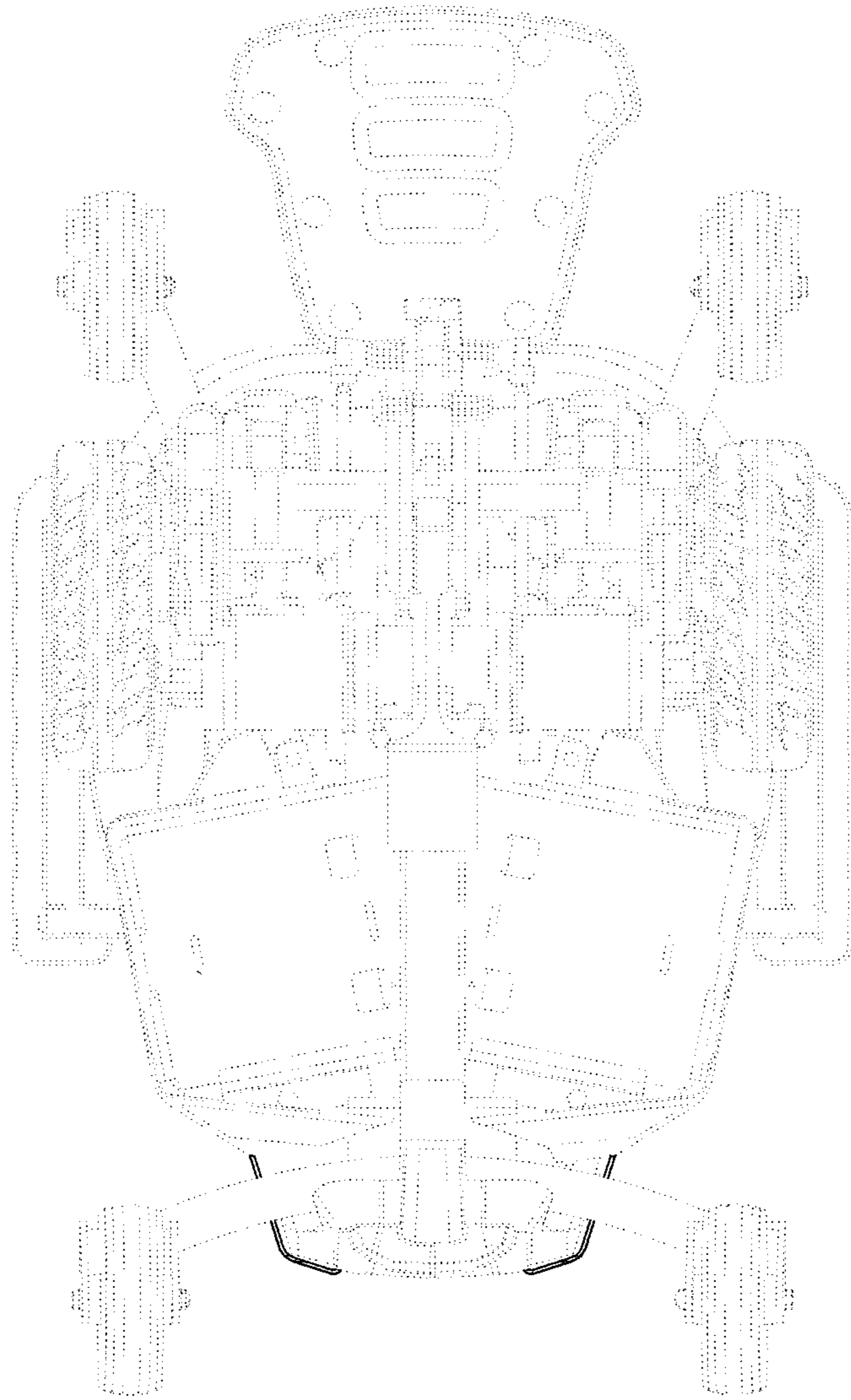
