(57) **CLAIM**

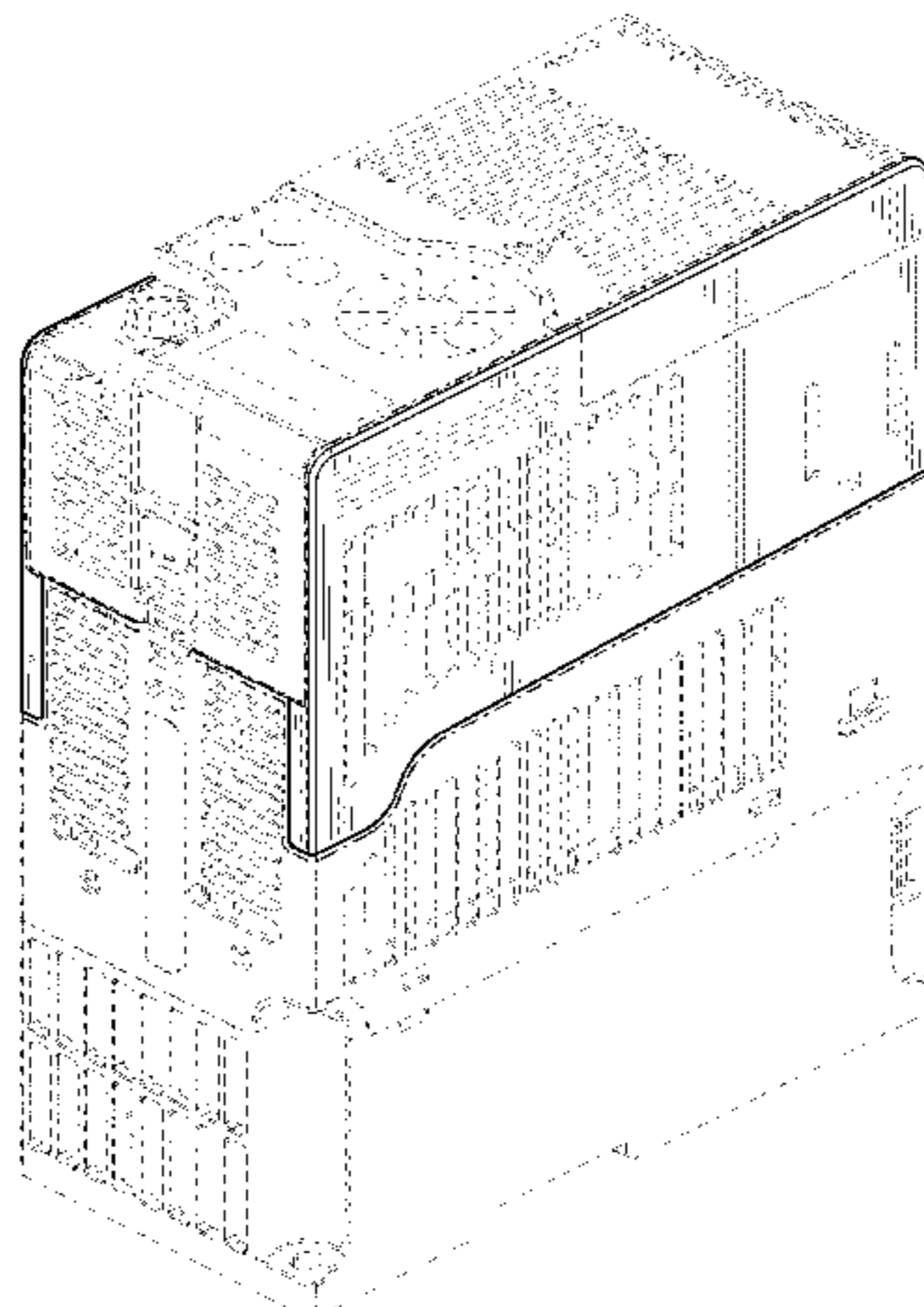
The ornamental design for an industrial control component interface, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of an industrial control component interface, showing our new design; FIG. 2 is a front side elevational view thereof; FIG. 3 is a rear side elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a bottom perspective view of a disassembled top portion of an industrial control component interface; FIG. 9 is a right side elevational view thereof; FIG. 10 is a left side elevational view thereof; FIG. 11 is a front side elevational view thereof; FIG. 12 is a rear side elevational view thereof; FIG. 13 is a bottom plan view thereof; FIG. 14 is a top perspective view of a disassembled bottom portion of an industrial control component interface; FIG. 15 is a right side elevational view thereof; FIG. 16 is a left side elevational view thereof; FIG. 17 is a top plan view thereof; FIG. 18 is a front side elevational view thereof; and, FIG. 19 is a rear side elevational view thereof.

In the drawings, the solid lines illustrate the claimed ornamental design, whereas the broken lines illustrate environmental features that form no part of the claimed ornamental design. The dash-dot line represents the boundary of the claim and forms no part of the claimed design.

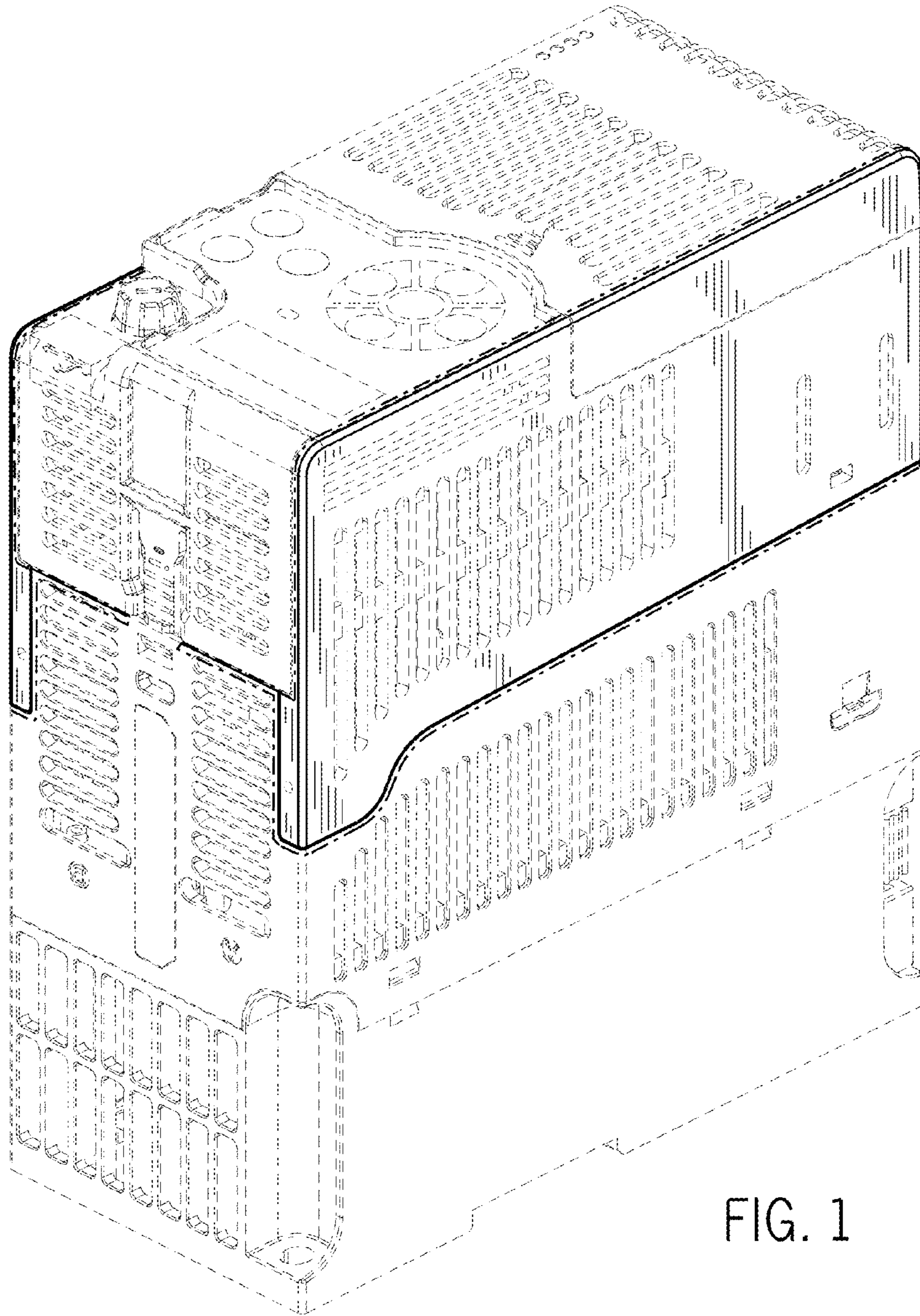

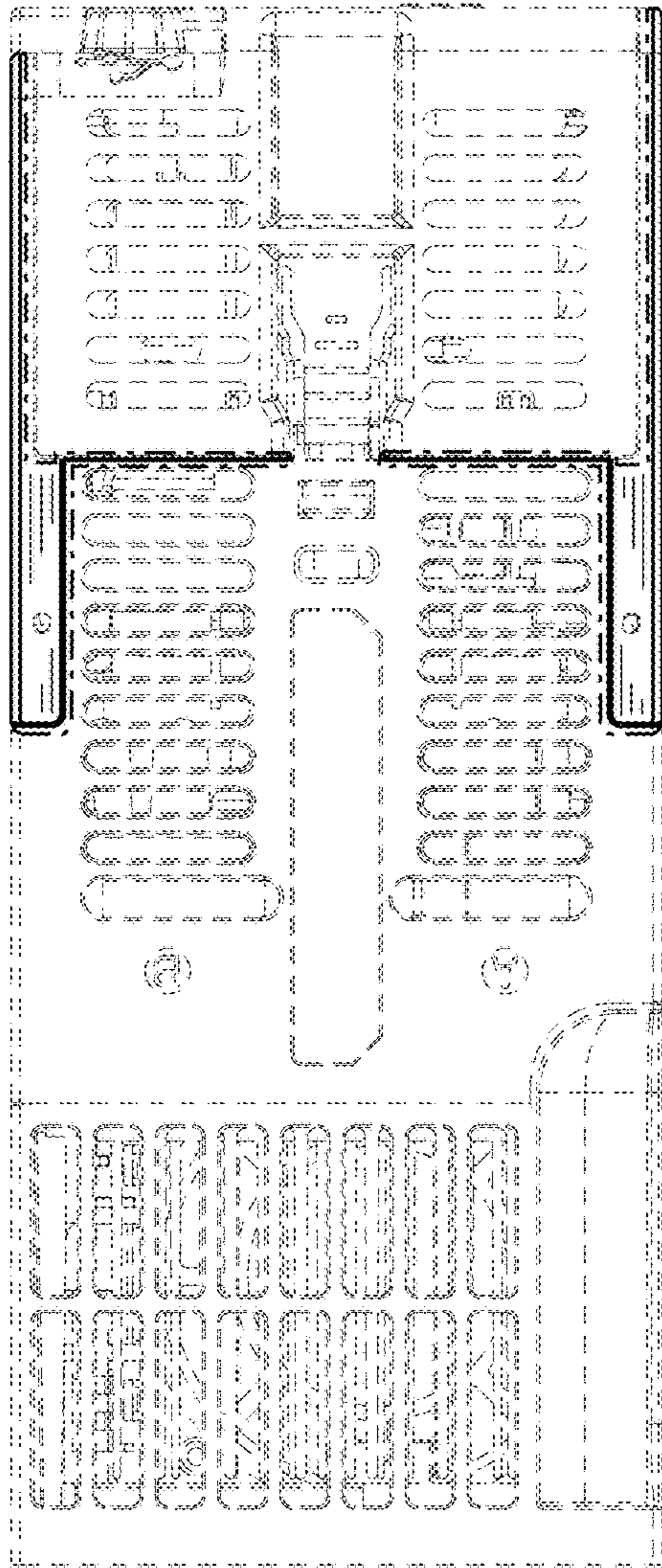

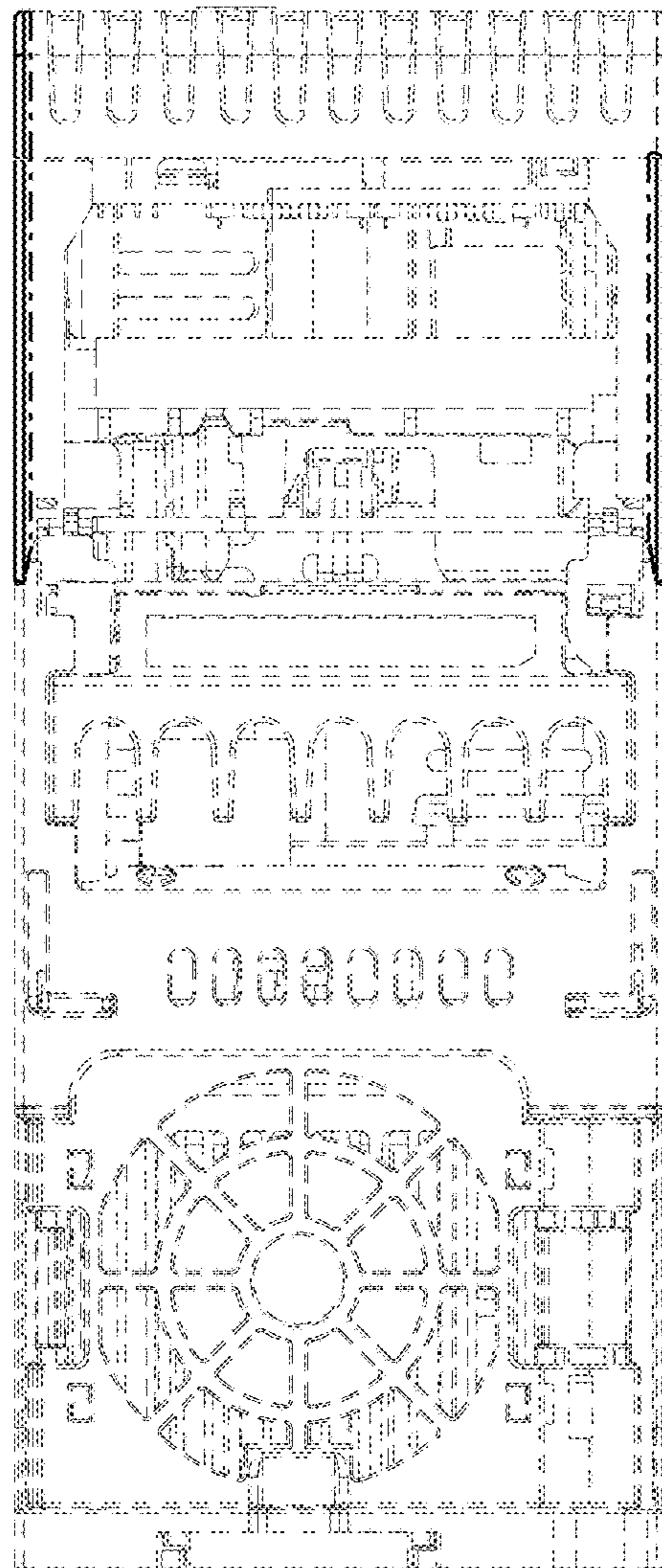

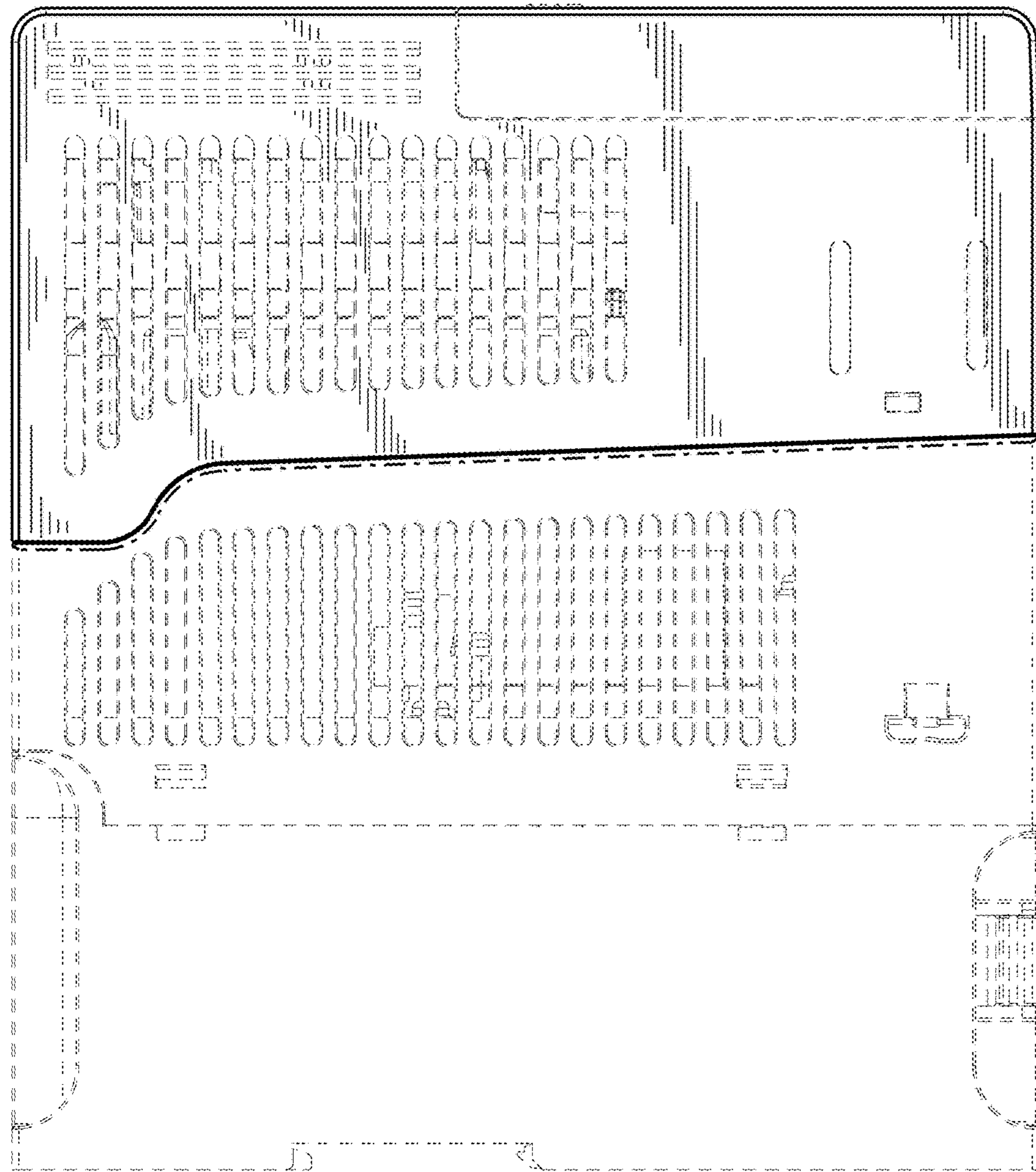

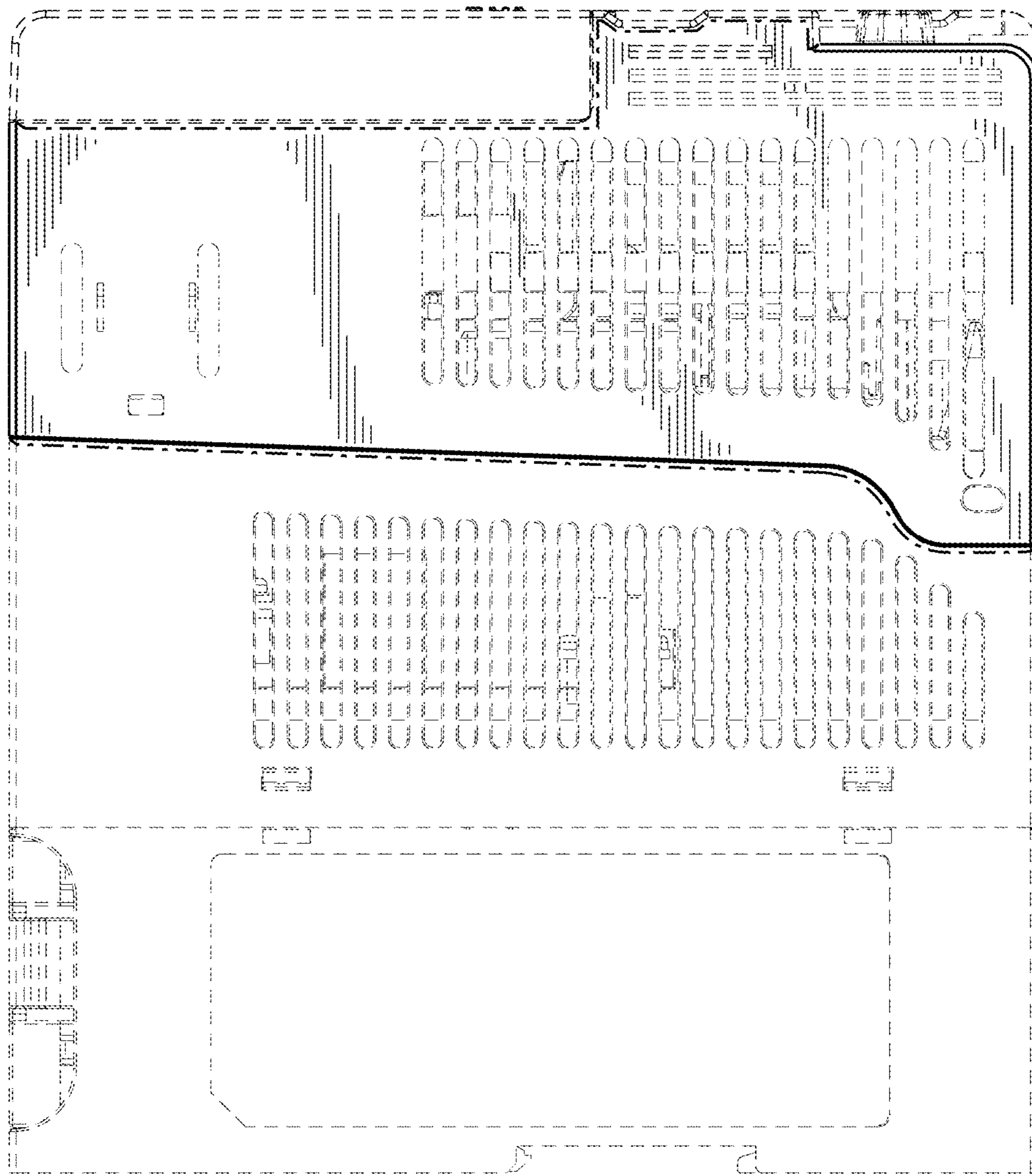

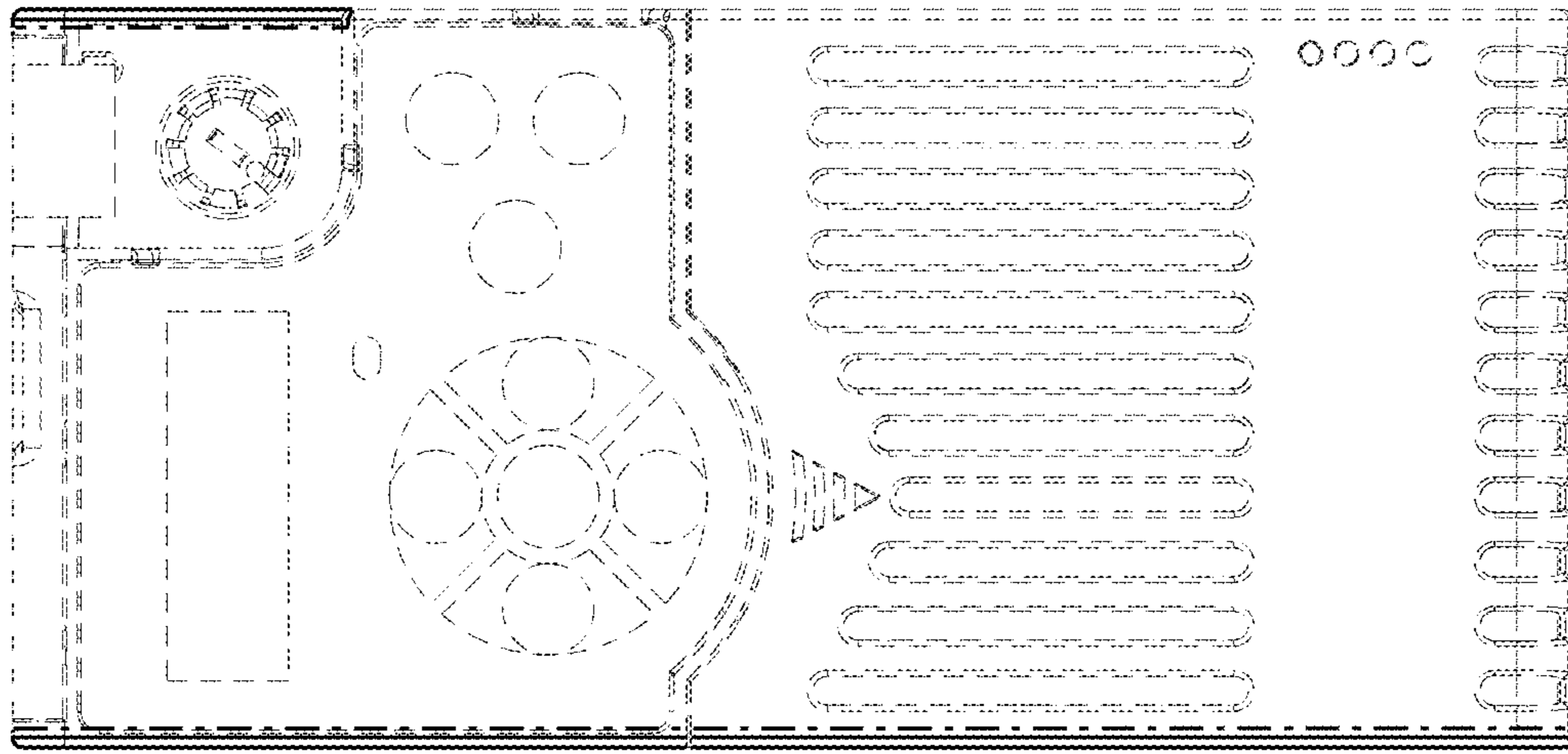

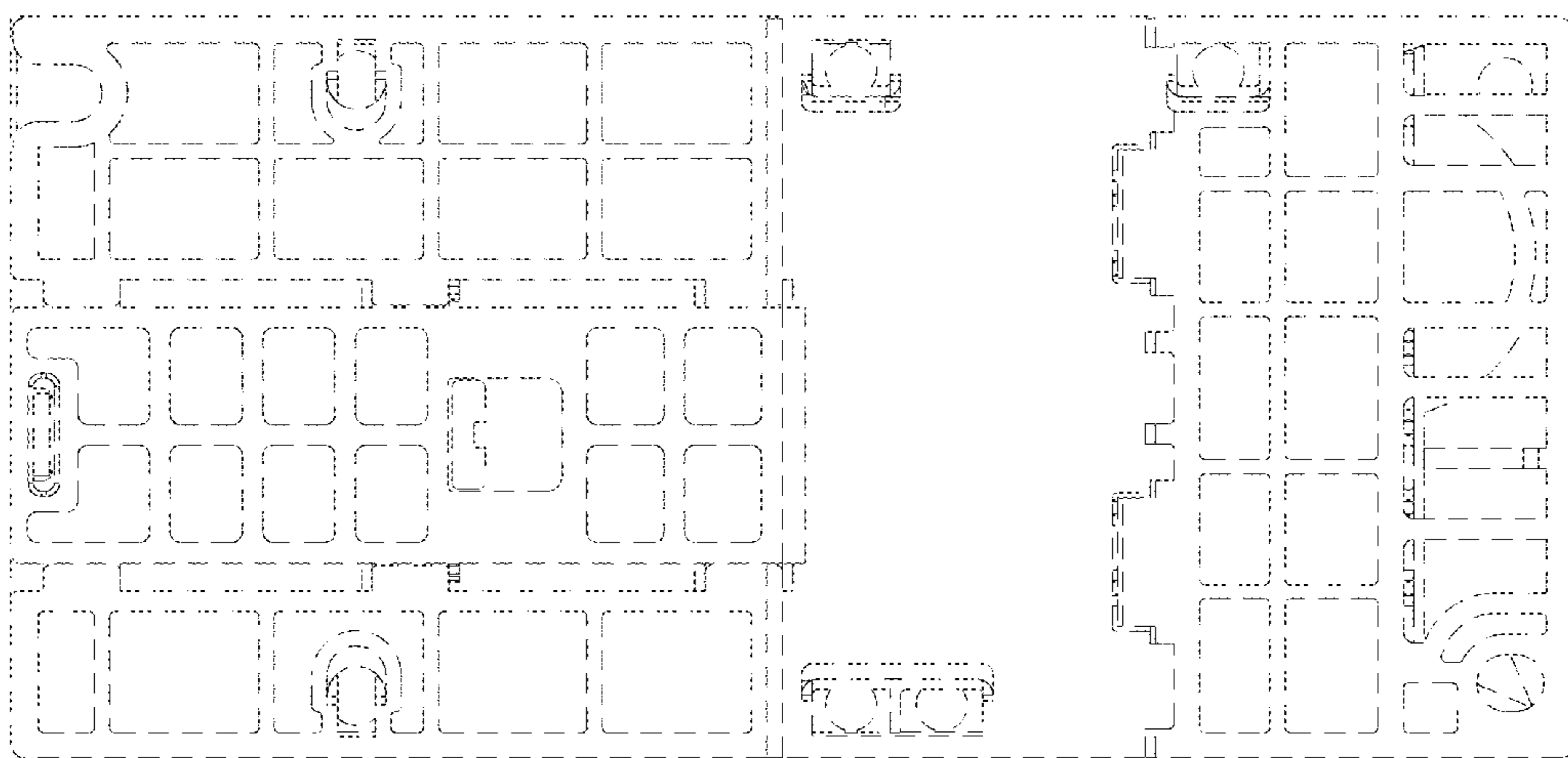

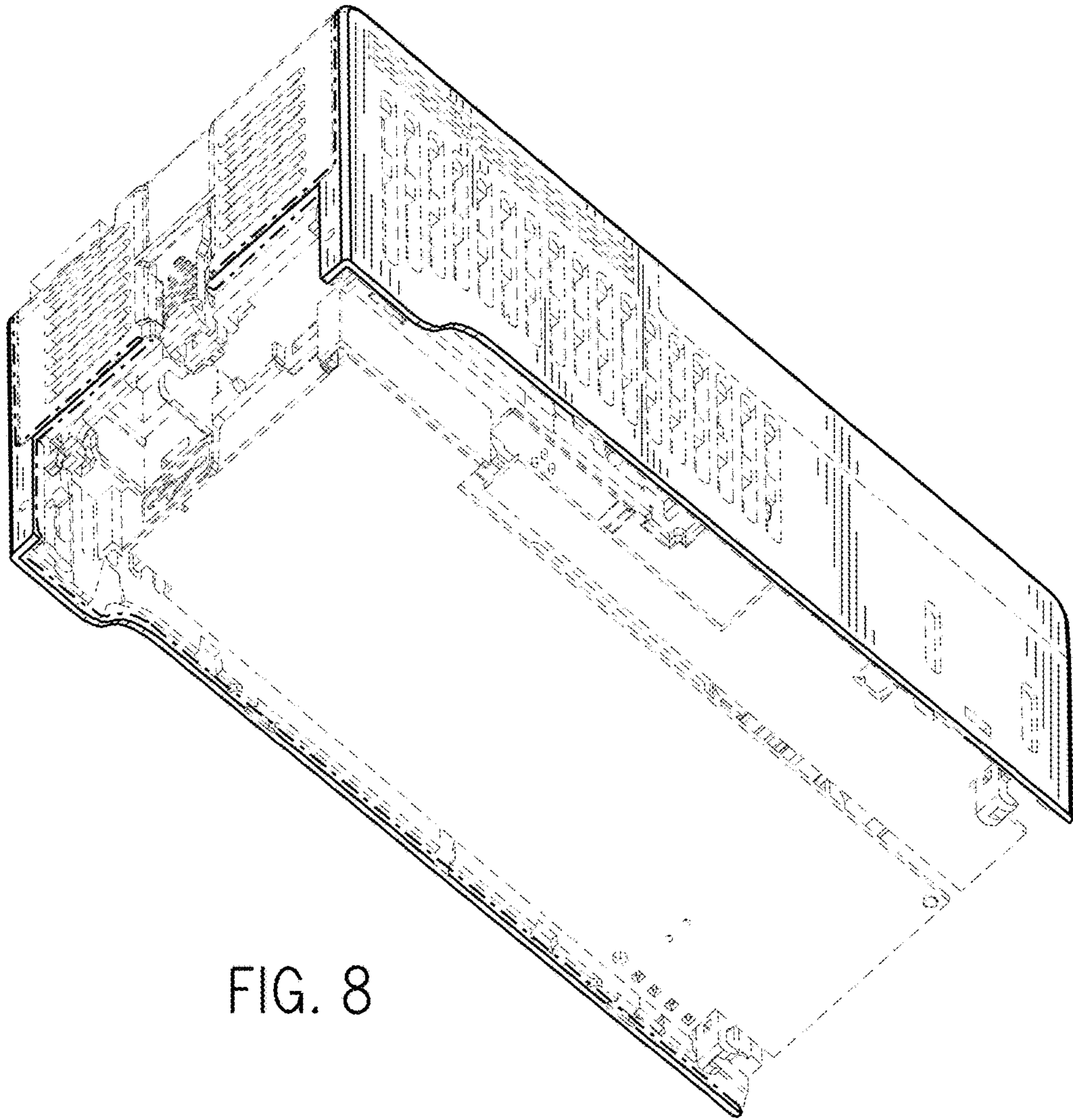

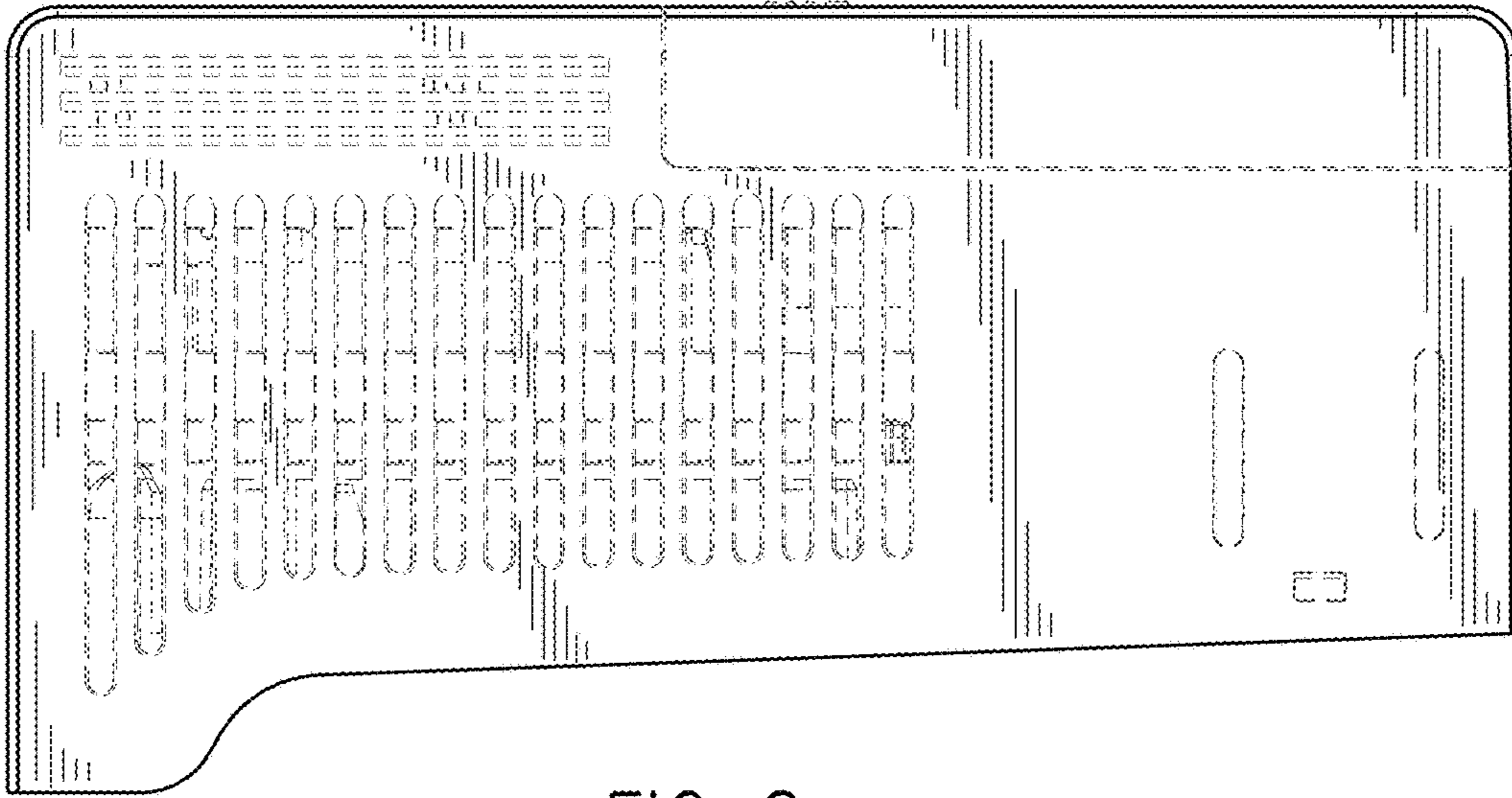

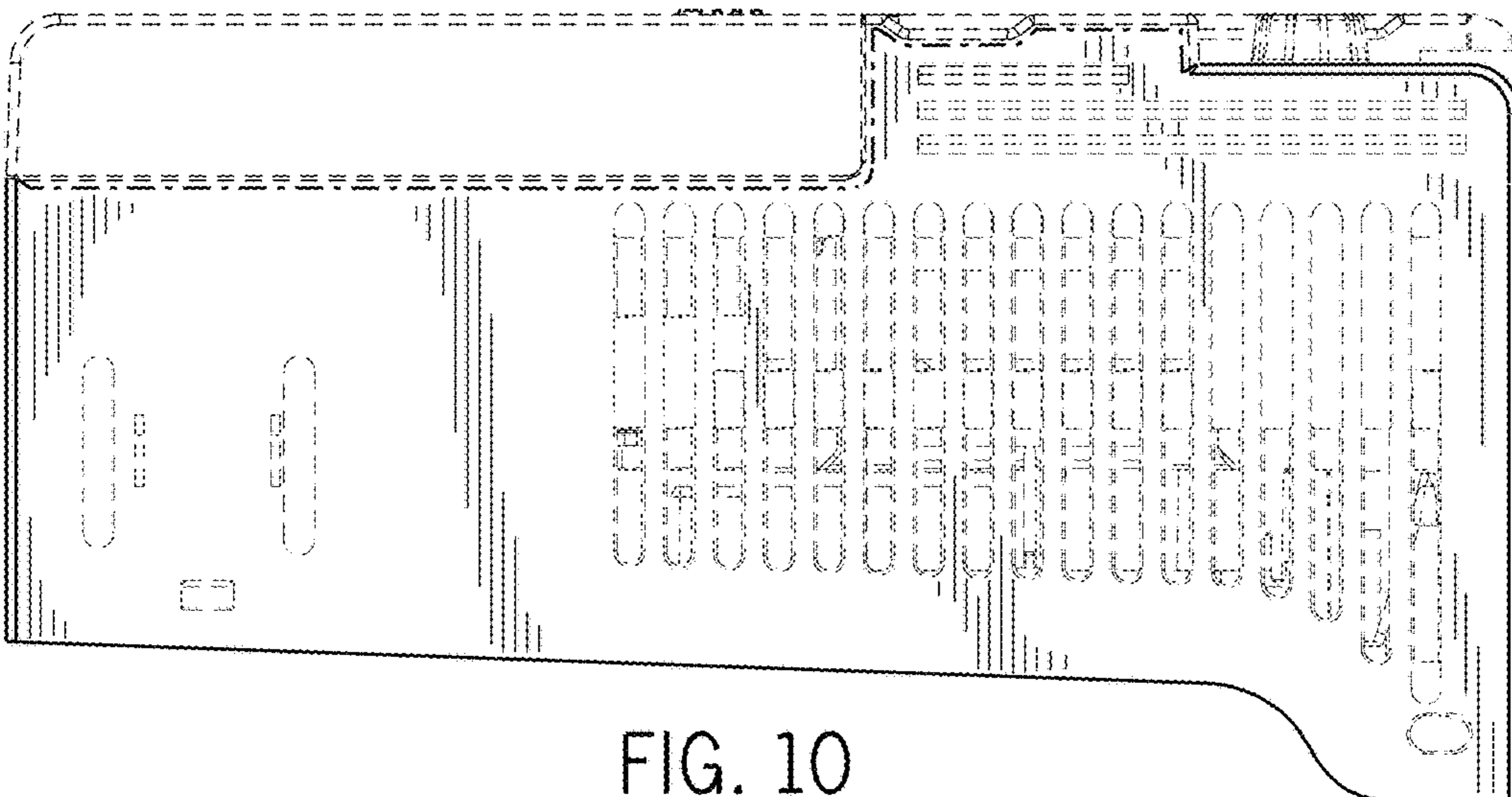

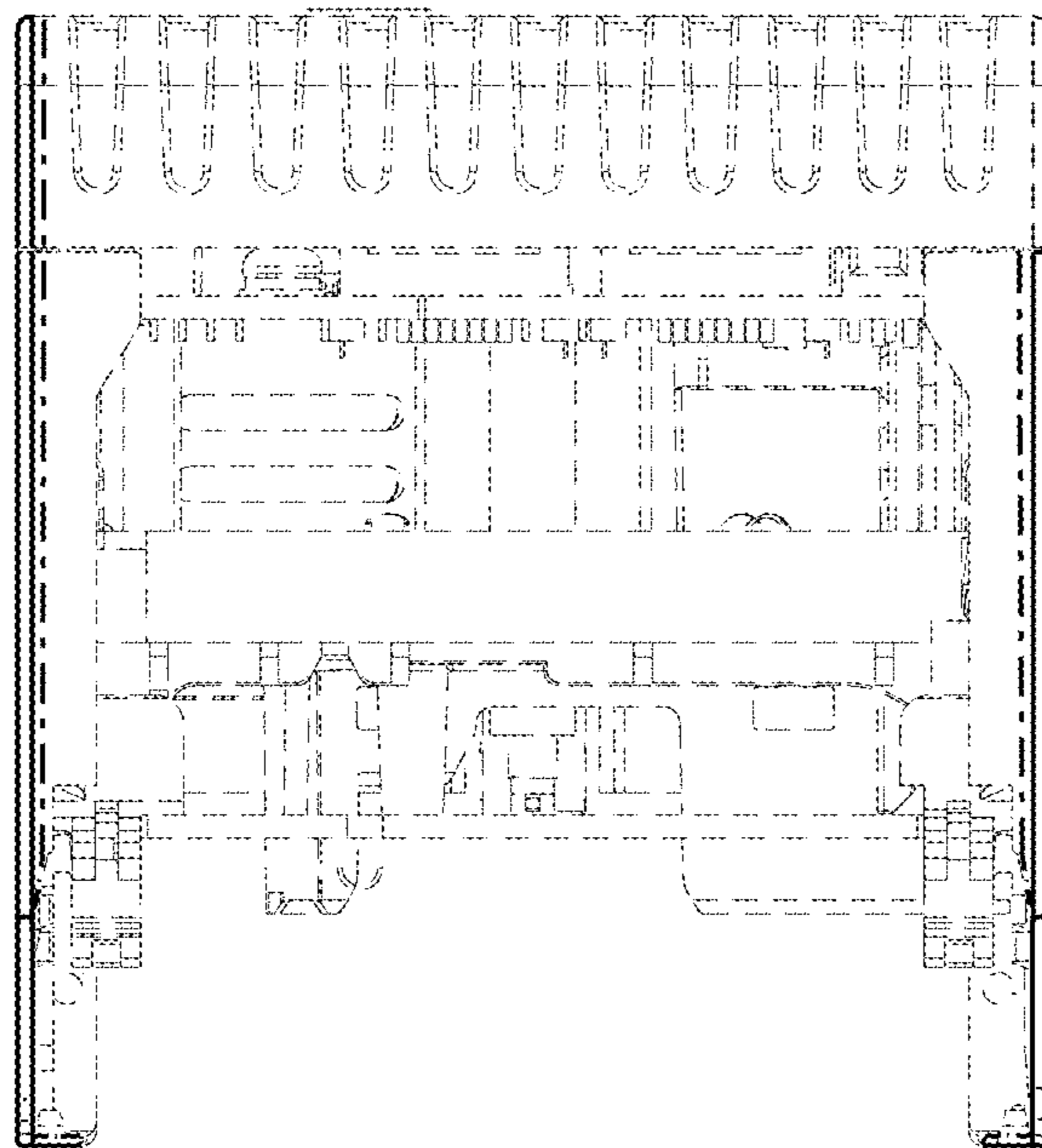

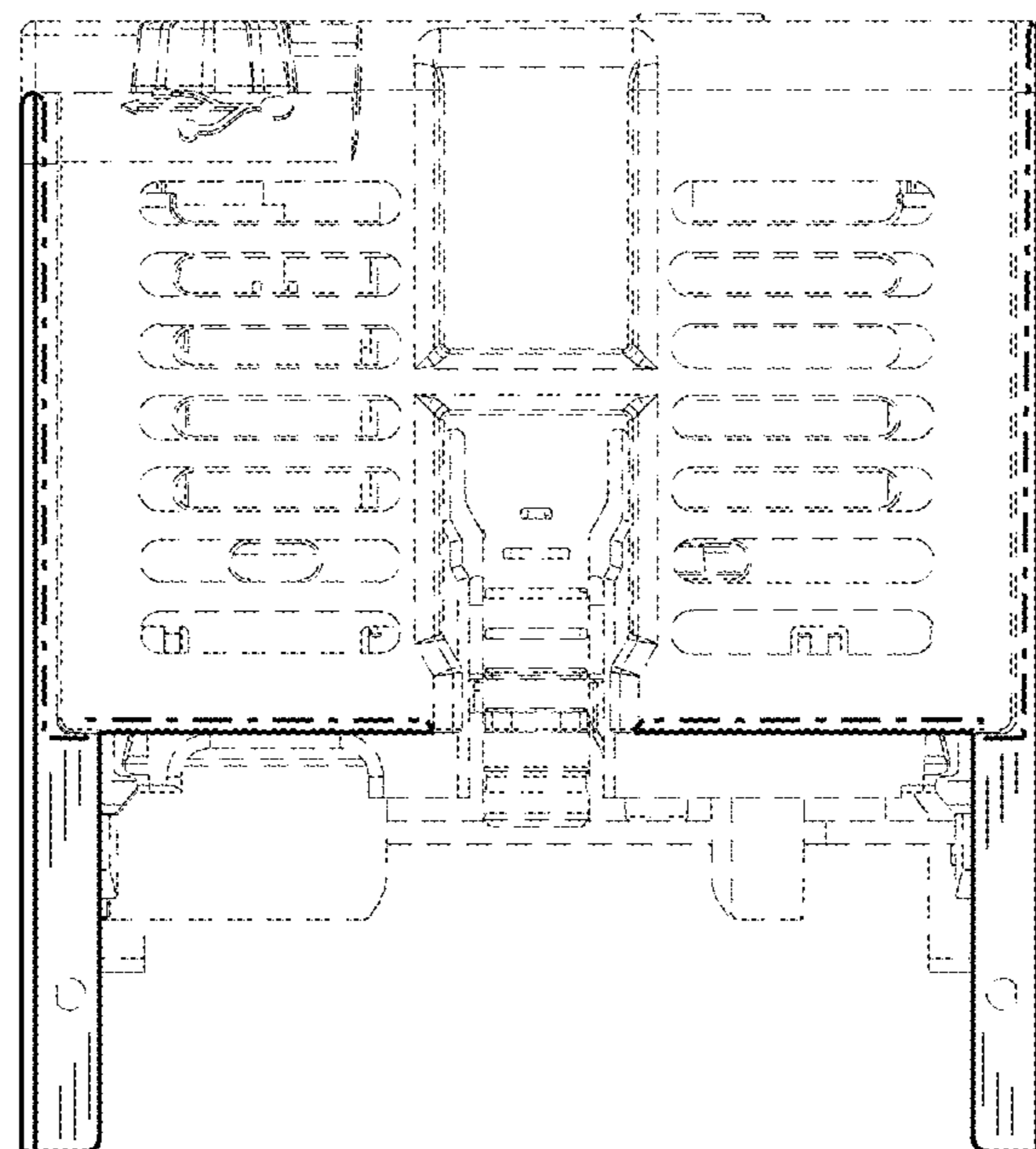

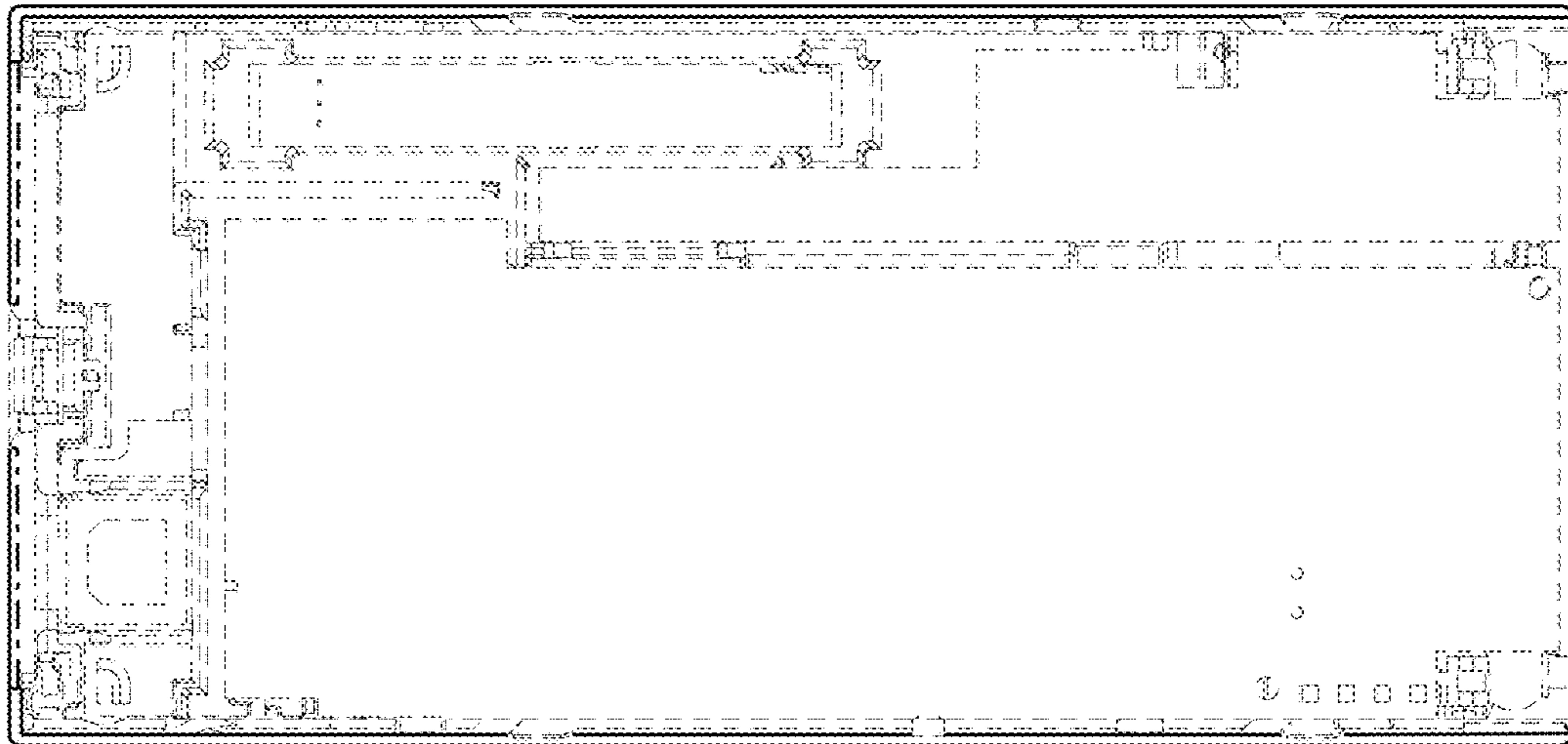
