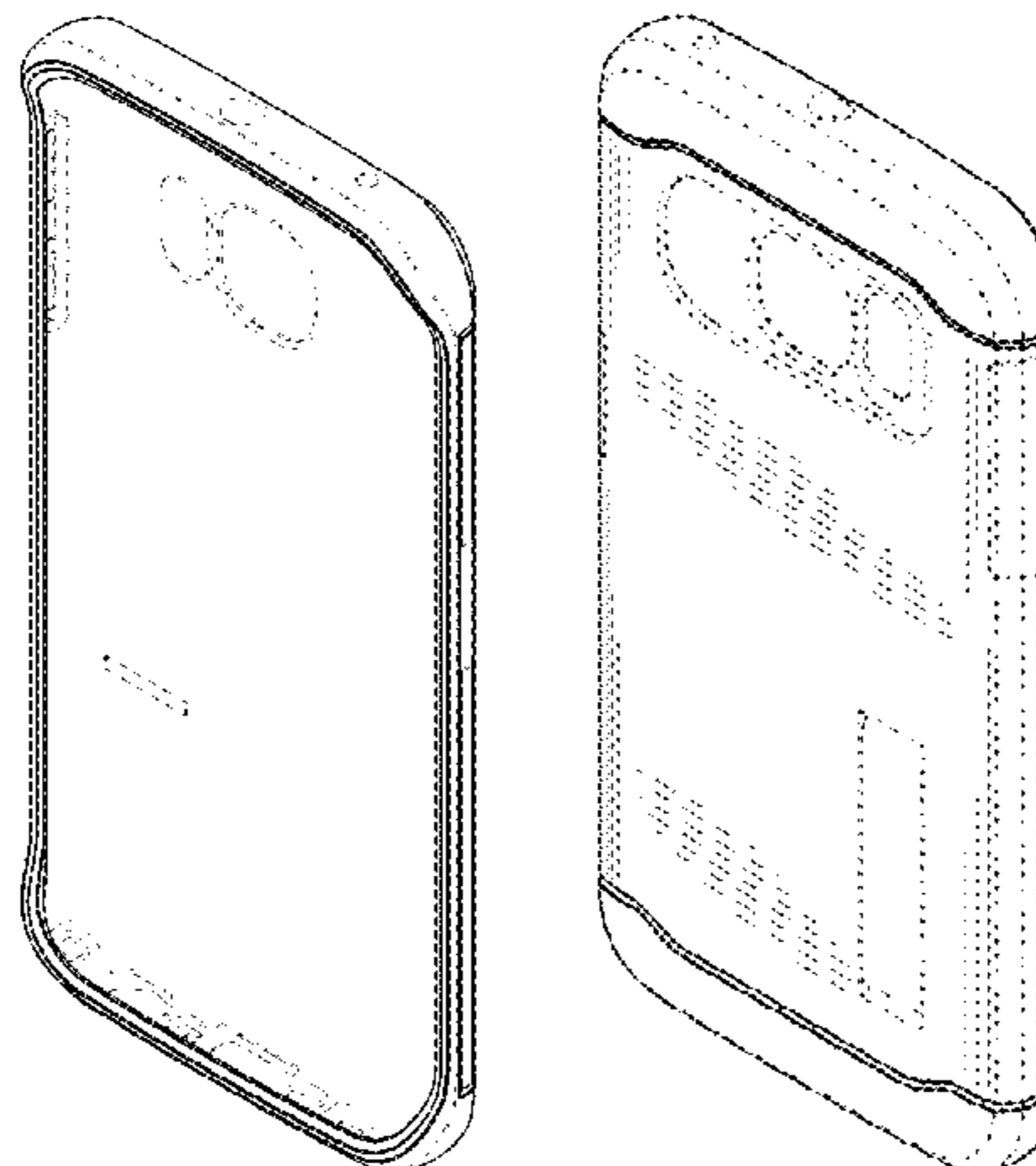
(57) **CLAIM**

The ornamental design for a case for electronic devices, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a case for electronic devices showing my new design;  
FIG. 2 is a rear perspective view thereof;

FIG. 4 is a rear elevational view thereof;

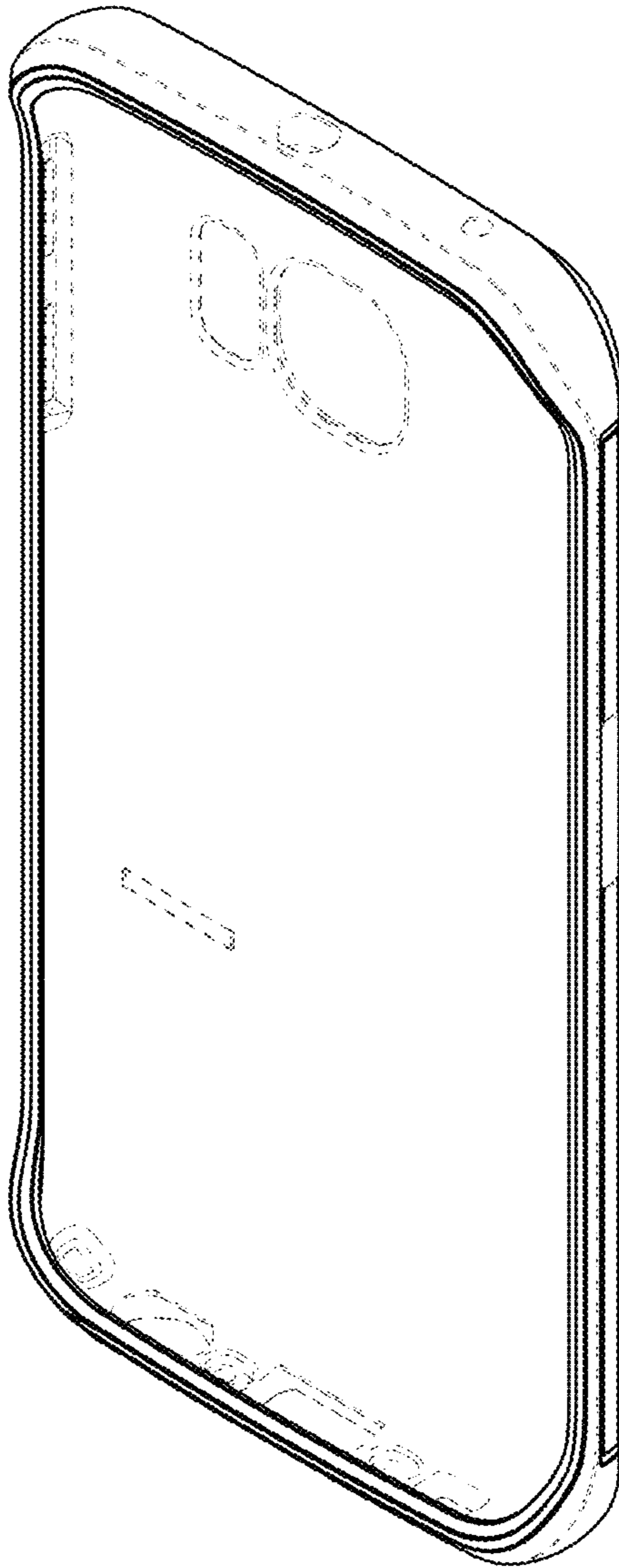

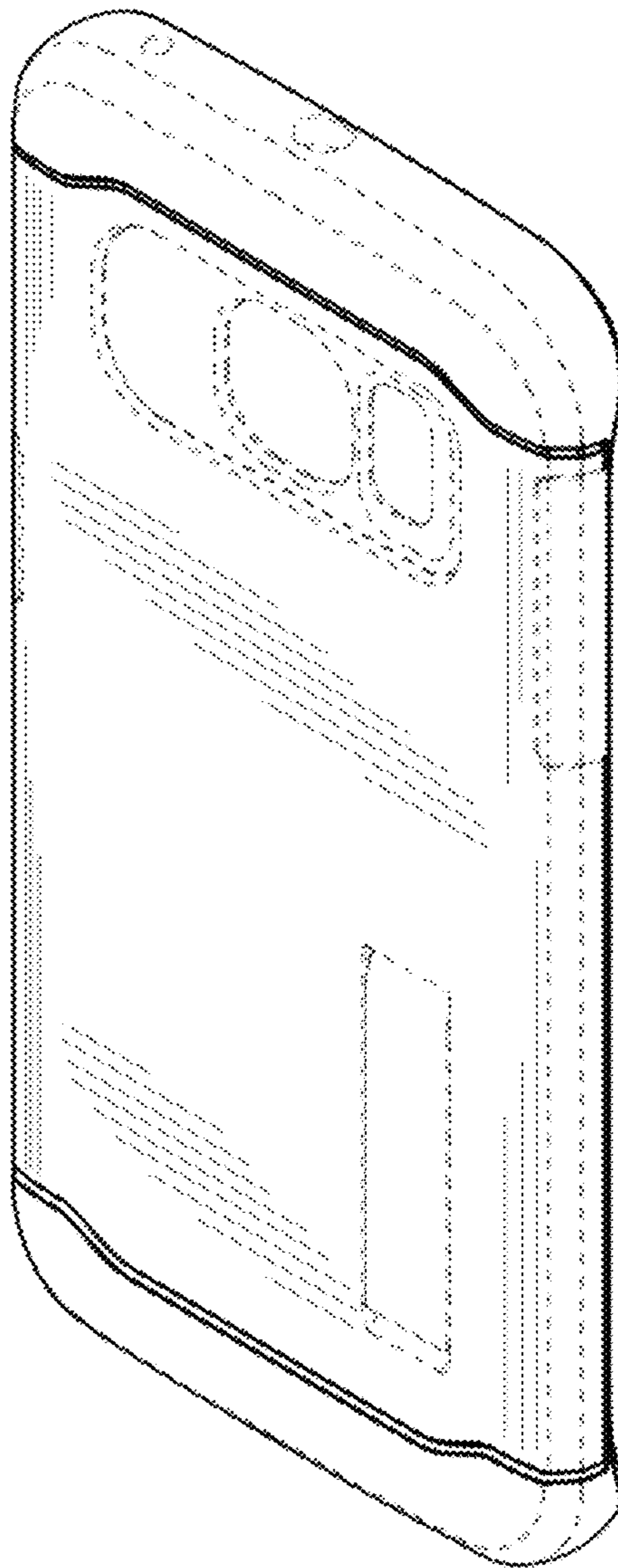

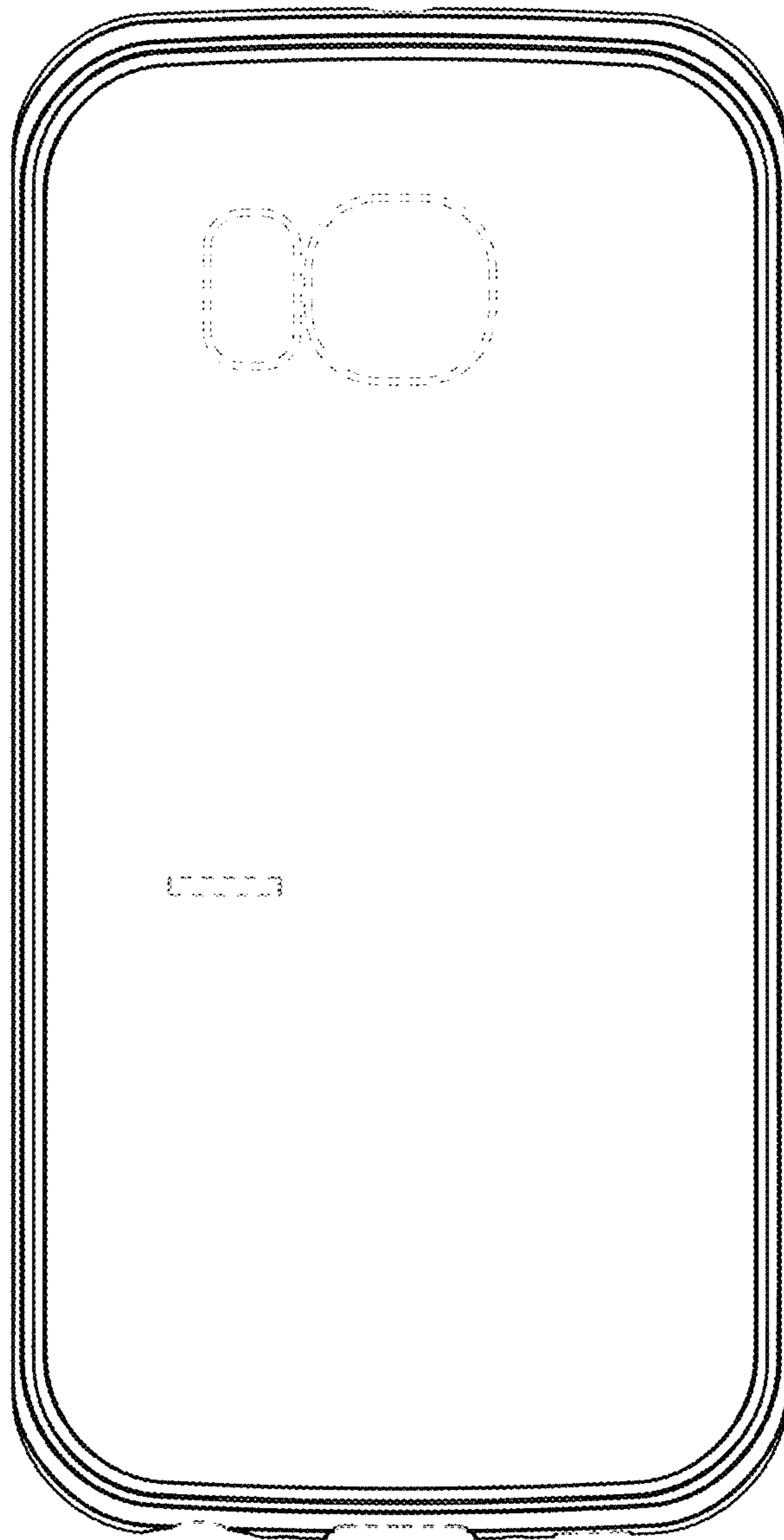

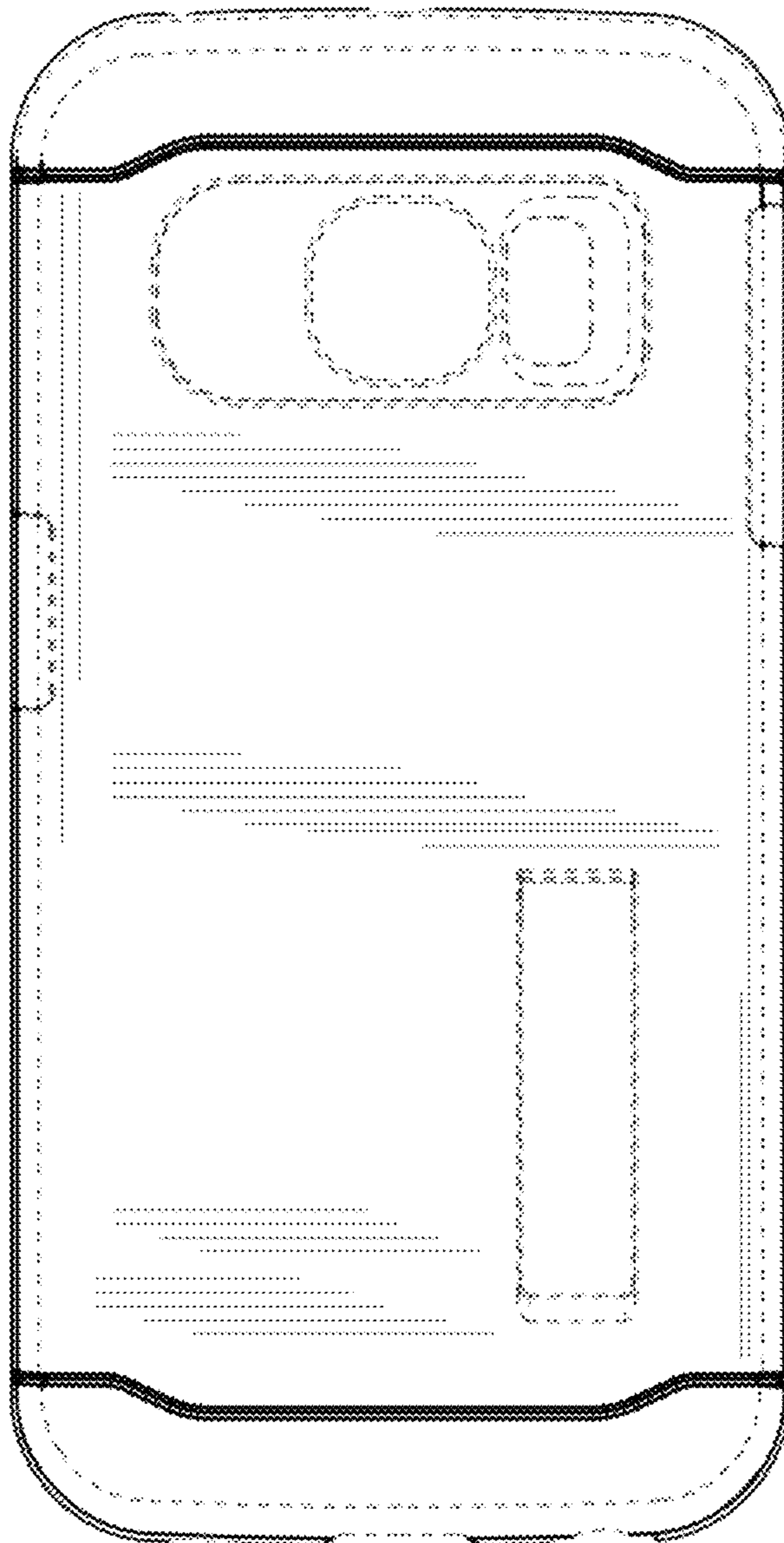

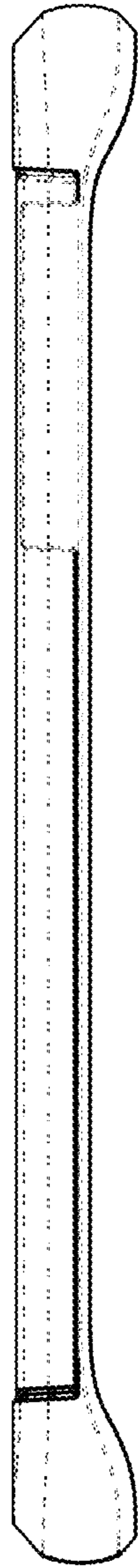

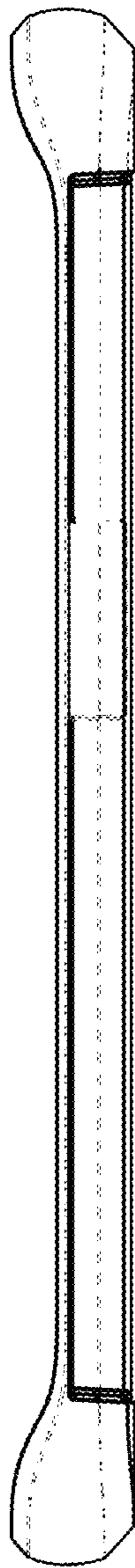

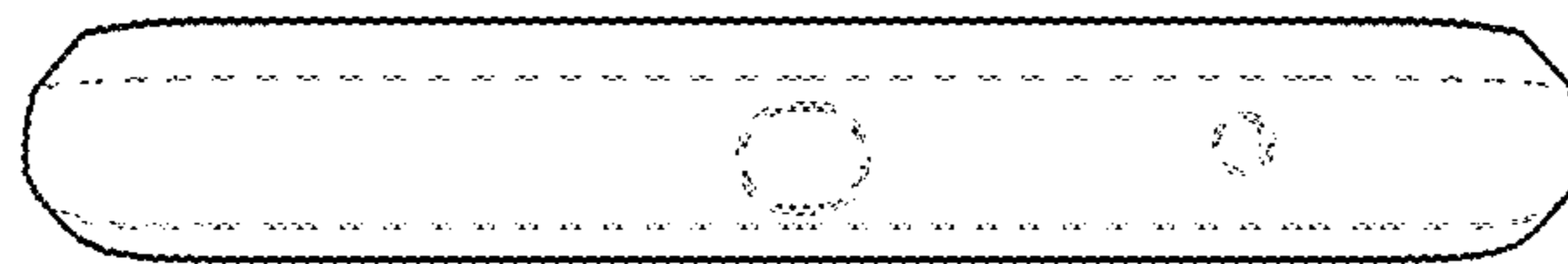

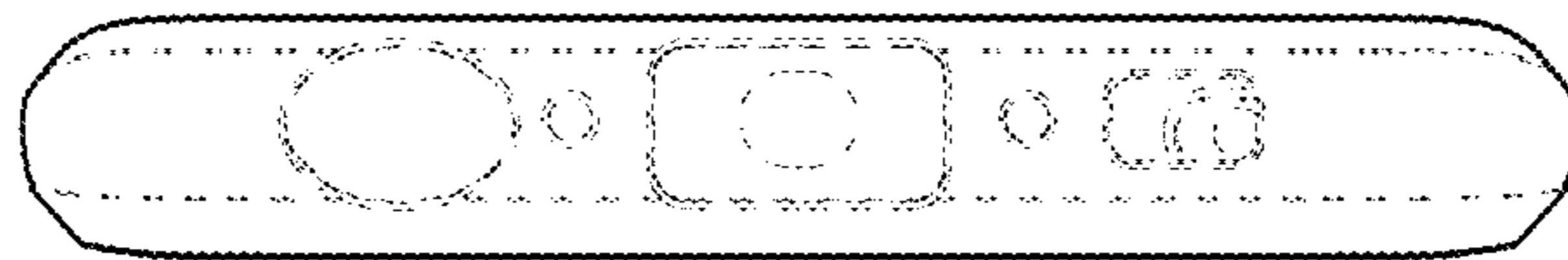

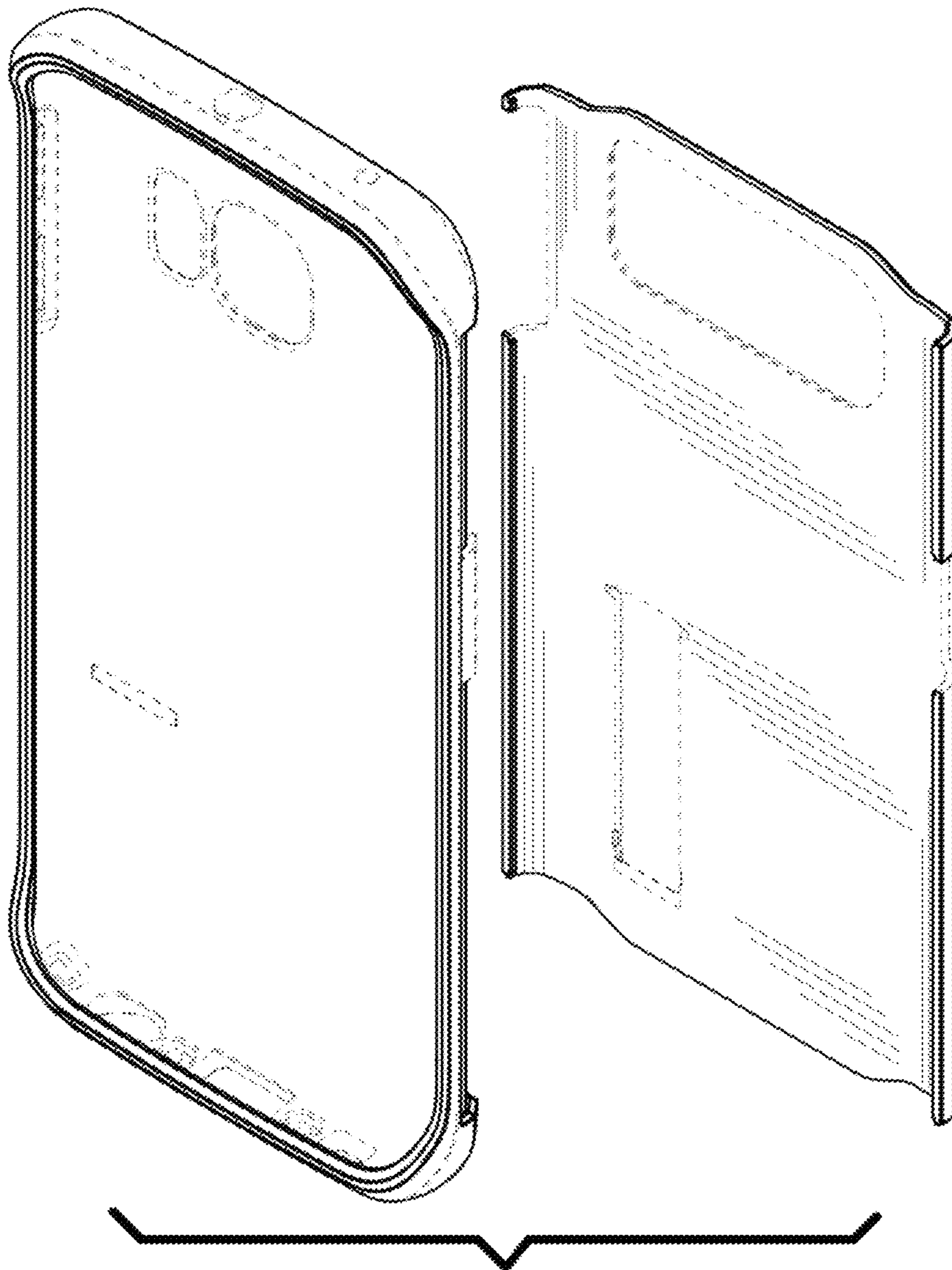

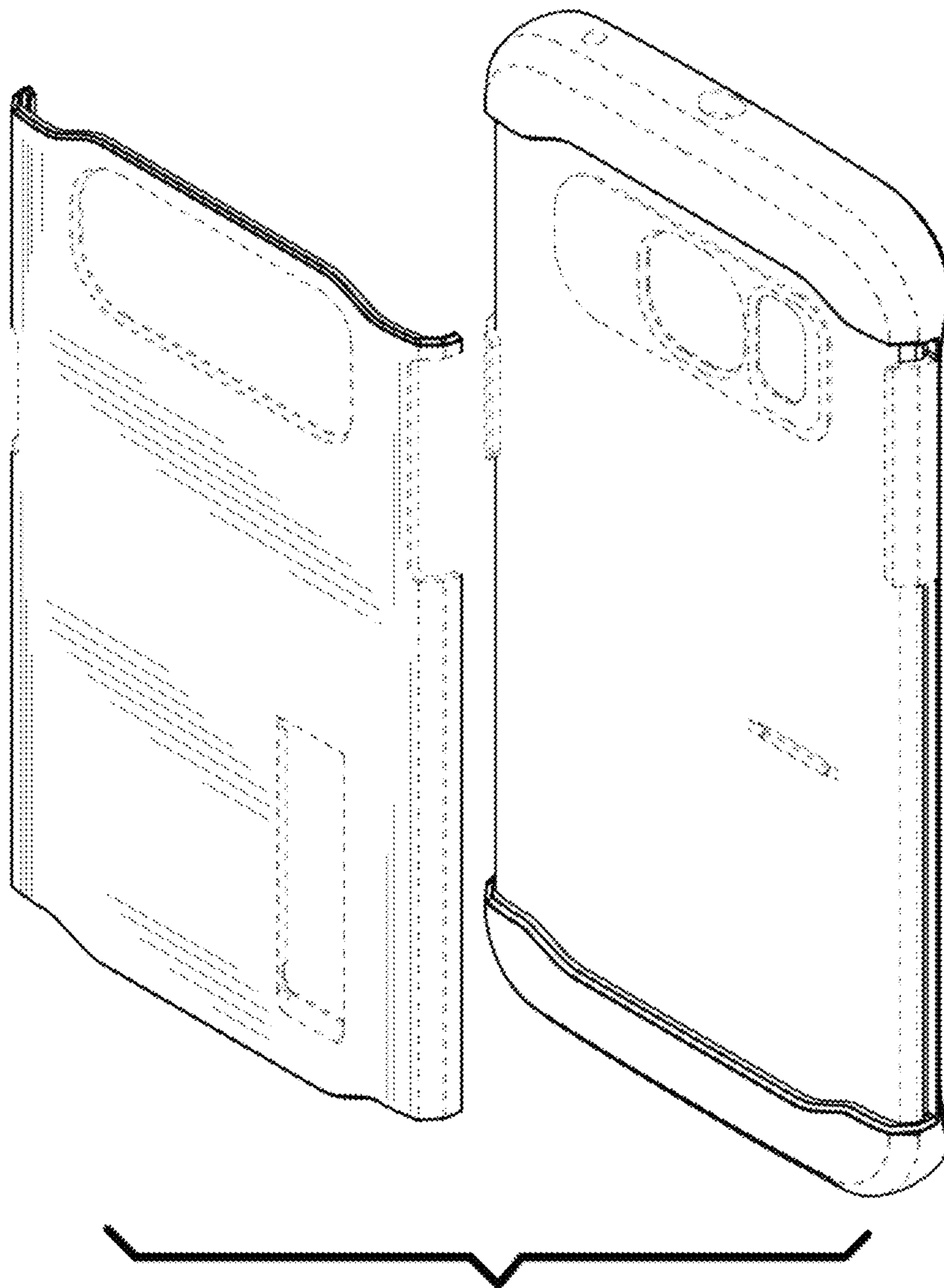

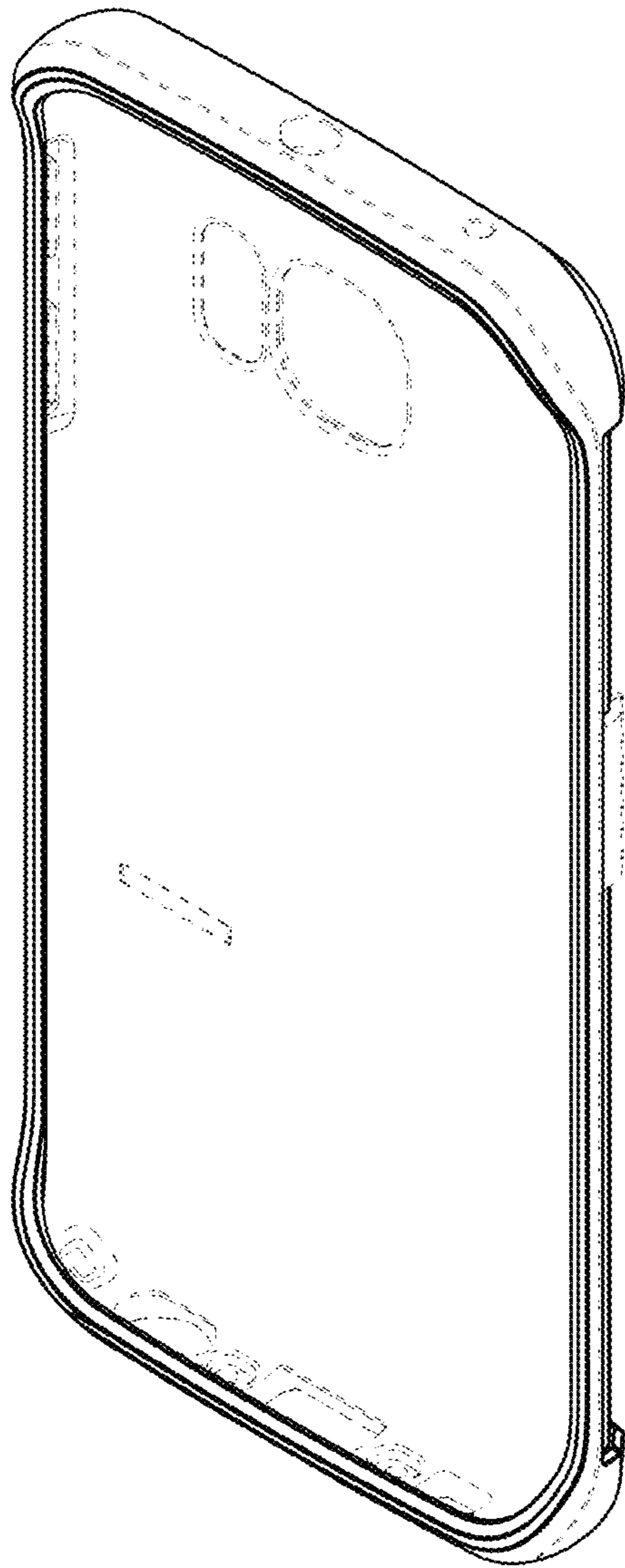

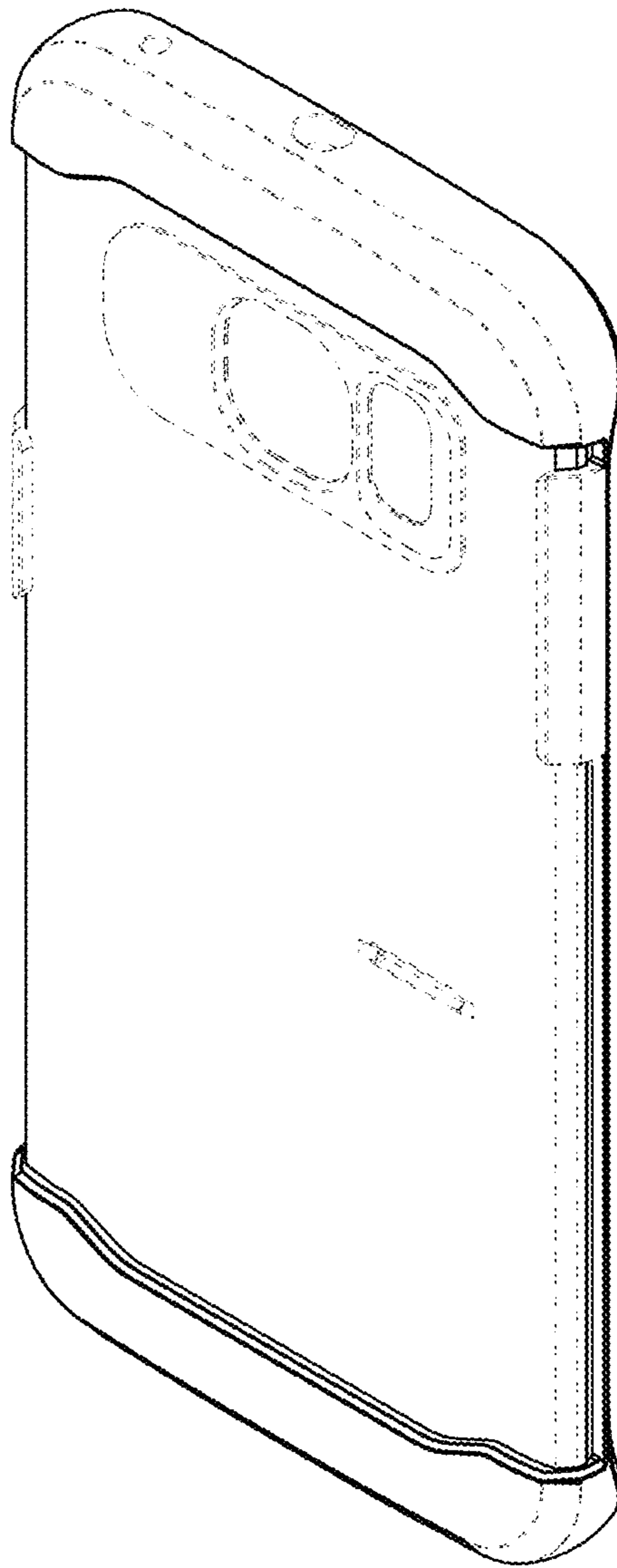

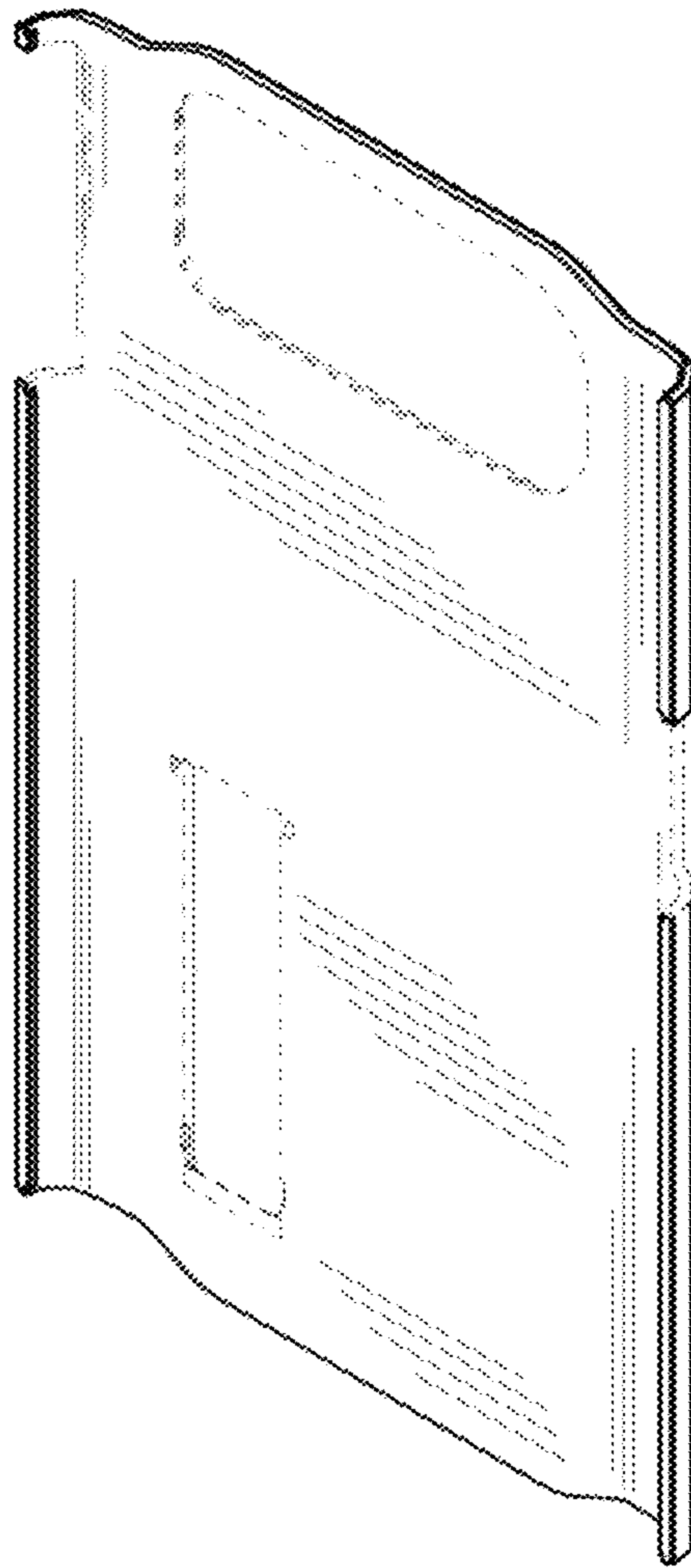
