(57) **CLAIM**

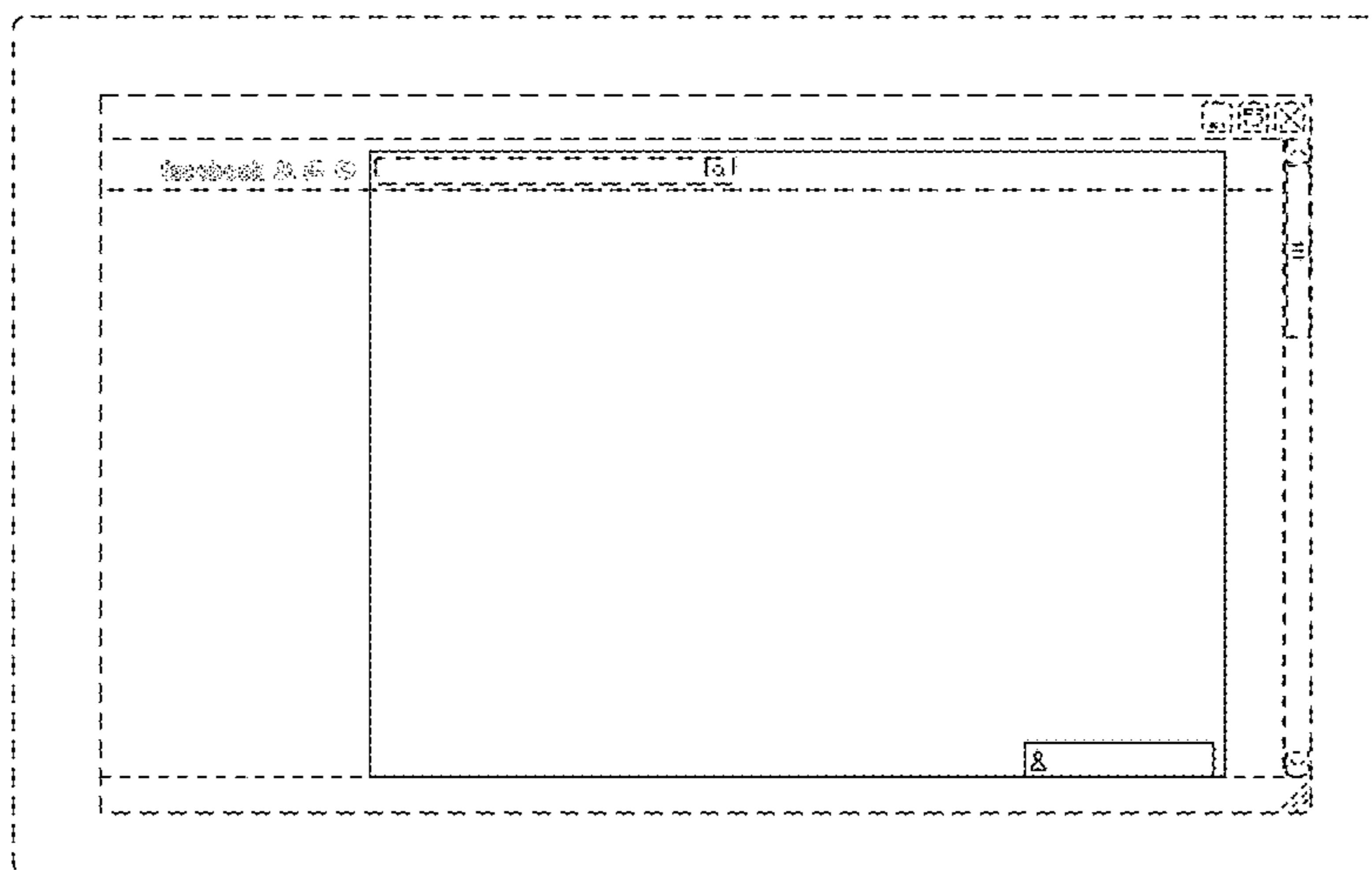
We claim the ornamental design for a display panel of a programmed computer system with a graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display panel of a programmed computer system with a graphical user interface; and, FIG. 2 is a front view of a portion thereof, on an enlarged scale, for ease of illustration.

The broken line showing a display panel and graphical user interface is included for the purpose of illustrating environmental structure; the broken lines form no part of the claimed design.

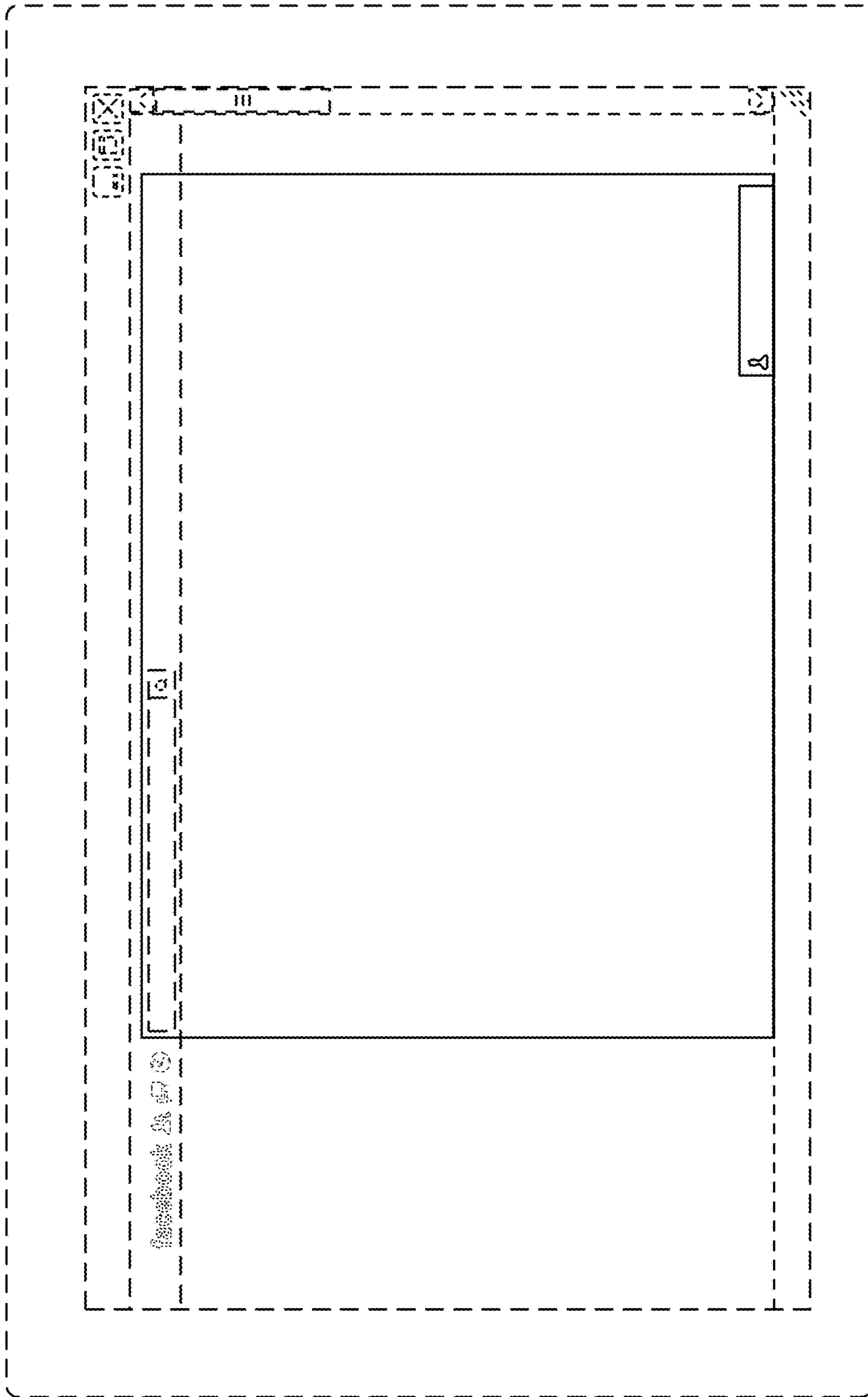

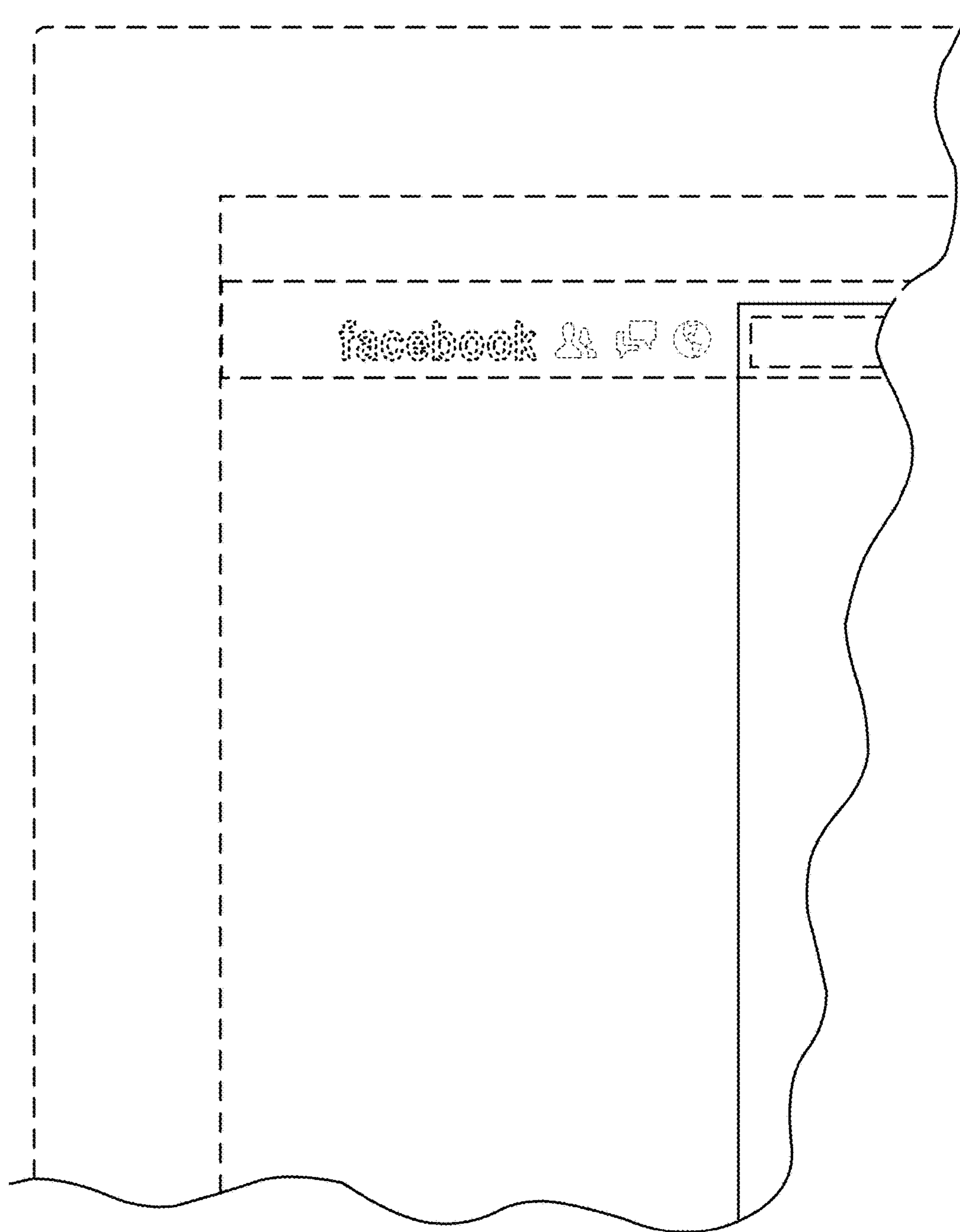
