DESCRIPTION

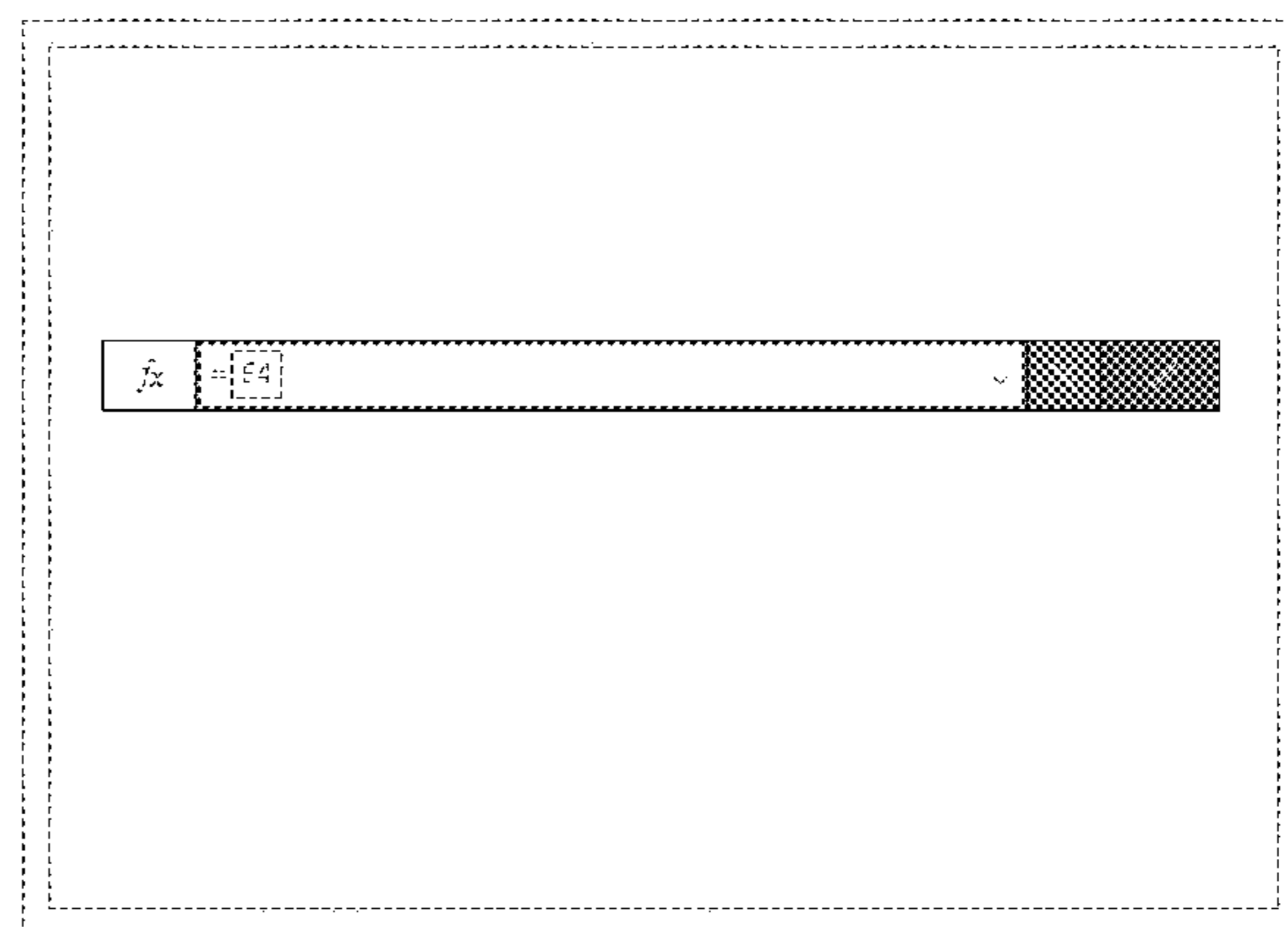
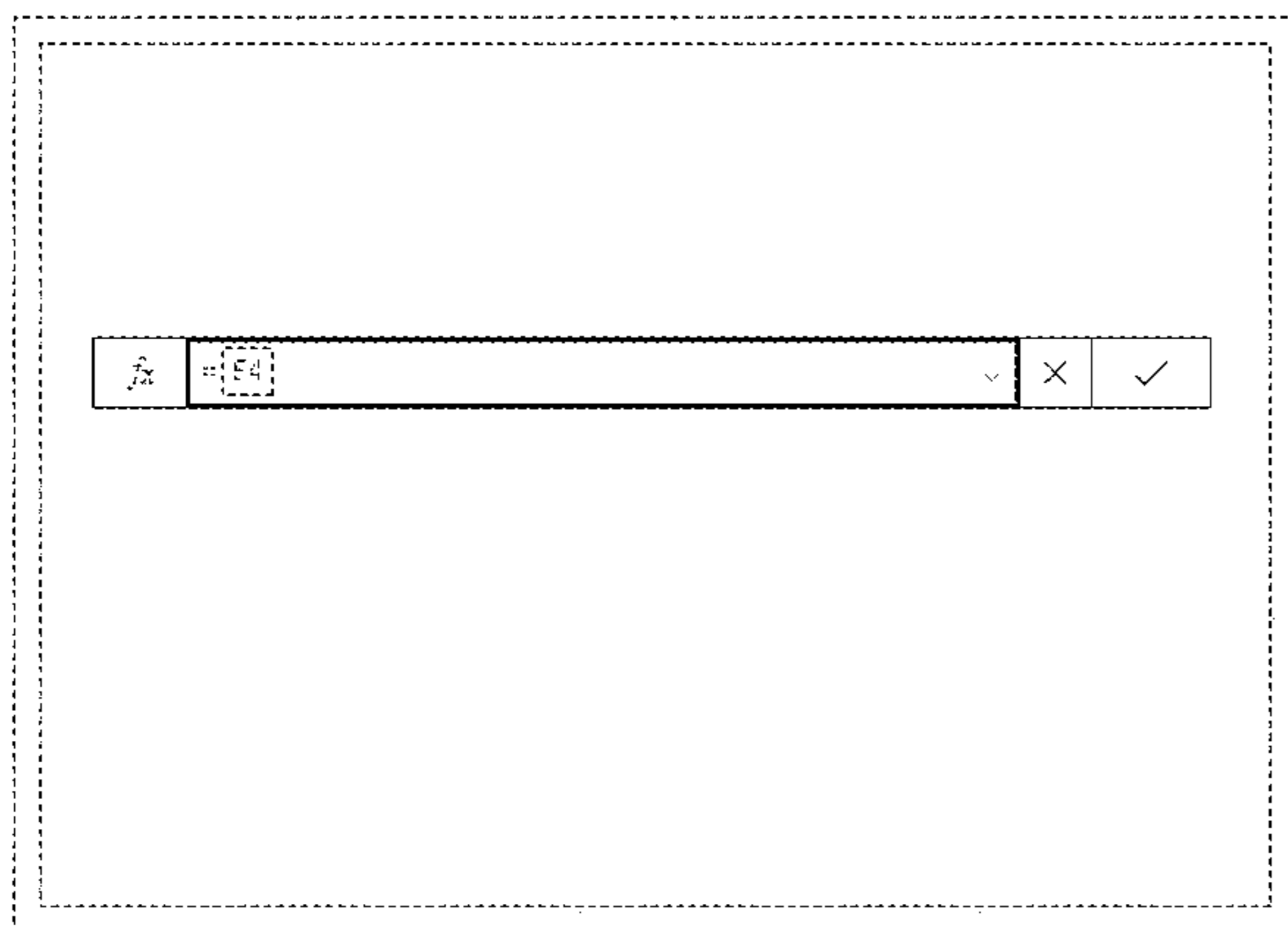

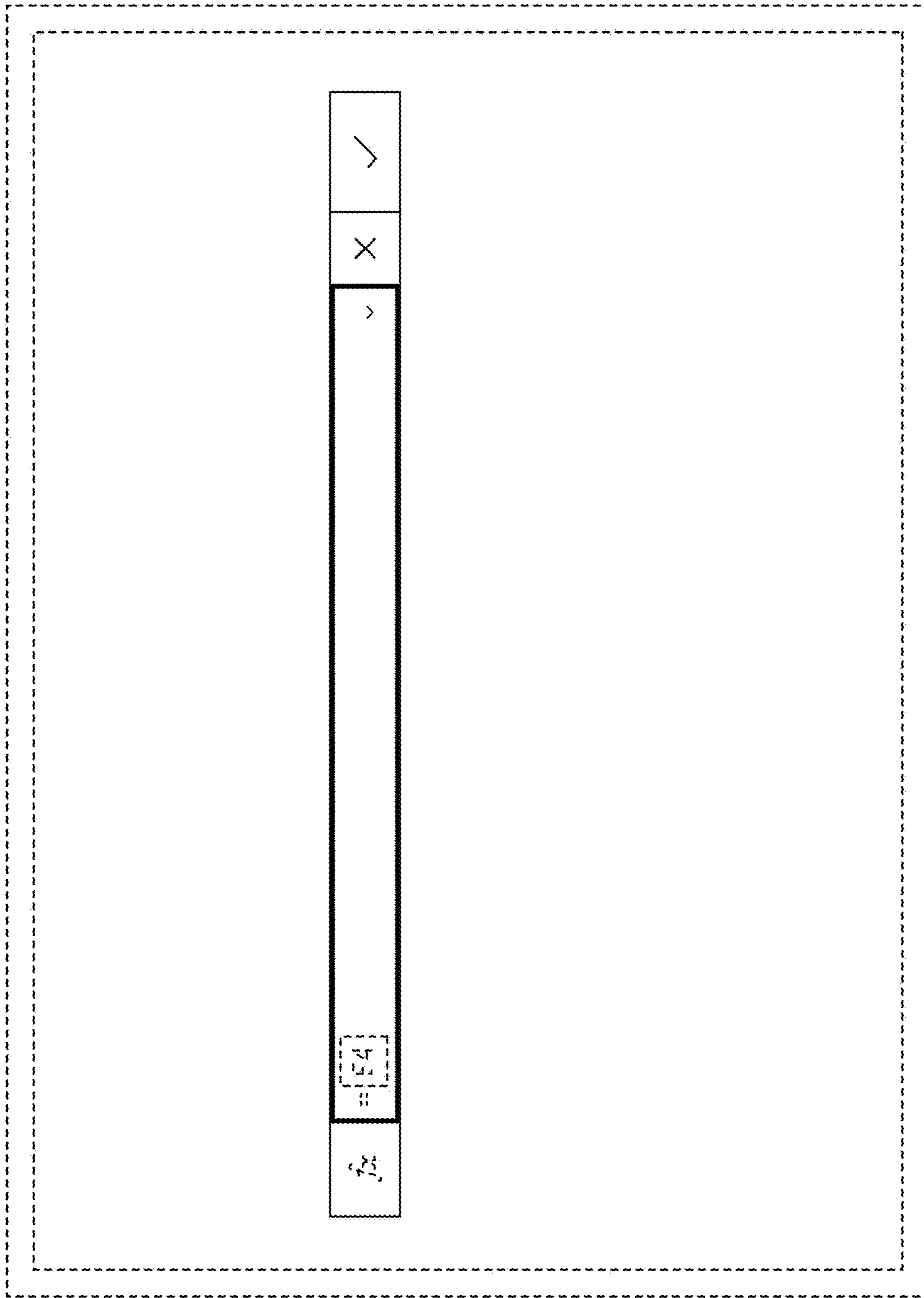

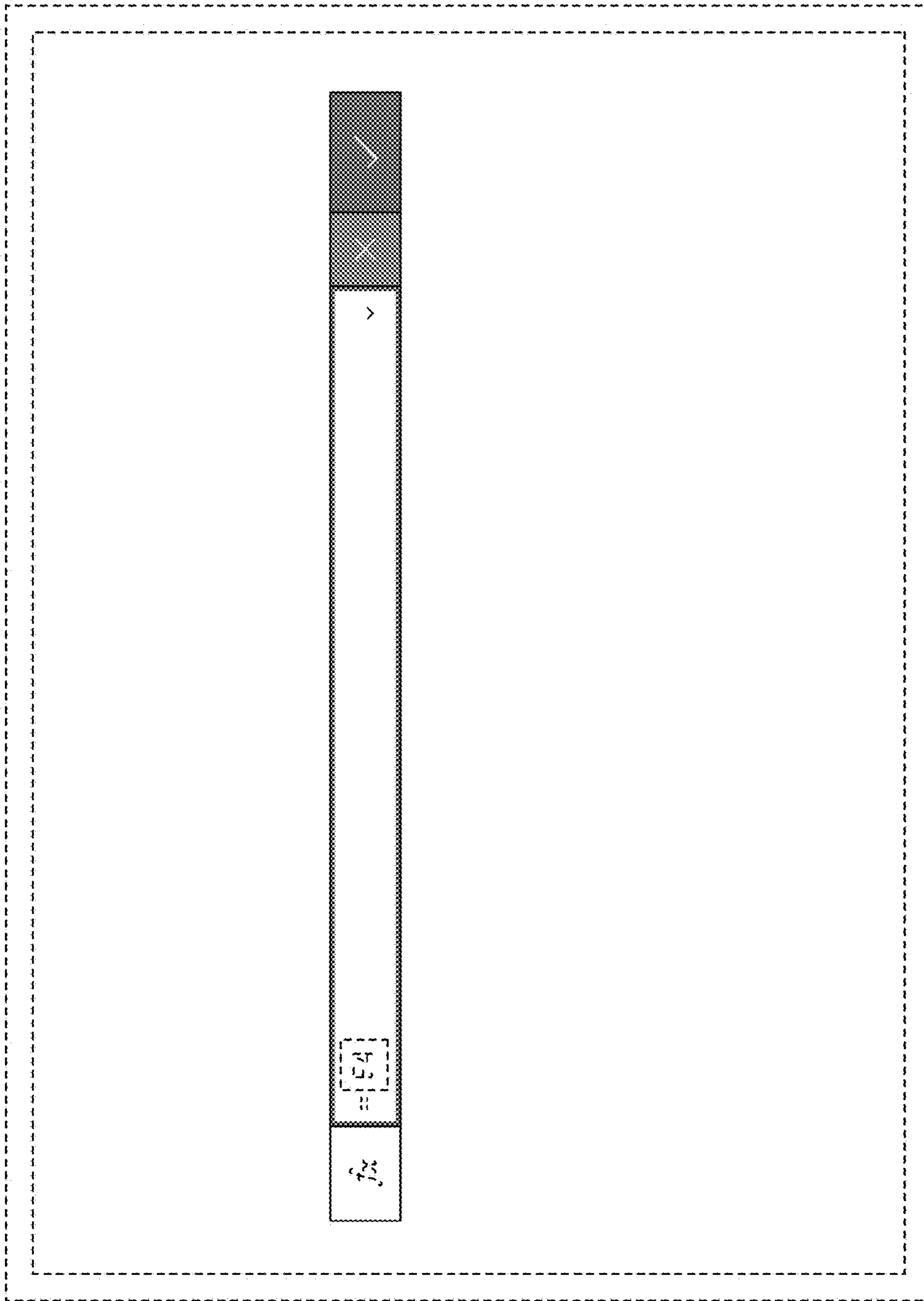
