(57) **CLAIM**

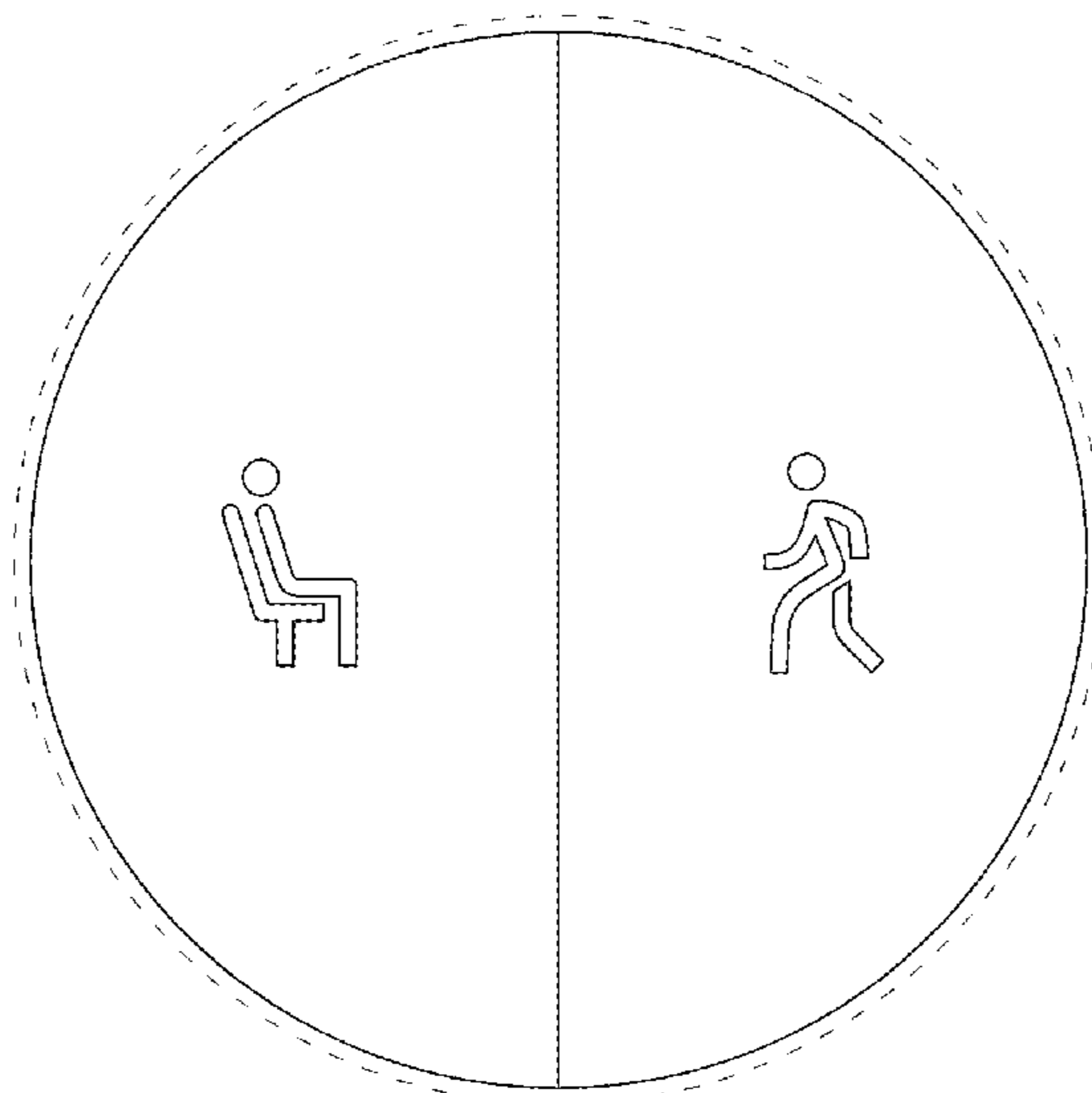
We claim, the ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.
