**DESCRIPTION**

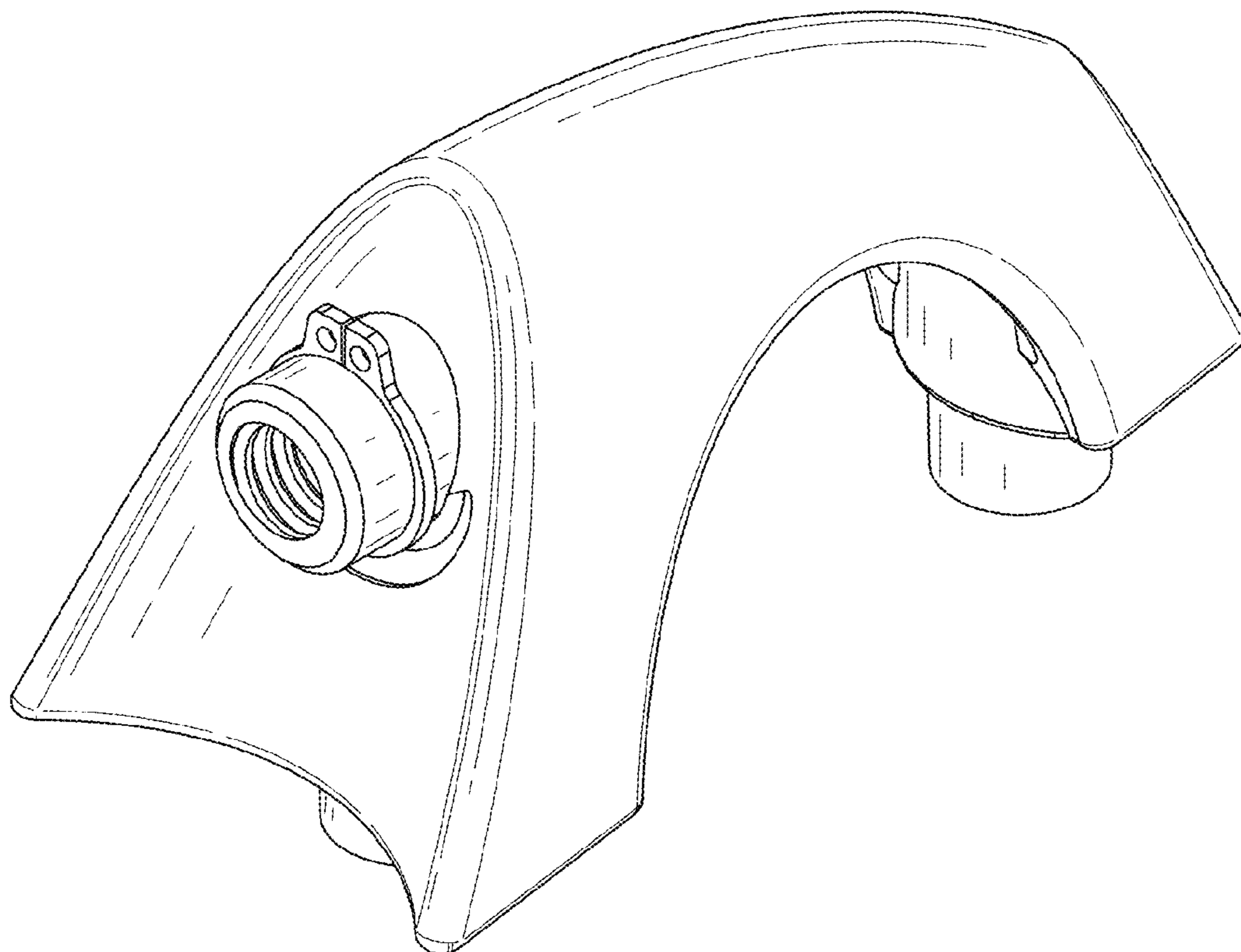
FIG. 1 is a perspective view of a drum tensioner showing my new design;

FIG. 8 is the opposing side view thereof.

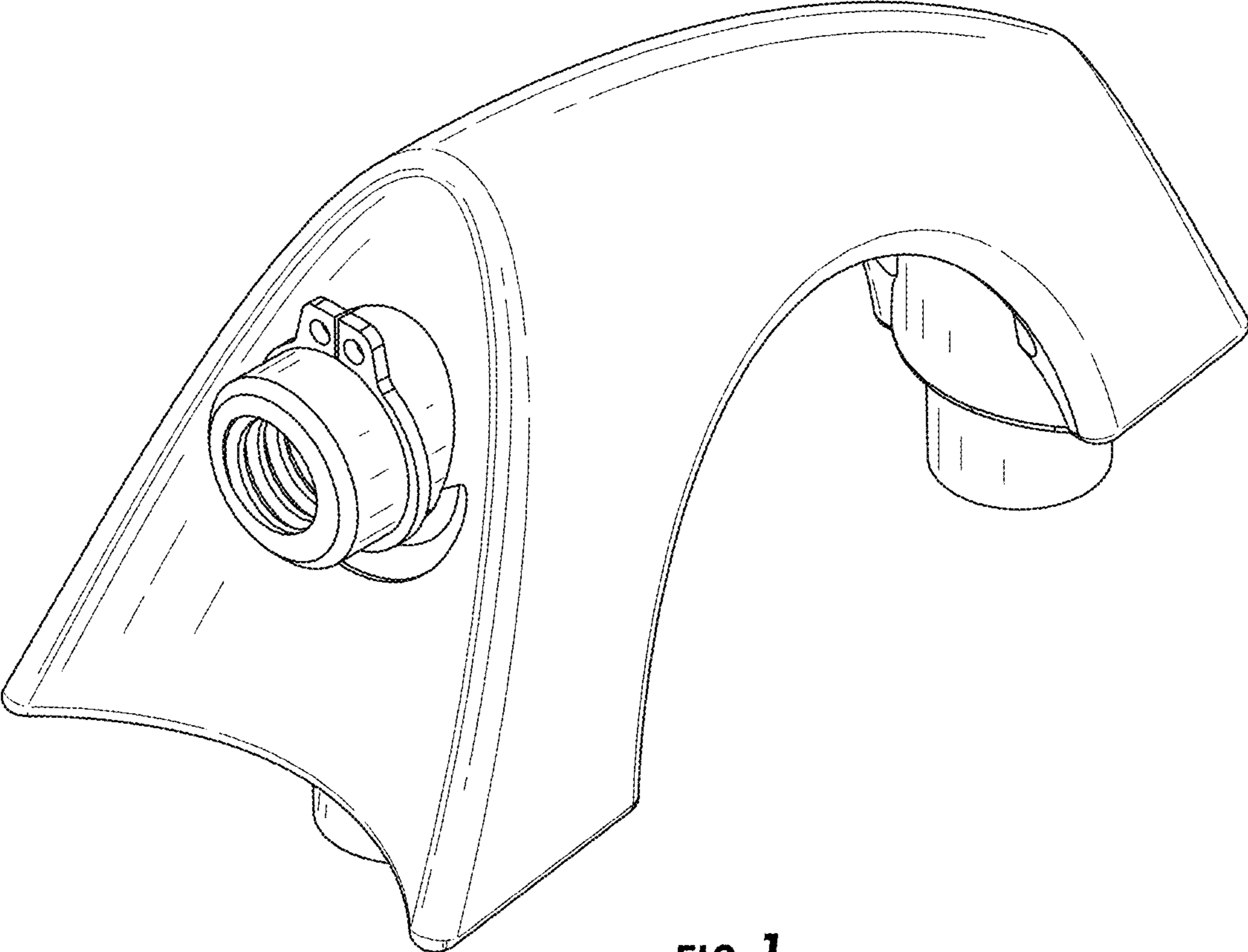

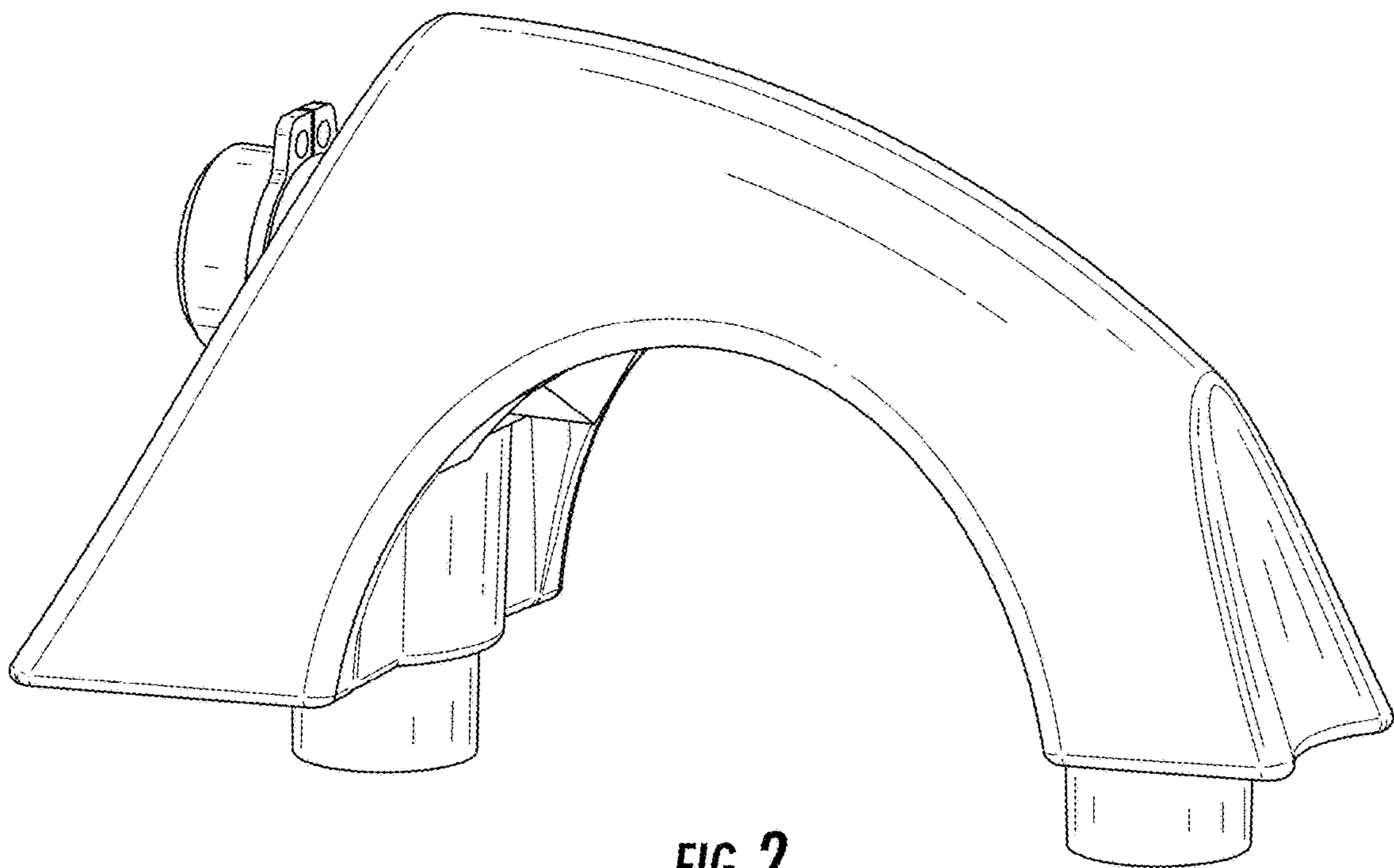
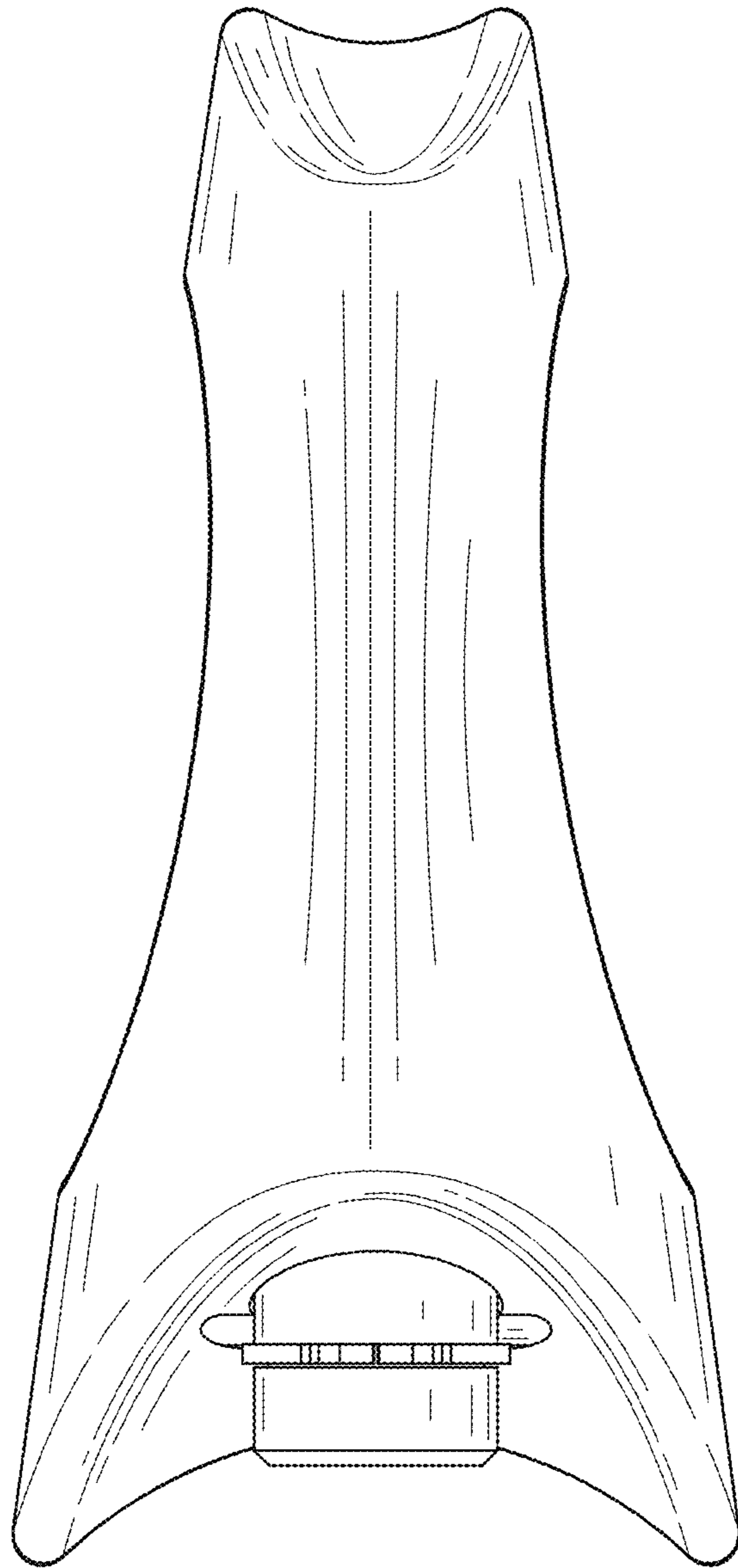

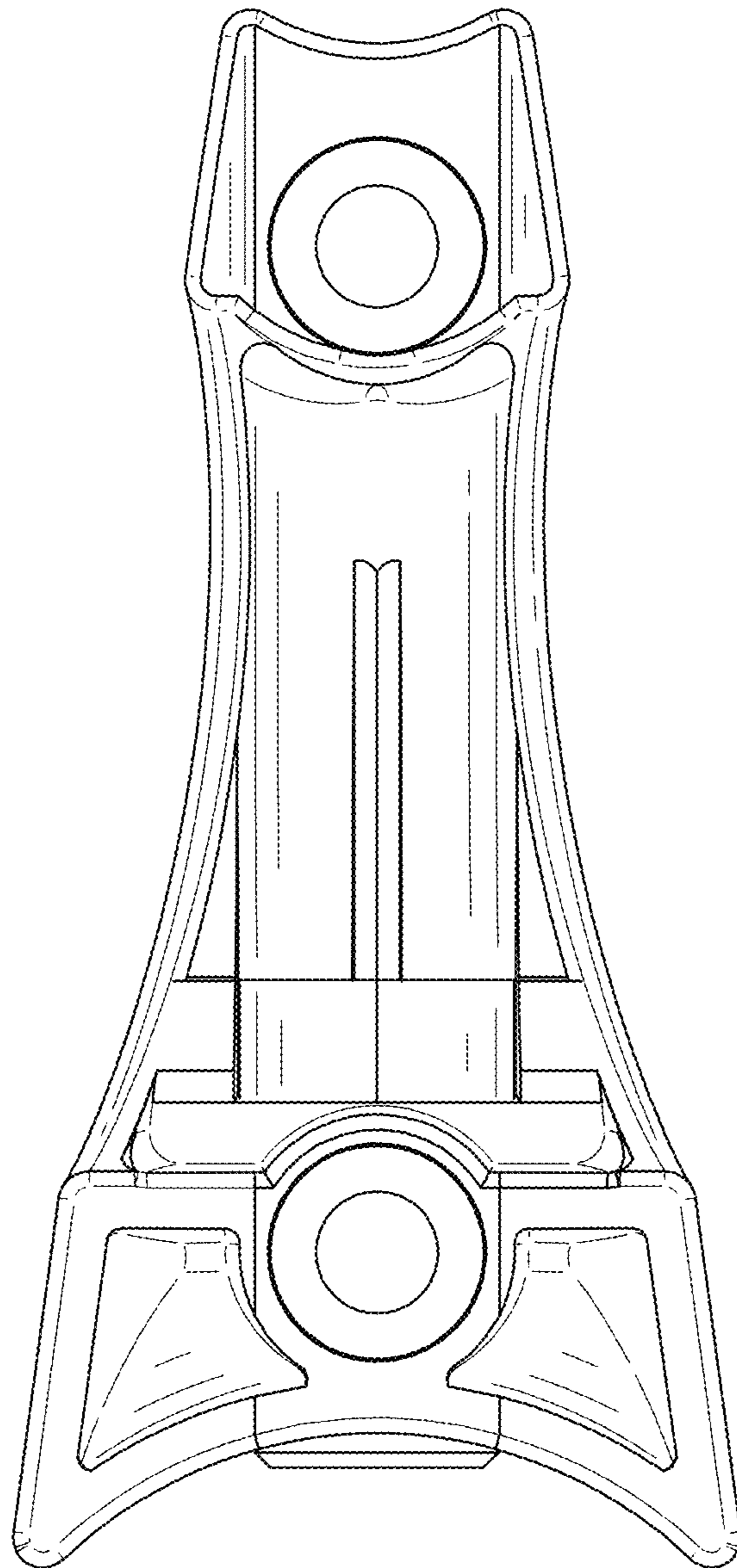
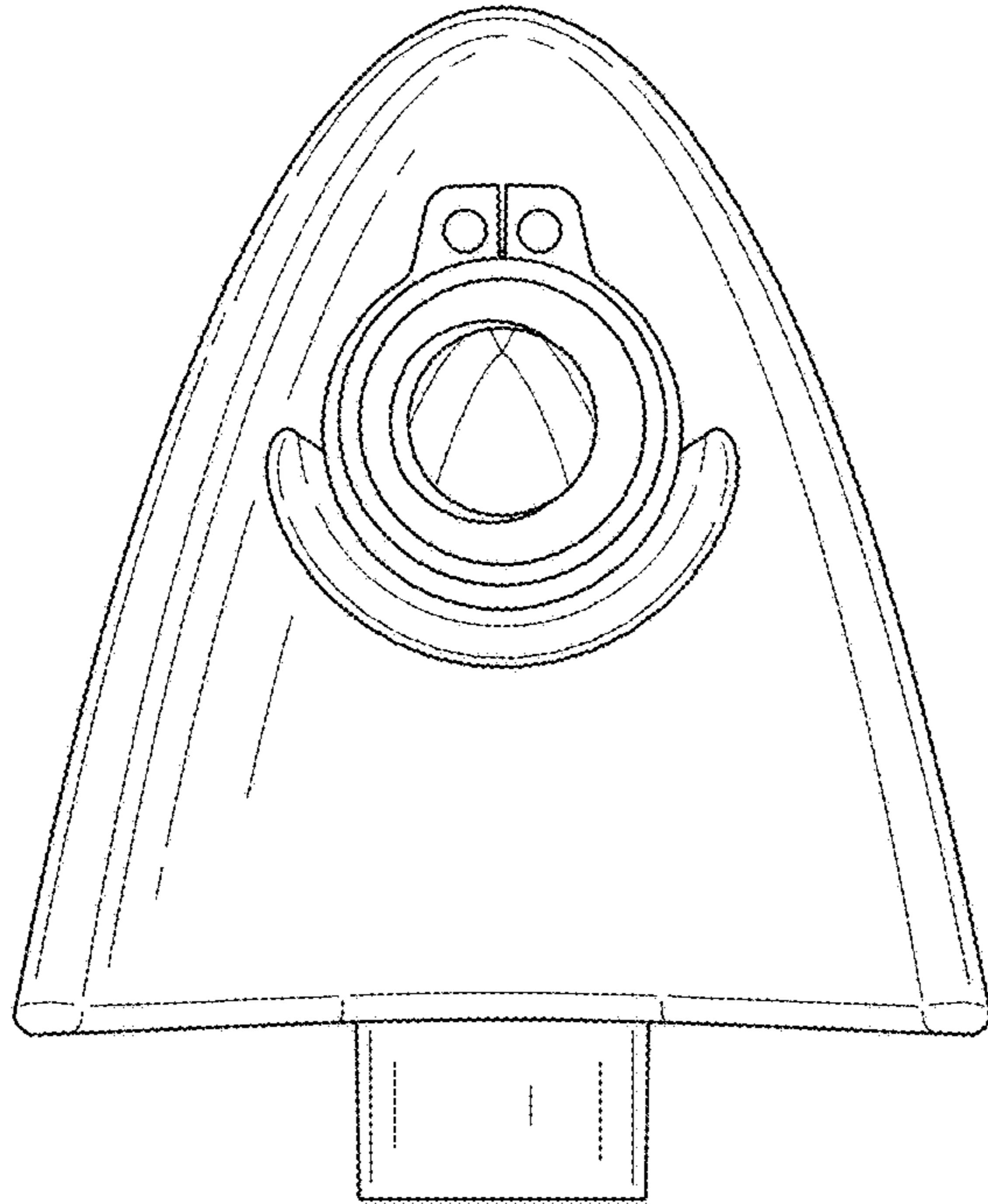
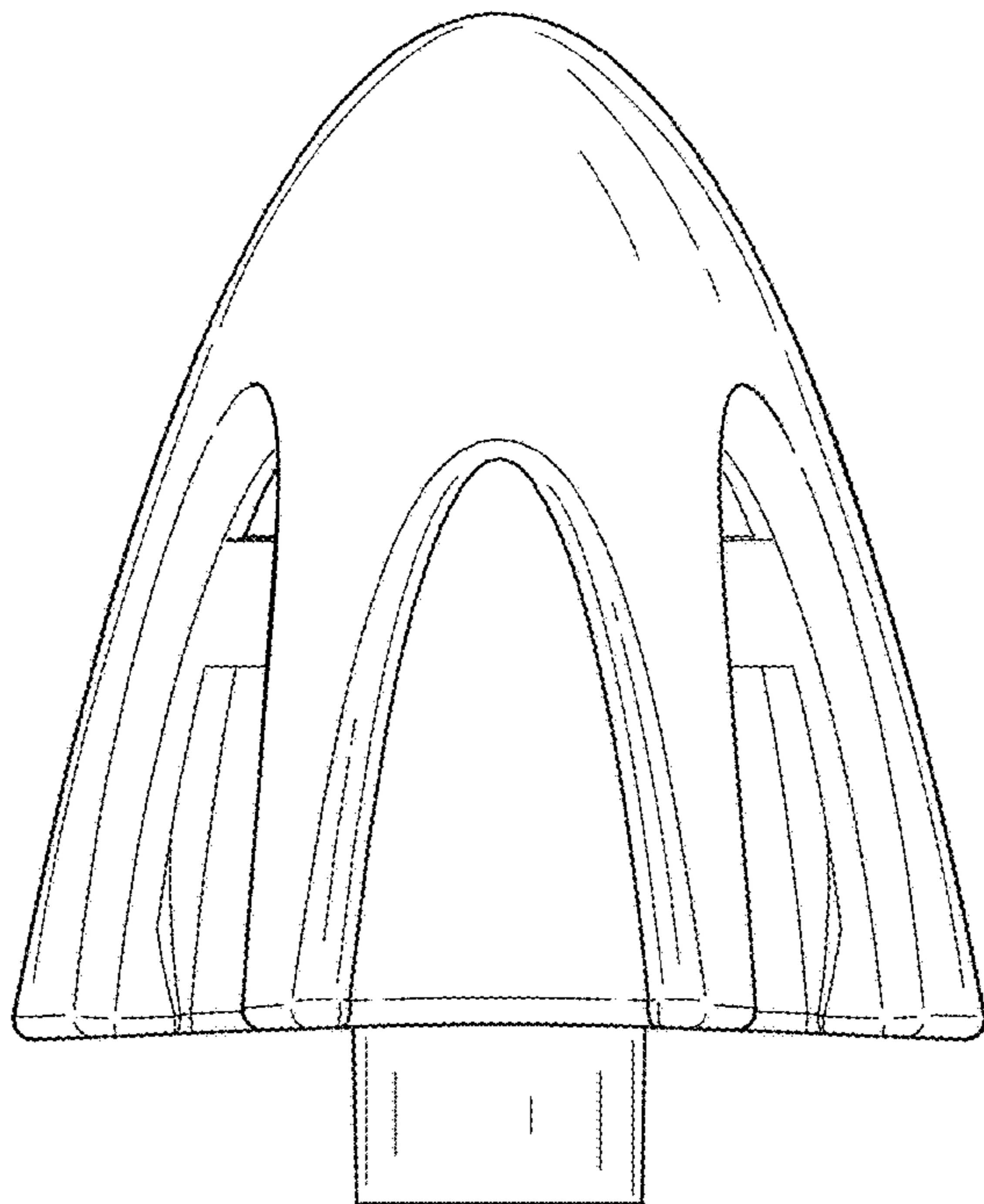


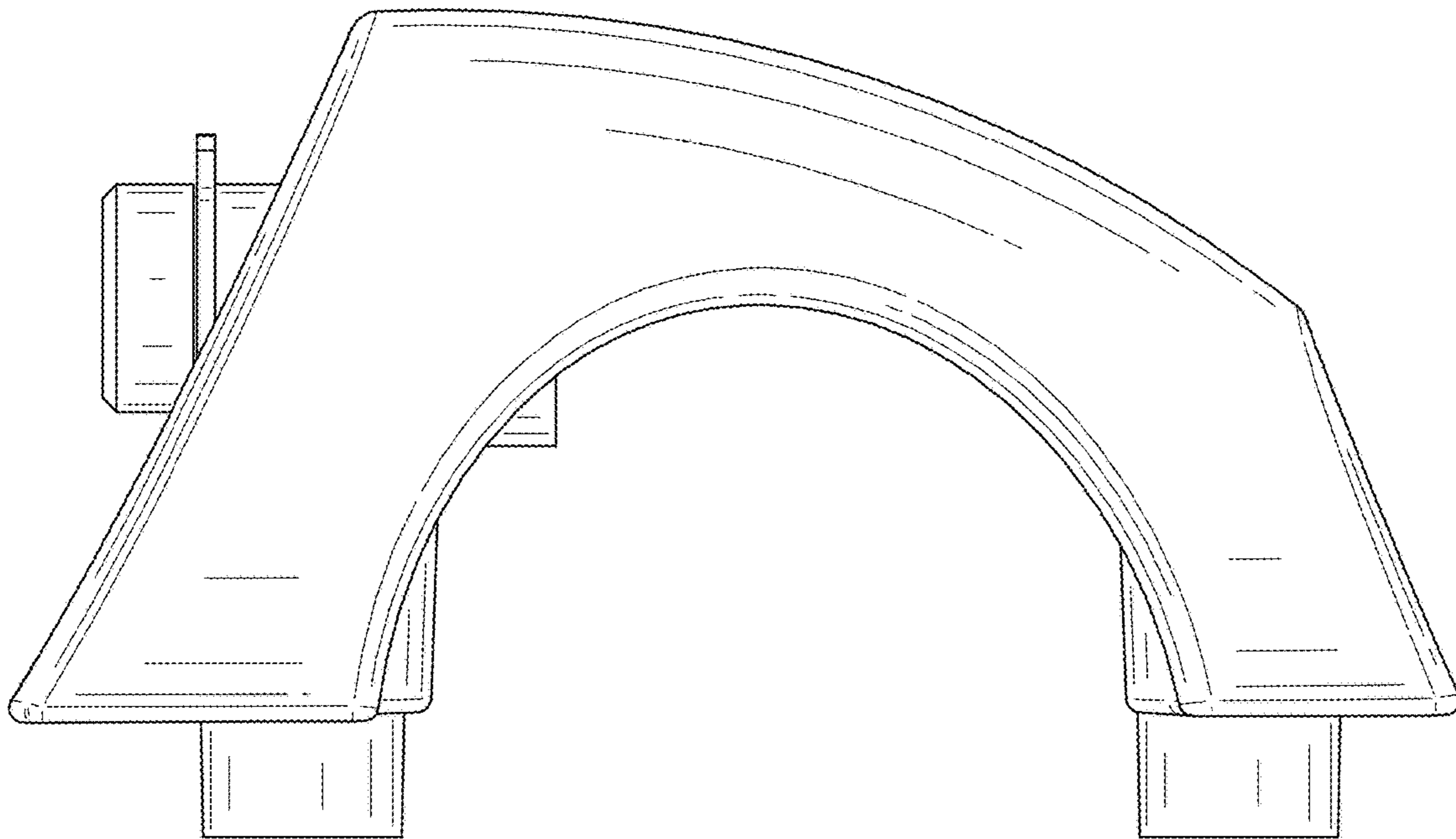

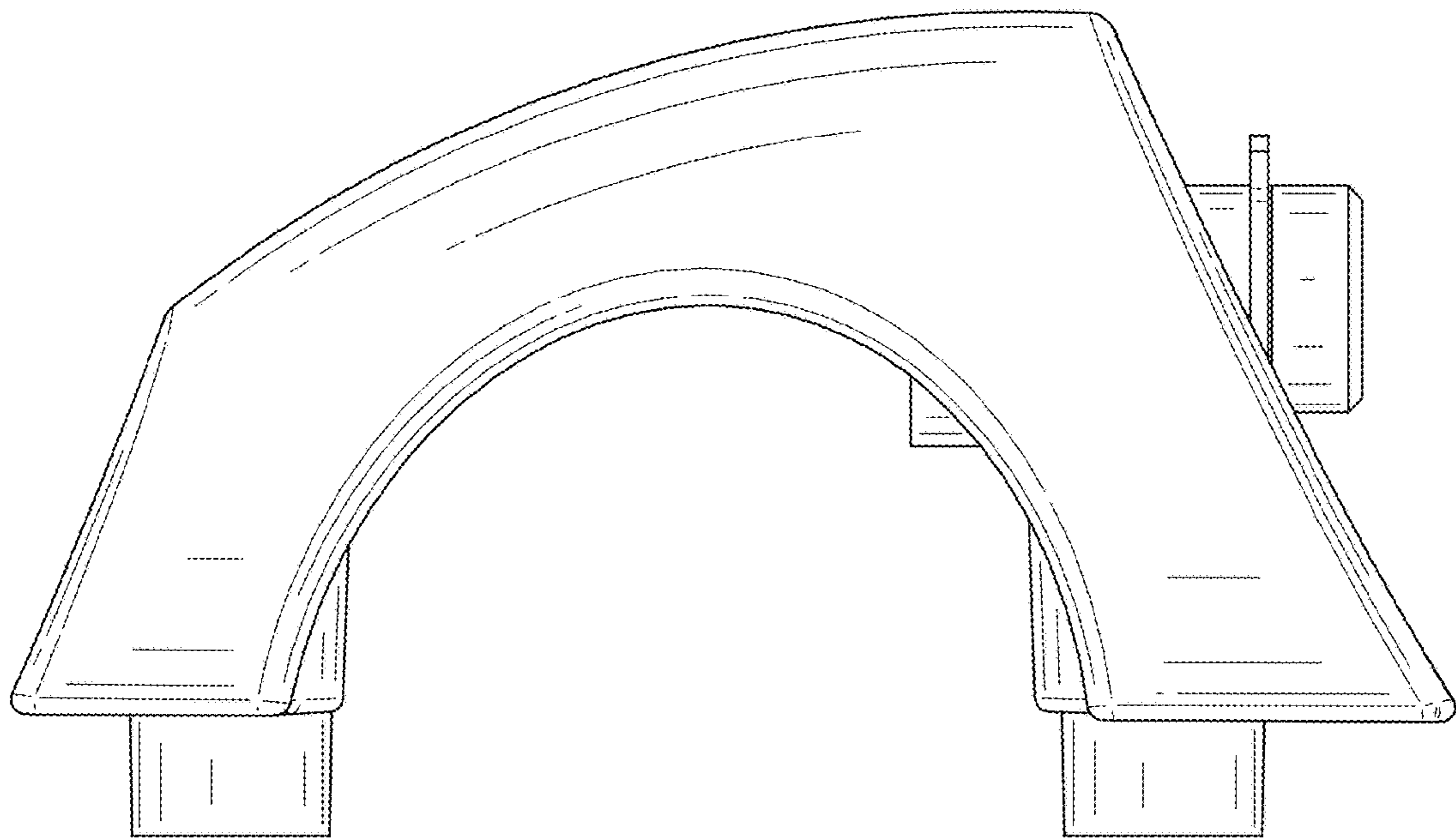
