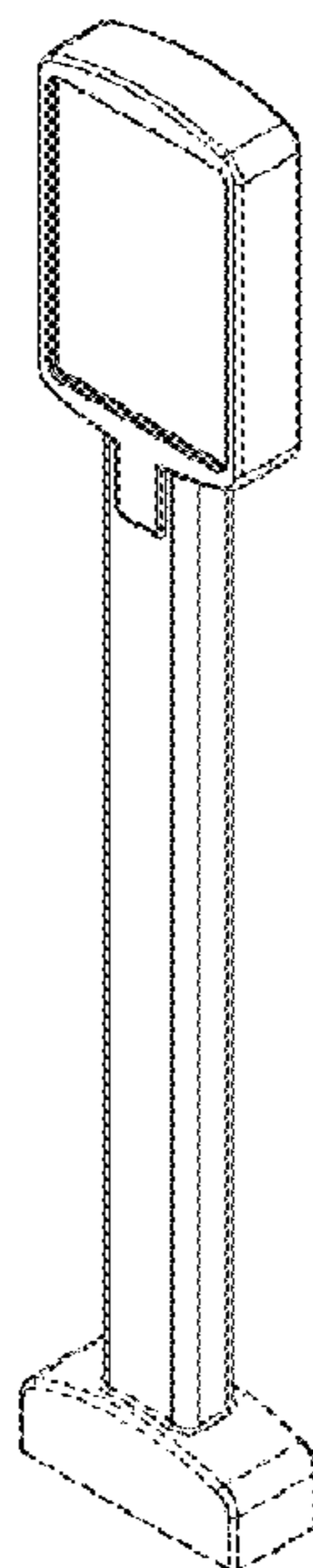
(57) **CLAIM**  
The ornamental design for a sign post, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the sign post; FIG. 2 is a front view of the sign post of FIG. 1, the rear view is a mirror image of the front view; FIG. 3 is a right side view of the sign post of FIG. 1, the left side view is a mirror image of the right side view; and, FIG. 4 is an enlarged top view of the sign post of FIG. 1. The broken line disclosure is for illustrating portions of the sign post that form no part of the claimed design.

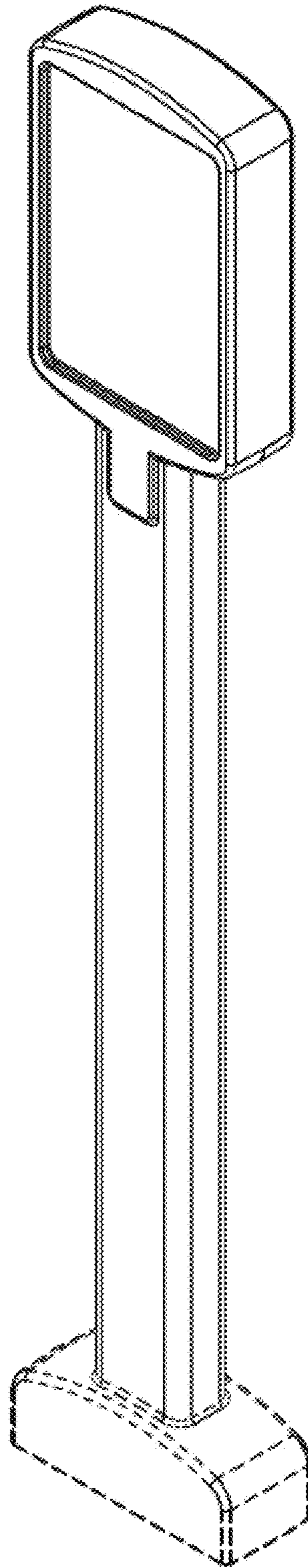

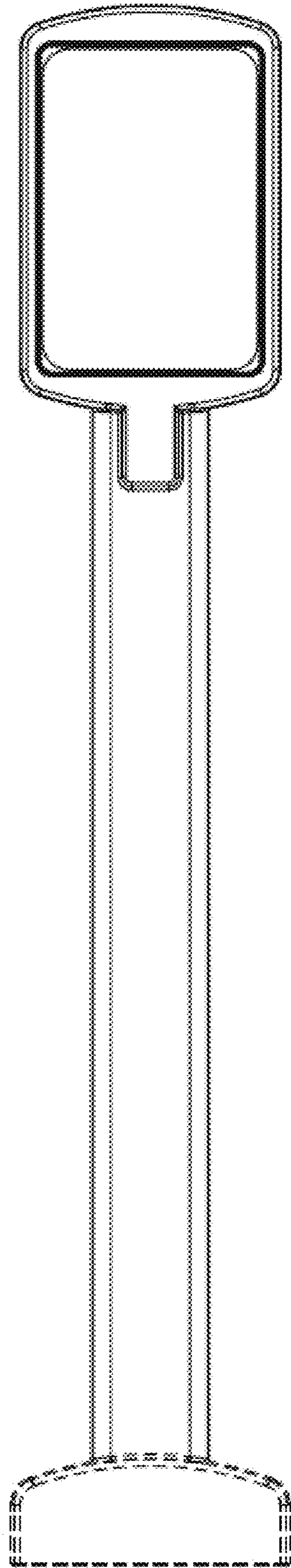

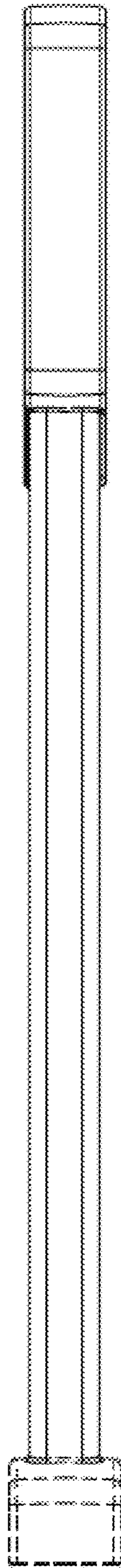

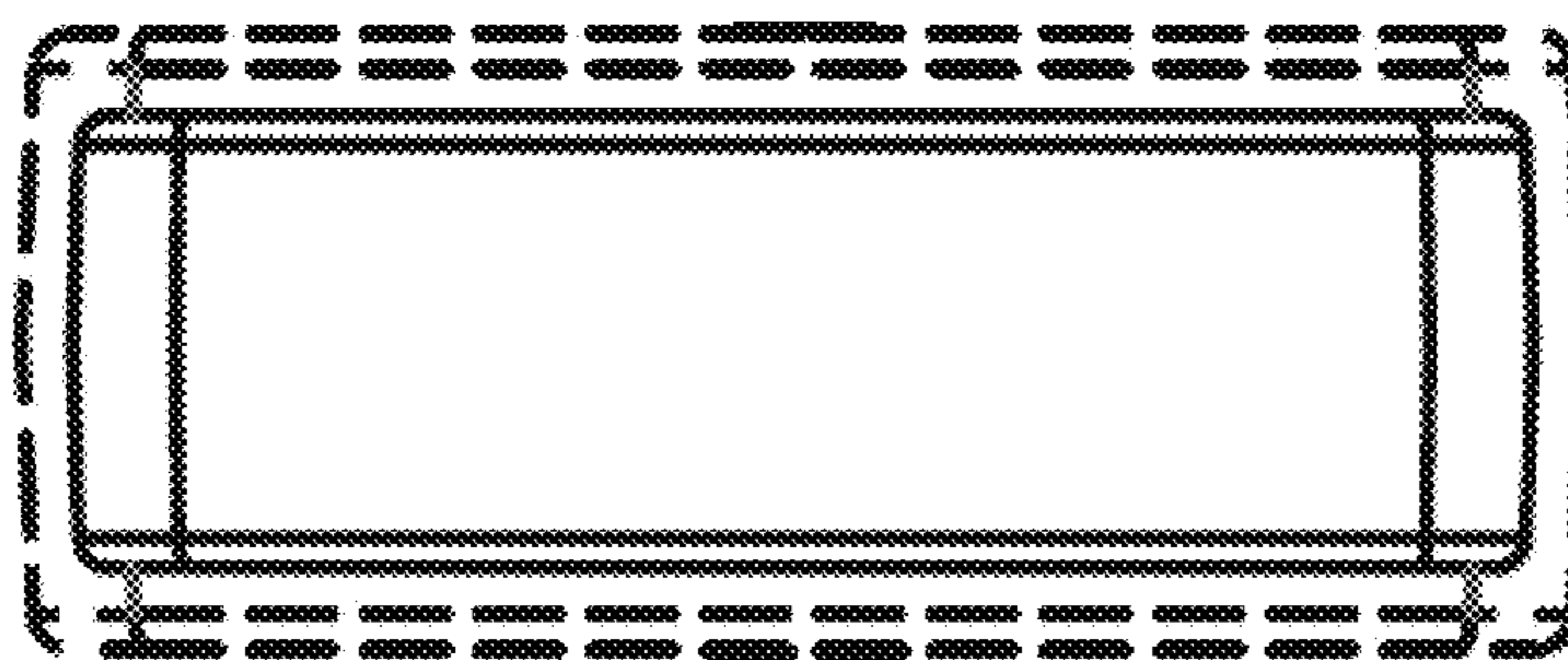
