(57) **CLAIM**

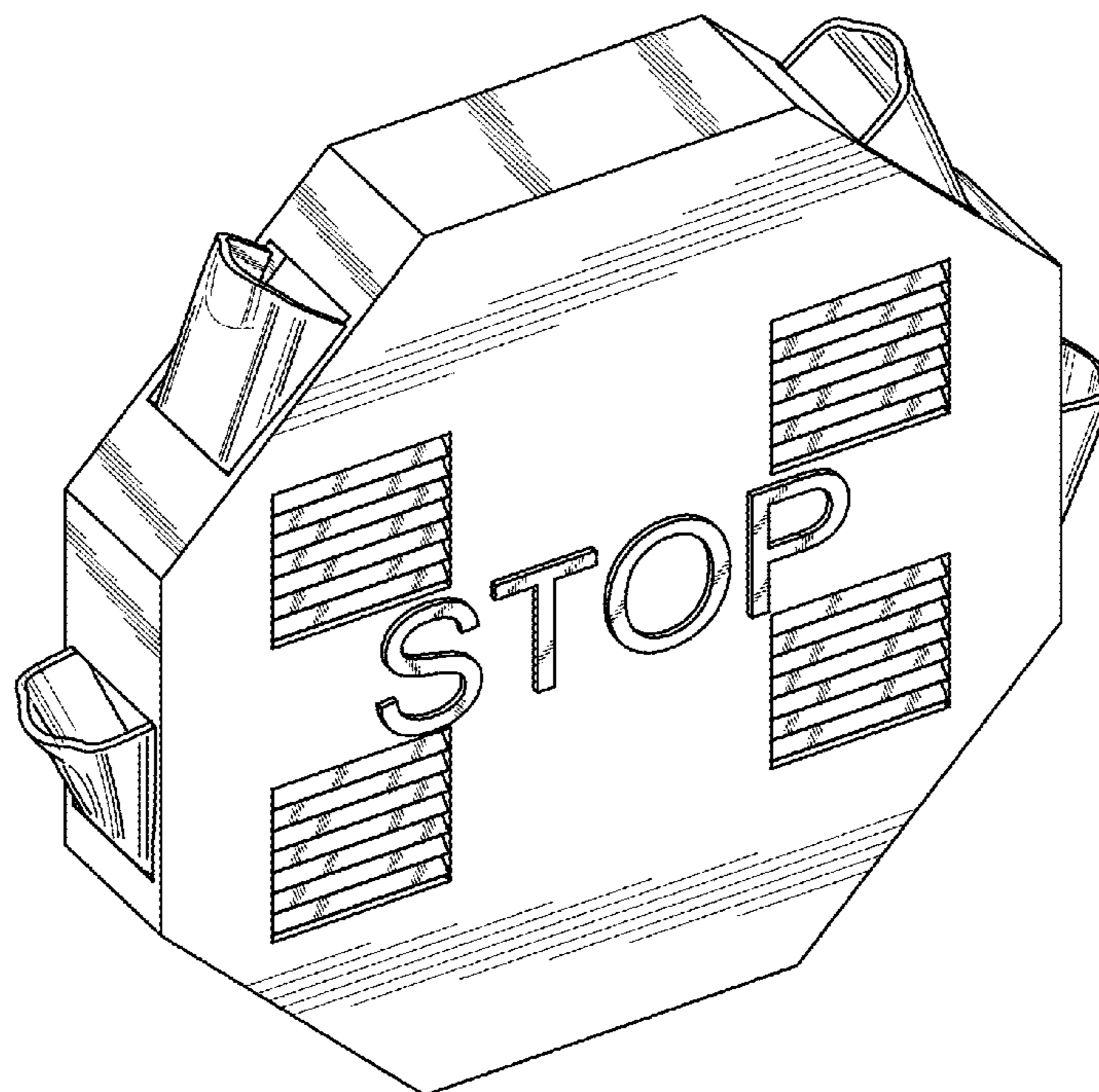
The ornamental design for a combination odor absorber and pest deterrent, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a combination odor absorber and pest deterrent with the doors shown in an open position, showing my new design;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a rear elevation view thereof;  
FIG. 4 is a left side view thereof;  
FIG. 5 is a right side view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof; and,

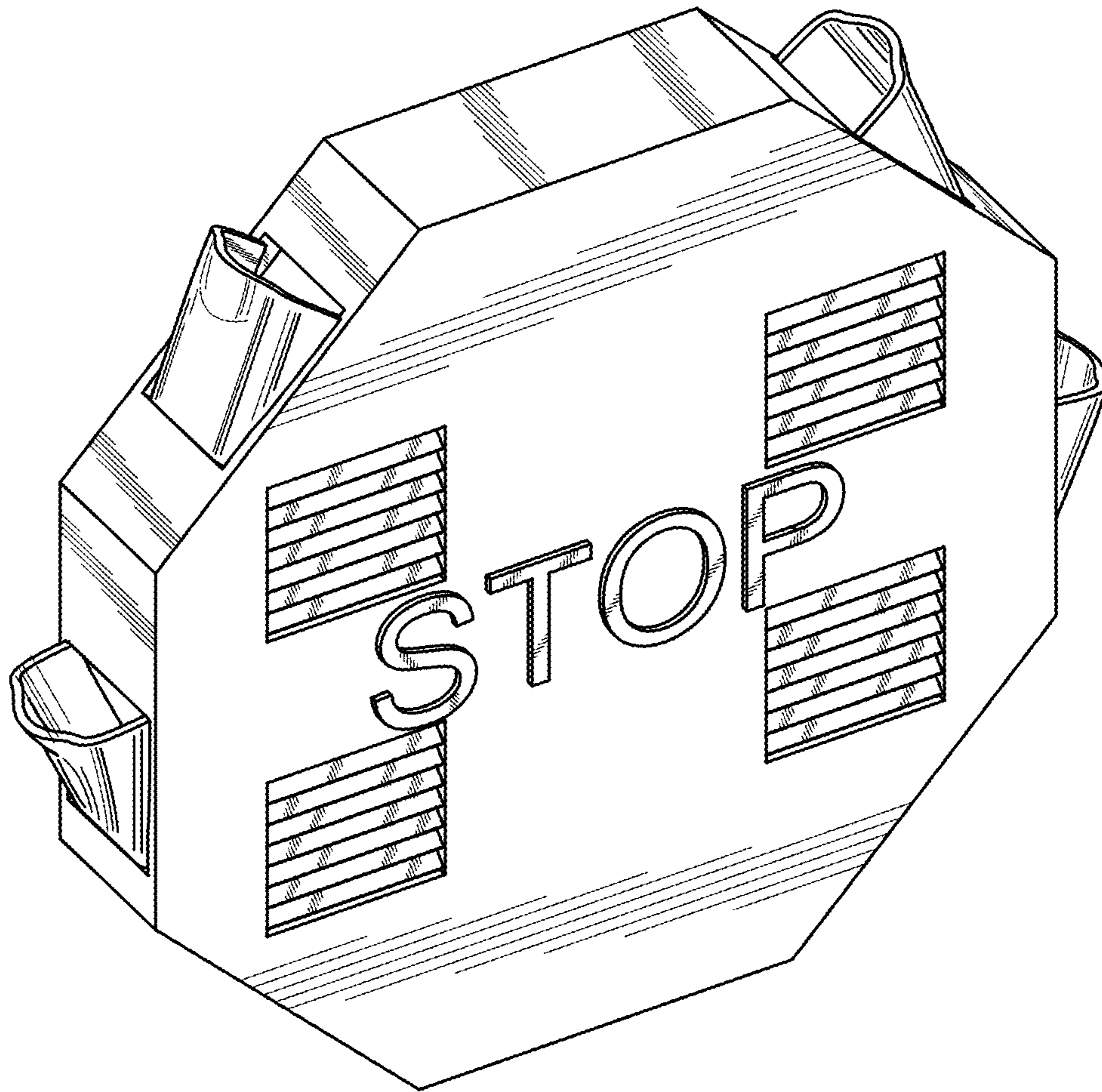

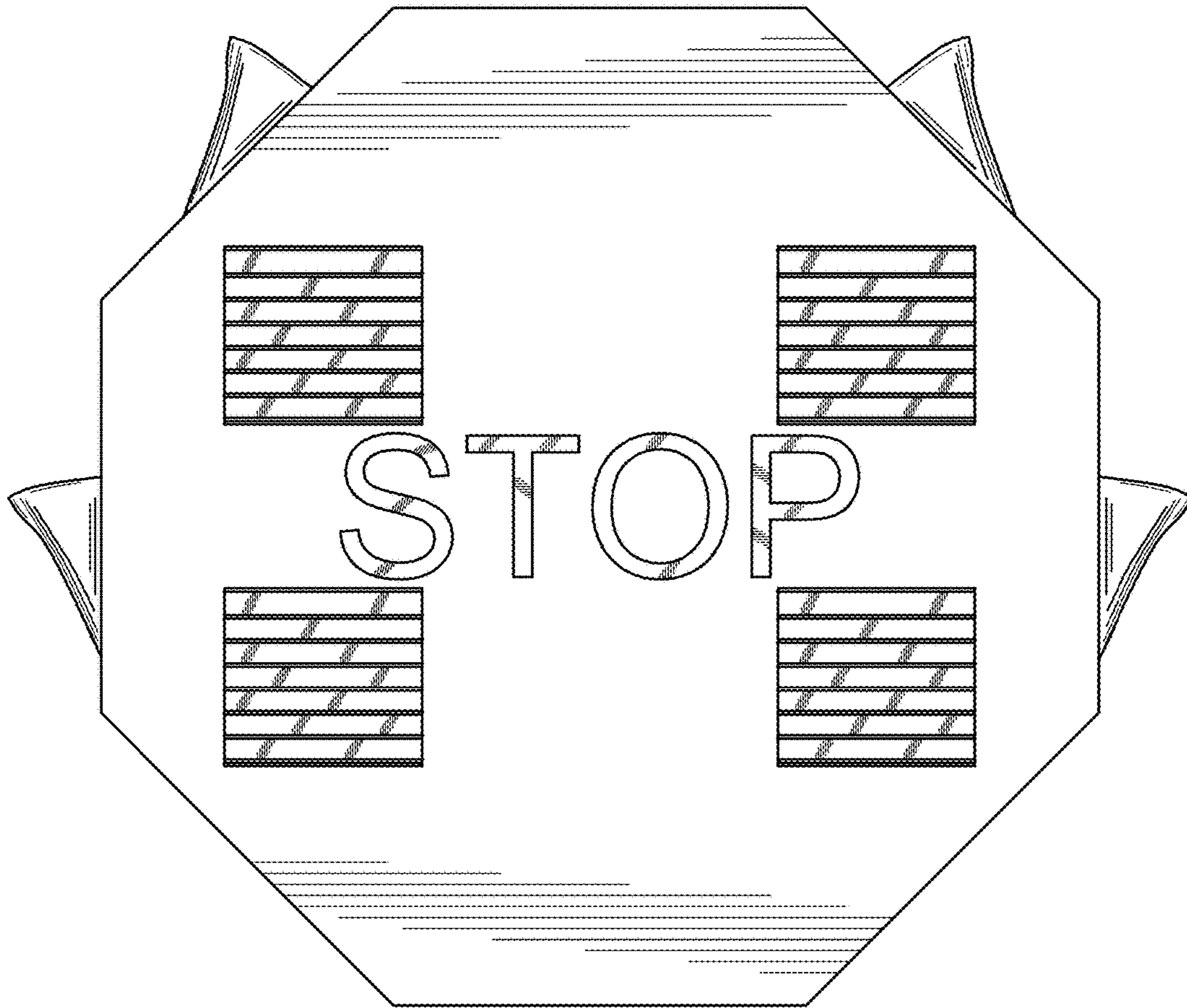

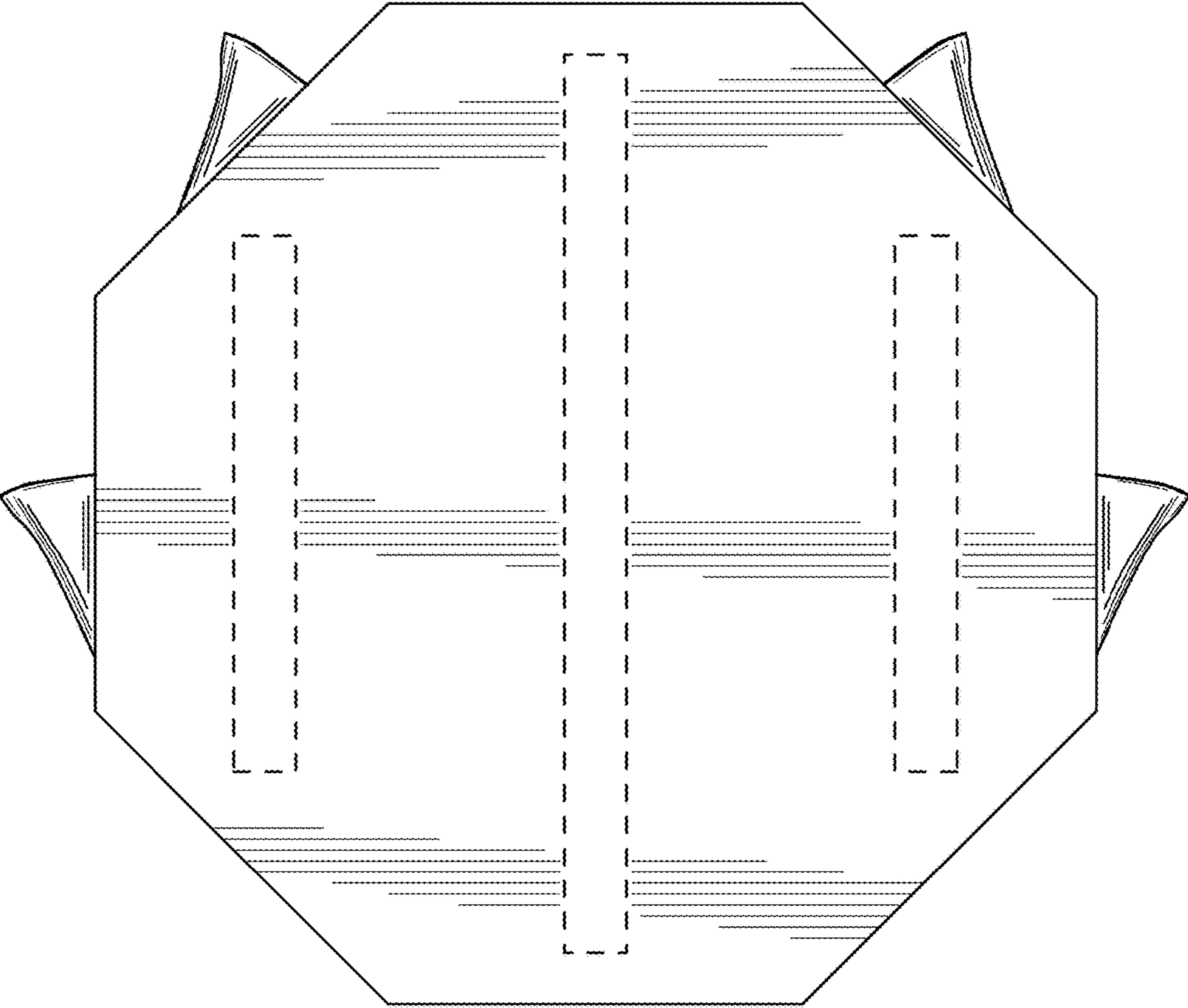

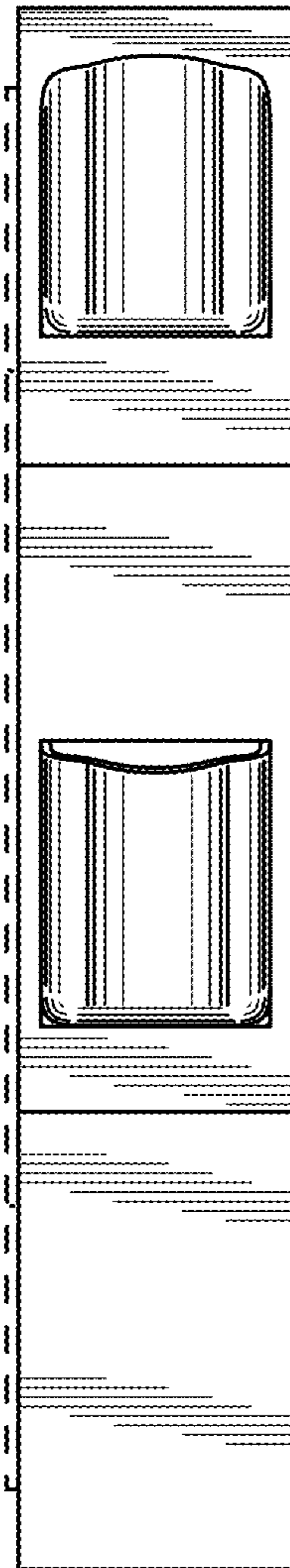

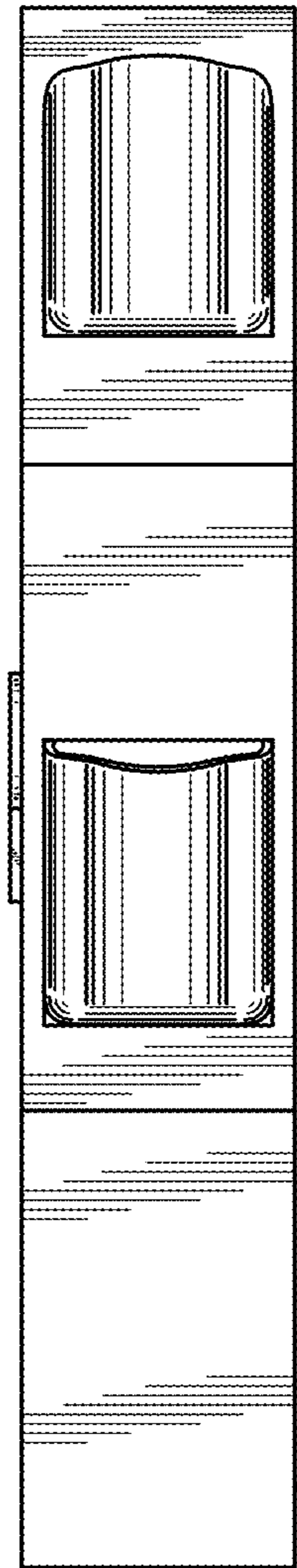

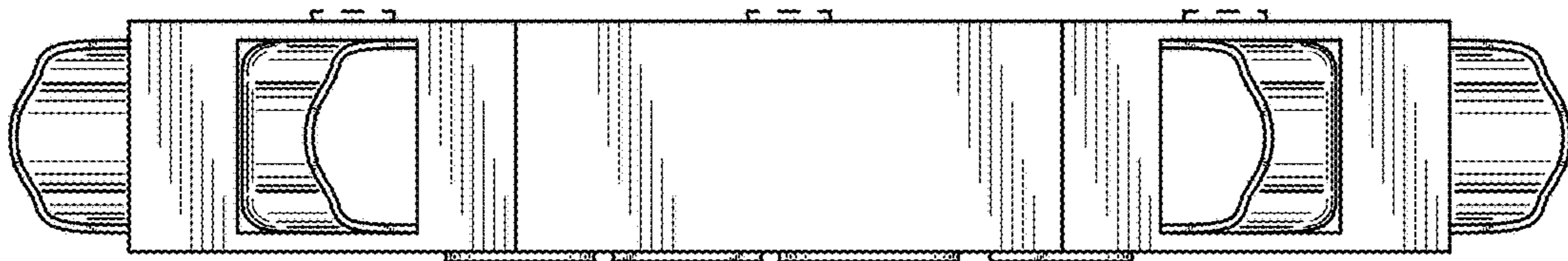

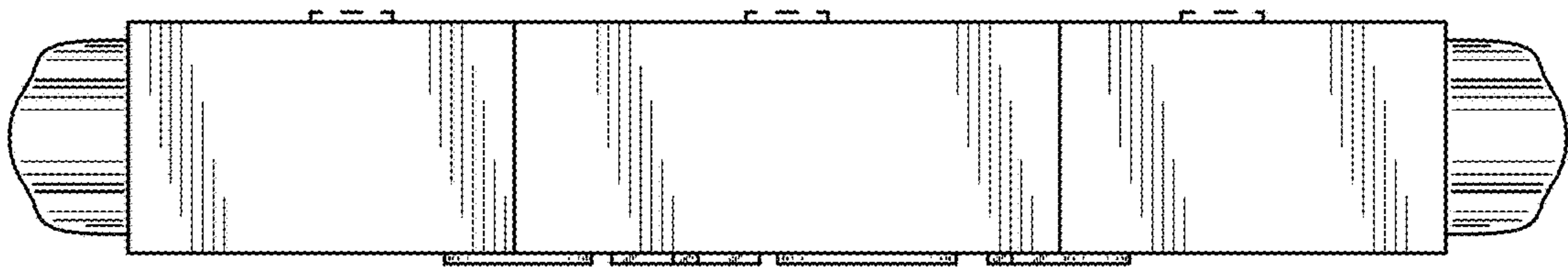

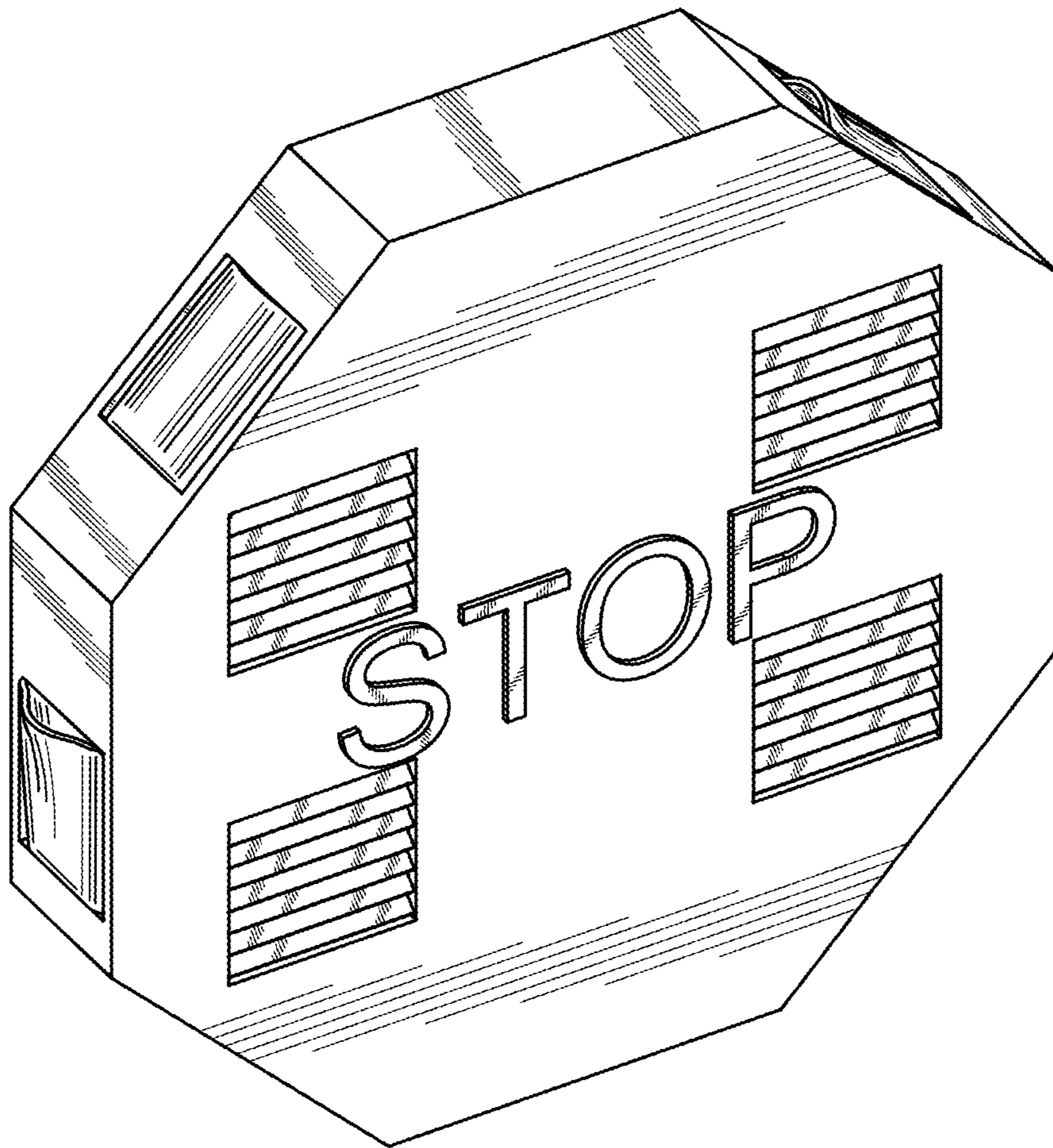
