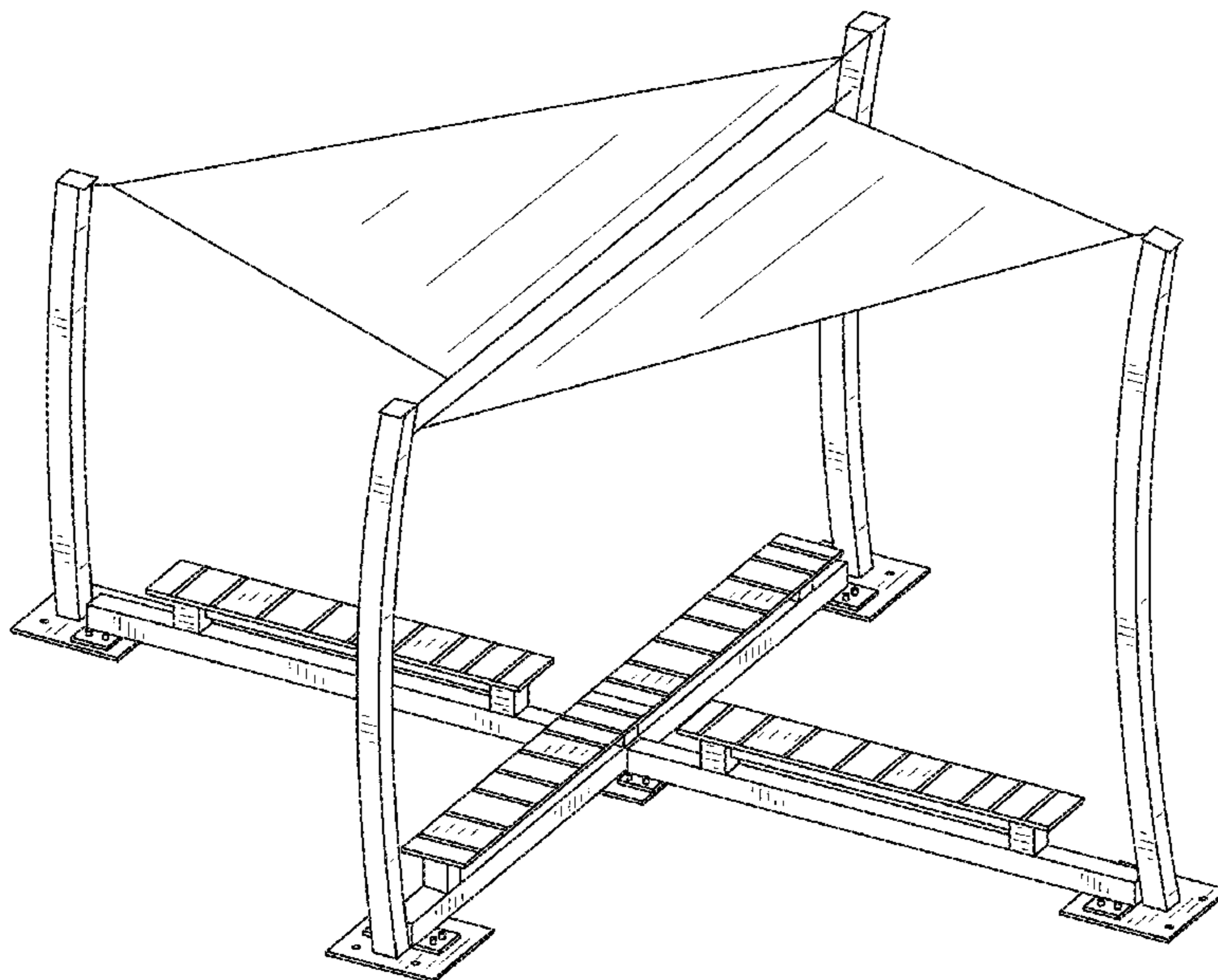
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top perspective view of the shade structure, showing my new design;
FIG. 2 is a front elevation view of the design illustrated in FIG. 1;

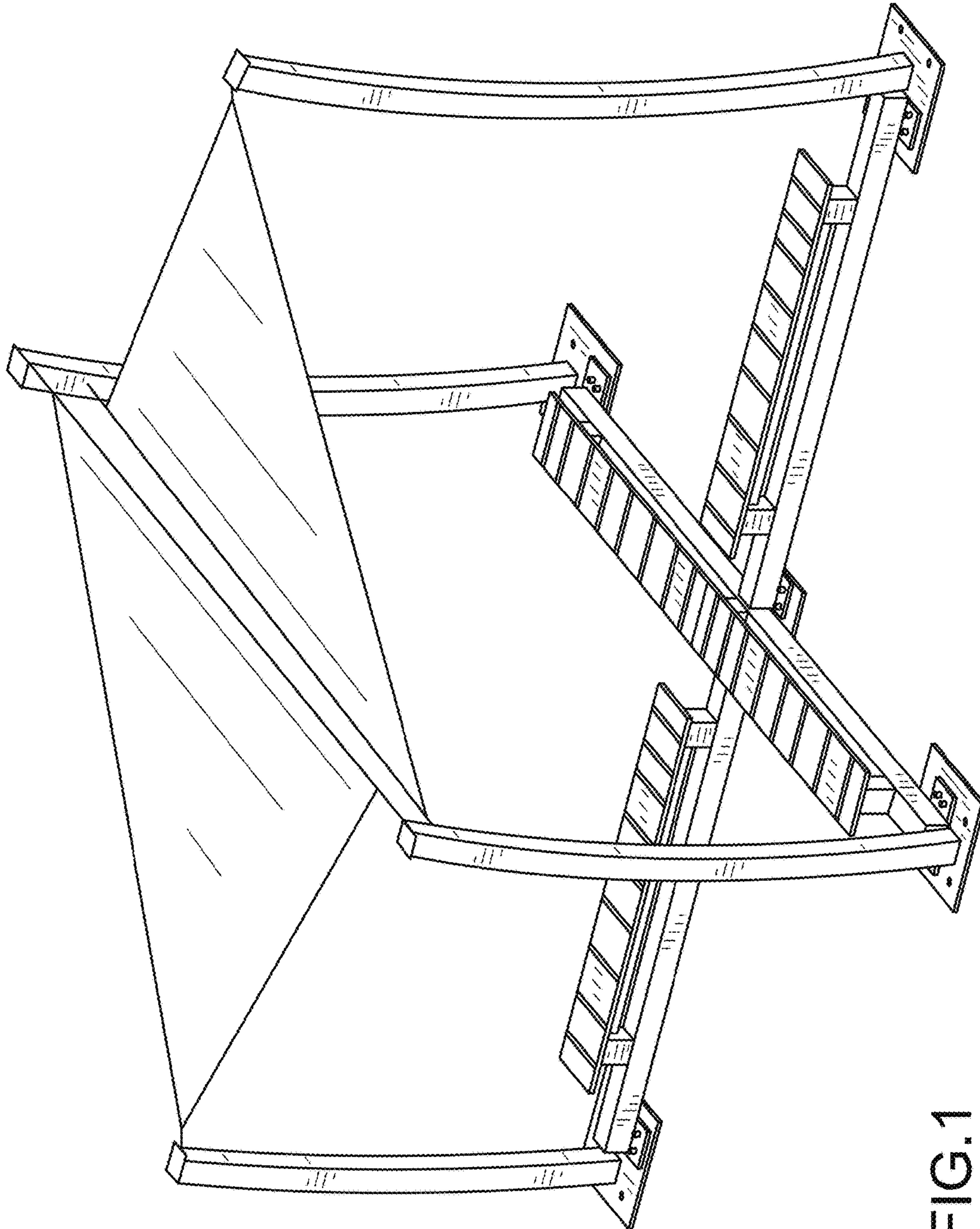

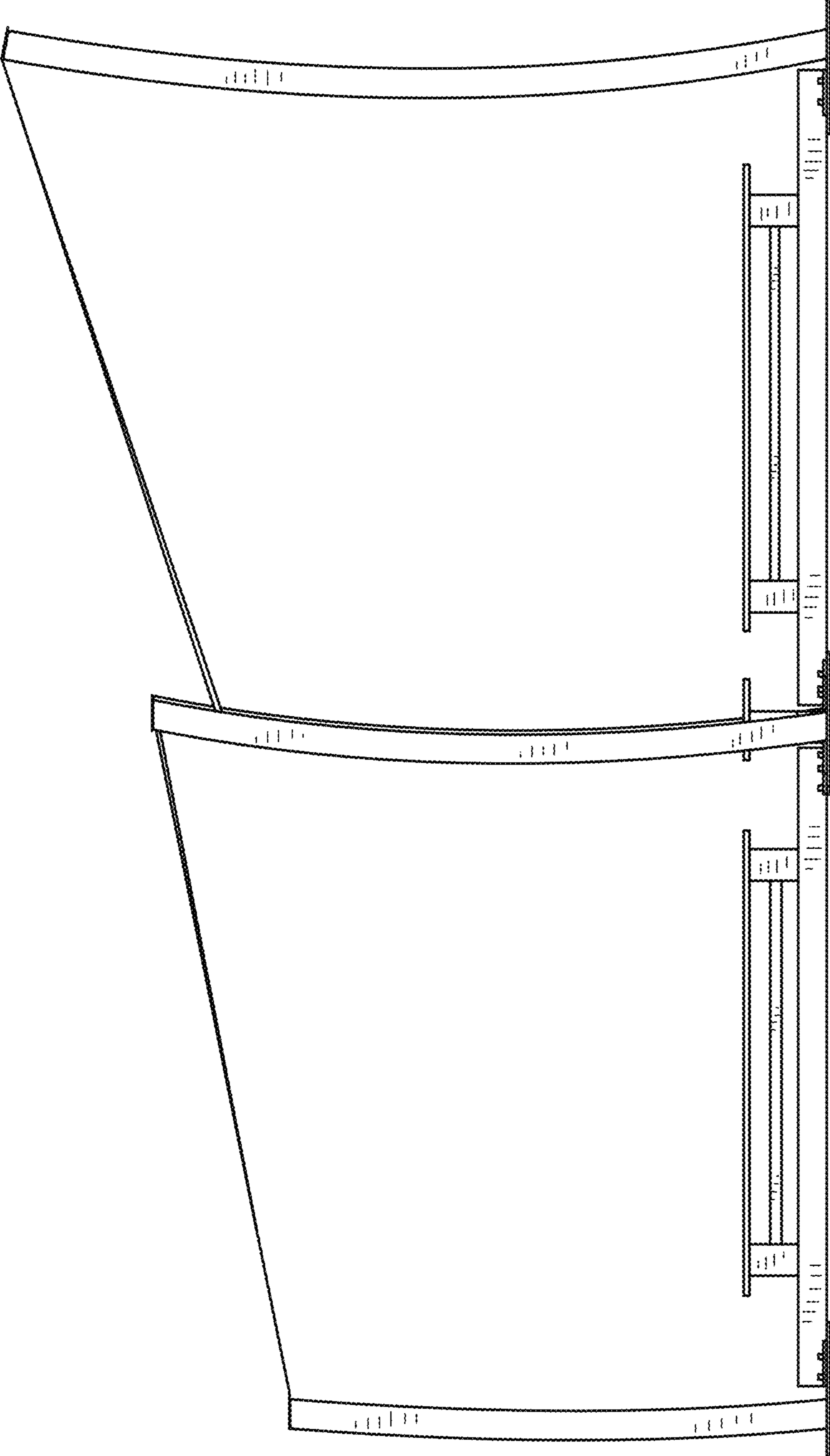

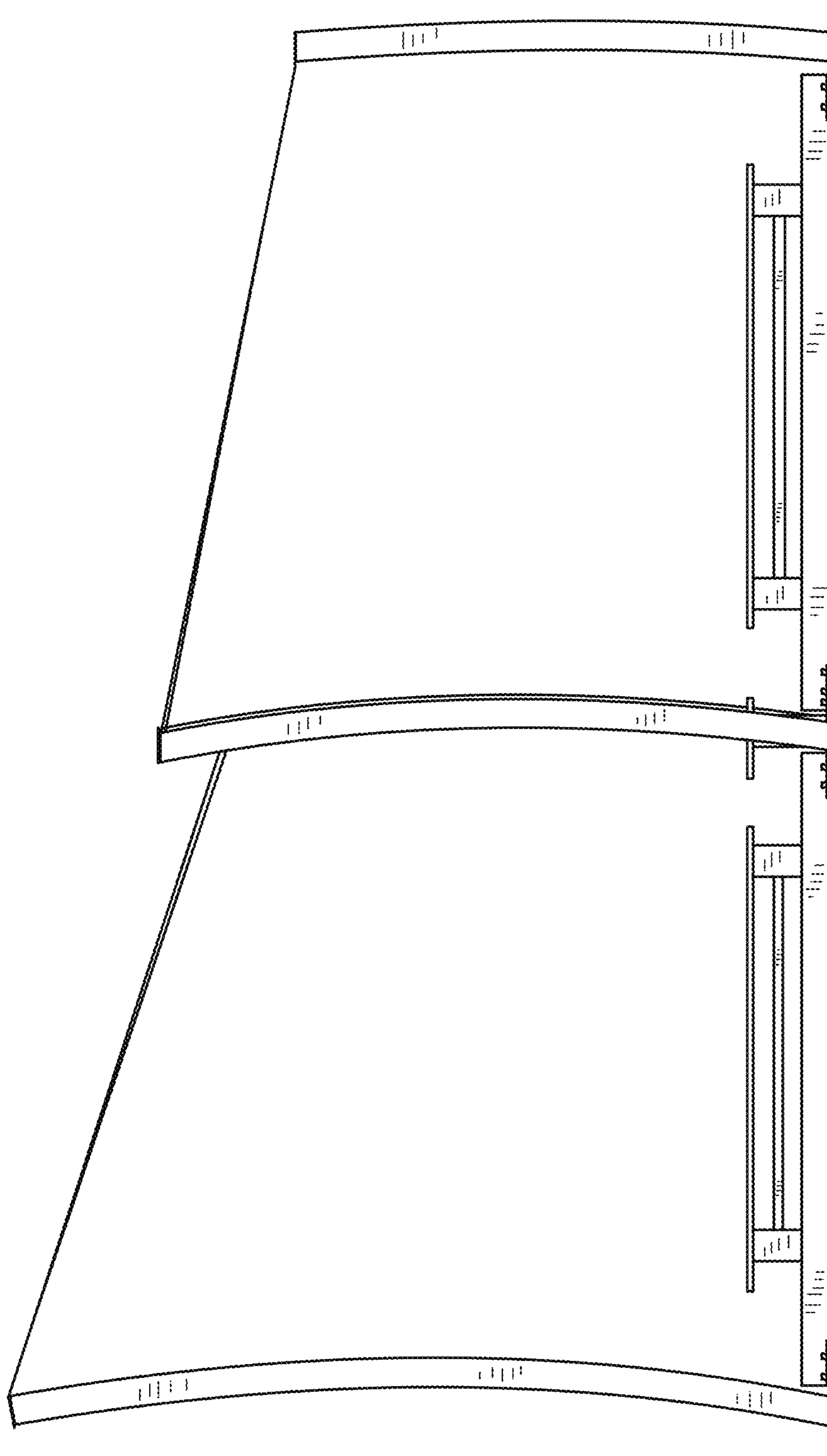

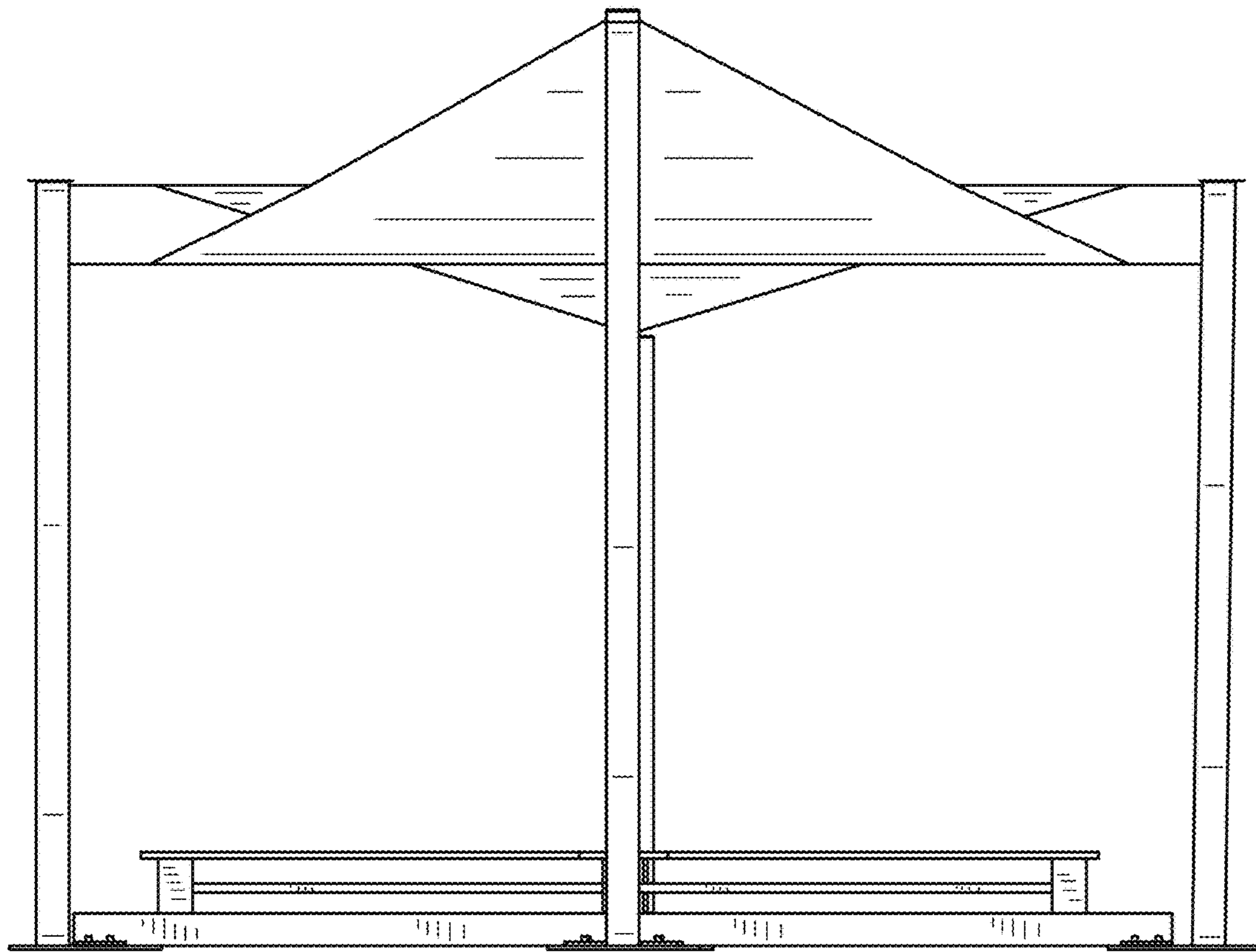

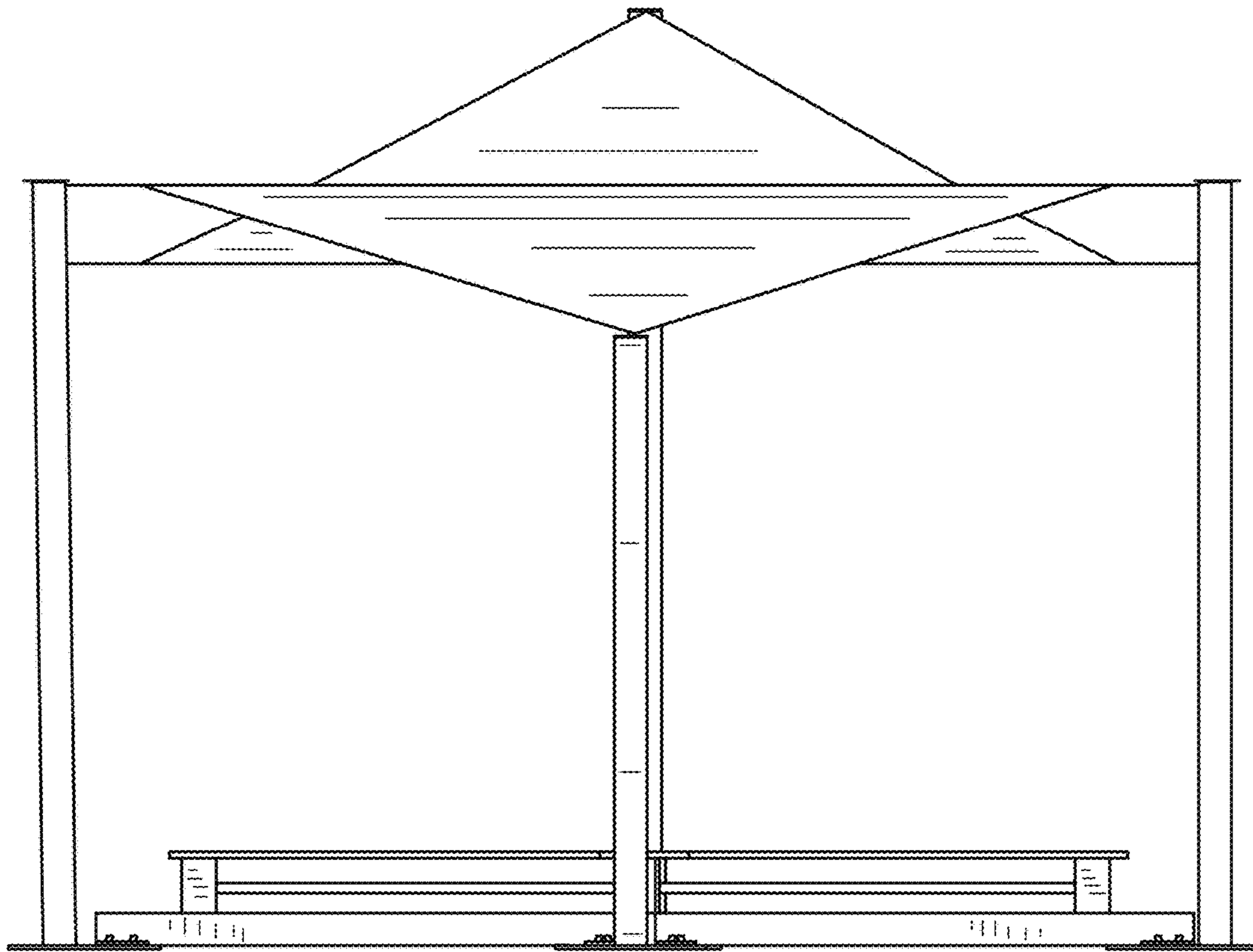

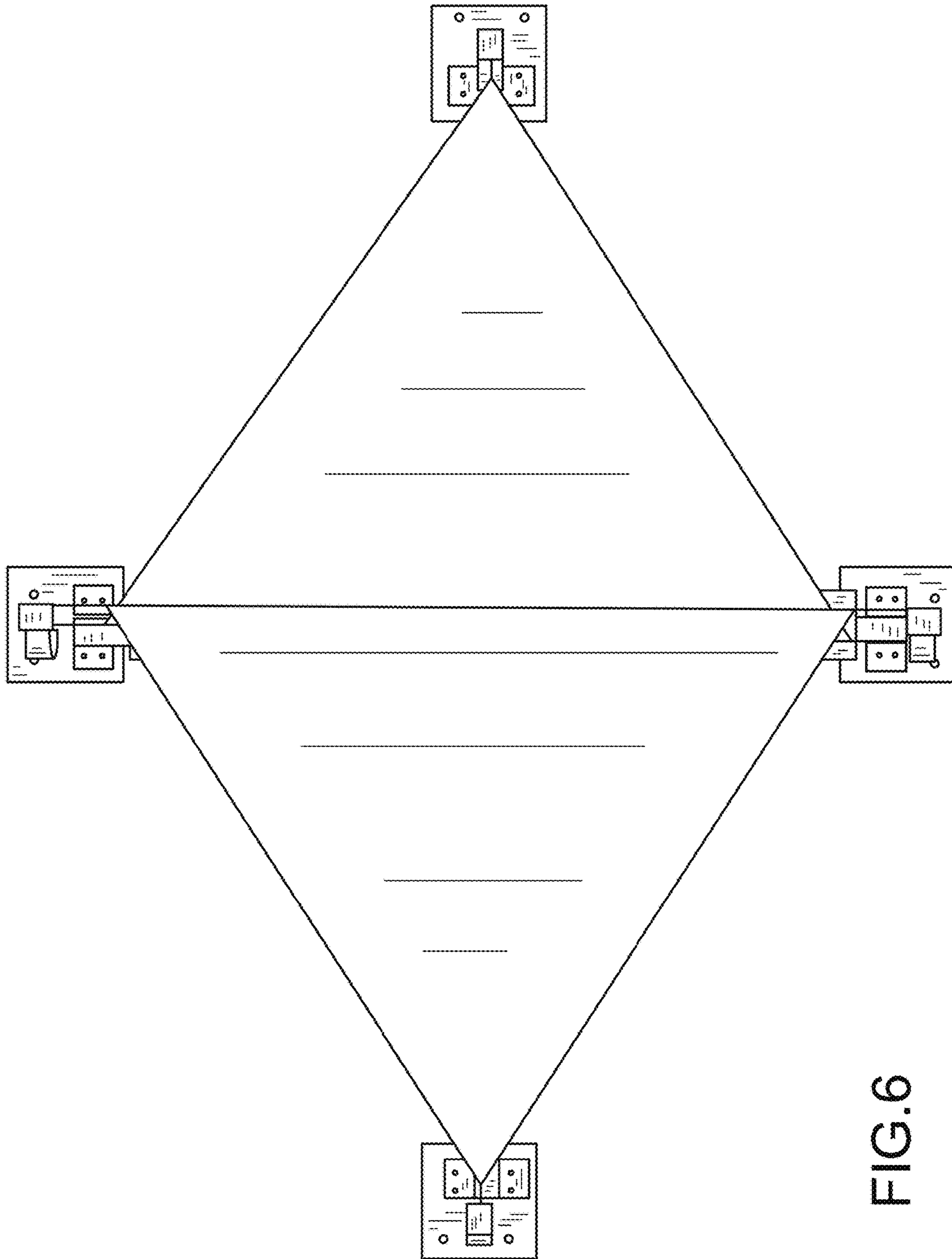

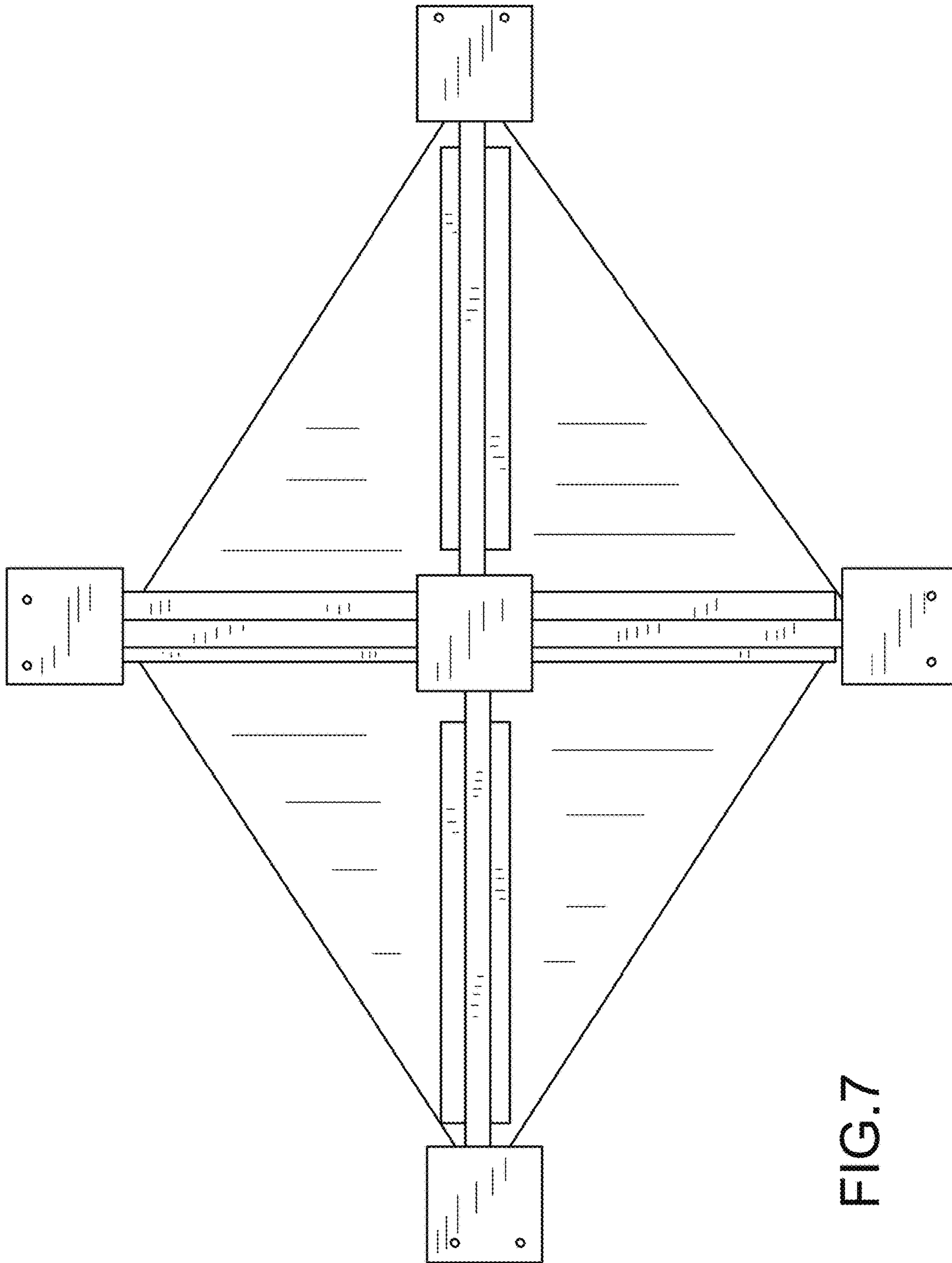
