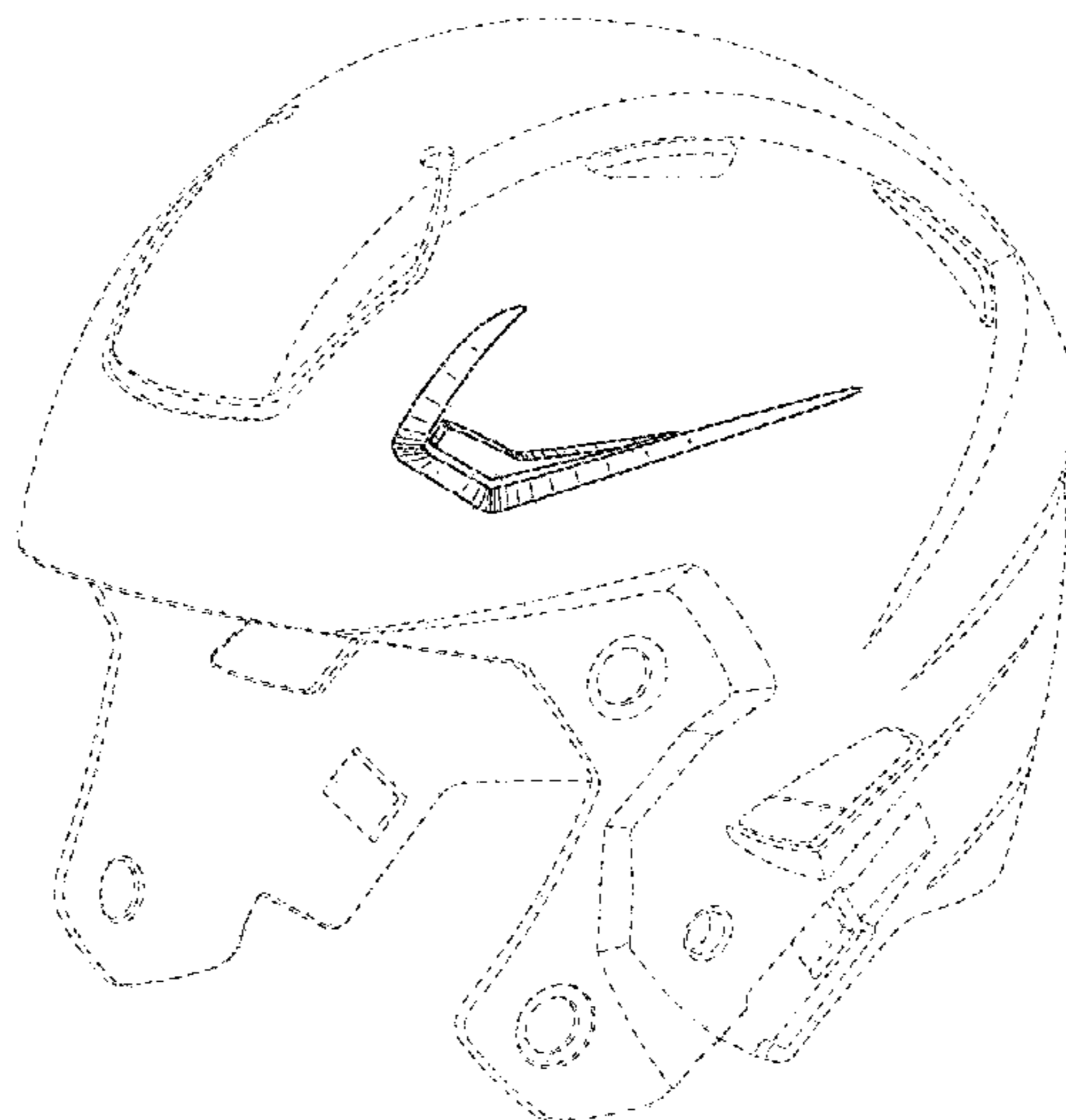
(57) **CLAIM**

I claim the ornamental design for a football helmet, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a football helmet according to the new design;
FIG. 2 is a left side view of the helmet of FIG. 1;
FIG. 3 is a right side view of the helmet of FIG. 1;
FIG. 4 is a front view of the helmet of FIG. 1;
FIG. 5 is a top view of the helmet of FIG. 1; and,

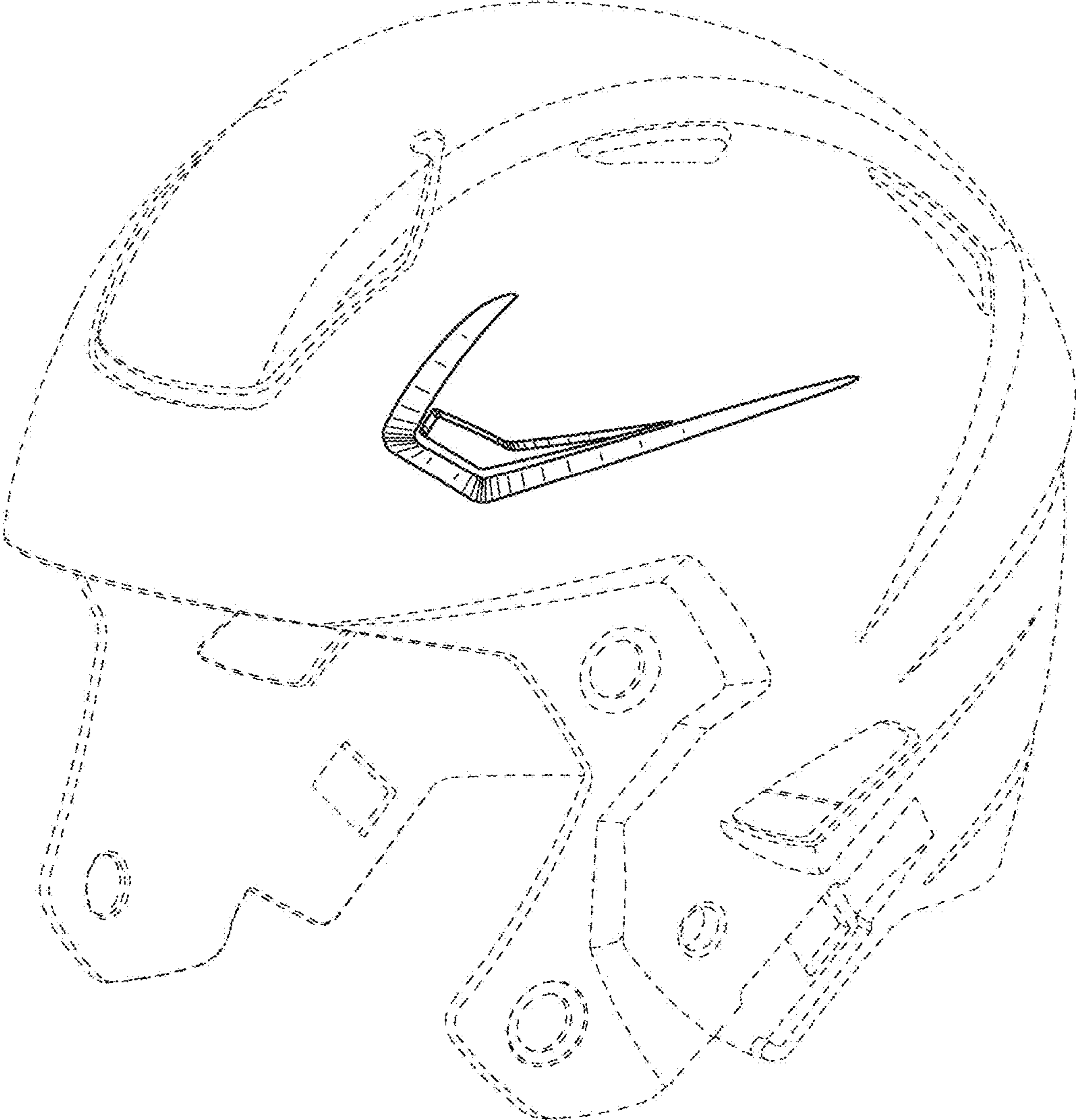

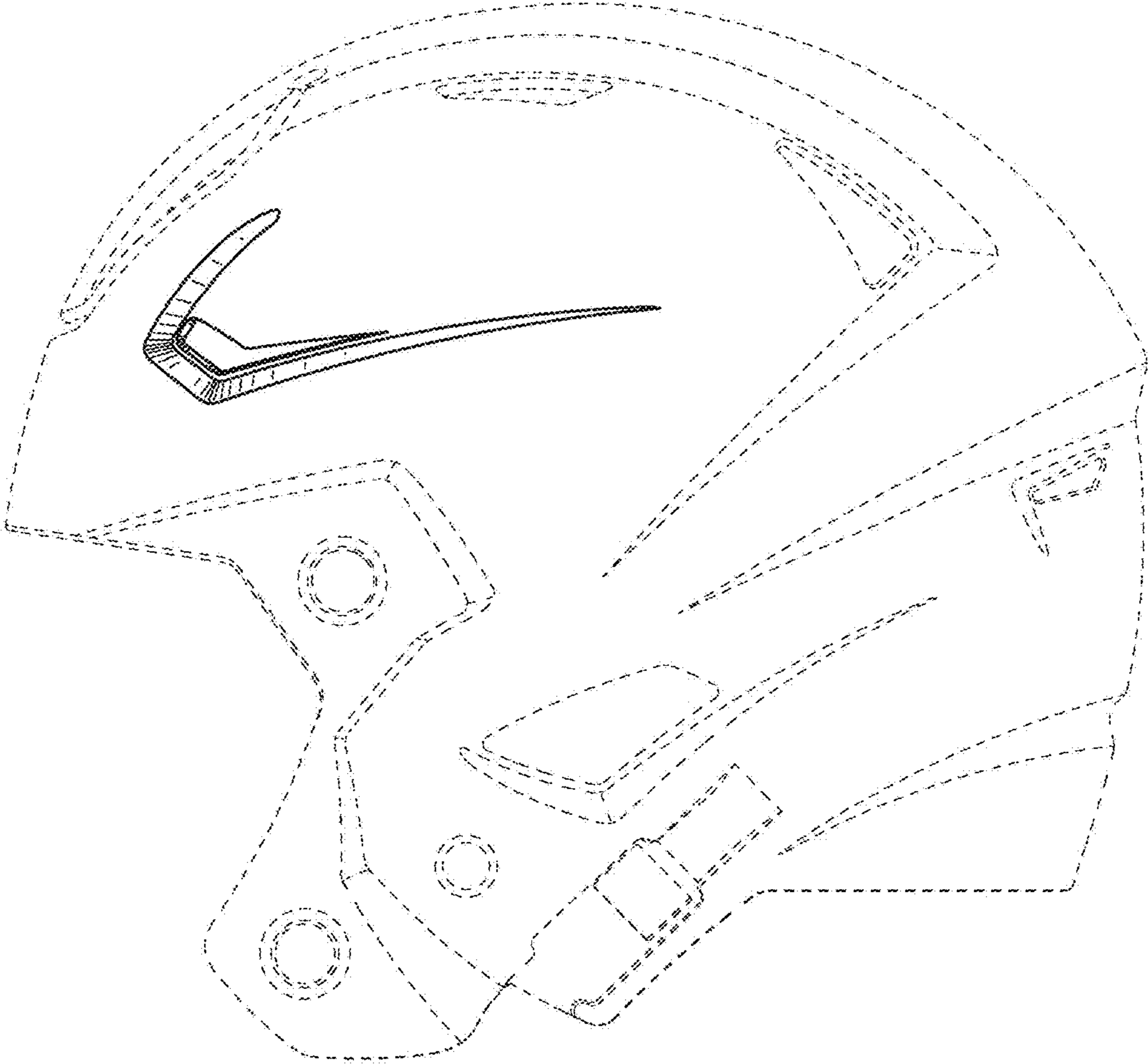

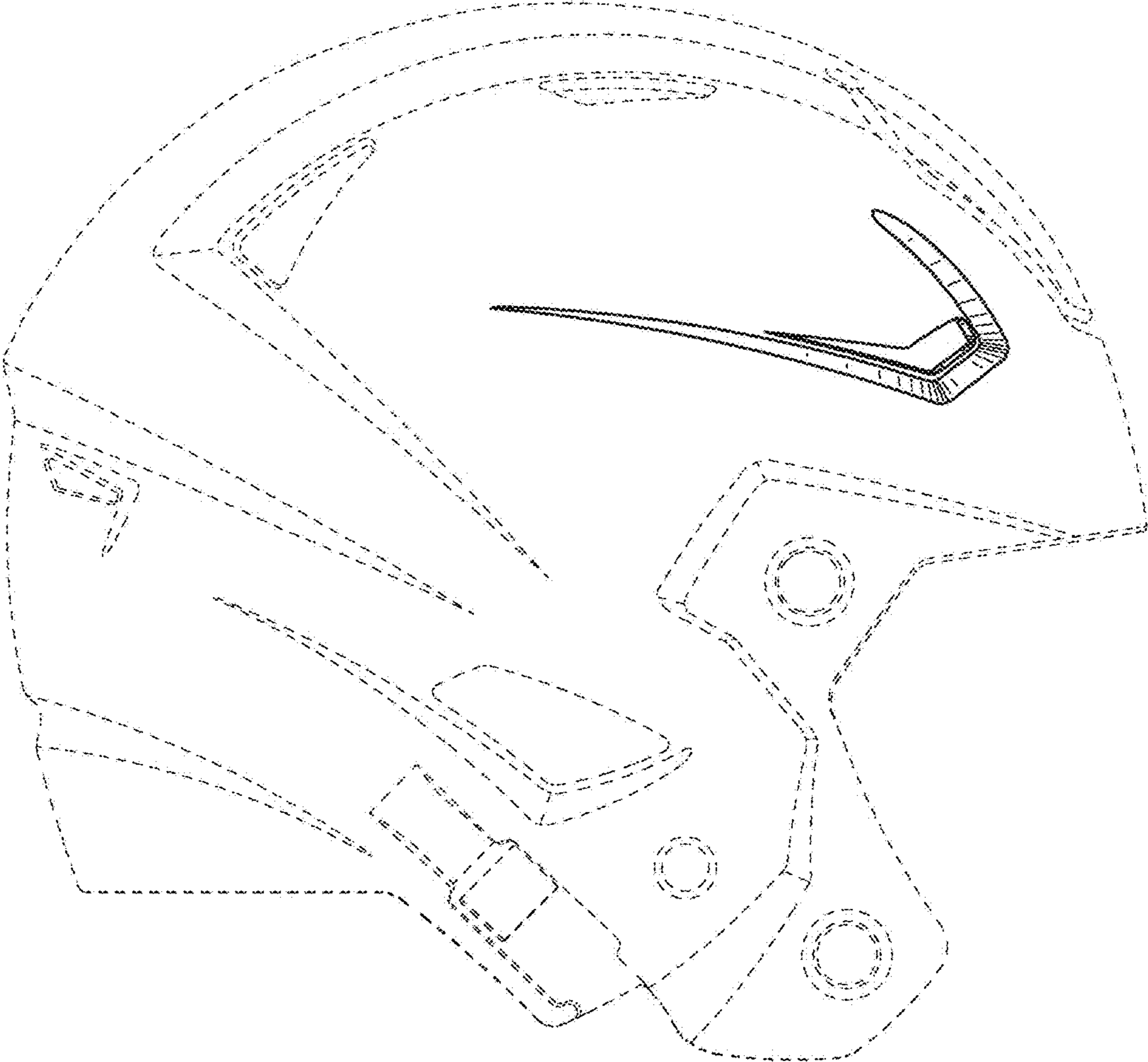

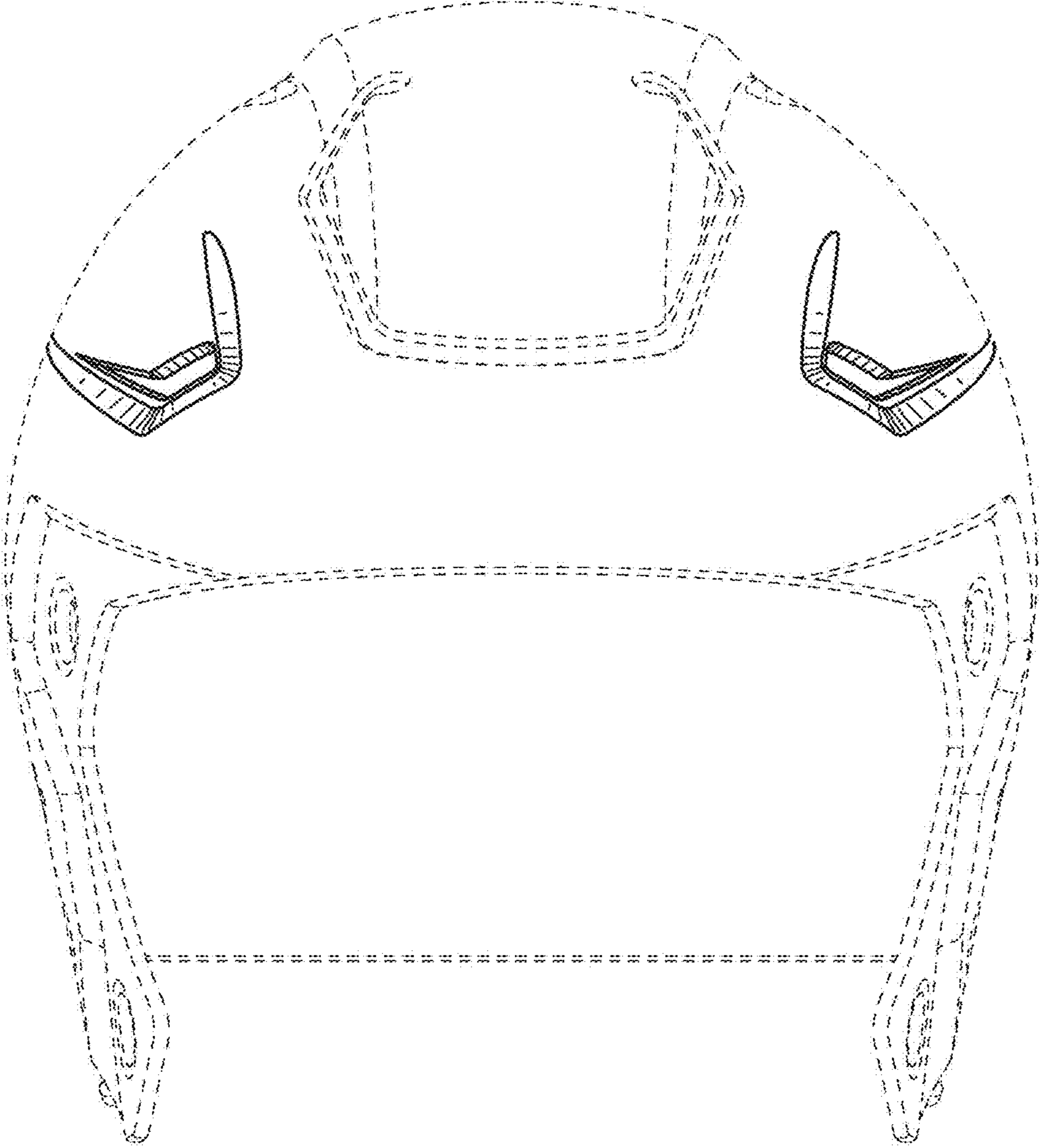

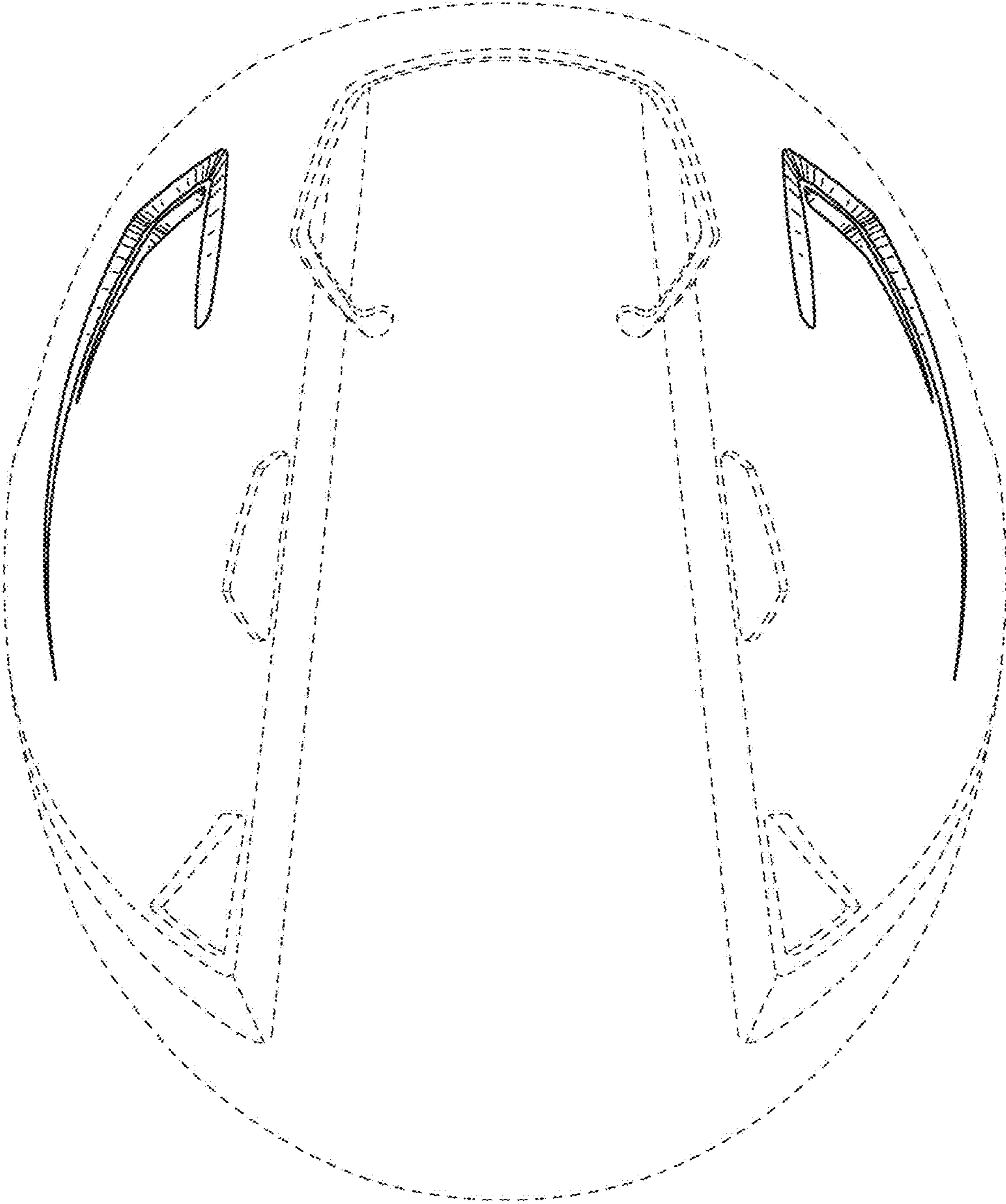

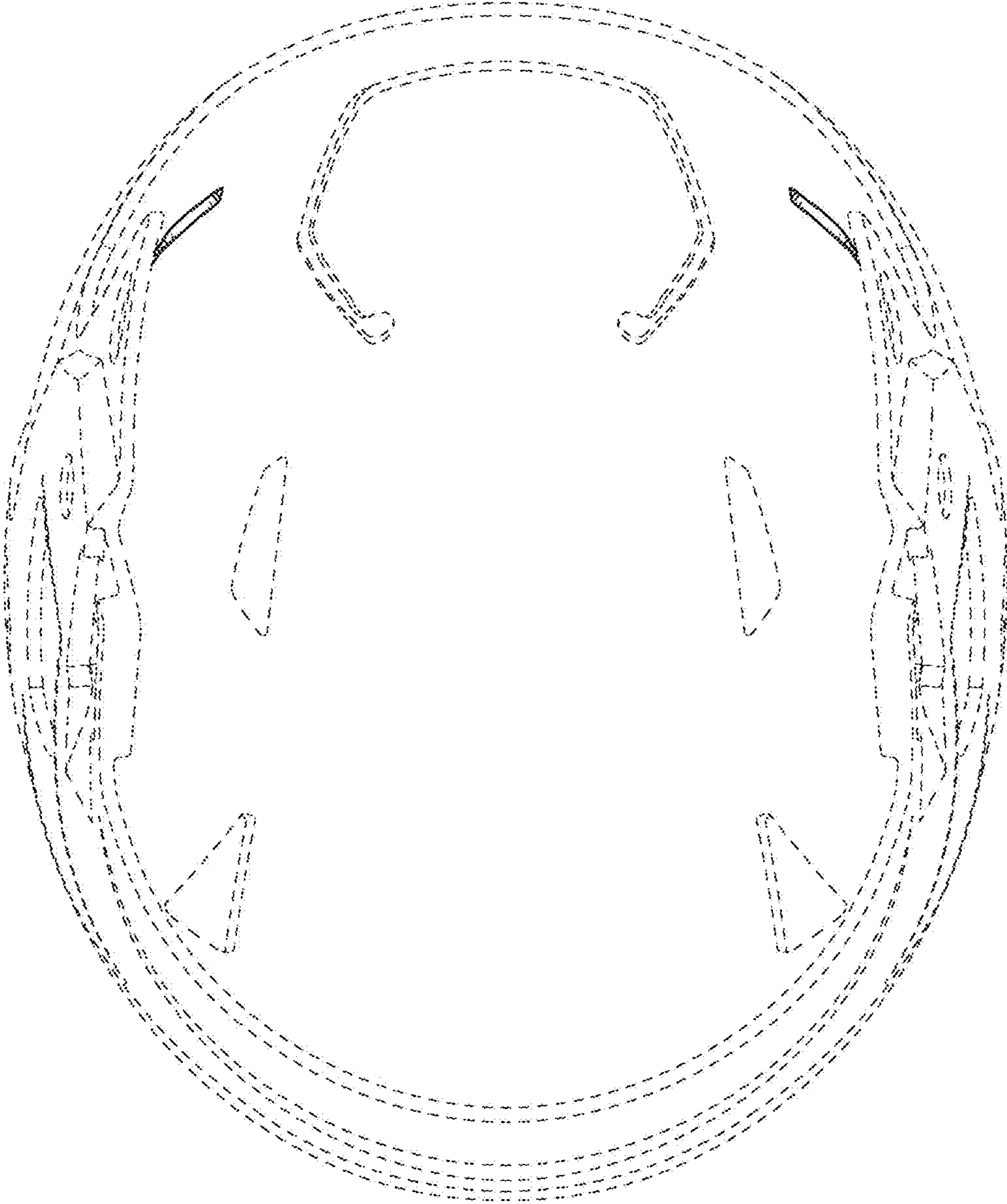
