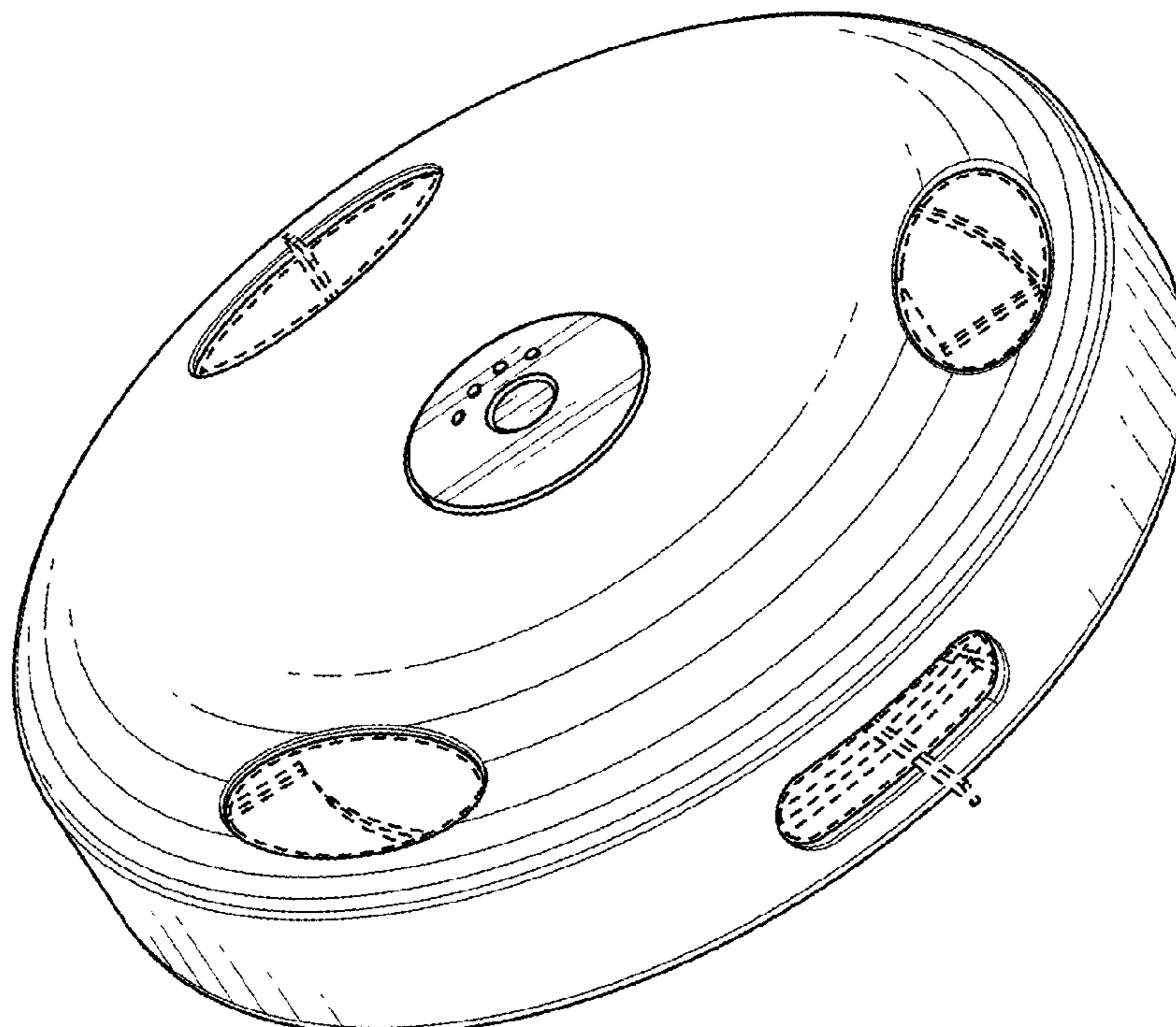
(57) **CLAIM**

I claim the ornamental design for a cat toy, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a cat toy showing my new design;
 FIG. 2 is another top perspective view thereof;
 FIG. 3 is a front elevational view of FIG. 2;
 FIG. 4 is a rear elevational view of FIG. 2;
 FIG. 5 is a right side elevational view of FIG. 2;

 FIG. 8 is a bottom plan view of FIG. 2.

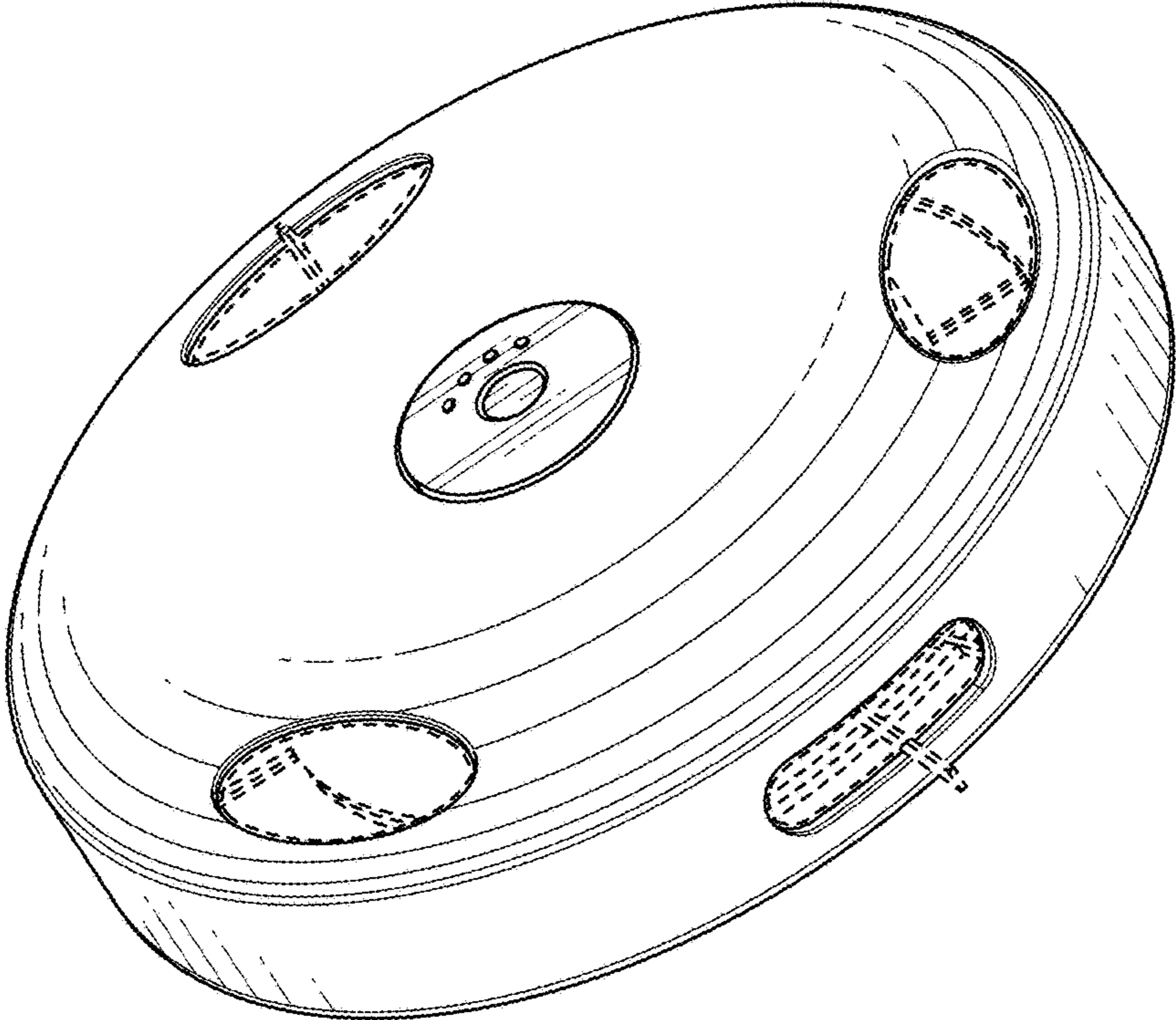

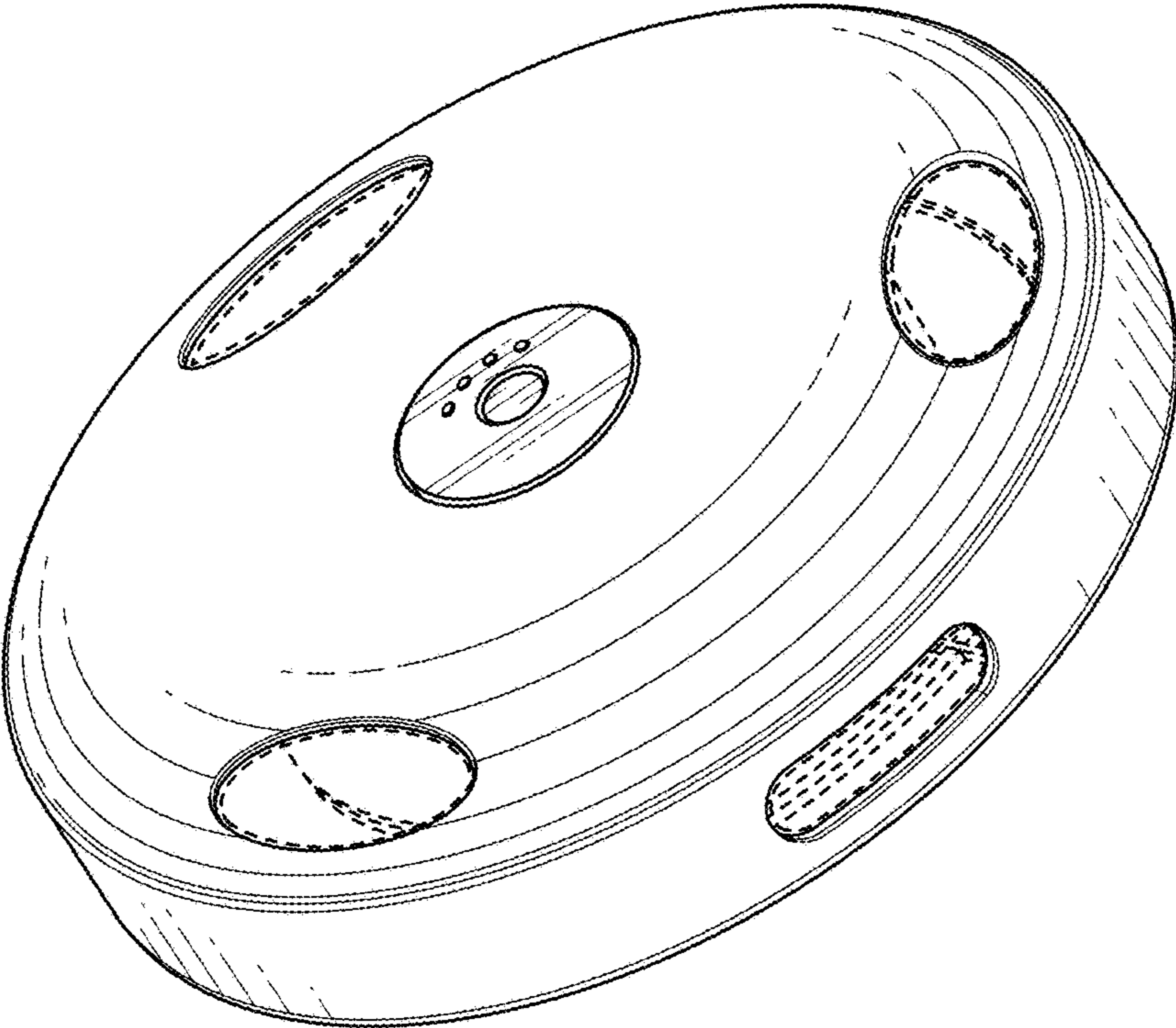

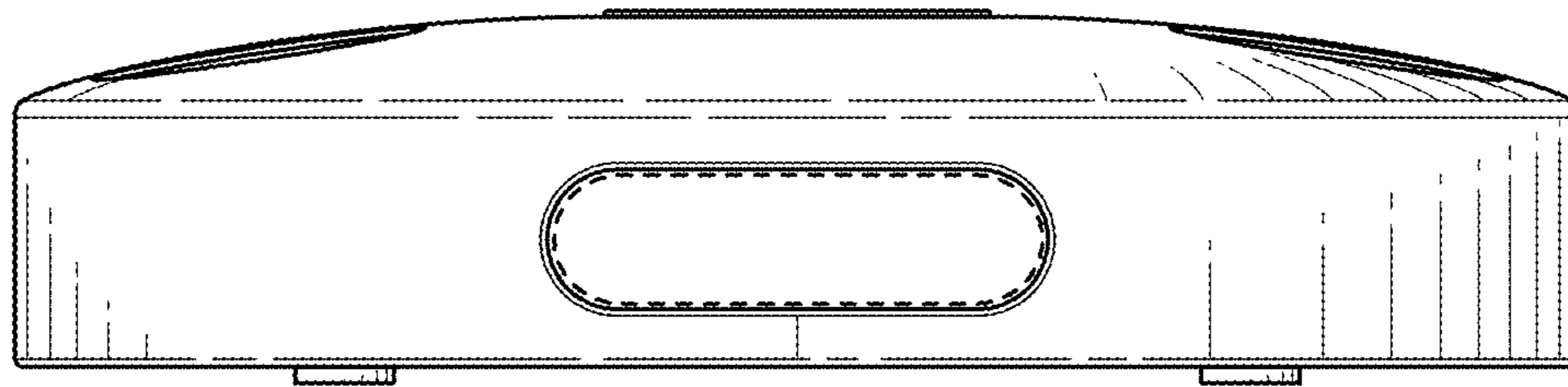

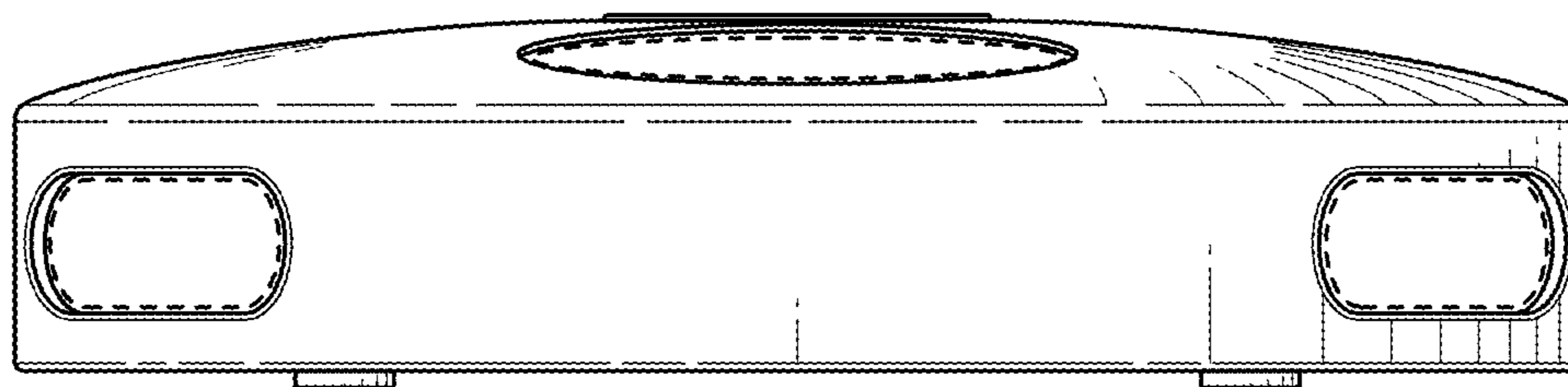

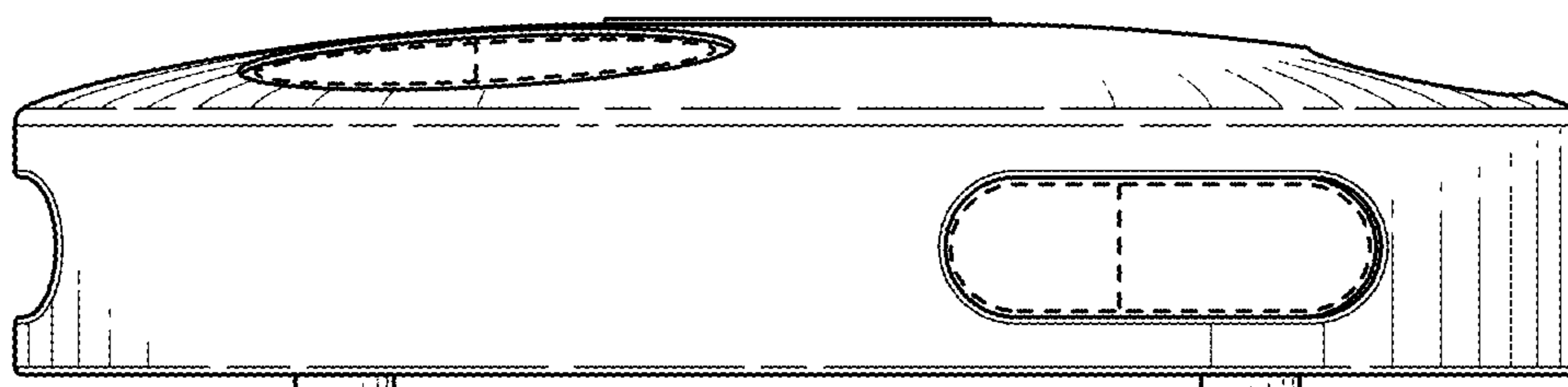

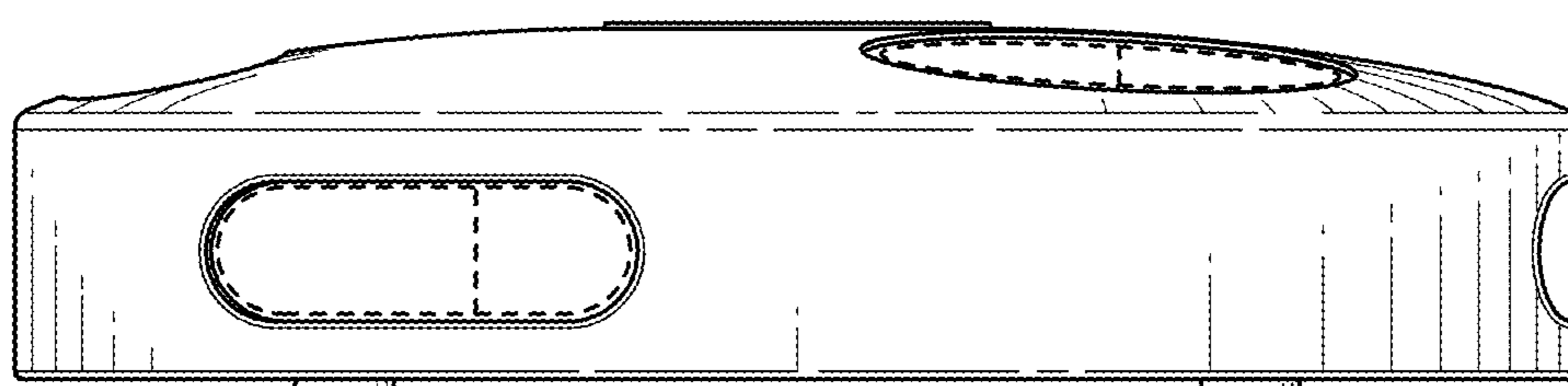

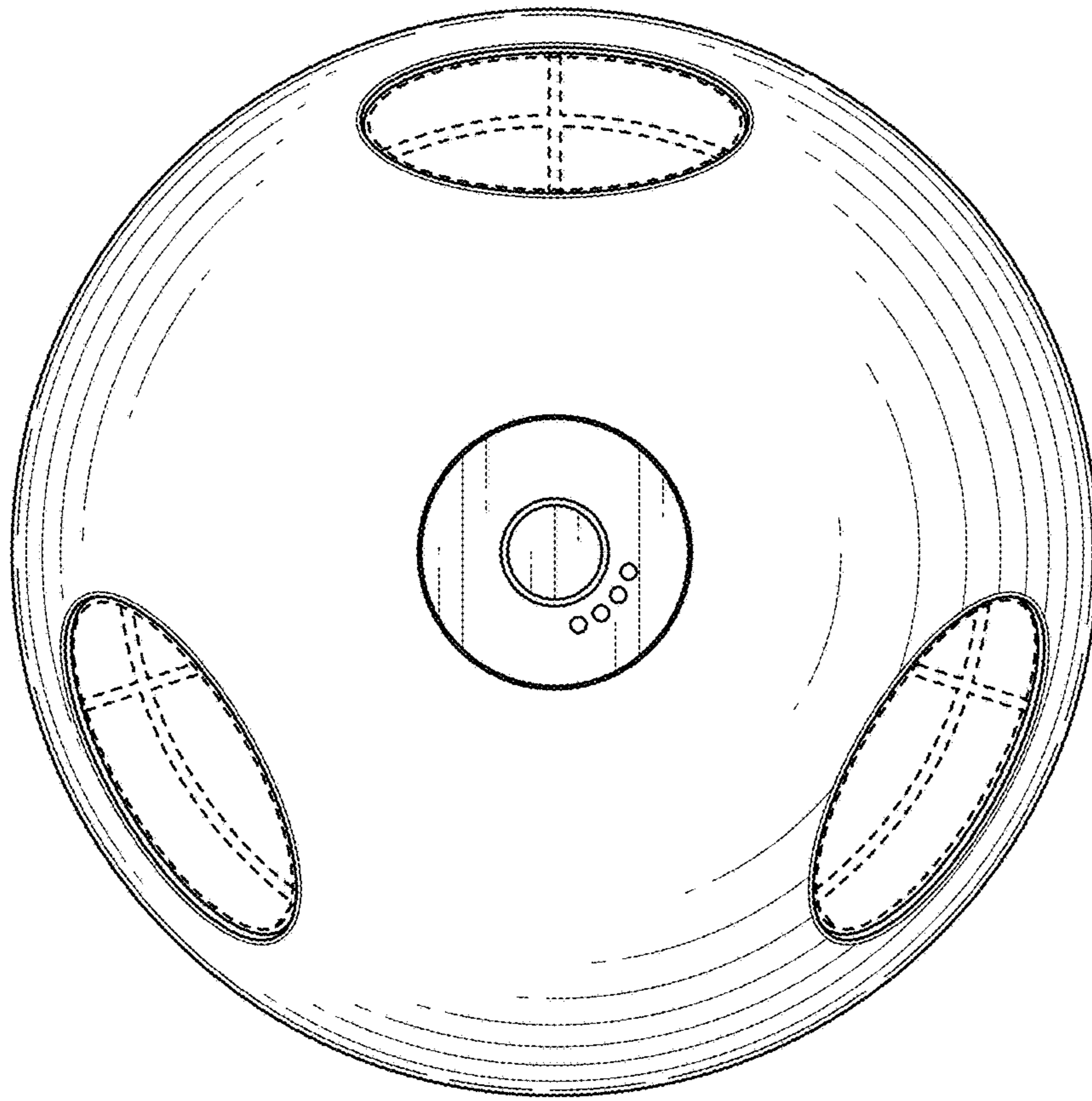

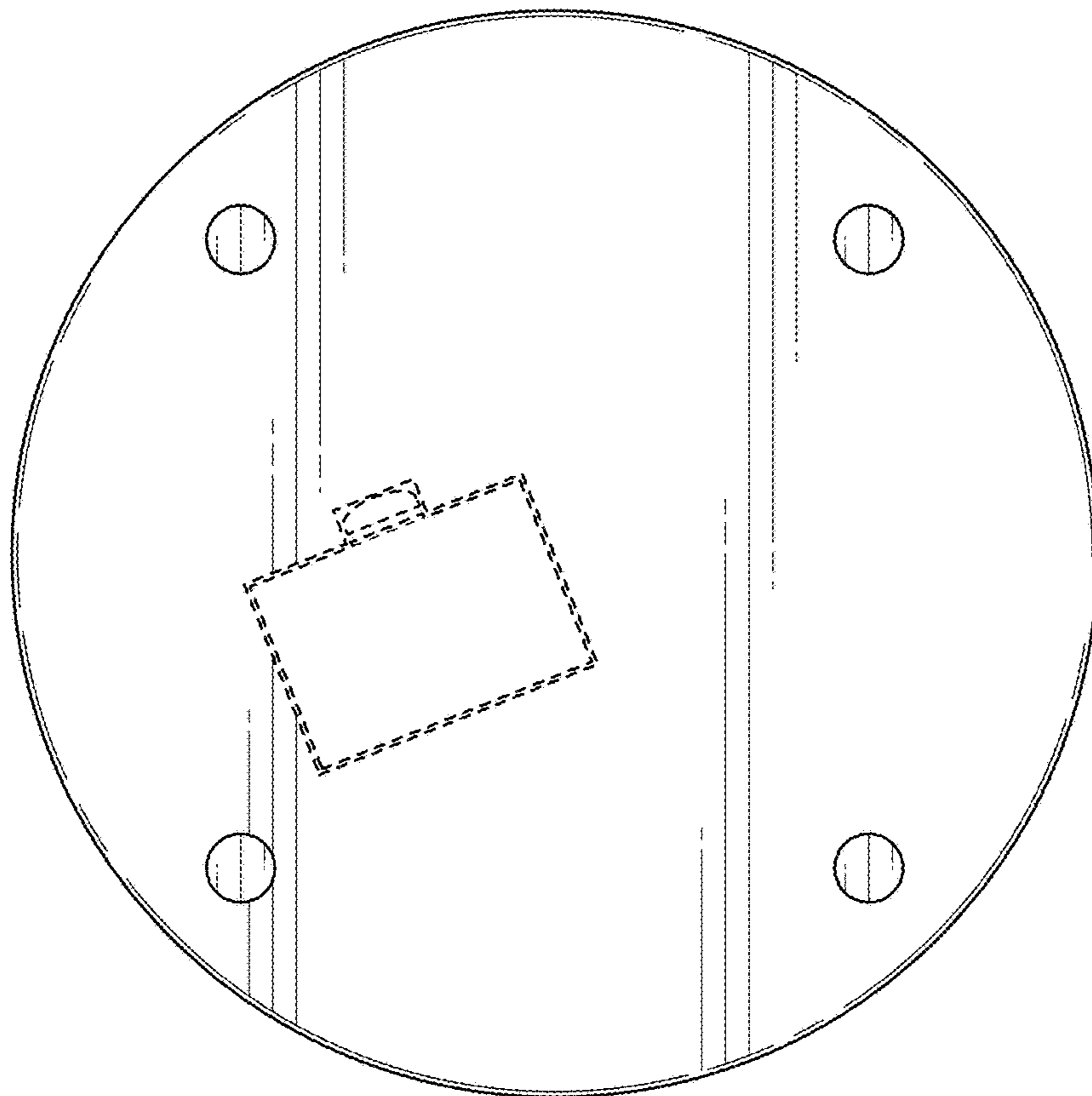
