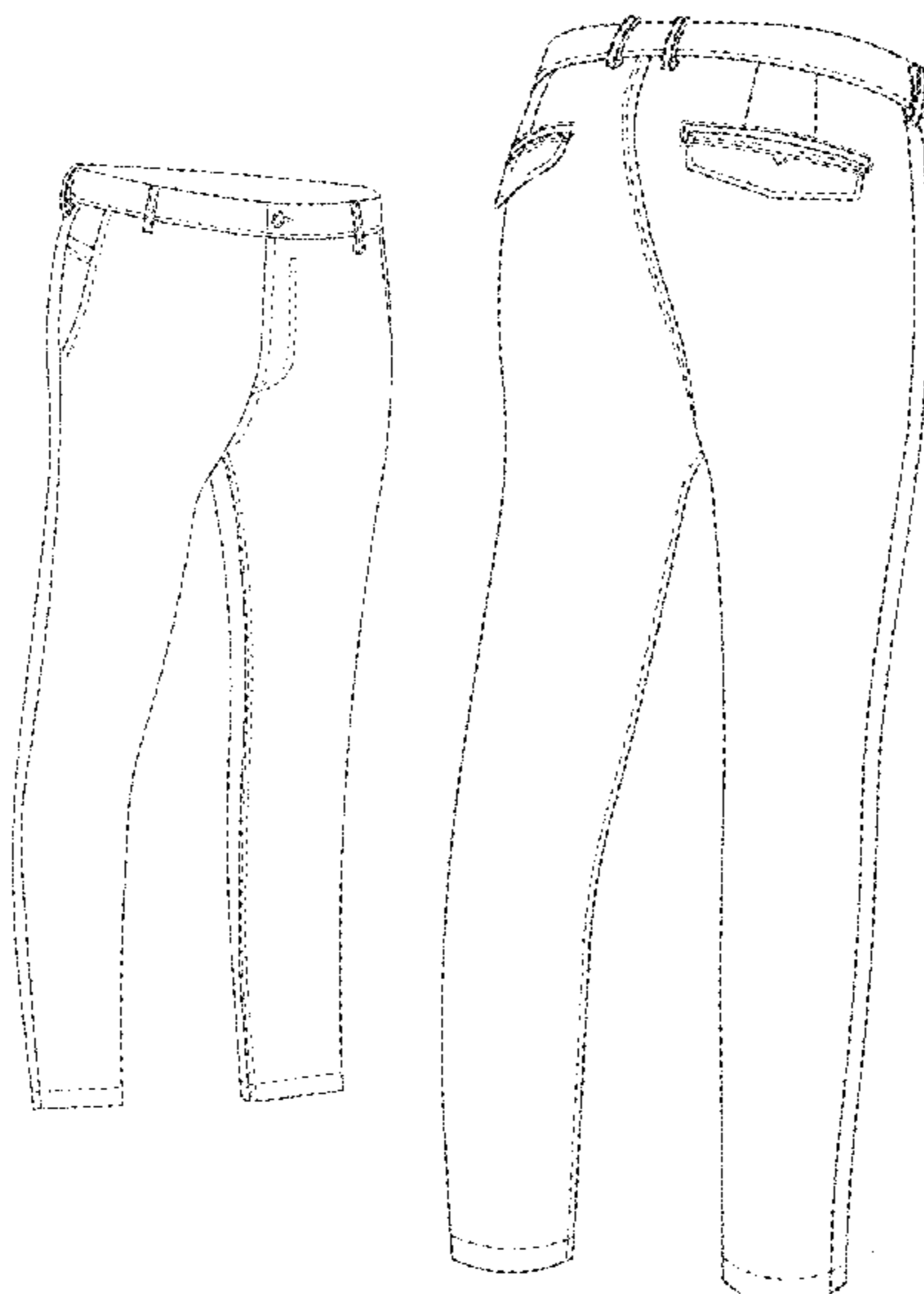
(57) **CLAIM**

The ornamental design for jeans, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the jeans;
 FIG. 2 is a rear perspective view of the jeans in FIG. 1;
 FIG. 3 is a front elevation view of the jeans in FIG. 1;
 FIG. 4 is rear elevation view of the jeans in FIG. 1;
 FIG. 5 is a right side view of the jeans in FIG. 1;
 FIG. 6 is left side view of the jeans in FIG. 1;
 FIG. 7 is rear view of the jeans in FIG. 1, with the pocket flaps tucked into the rear pockets; and,
 FIG. 8 is an enlarged view of one of the rear pockets of the jeans in FIG. 1, with the pocket partially tucked into the associated pocket.
 The broken lines shown in the drawings represent stitching in the fabric.

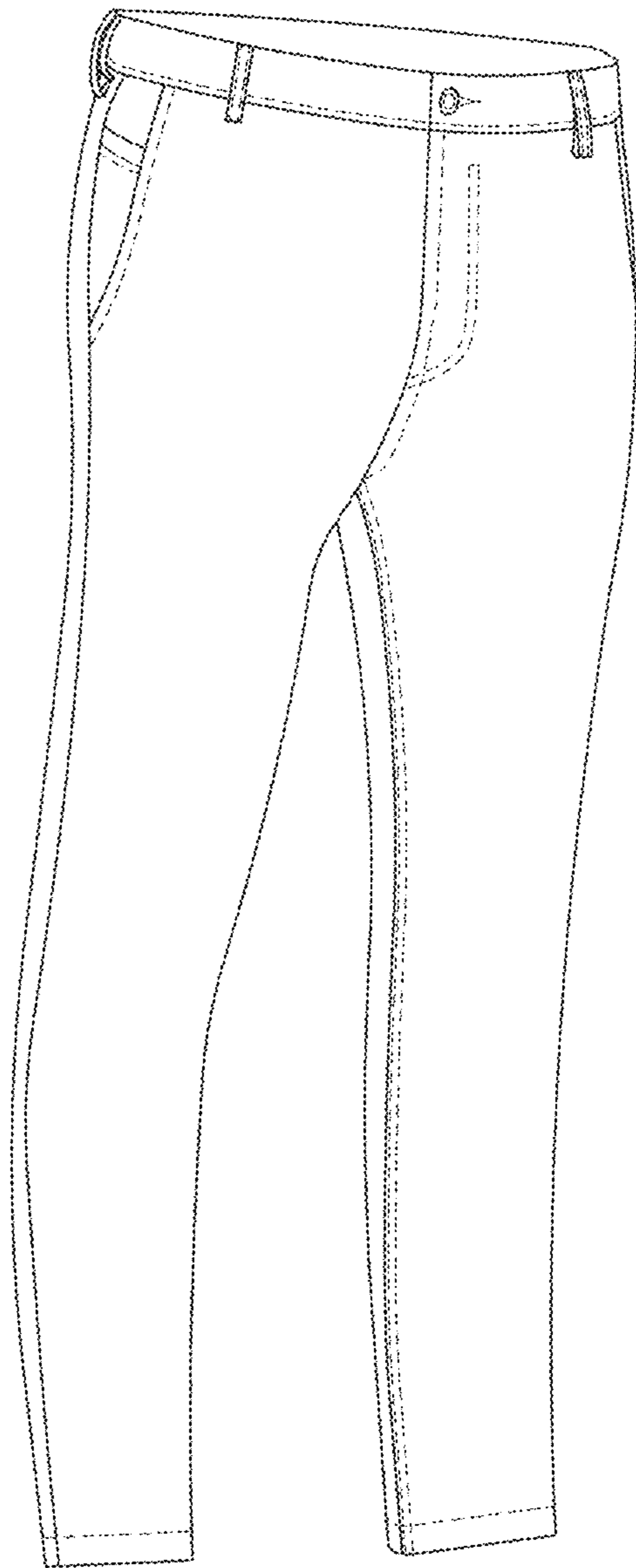

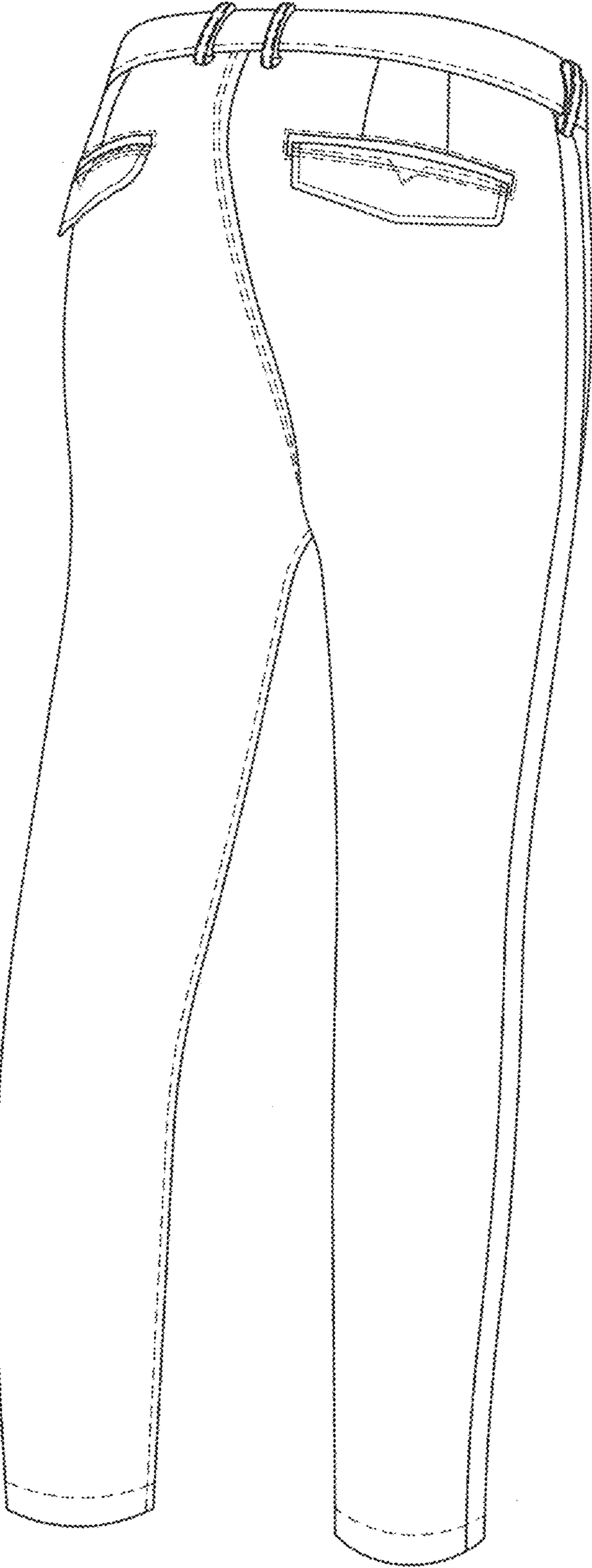

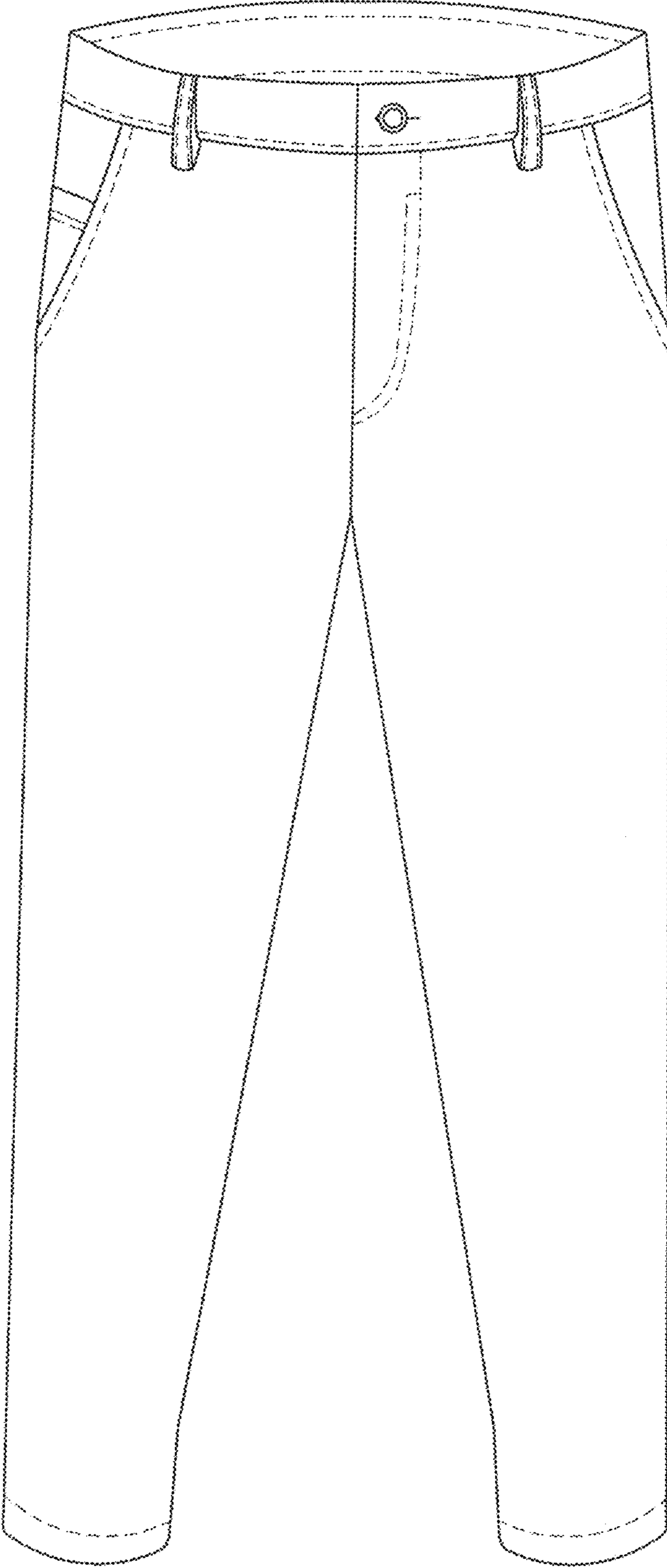

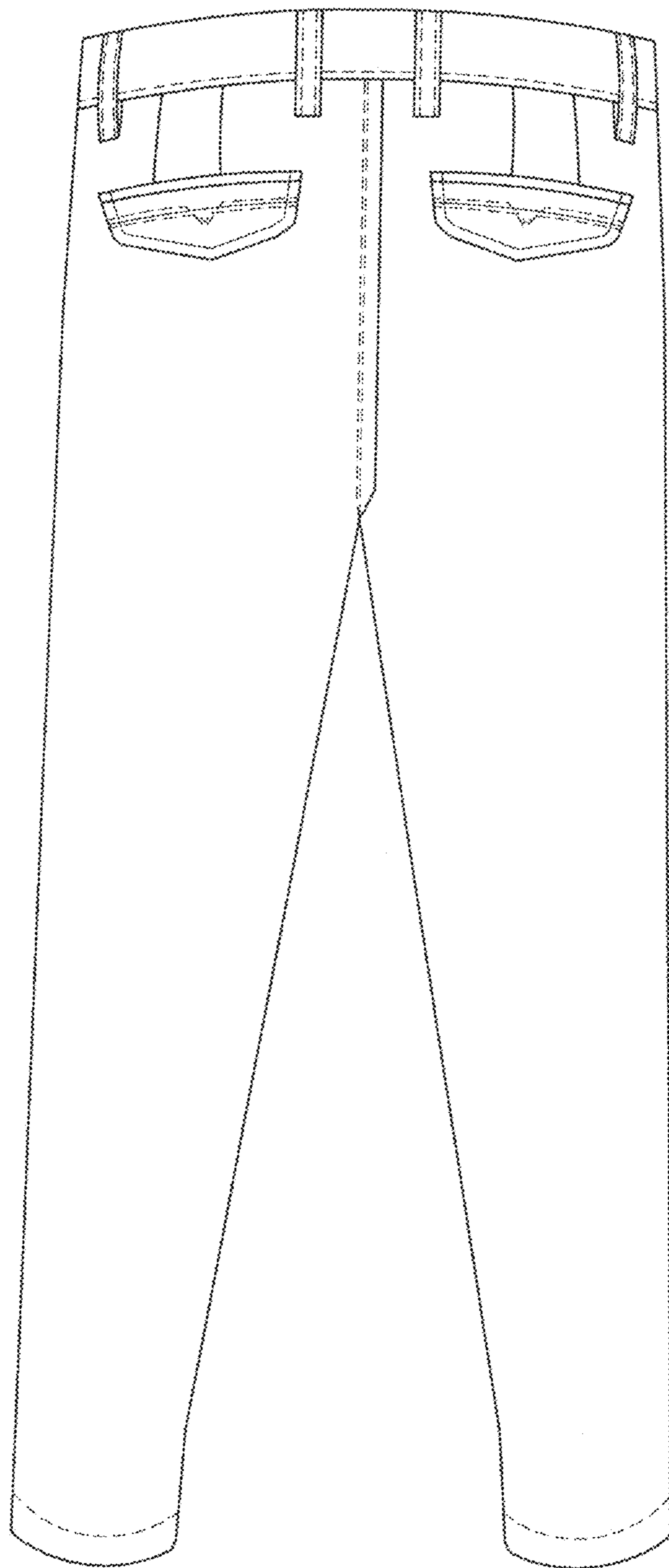

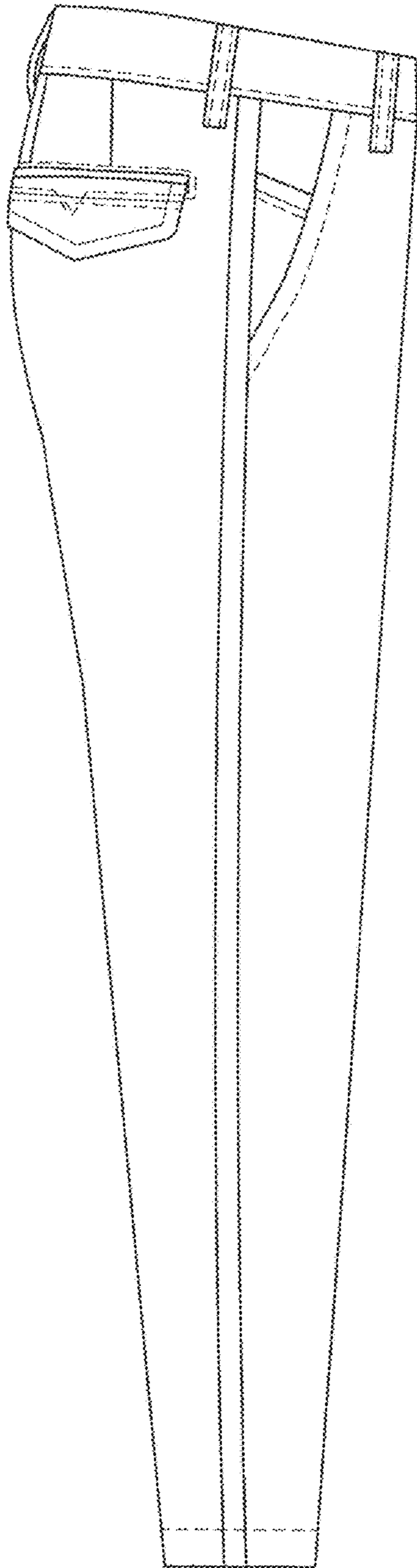

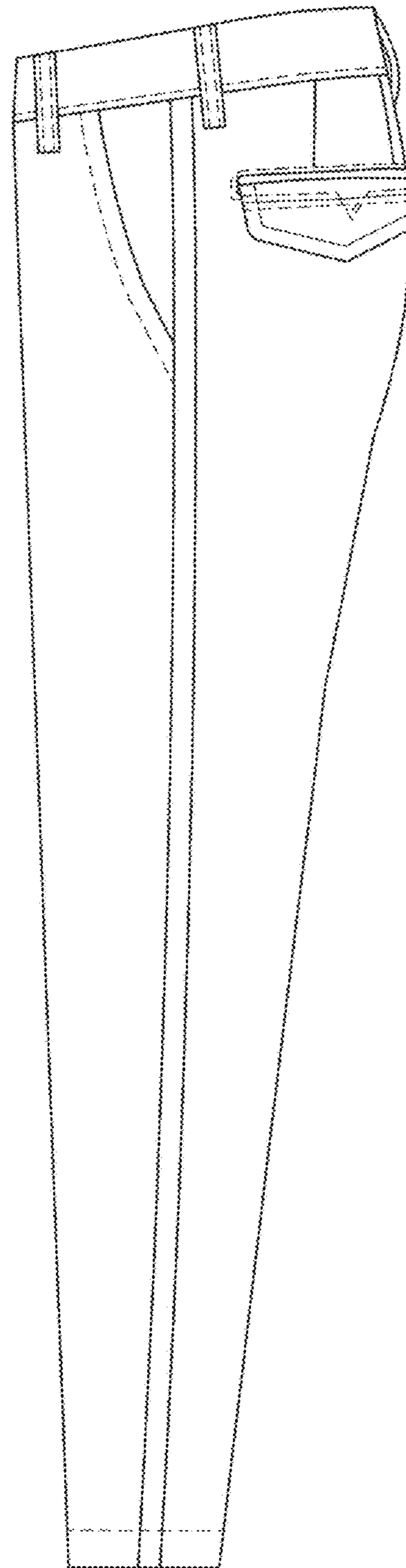

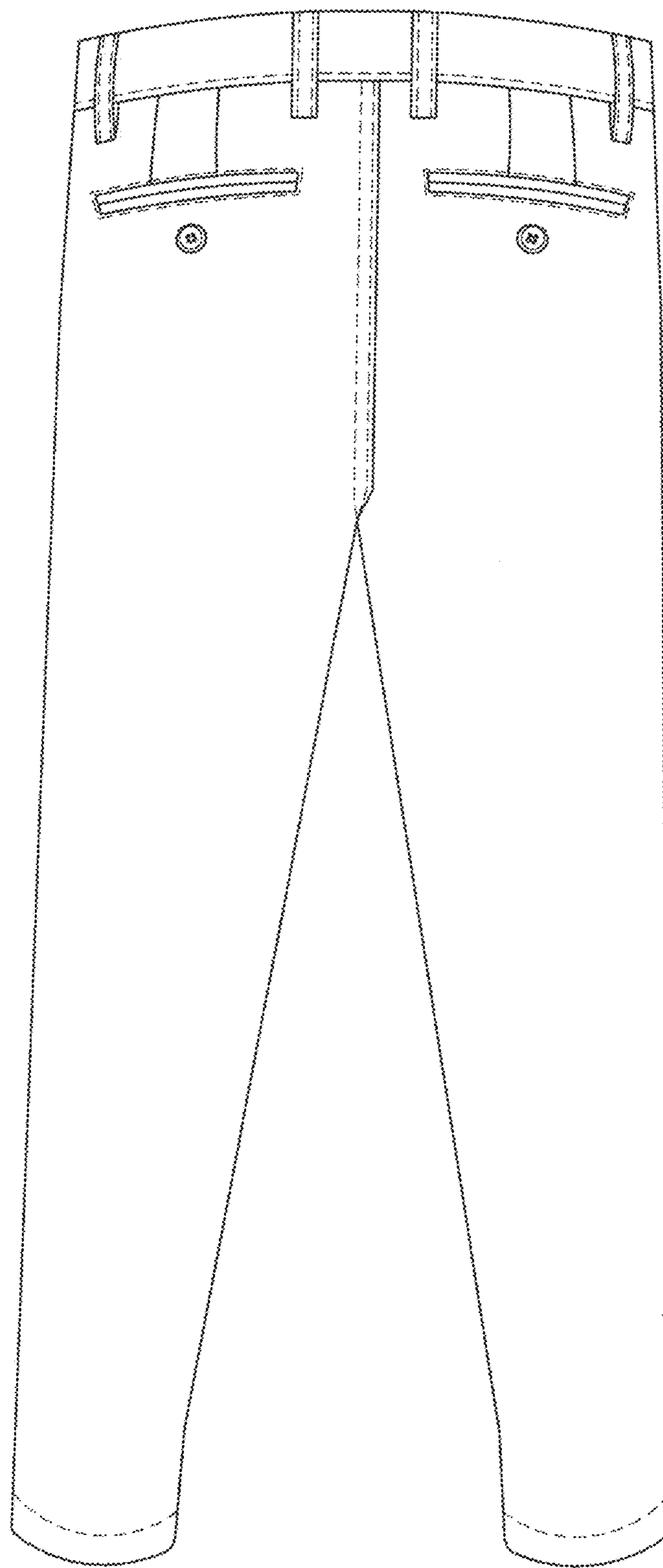

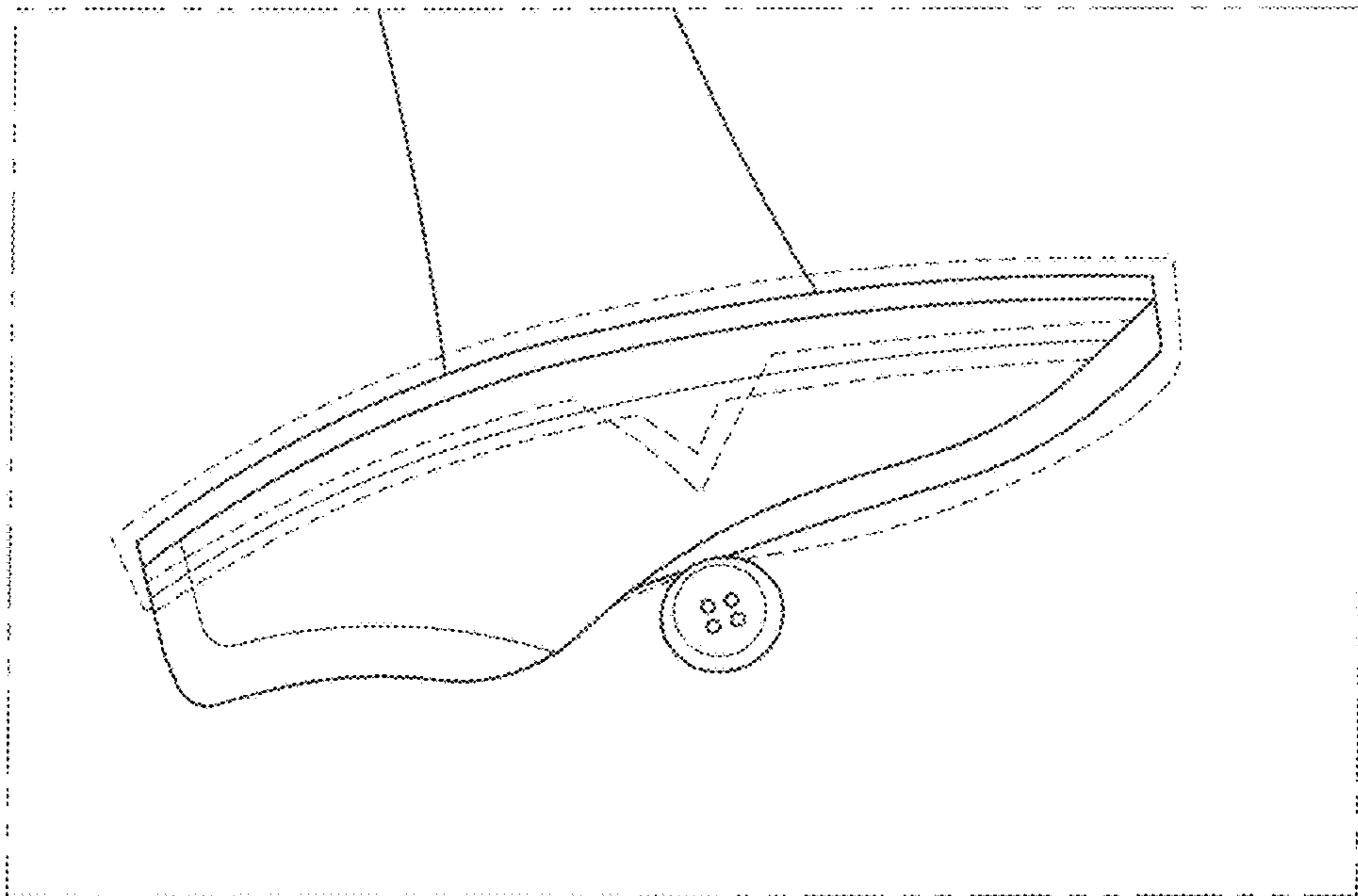
