DESCRIPTION

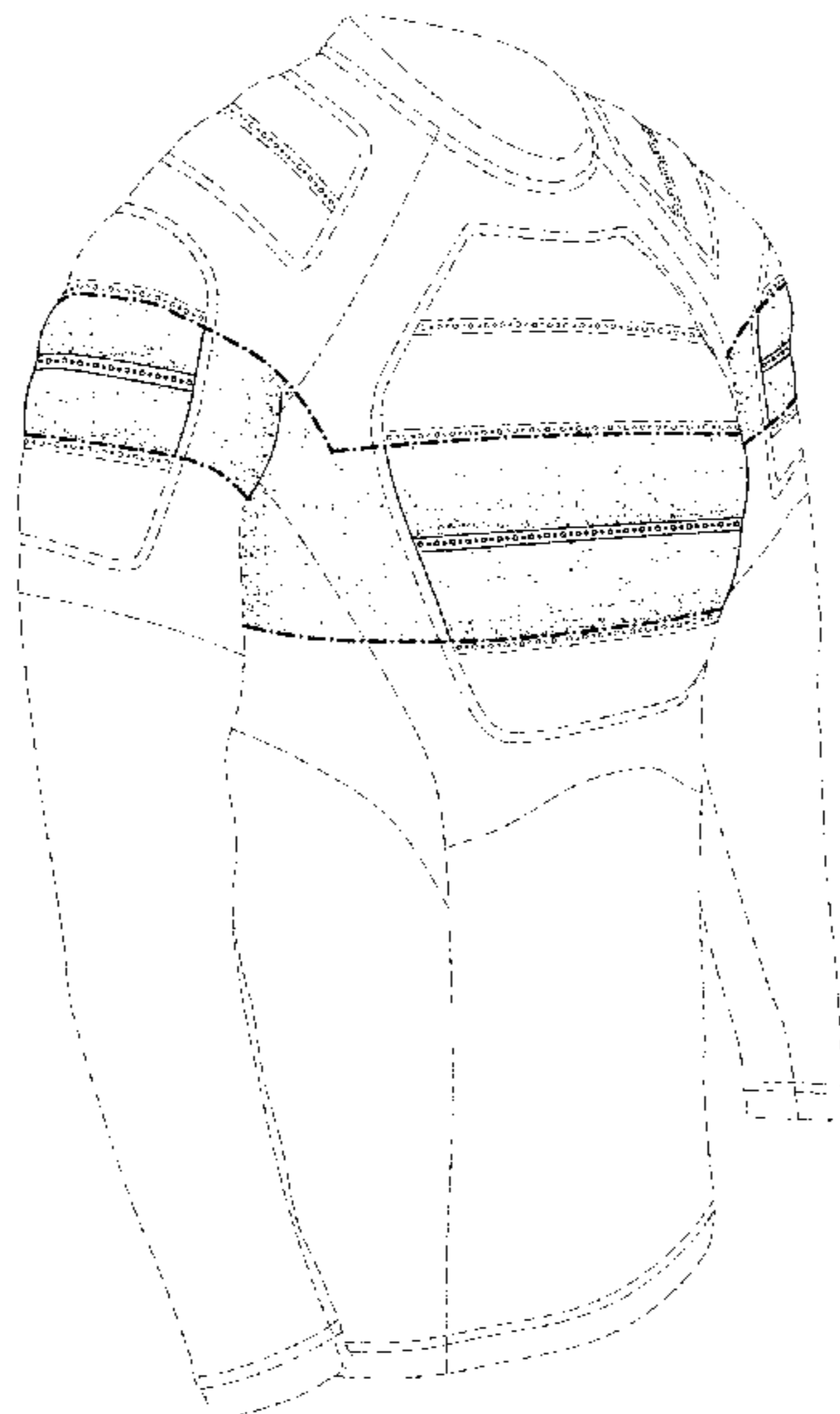
FIG. 1 is a left front perspective view of a shirt according to the present design;

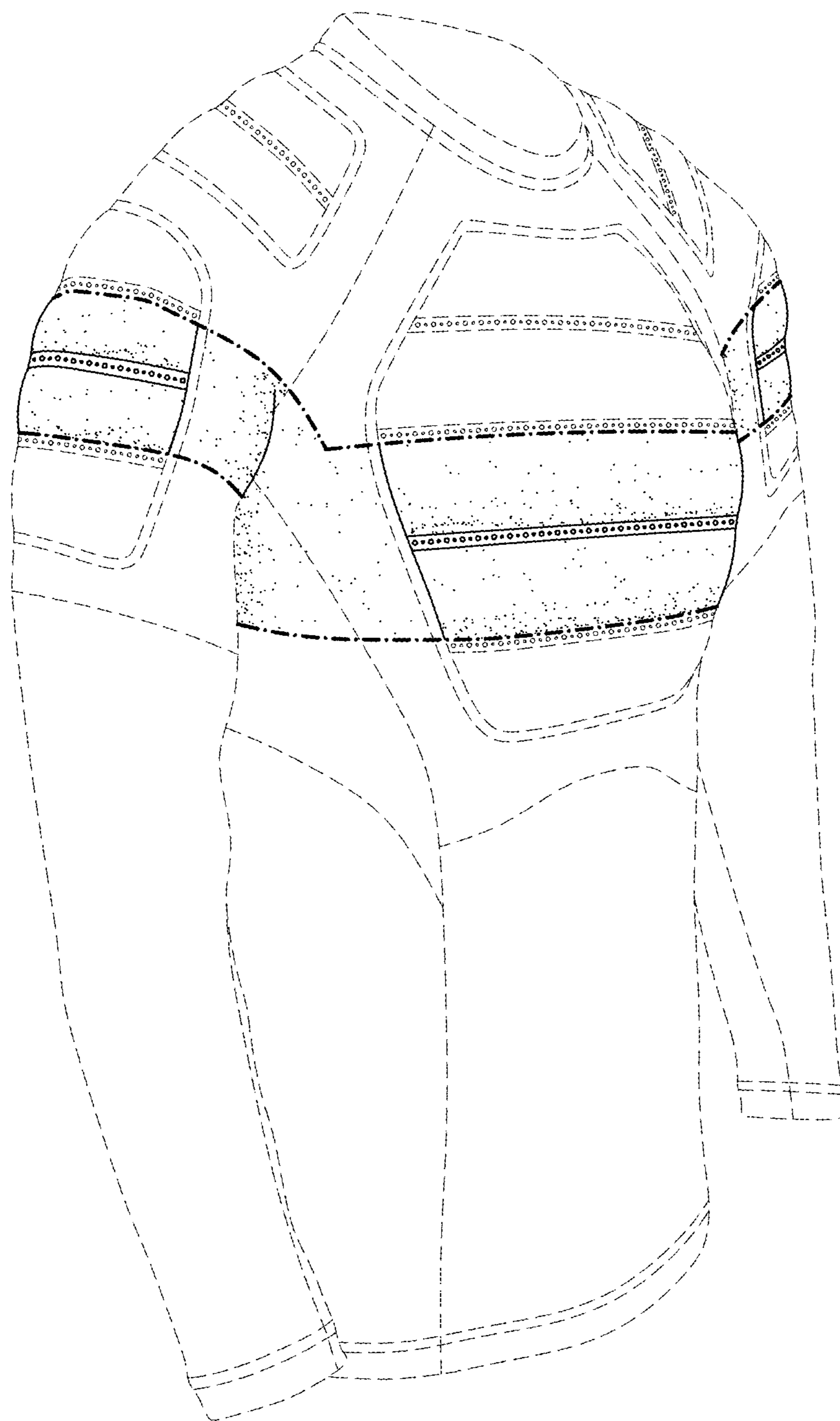

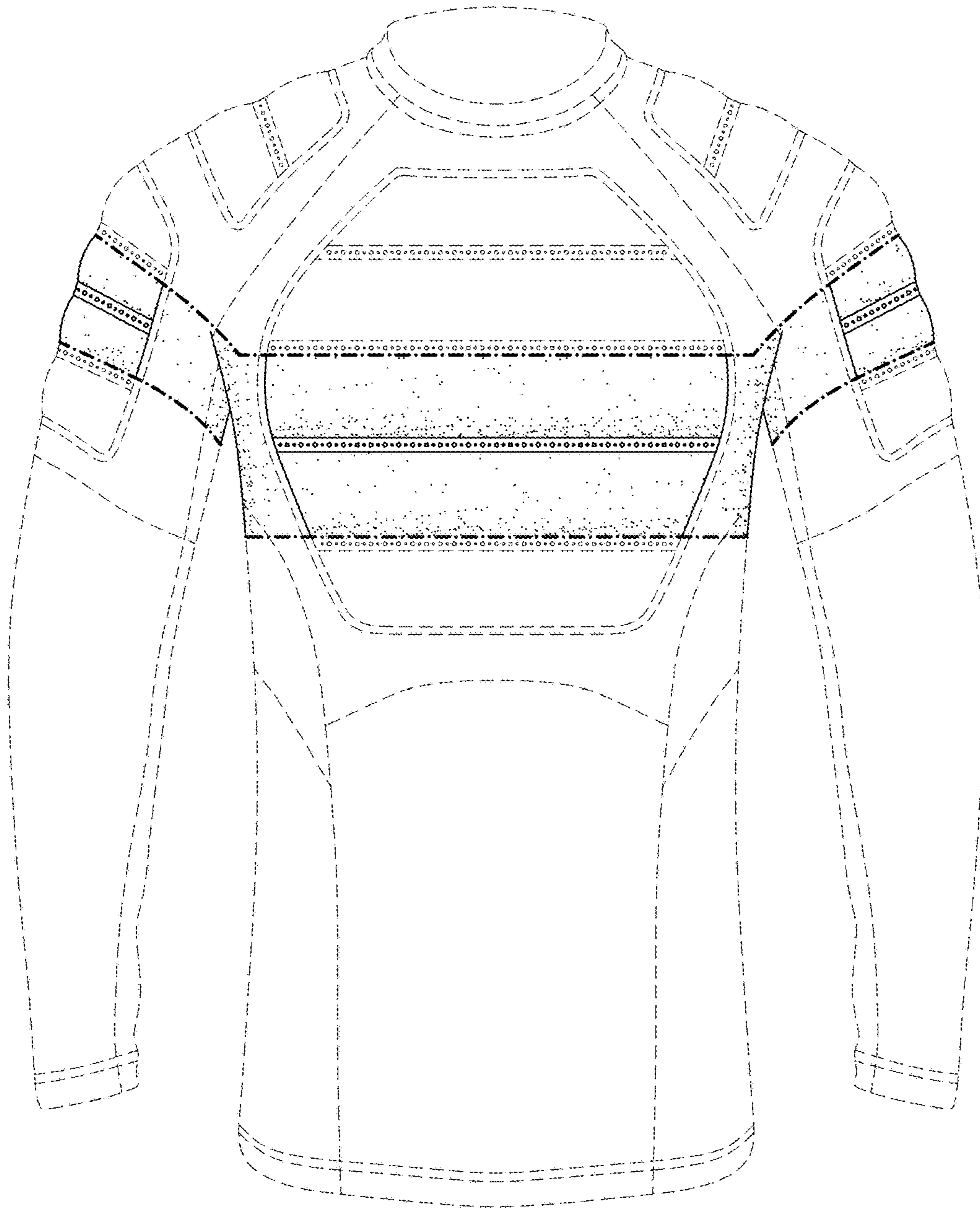

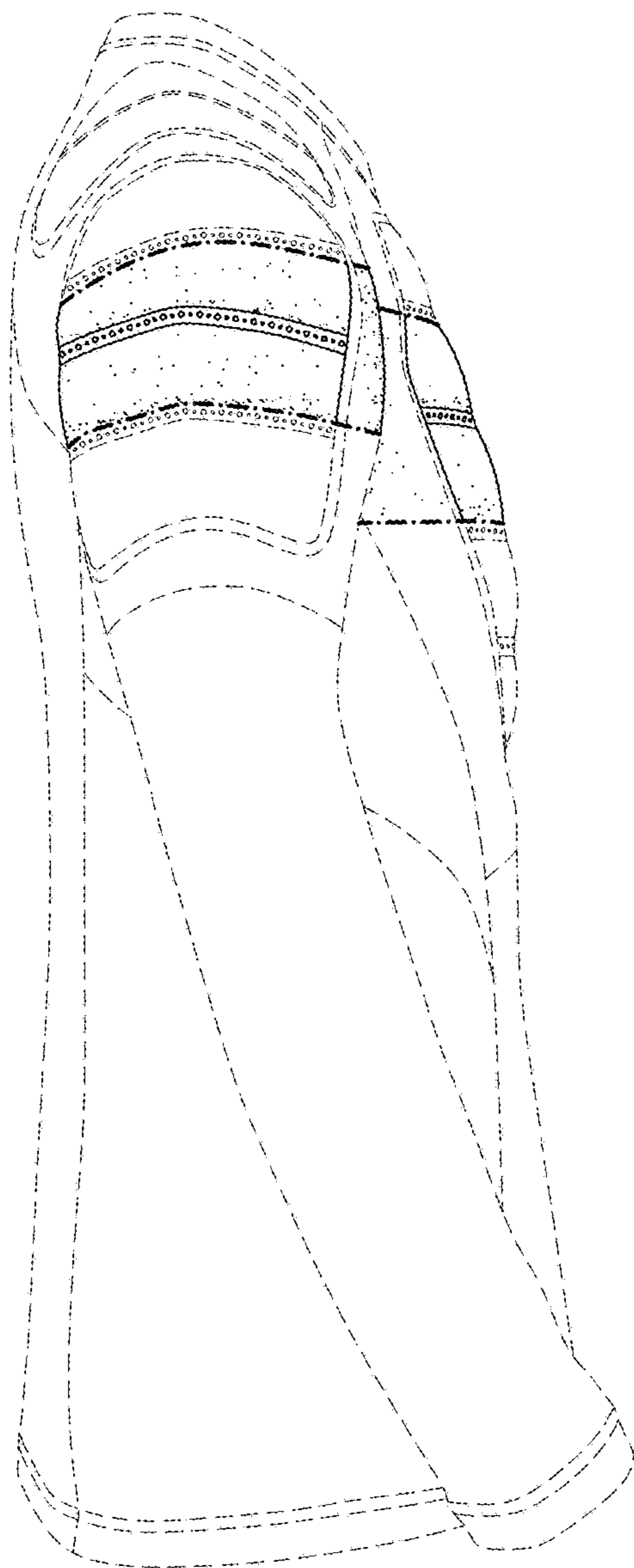

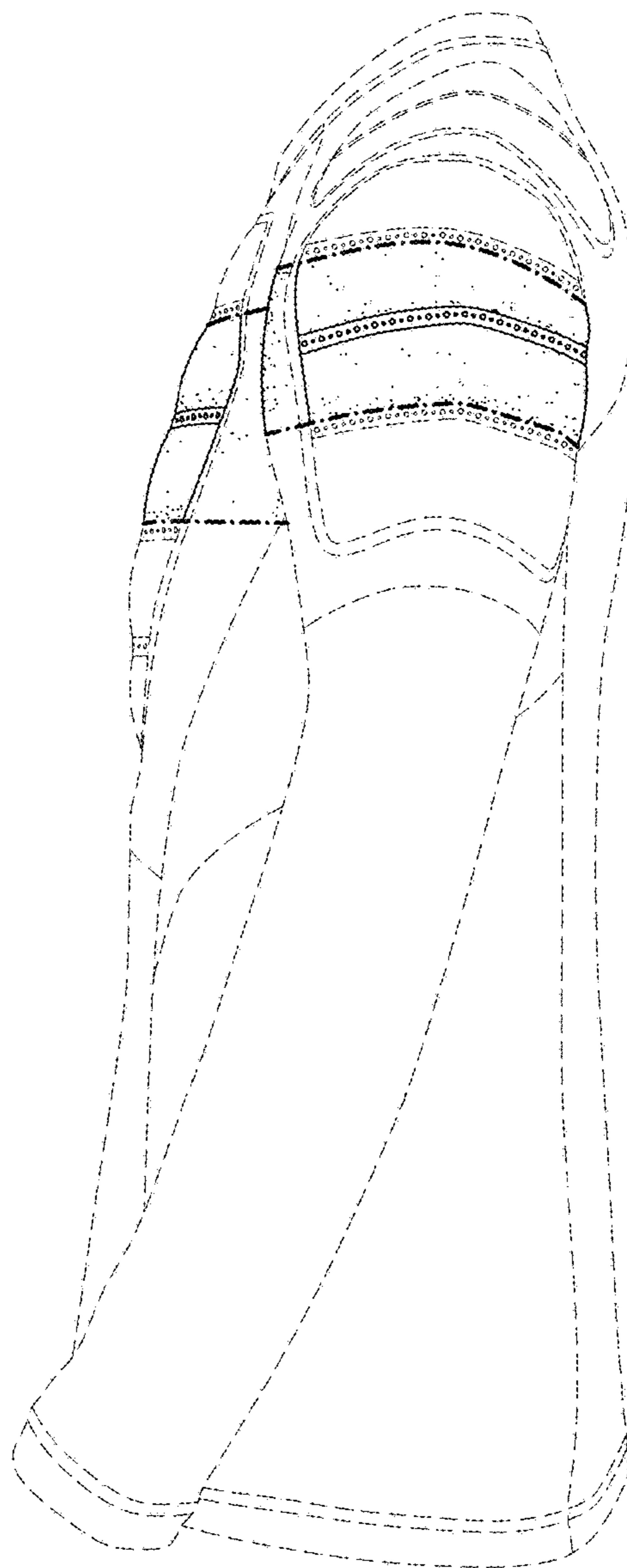

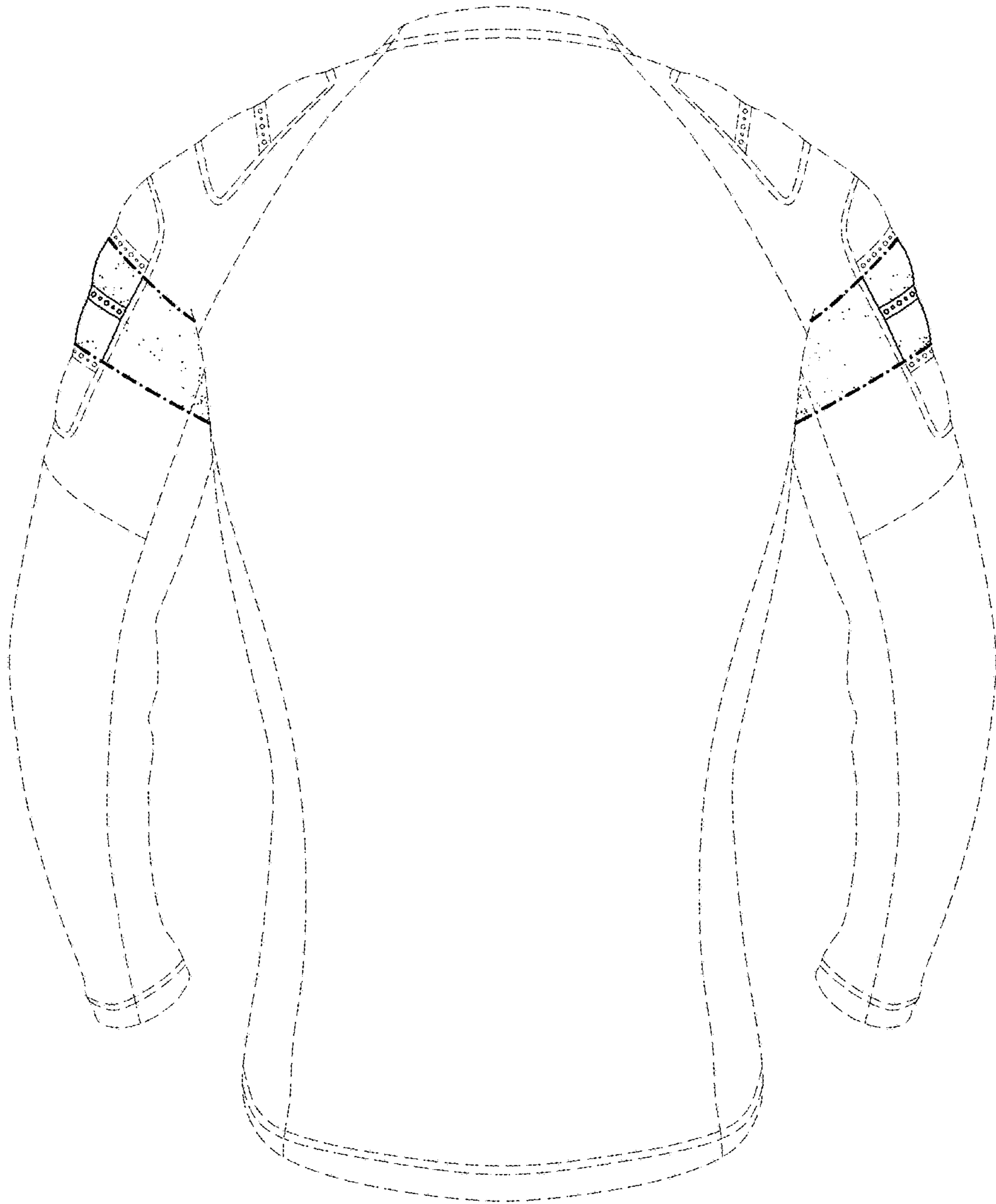
