The ornamental design for a forage cap, as shown and
described.

DESCRIPTION

FIG. 1 is a front-right perspective view of a design for a
forage cap according to the present invention;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevation view thereof;

FIG. 4 is a rear elevation view thereof;

FIG. 5 is a rear-right perspective view thereof;

FIG. 6 is right side elevation view thereof;

FIG. 7 is a left side elevation view thereof;

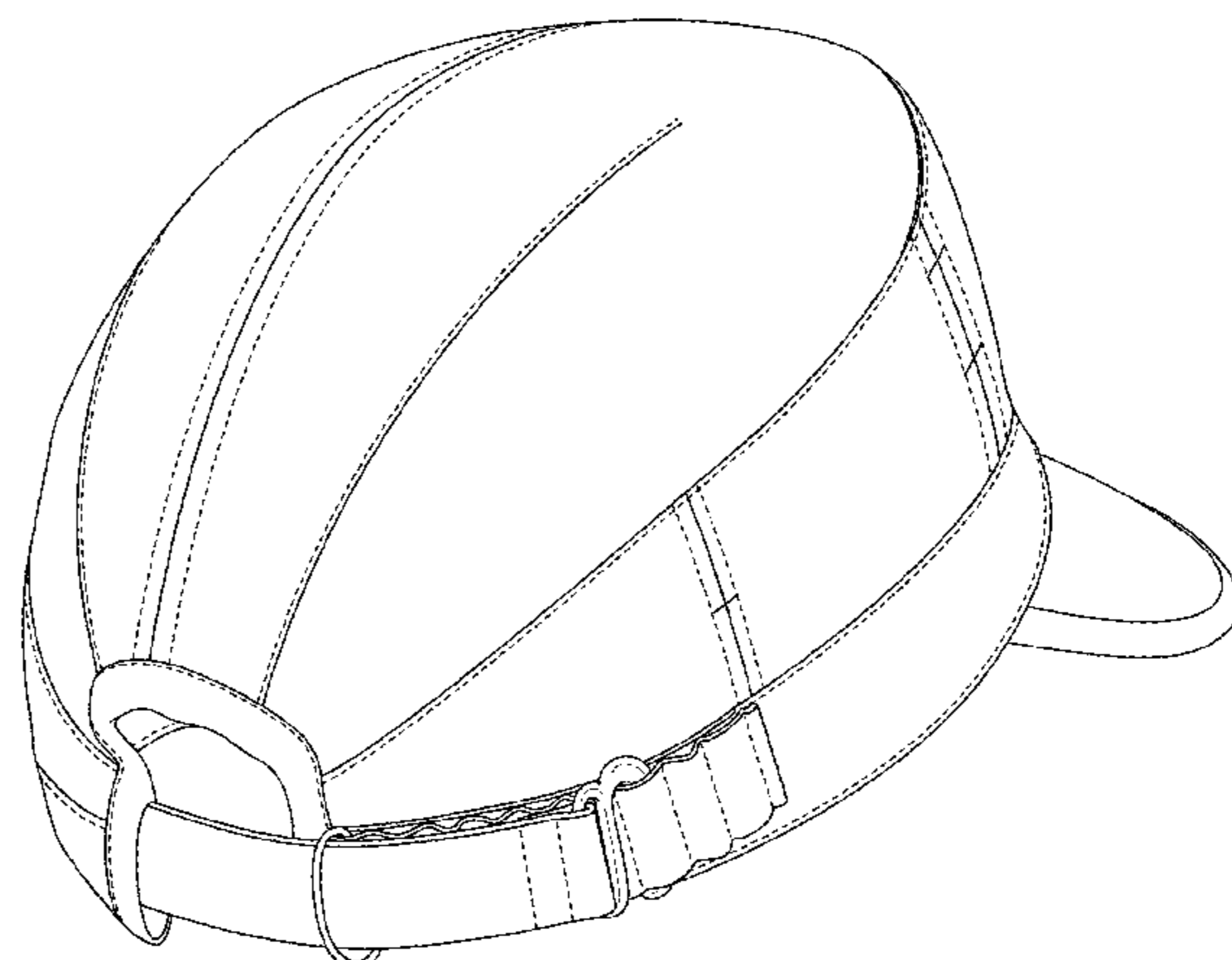
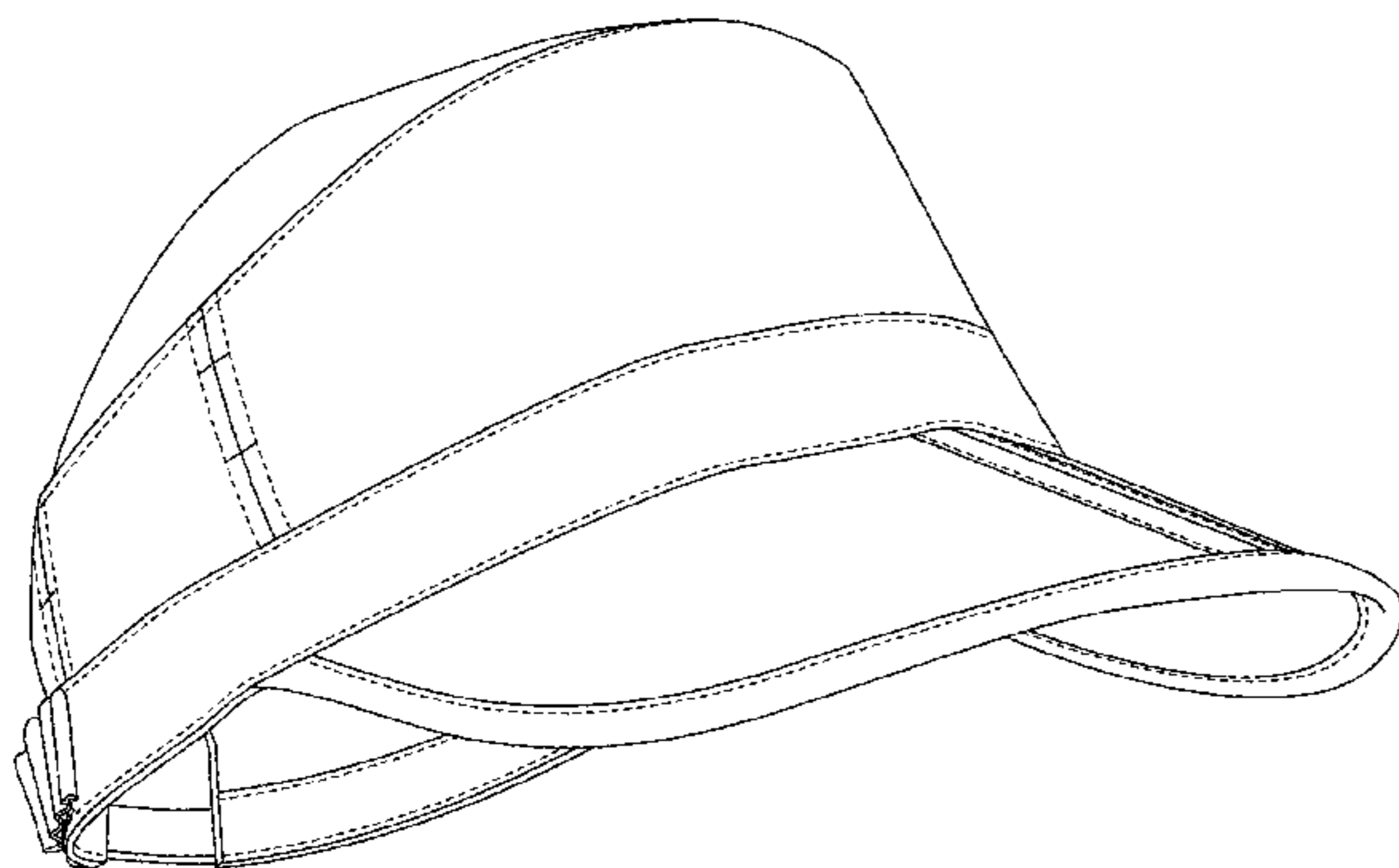
FIG. 8 is a bottom plan view thereof;

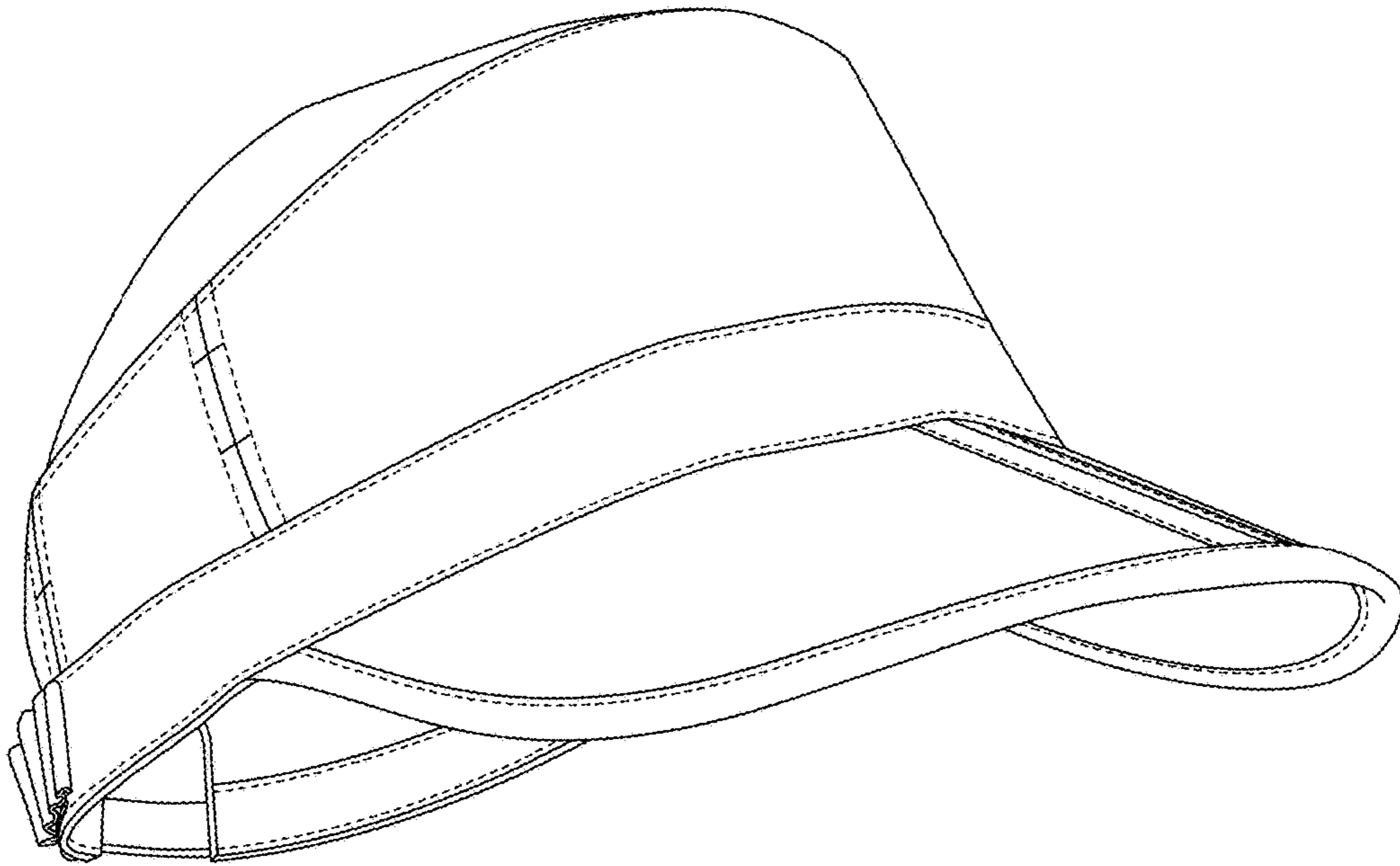

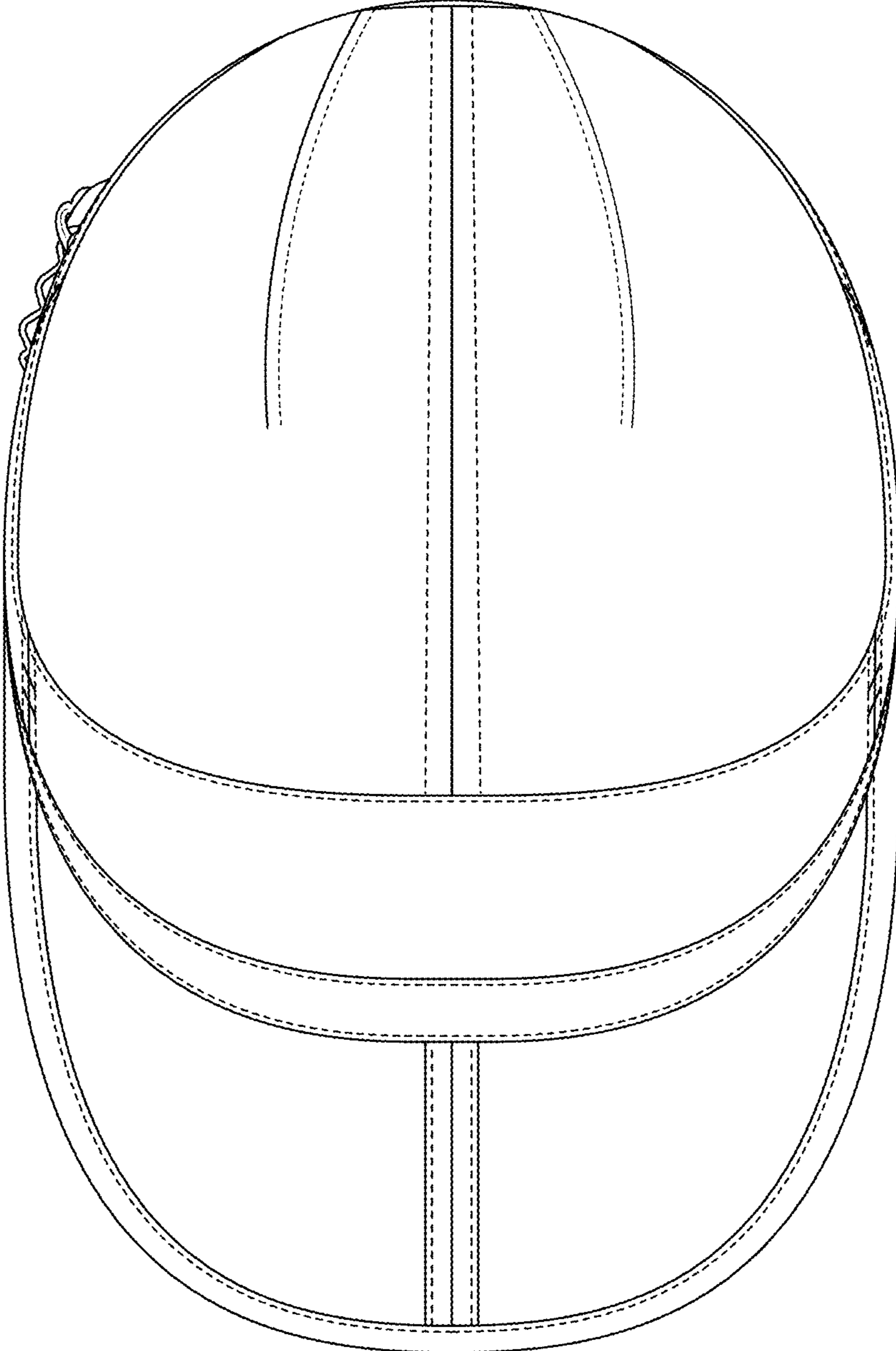

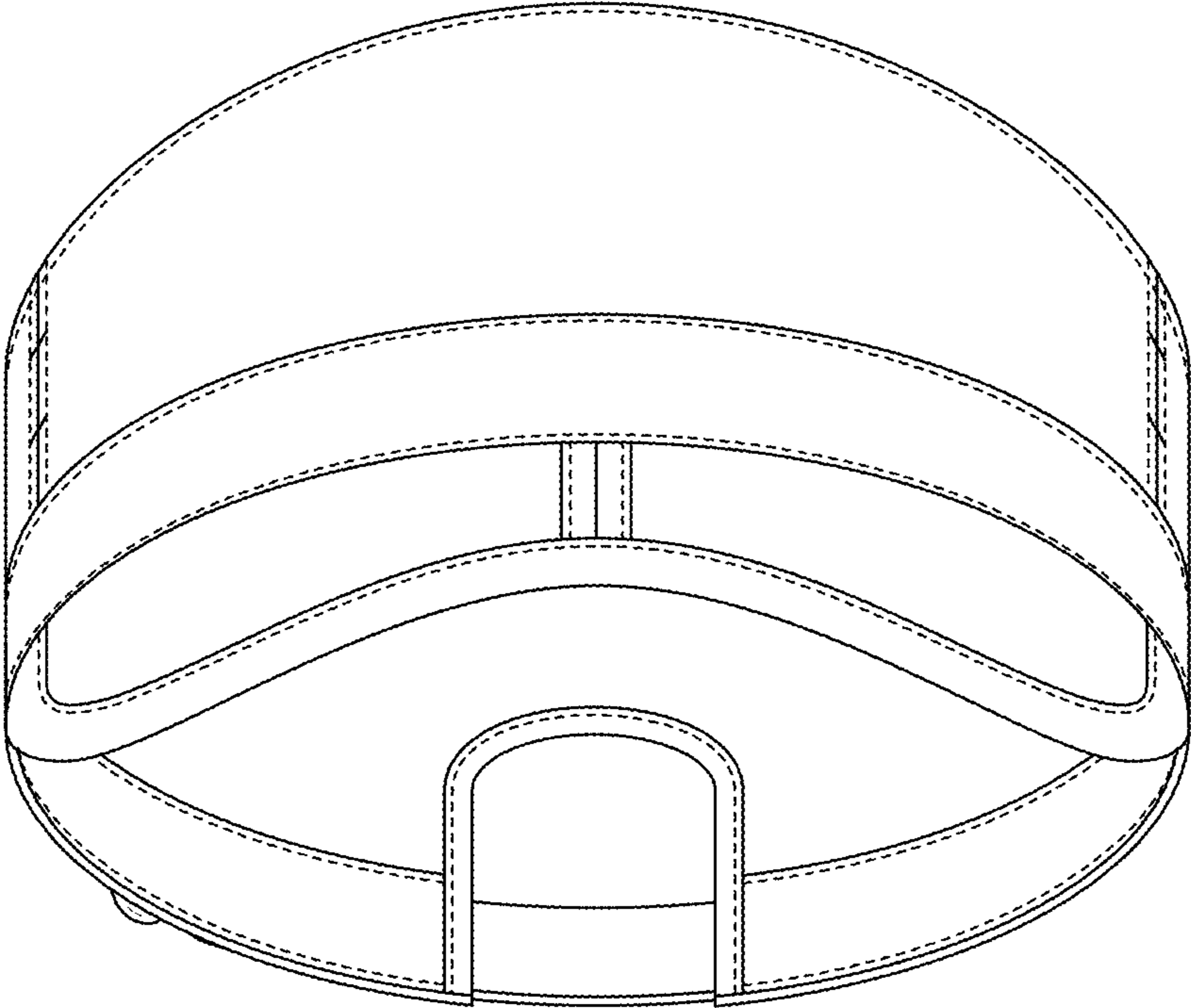

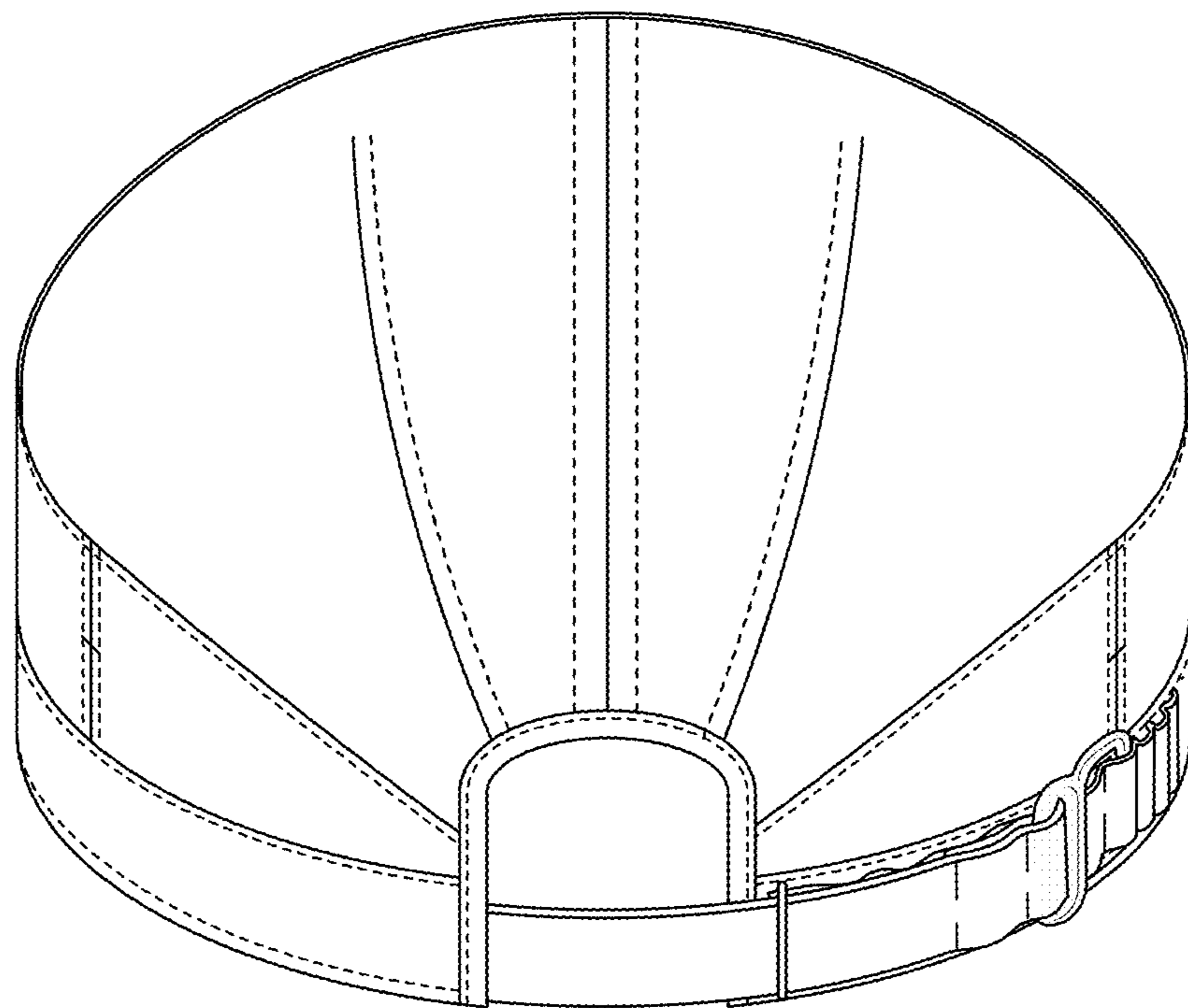

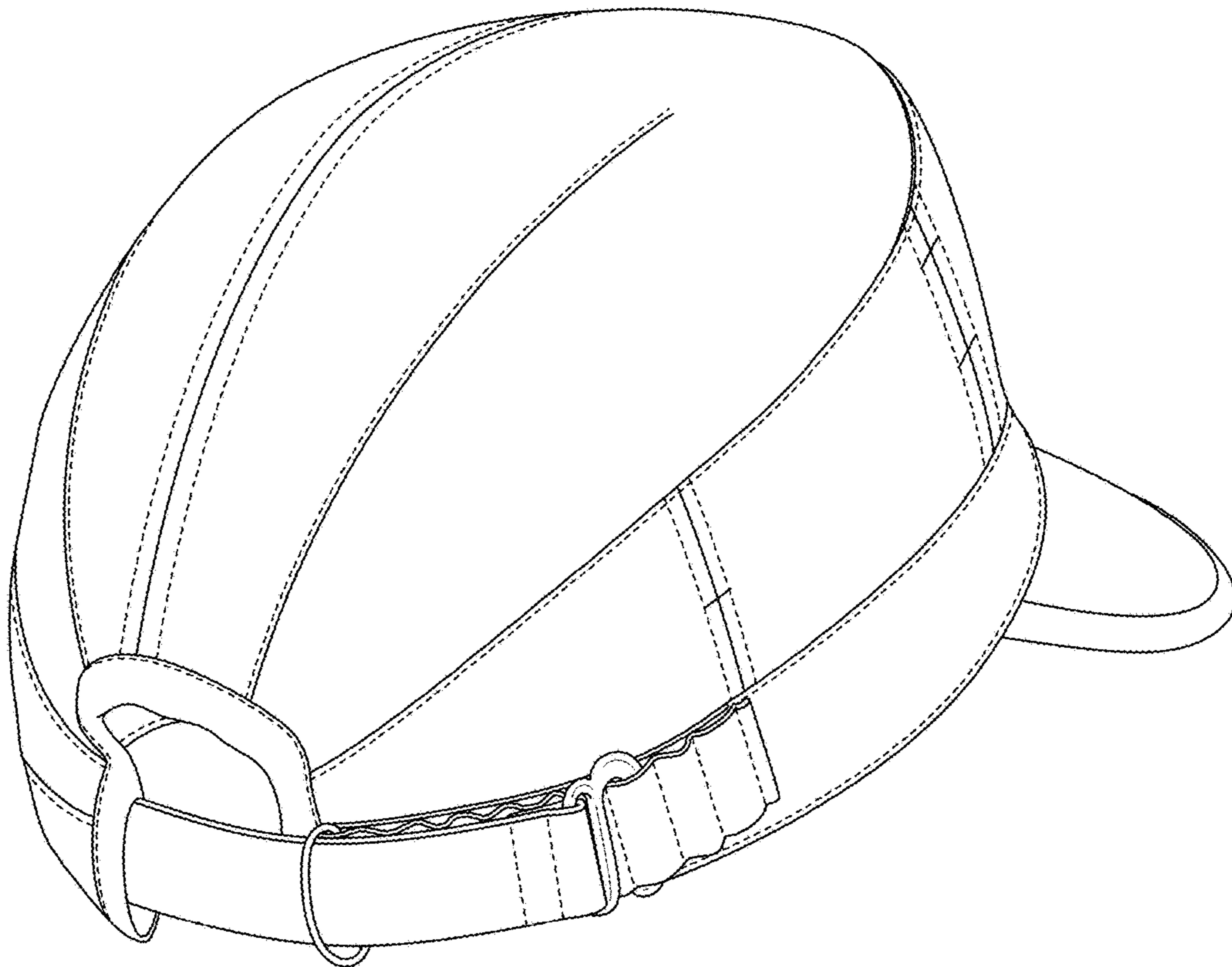

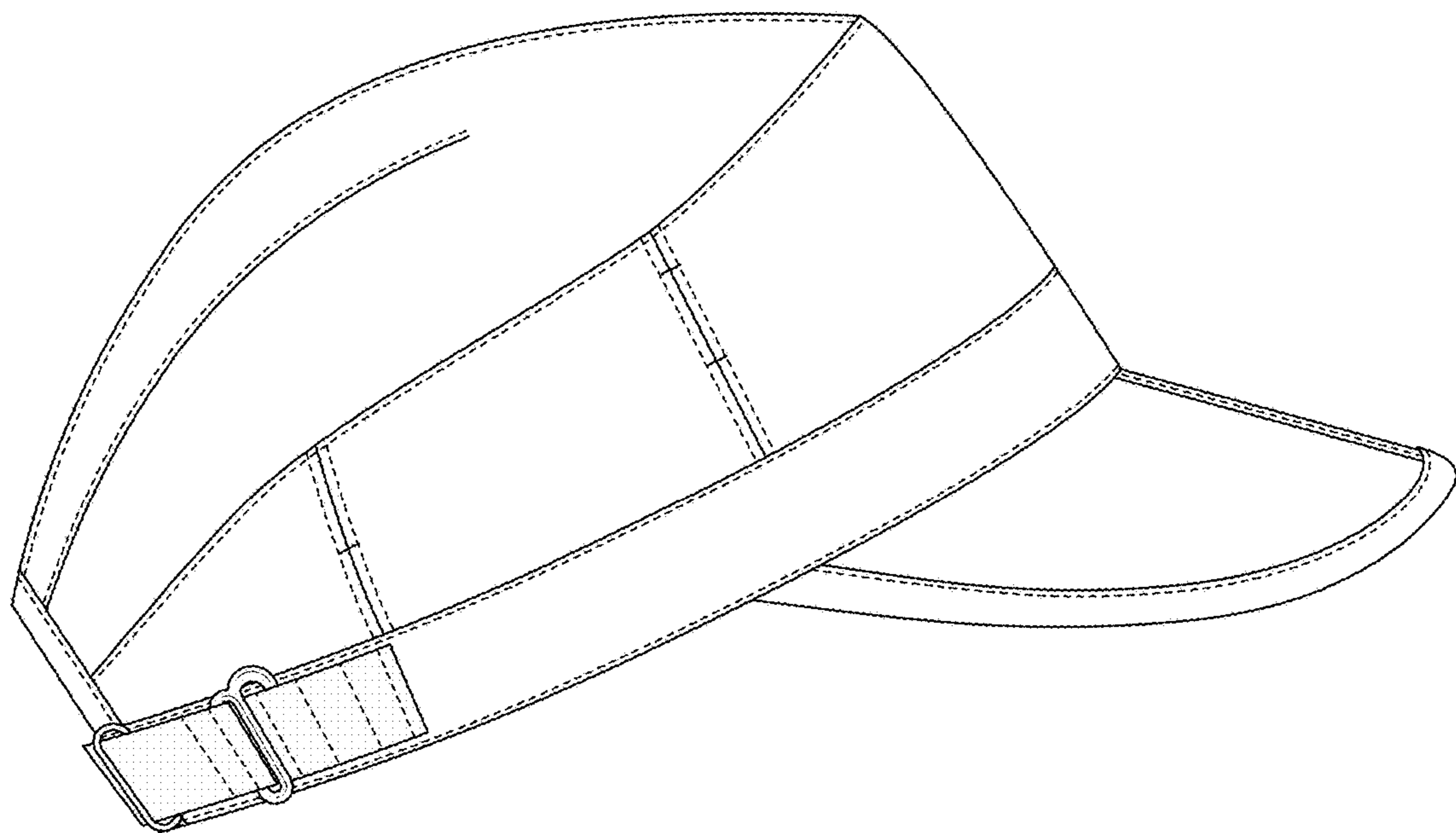

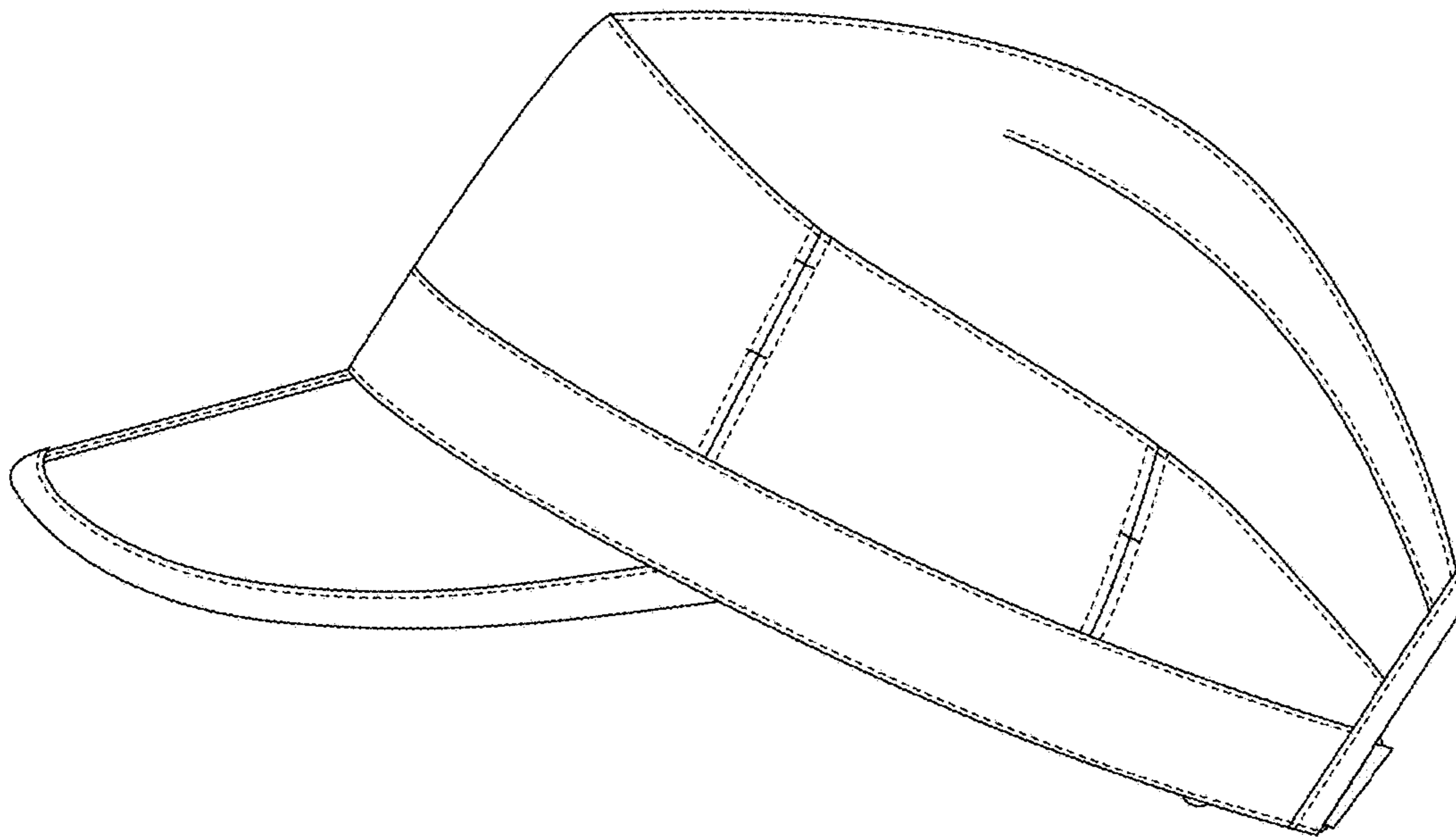

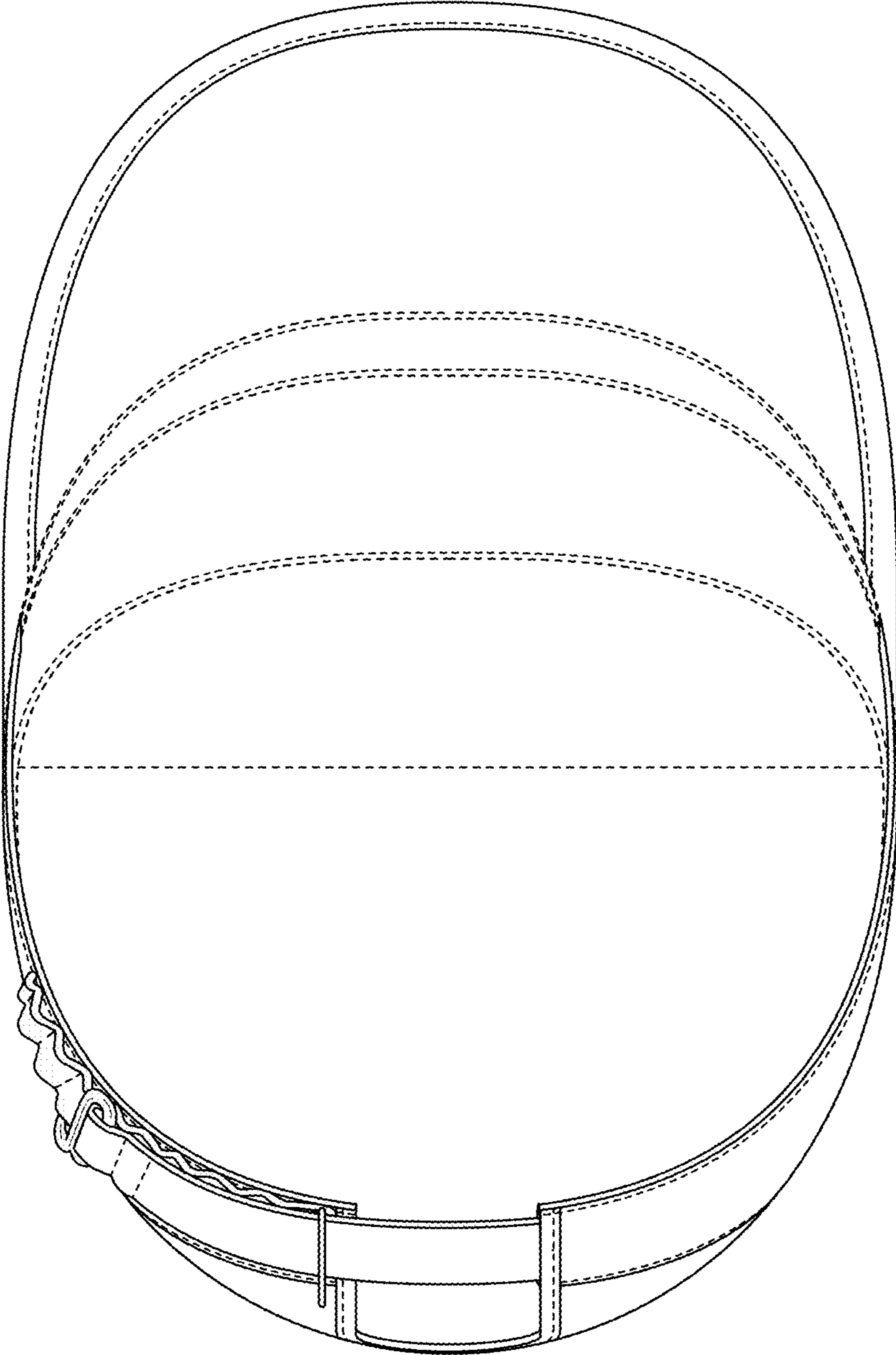

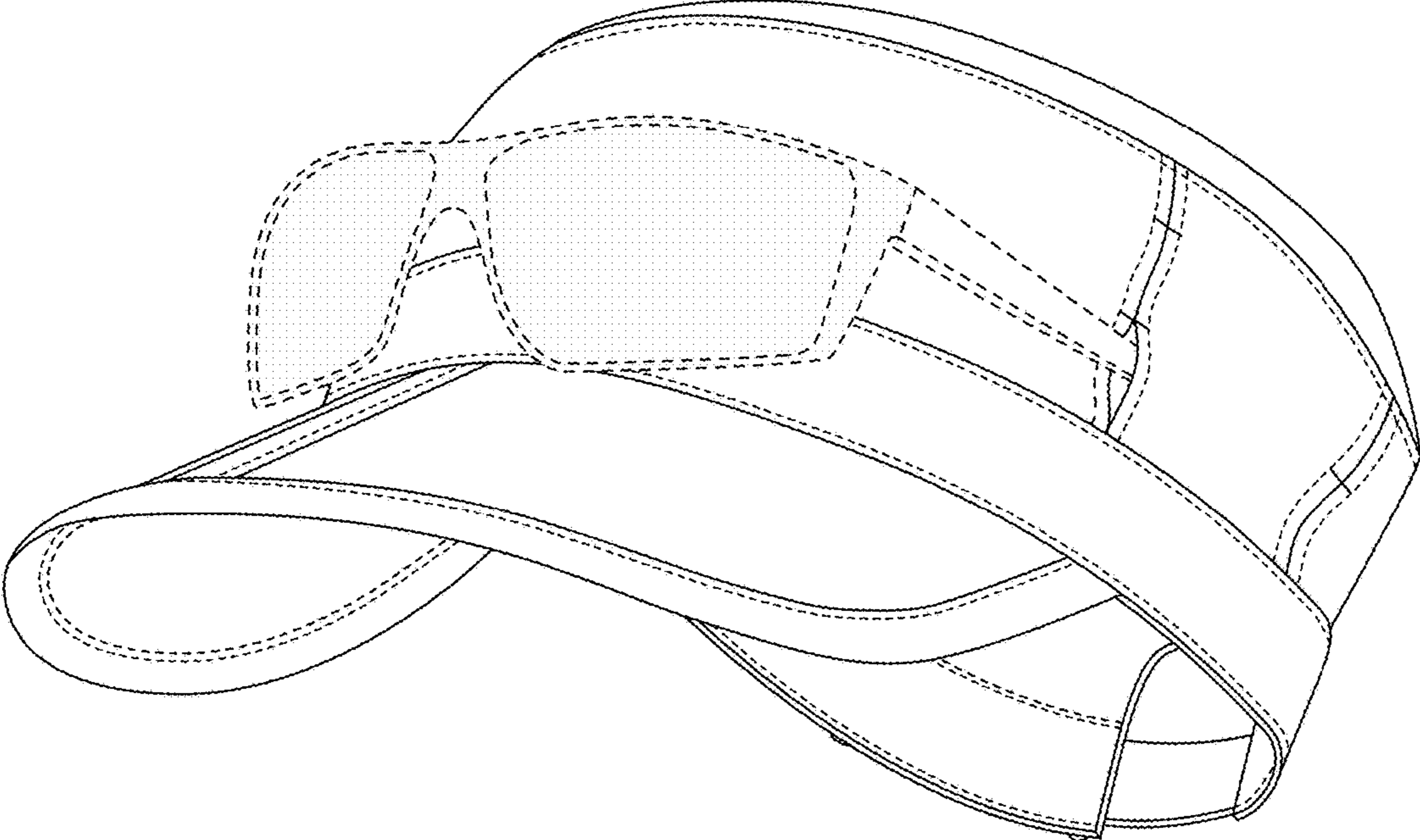

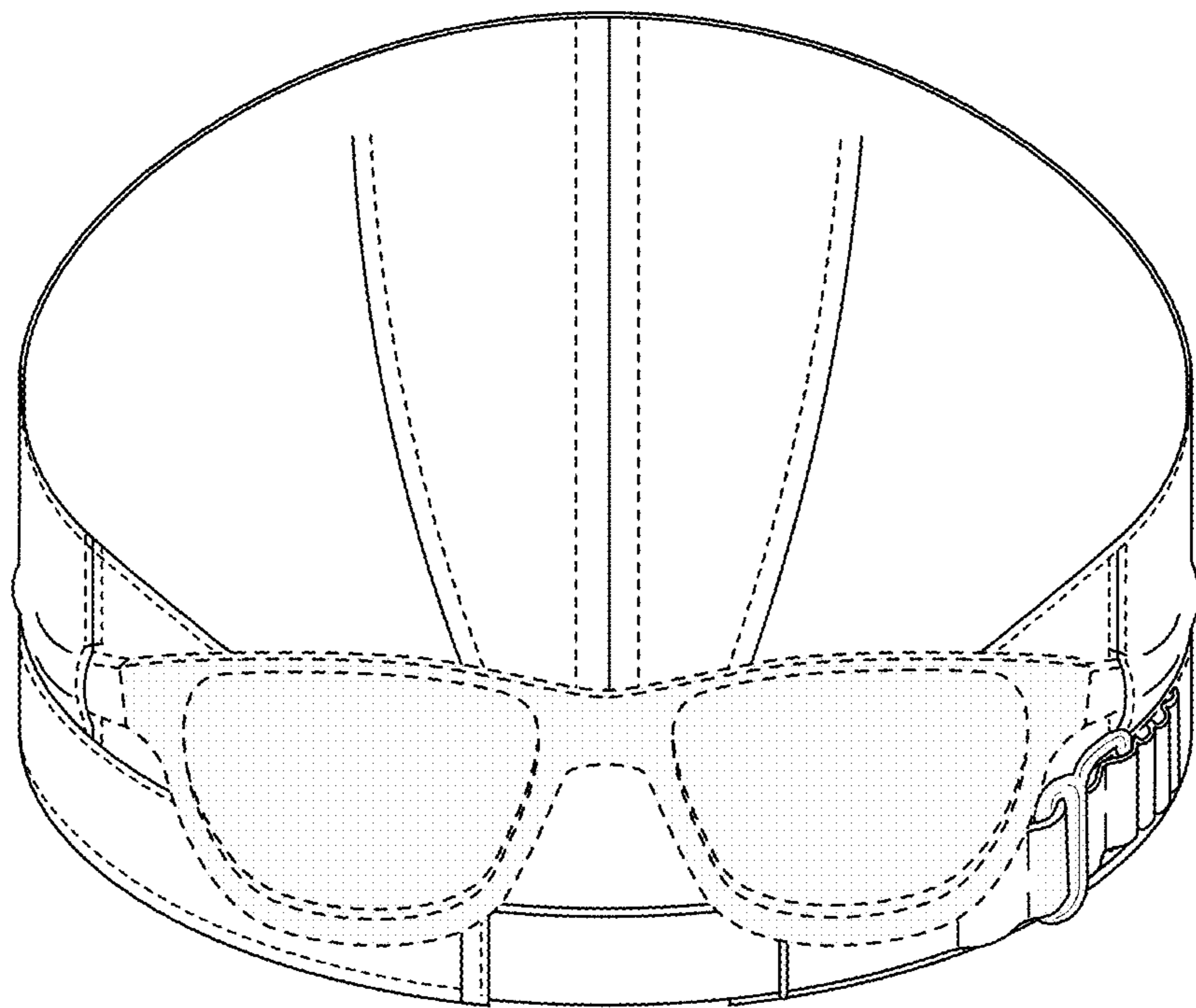
