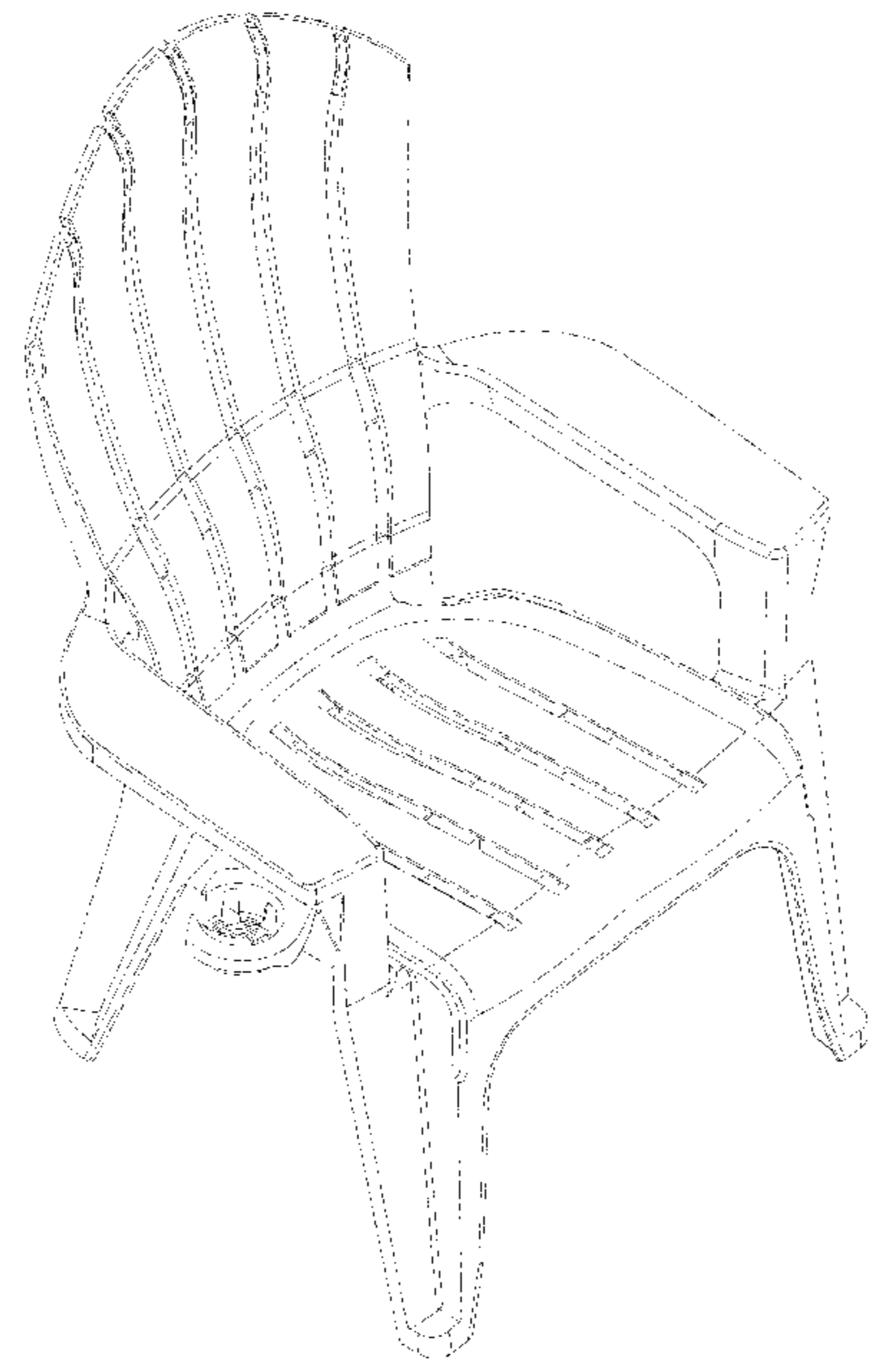
(57) **CLAIM**

The ornamental design for a chair with retractable cup holder, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of our chair with retractable cup holder with the cup holder in a retracted position, FIG. 2 is a front view thereof, FIG. 3 is a left side view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a rear view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom view thereof; and, FIG. 8 is a front perspective view similar to FIG. 1 with the cup holder in an extended position.

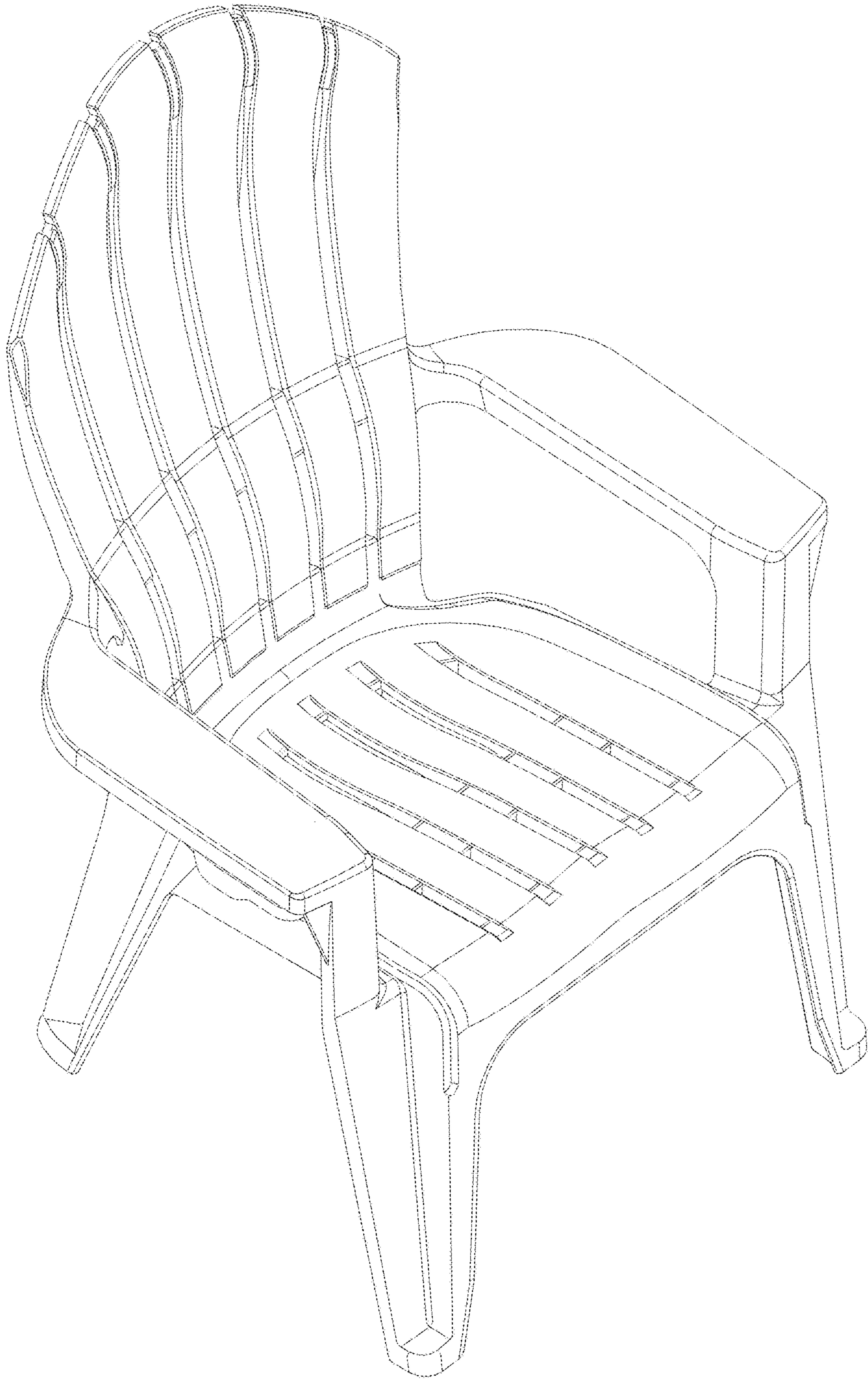

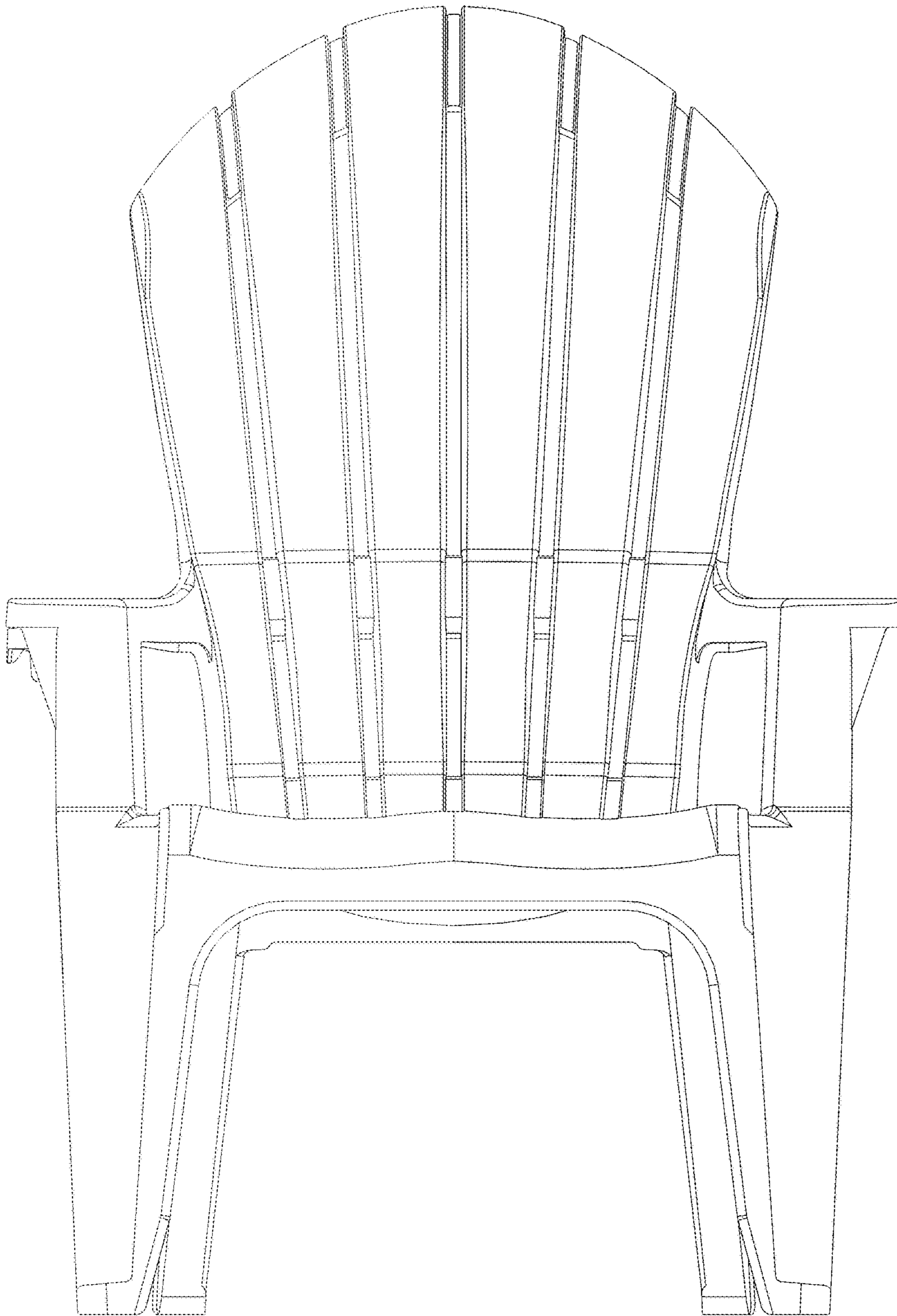

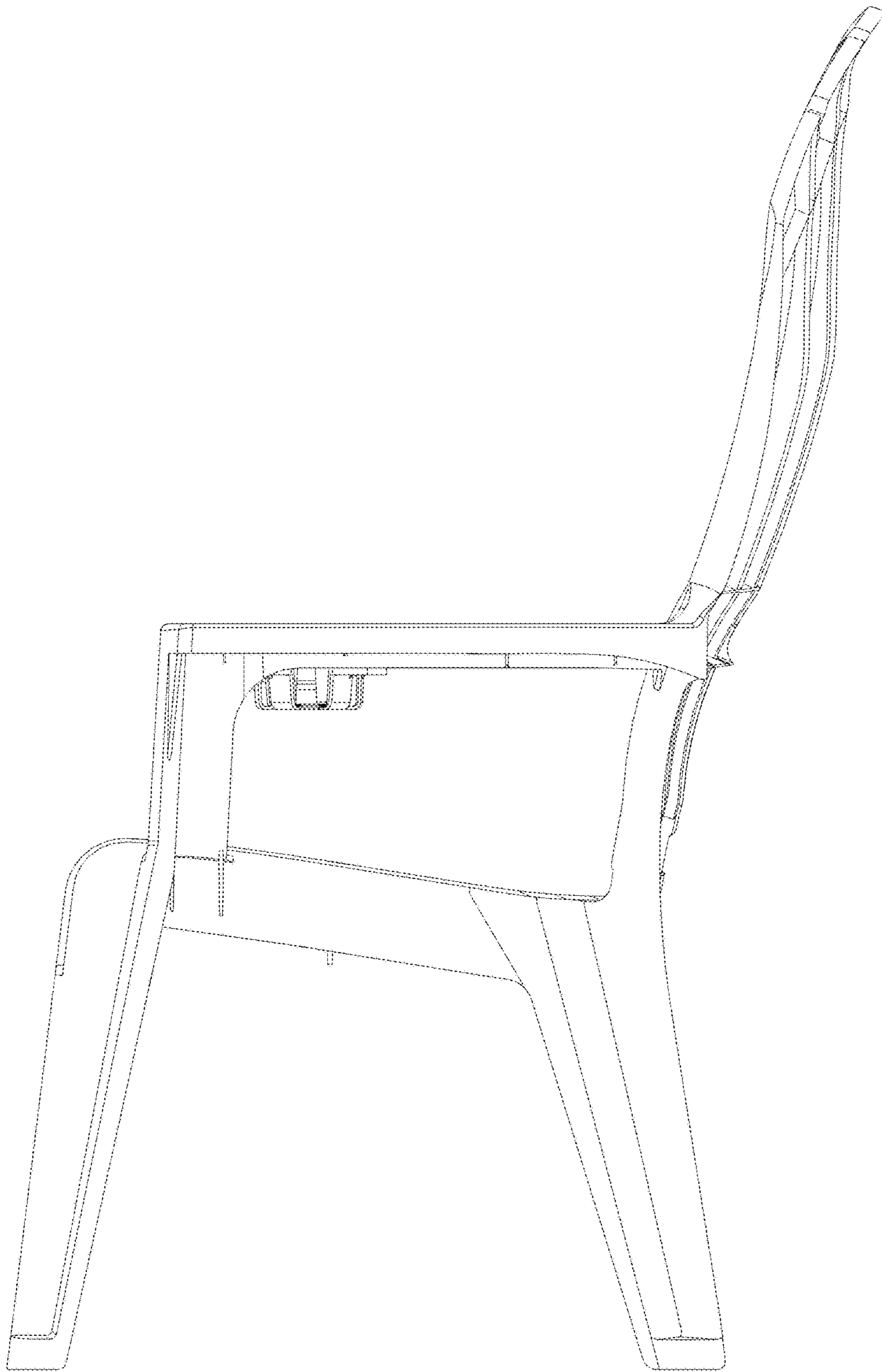

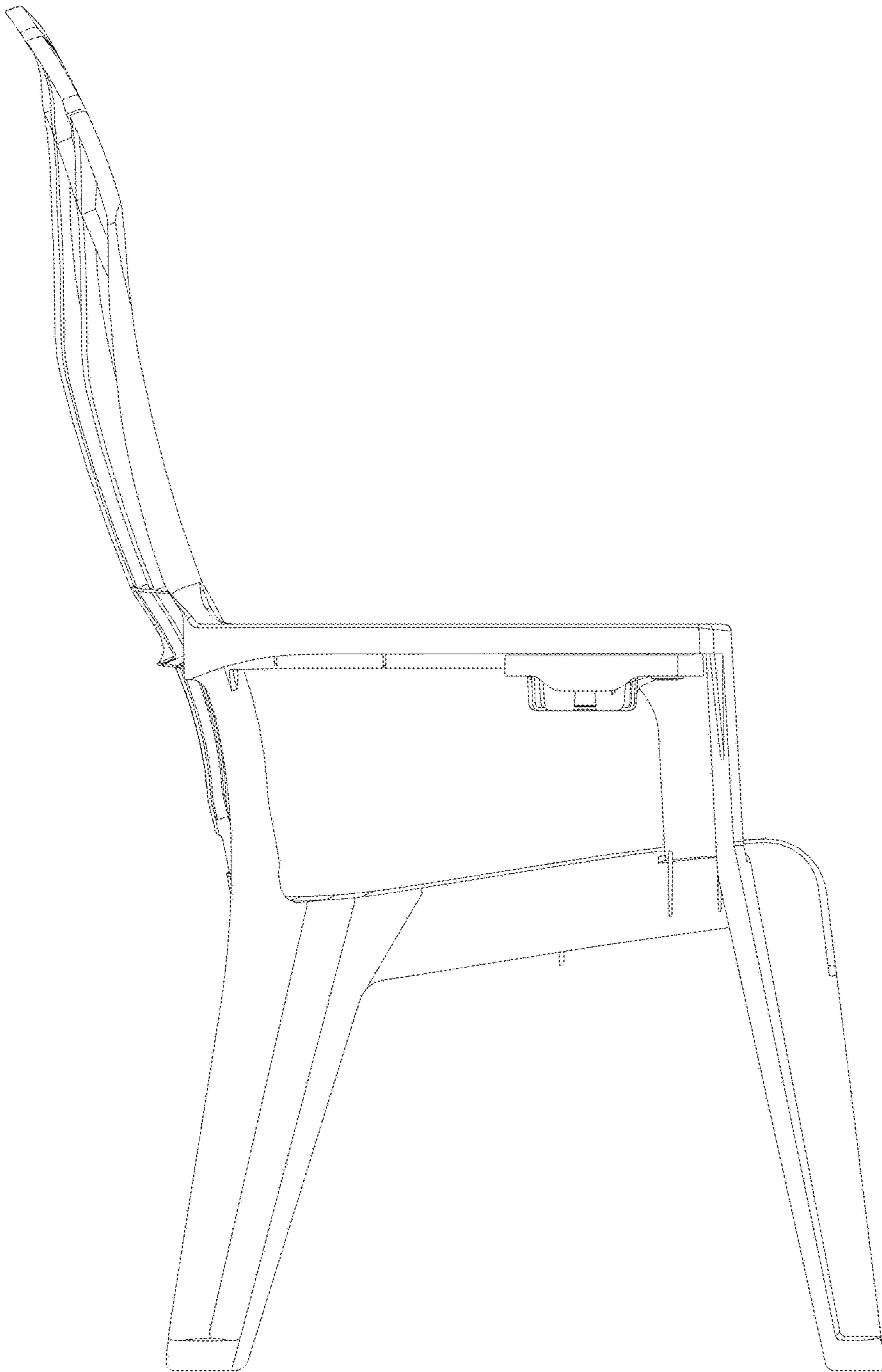

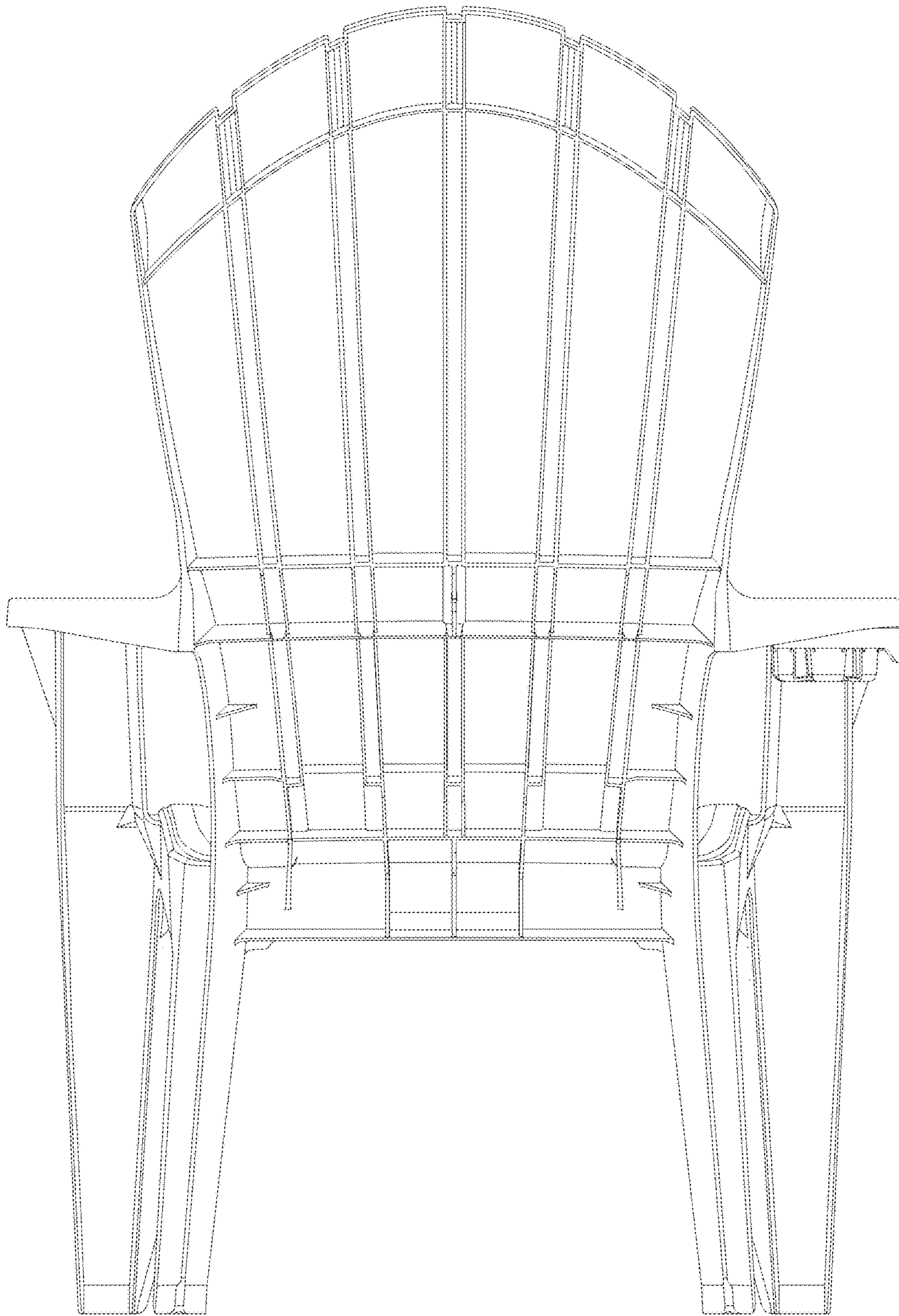

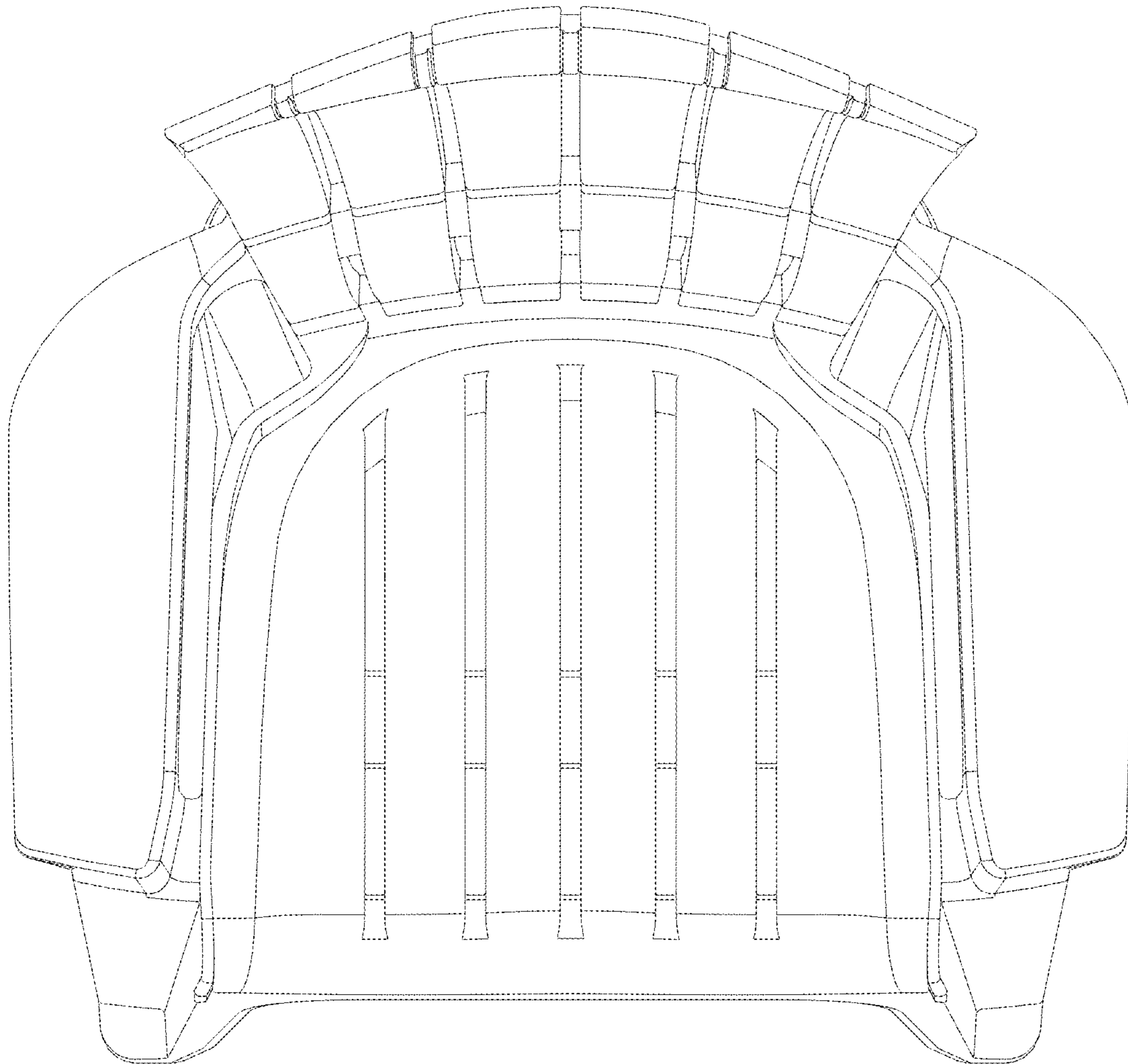

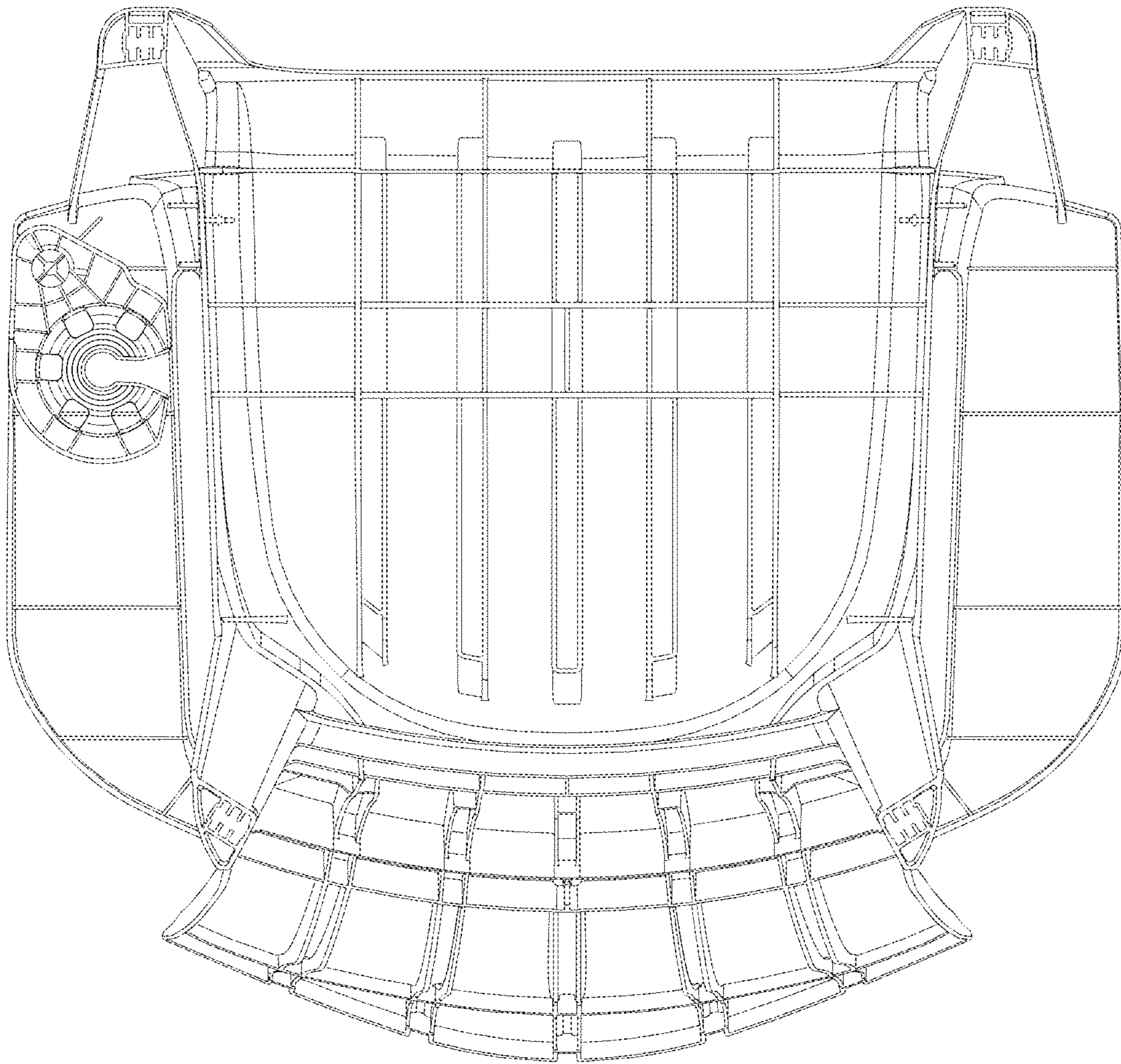

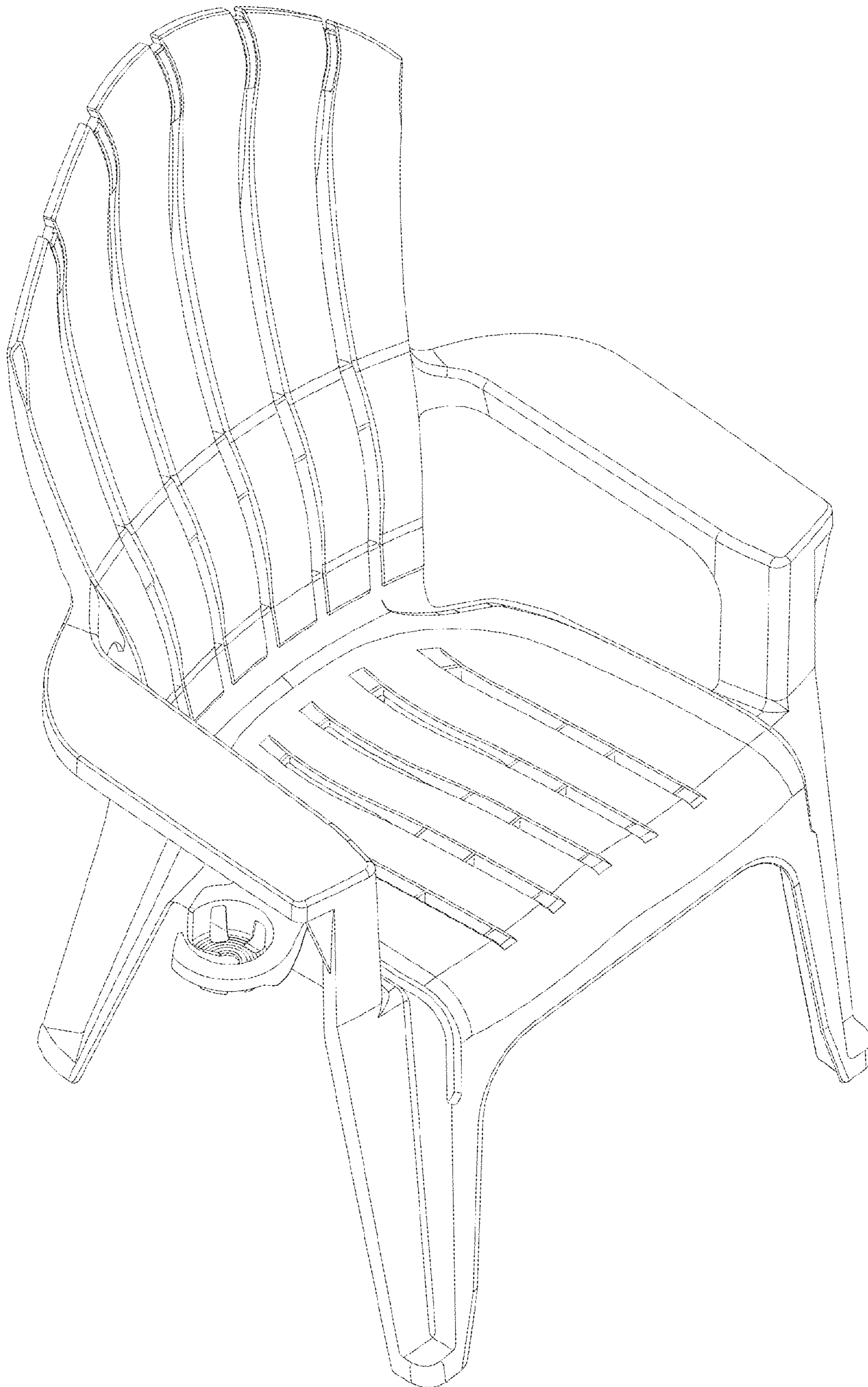
