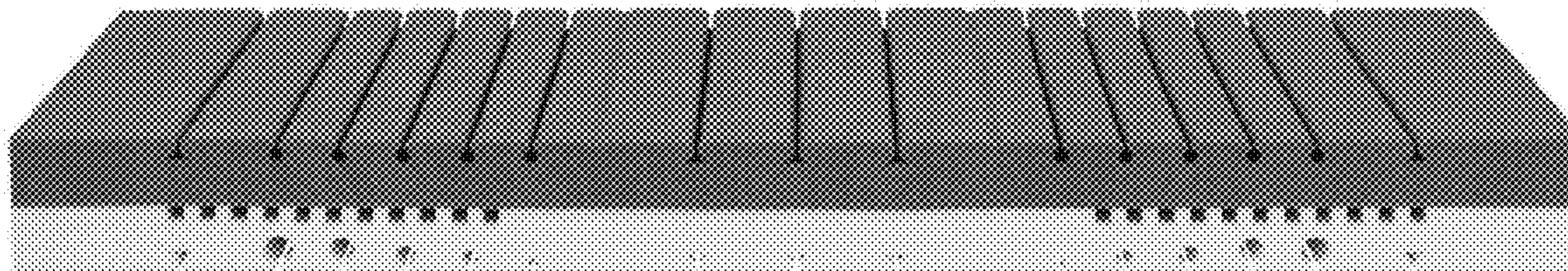

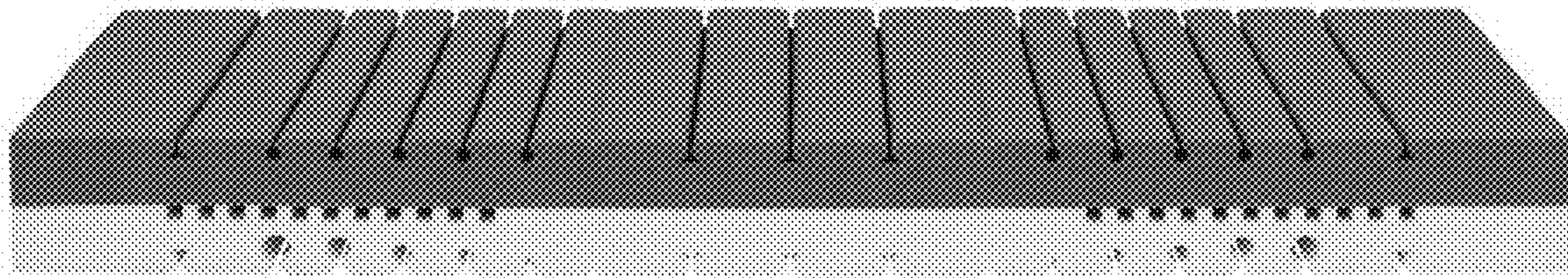
(57) **CLAIM**

1.3 is an enlarged fragmentary top perspective.

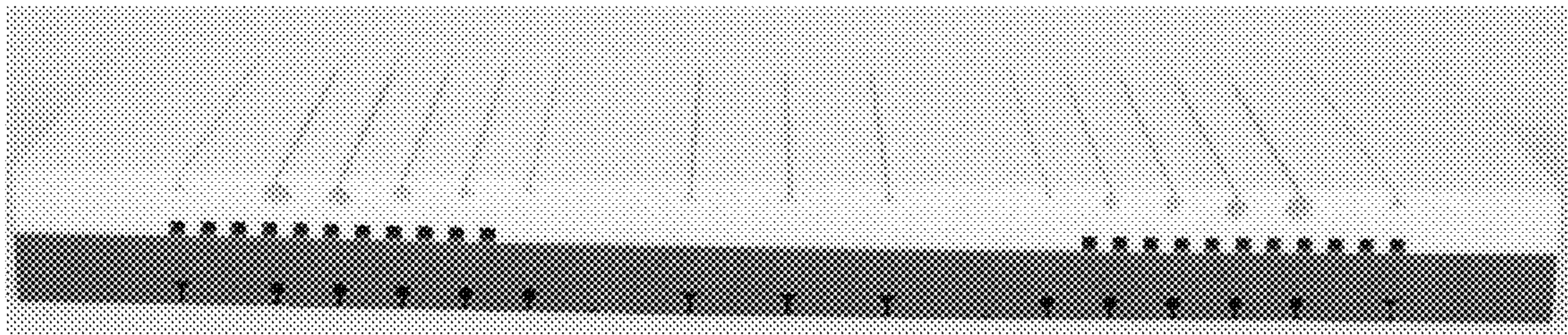
