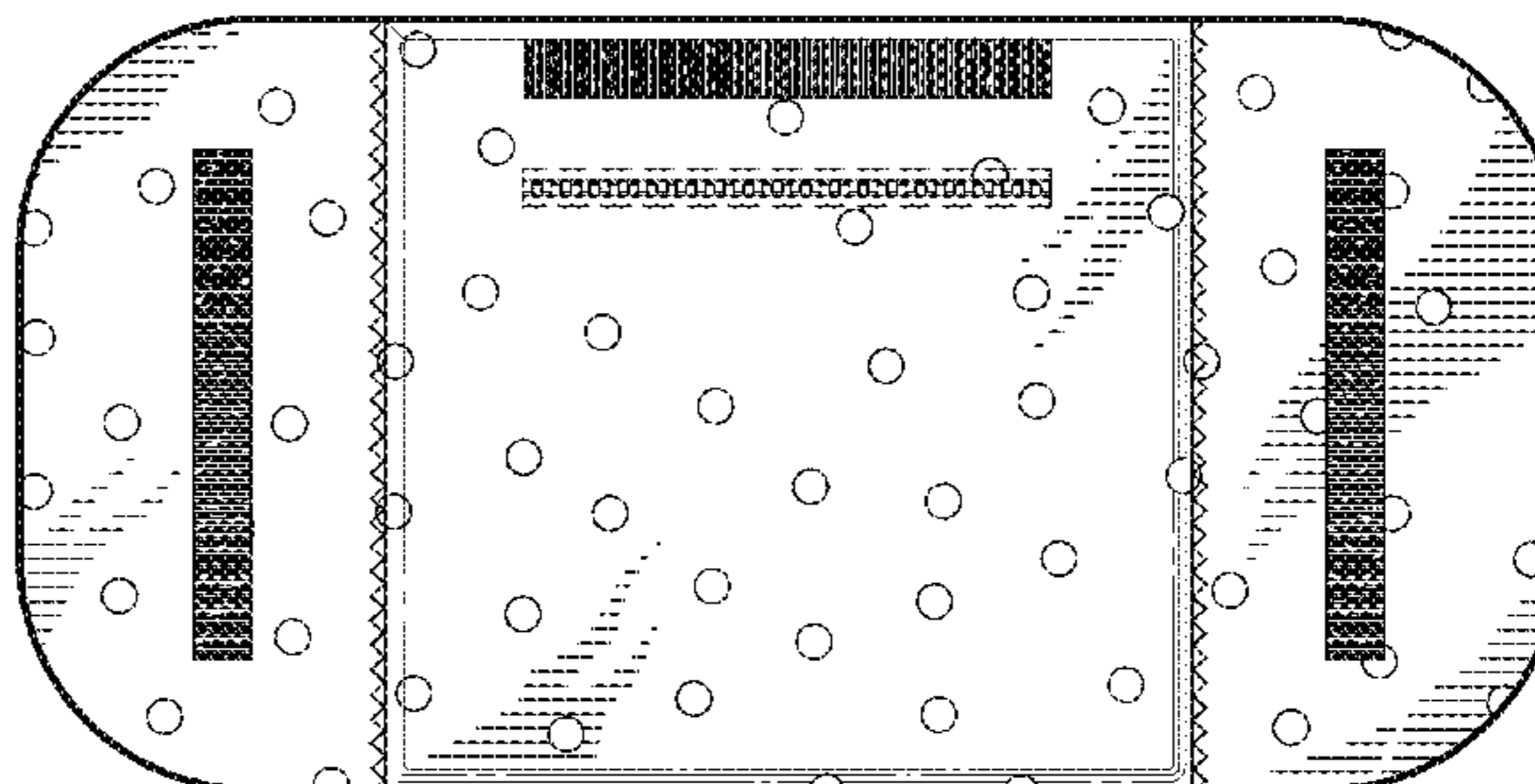
(57) **CLAIM**

The ornamental design for a furniture damage covering device, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of a furniture damage covering device showing my new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a back view thereof;  
FIG. 4 is a right side view thereof, the left side view is the same;  
FIG. 5 is a top view thereof, the bottom view is the same;  
FIG. 6 is a view showing the furniture damage covering device of FIG. 1 installed on a piece of furniture; and,  
FIG. 7 is another view showing the furniture damage covering device of FIG. 1 installed in an alternate location on a piece of furniture.

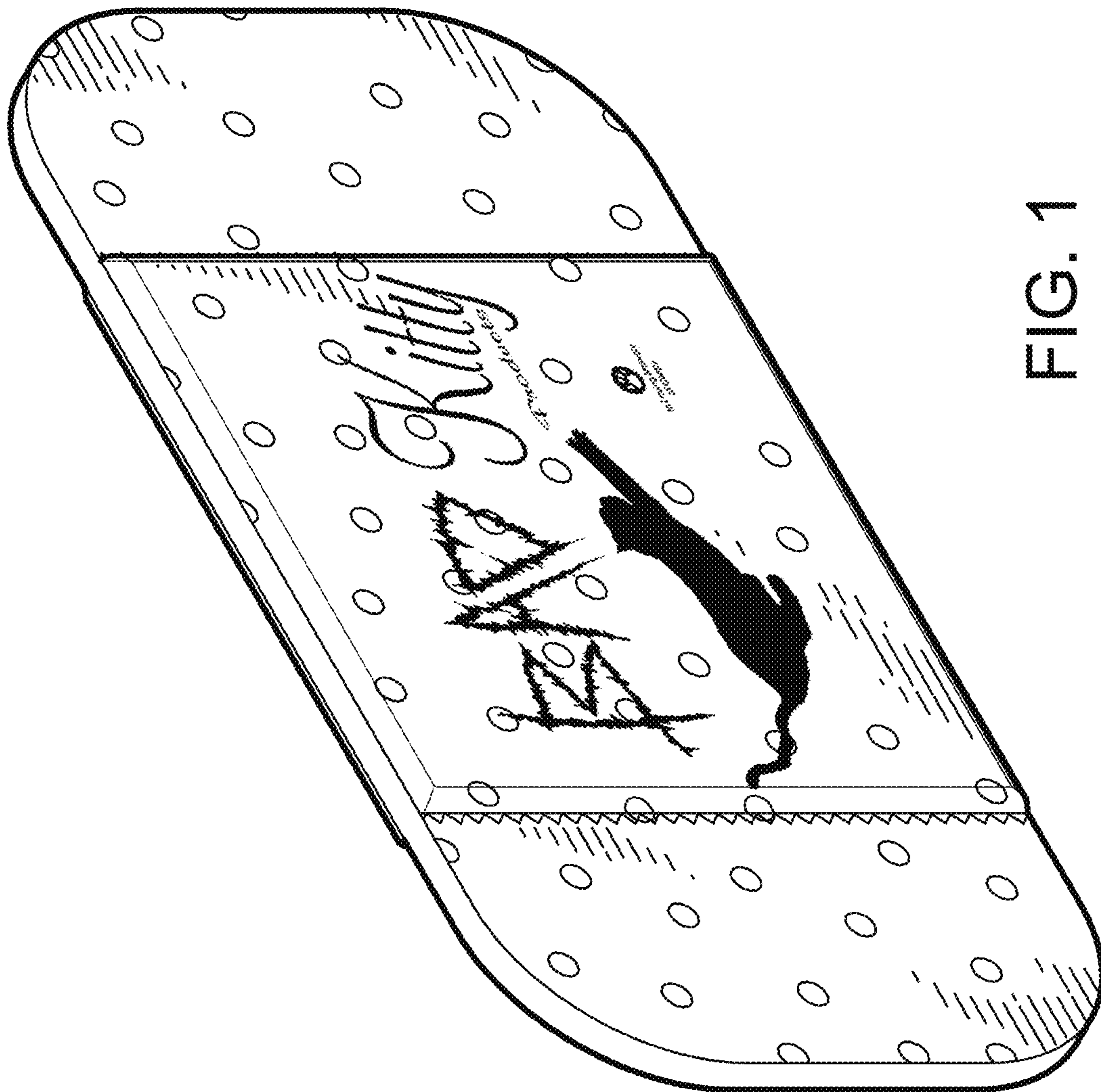

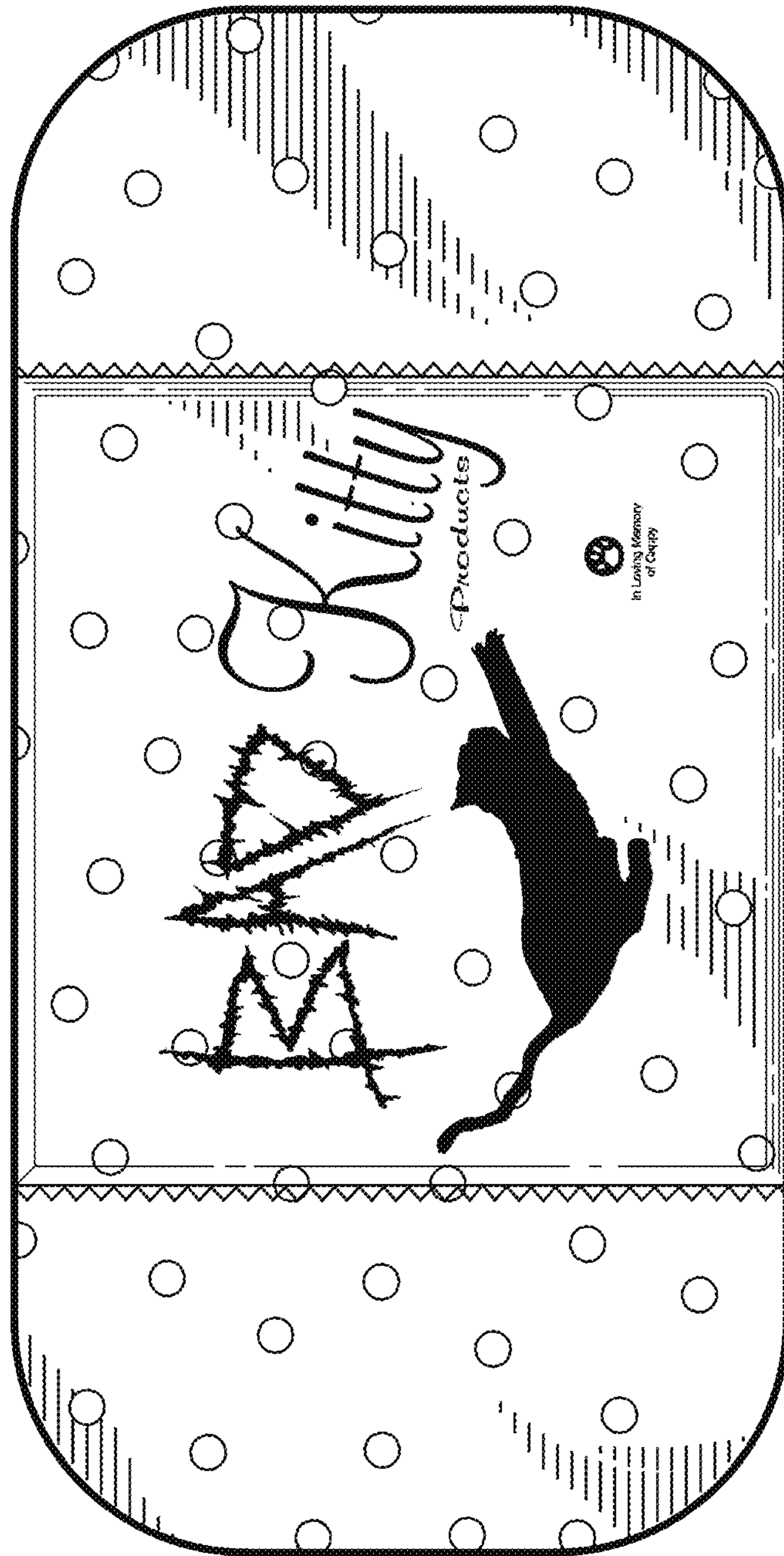

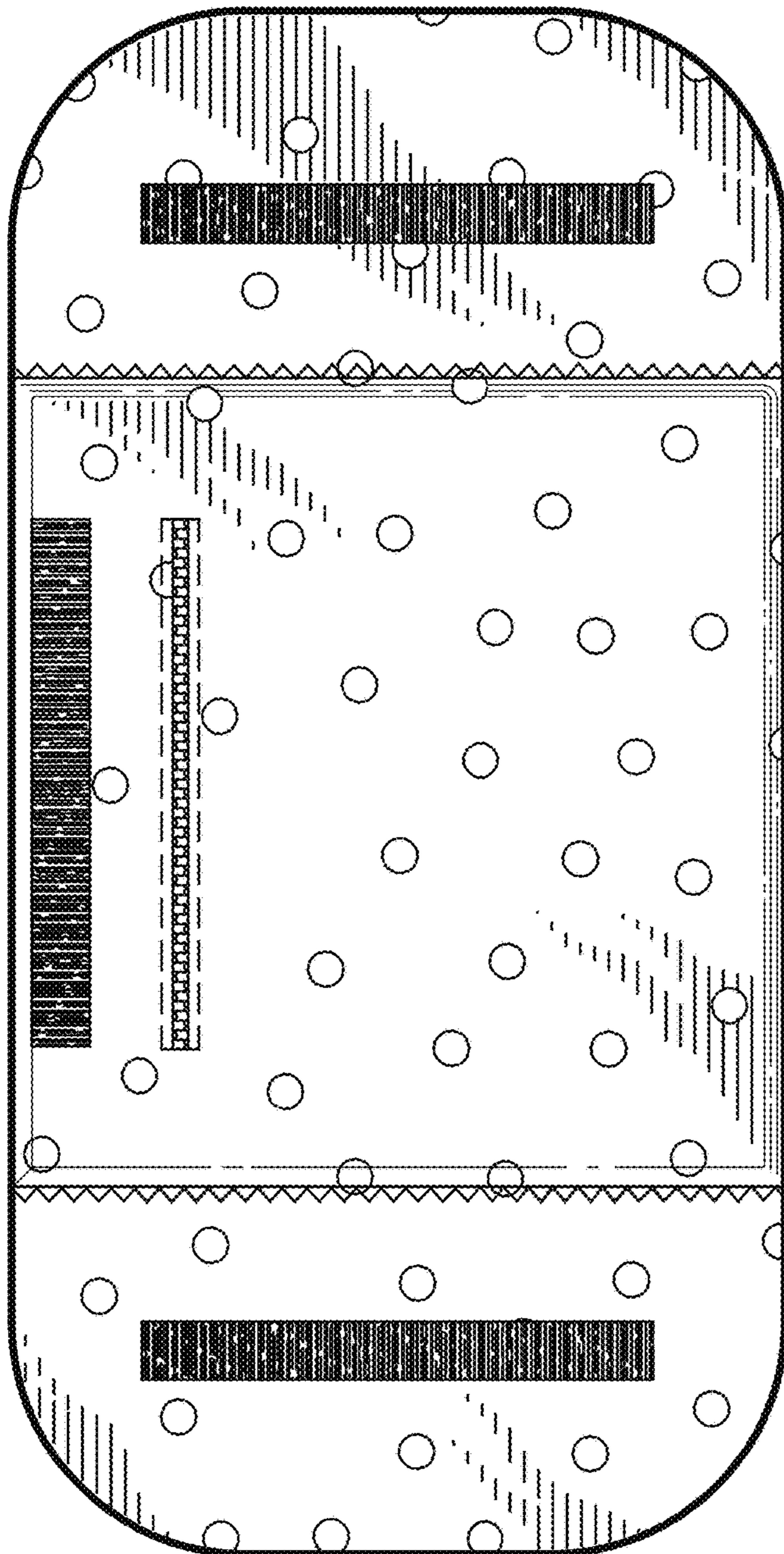

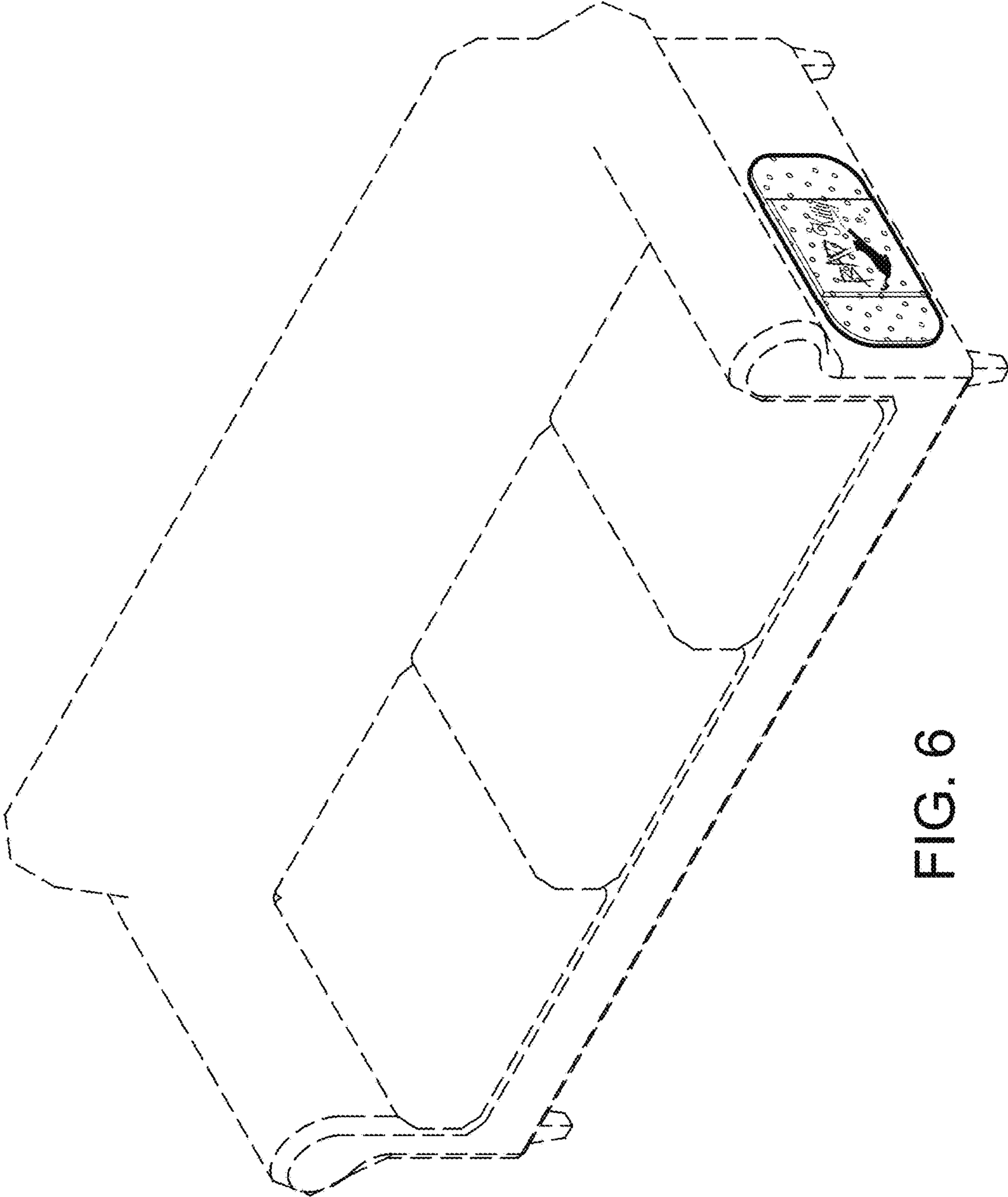

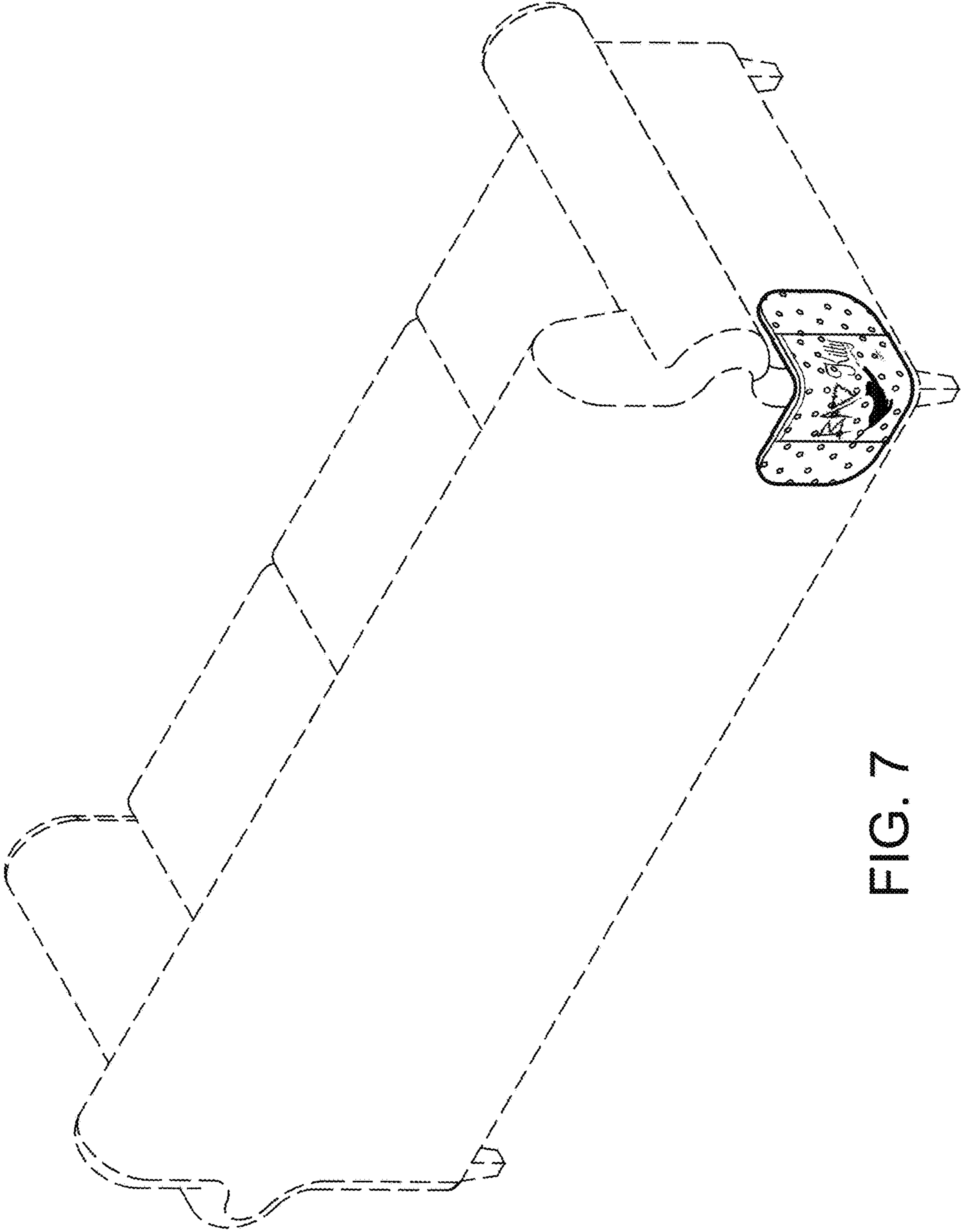
