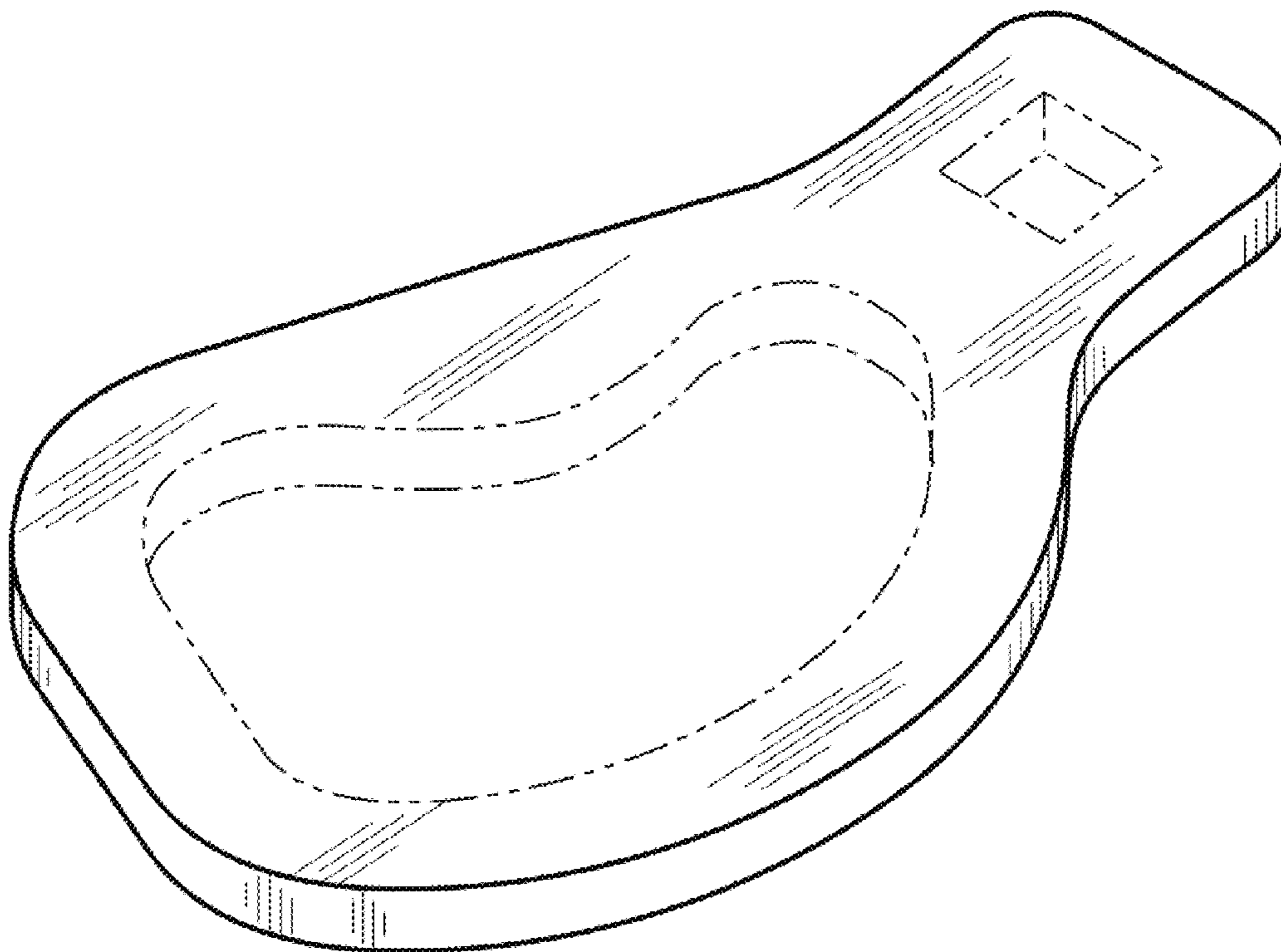
(57) **CLAIM**

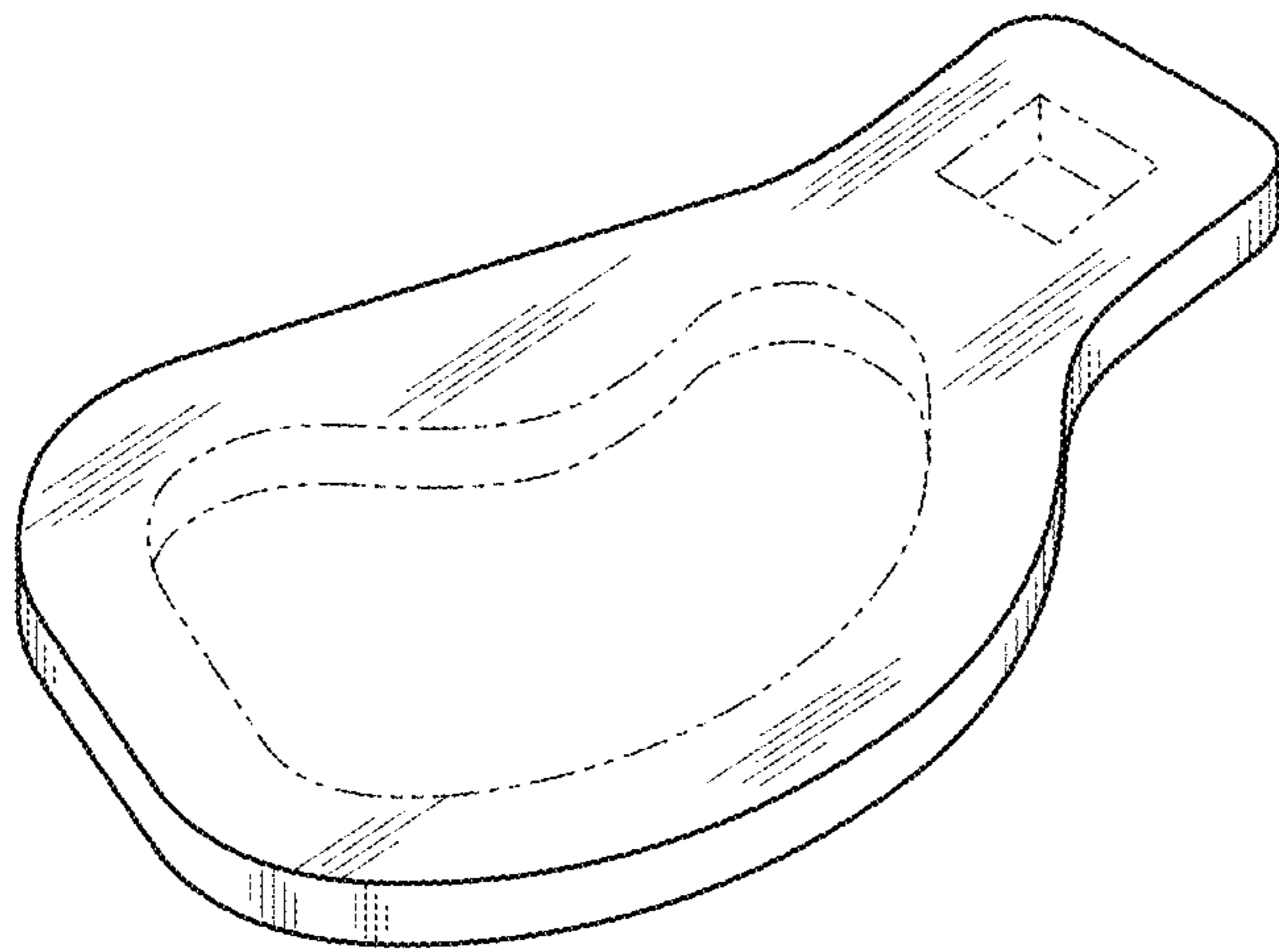
The ornamental design for an alignment tool, as shown and described.

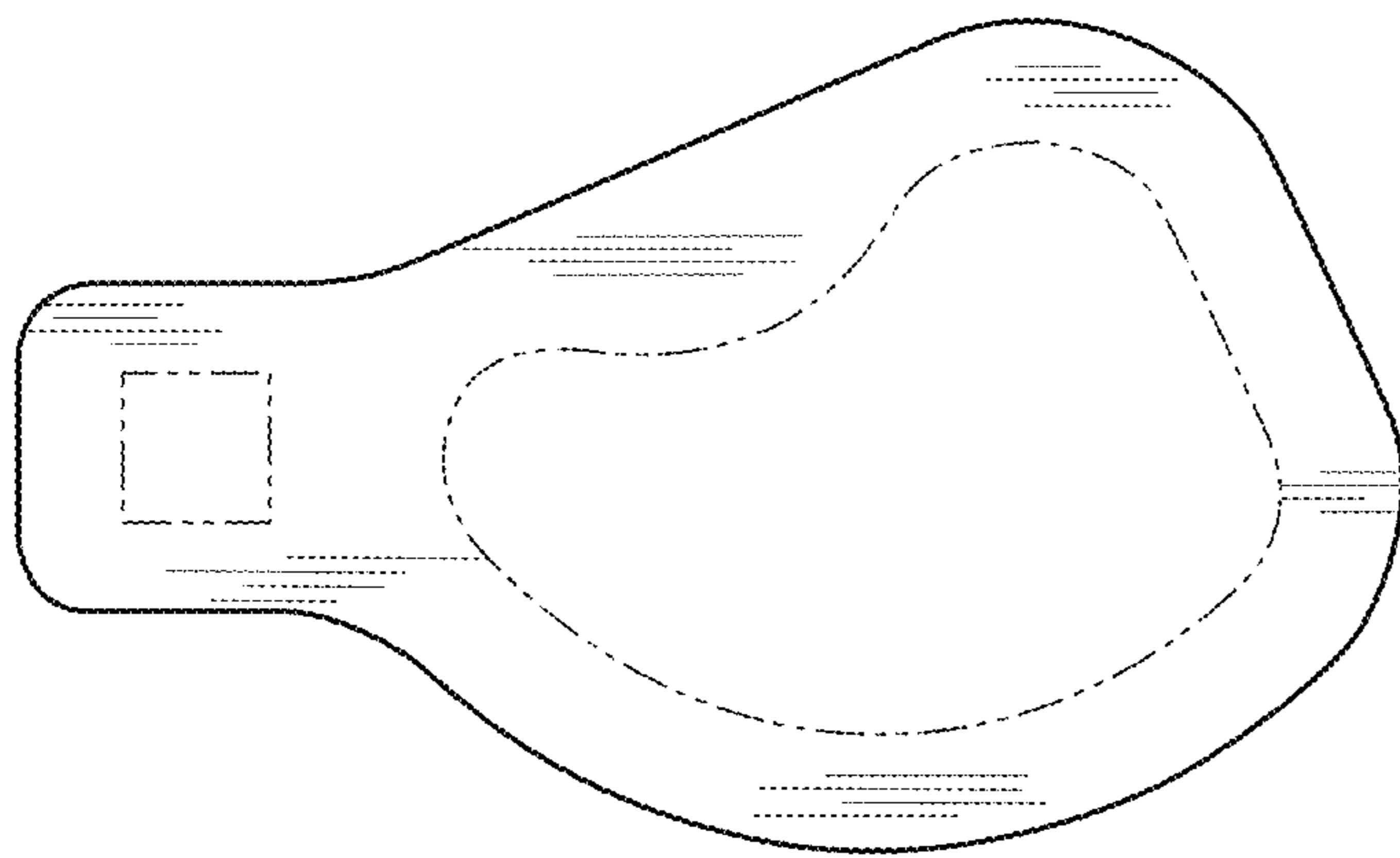
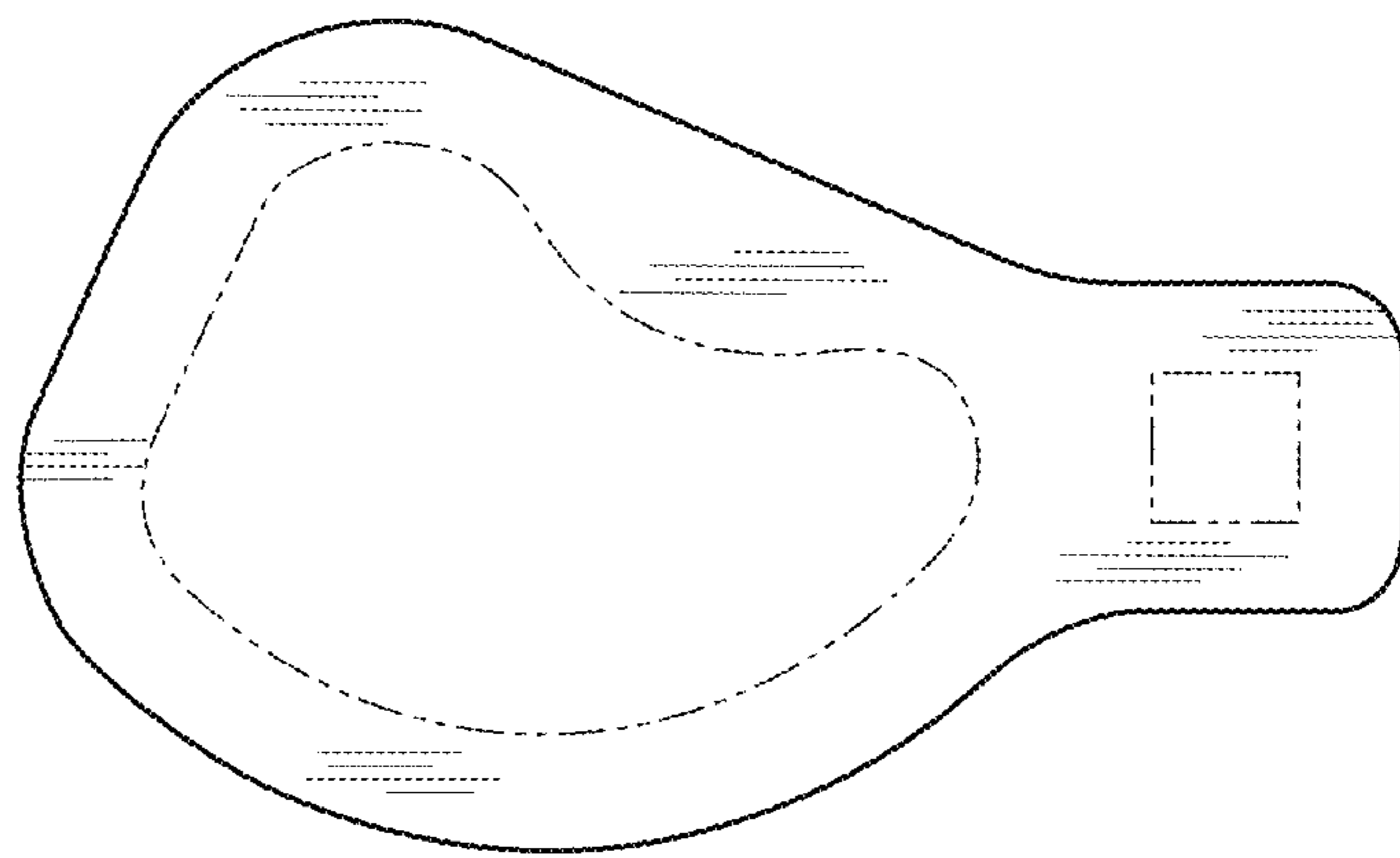
