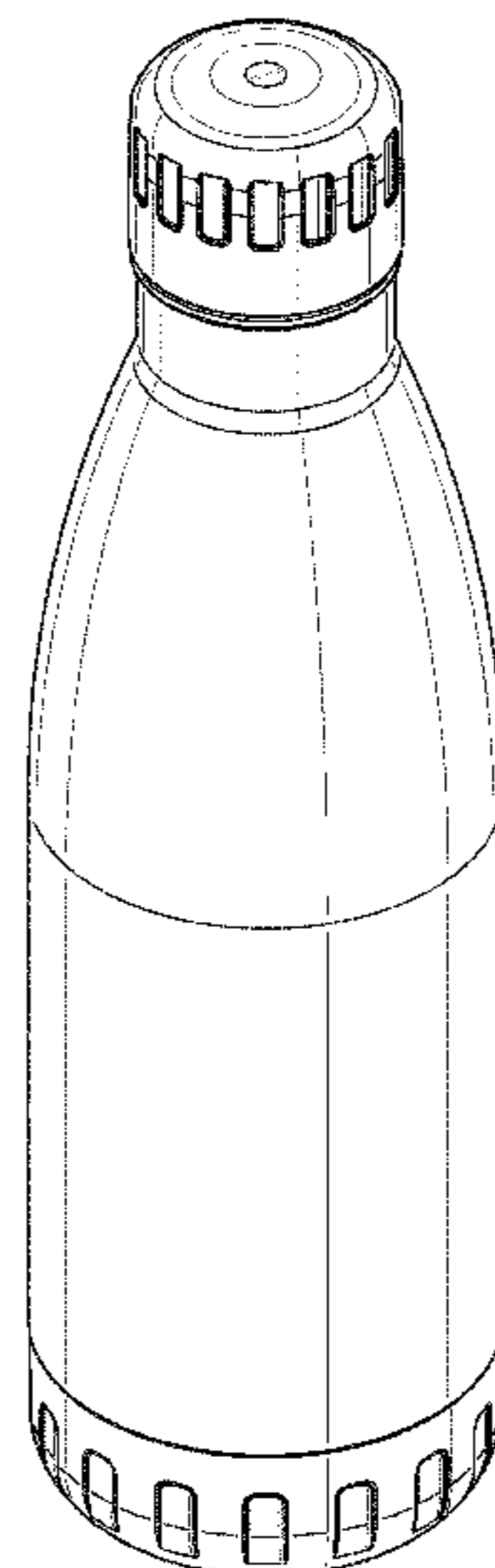
(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the bottle.  
FIG. 2 is a front elevation view of the bottle.  
FIG. 3 is a rear elevation view of the bottle.  
FIG. 4 is a right side of the bottle.  
FIG. 5 is a left side view of the bottle.  
FIG. 6 is a top plan view of the bottle; and,  
FIG. 7 is a bottom plan view of the bottle.  
The broken line shows an unclaimed portion of the bottom of the bottle and is included for the purpose of illustrating portions of the bottle that form no part of the claimed design.

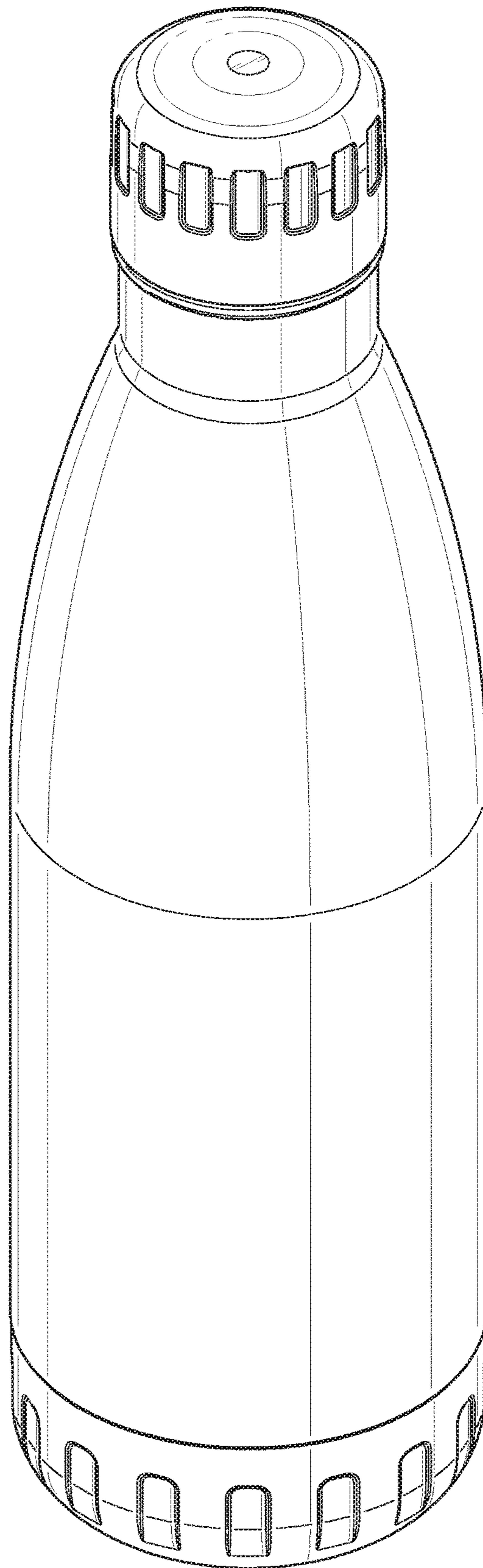

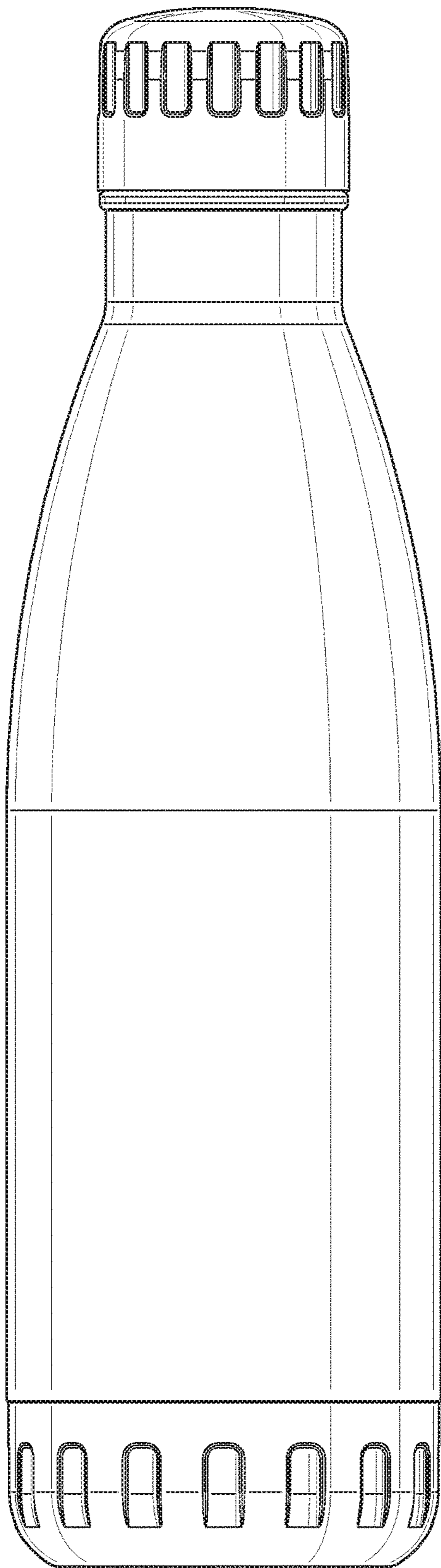

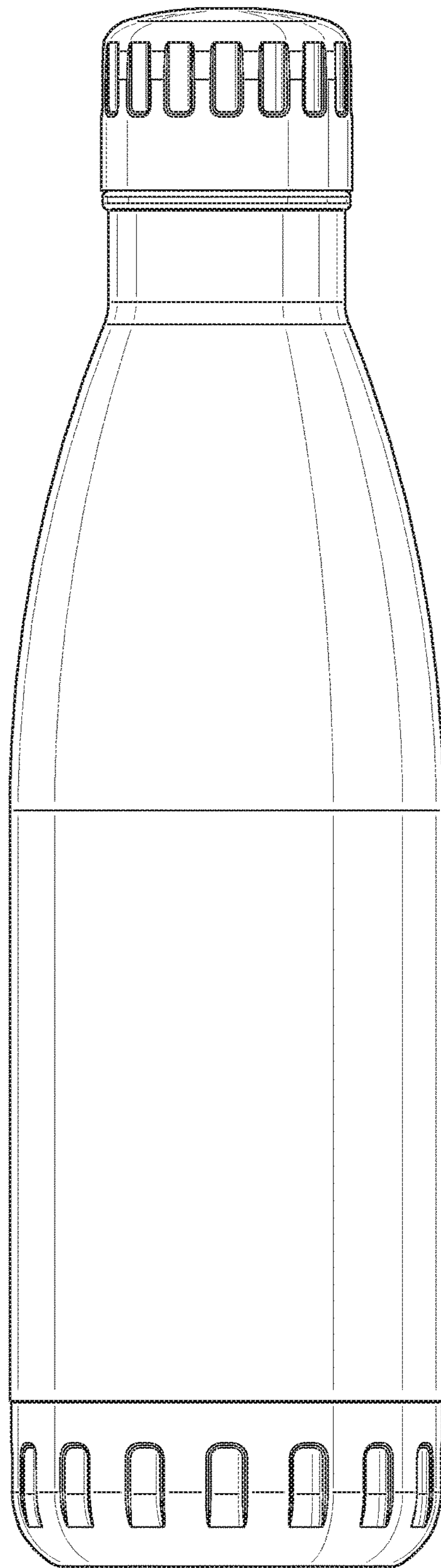

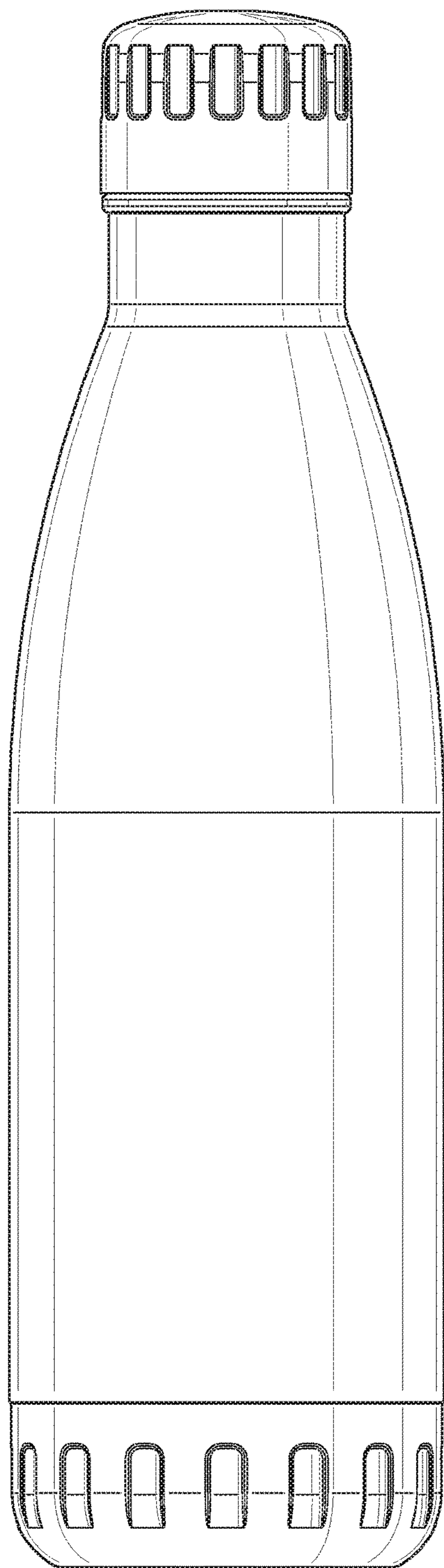

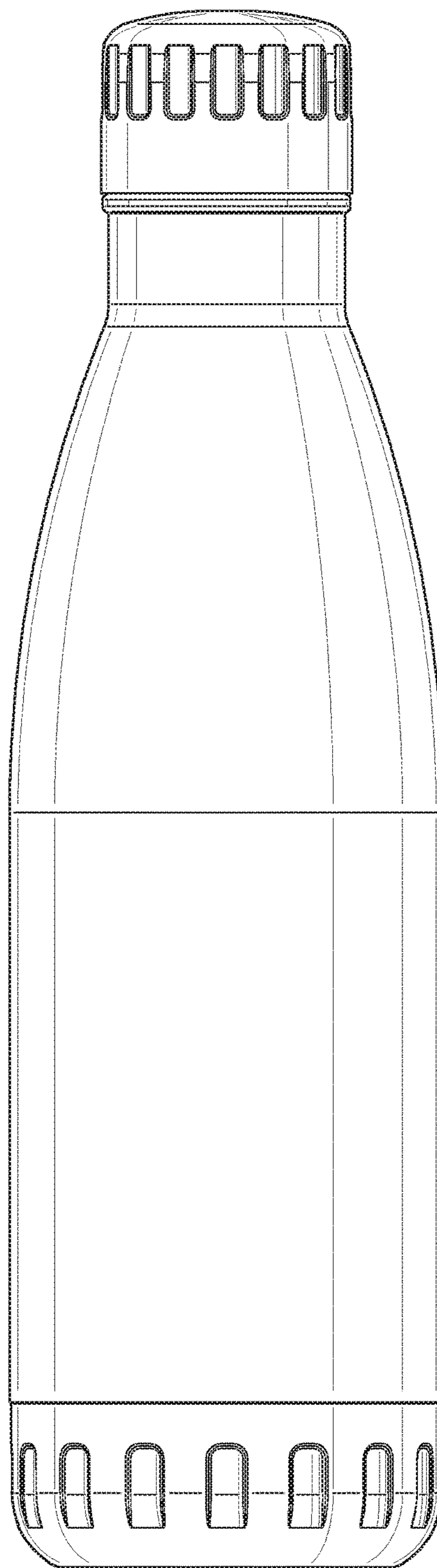

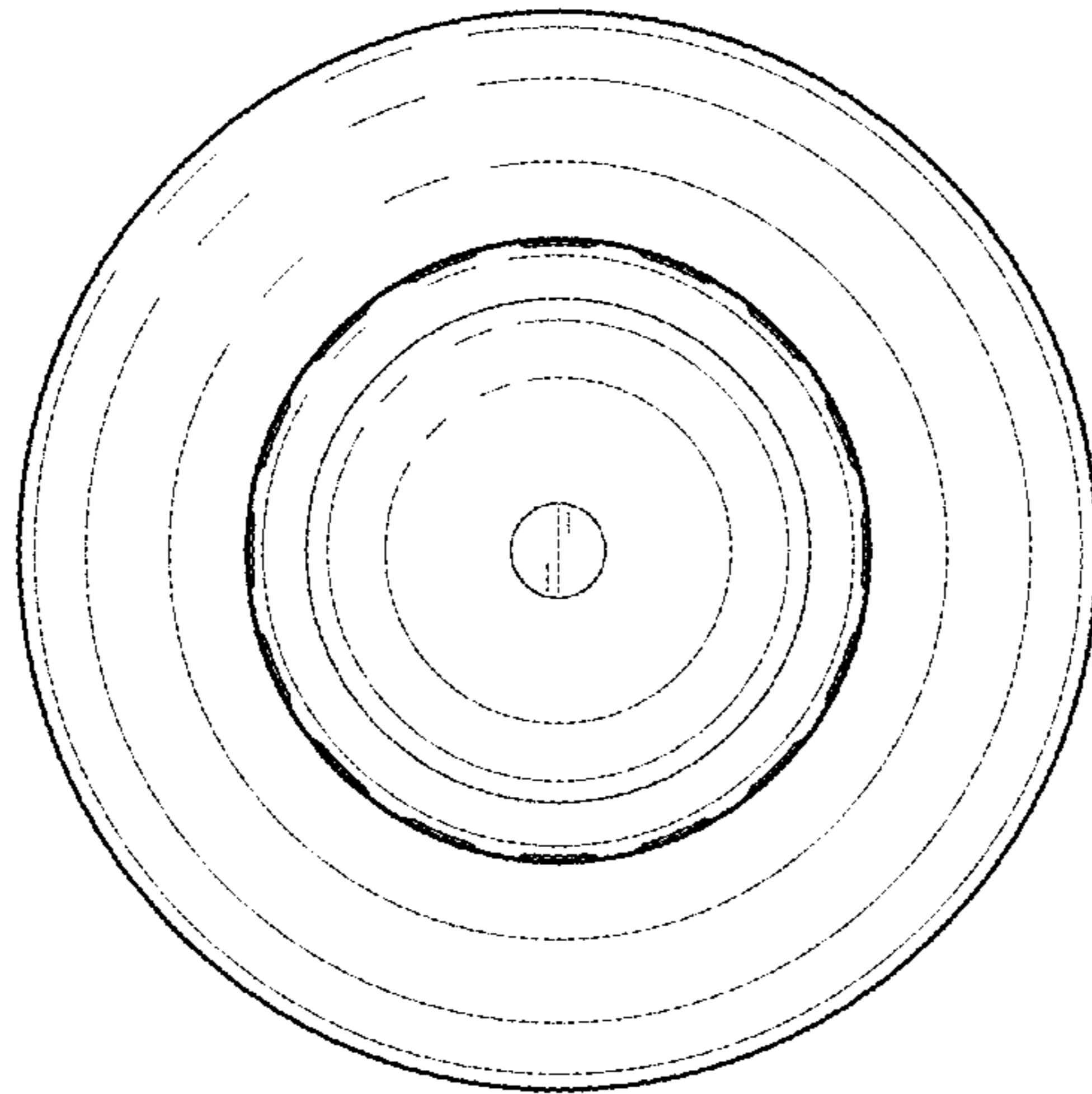

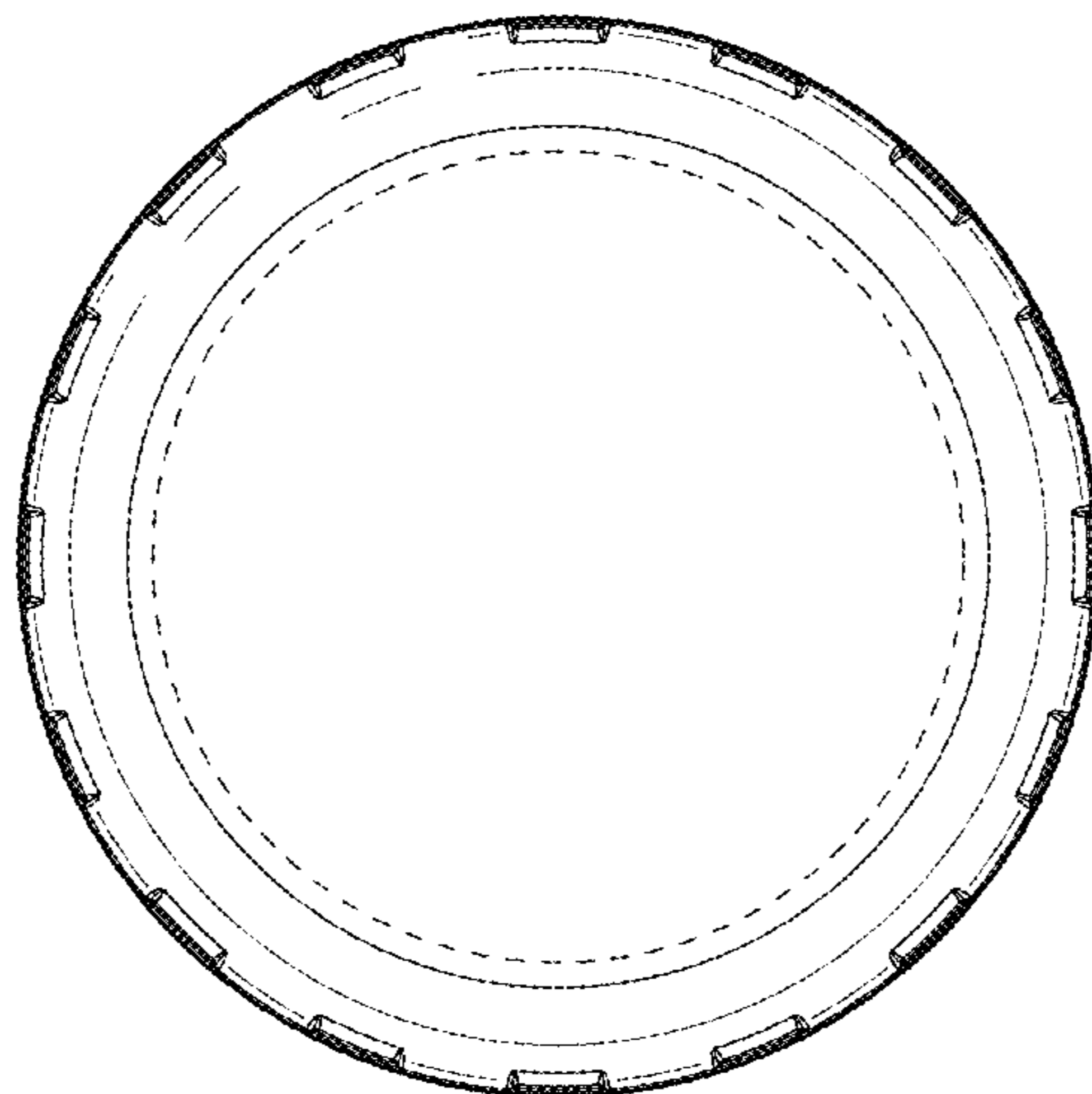
