(57) **CLAIM**

We claim the ornamental design for a jersey-shaped flag including cutouts, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment of a jersey-shaped flag including cutouts showing the new design, the back view being a mirror image thereof;

FIG. 2 is a top view thereof.

FIG. 3 is a bottom view thereof.

FIG. 4 is a left side view thereof.

FIG. 5 is a right side view thereof.

FIG. 6 is a front view of a second embodiment of a jersey-shaped flag including cutouts showing the new design, the back view being a mirror image thereof.

FIG. 7 is a top view thereof.

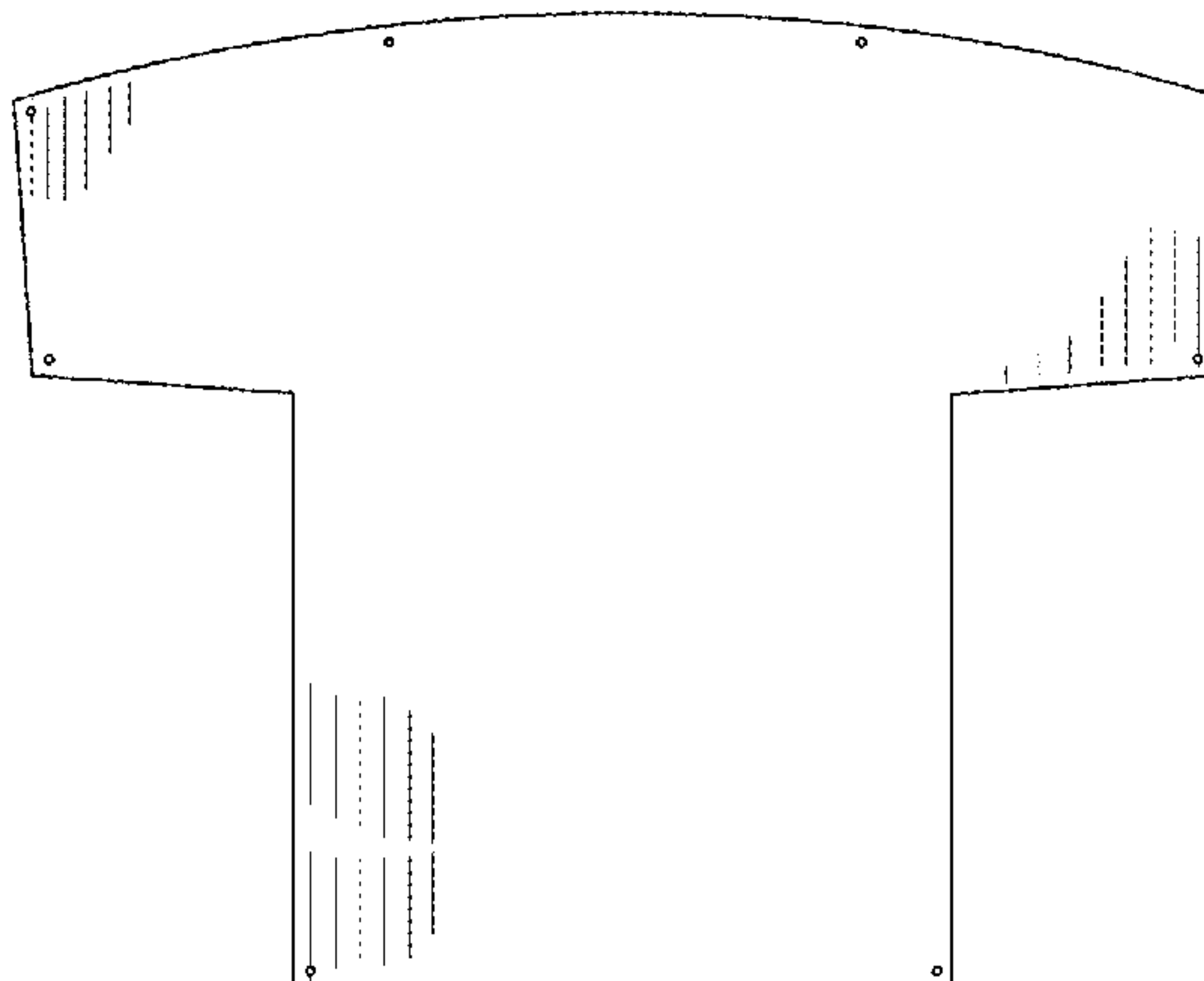
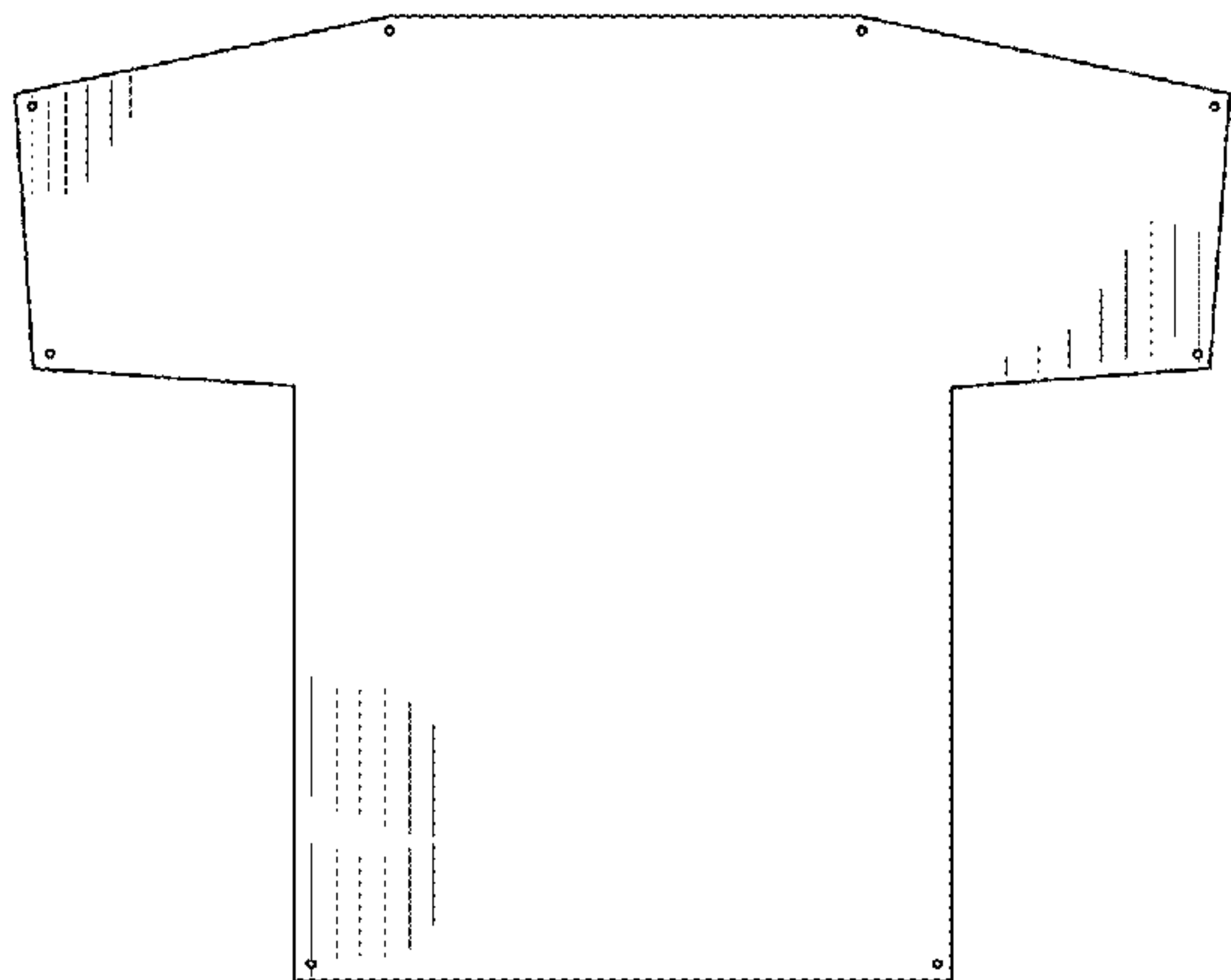
FIG. 8 is a bottom view thereof.

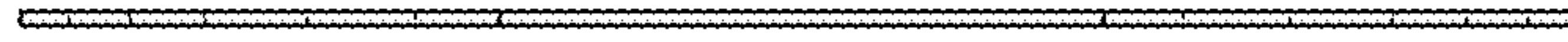

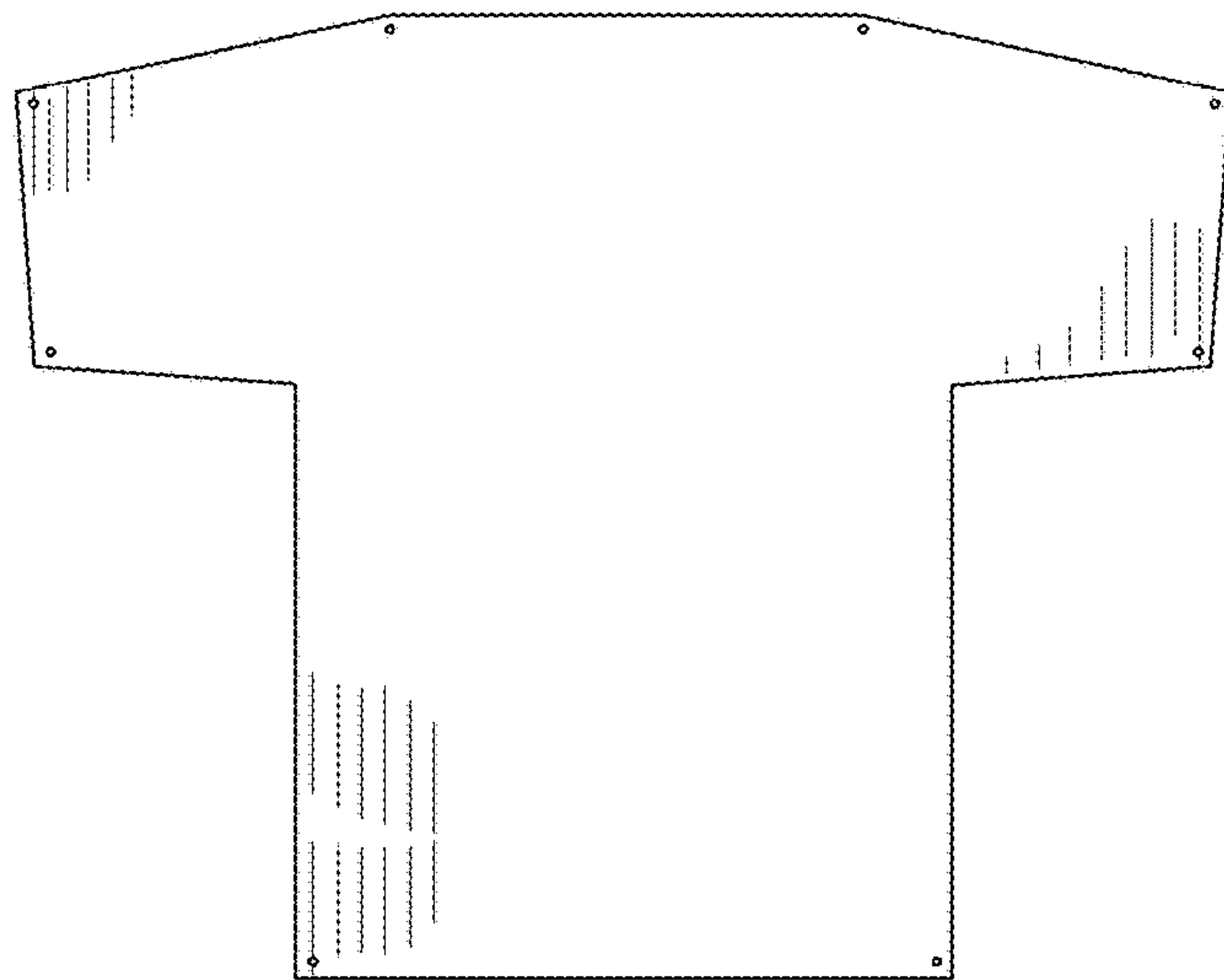

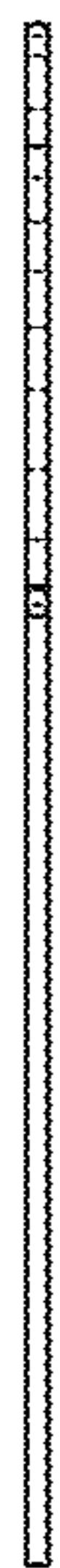

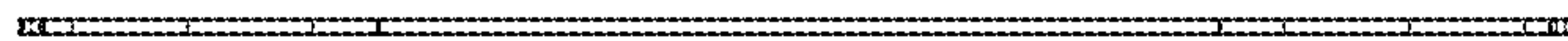

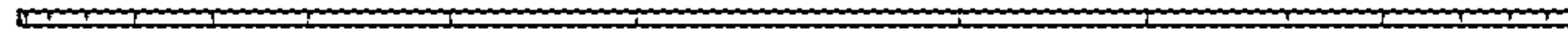

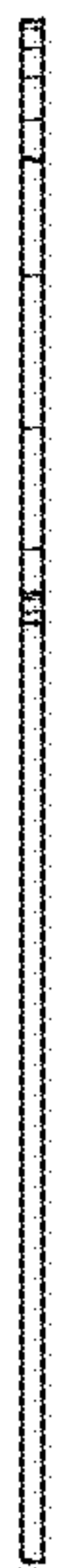

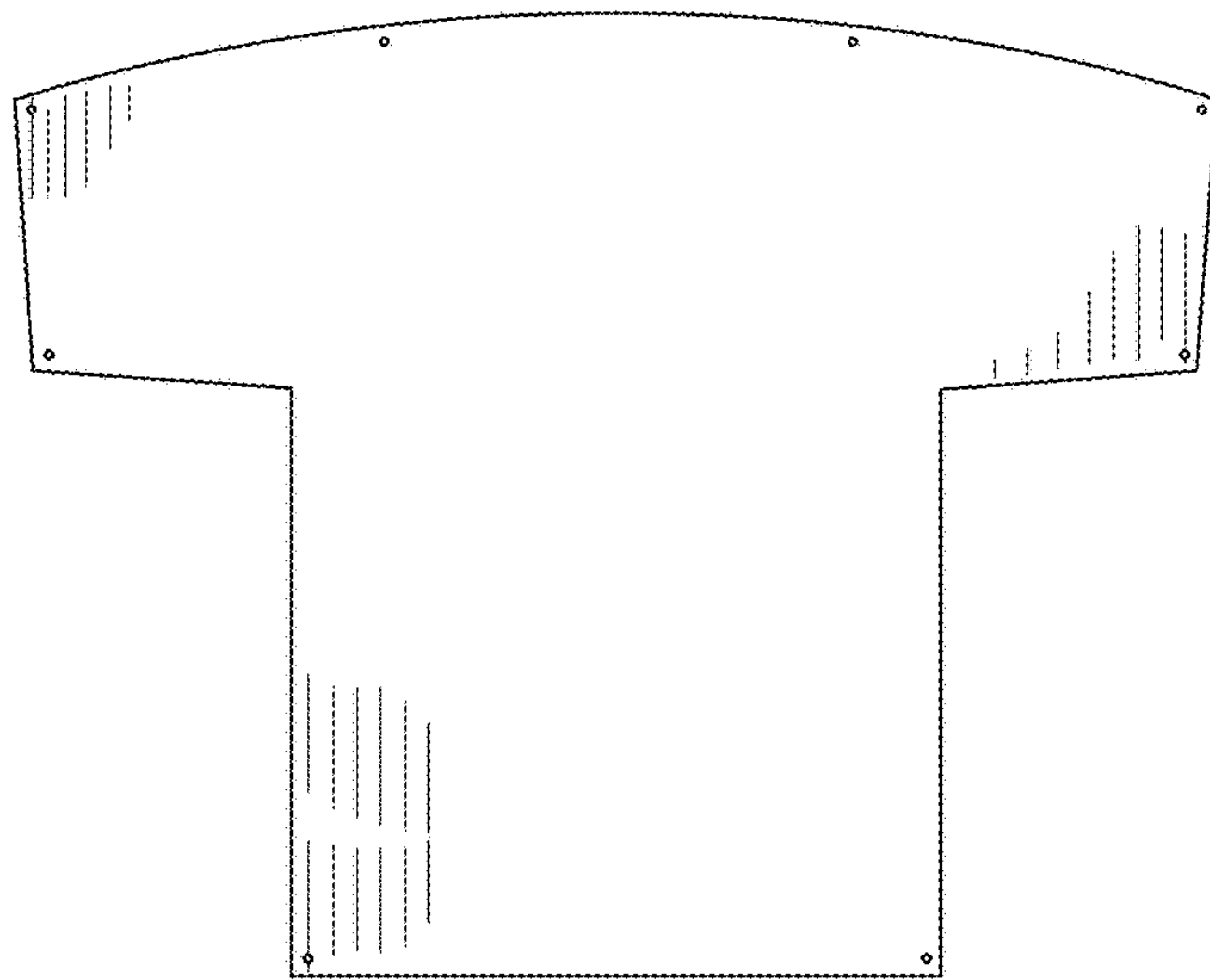

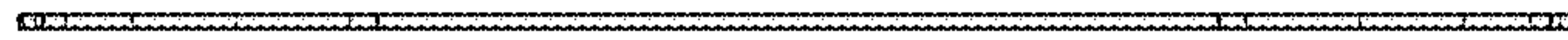
