DESCRIPTION

FIG. 1 is a front and left side perspective view of an all-terrain vehicle showing our new design;

 FIG. 5 is a right side elevation view thereof;

 FIG. 8 is a rear elevation view thereof.

The portions of the all-terrain vehicle shown in broken lines form no part of the claimed design.

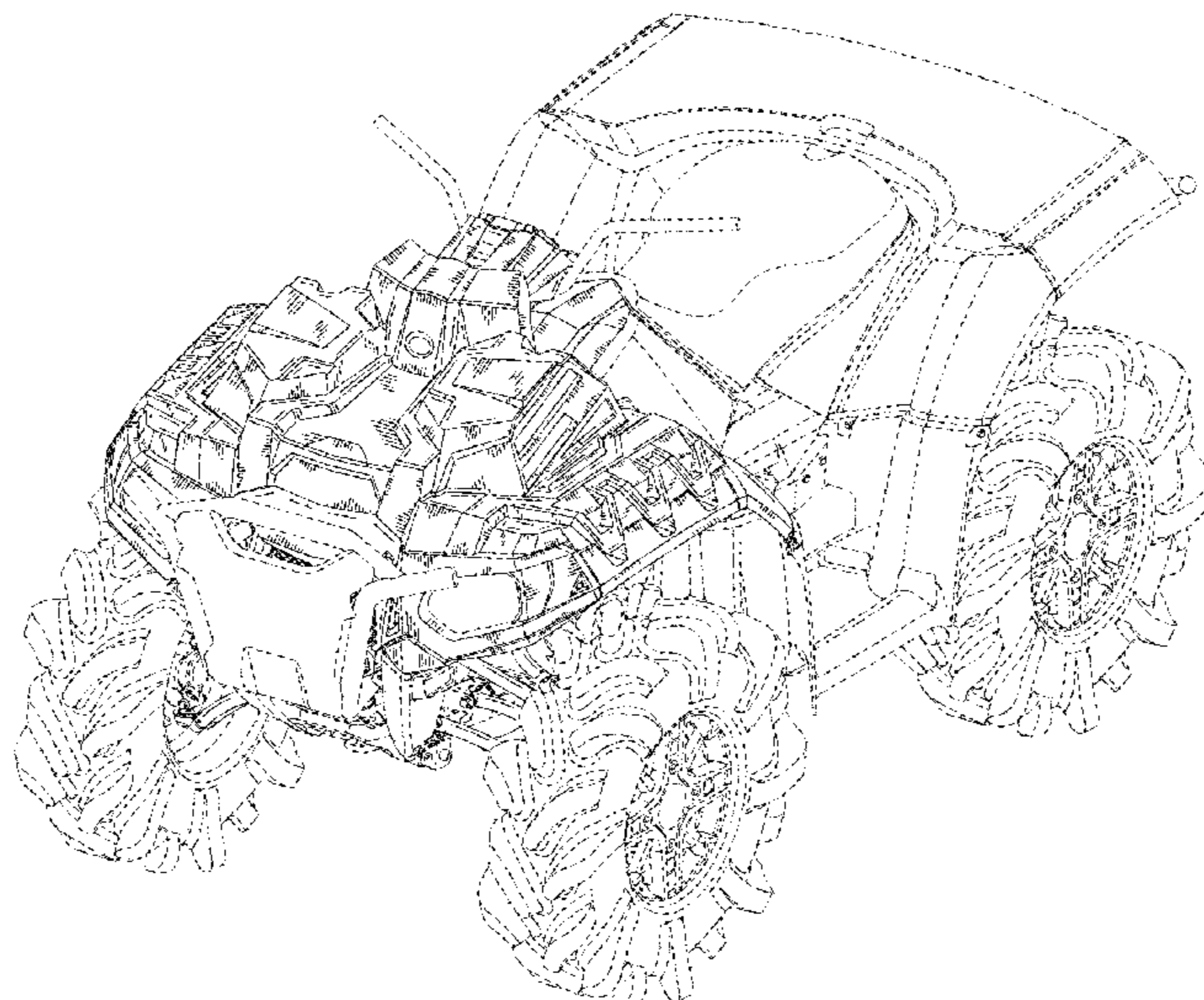

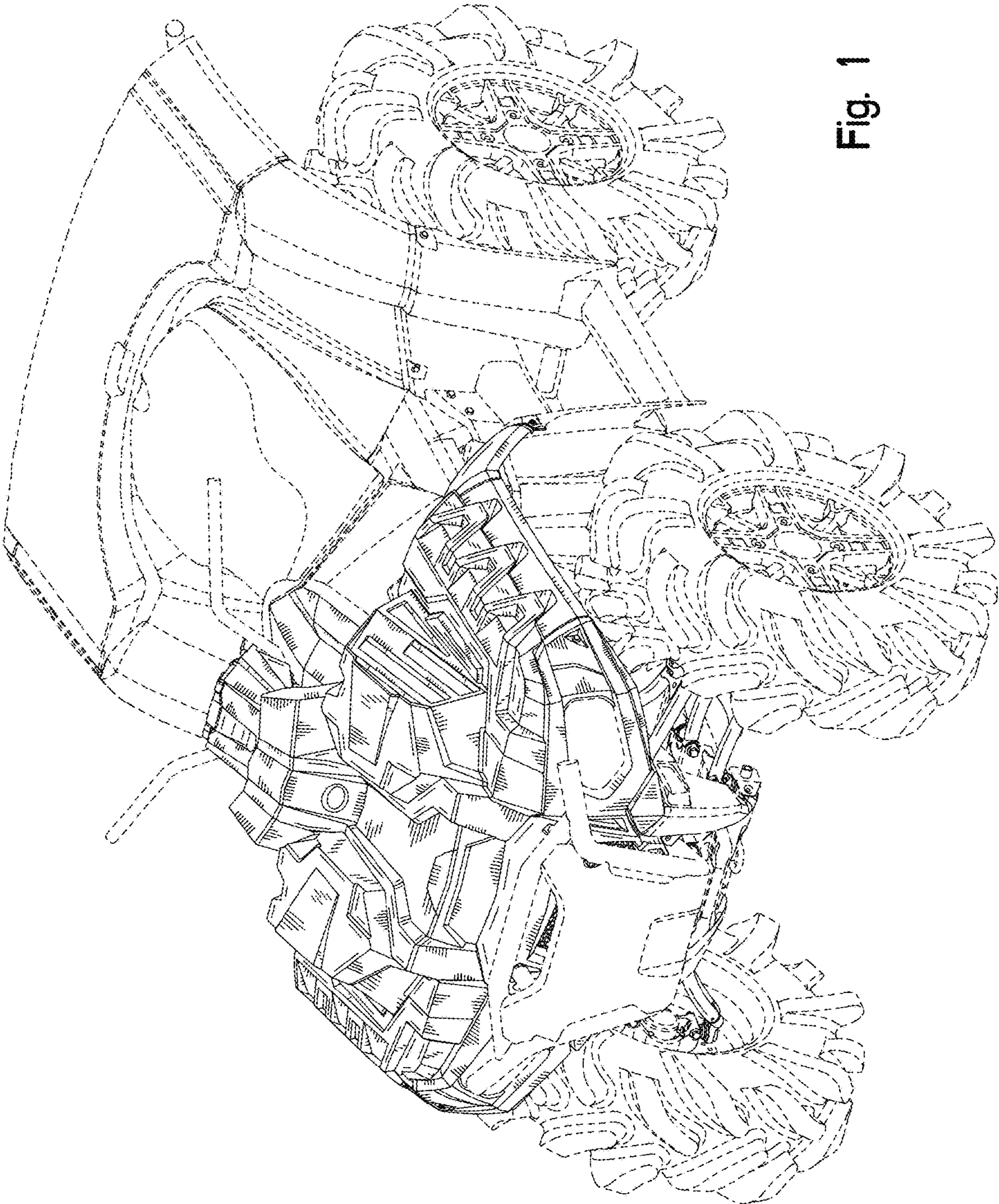

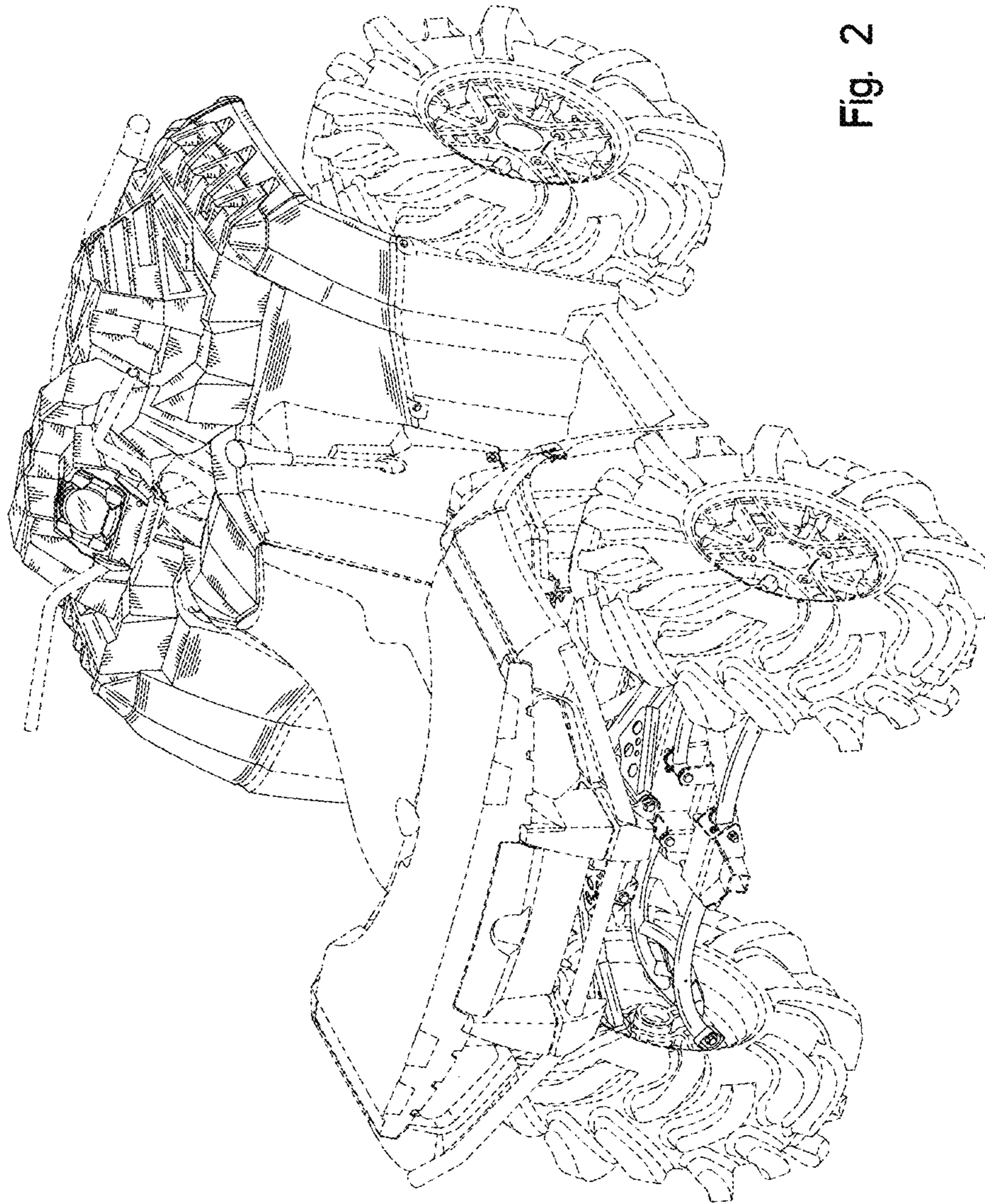

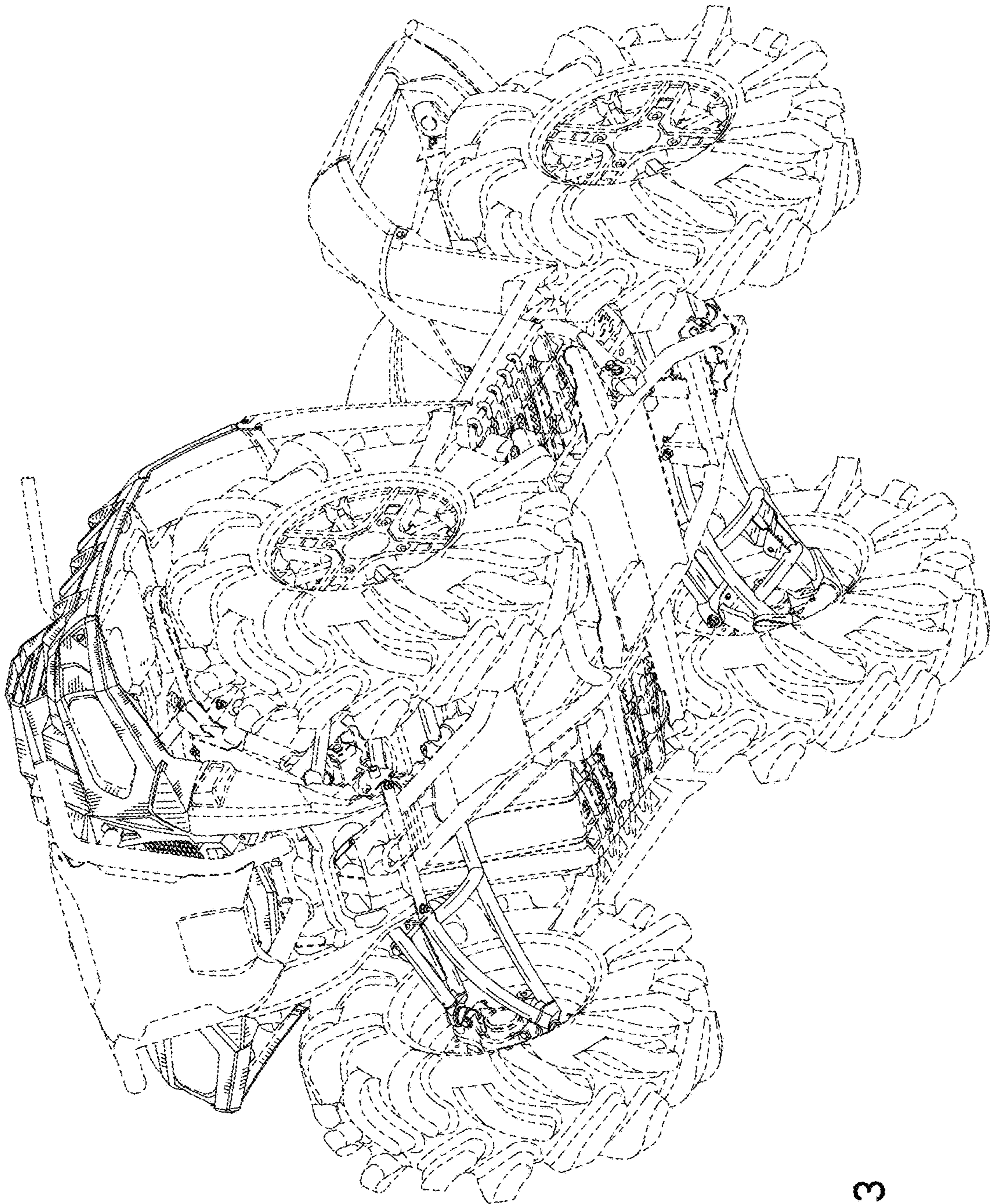

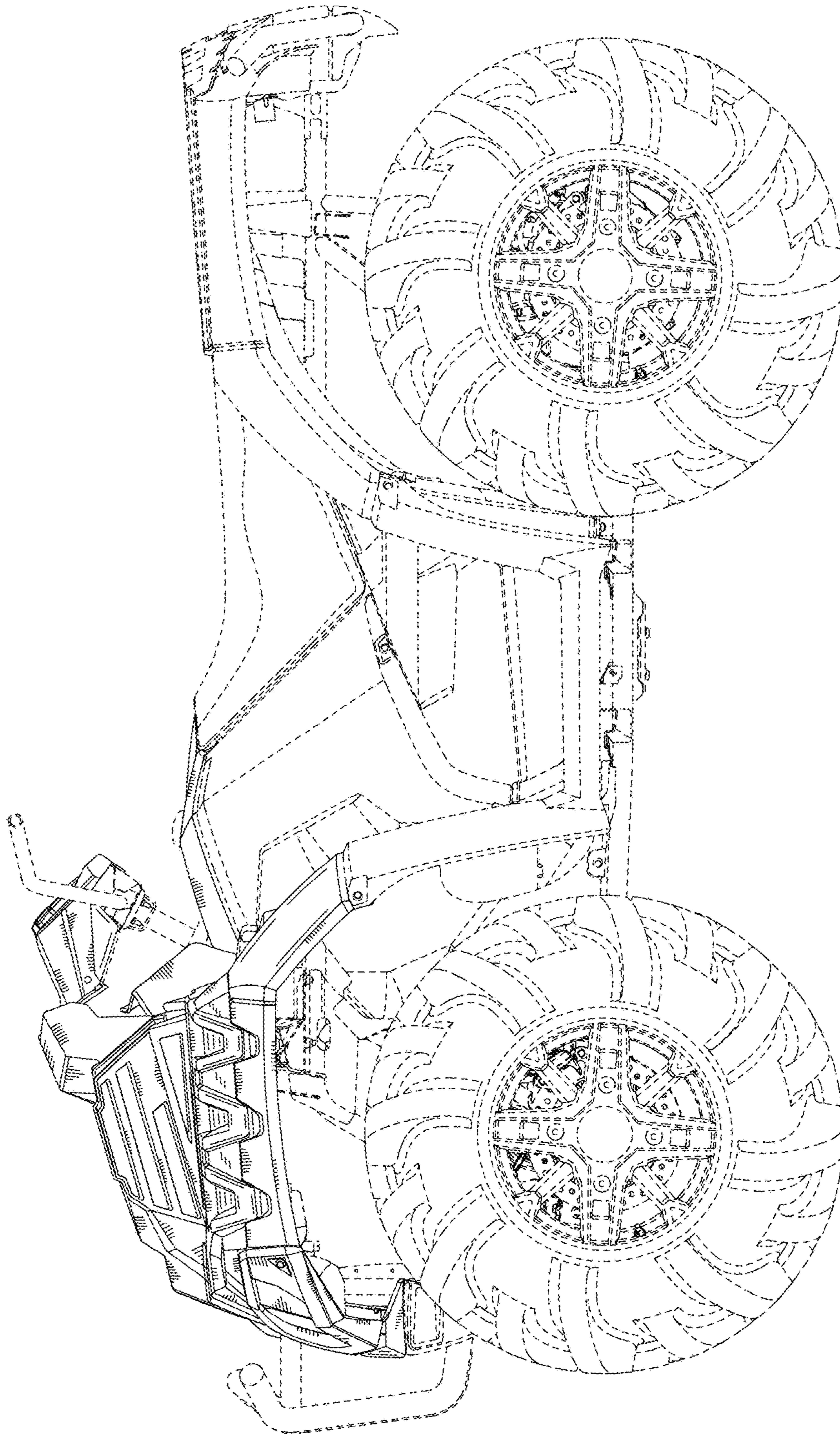

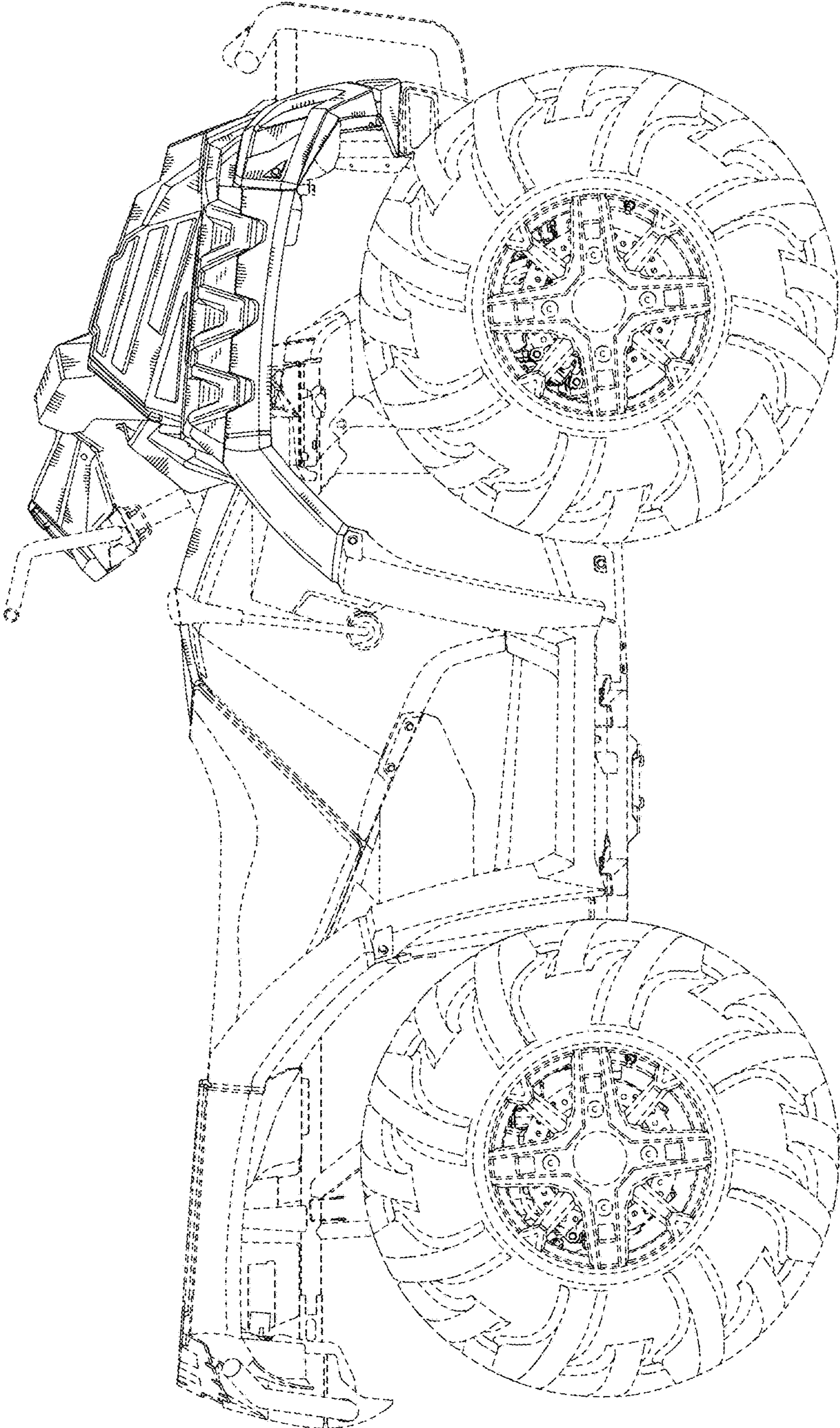

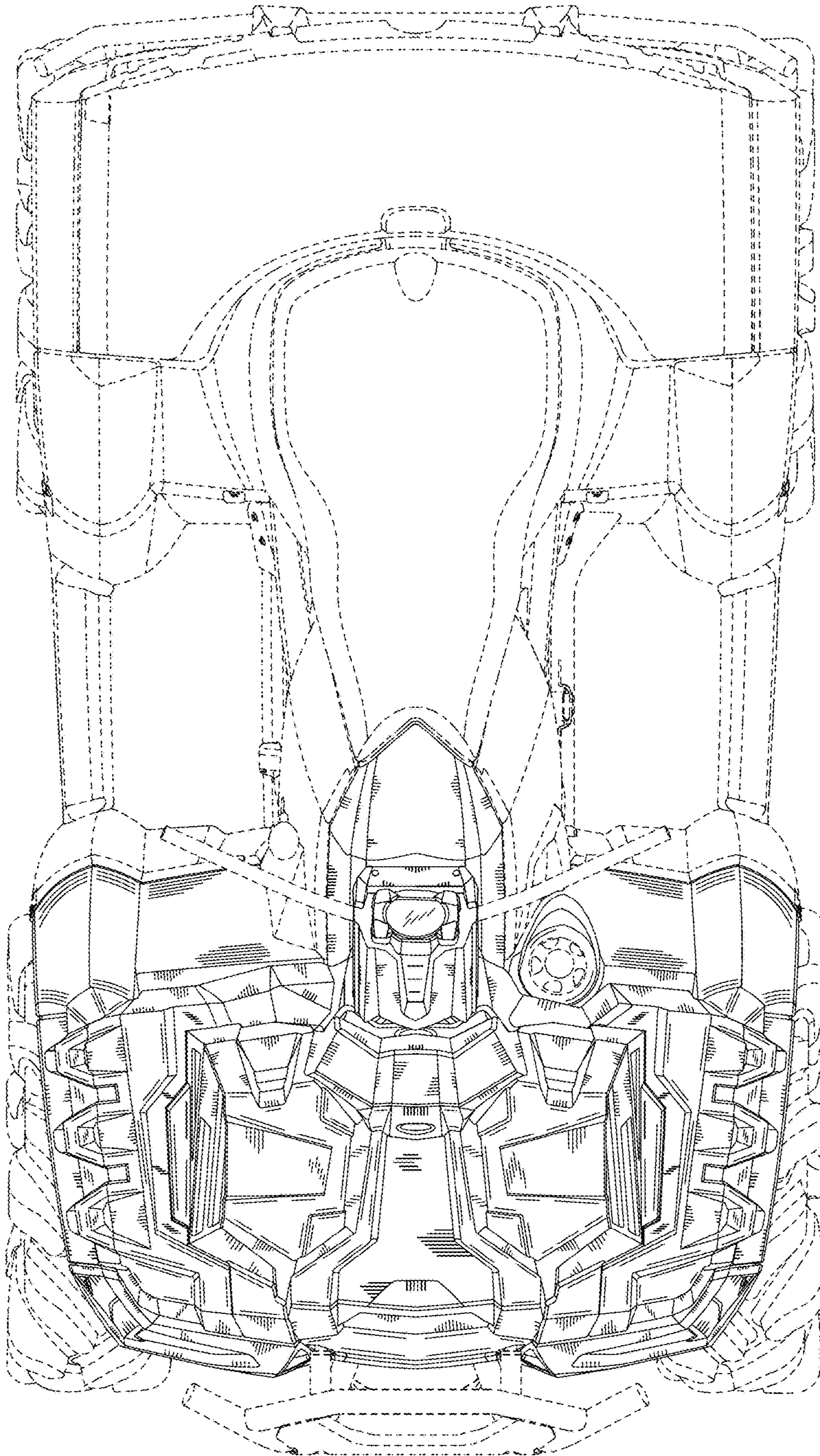

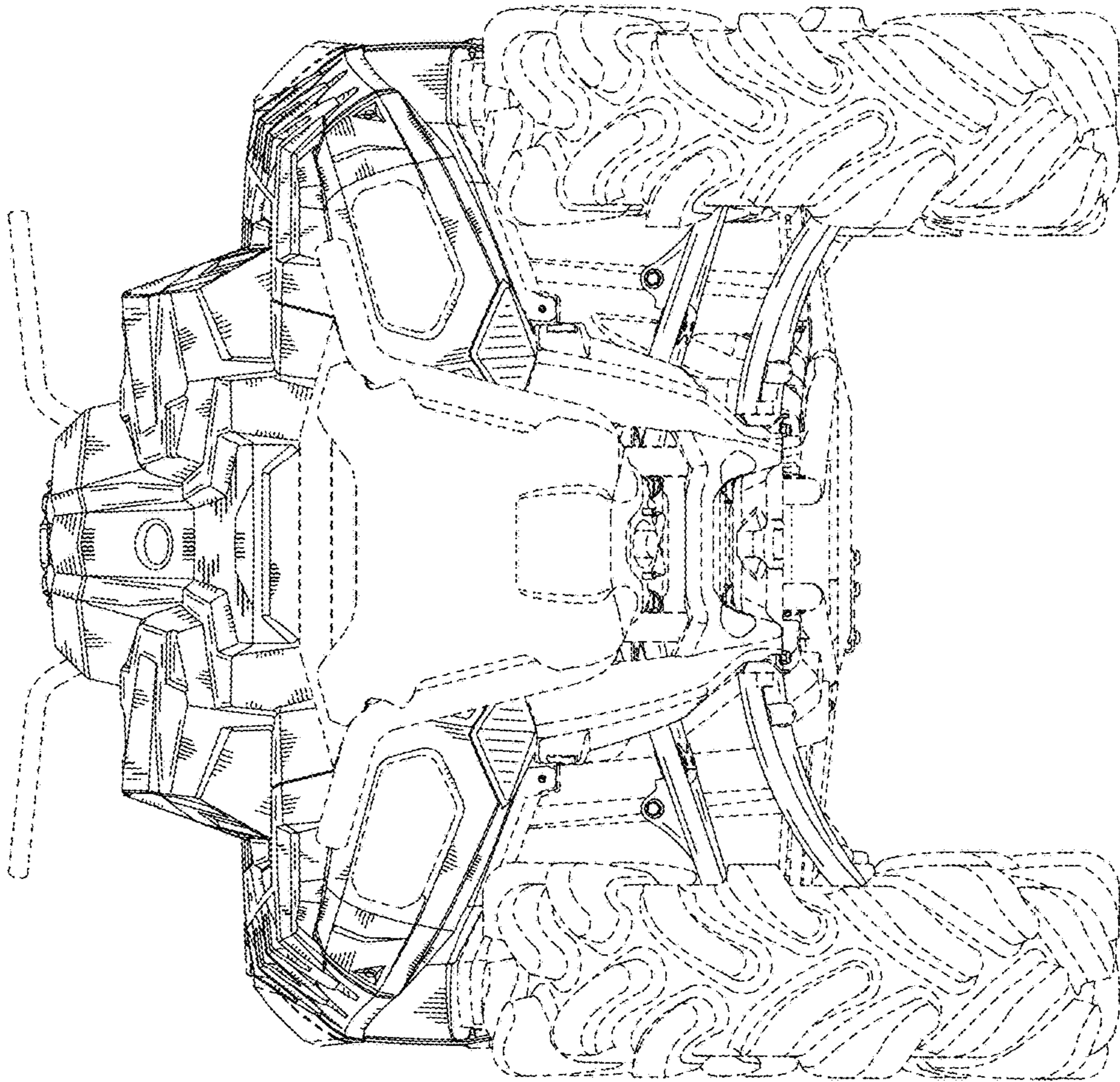

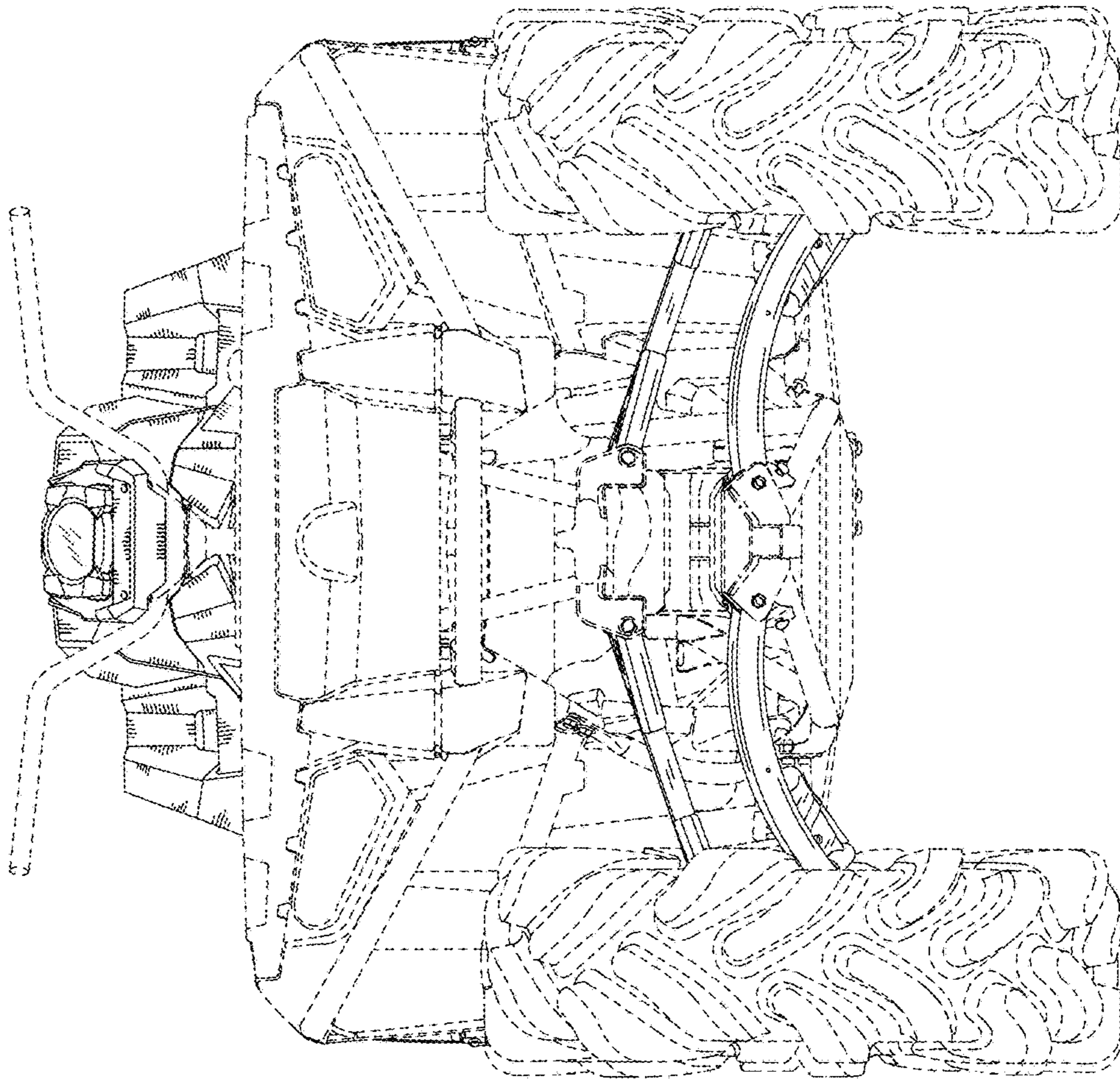
