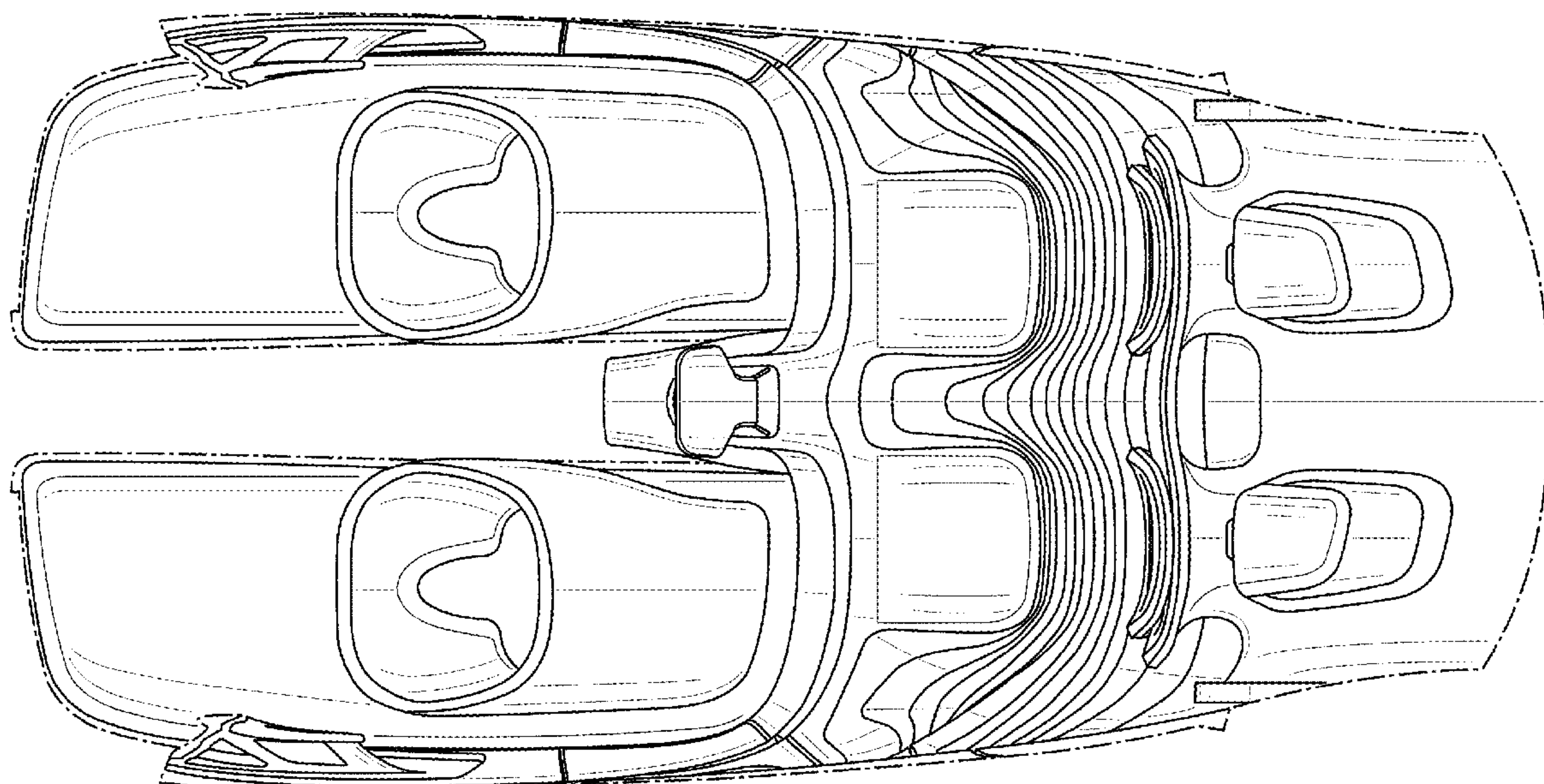

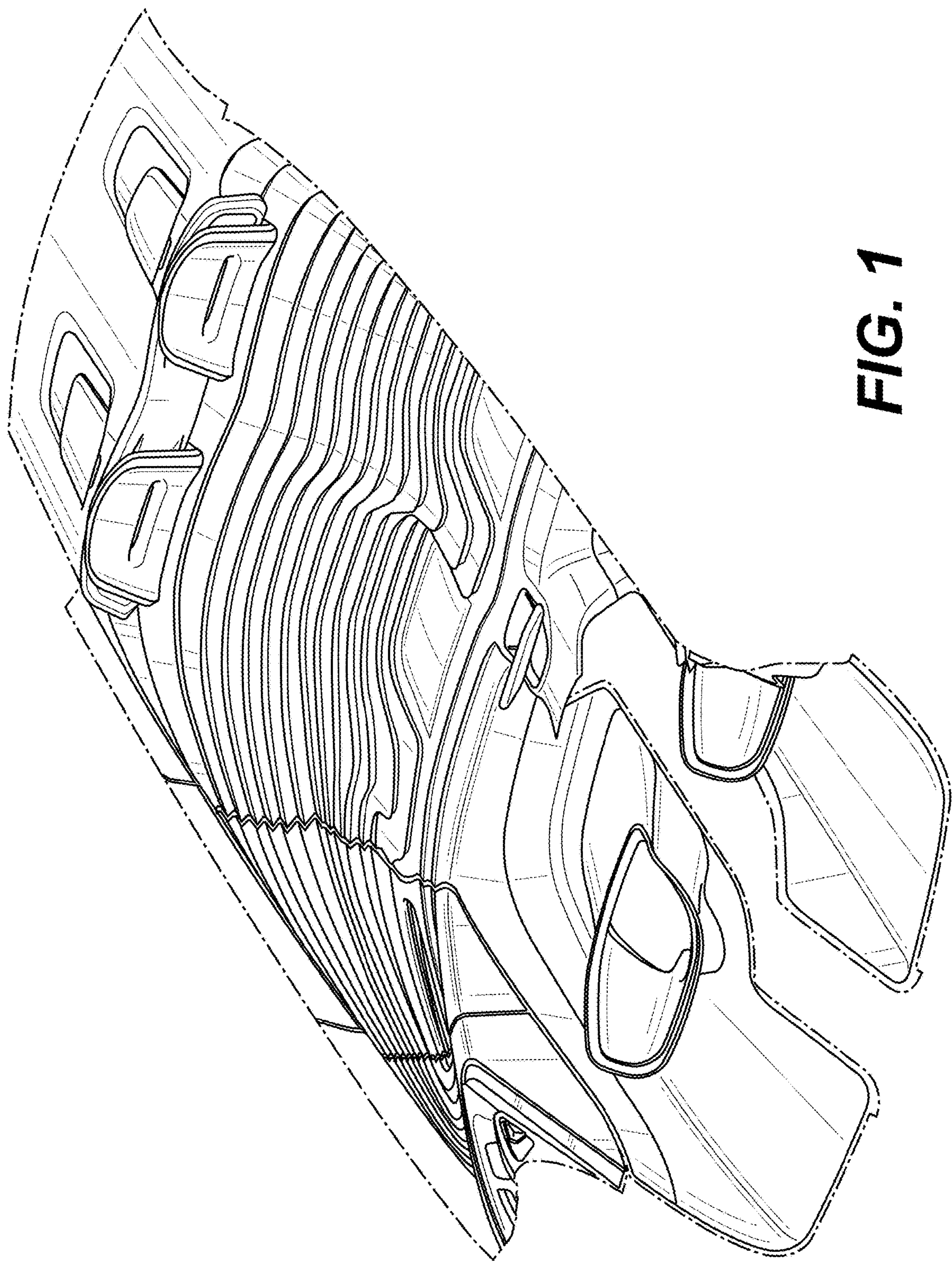
The ornamental design for an vehicle interior, as shown and

DESCRIPTION

FIG. 1 is a top, front, right perspective view of vehicle
interior, showing my new design;
FIG. 2 is a top, rear, left perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is right side view thereof;
FIG. 6 is left side view thereof; and,
FIG. 7 is a top plan view thereof.

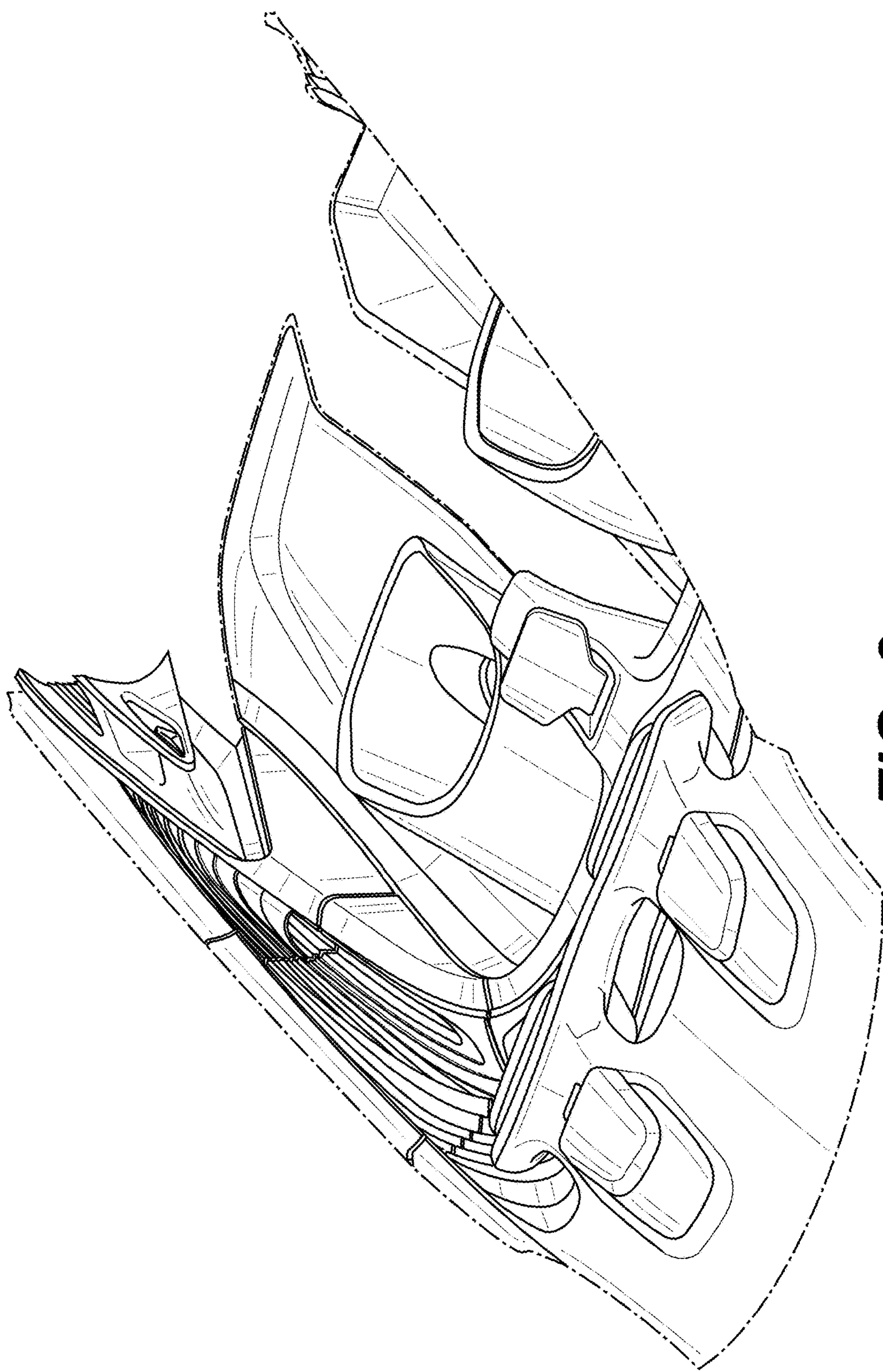

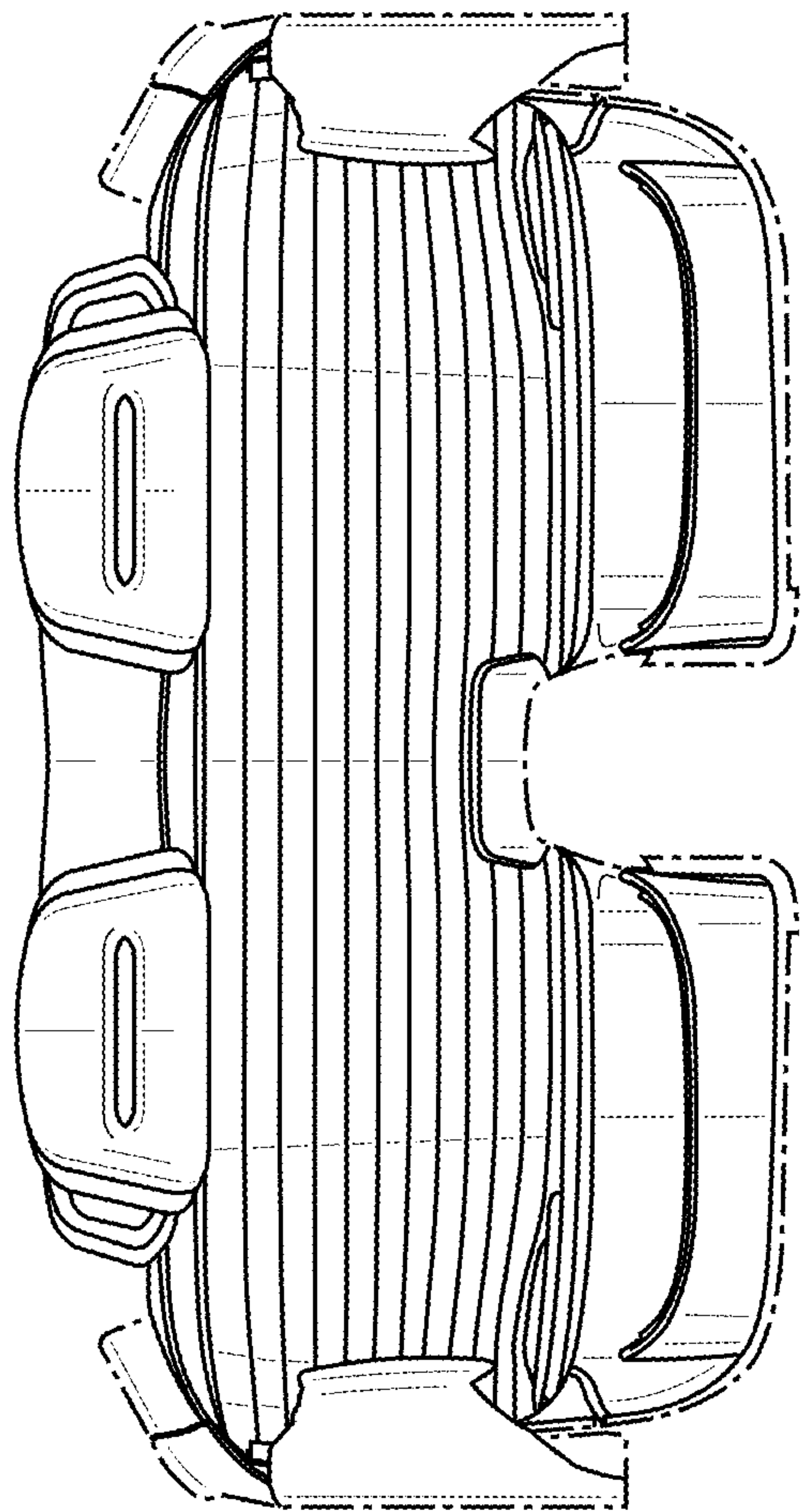

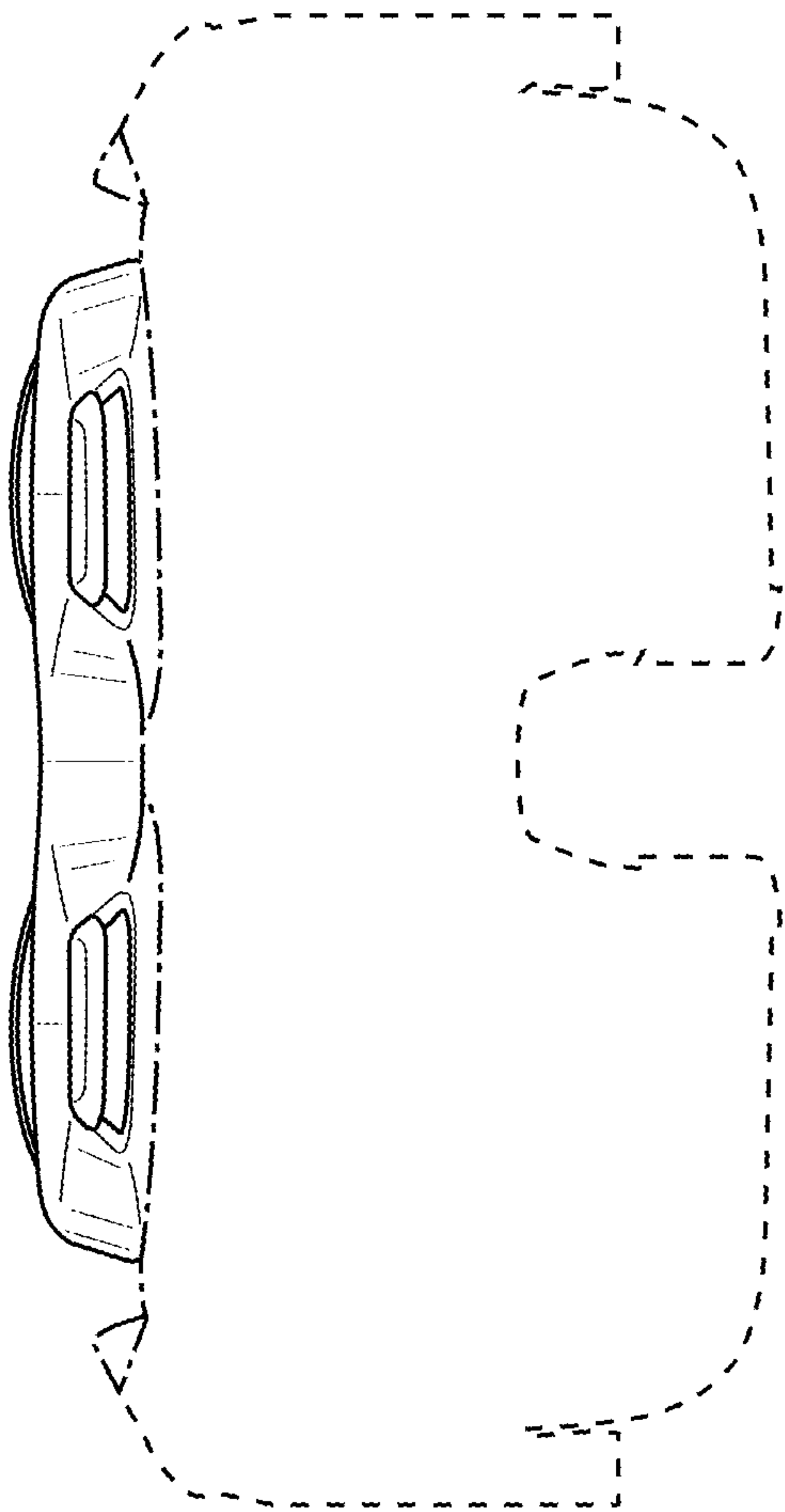

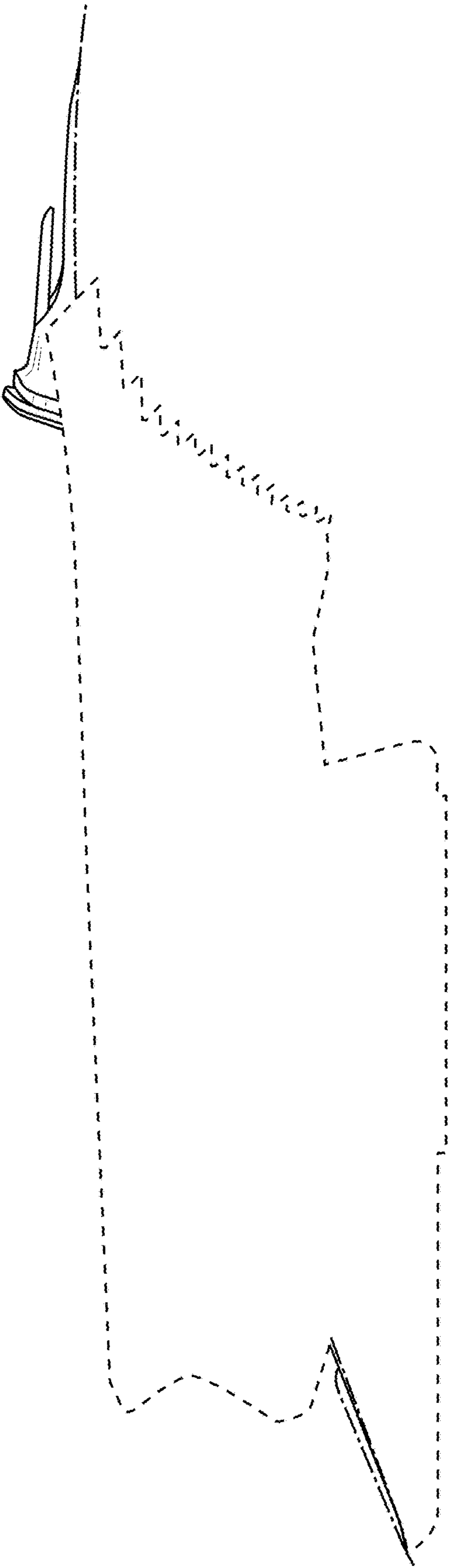

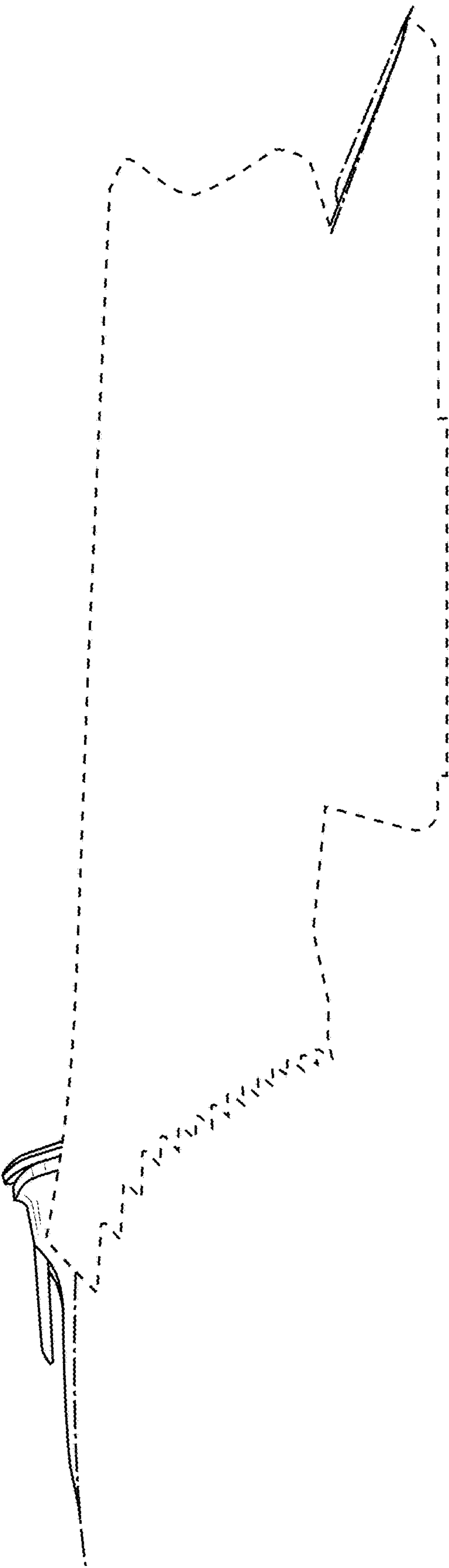

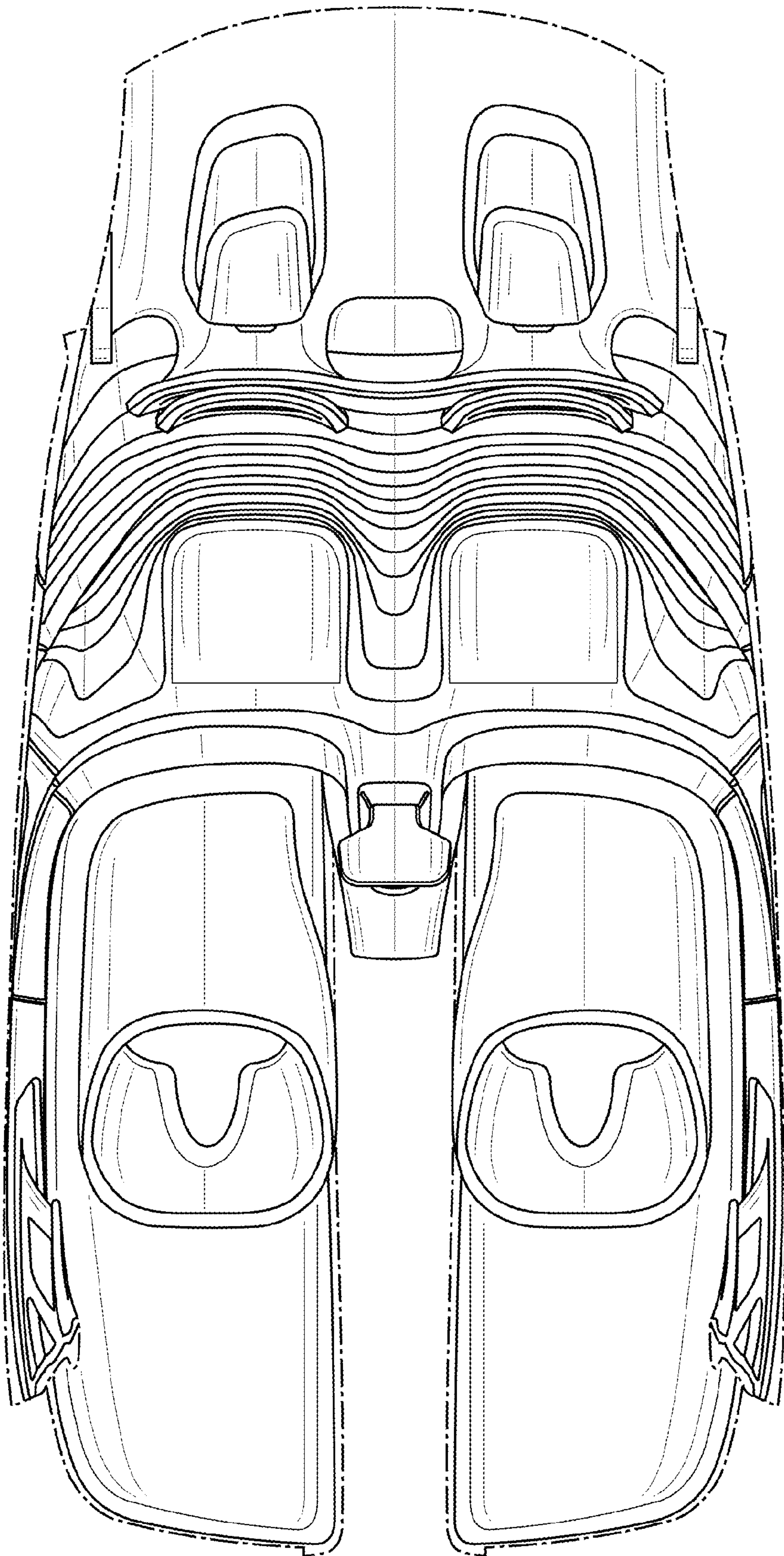
