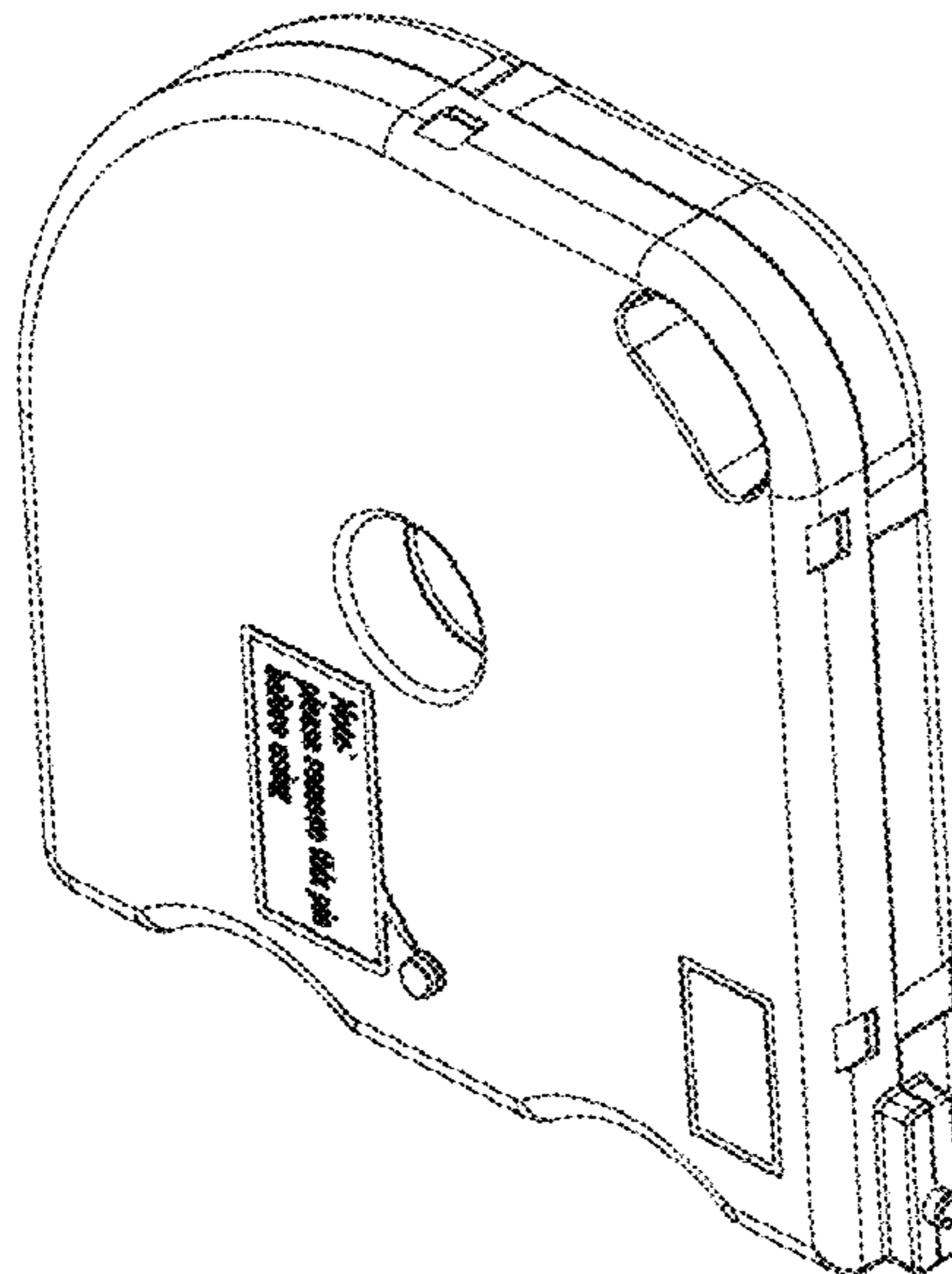
(57) **CLAIM**

The ornamental designs for a filament cartridge for 3D printing, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a filament cartridge for 3D printing in accordance with our new design;

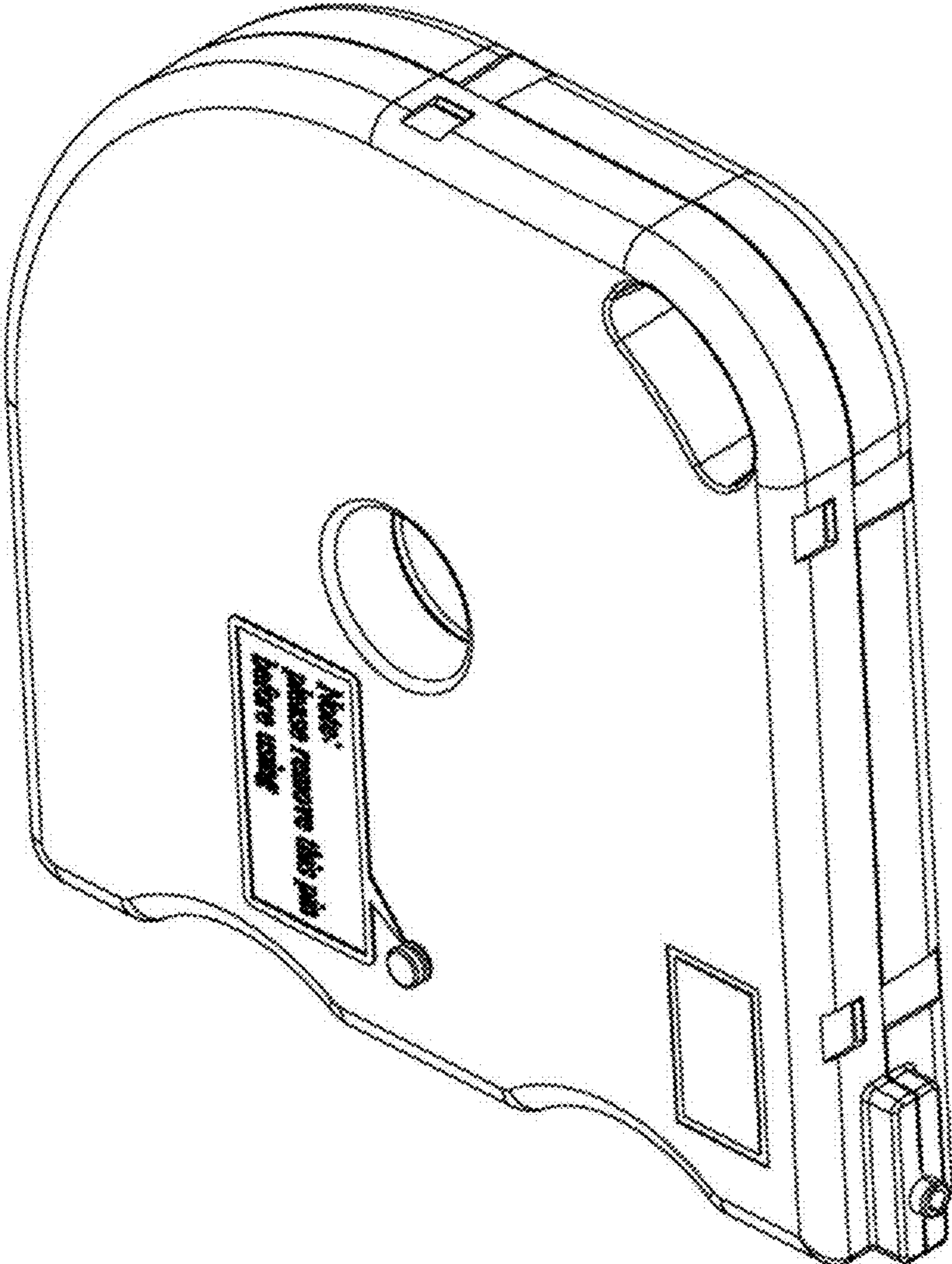

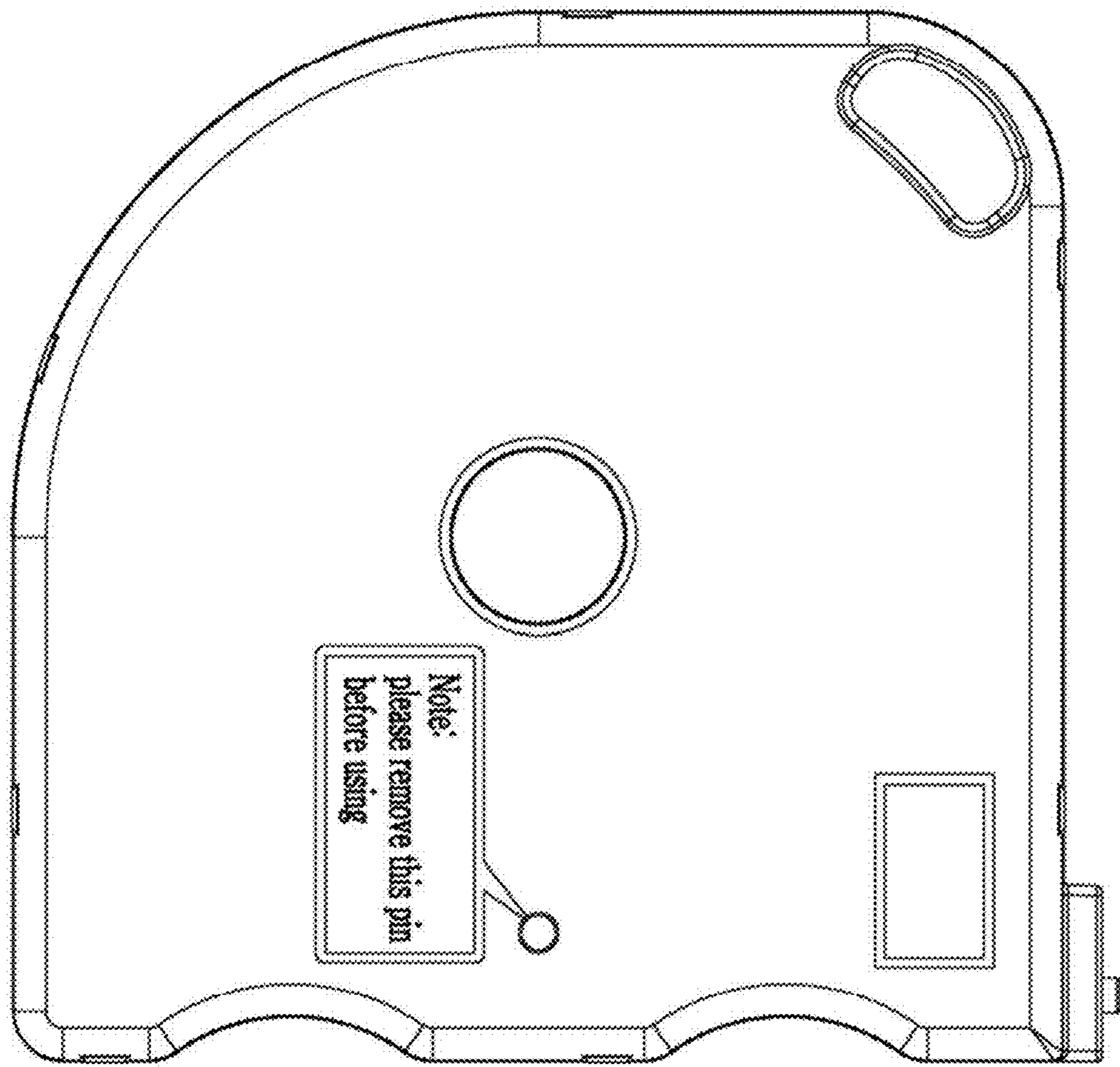

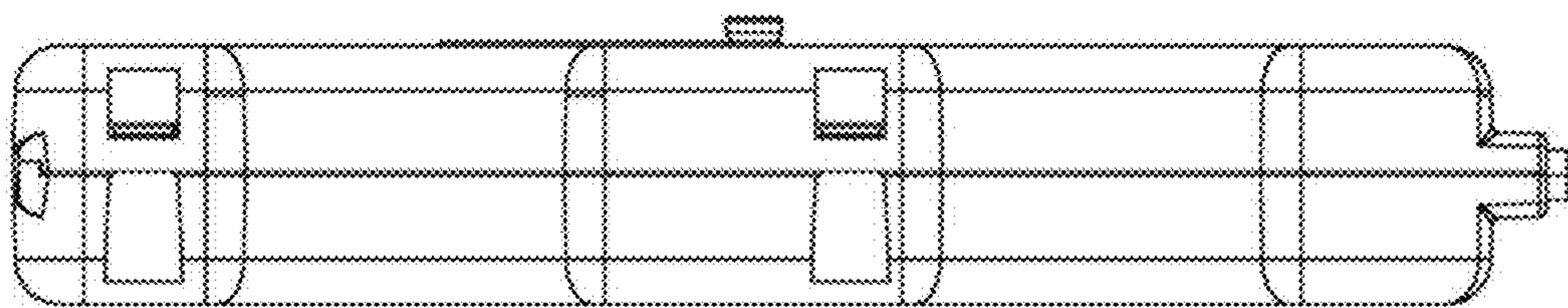

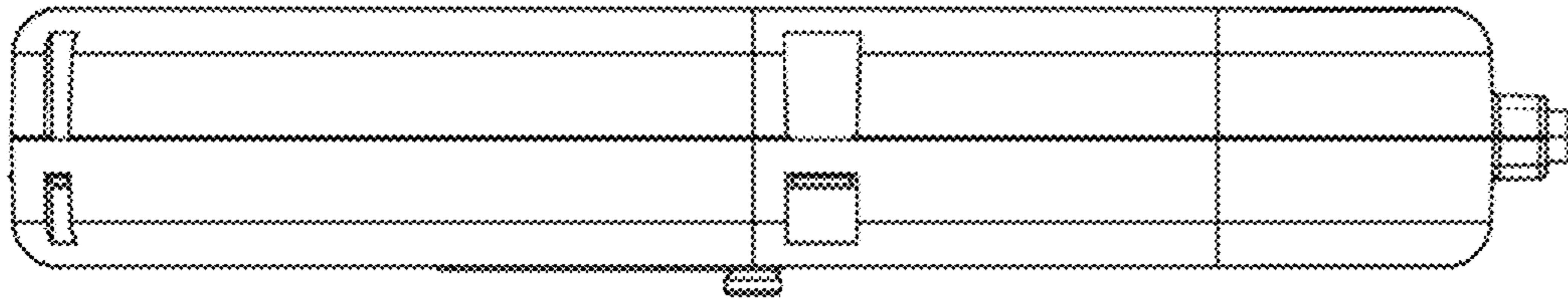

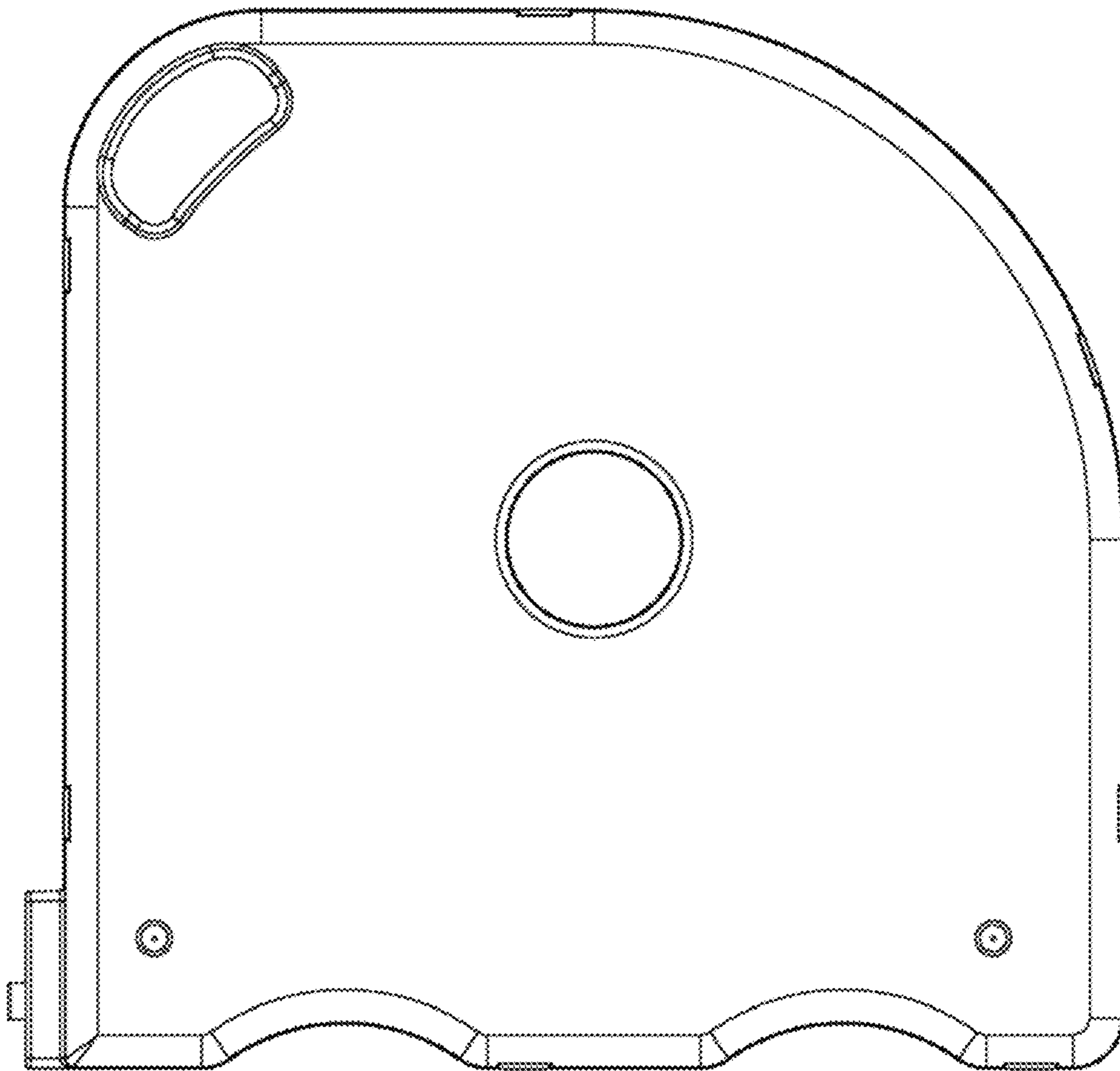

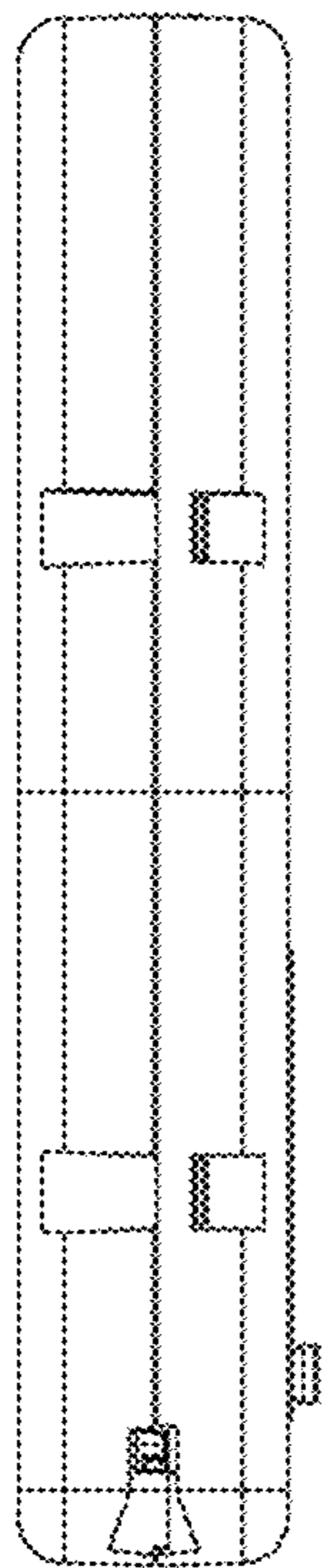

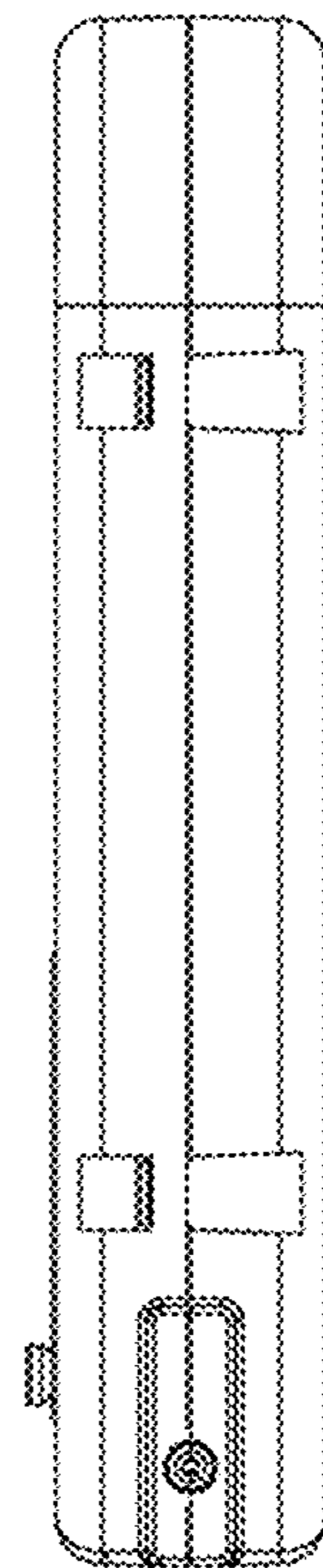
