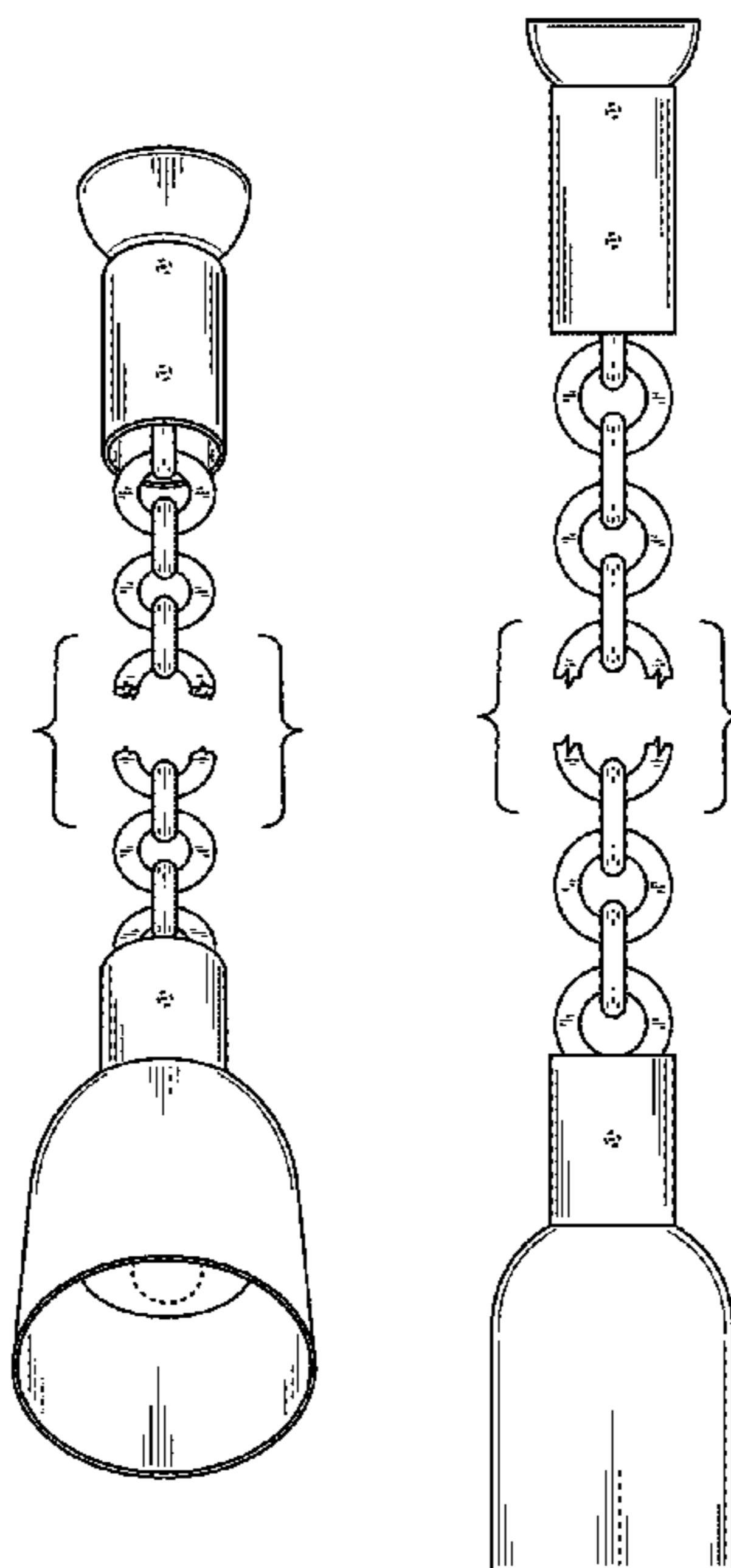
(57) **CLAIM**

The ornamental design for a mono-light fixture, as shown
and described.

DESCRIPTION

FIG. 1 is a perspective view of the mono-light fixture,
showing our new design;
FIG. 2 is a front elevation view thereof, the rear elevation
view being a mirror image;
FIG. 3 is the right side elevation view, the left side elevation
view being a mirror image;
FIG. 4 is a top plan view thereof; and,
FIG. 5 is a bottom plan view thereof.
The break lines in FIGS. 1, 2 and 3 are to indicate that the
appearance of any portion of the mono-light fixture between
the break lines forms no part of the claimed design, and the
broken lines shown on the drawings depict portions of the
light fixture that form no part of the claimed design.

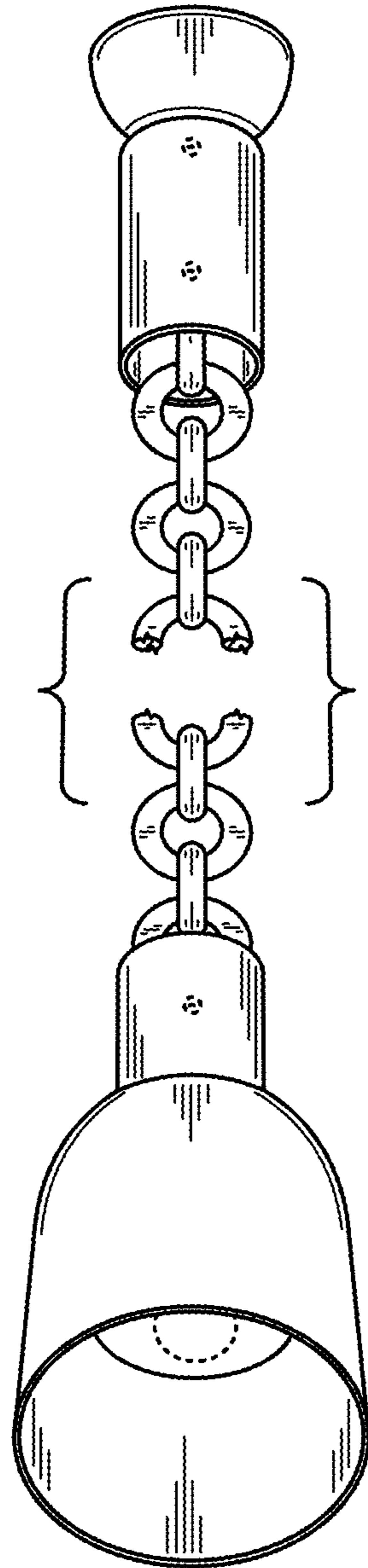

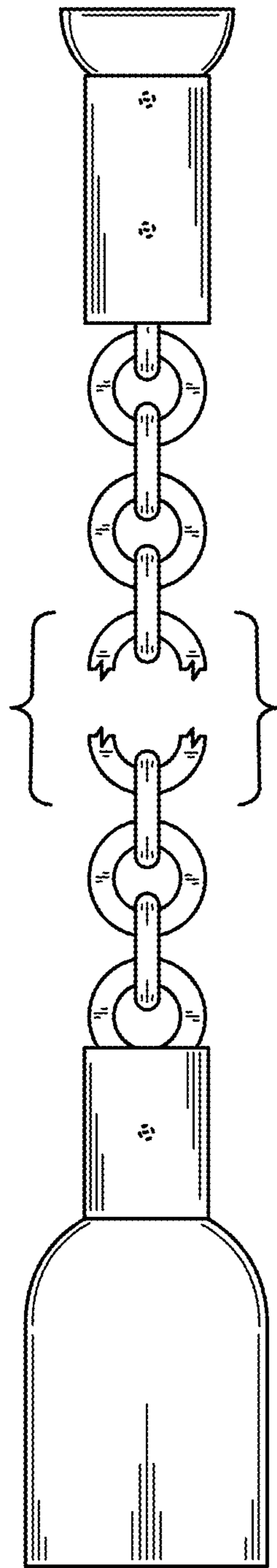

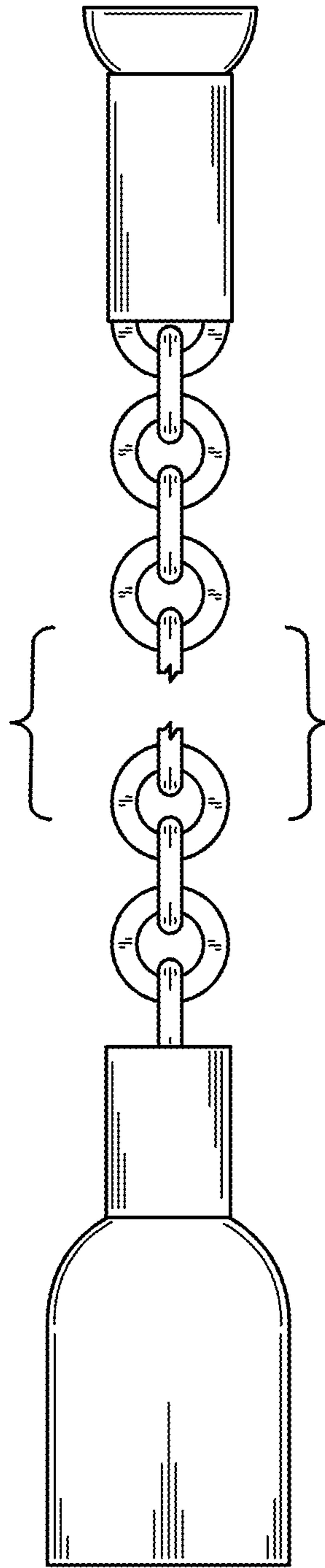

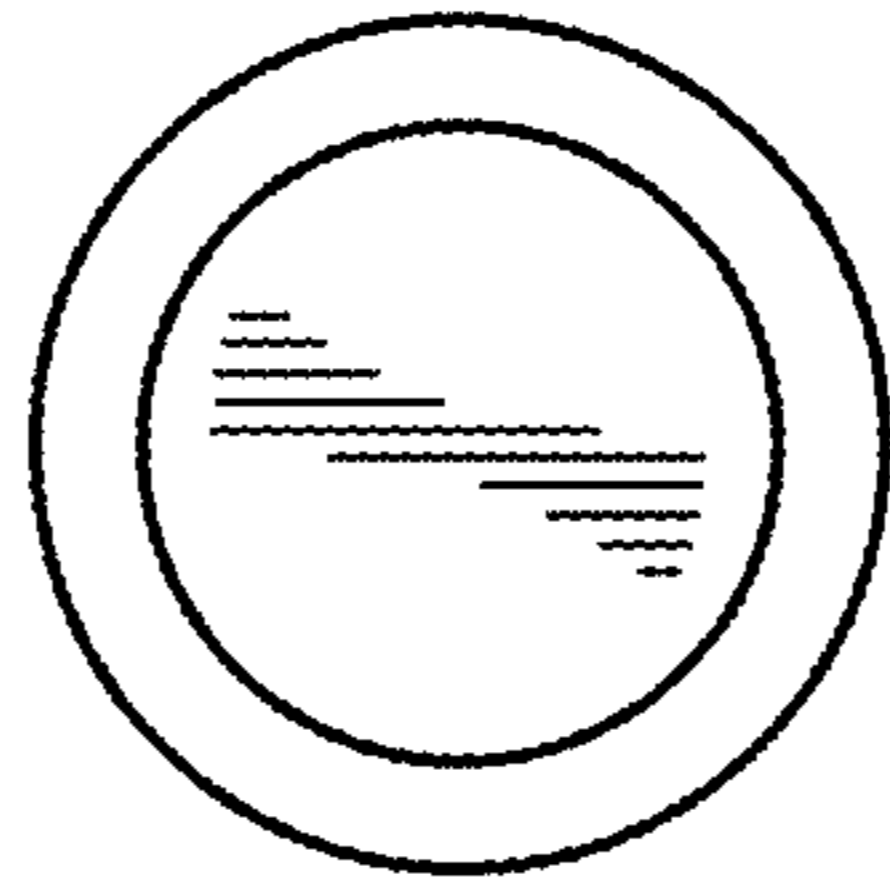

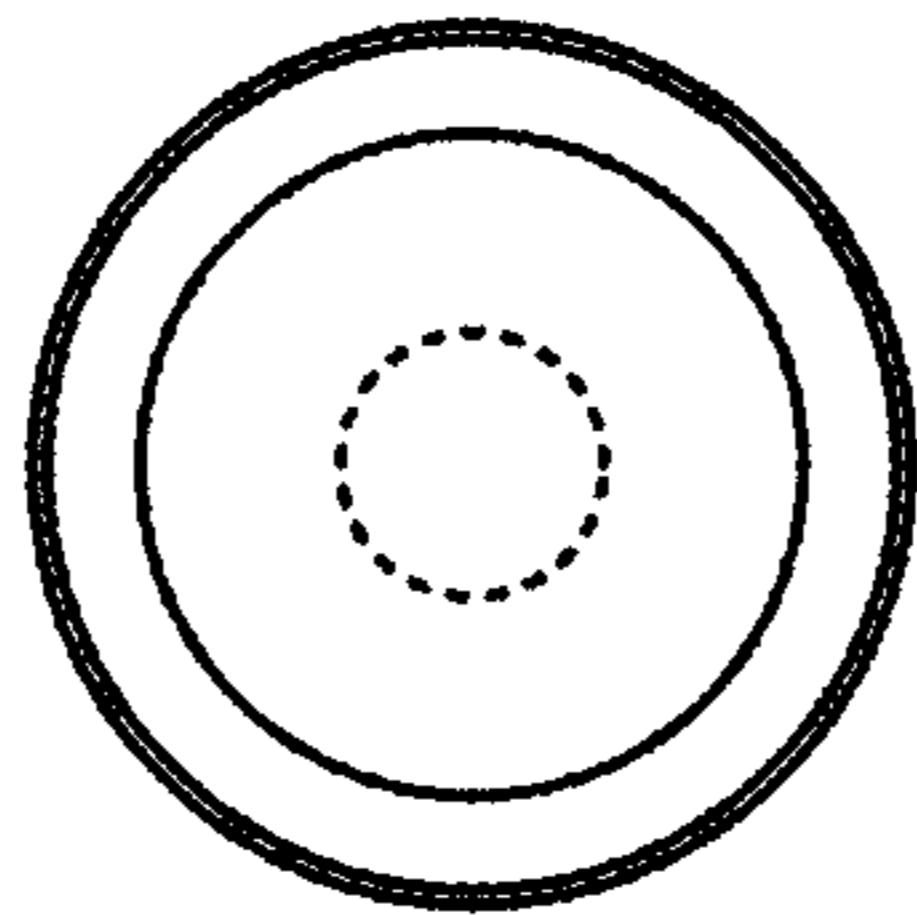
