The ornamental design for a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe outsole showing my new design;

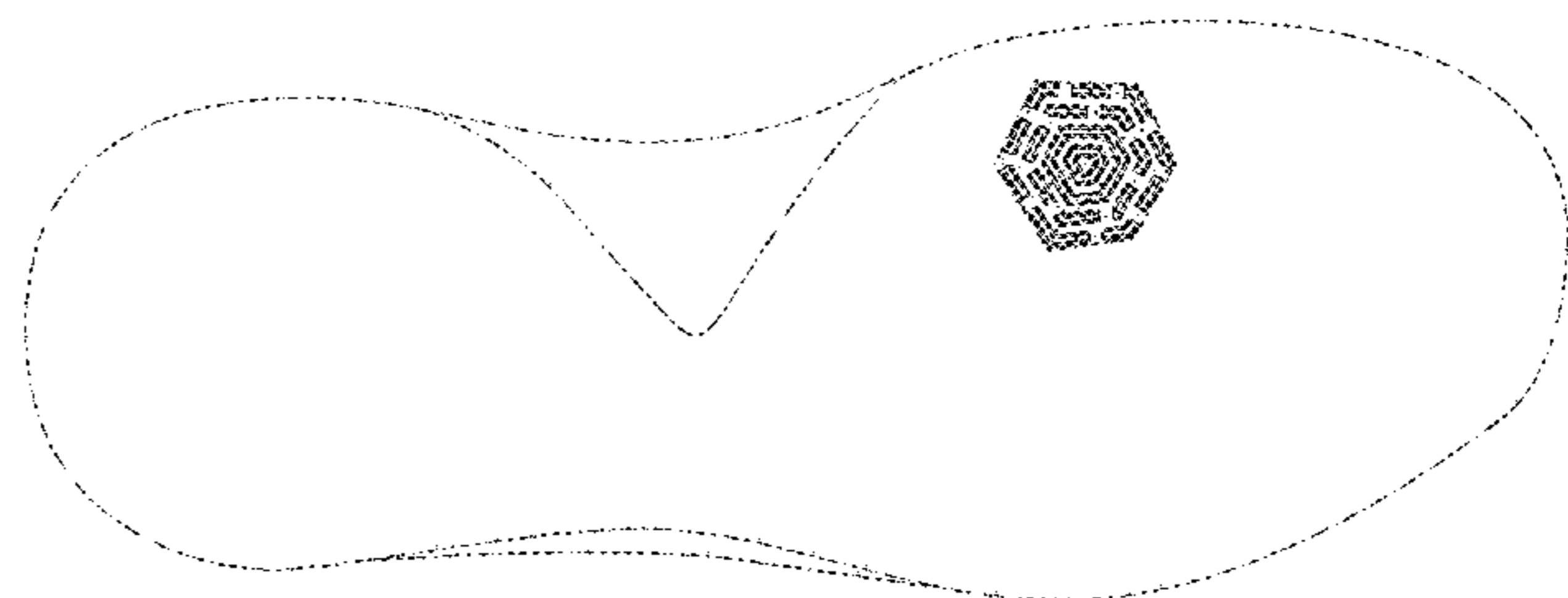
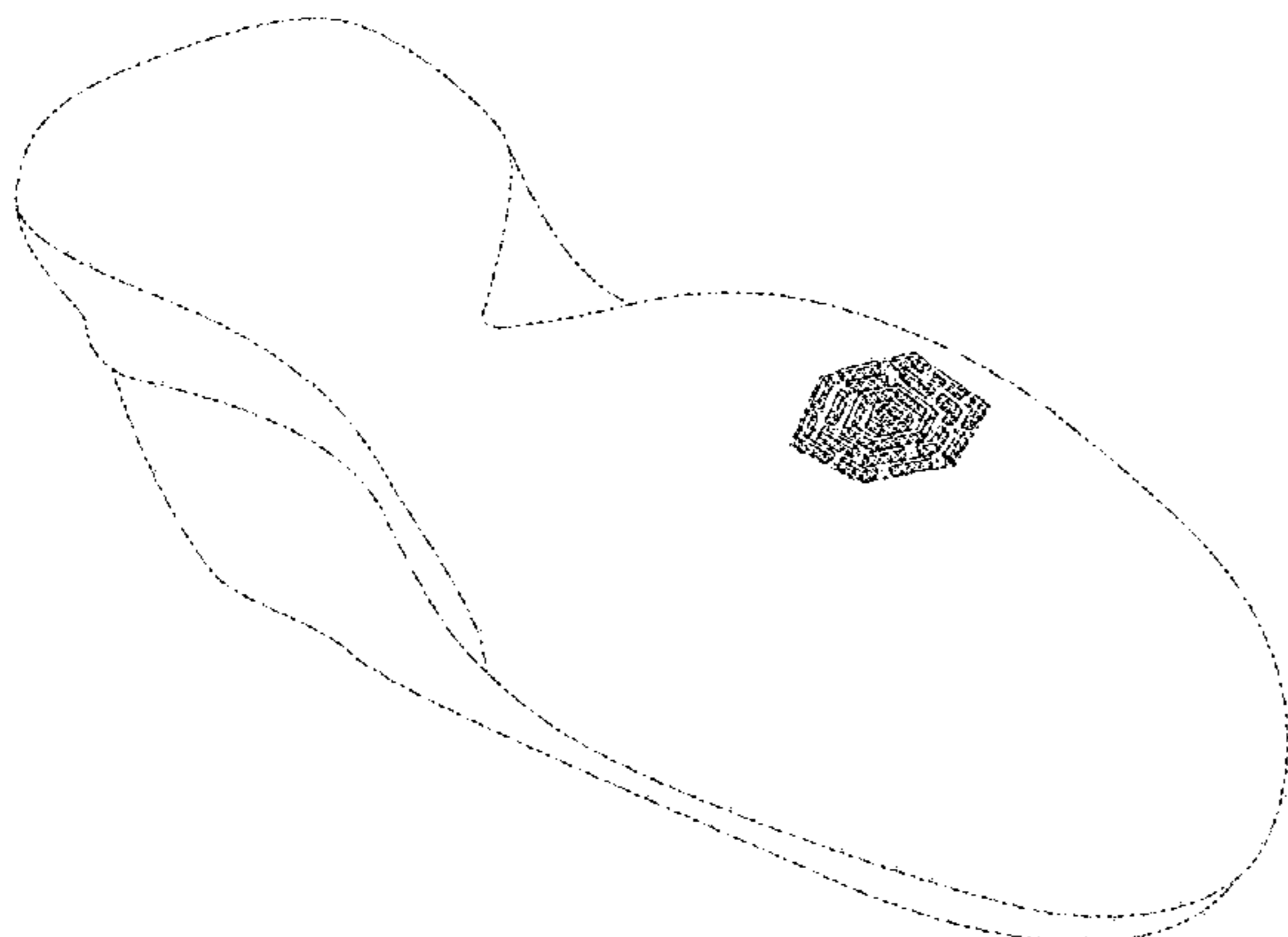
FIG. 2 is a bottom view thereof;

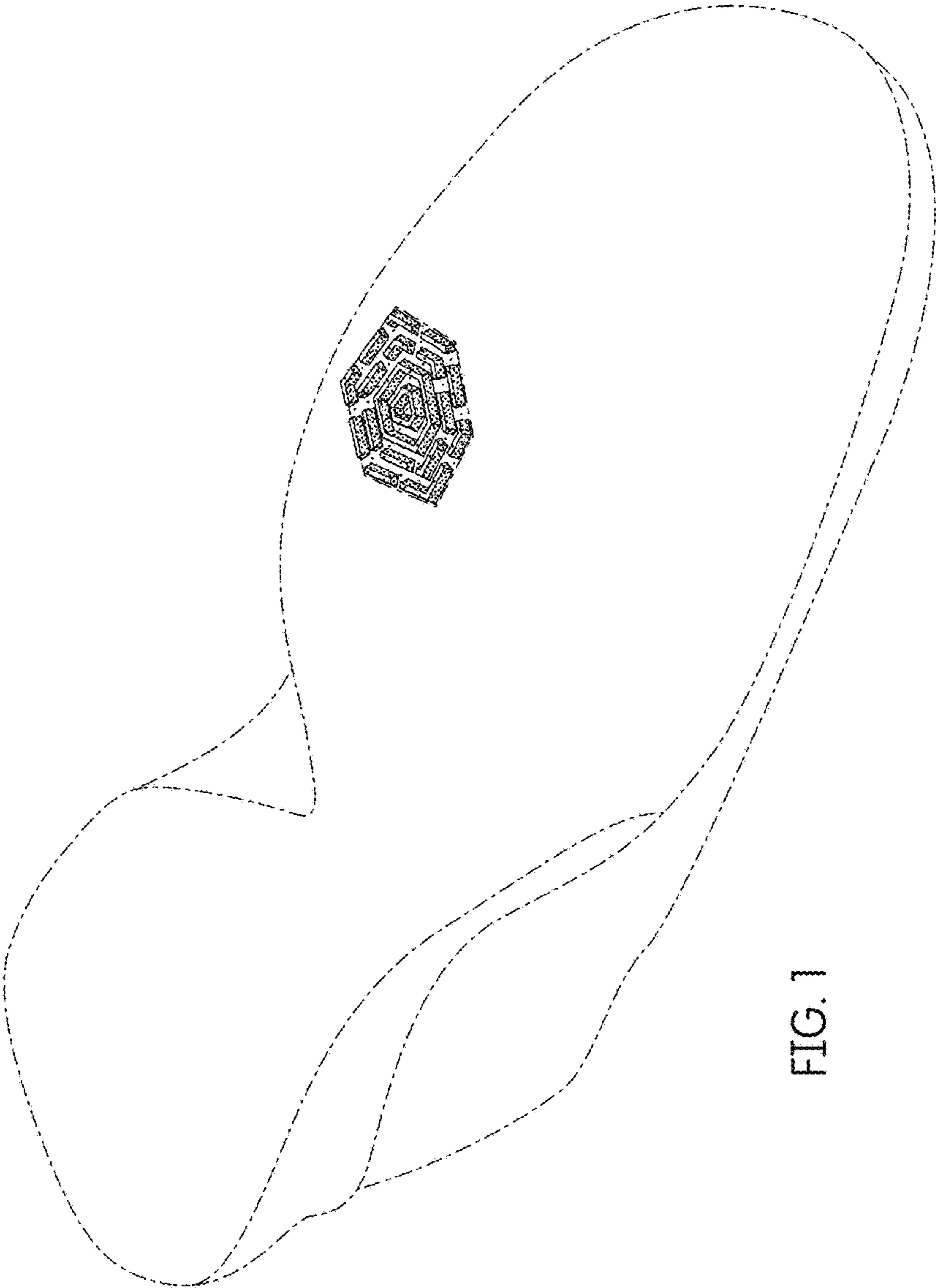

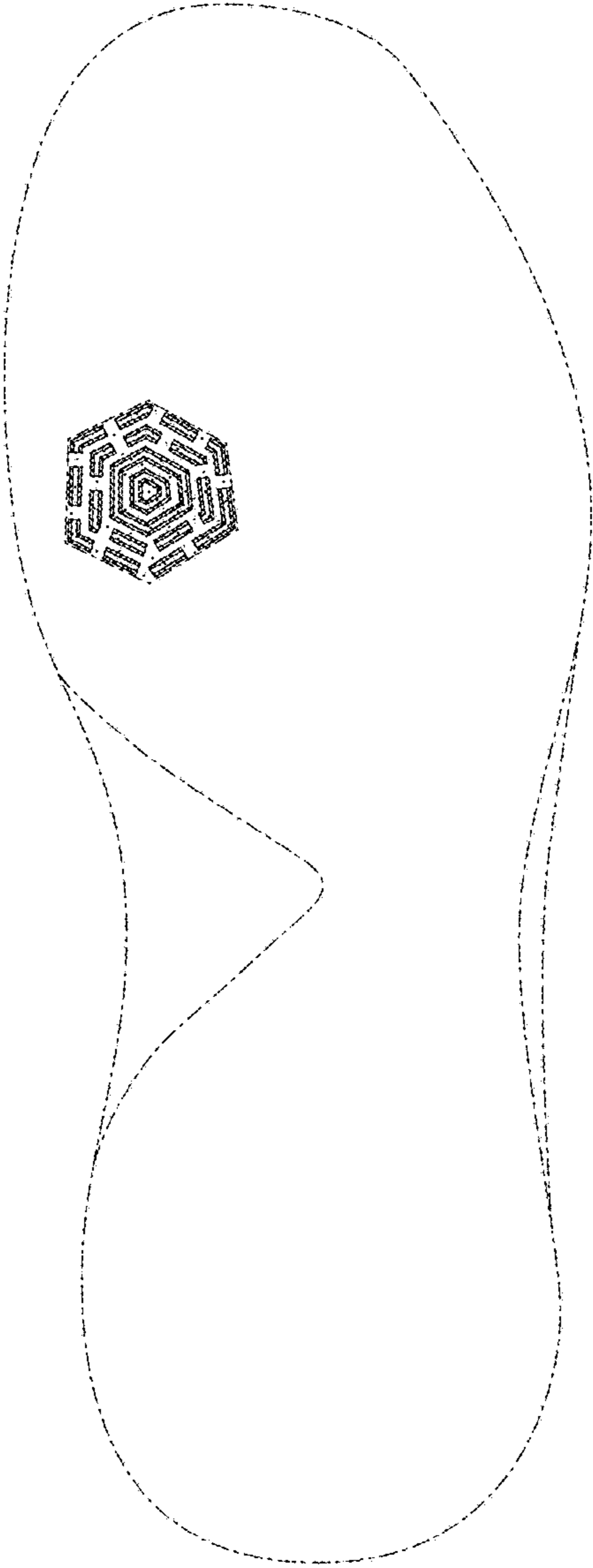

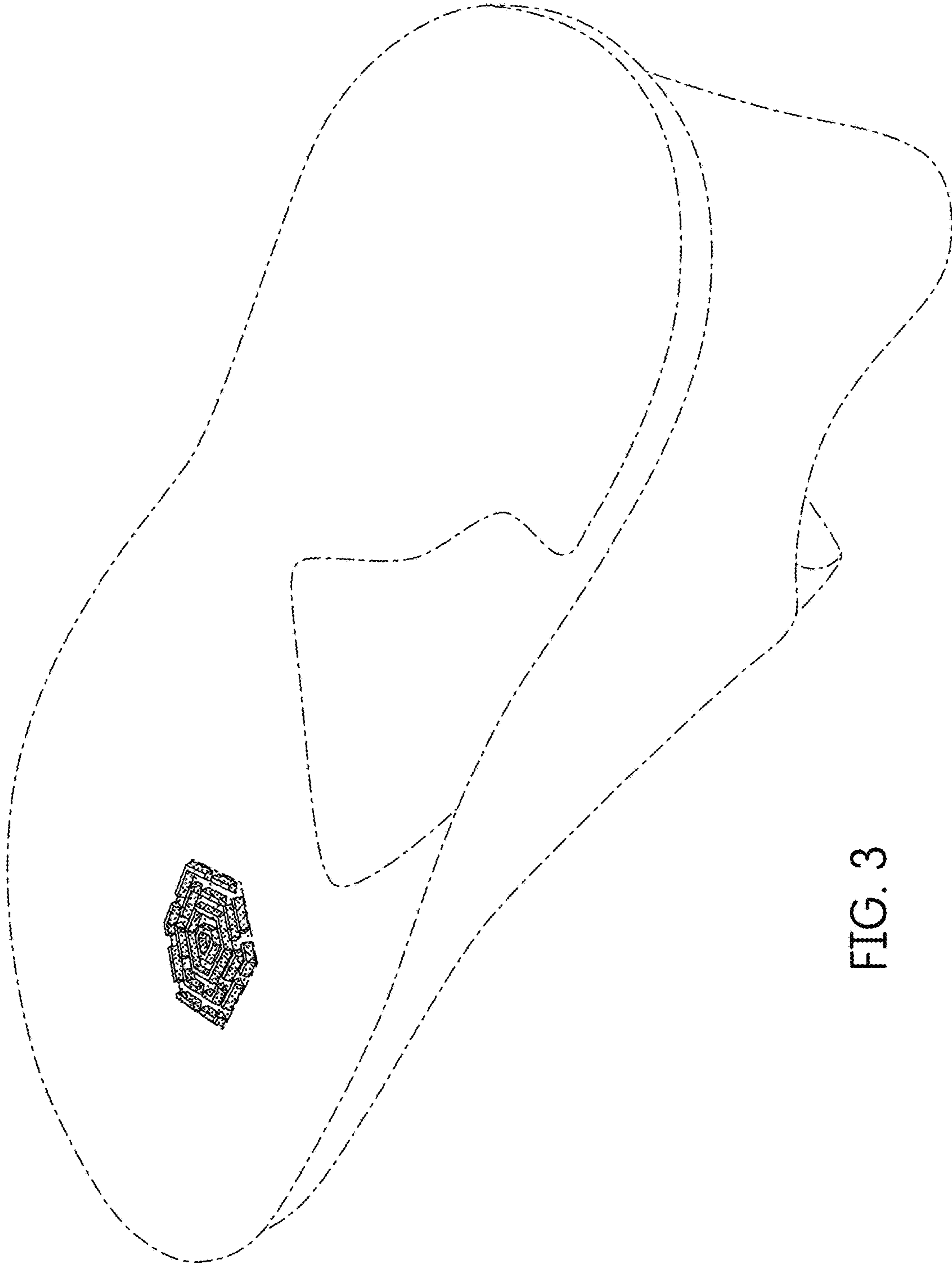

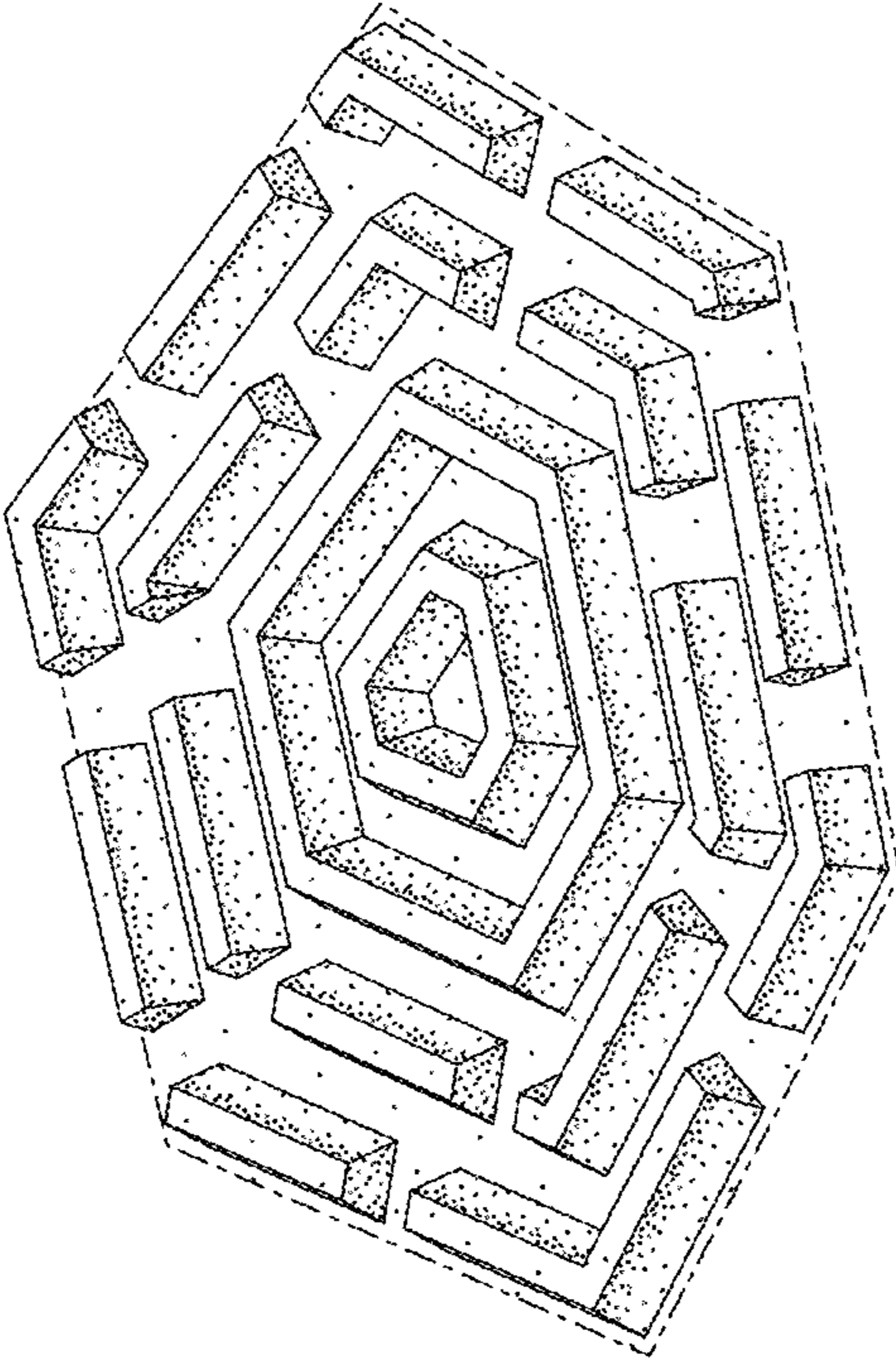
