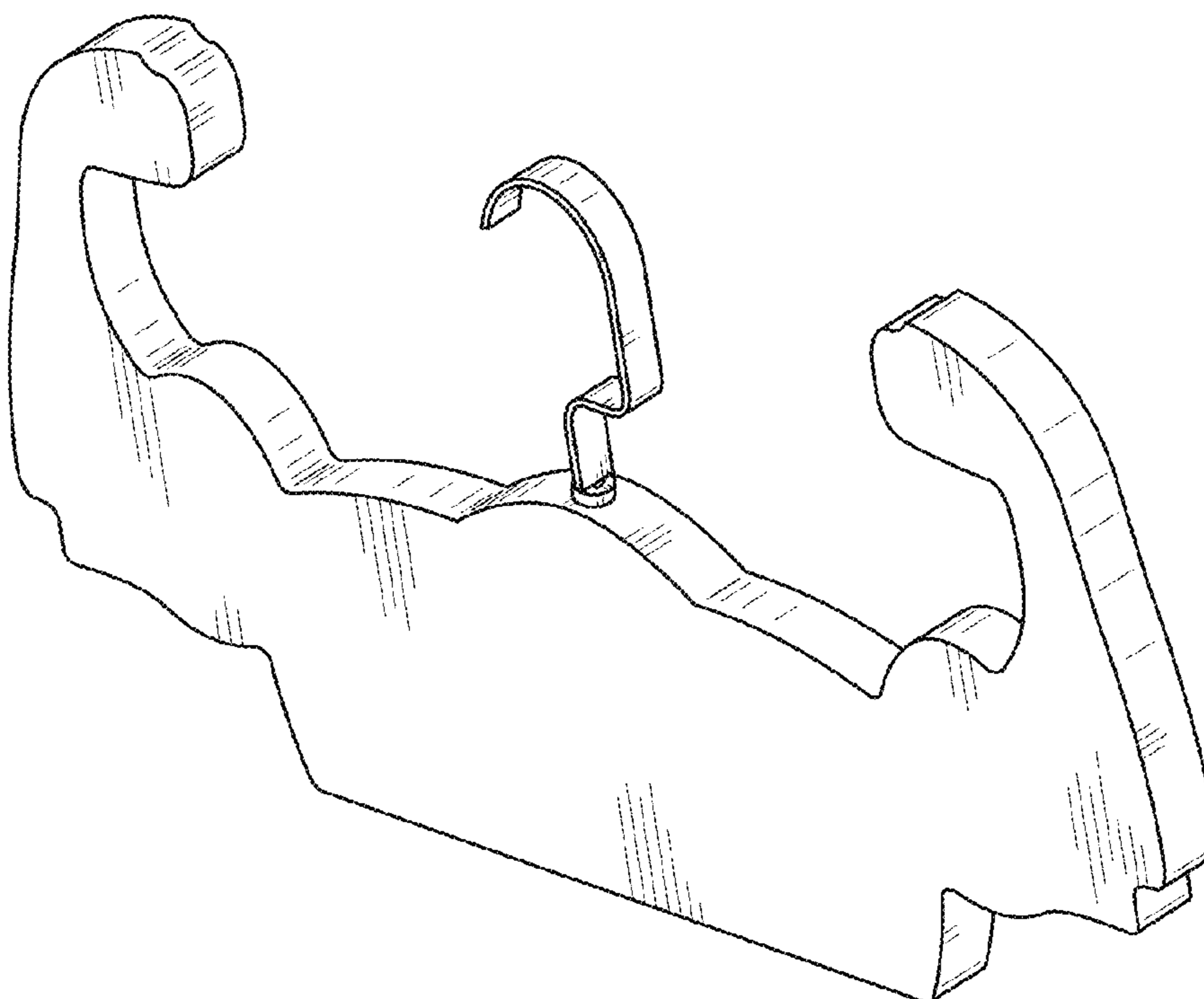
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front and side perspective view of a clothes hanger;  
FIG. 2 is a bottom and side perspective view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a side elevational view thereof; the opposite side elevational view being a mirror image;

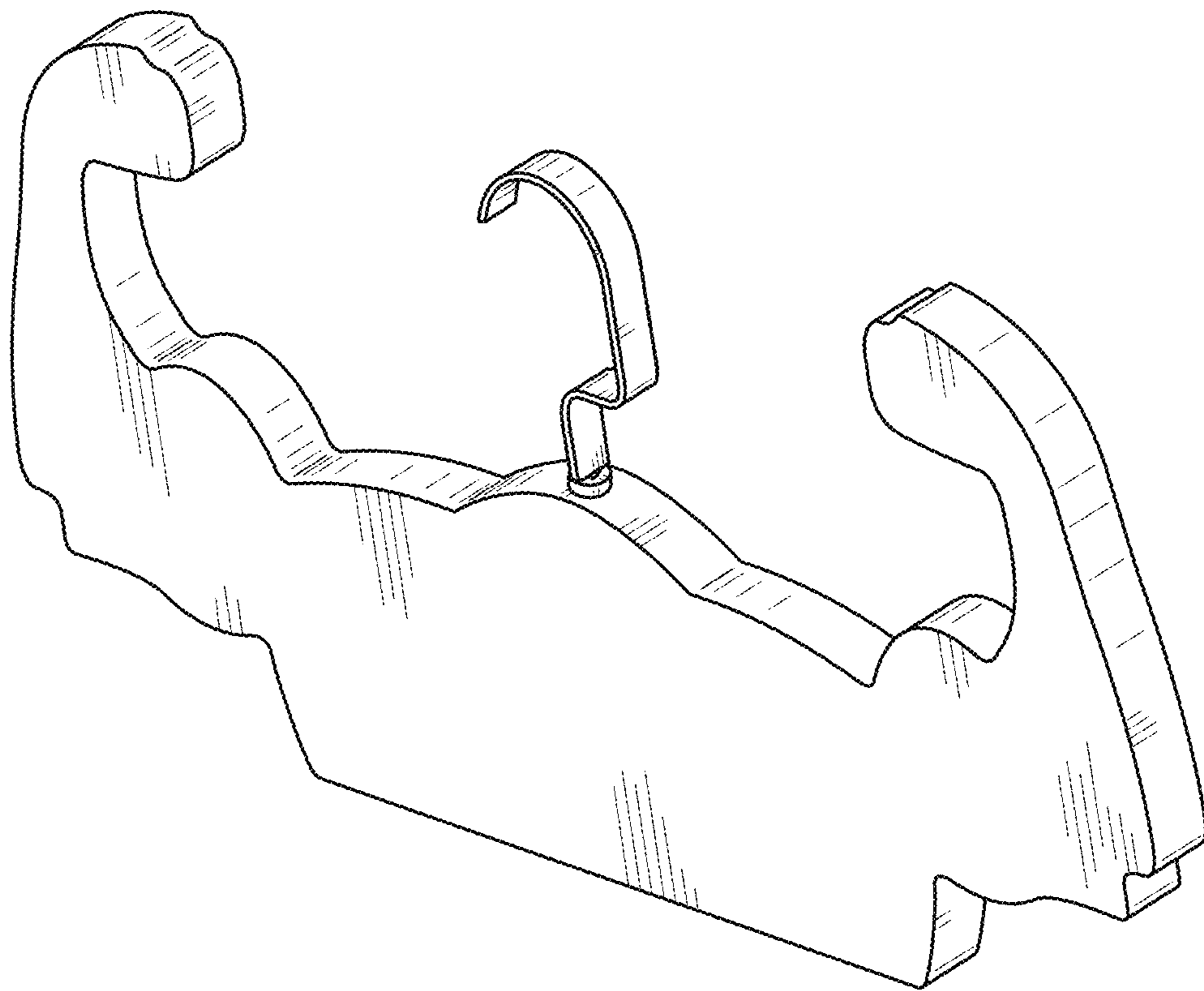

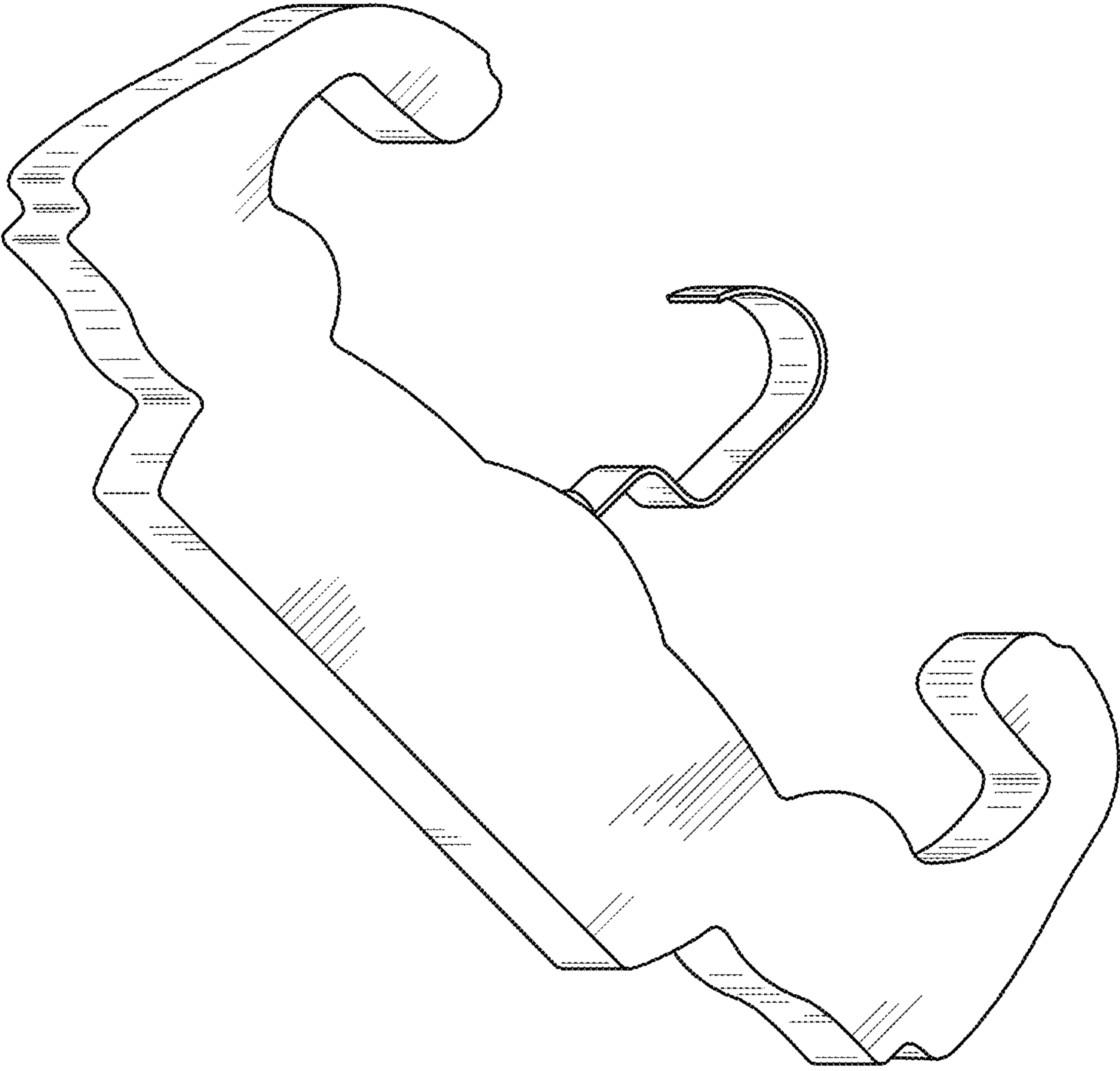

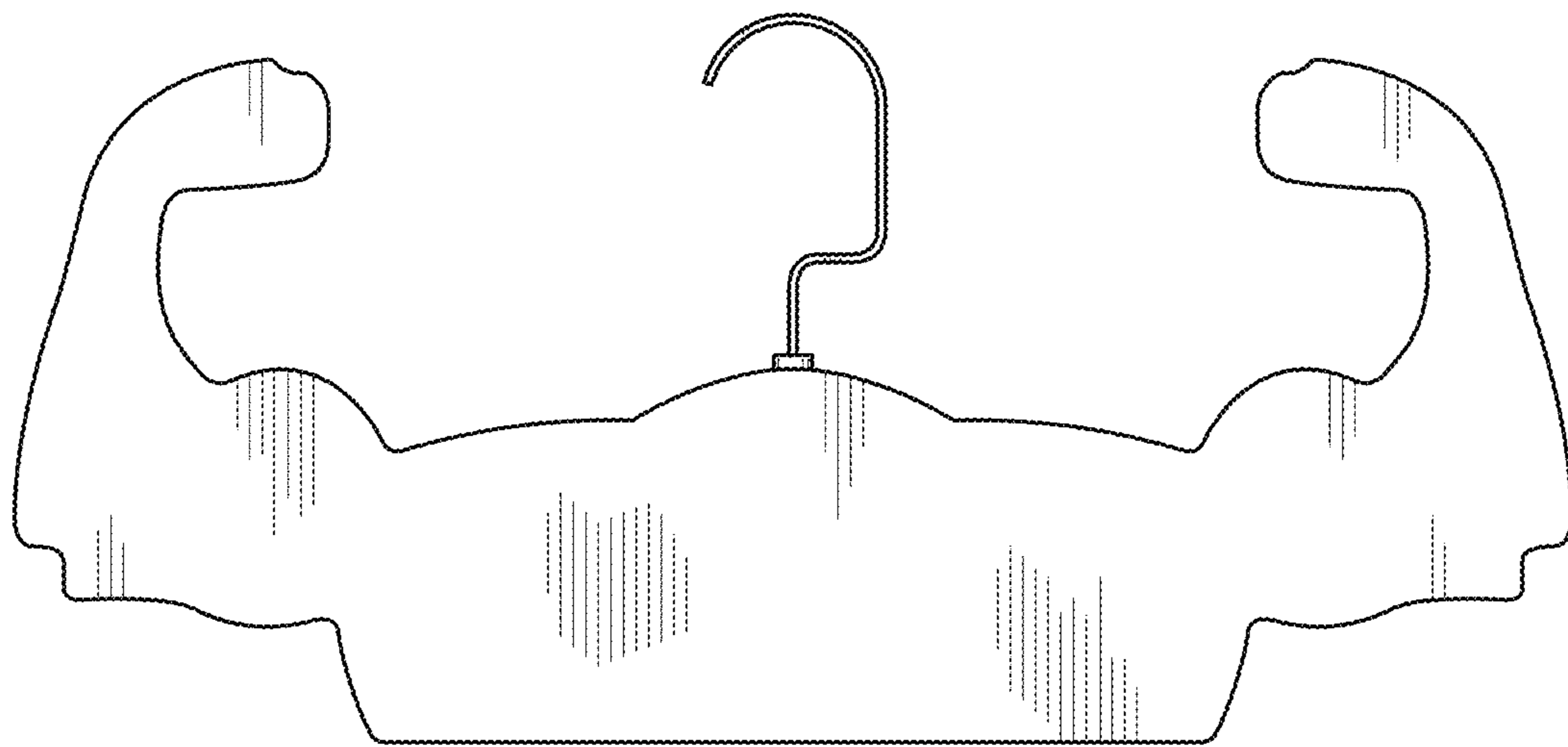

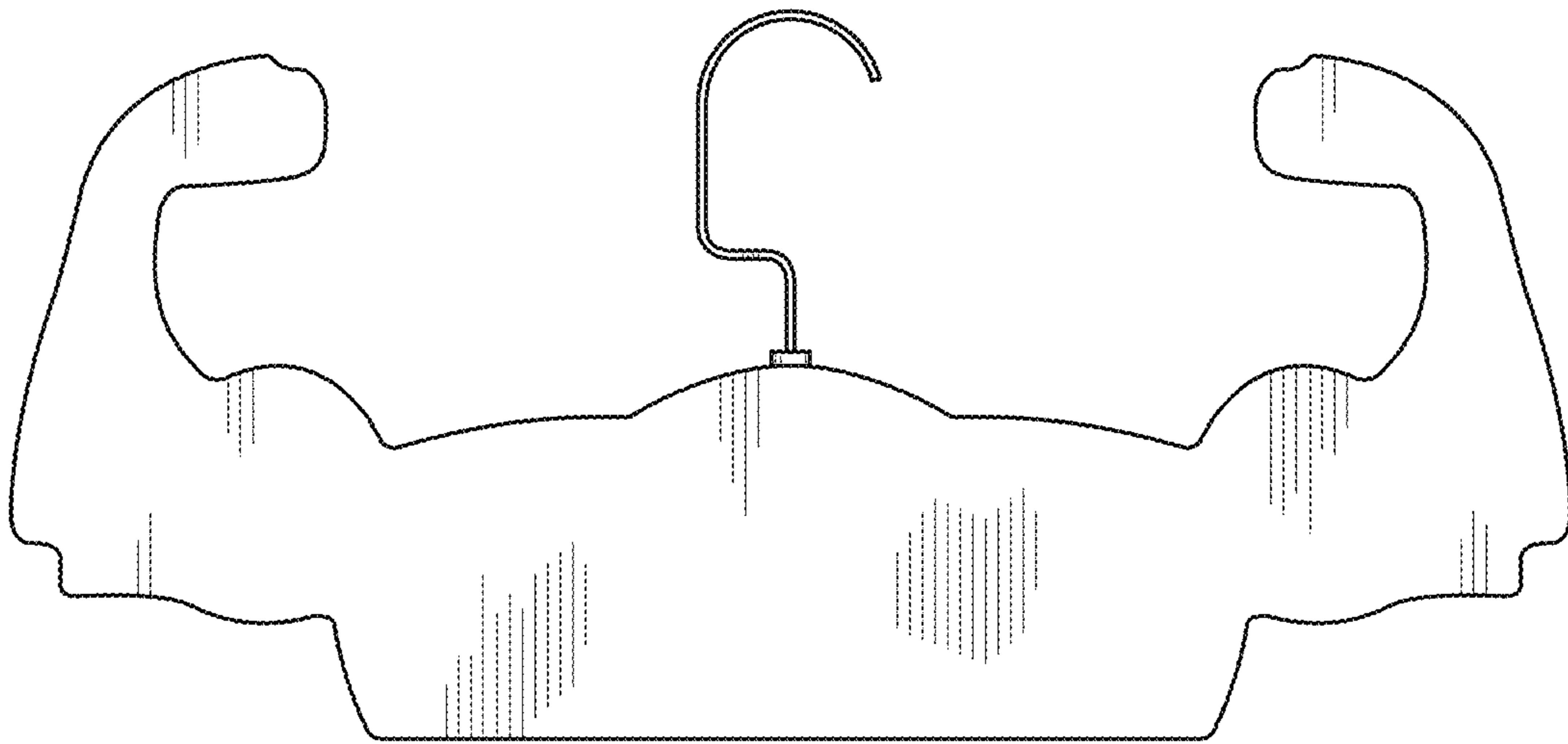

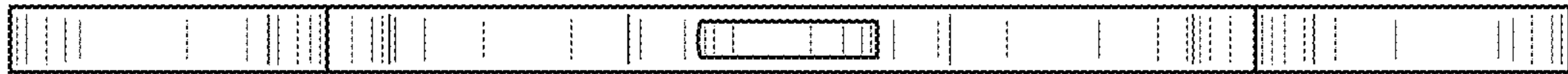
