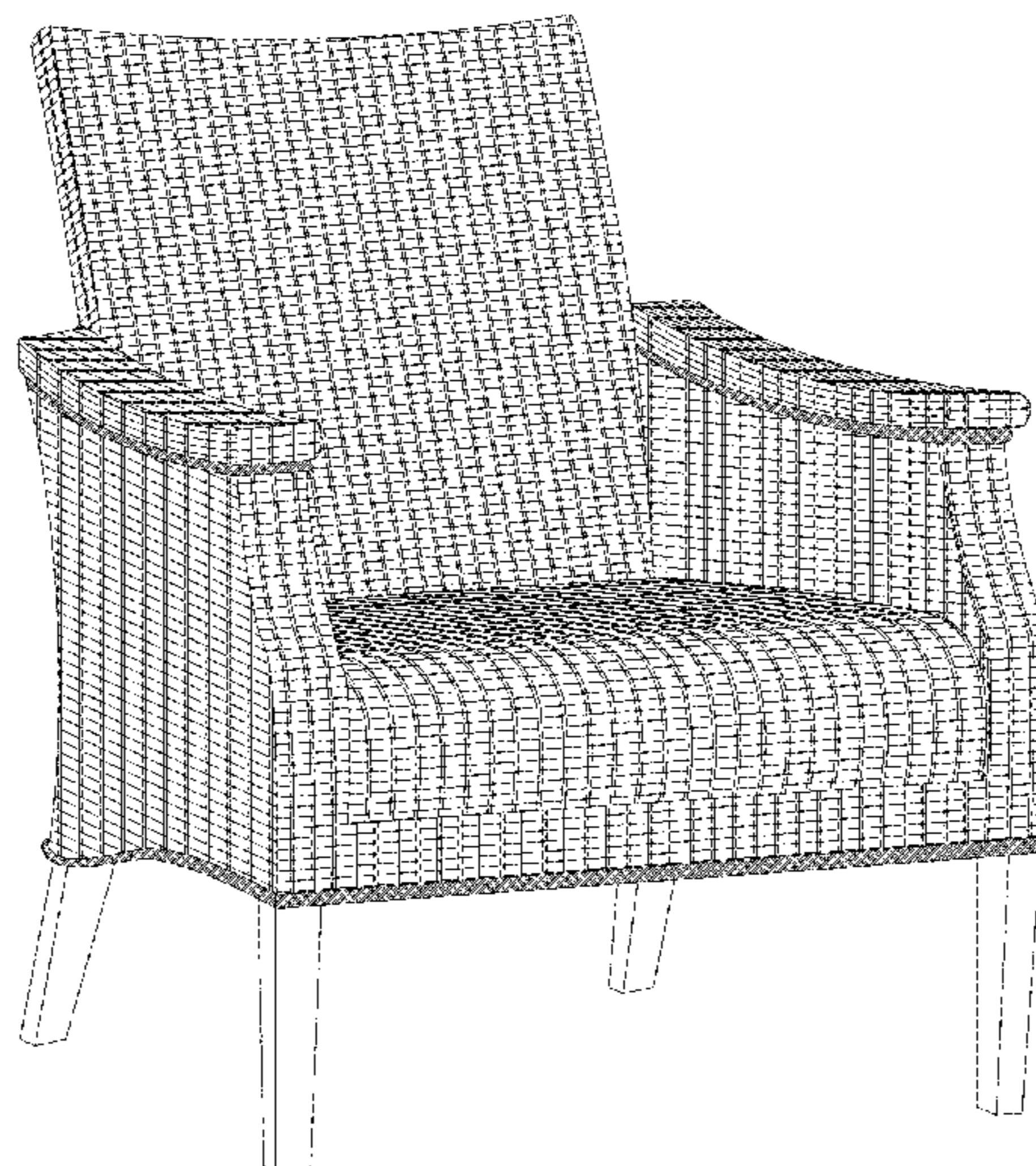
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the front and side of the lounge chair showing our ornamental design.
FIG. 2 is a side elevation view of the lounge chair, the opposite side being a mirror image thereof.
FIG. 3 is a top down view of the lounge chair.

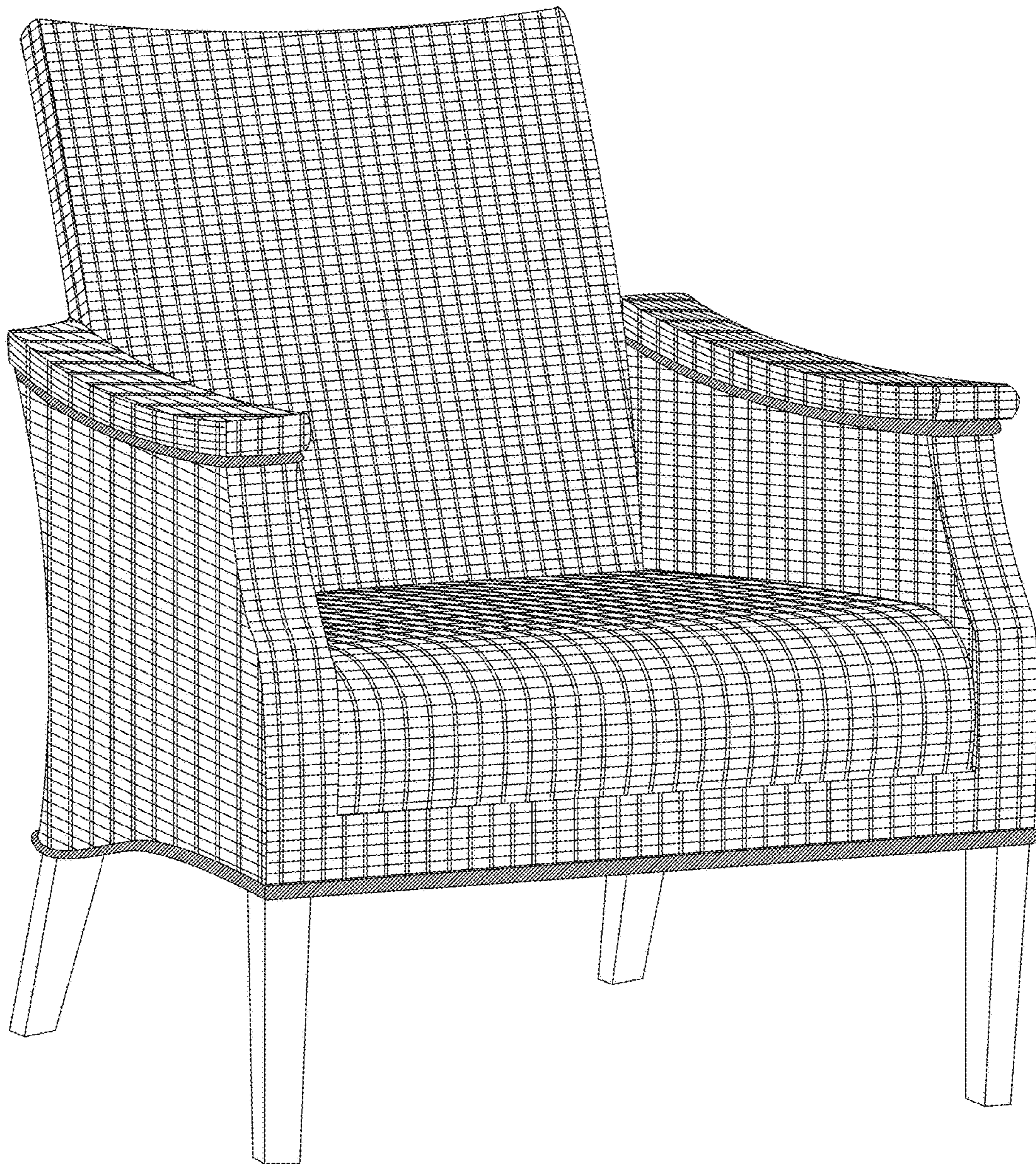

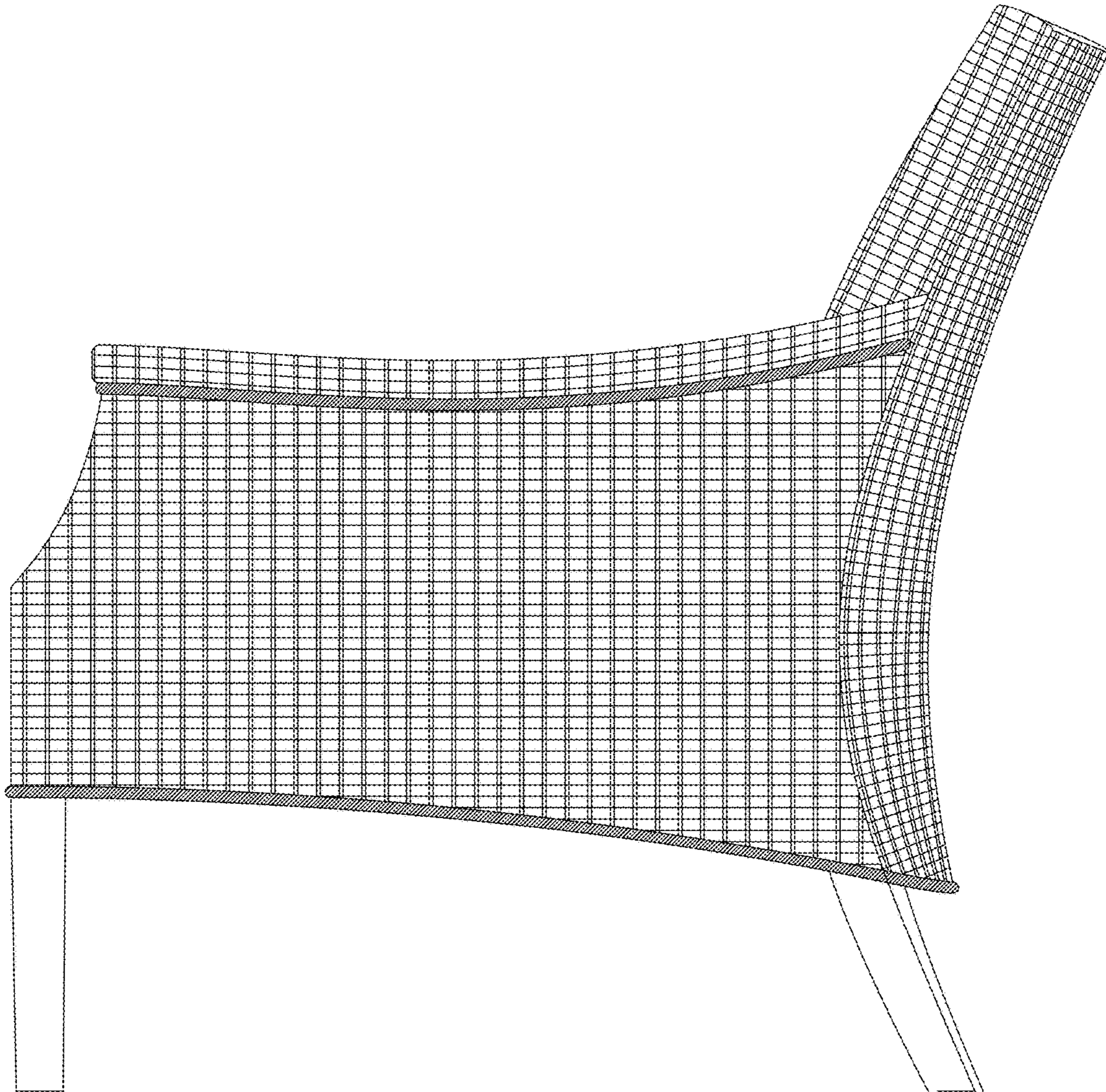

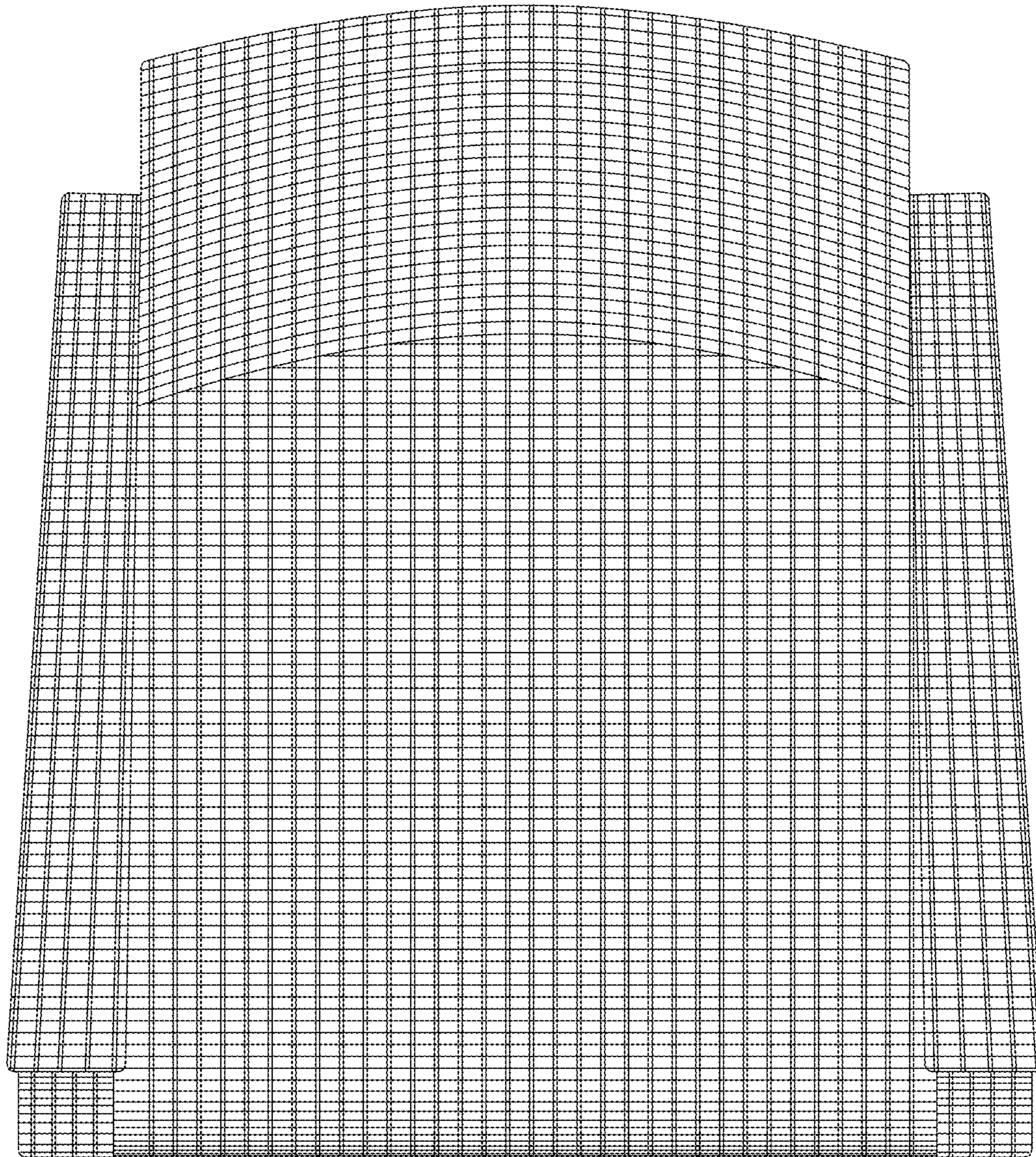

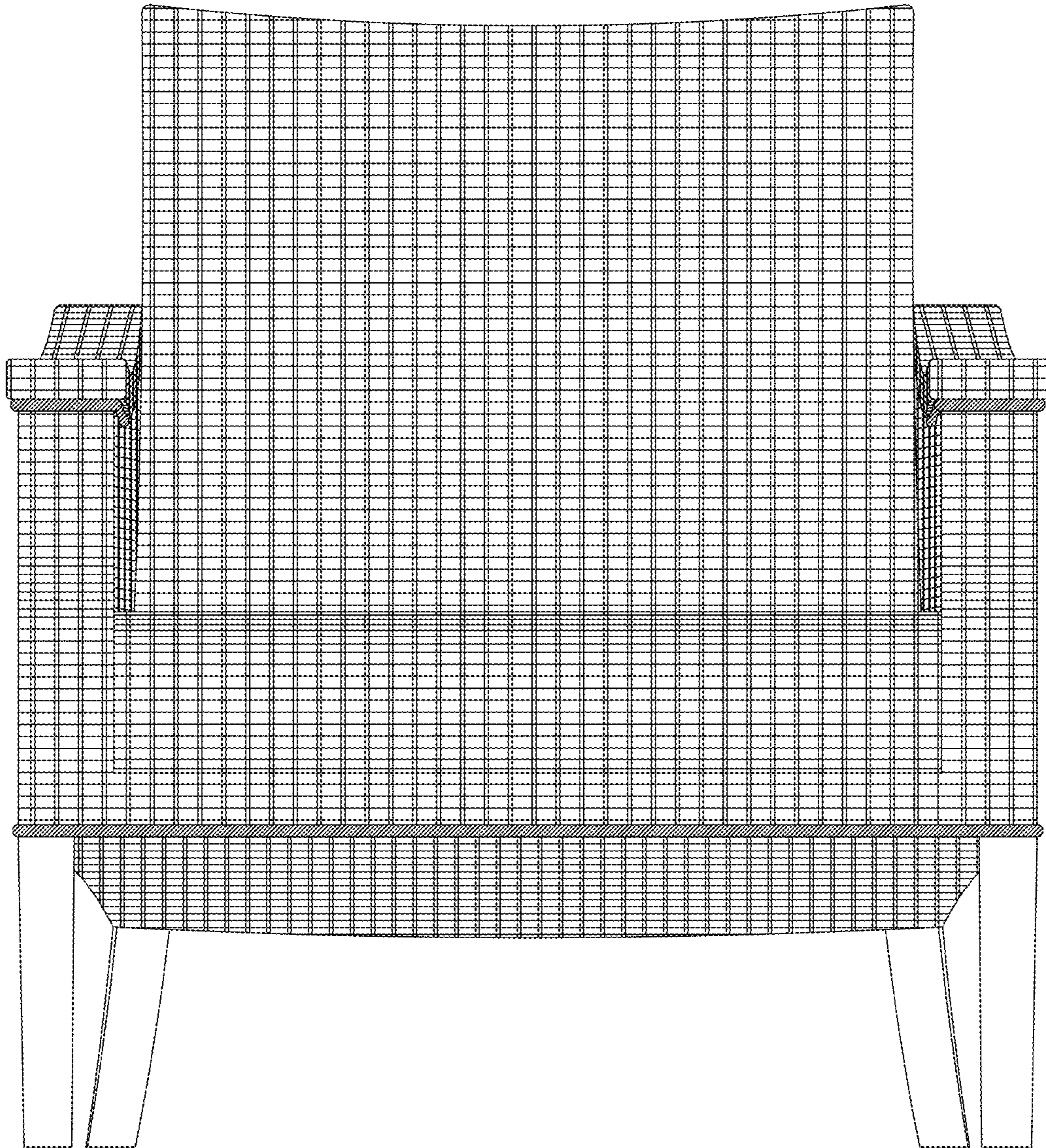

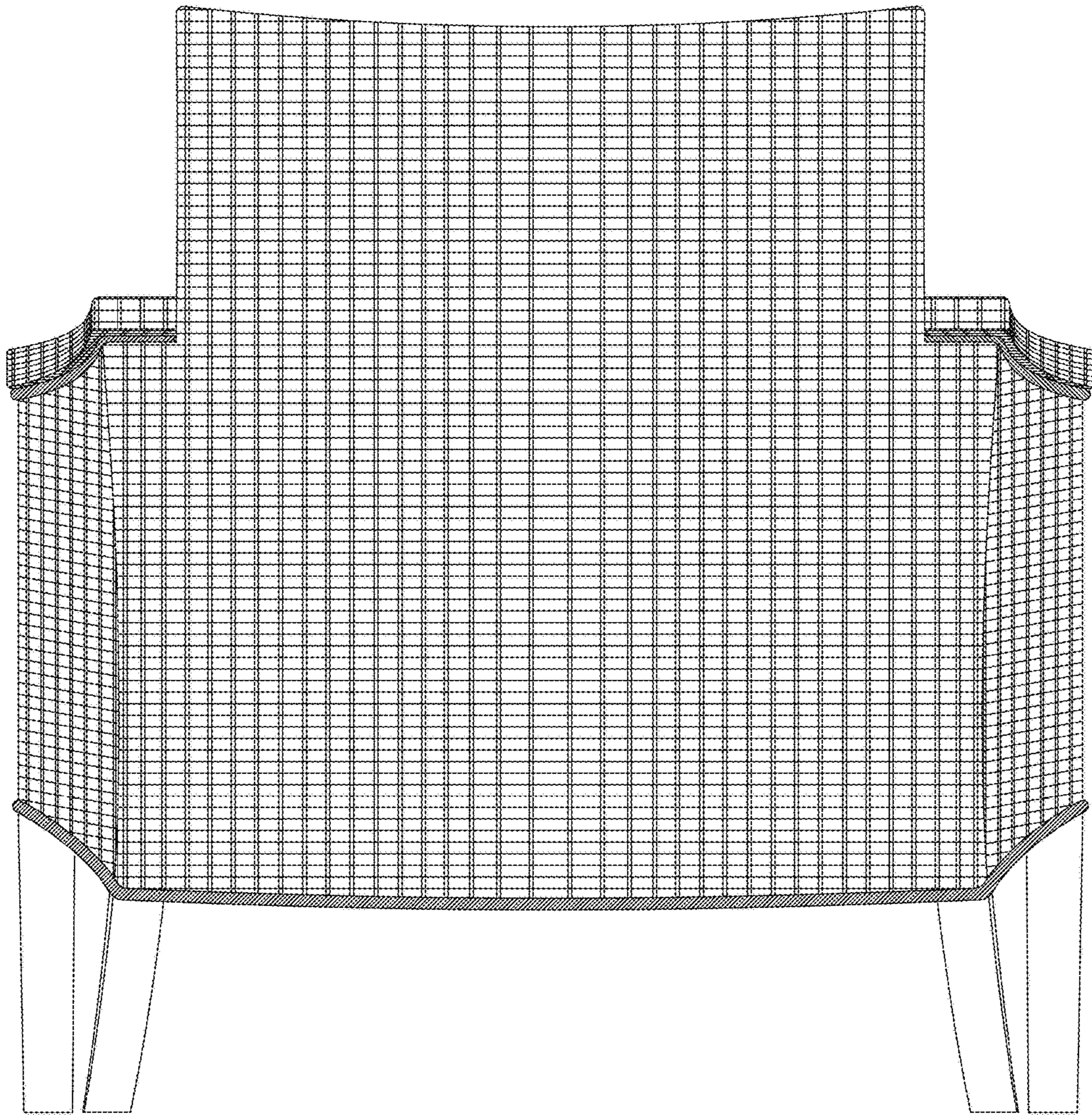
