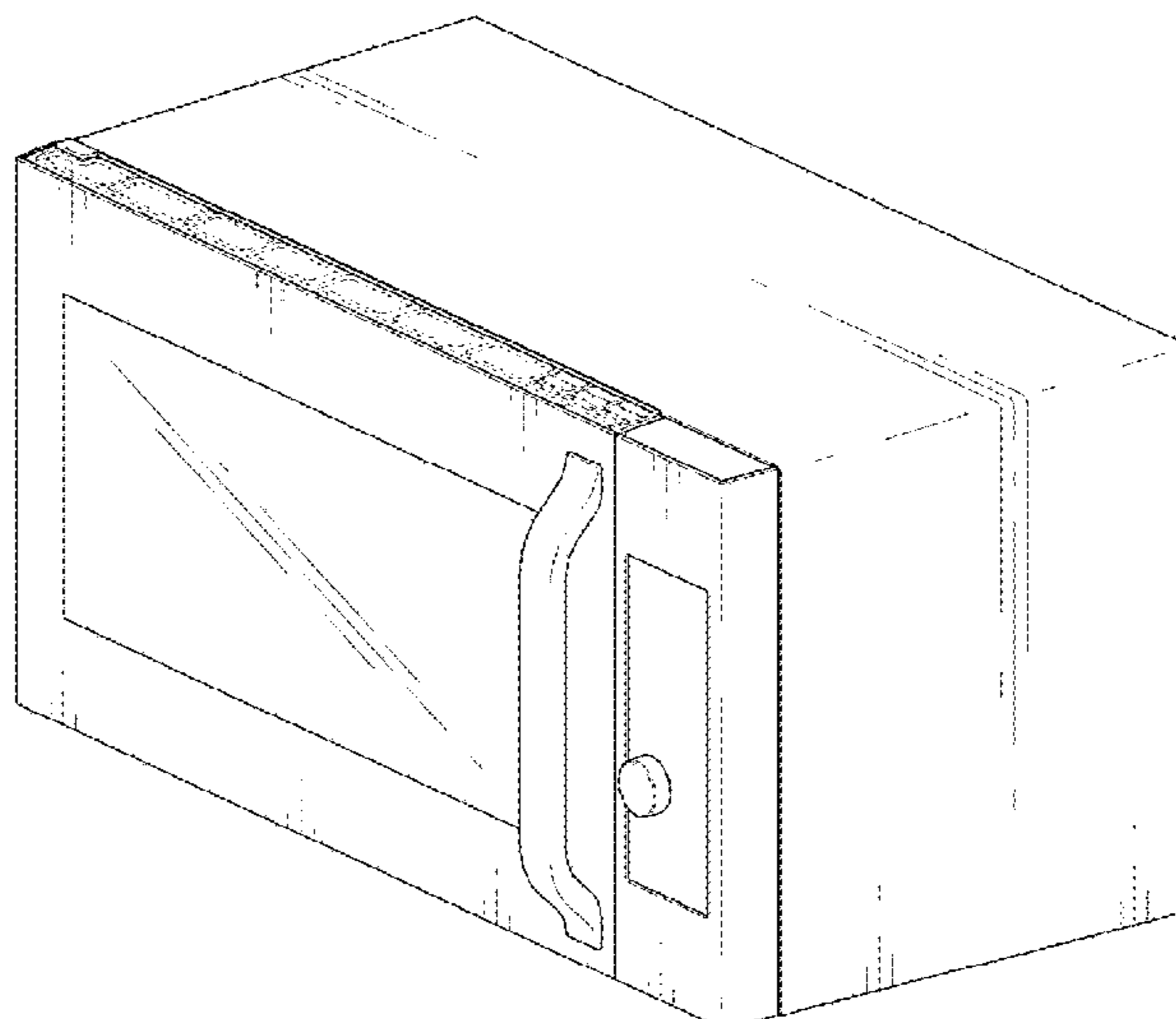
The ornamental design for an oven range, as shown and described.

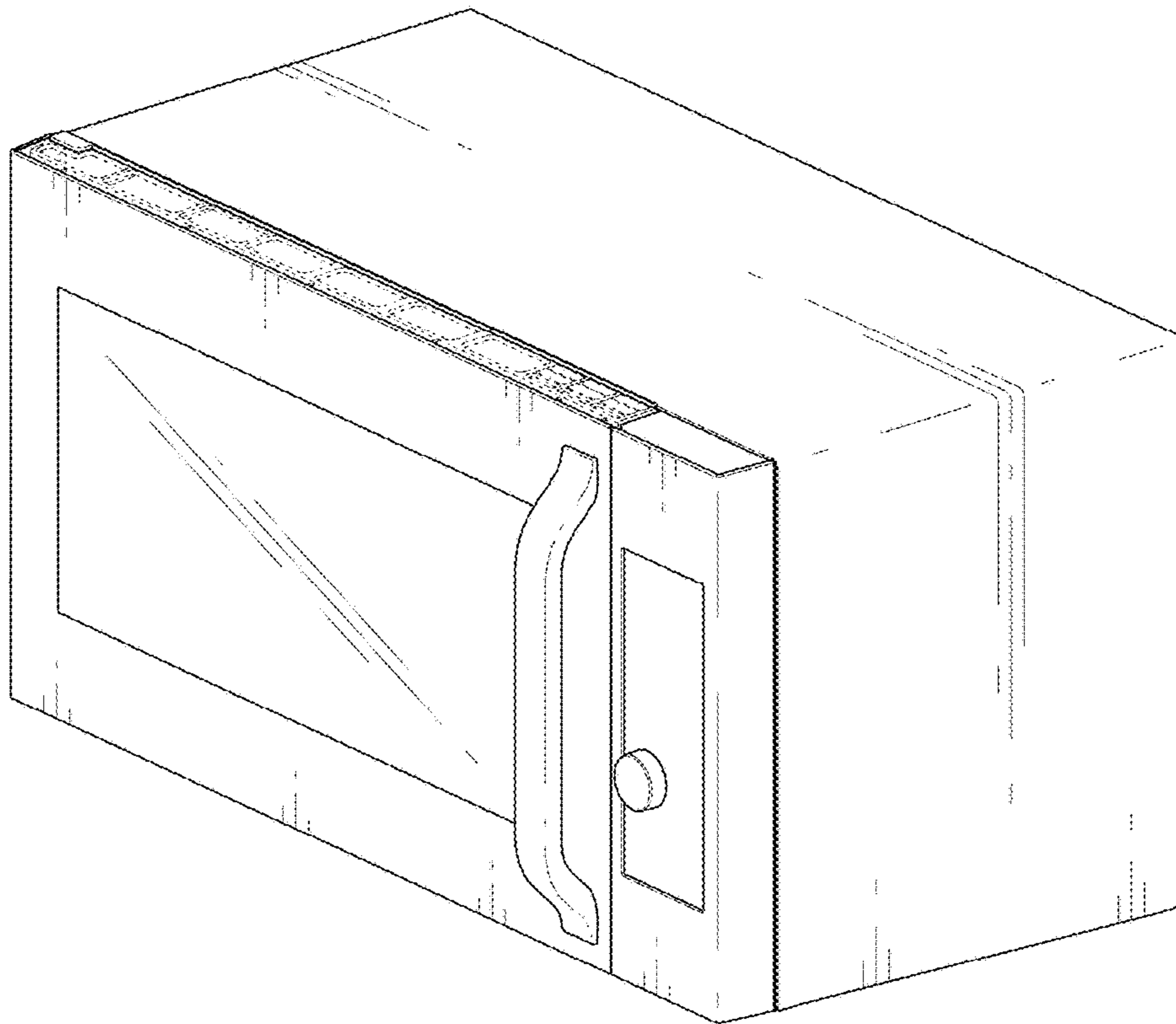

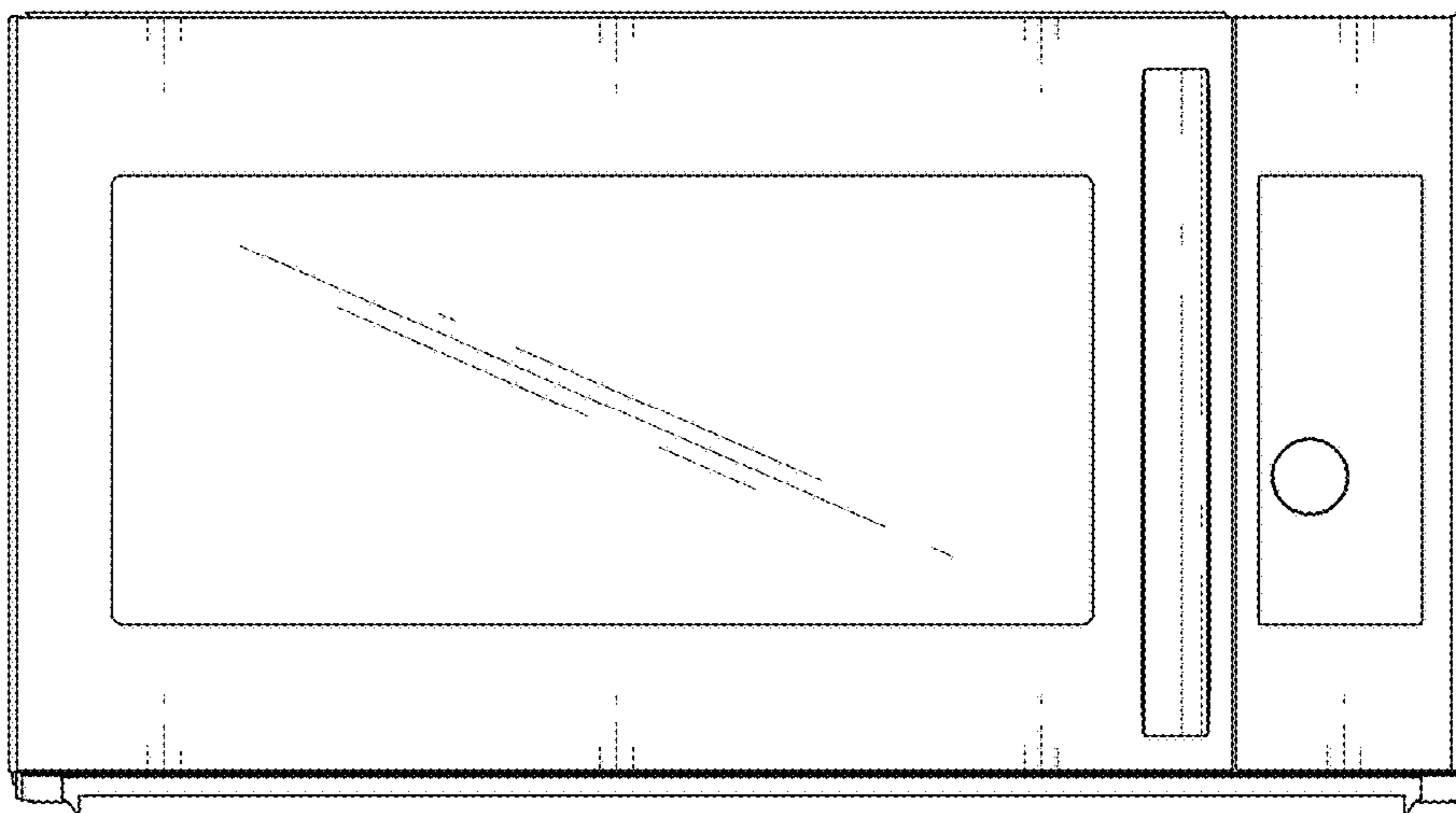

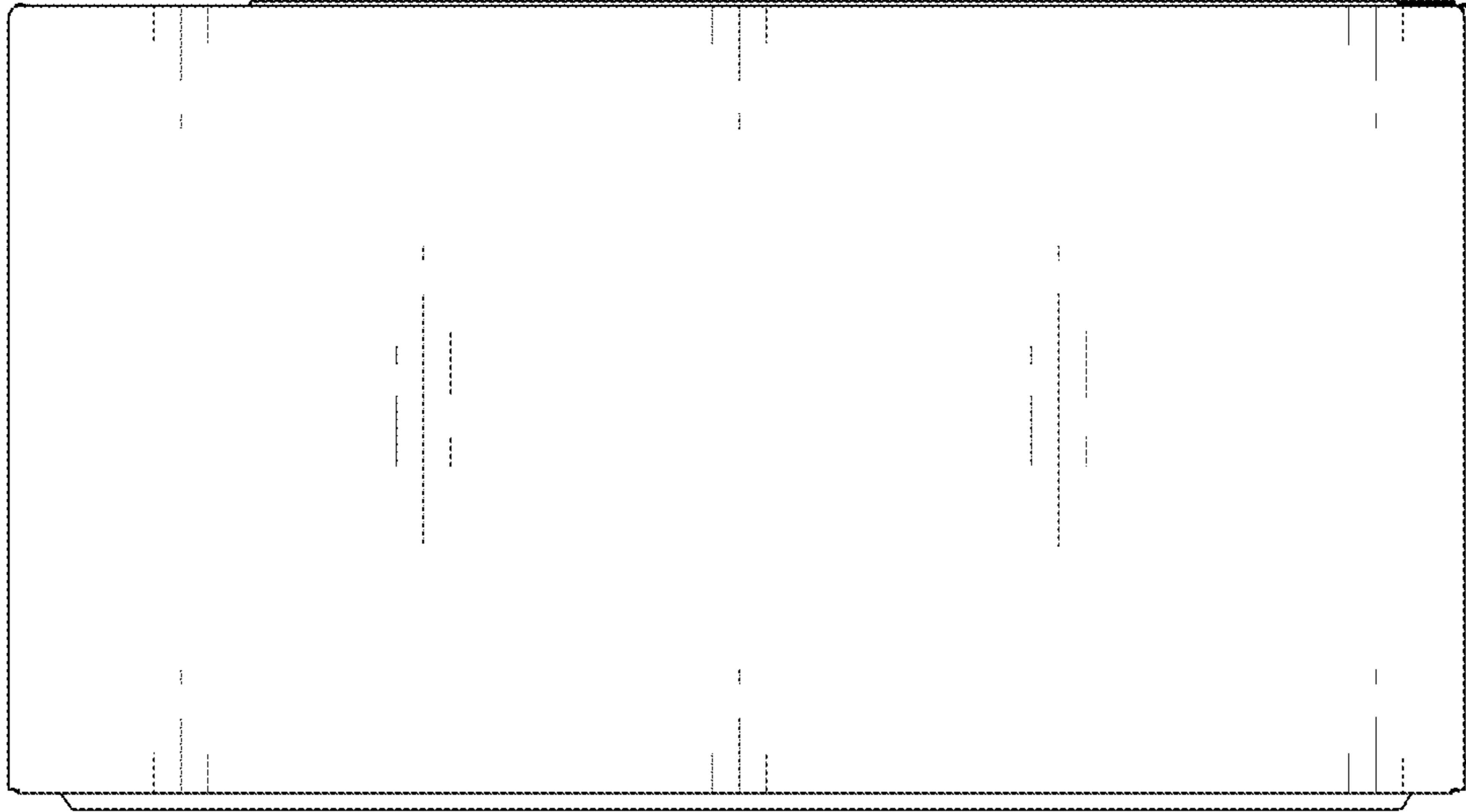

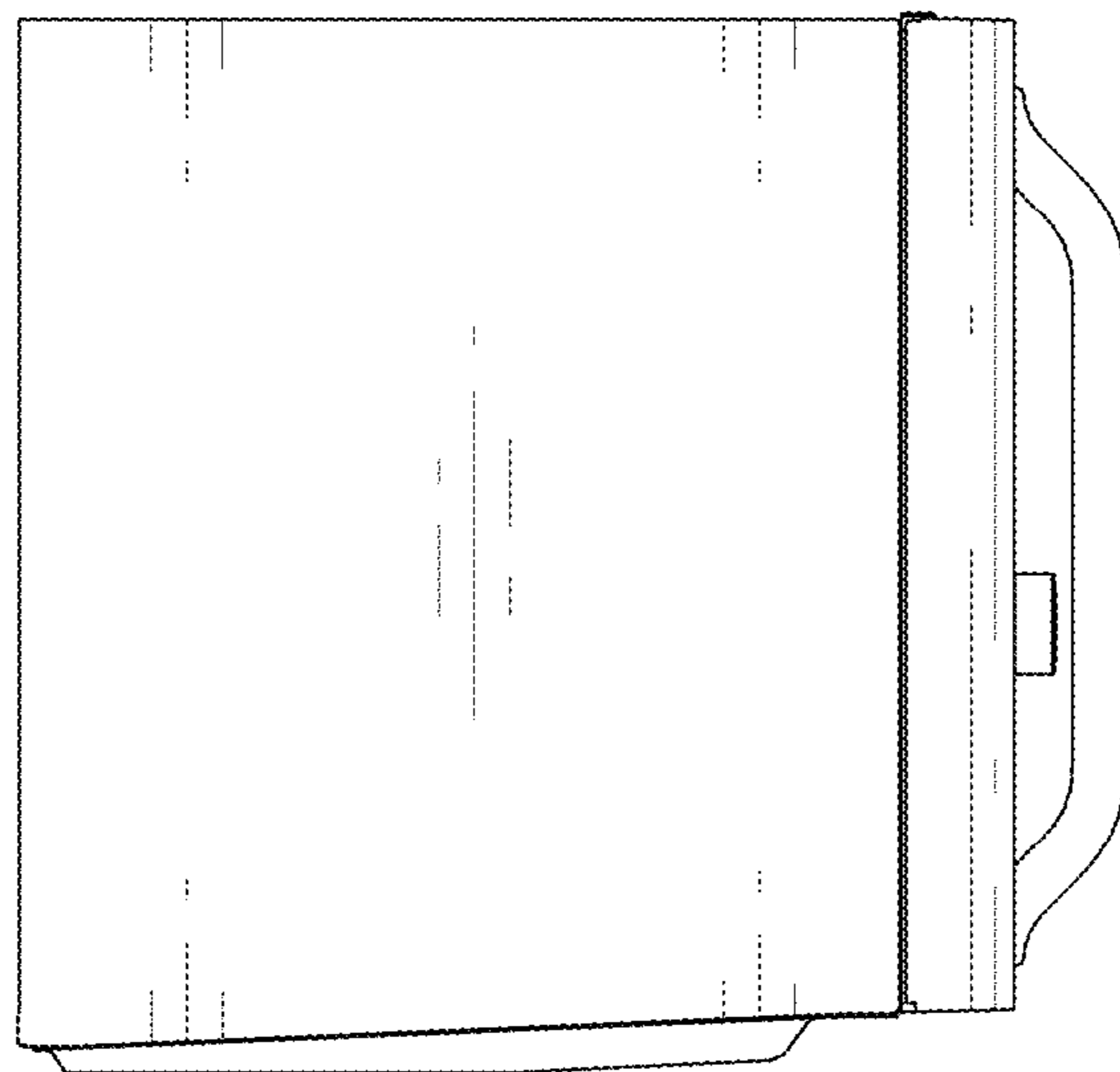

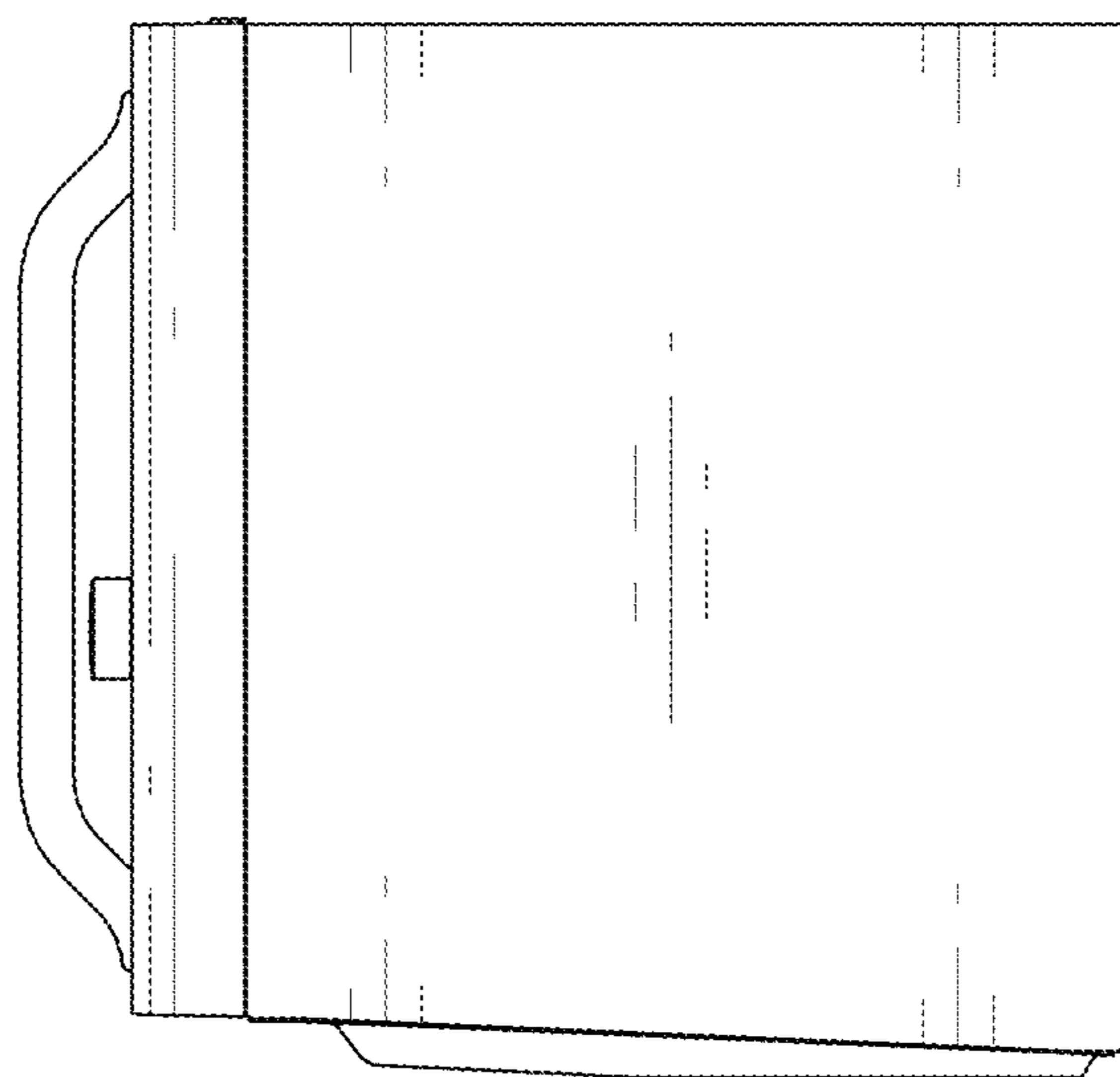

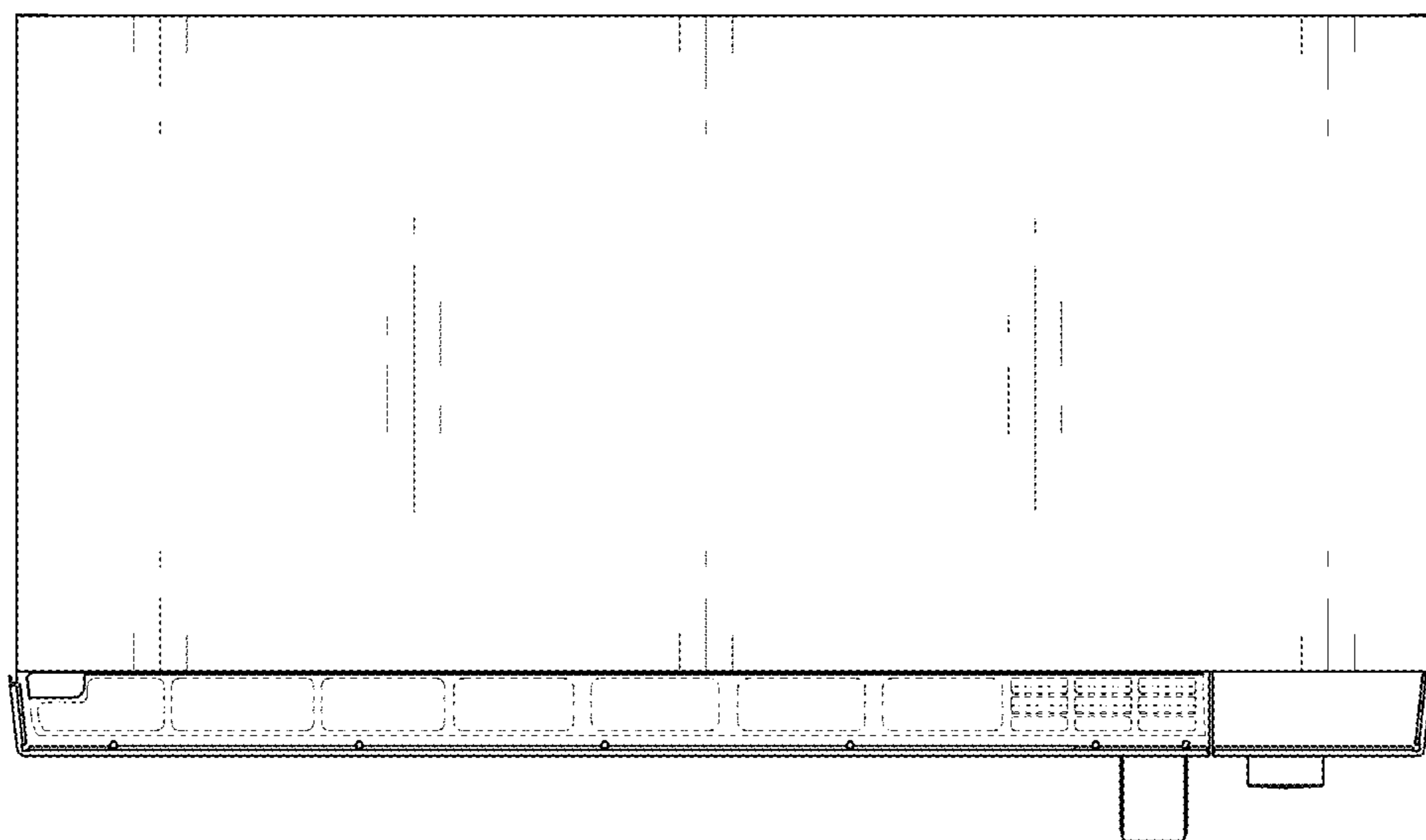
