(57) **CLAIM**

The ornamental wicker design for a container with scallops and wicker appearance, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a container with scallops and wicker appearance;

FIG. 2 is a top plan view of our container with scallops and wicker appearance;

FIG. 3 is a front elevational view of our container with scallops and wicker appearance;

FIG. 4 is a right side elevational view of our container with scallops and wicker appearance, the left side elevational view being a mirror image thereof;

FIG. 5 is a bottom plan view of our container with scallops and wicker appearance;

FIG. 6 is a cross-sectional side elevation view of our container with scallops and wicker appearance taken in the direction of cutting plane 6-6 of FIG. 2.

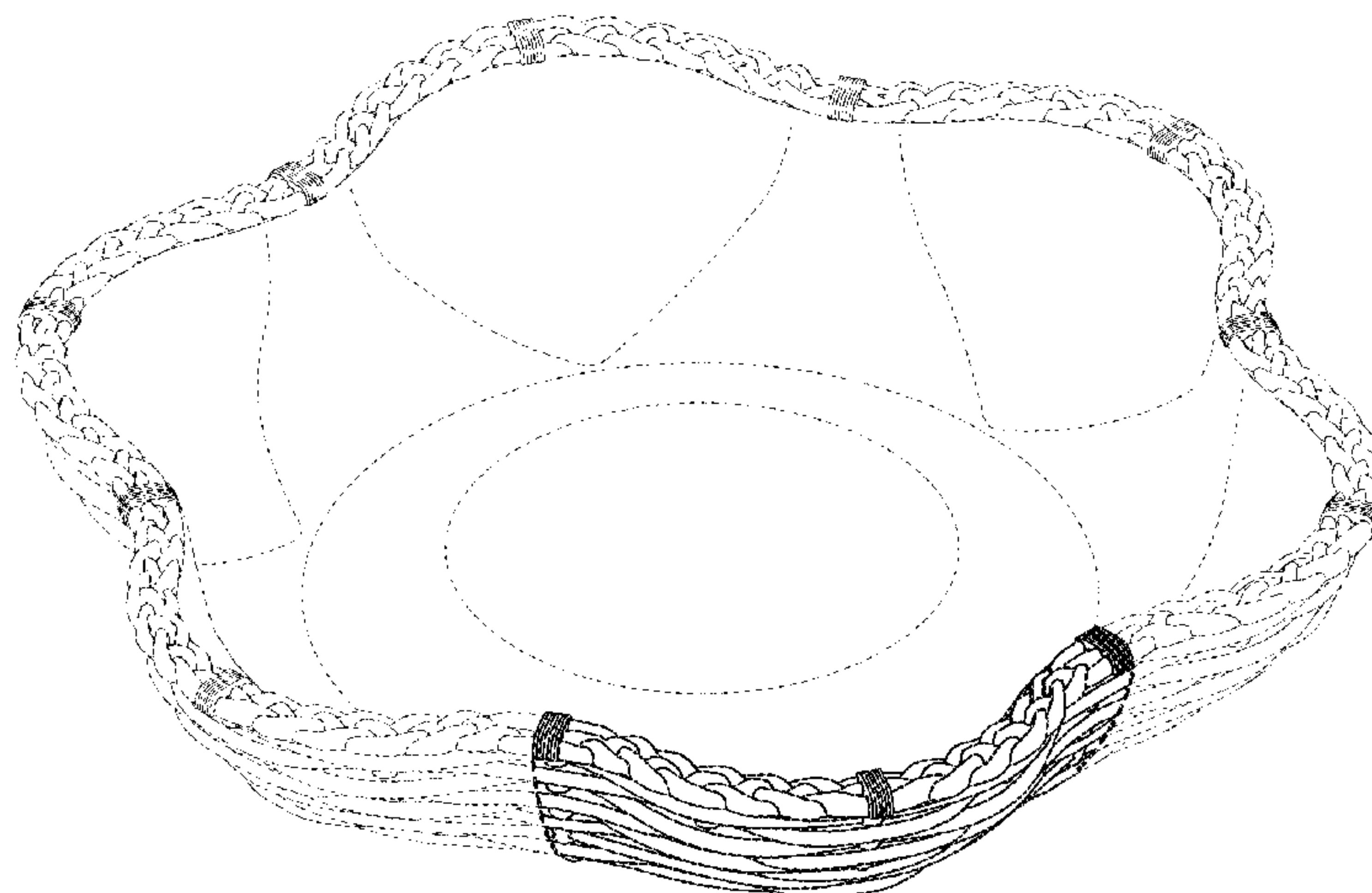
FIG. 7 is a cross-sectional side elevational view of our container with scallops and wicker appearance taken in the direction of cutting plane 7-7 of FIG. 2.

FIG. 8 is a cross-sectional side elevation view of our container with scallops and wicker appearance taken in the direction of cutting plane 8-8 of FIG. 2; and,

FIG. 9 is a rear cross-sectional view of our container with scallops and wicker appearance taken in the direction of cutting plane 9-9 of FIG. 2.

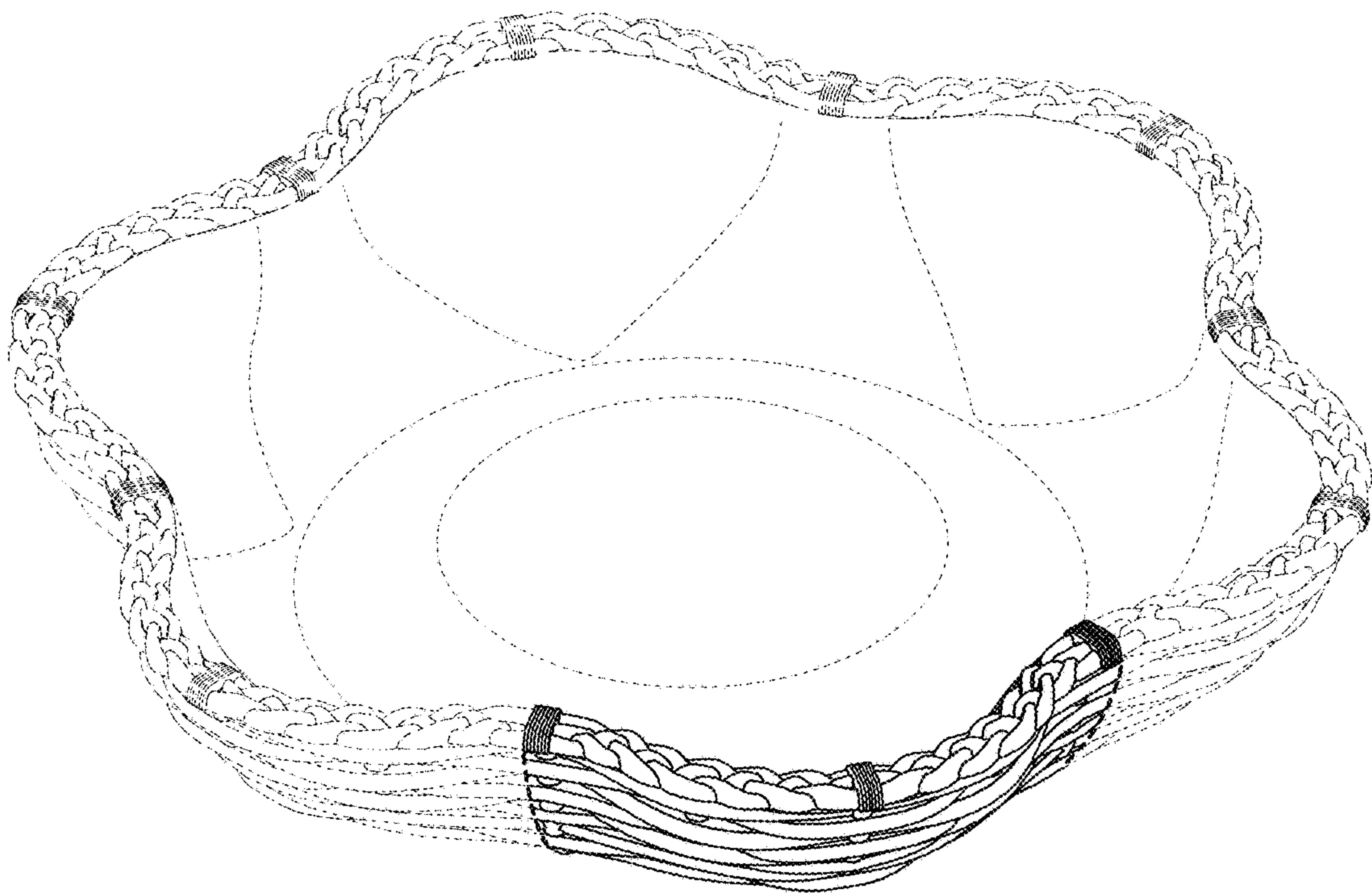

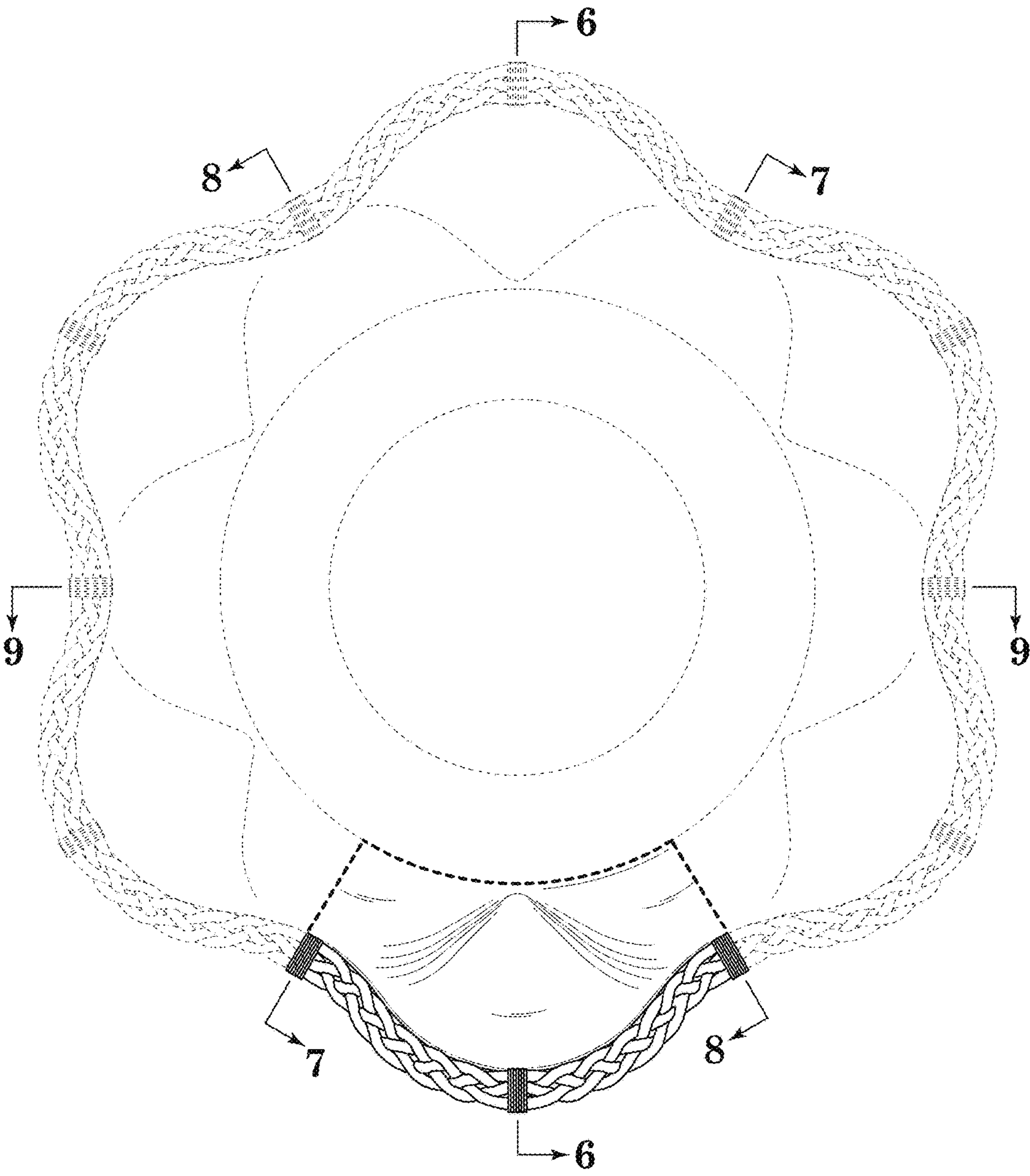

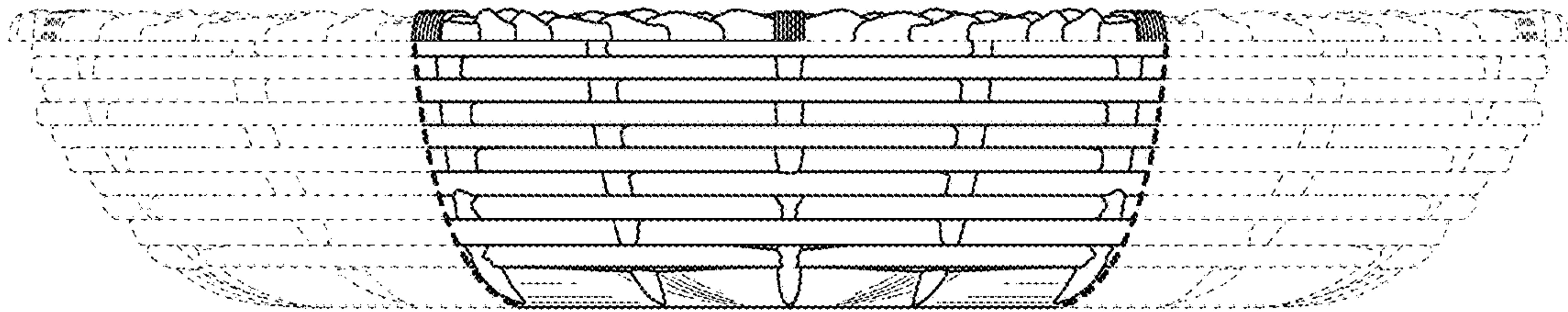

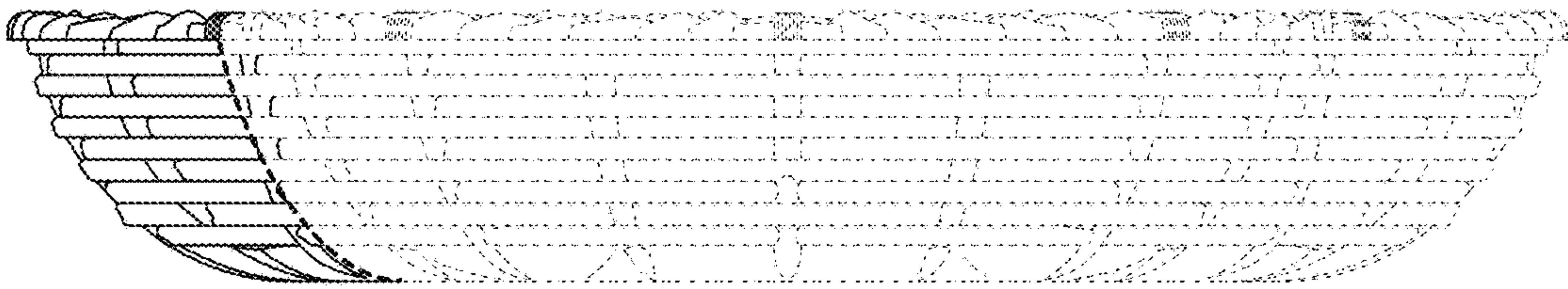

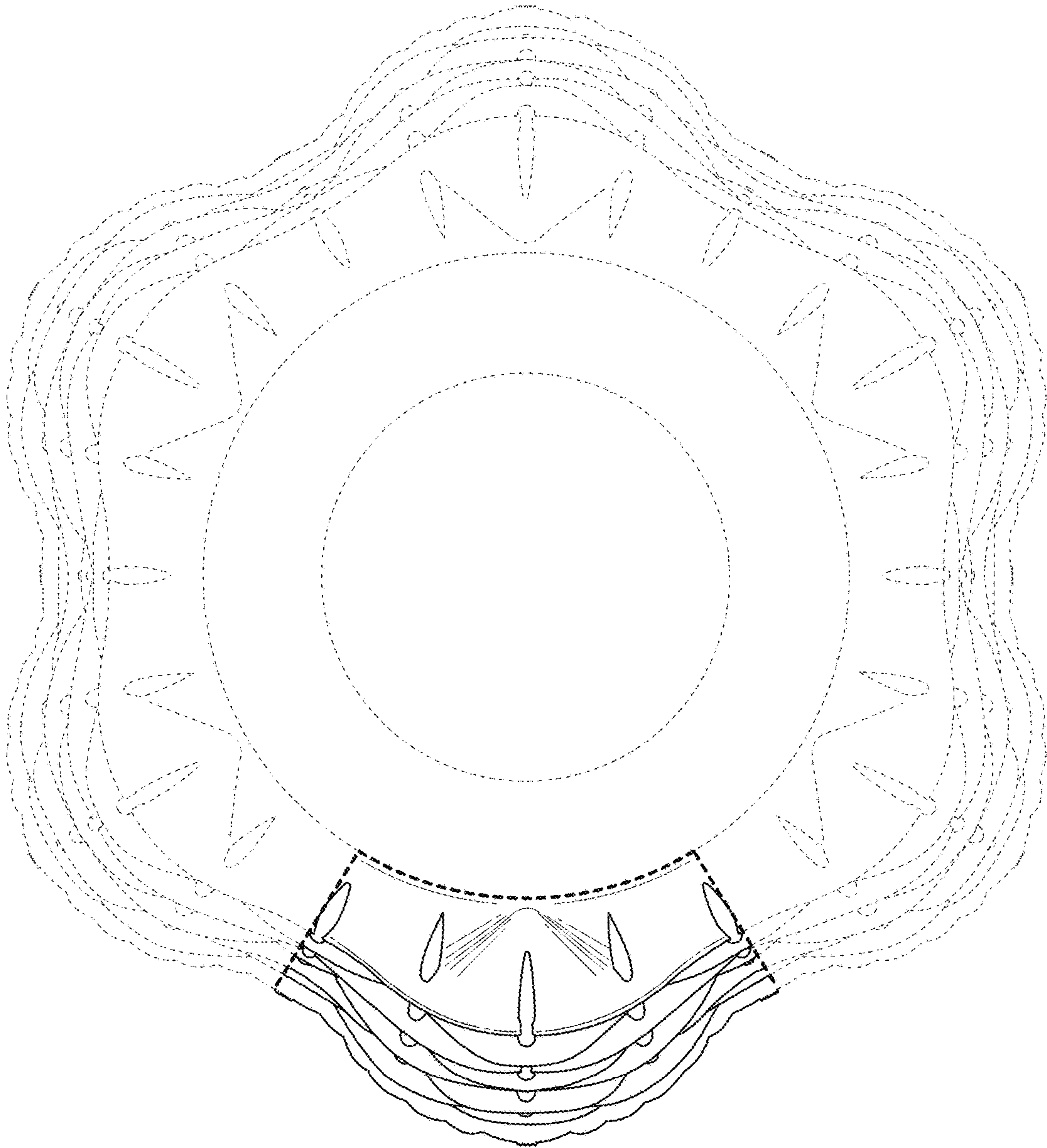

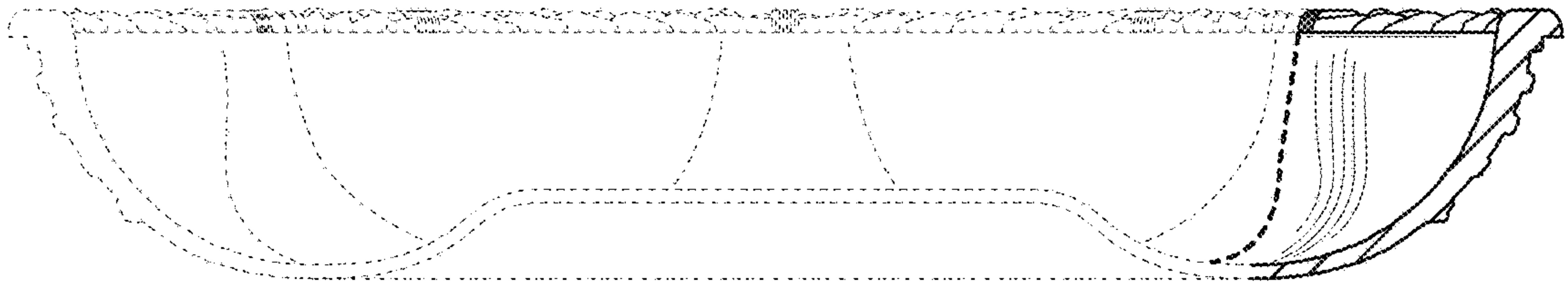

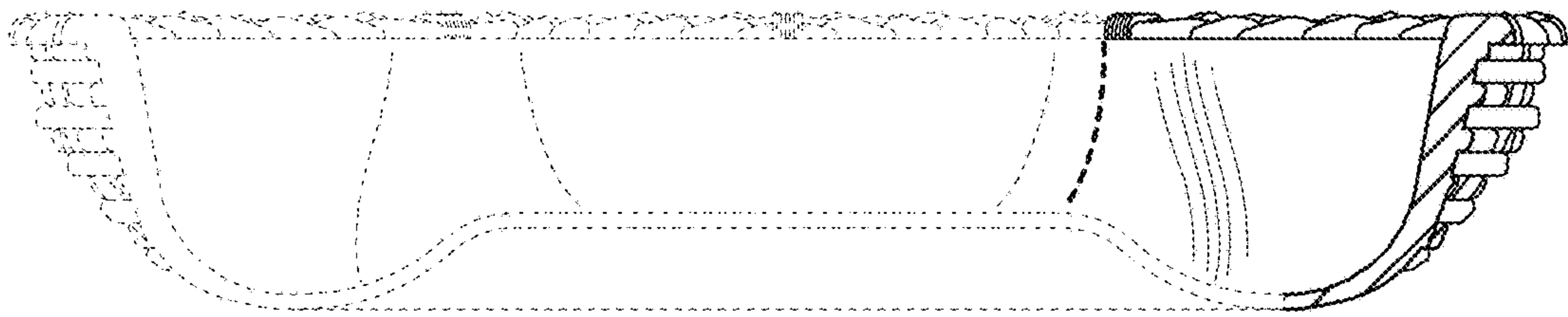

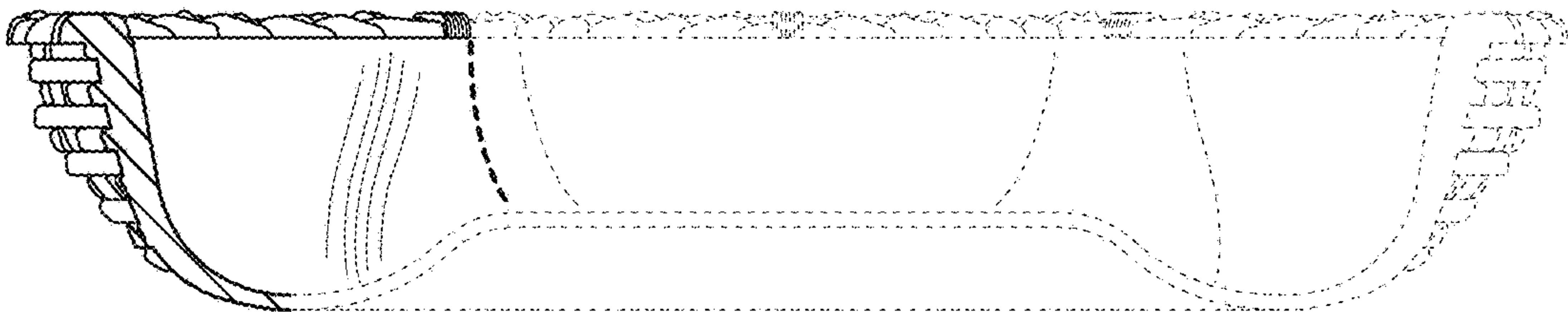

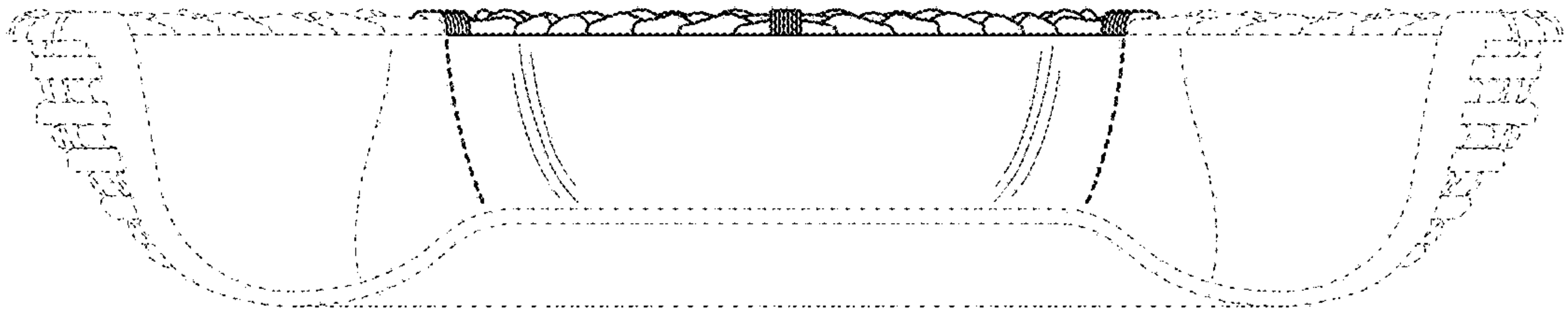
