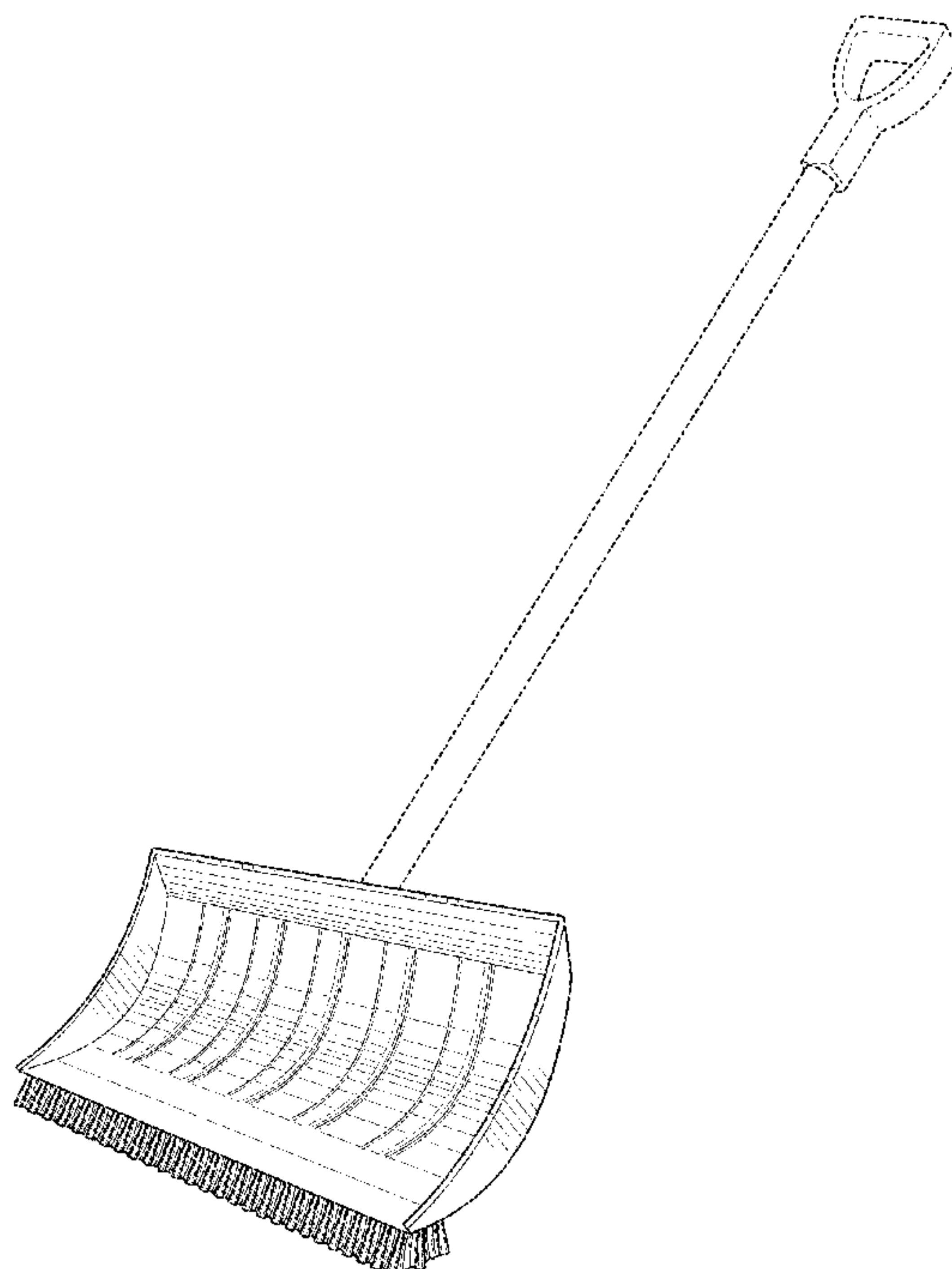
(57) **CLAIM**

The ornamental design for a combination shovel and broom,  
as shown and described.

**DESCRIPTION**

FIG. 1 shows a perspective view of a combination shovel and broom showing our new design;  
FIG. 2 shows a front view thereof;  
FIG. 3 shows a rear view thereof;  
FIG. 4 shows a left side view thereof;  
FIG. 5 shows a right side view thereof;  
FIG. 6 shows a top plan view thereof; and,  
FIG. 7 shows a bottom plan view thereof.  
The shade lines in the Figures show contour and not surface ornamentation.  
The broken lines shown in the Figures show portions of the combination shovel and broom which form no part of the claimed design.

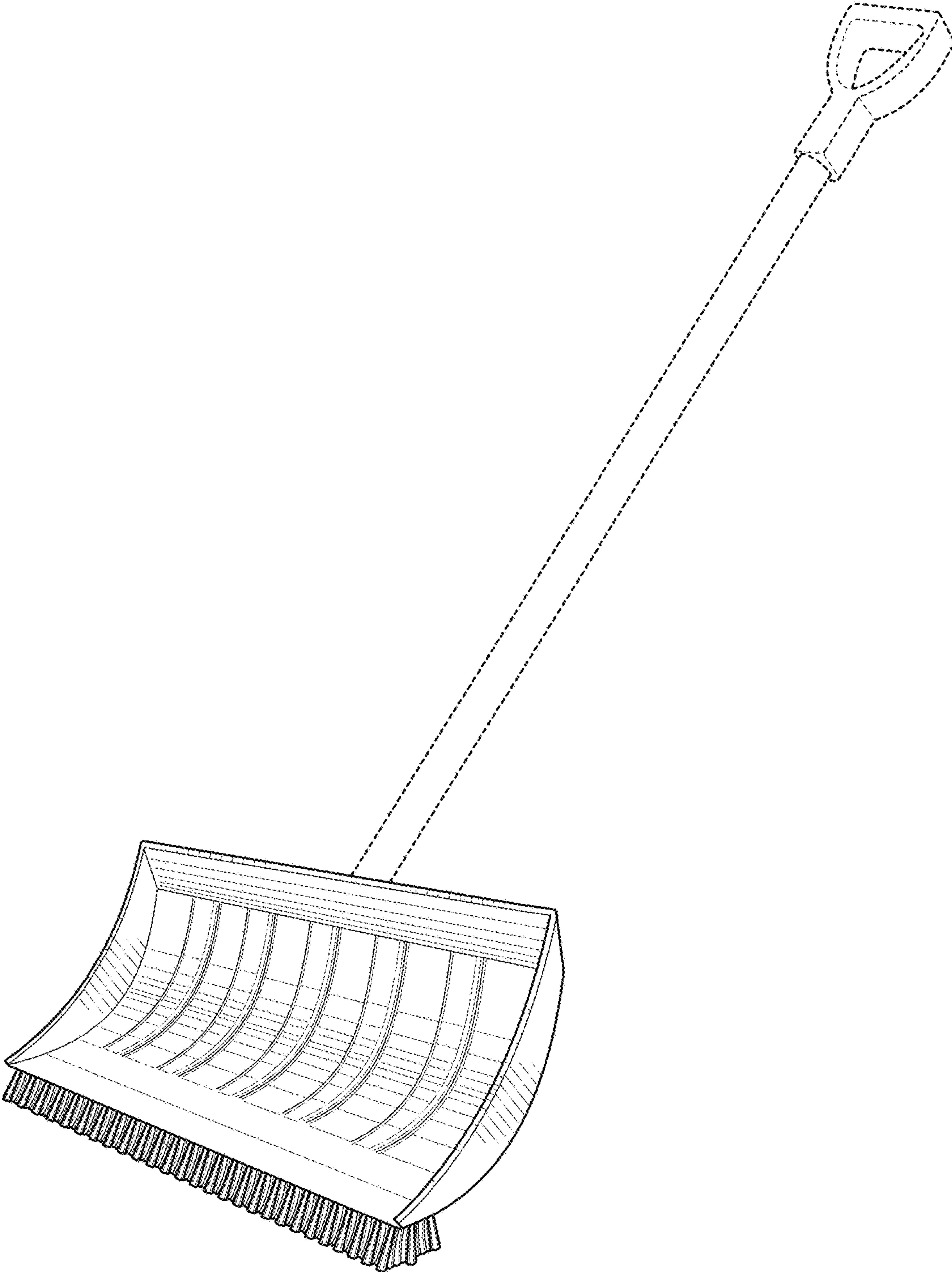

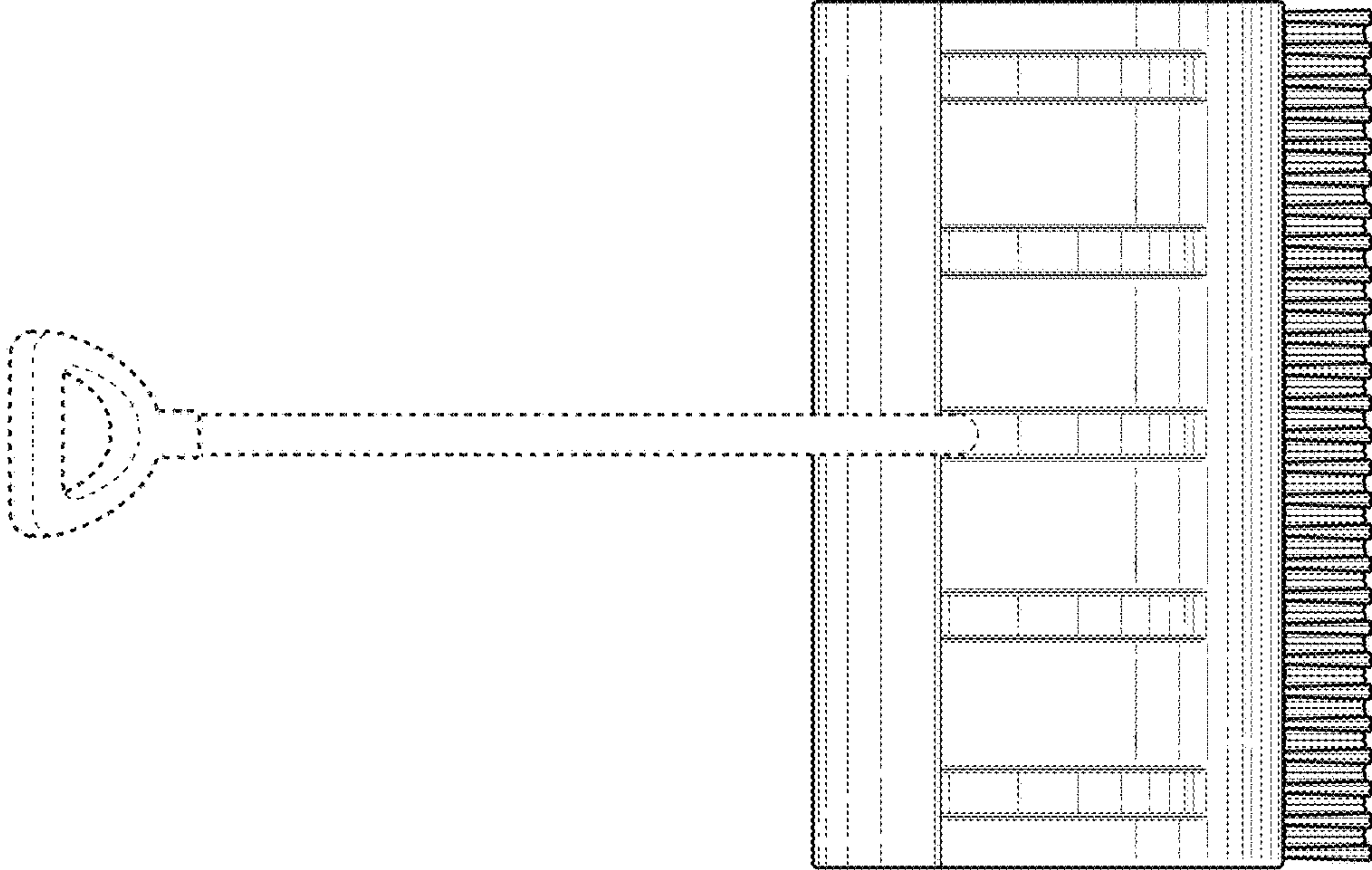

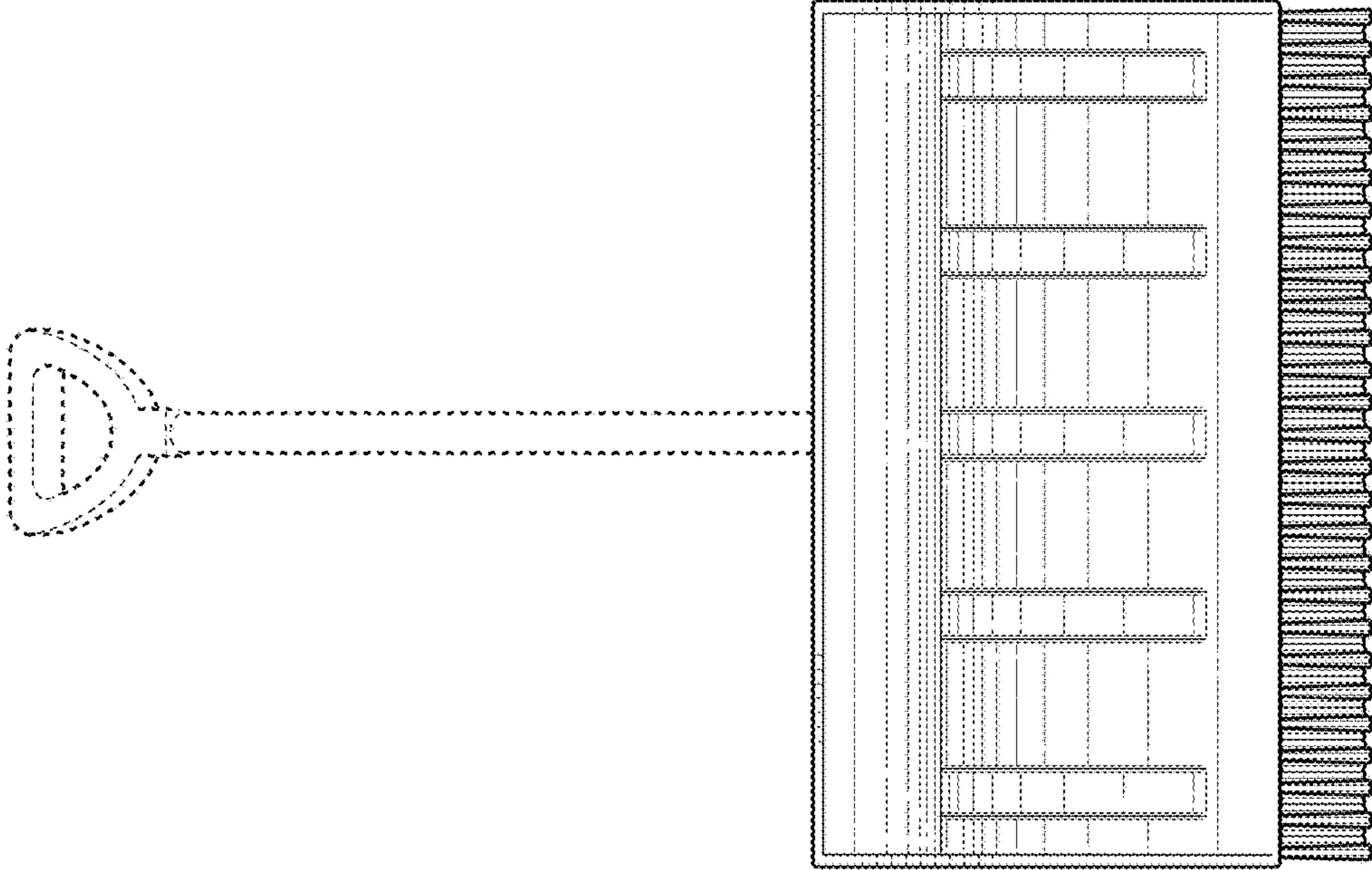

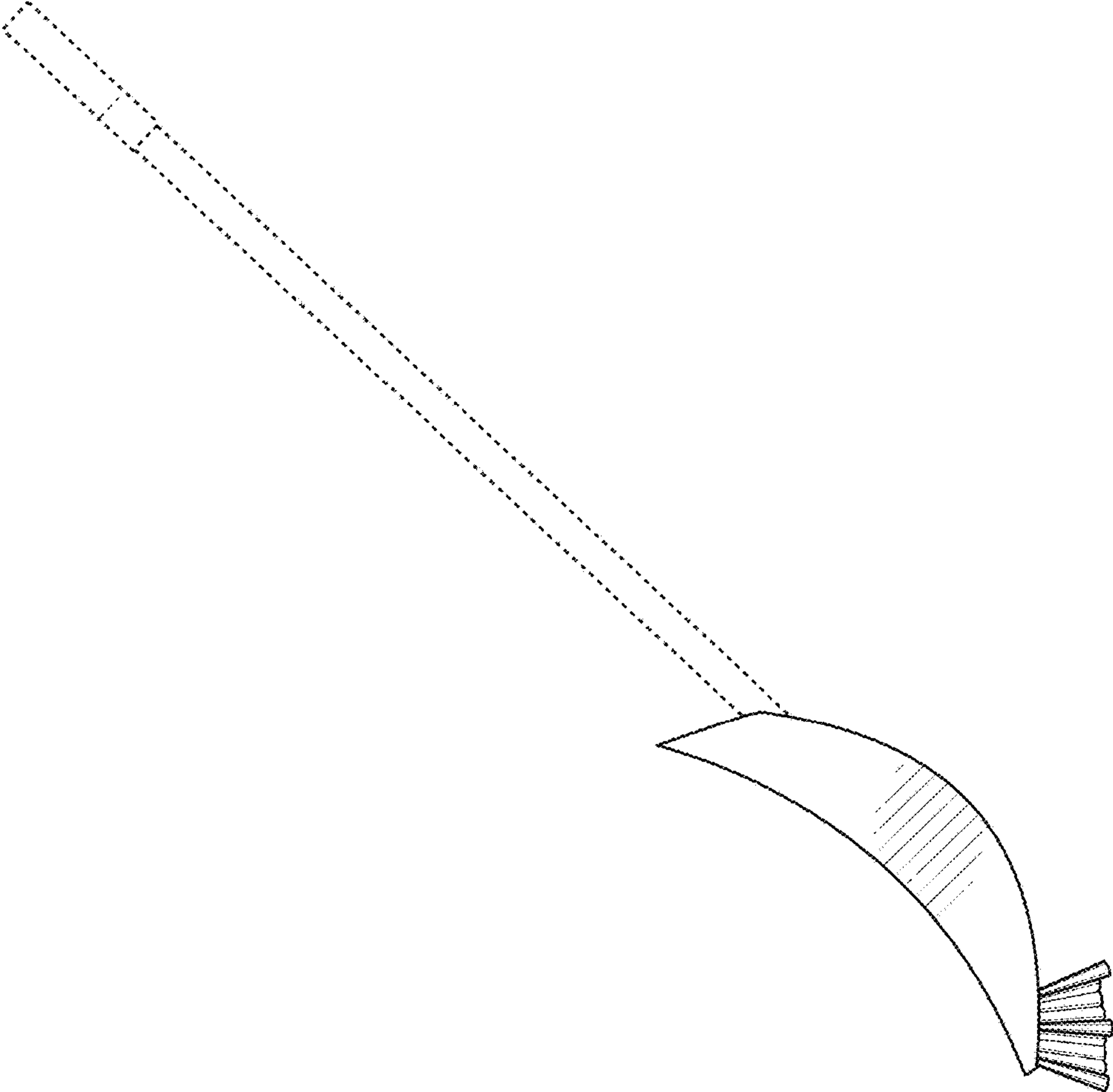

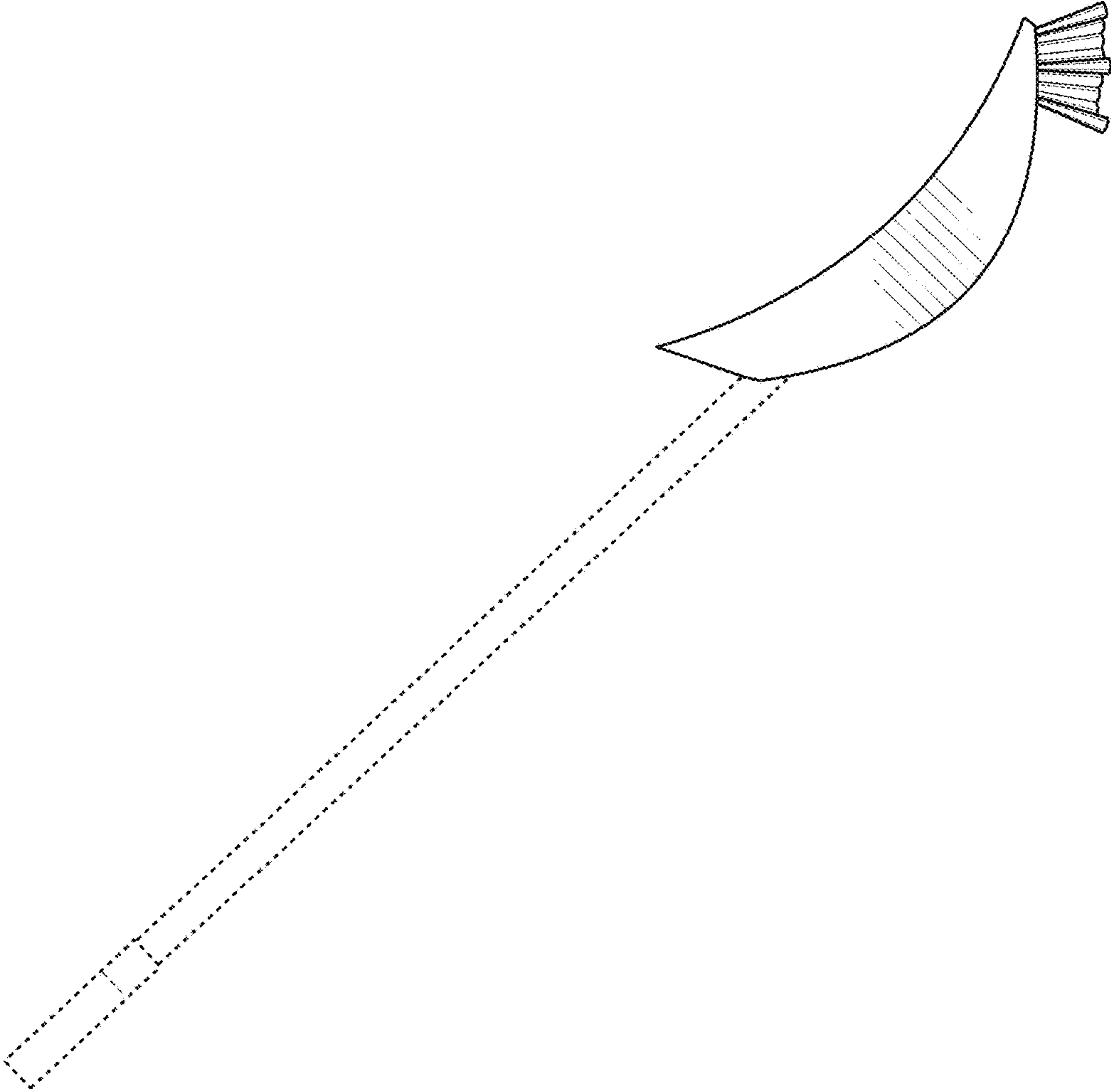

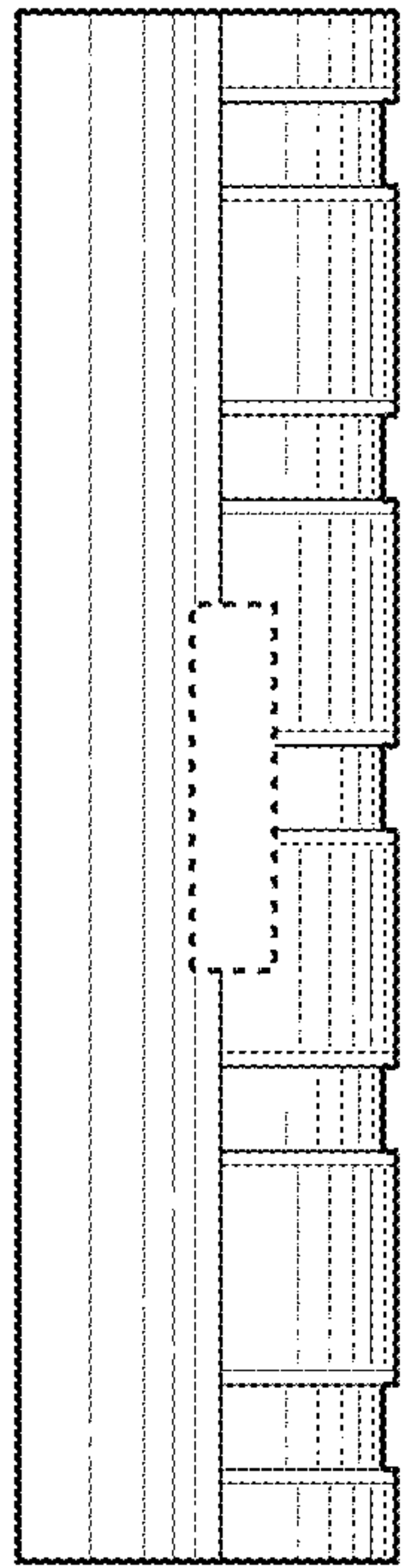

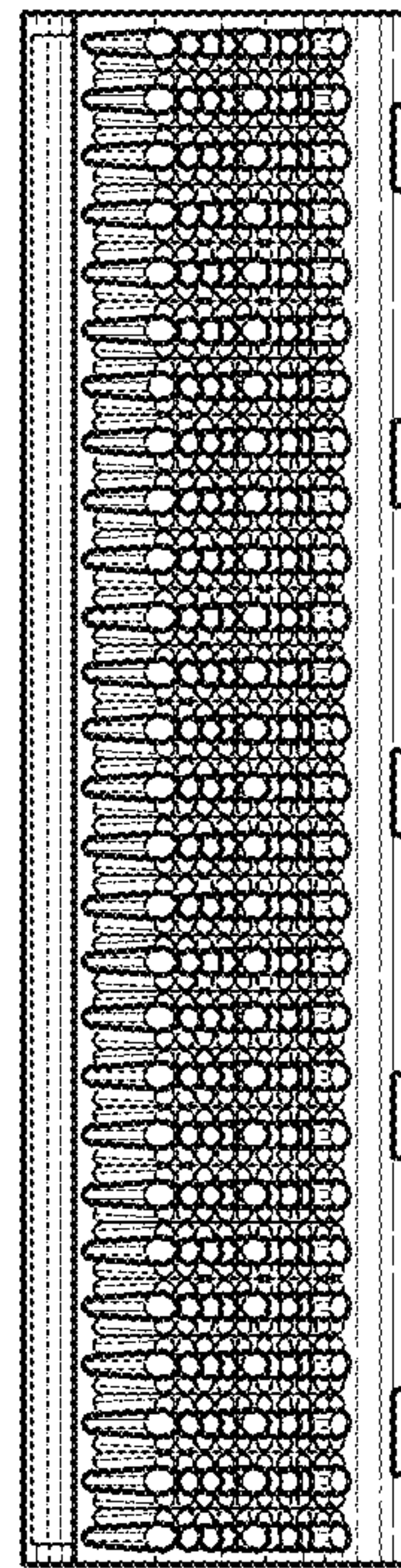
