FIG. 4 is a bottom side view of the pendant of FIG. 1.

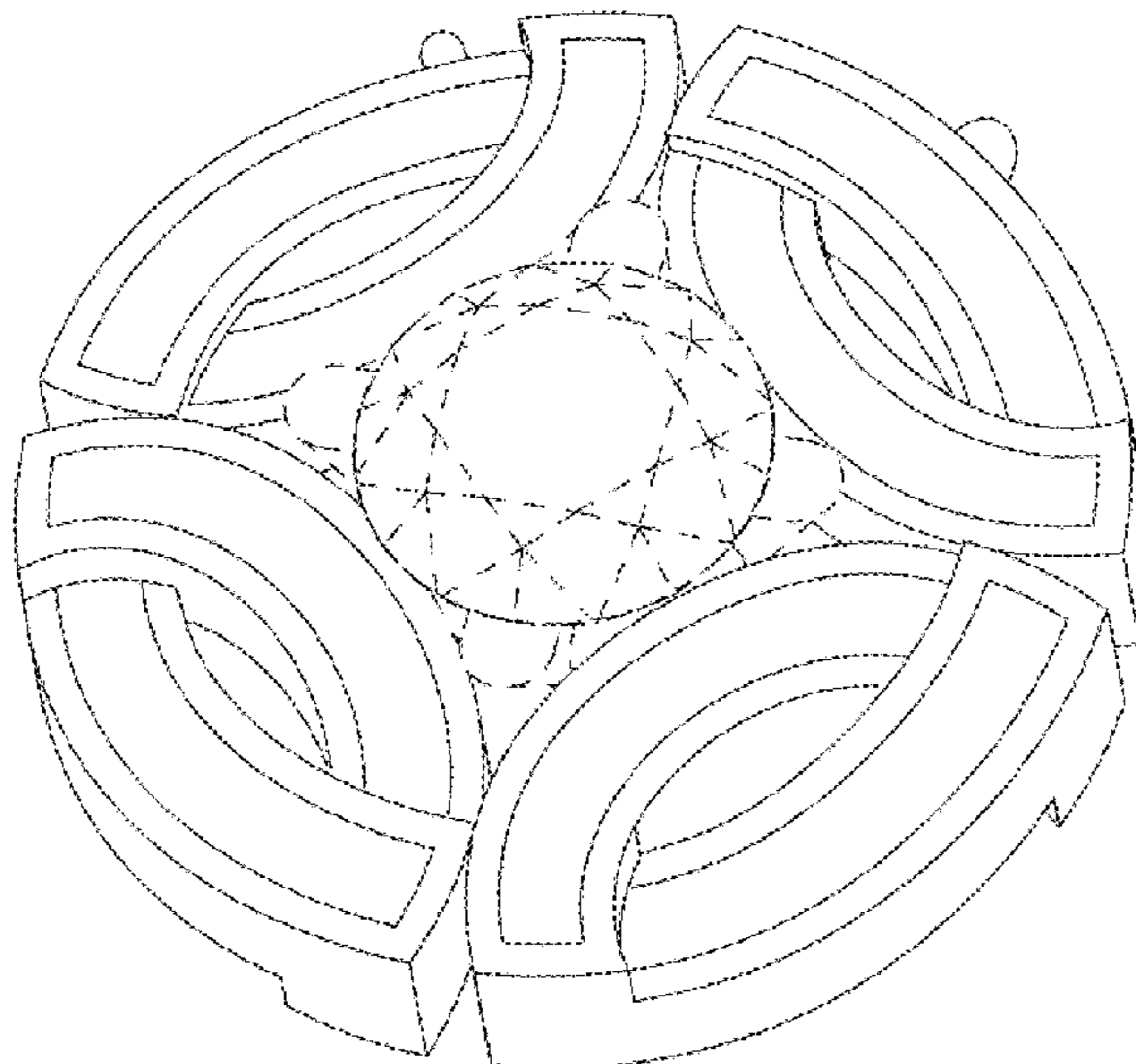
FIG. 5 is a left side view of the pendant of FIG. 1.

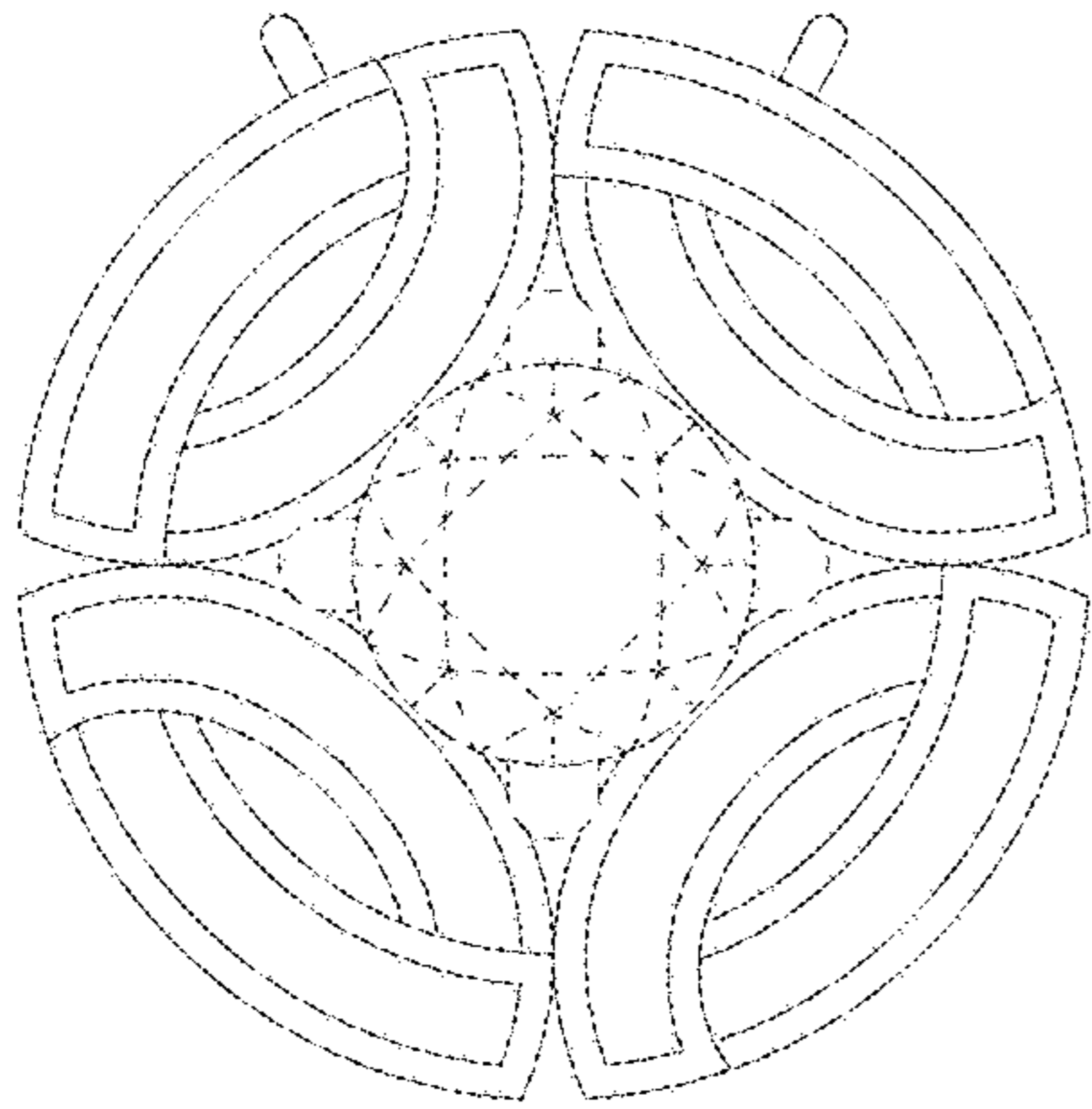

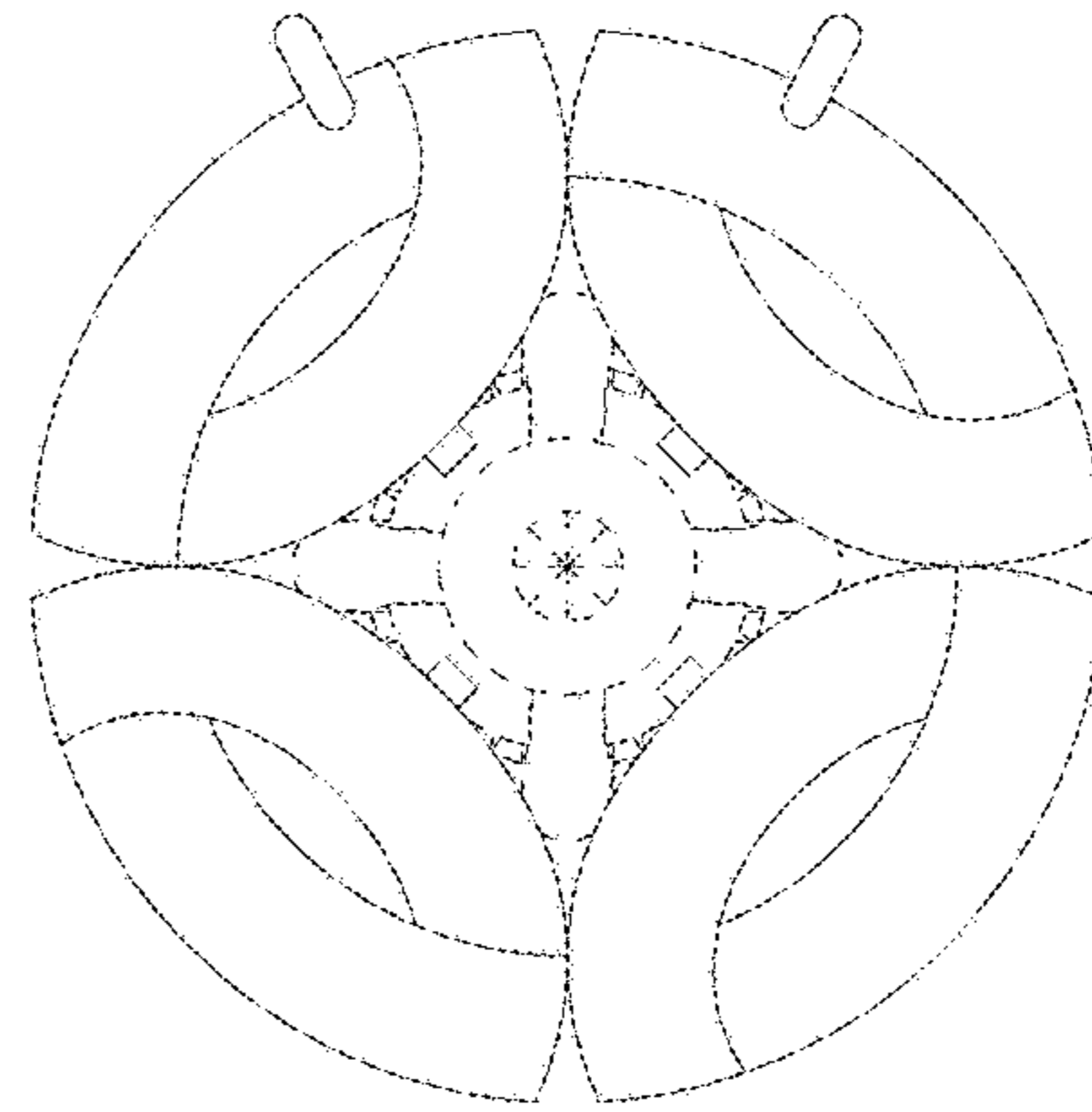

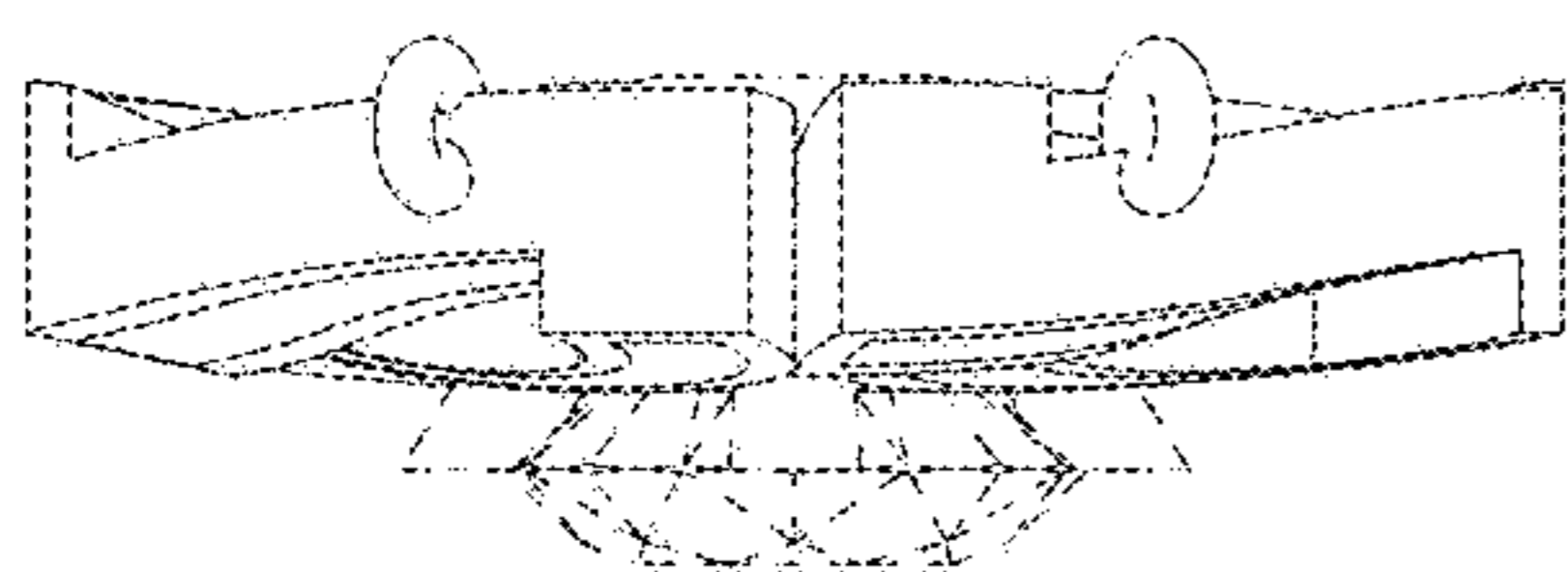

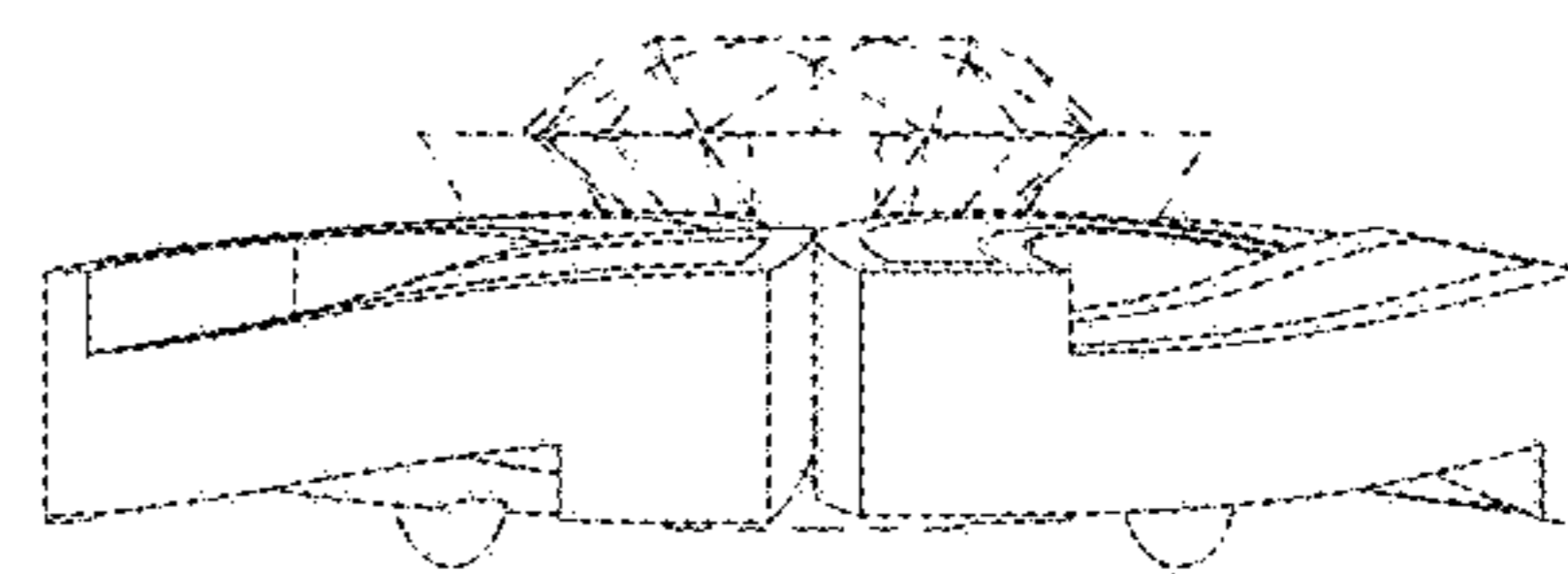

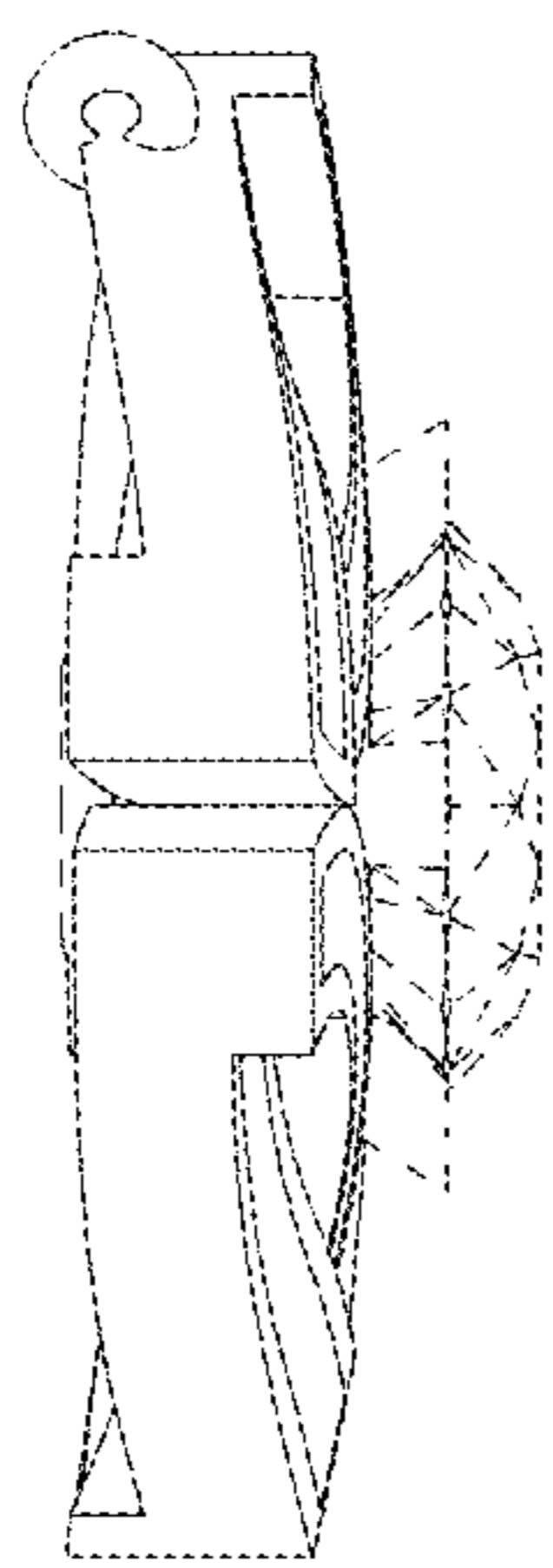

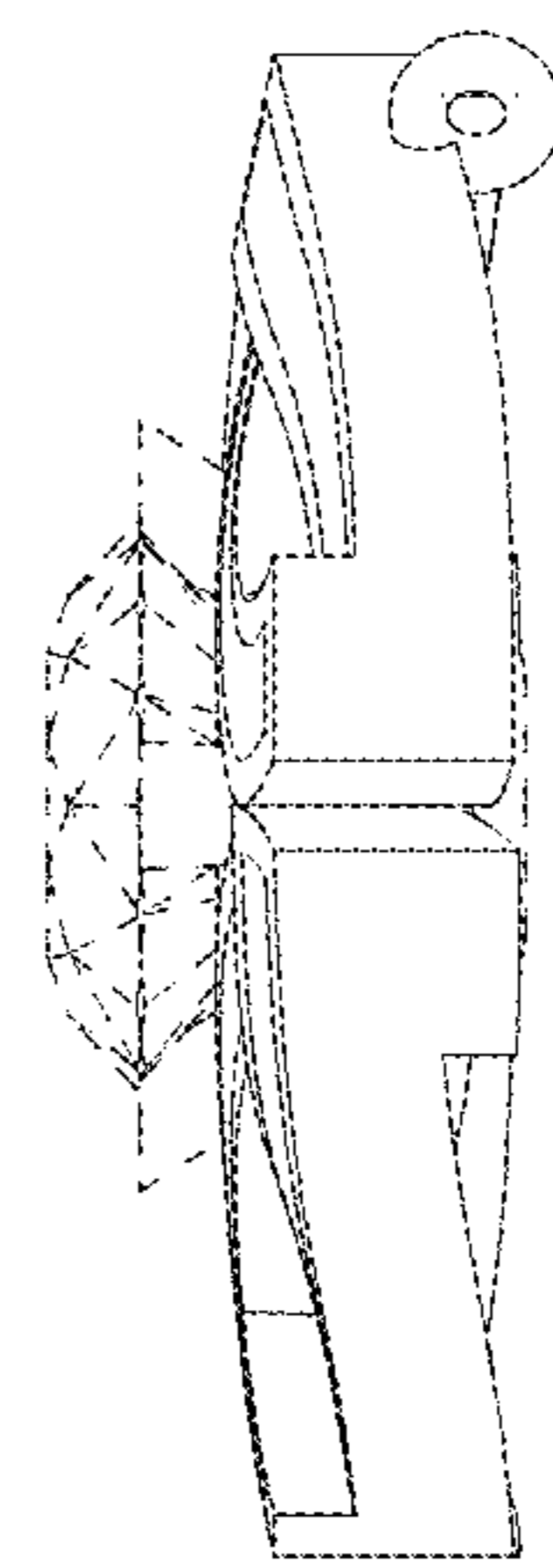

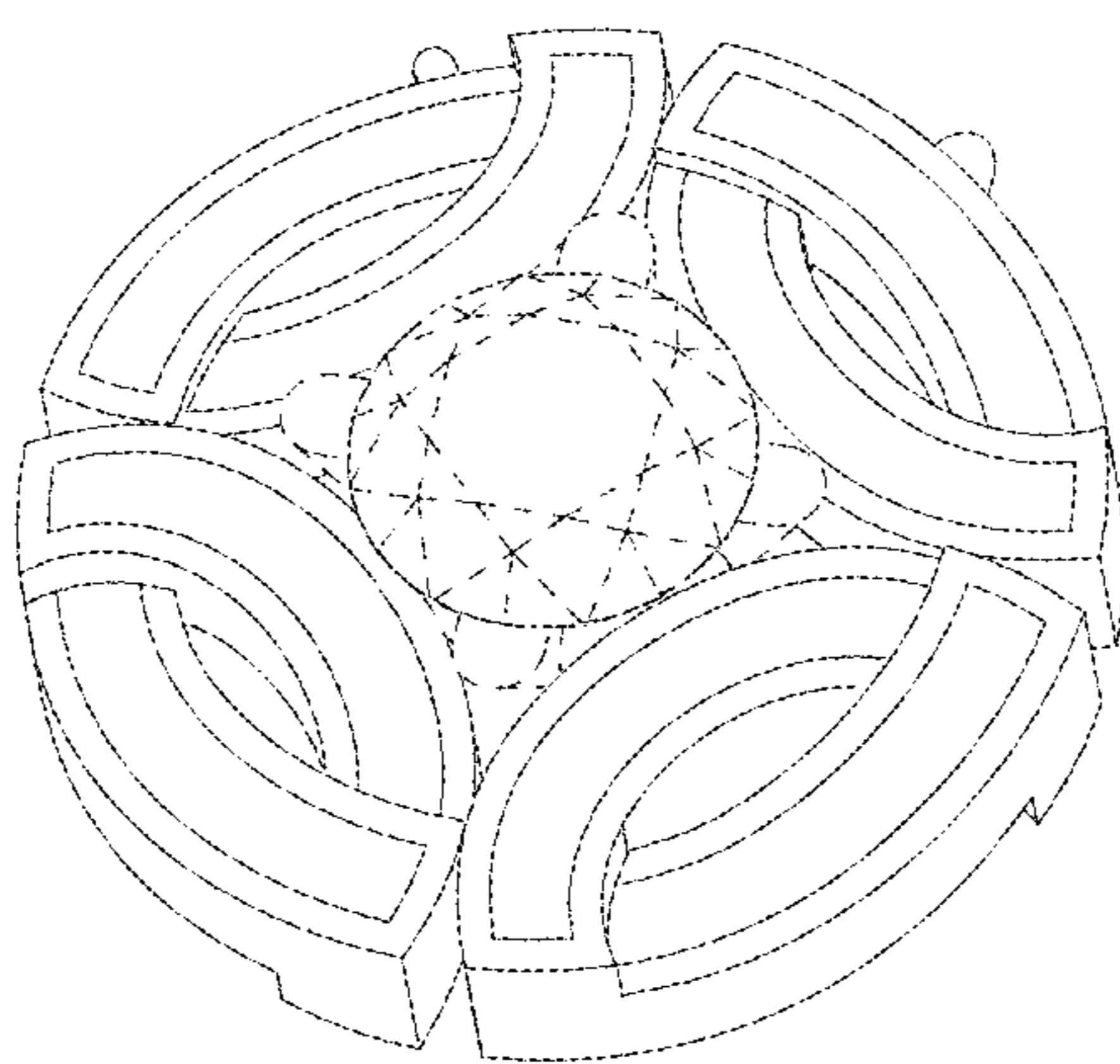
