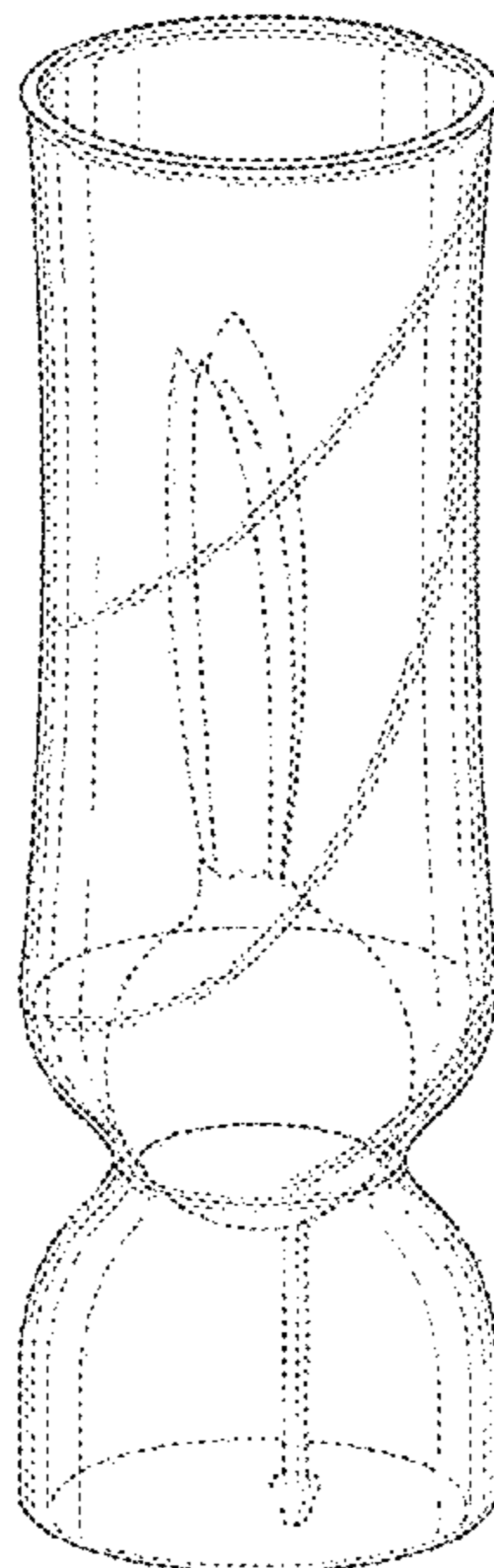
The ornamental design for a flower vase, as shown and described.

DESCRIPTION

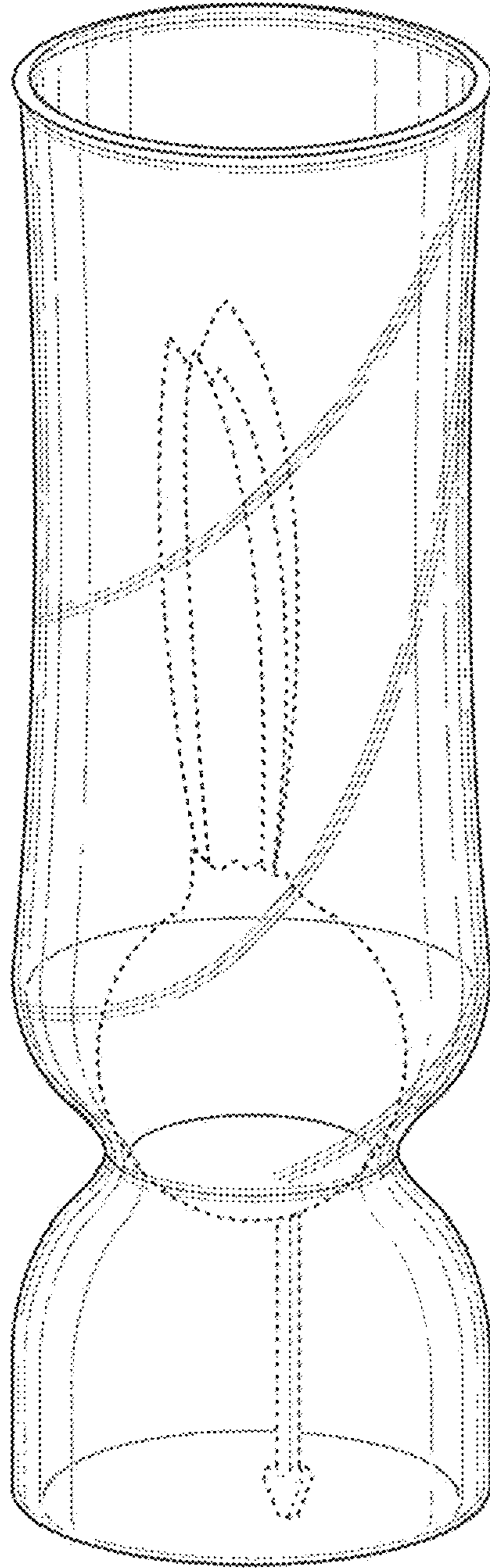

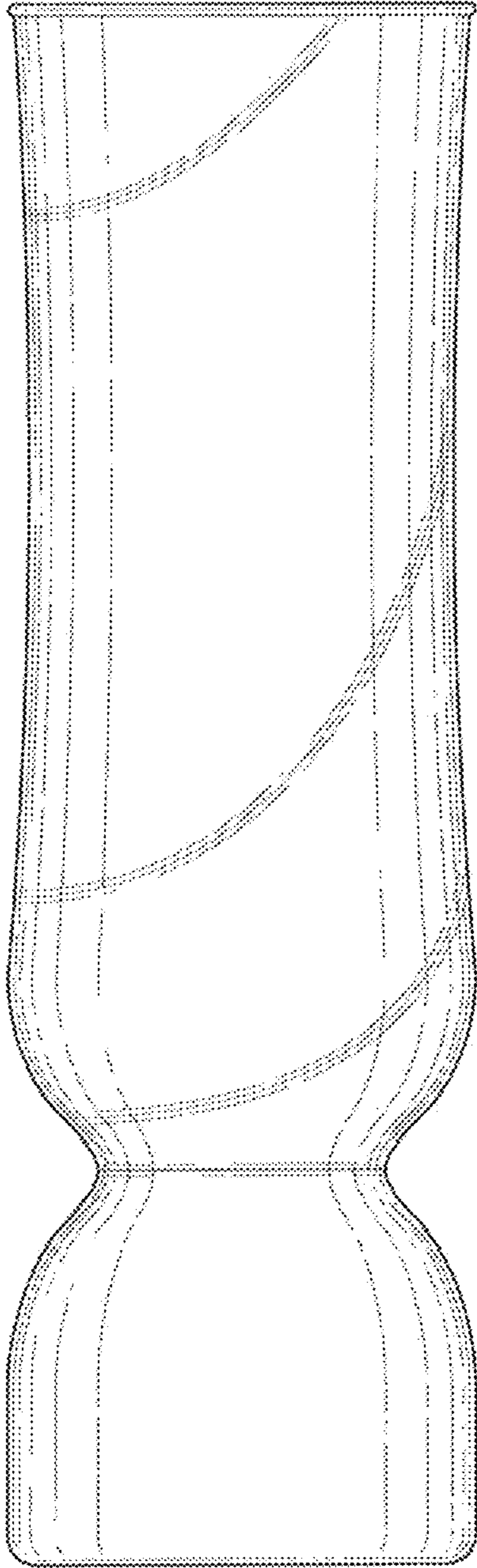

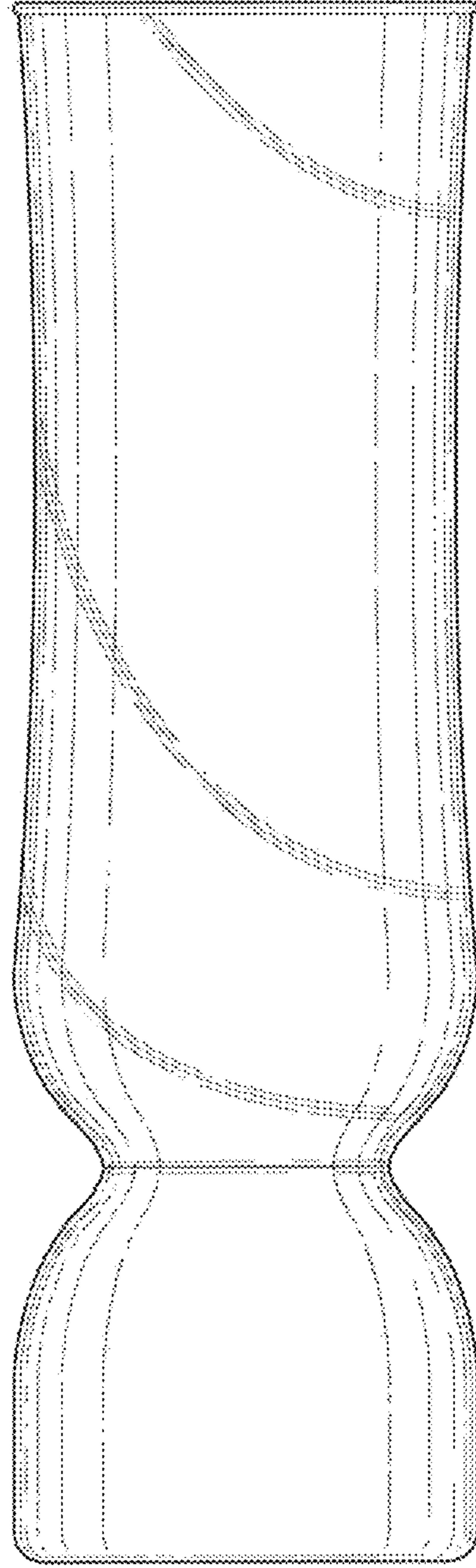

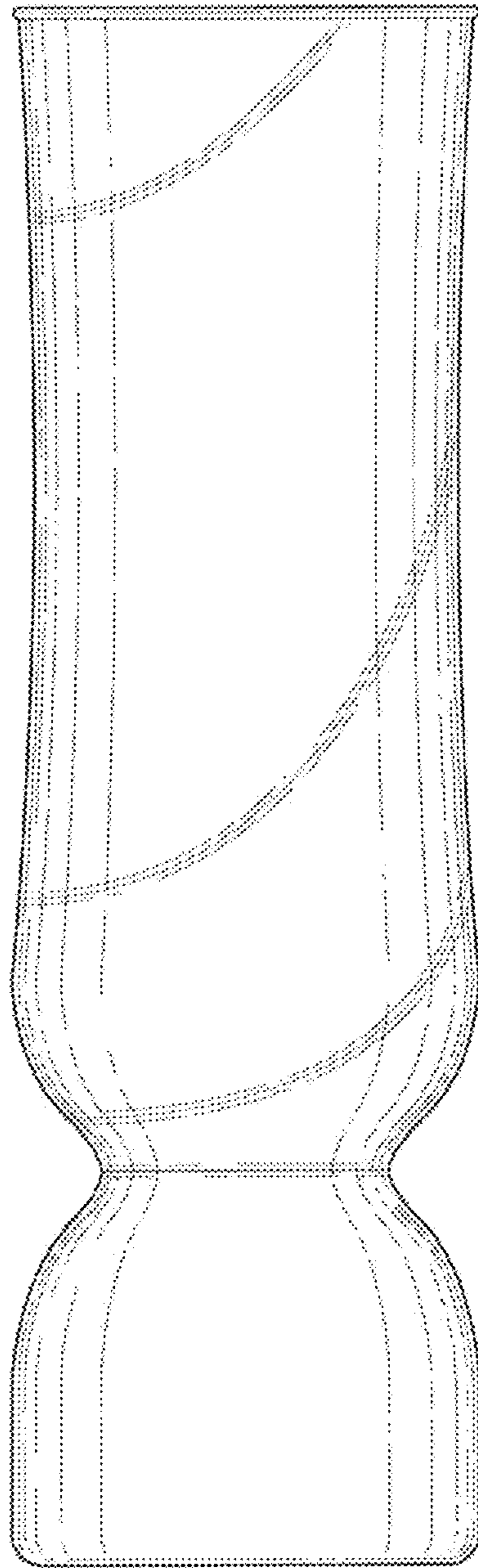

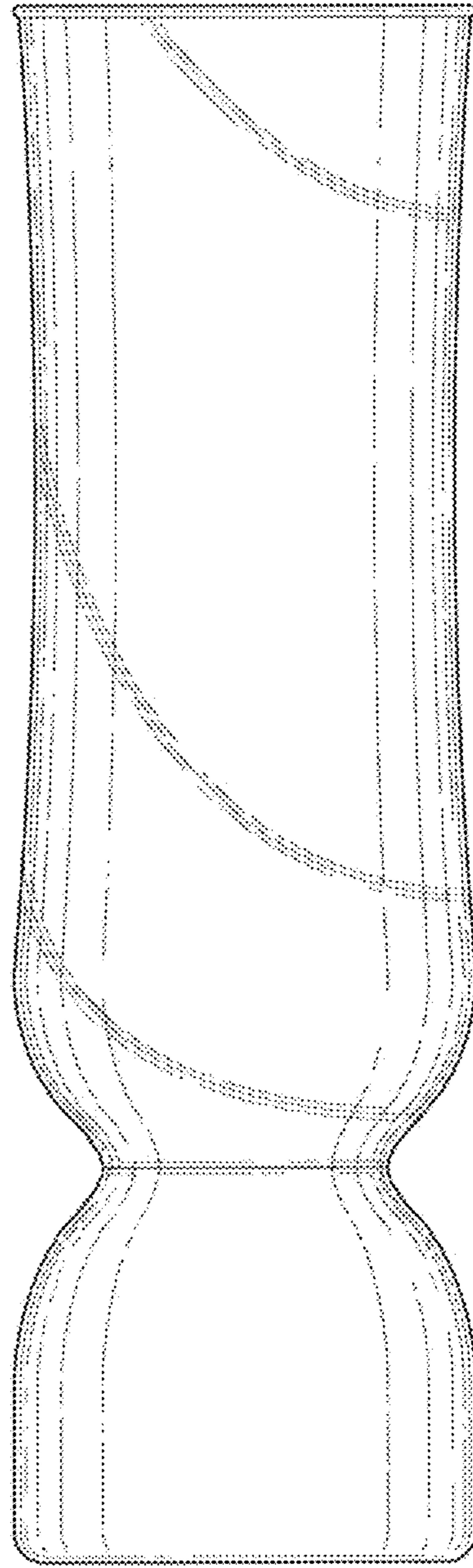

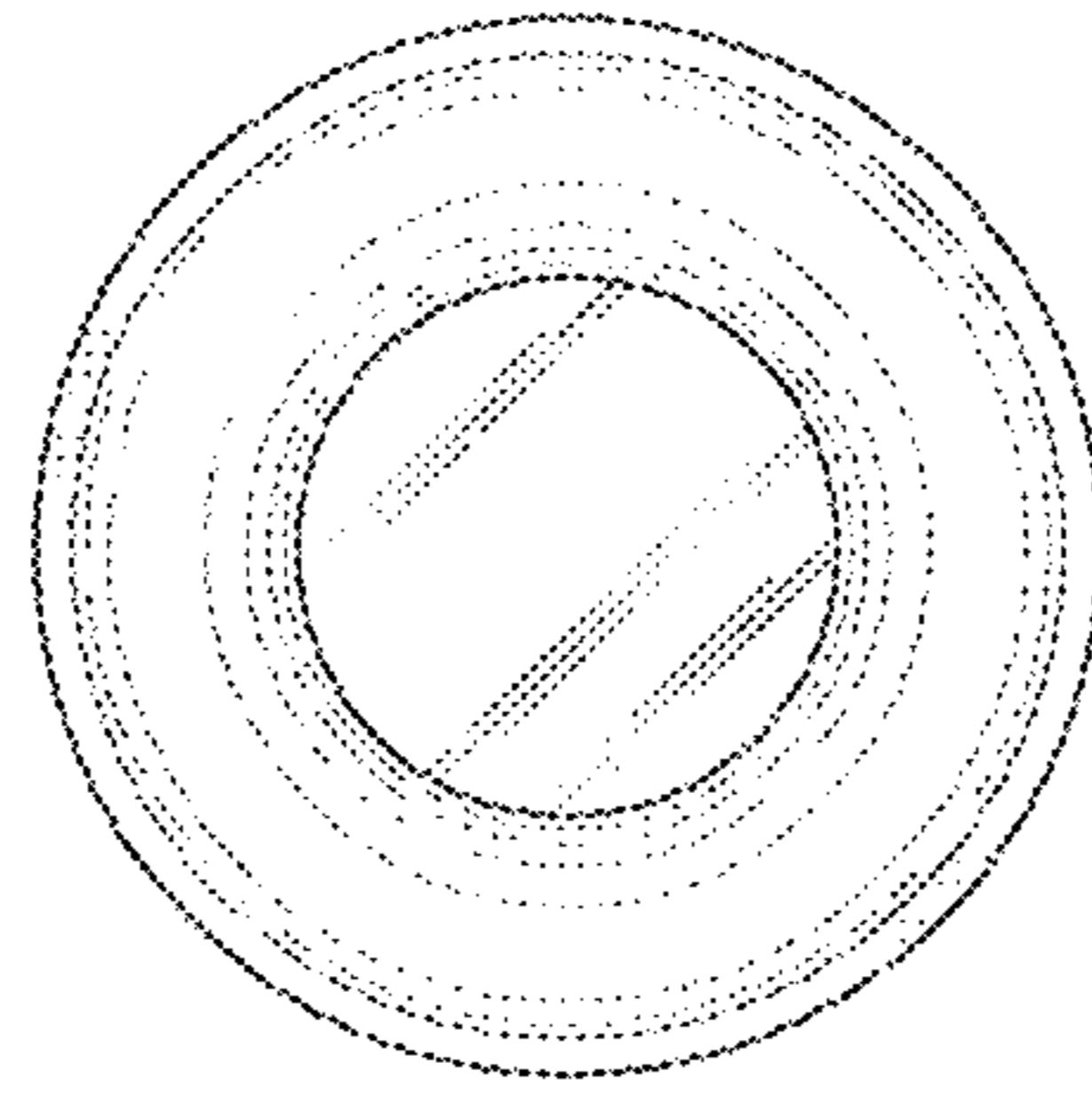

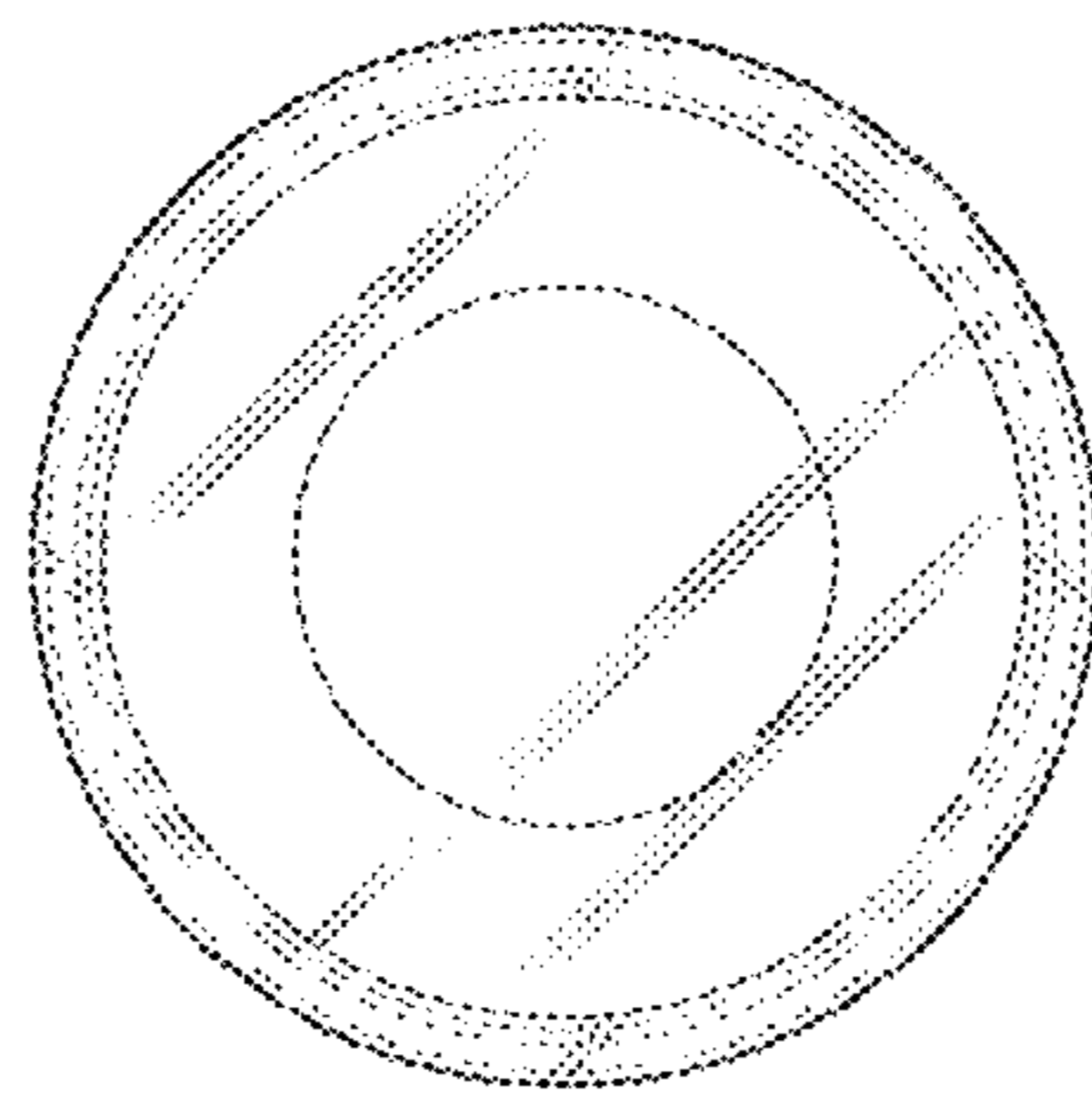
