FIG. 9 is an enlarged view of the encircled portion 9 in FIG. 1.

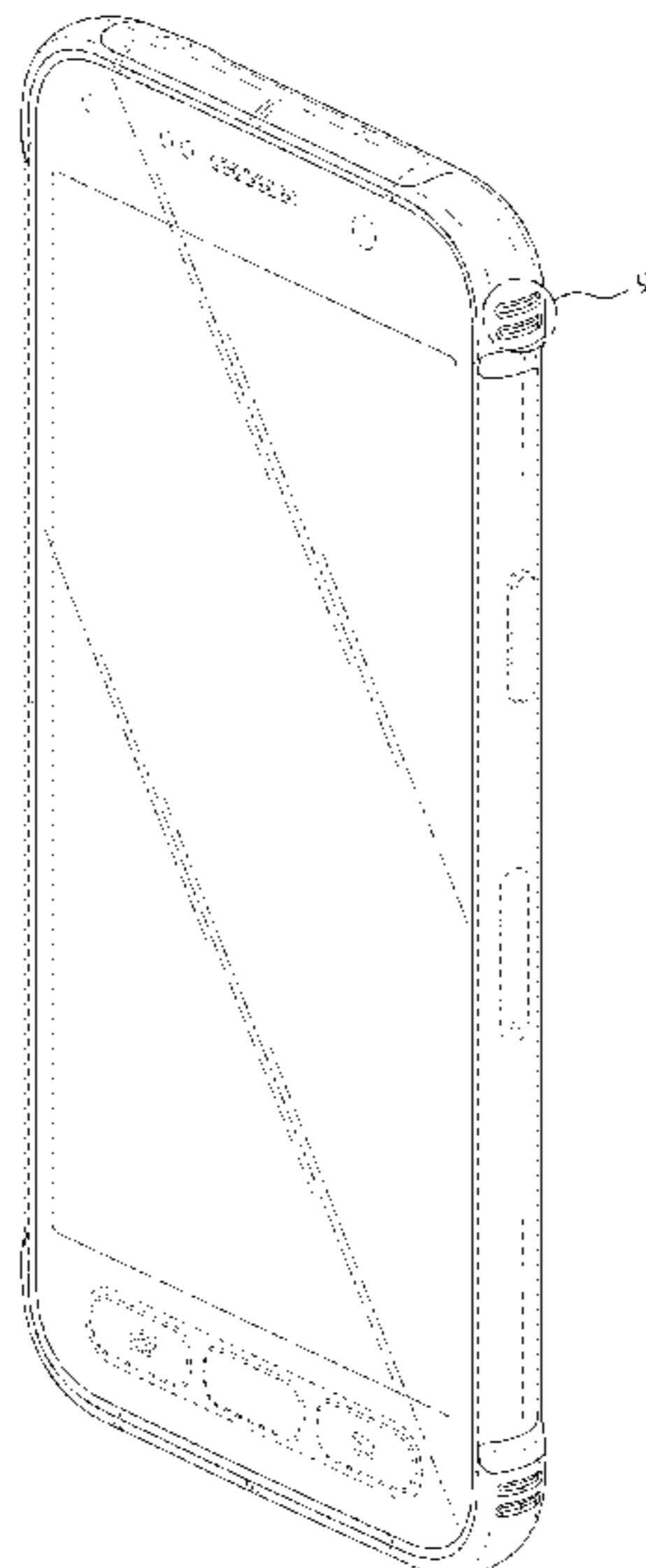

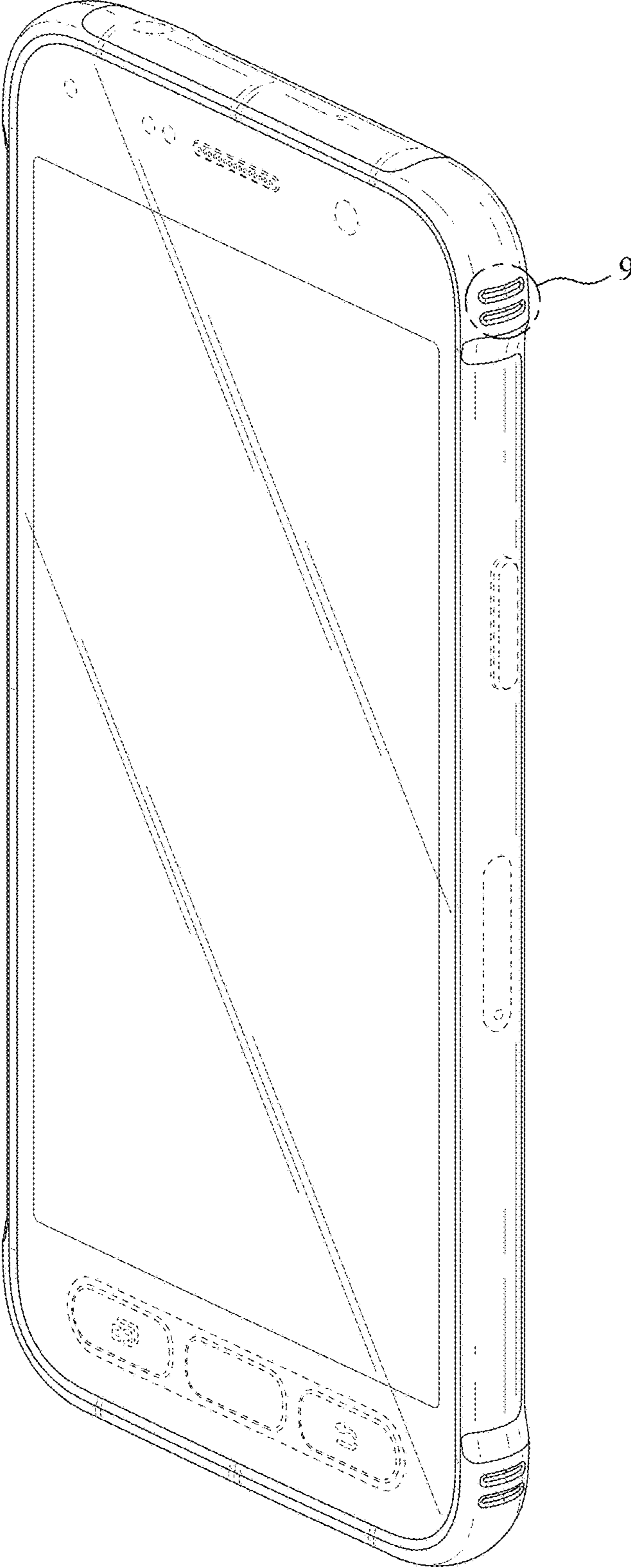

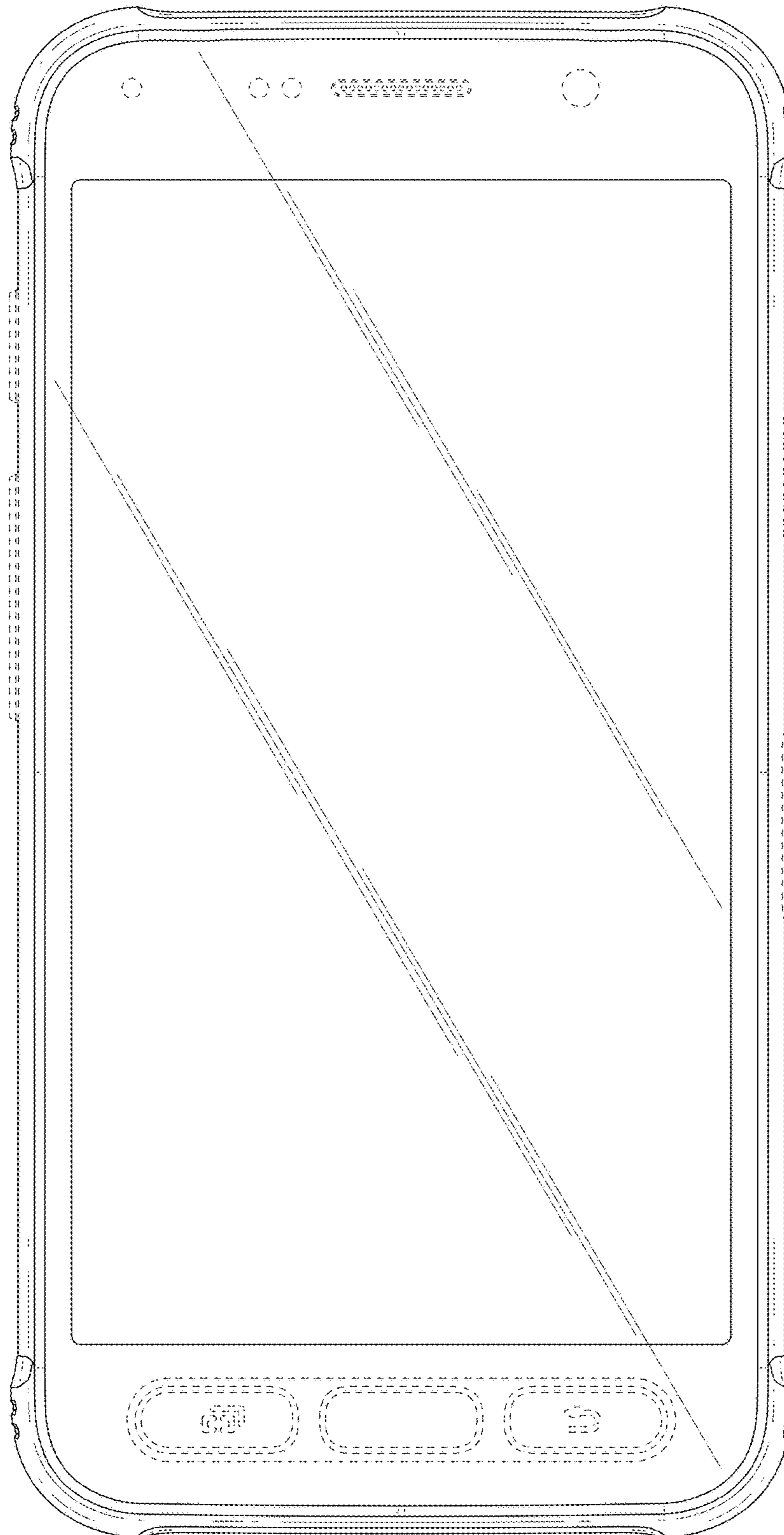

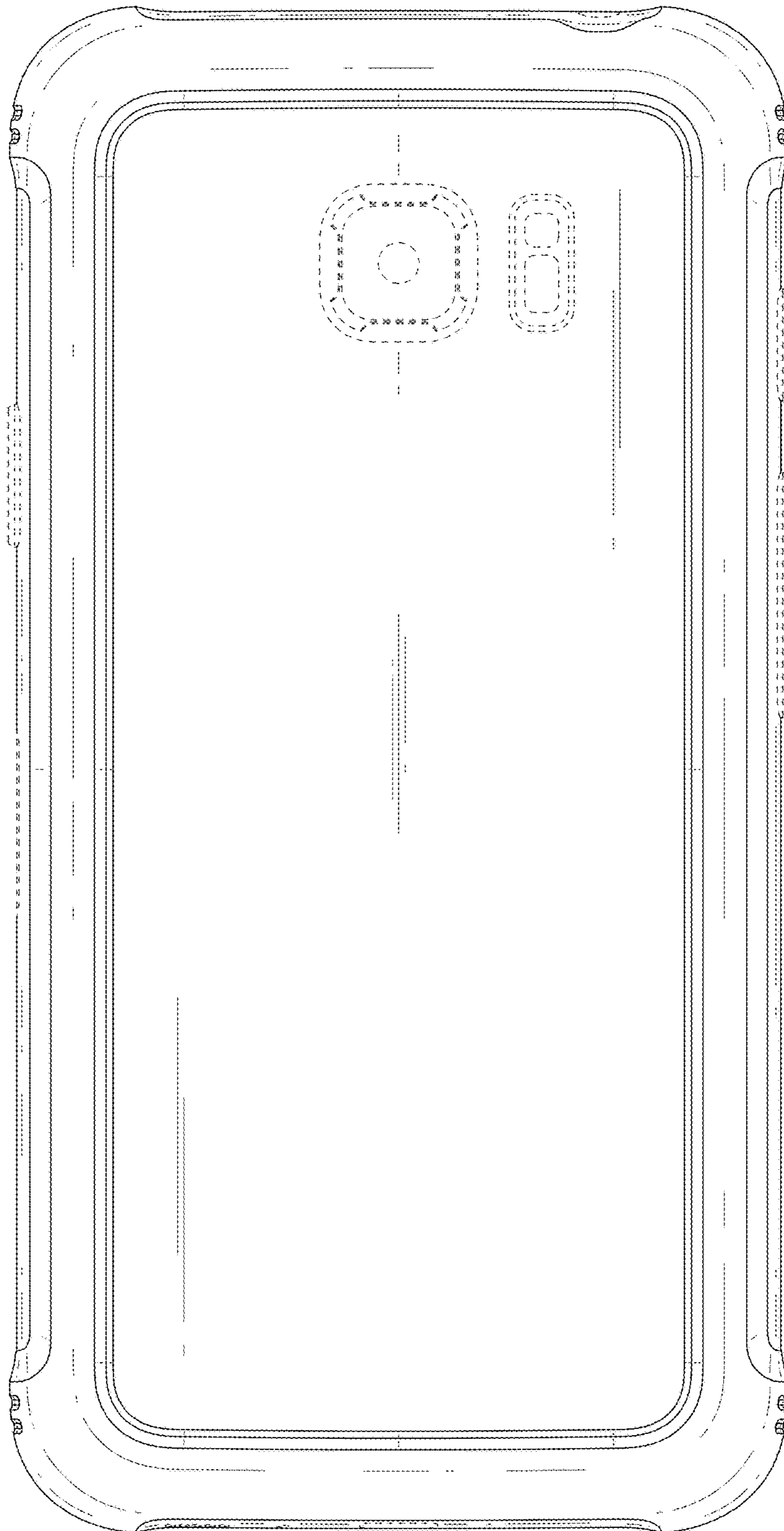

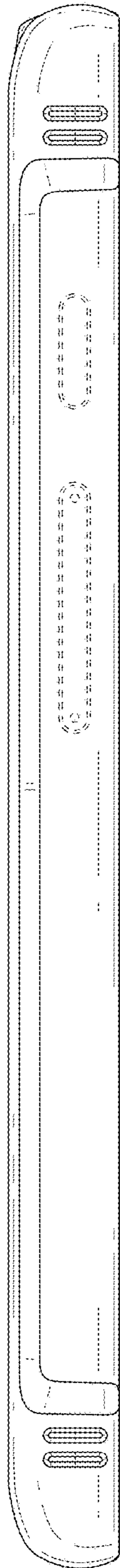

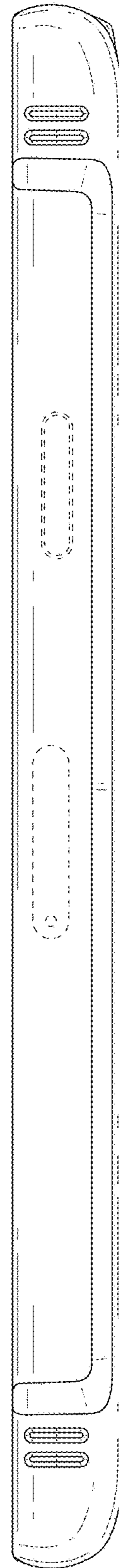

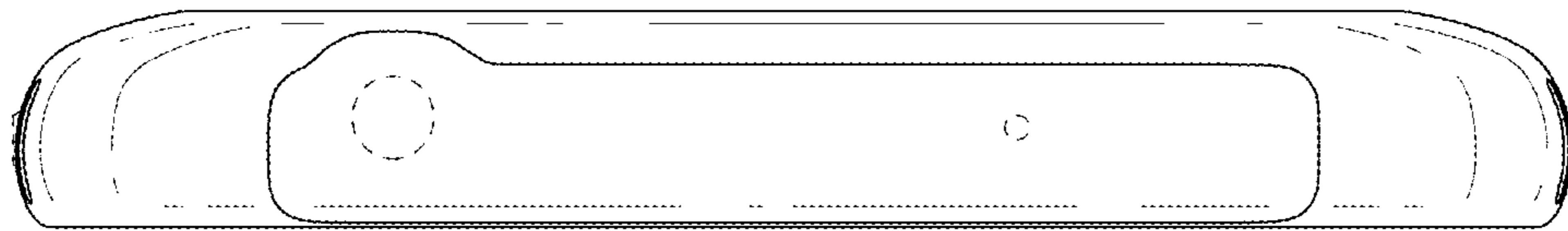

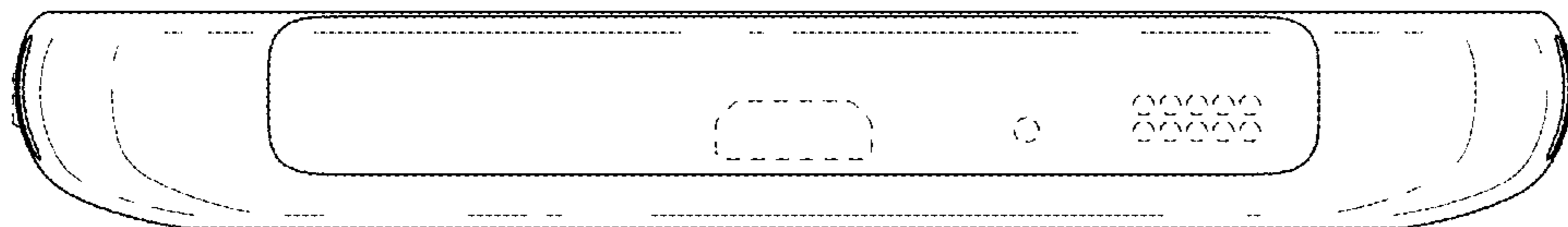

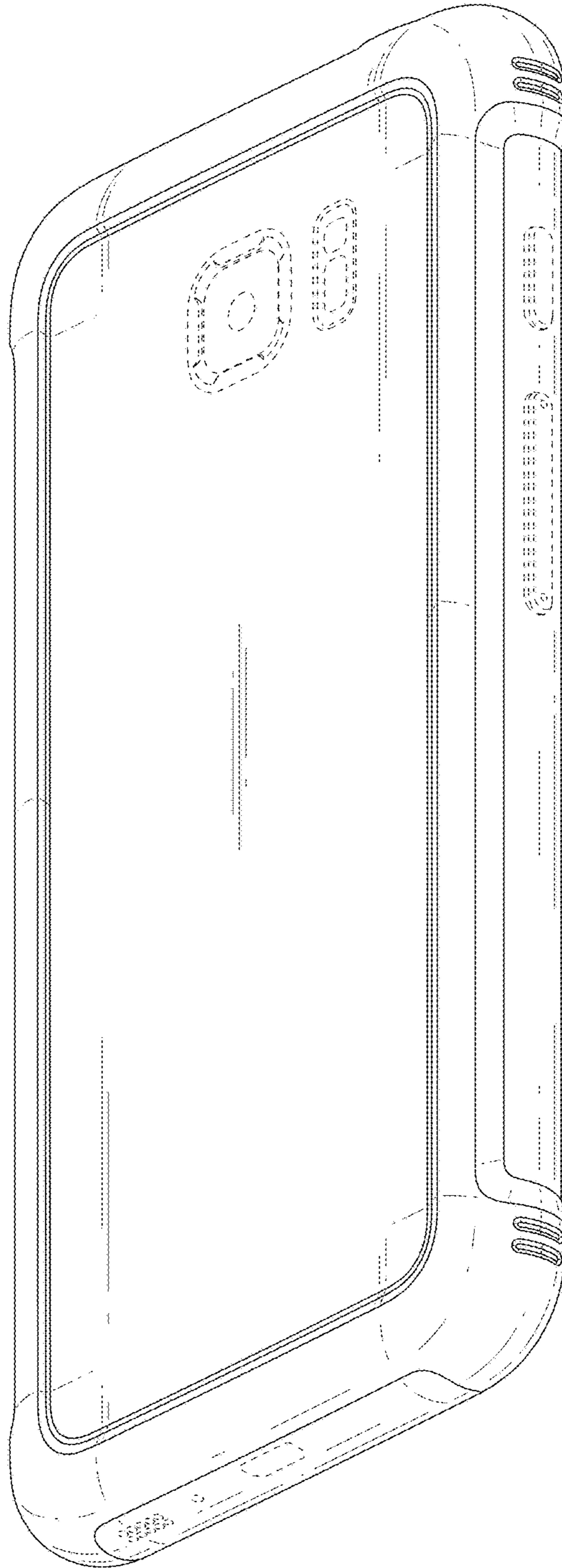
