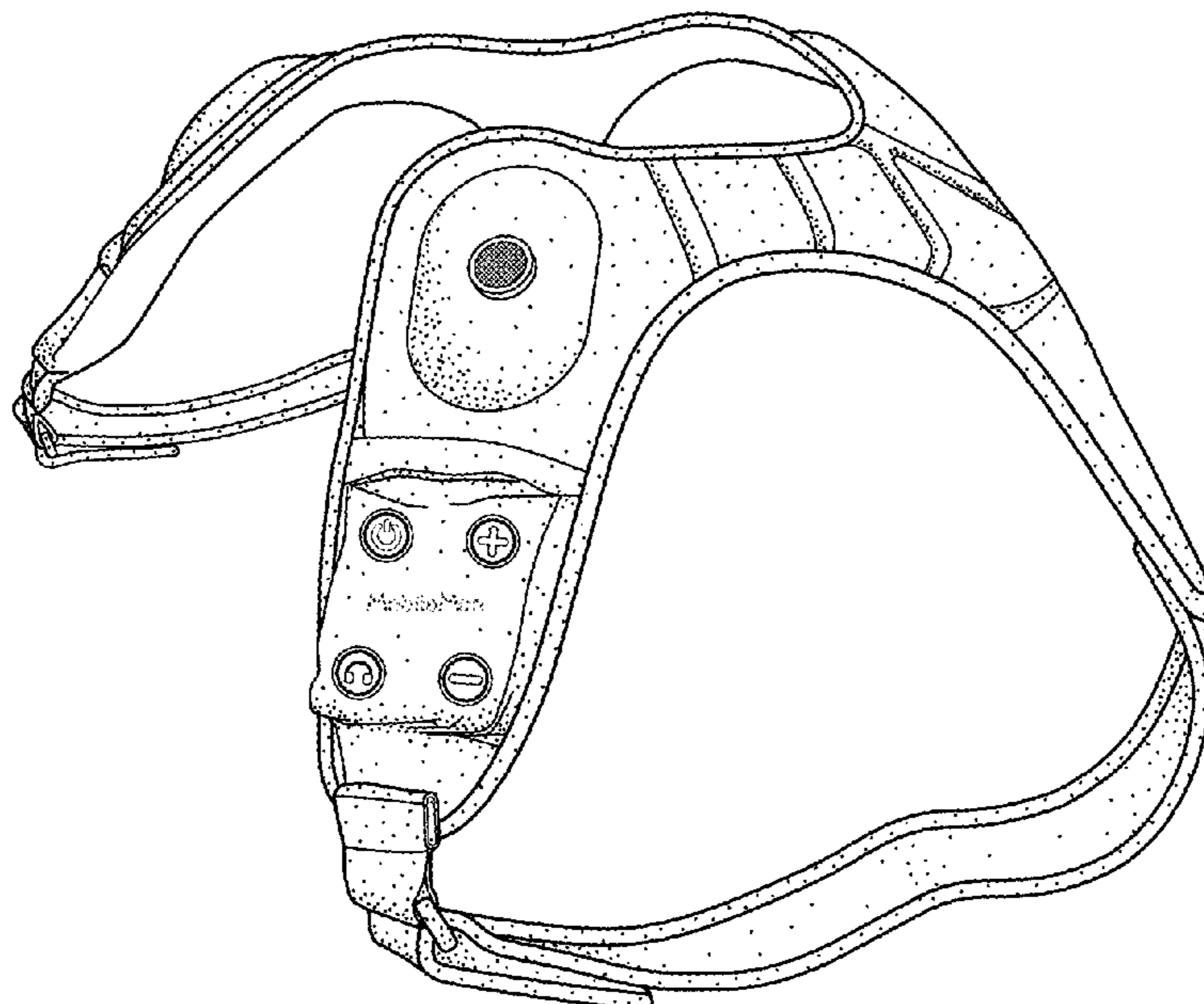
The ornamental design for wearable speakers, as shown and described.

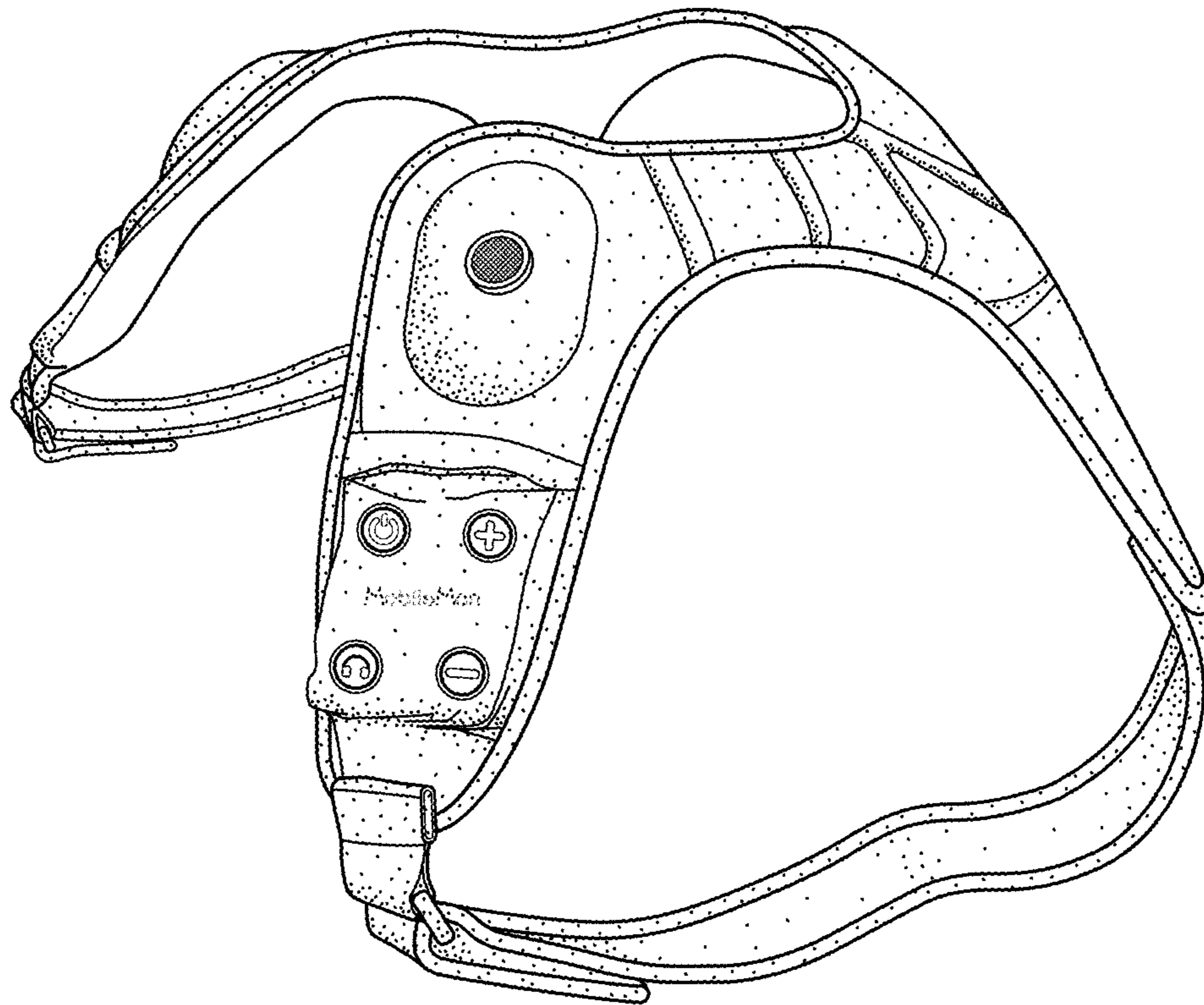

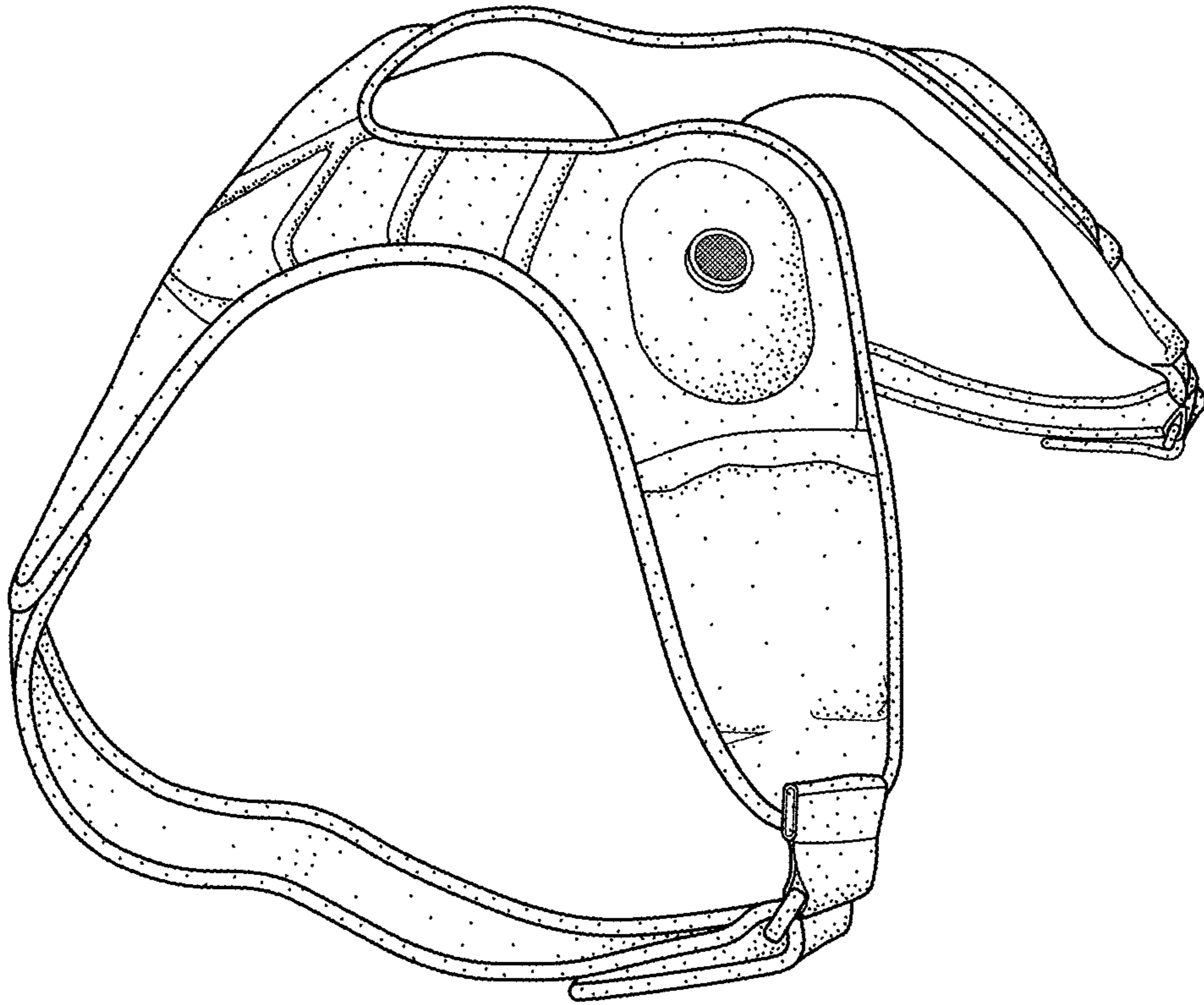

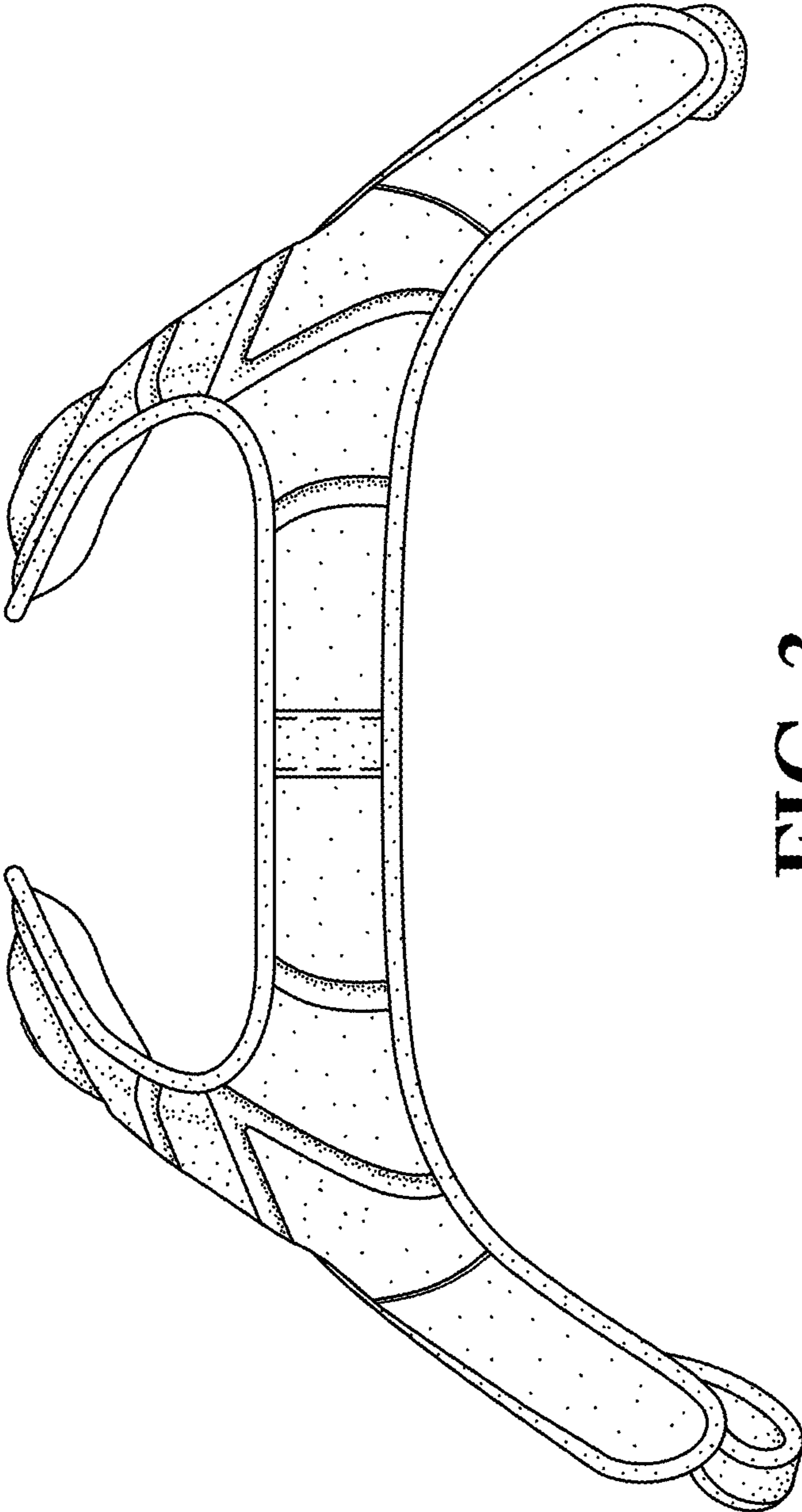

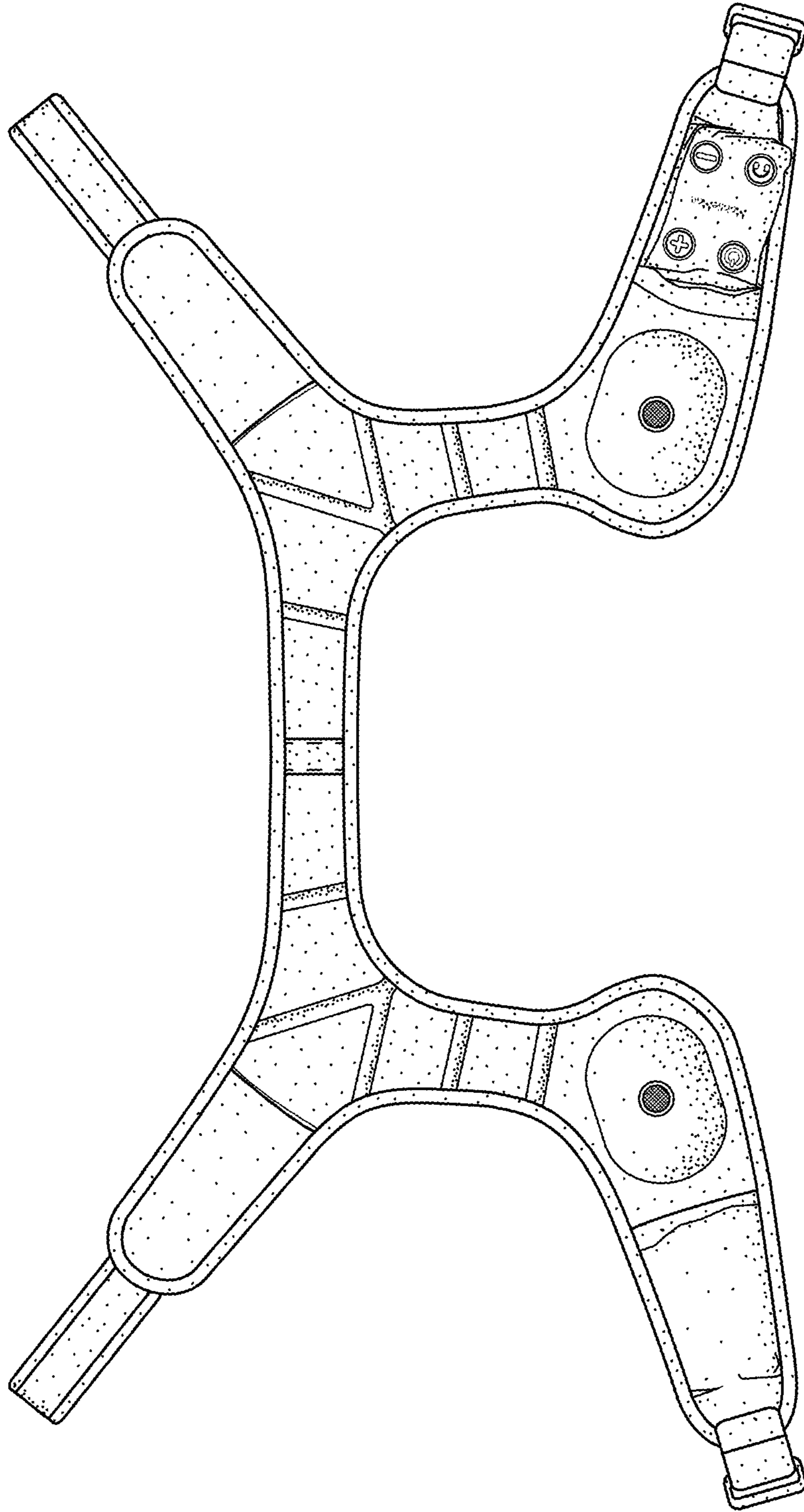
