The ornamental design for a tablet computer, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a tablet computer showing our new design;

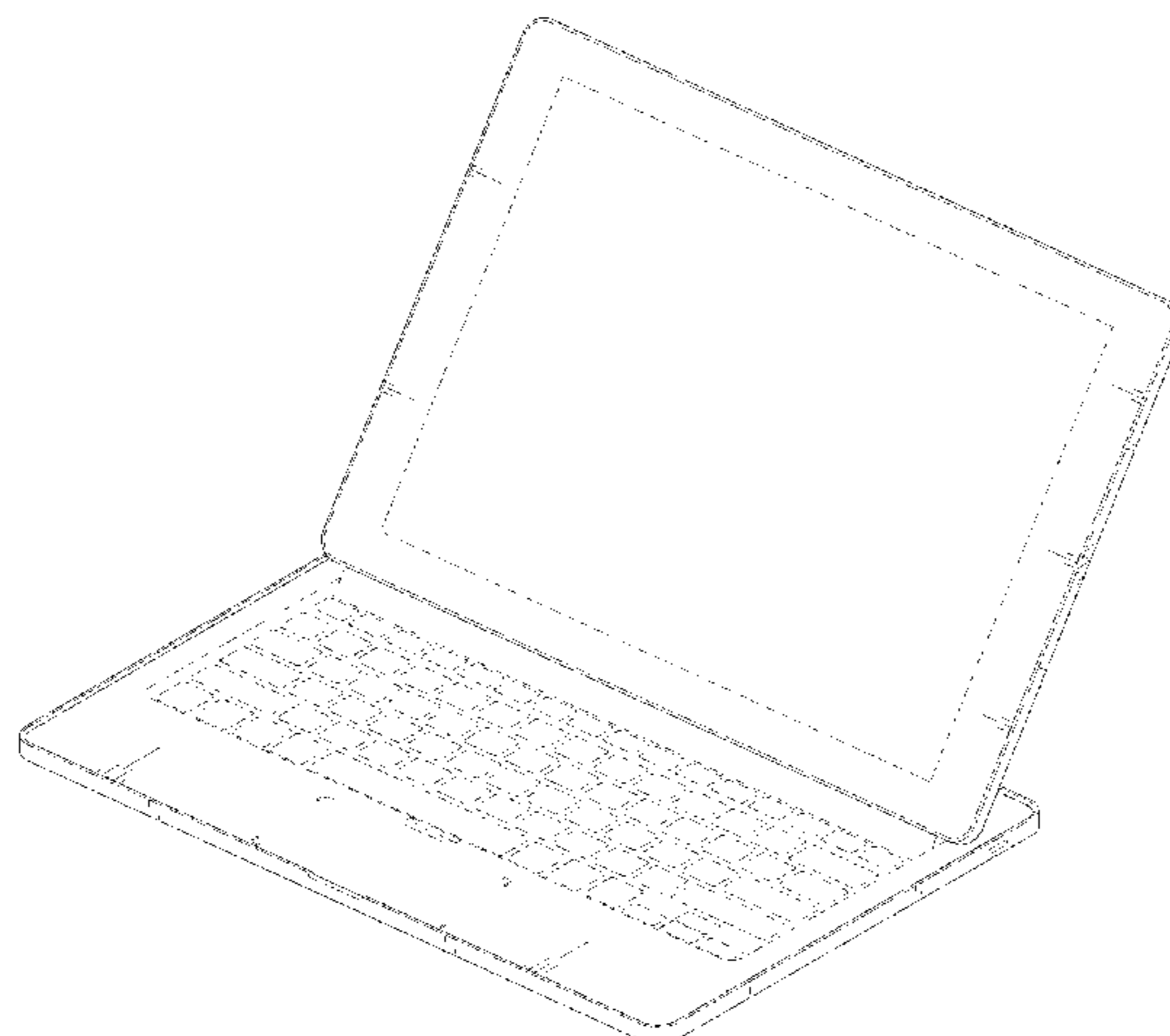

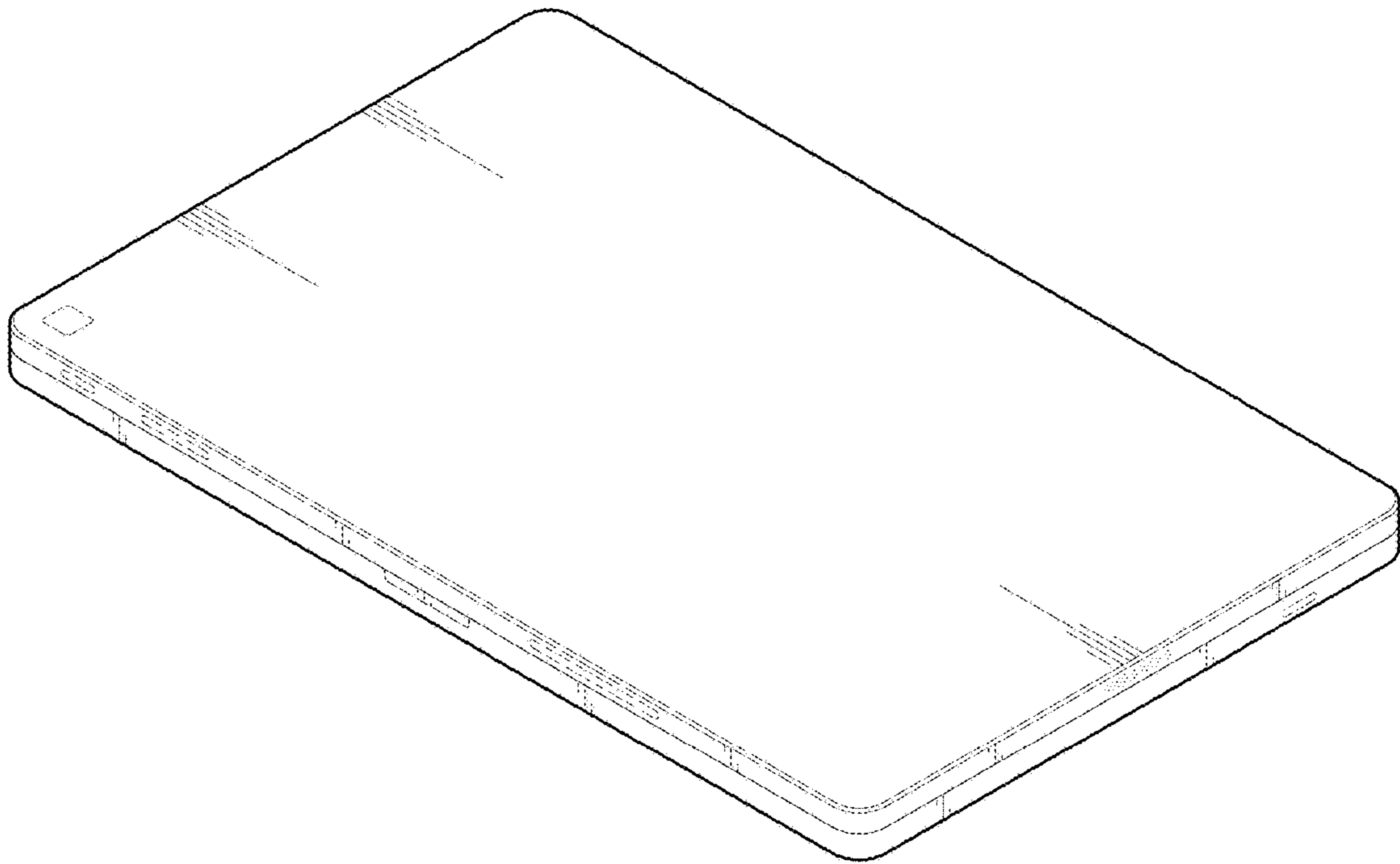

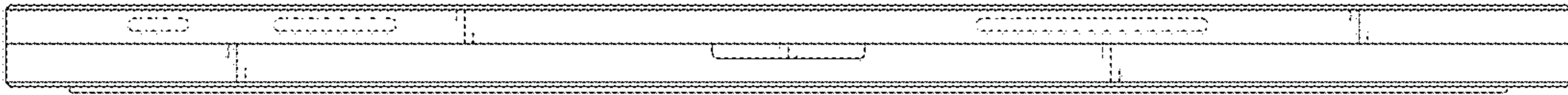

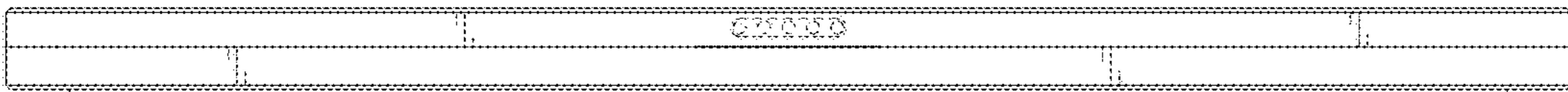

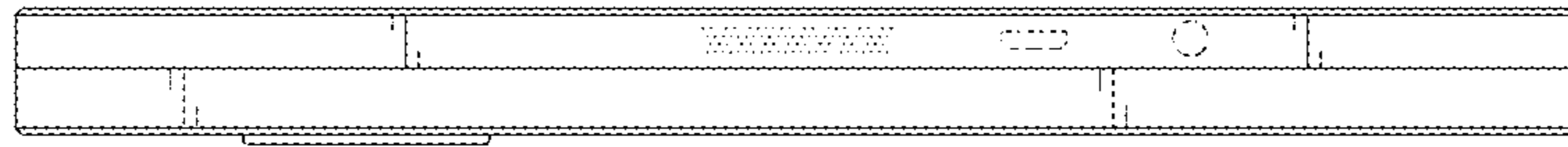

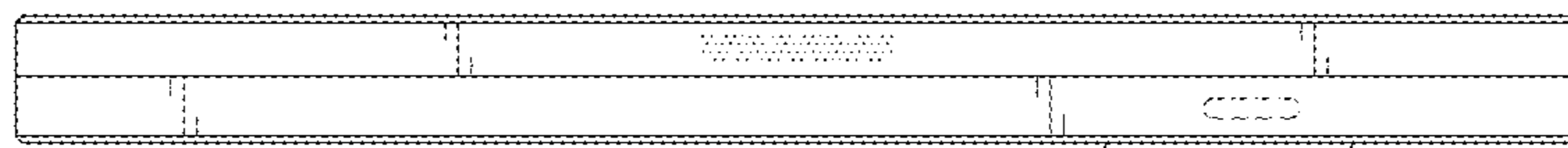

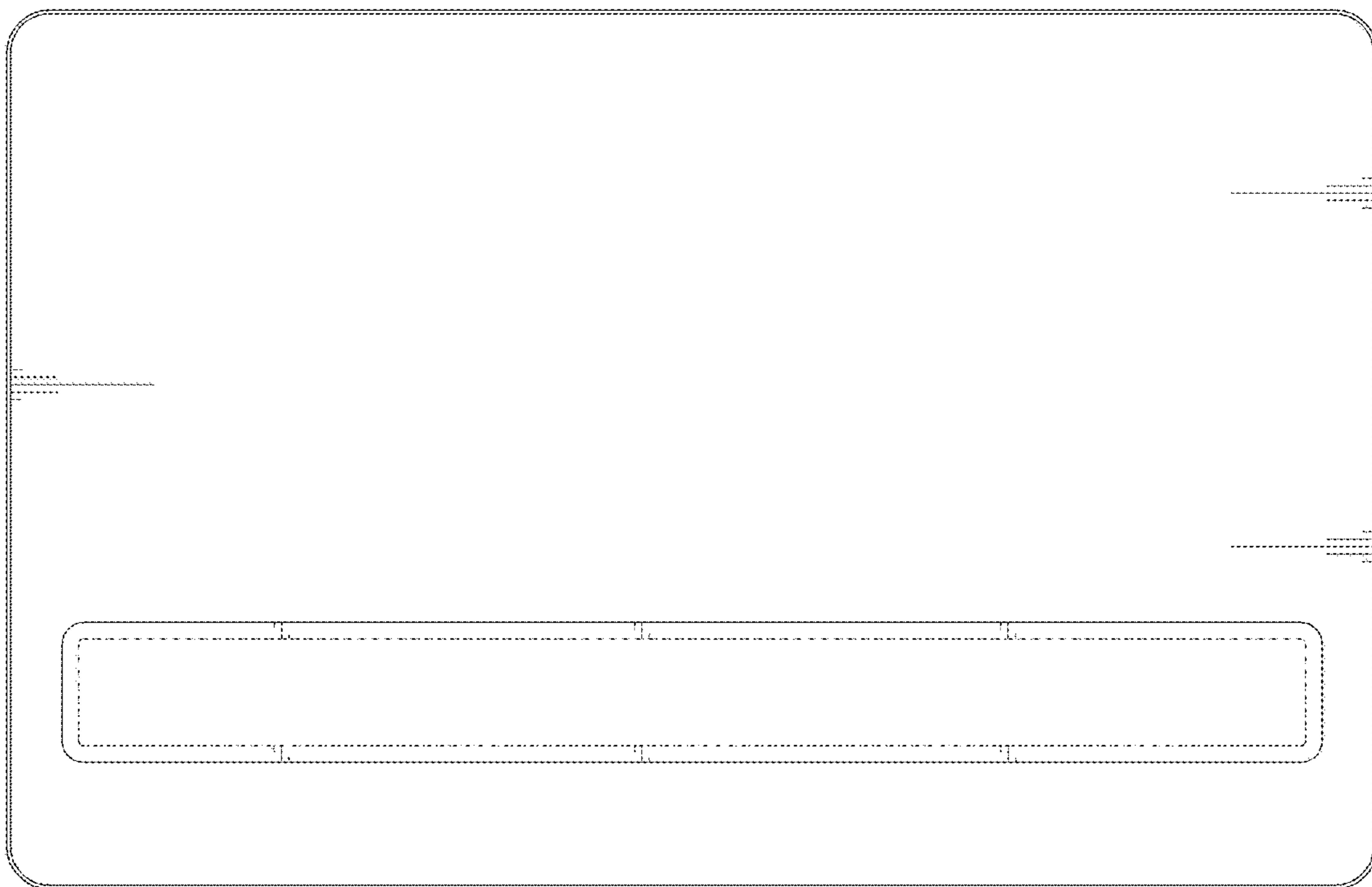
