(57) **CLAIM**

The ornamental design for a display screen or a portion thereof with animated graphical user interface for a profit and loss table, as shown and described.

**DESCRIPTION**

FIG. 6 is a front view of a sixth image thereof; and,

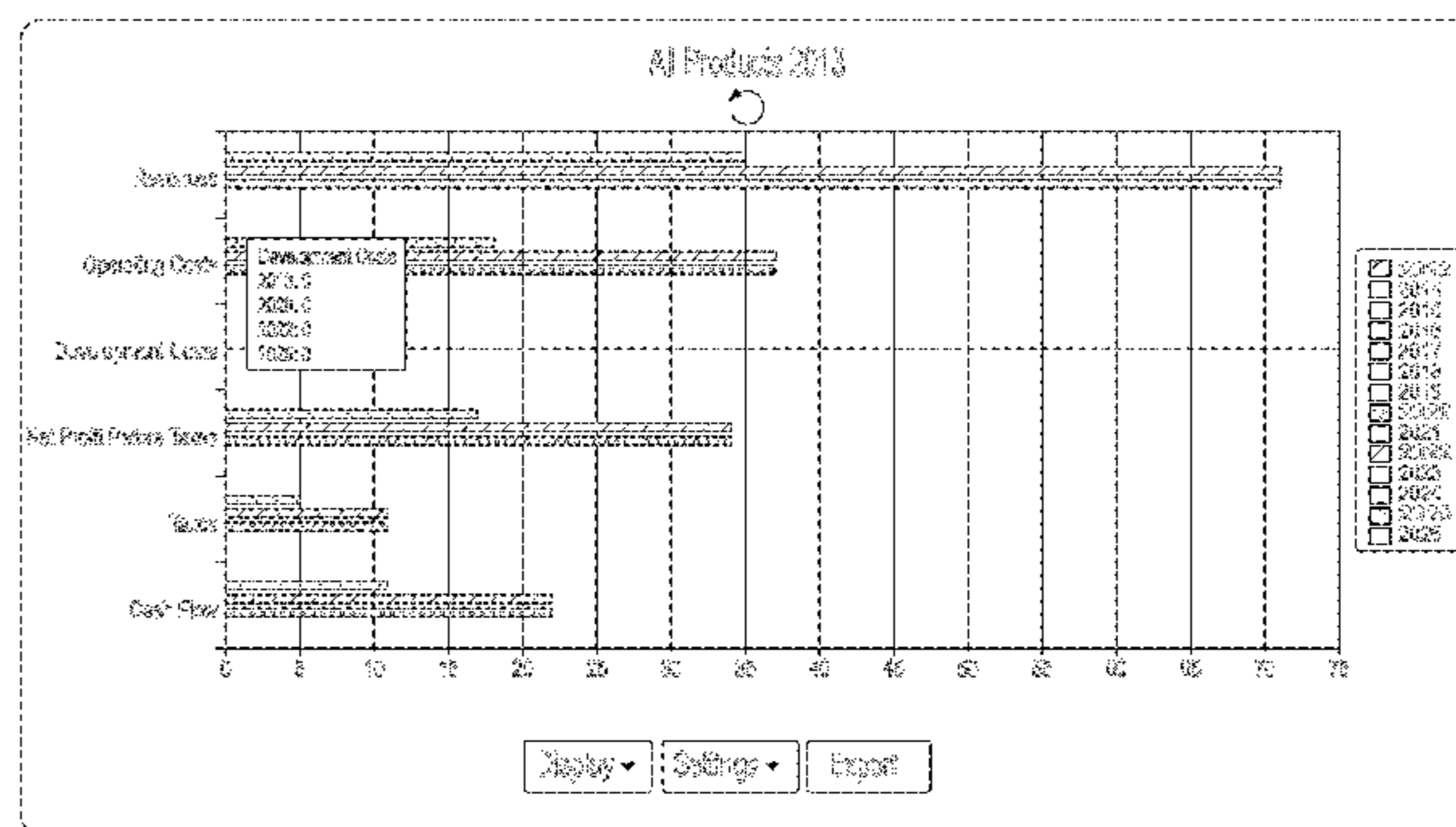
FIG. 7 is a front view of a seventh image thereof.

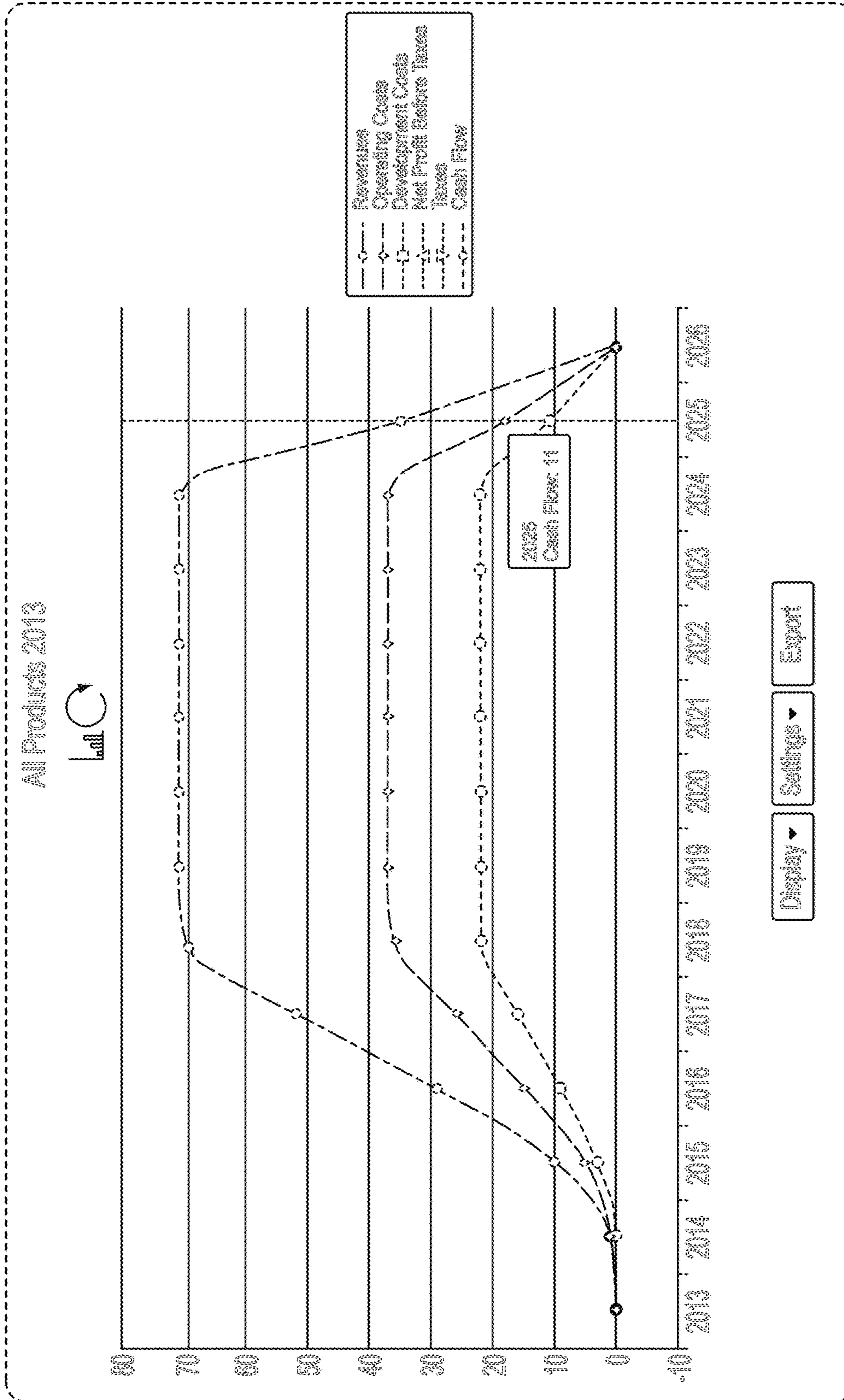

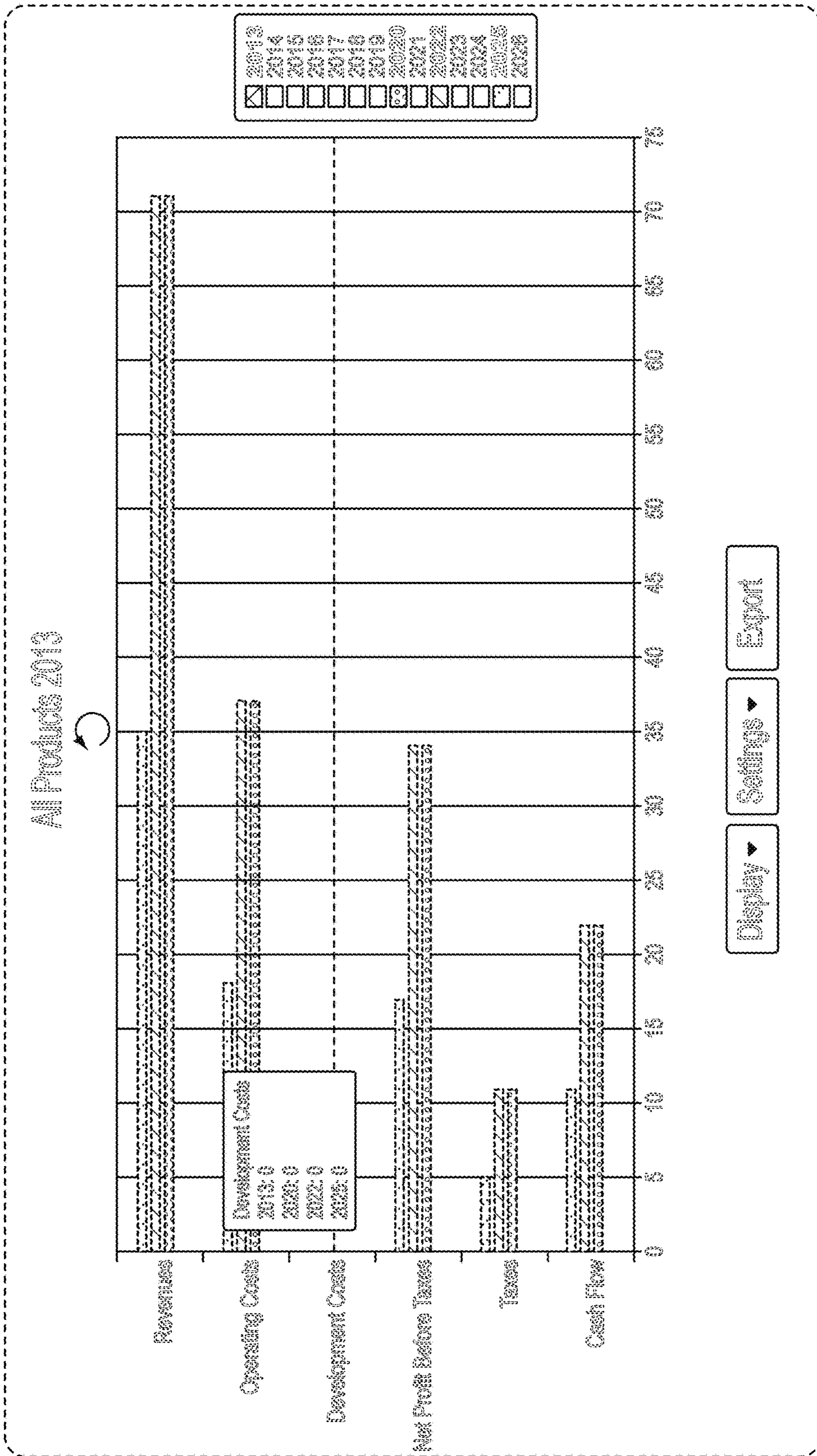
