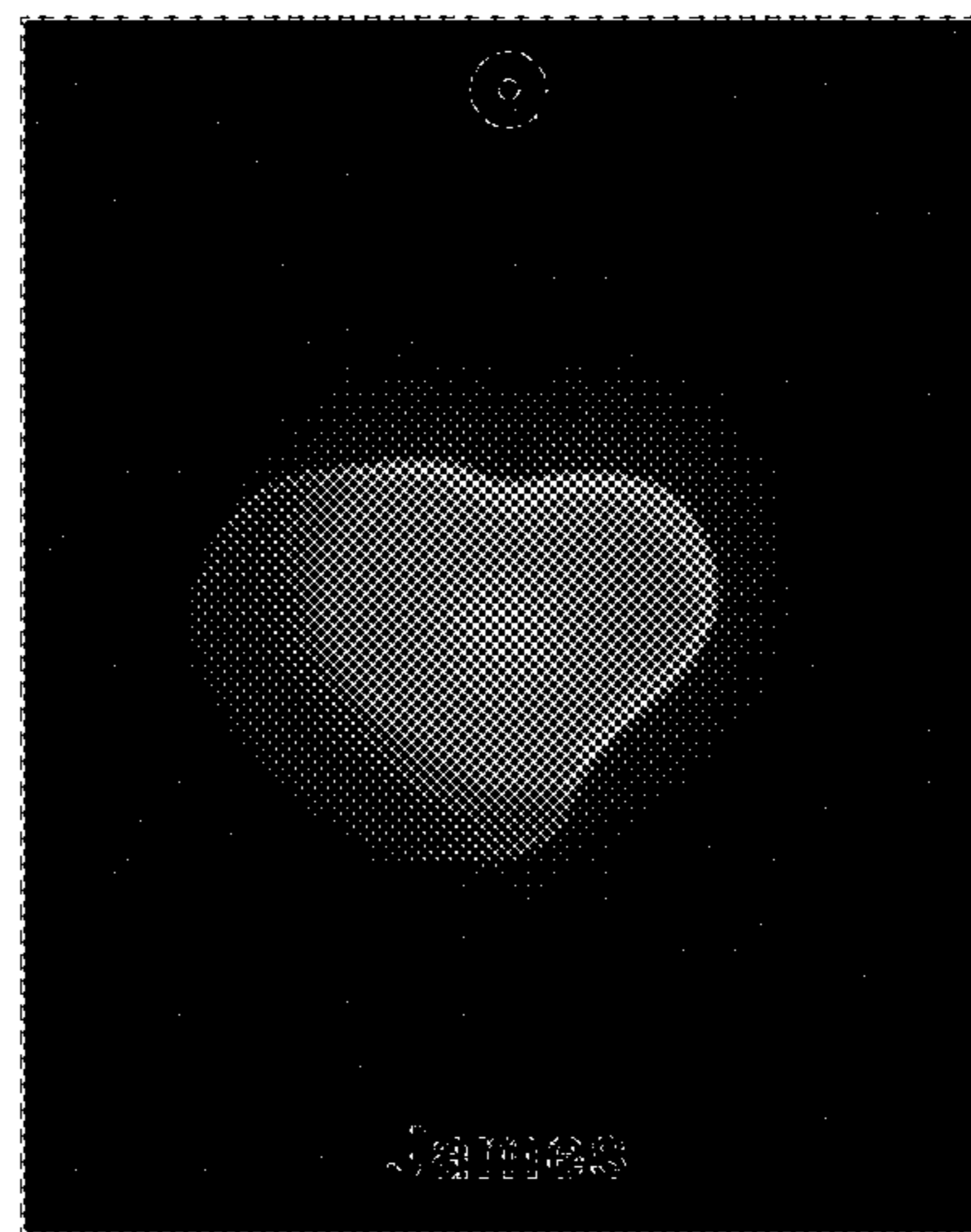
DESCRIPTION

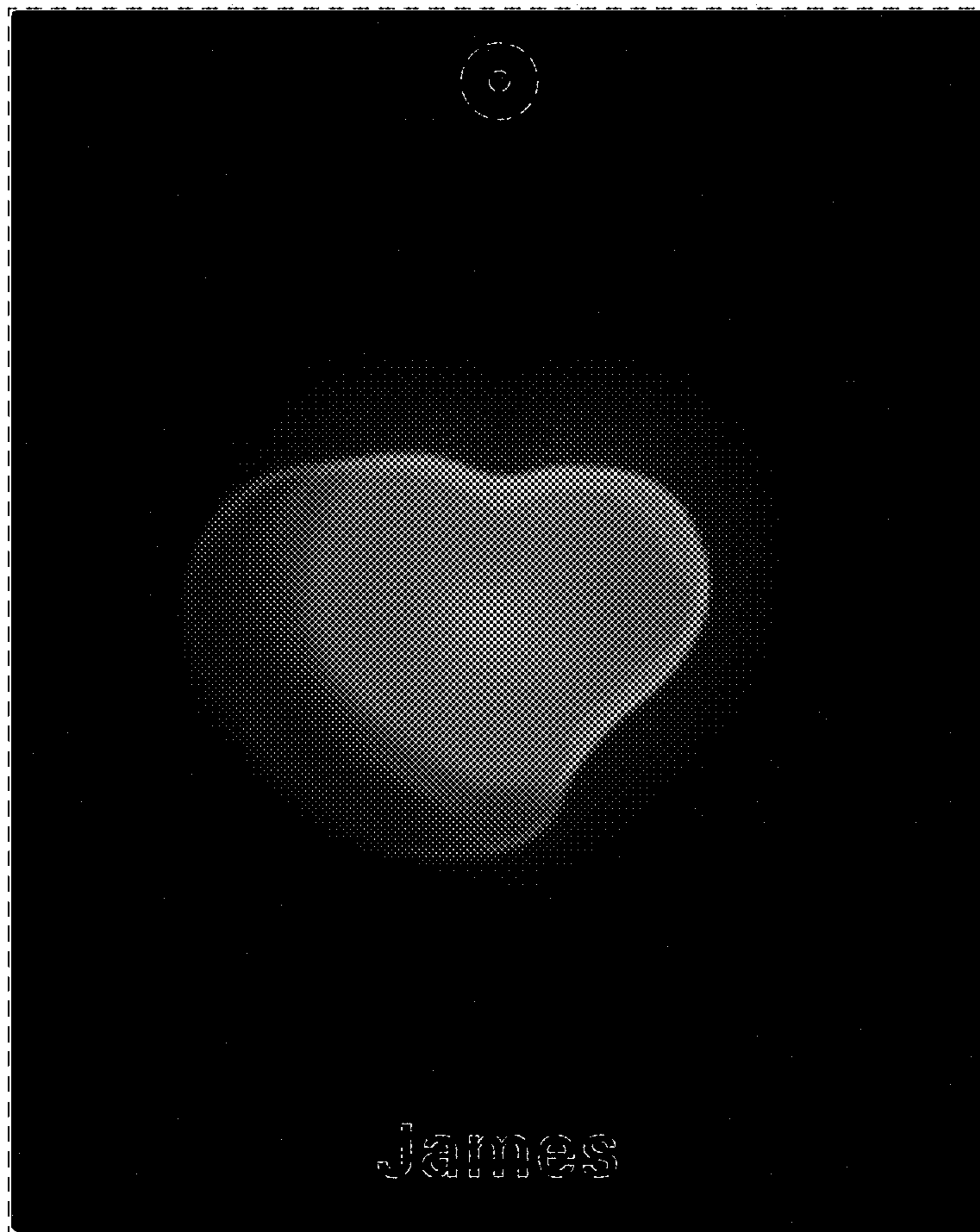

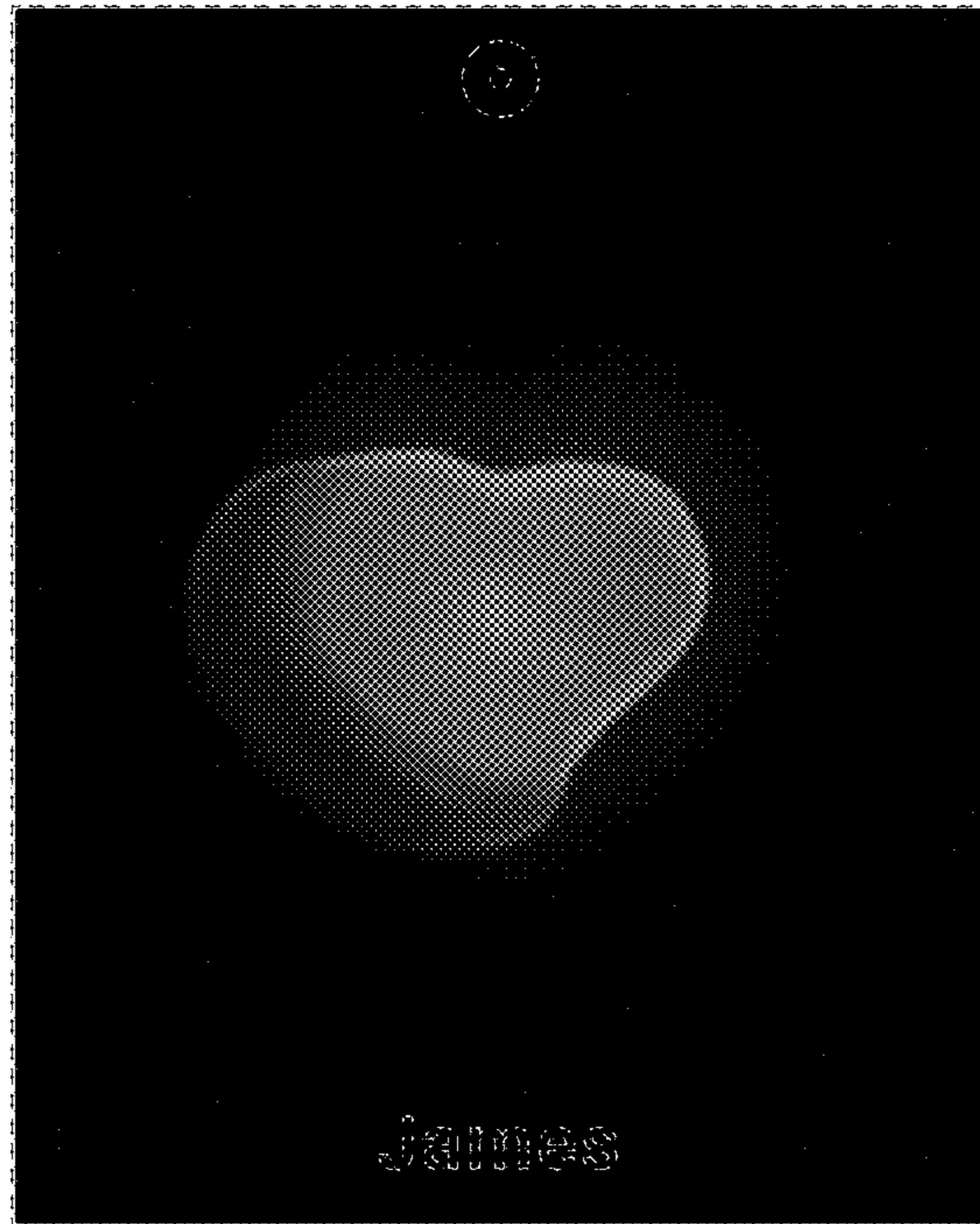
