FIG. 9 is a front view of a third embodiment of the display screen for a graphical user interface, showing our new design;

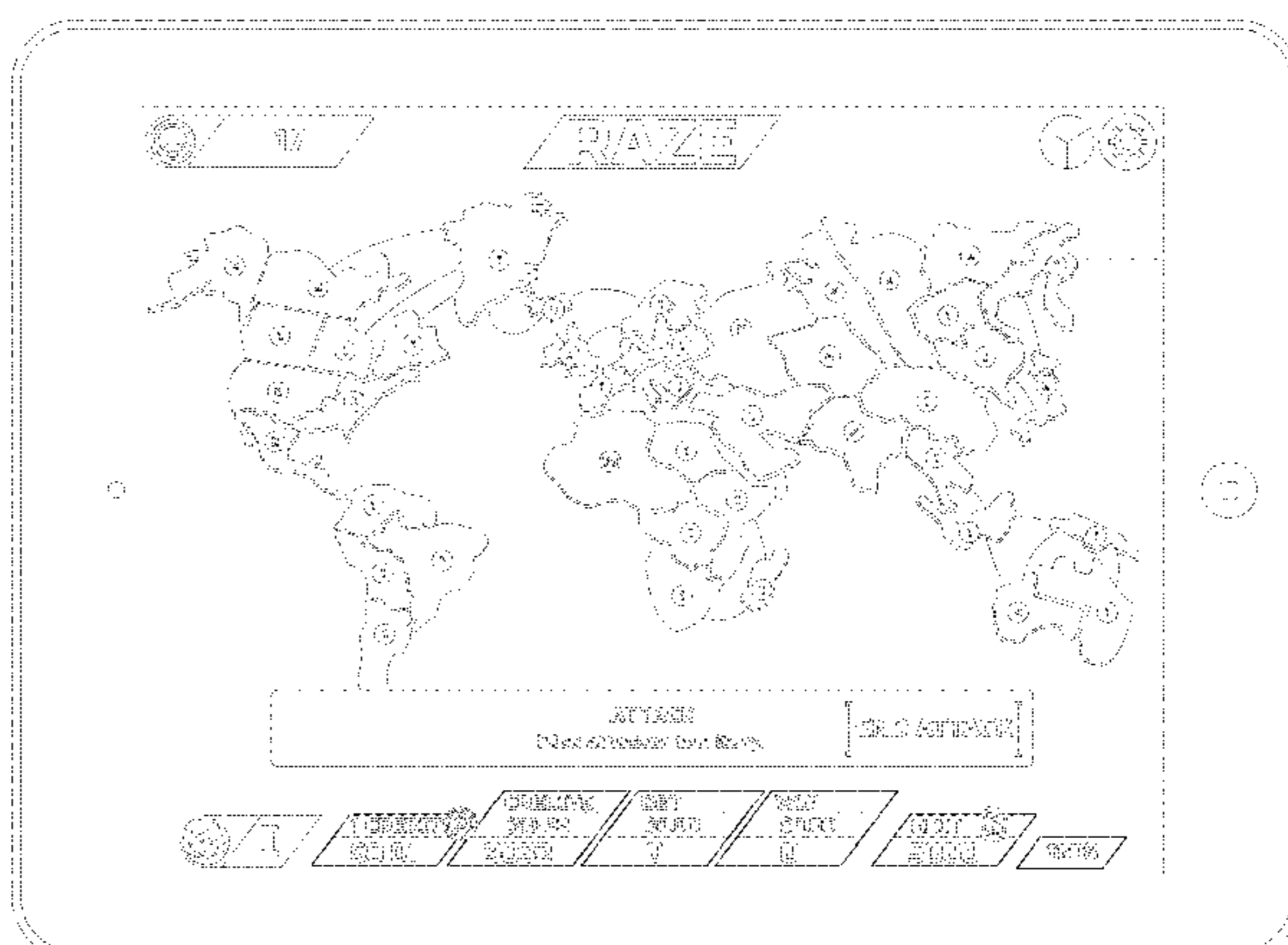
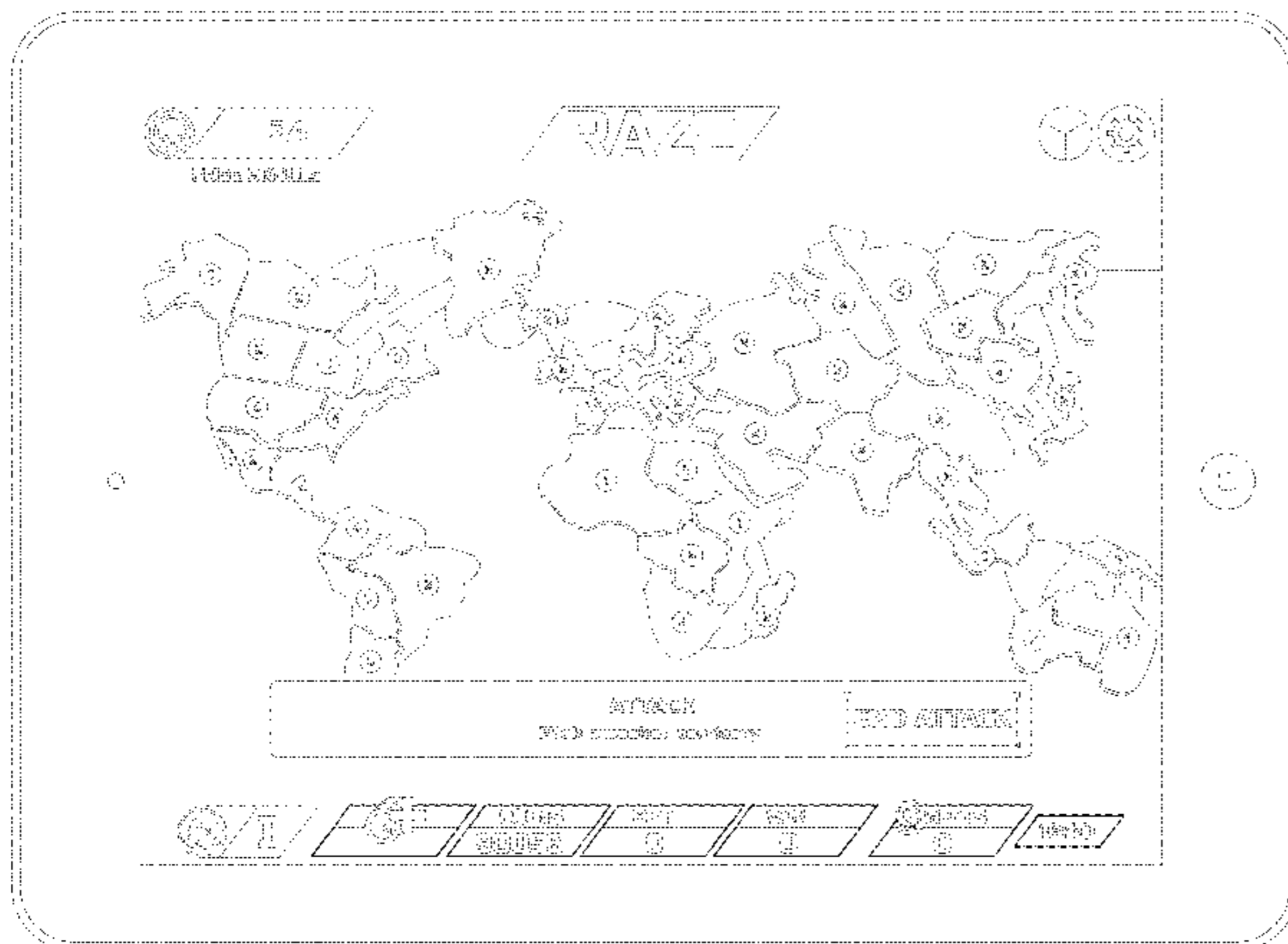
FIG. 10 is another front view thereof;

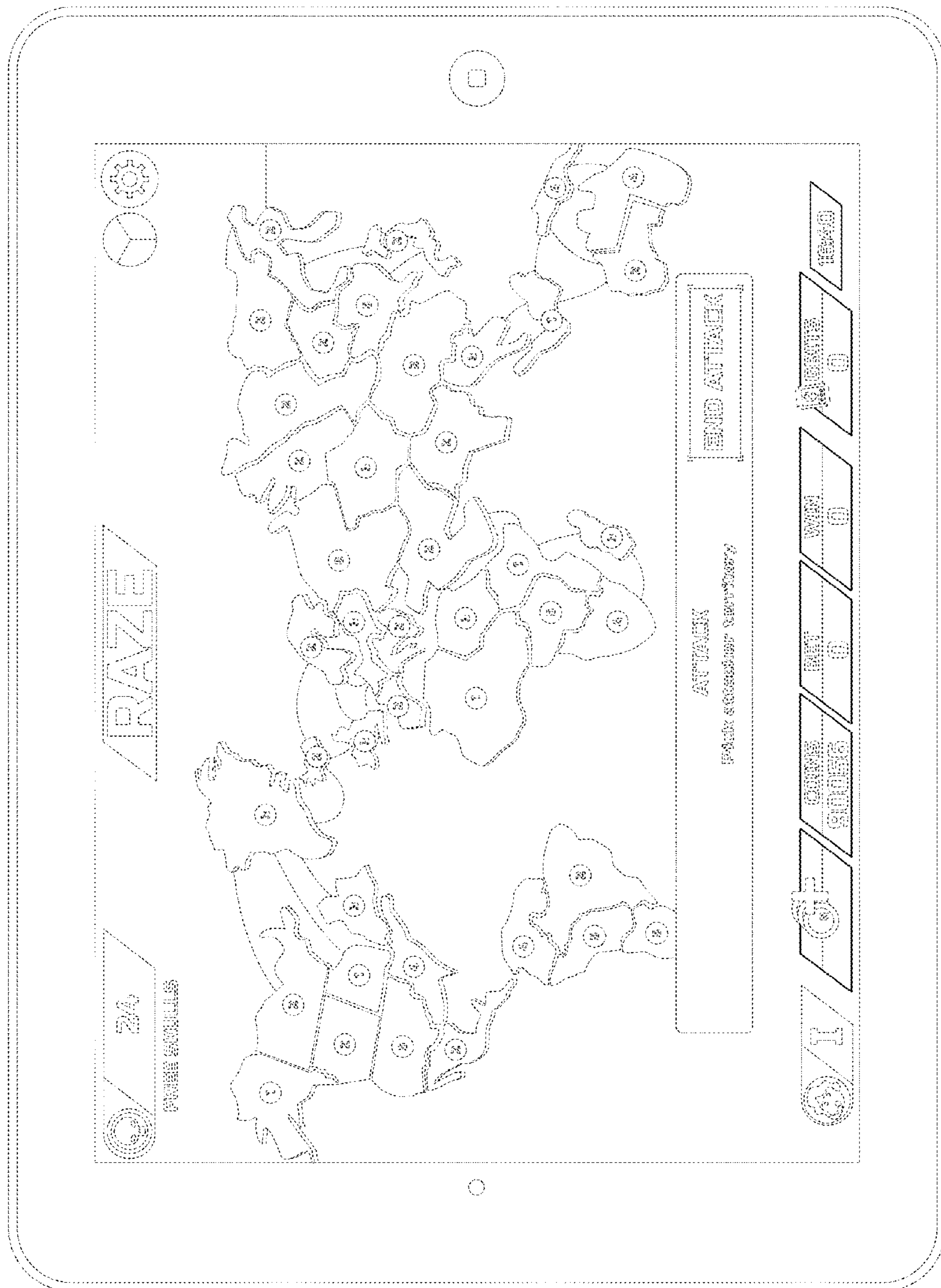

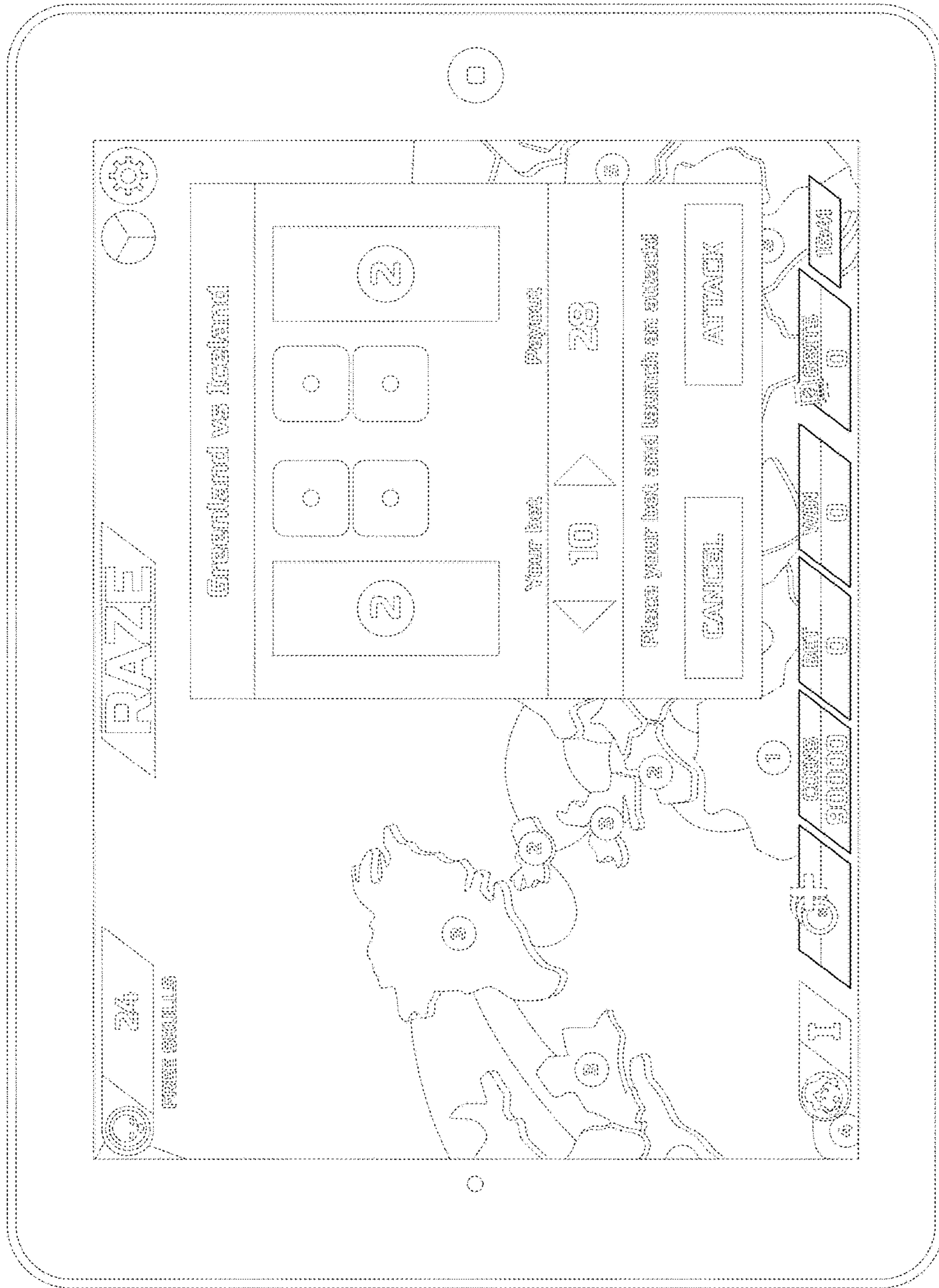

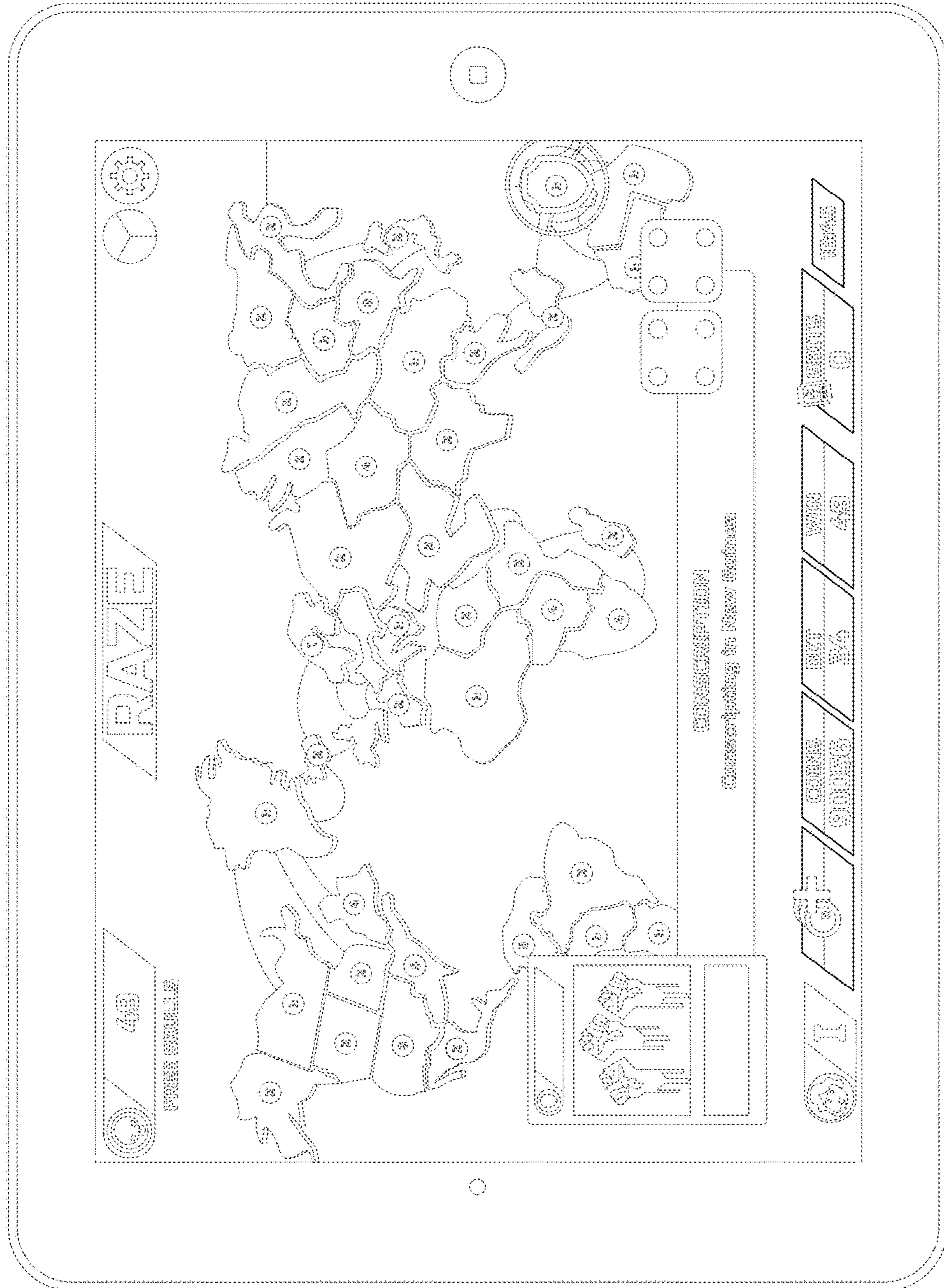

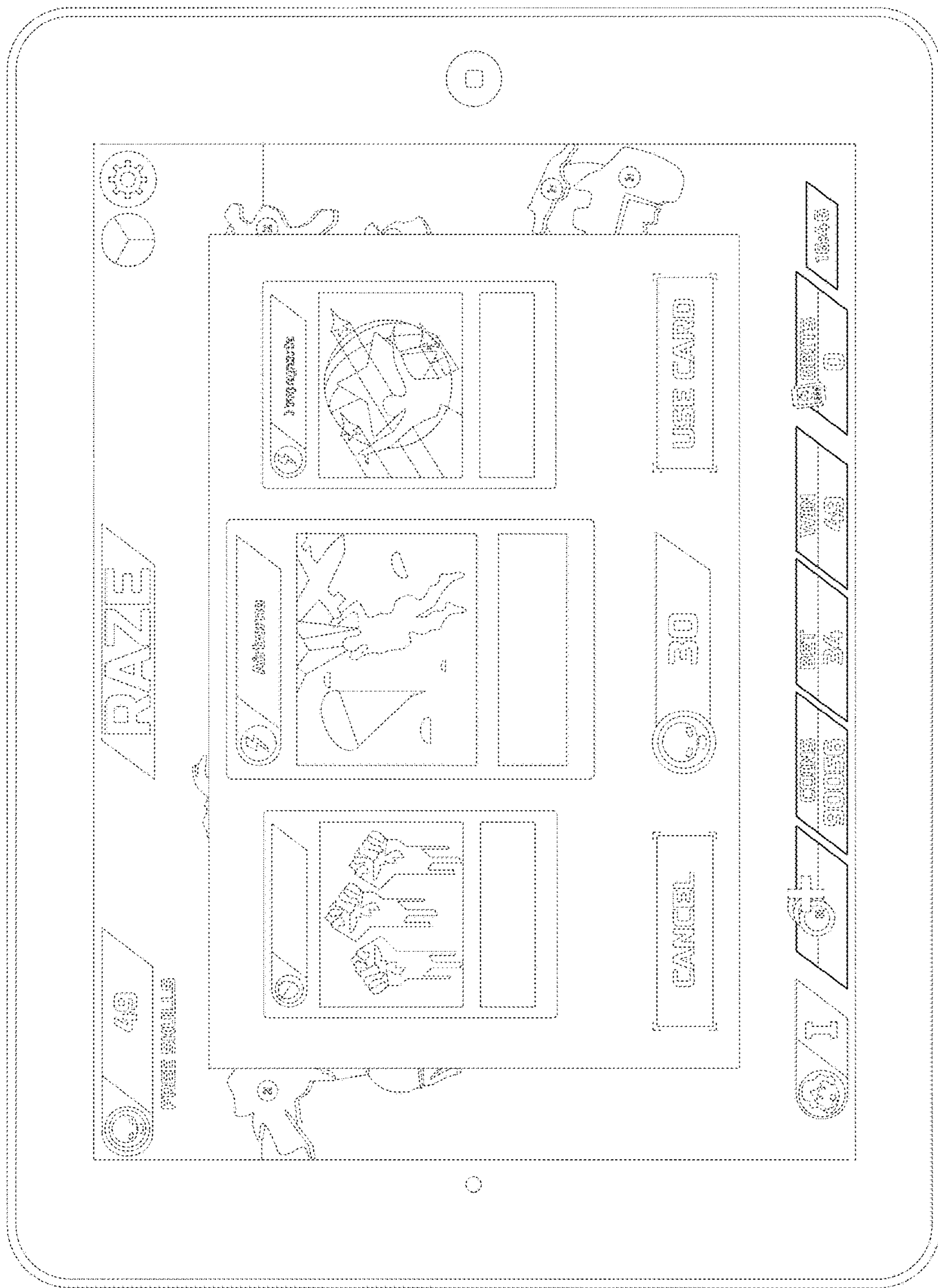
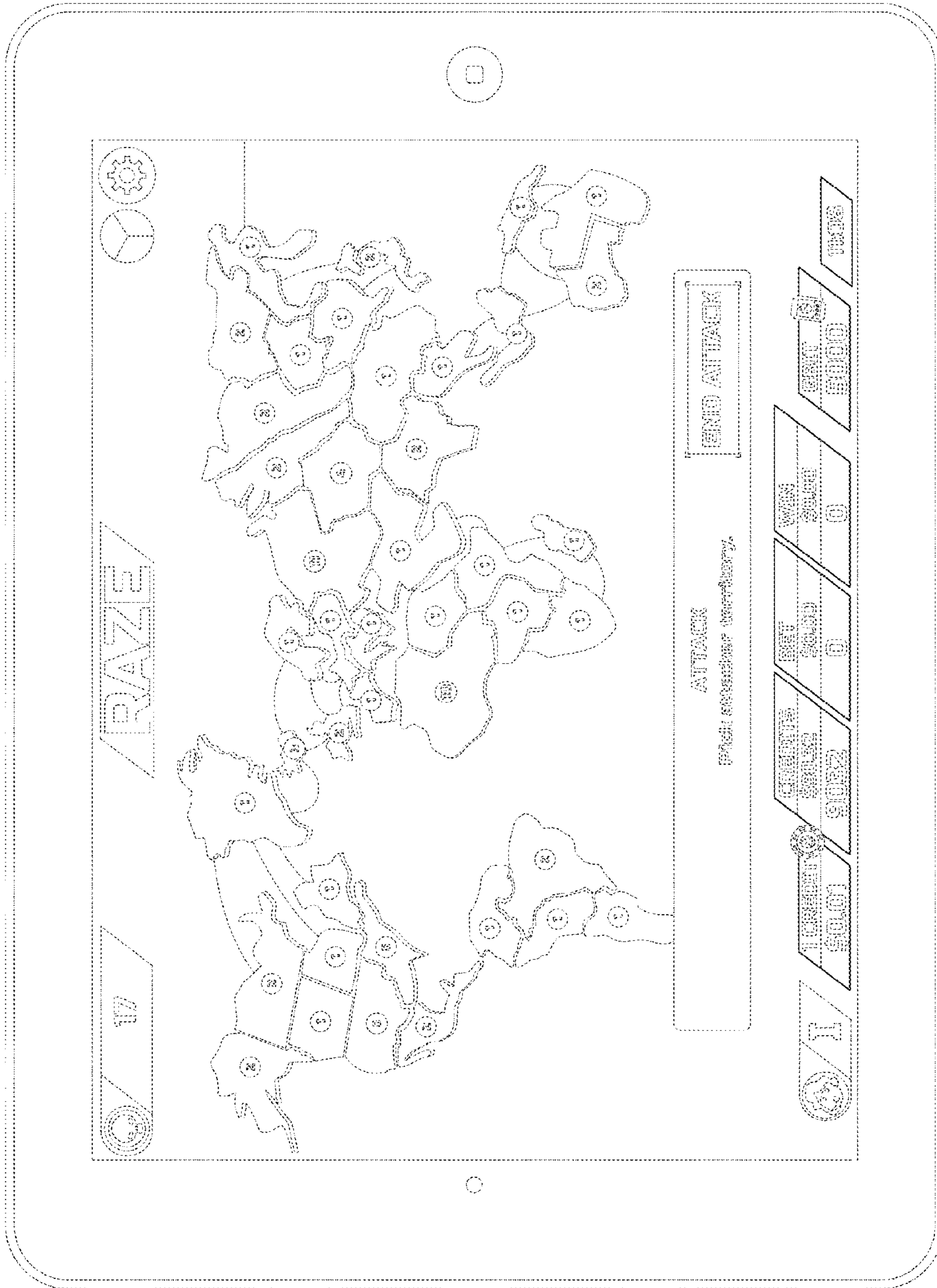

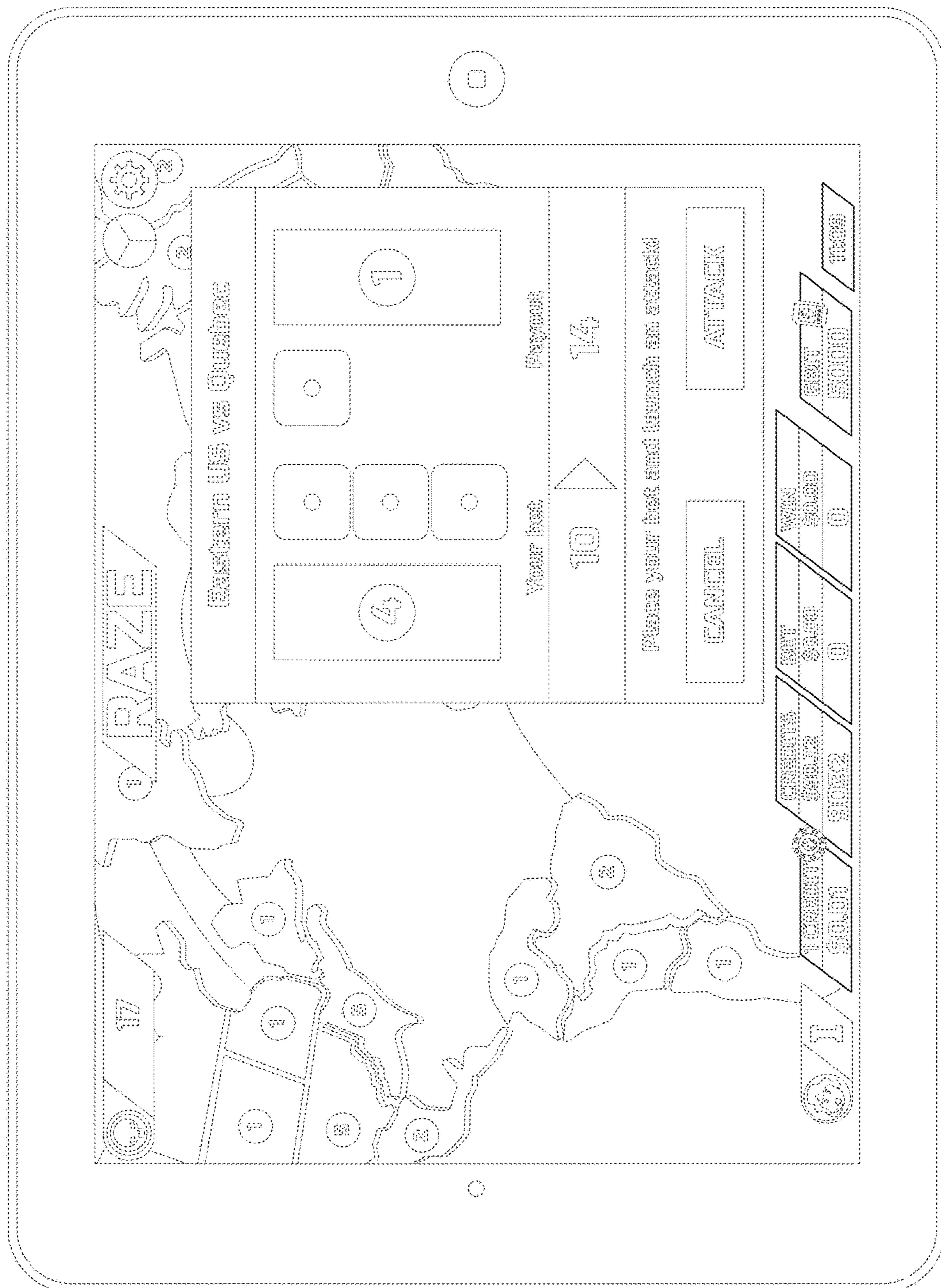

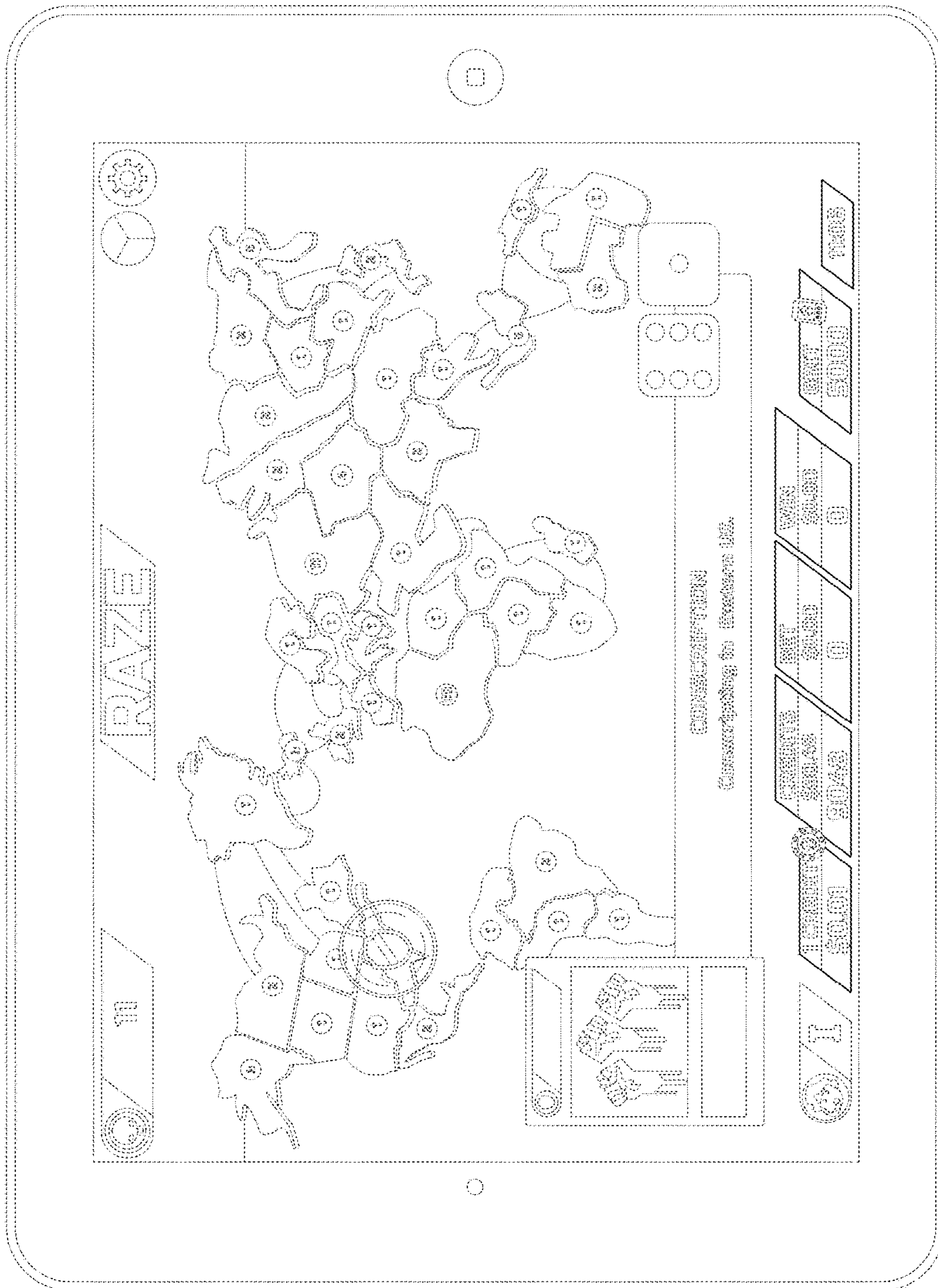

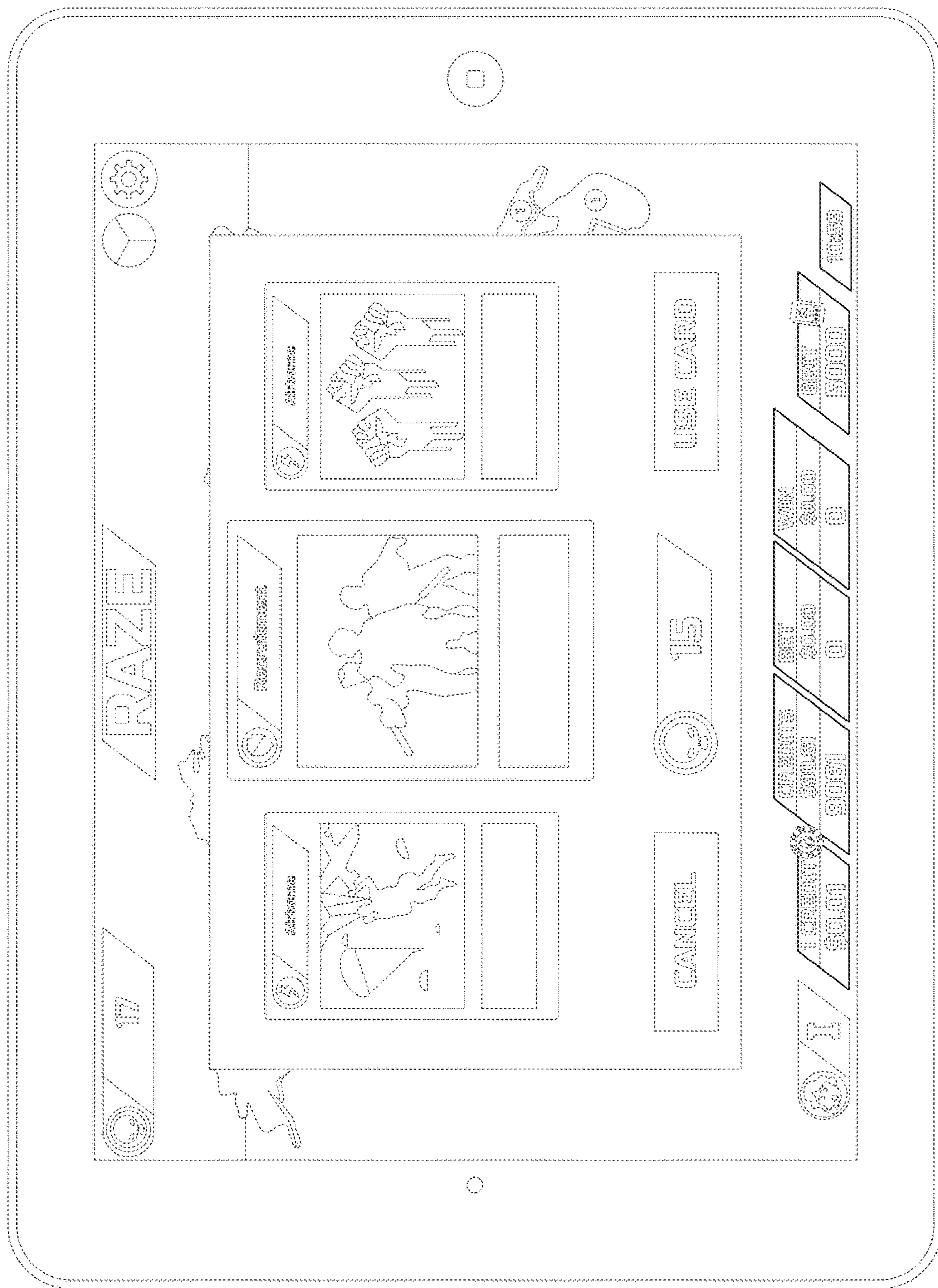

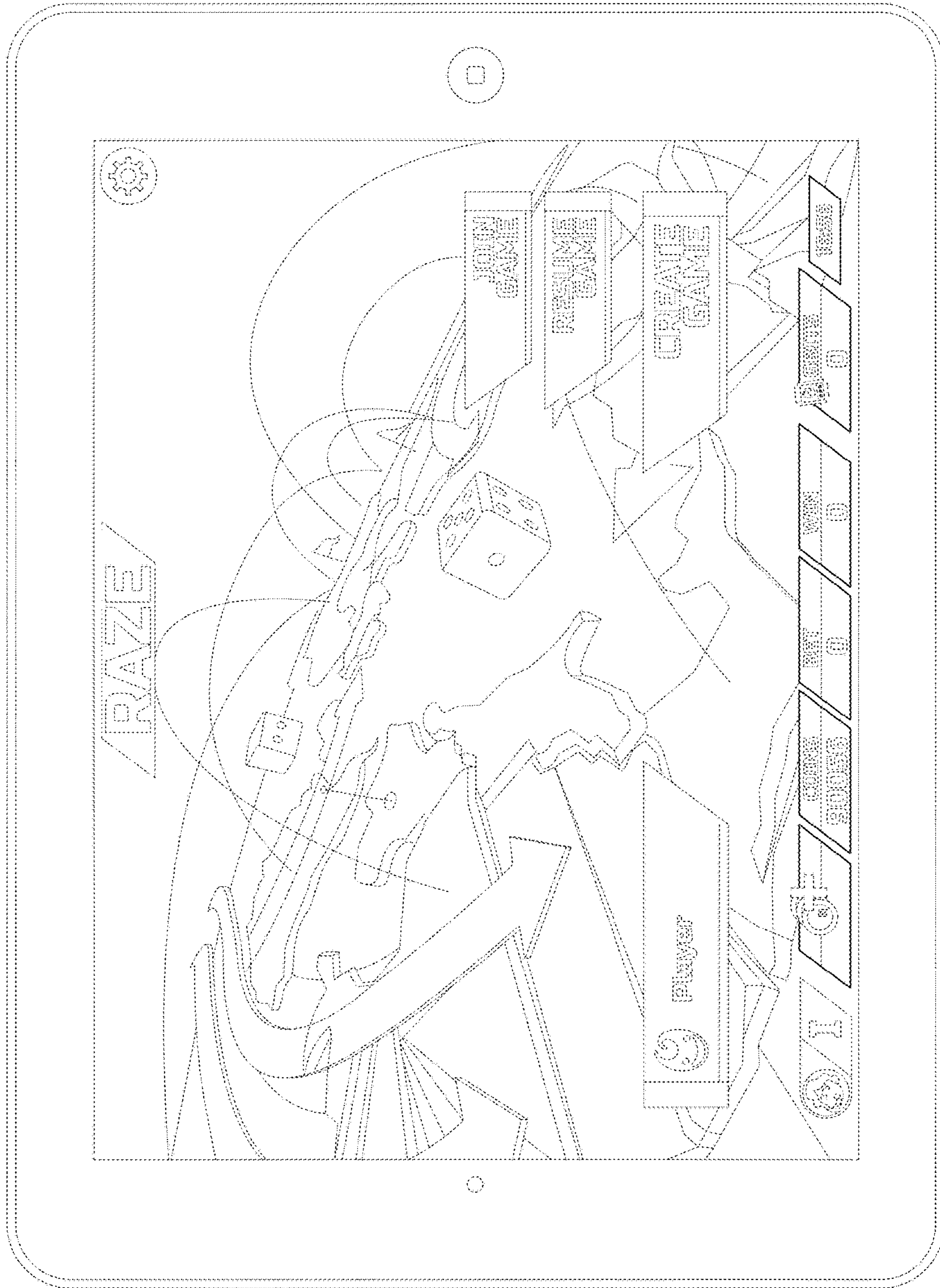

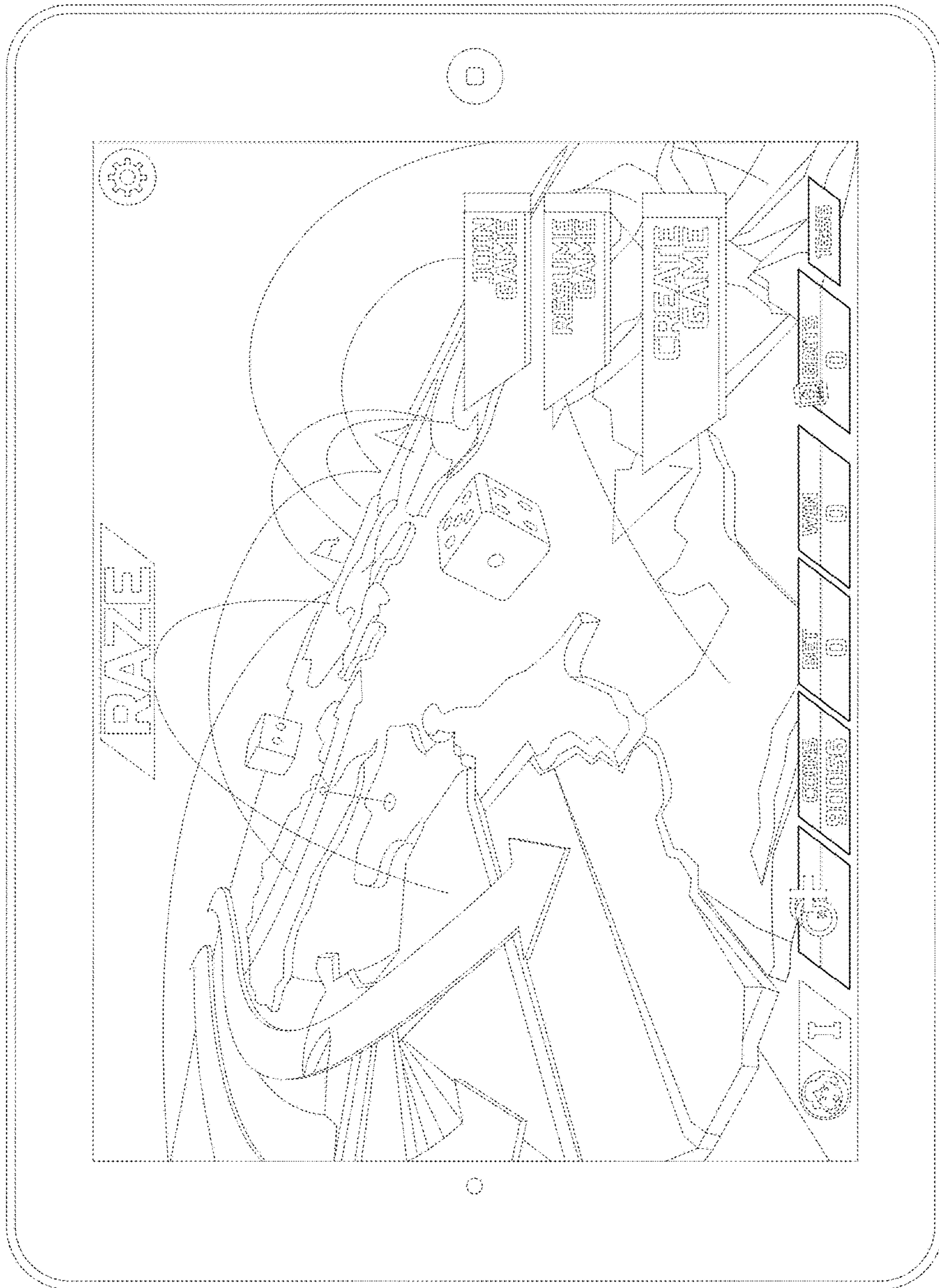

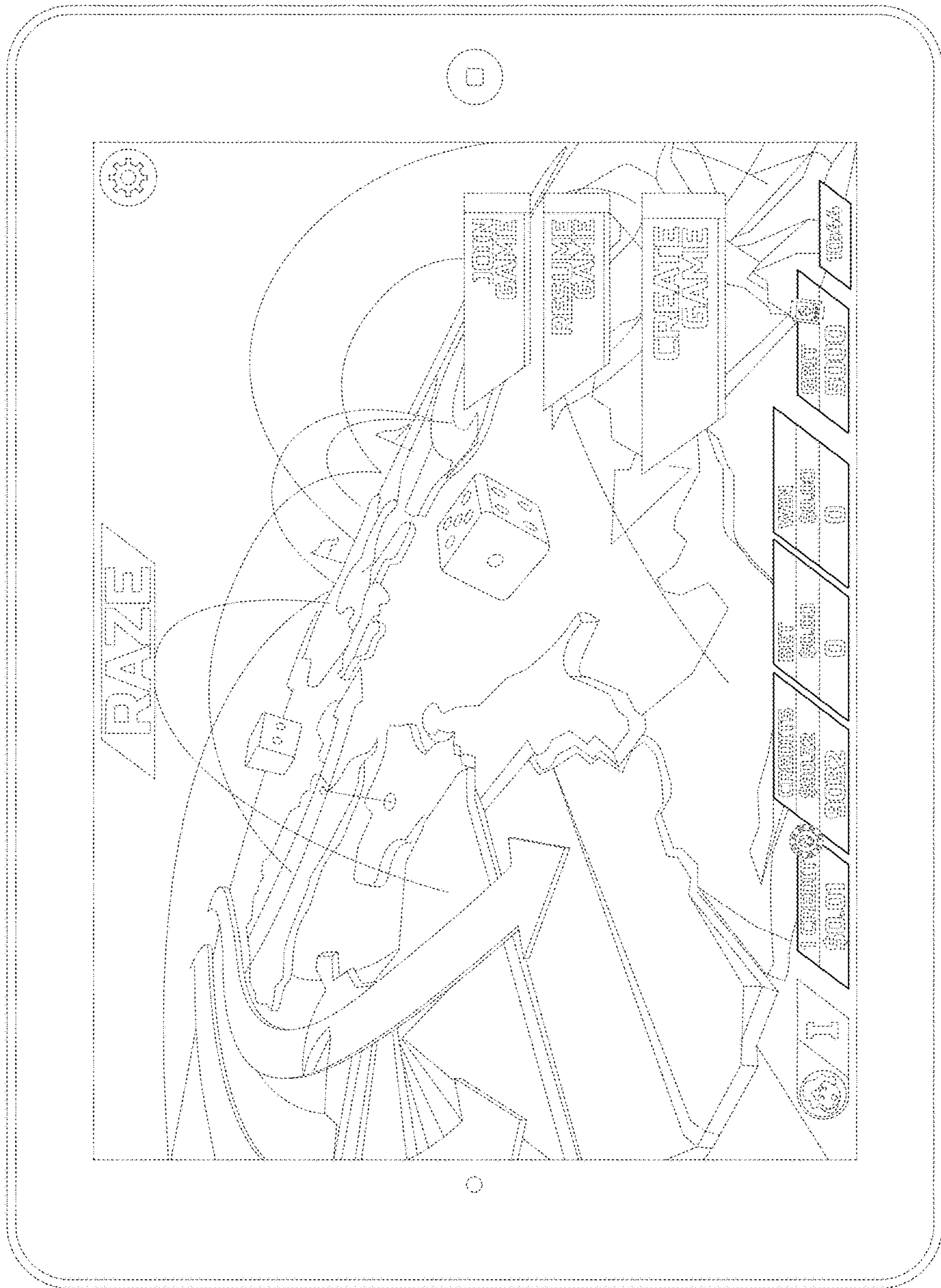

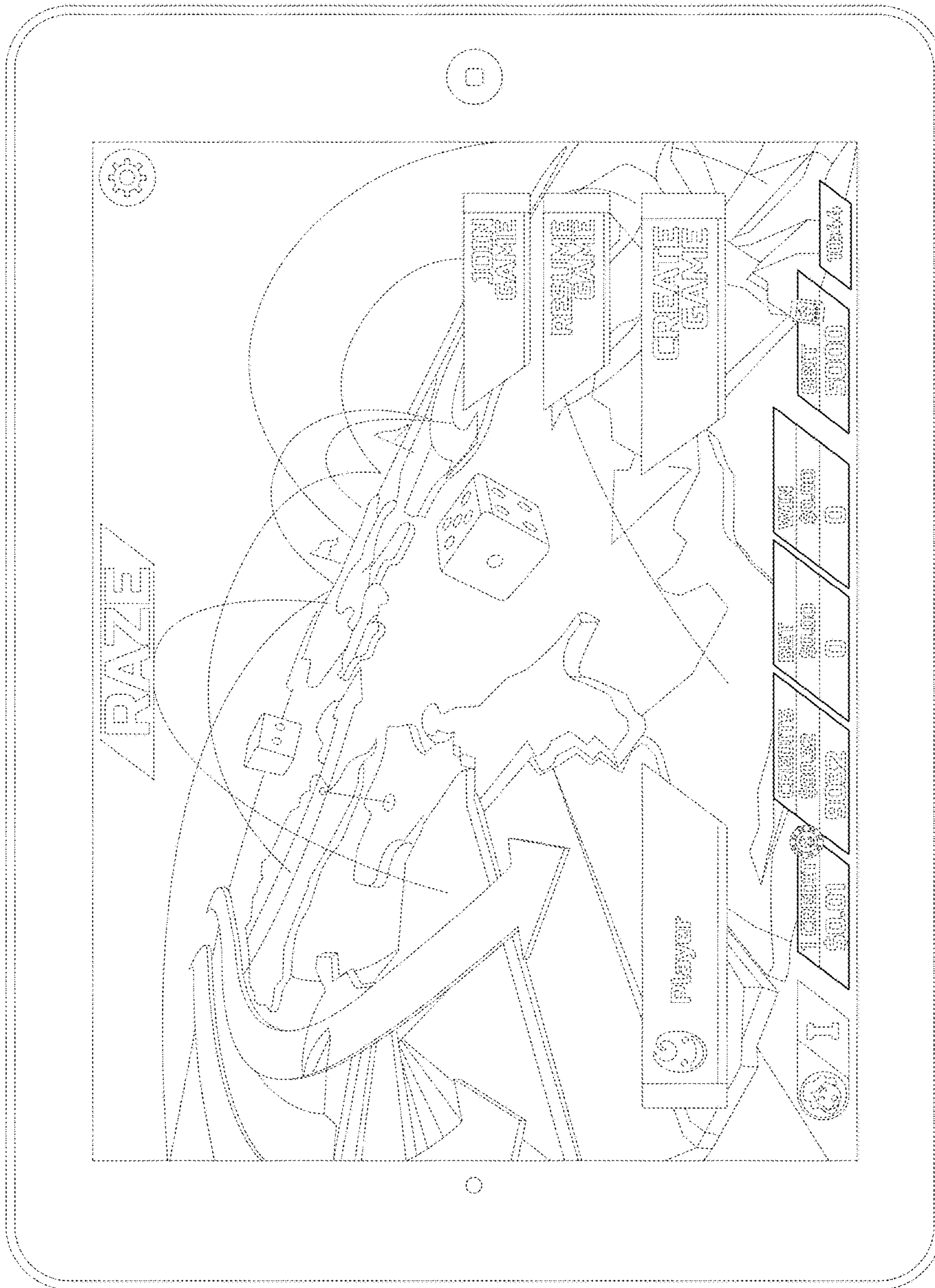
