(57) **CLAIM**

The ornamental design for the shoulder rest for musical instrument, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom perspective view of a shoulder rest for musical instrument with the forks positioned in a retracted and open posture;

FIG. 2 is a bottom perspective view of the shoulder rest for musical instrument with the forks positioned in an extended and open posture;

FIG. 3 is a bottom view of the shoulder rest of FIG. 1;

FIG. 4 is a bottom view of the shoulder rest of FIG. 2;

FIG. 5 is a side view of the shoulder rest of FIG. 1;

FIG. 6 is a side view of the shoulder rest of FIG. 2;

FIG. 7 is an end view of the shoulder rest of FIG. 1;

FIG. 8 is an end view of the shoulder rest of FIG. 2;

FIG. 9 is a top view of the shoulder rest of FIG. 1;

FIG. 10 is a top view of the shoulder rest of FIG. 2;

FIG. 11 is a top perspective view of the shoulder rest of FIG. 1;

FIG. 12 is a top perspective view of the shoulder rest of FIG. 2;

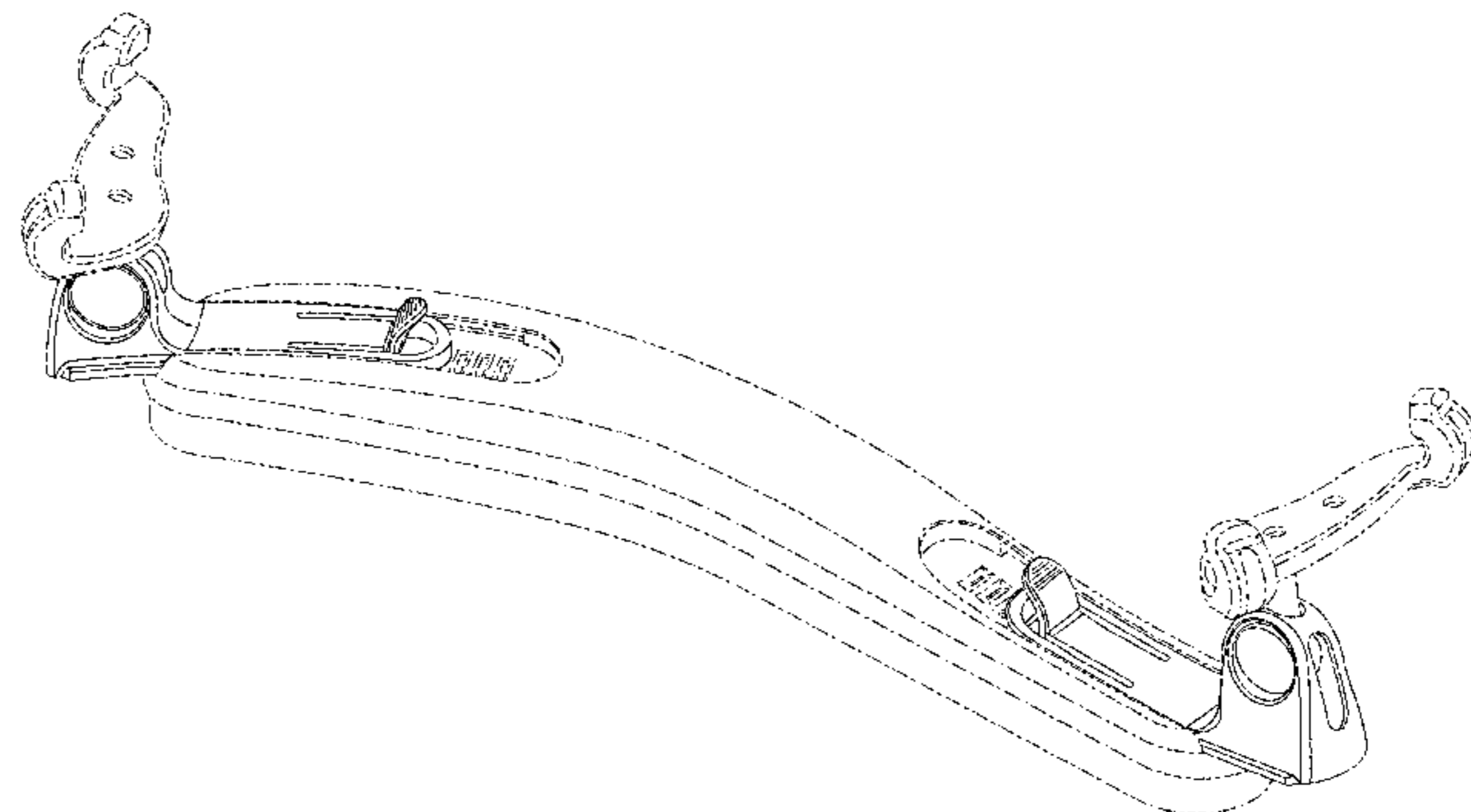
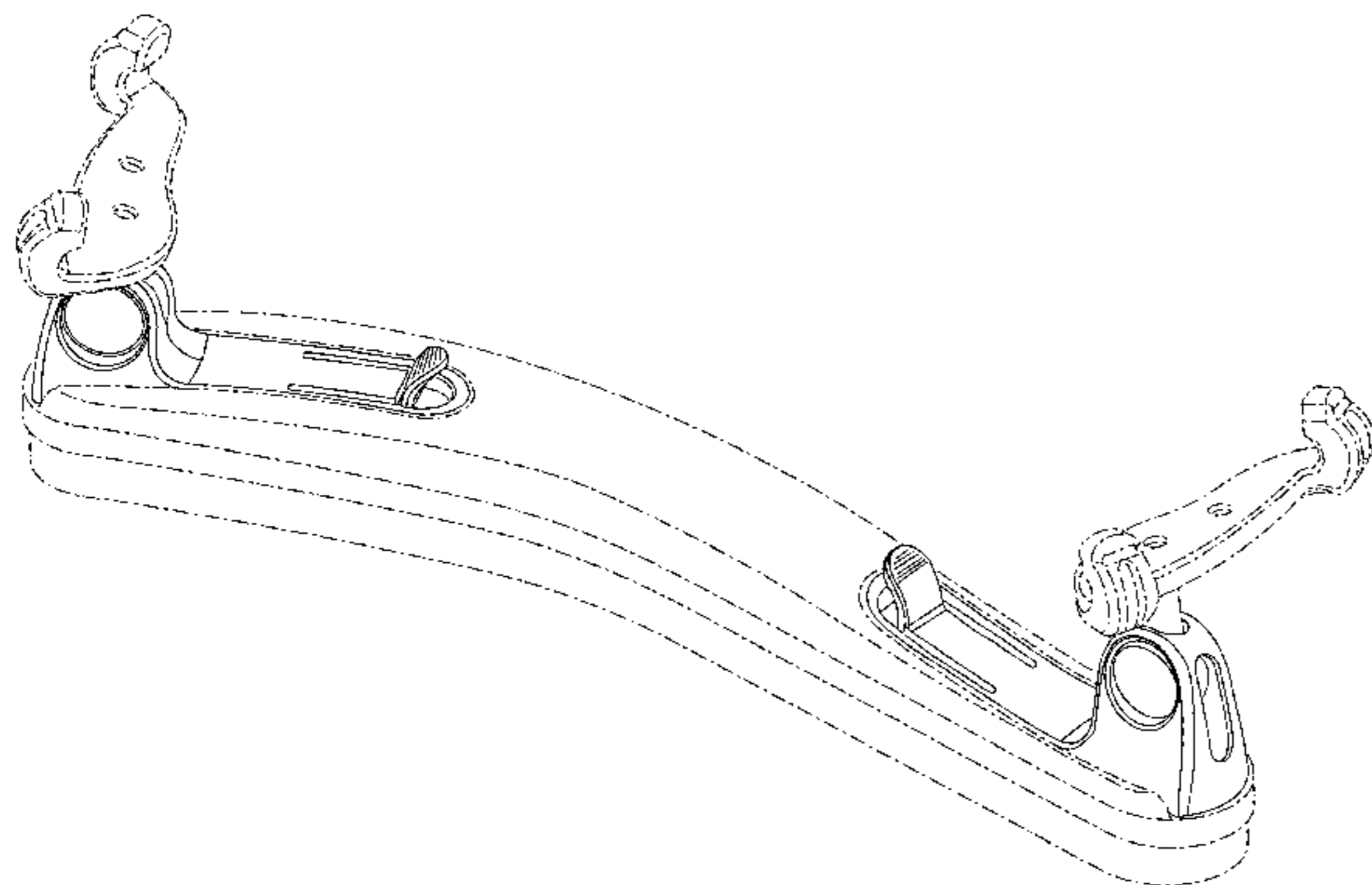
FIG. 13 is a top perspective view of the shoulder rest with the forks in a folded posture;

FIG. 14 is a bottom perspective view of the shoulder rest with the forks in the folded posture; and,

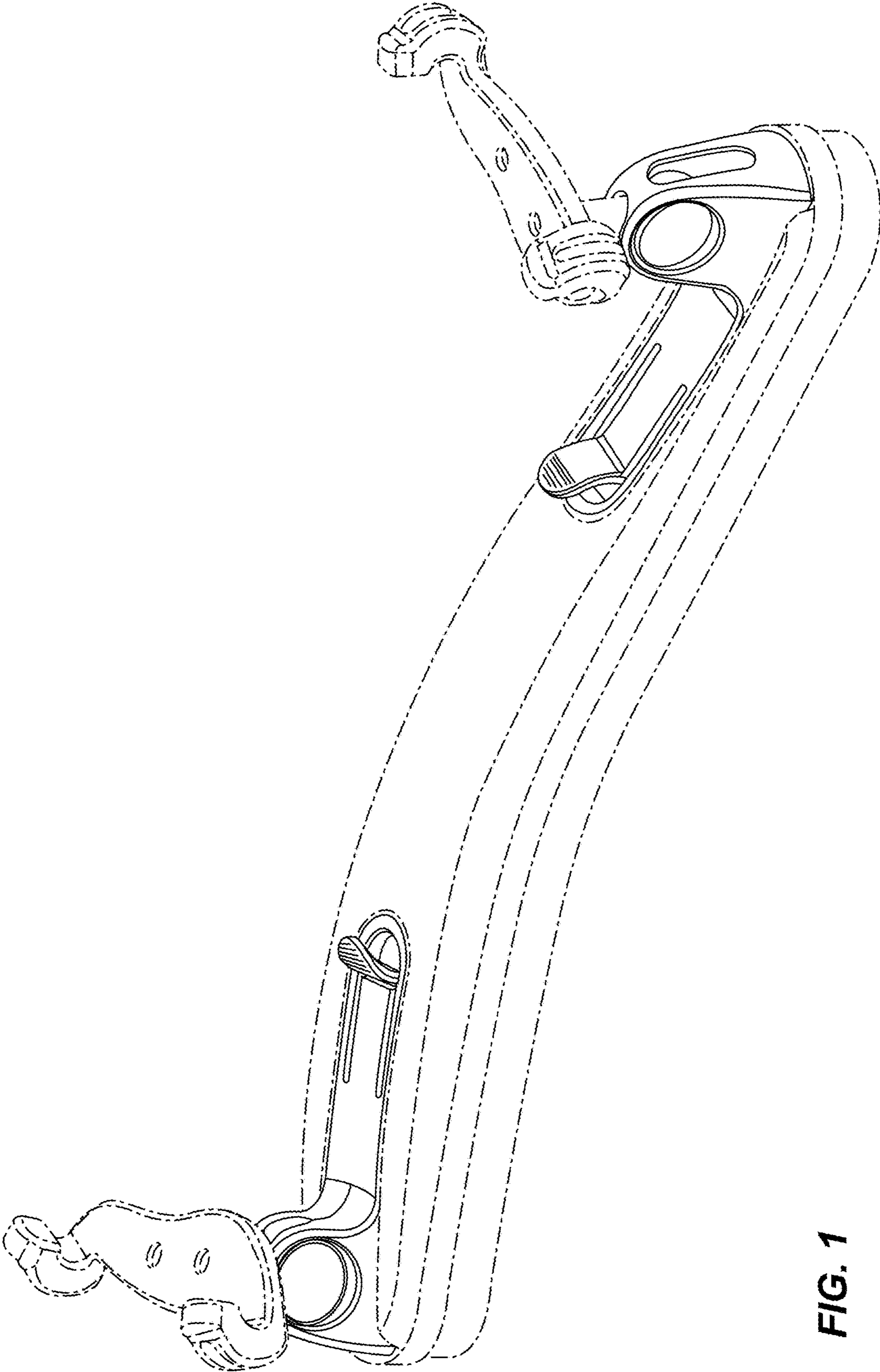

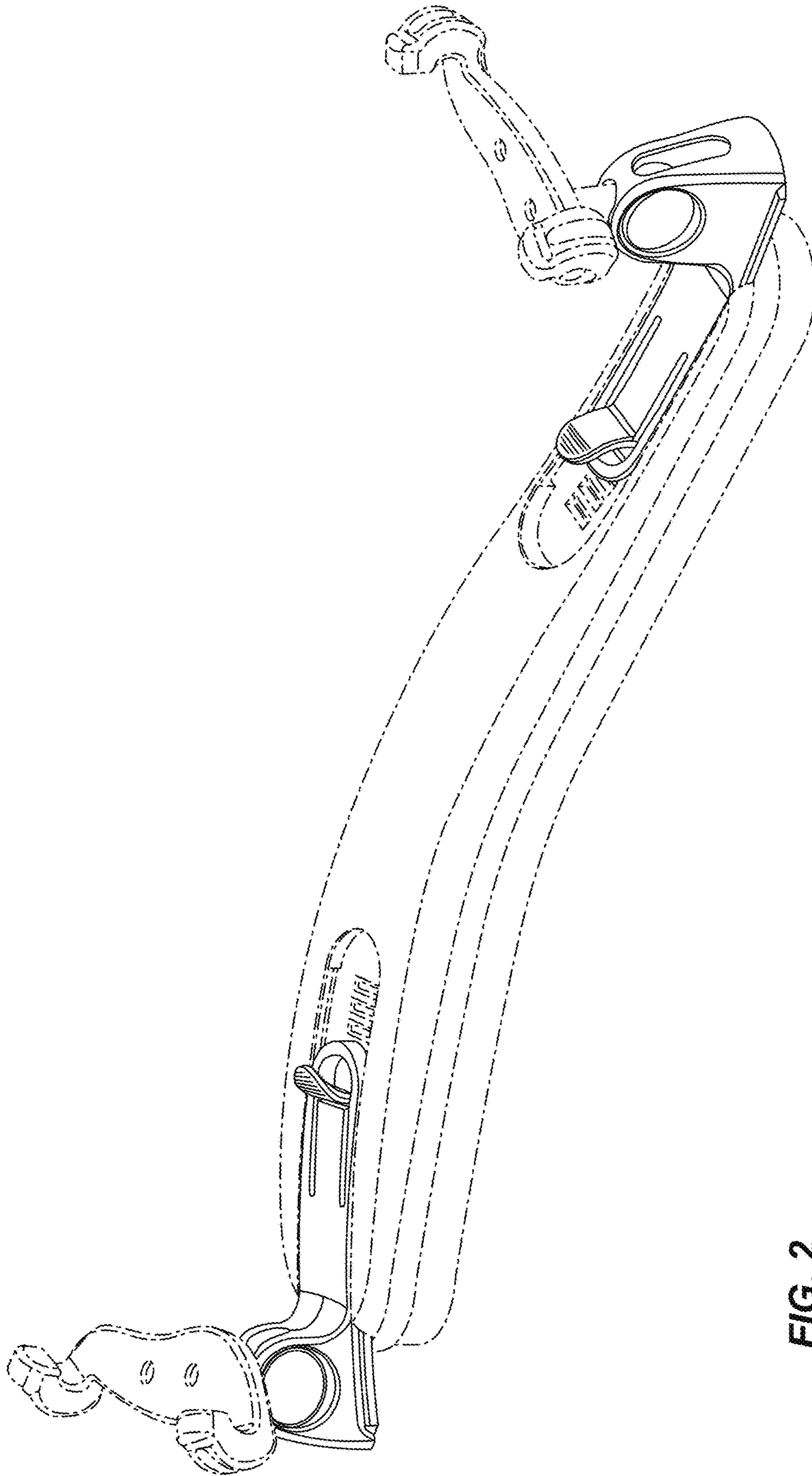
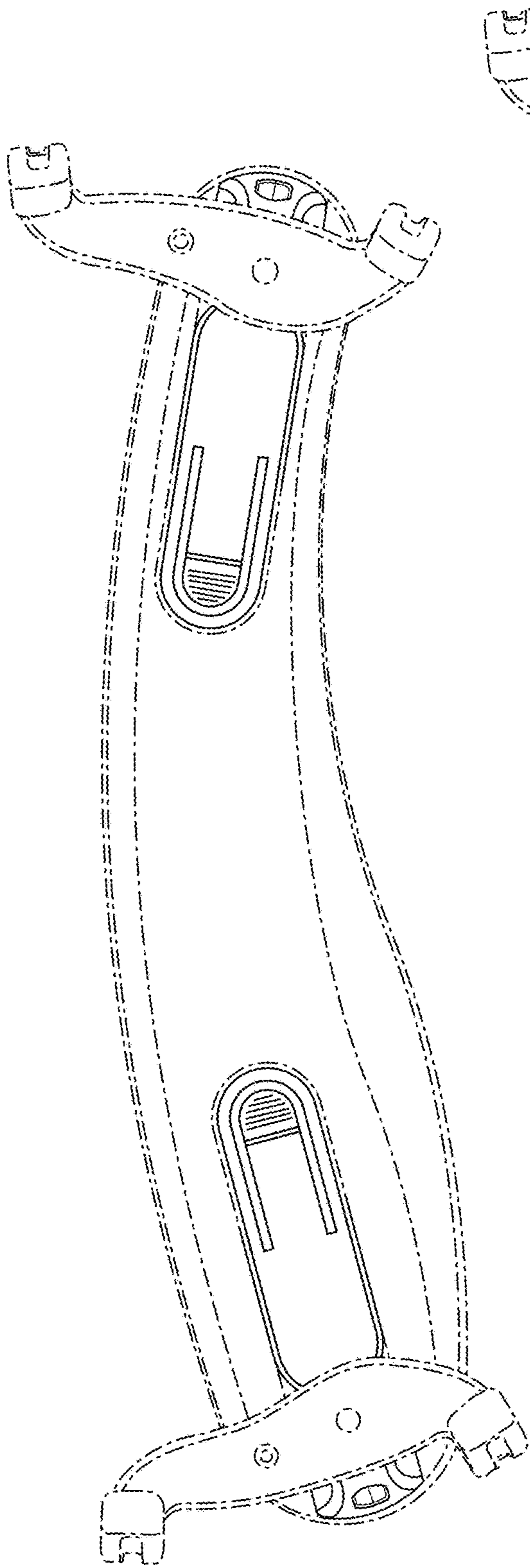
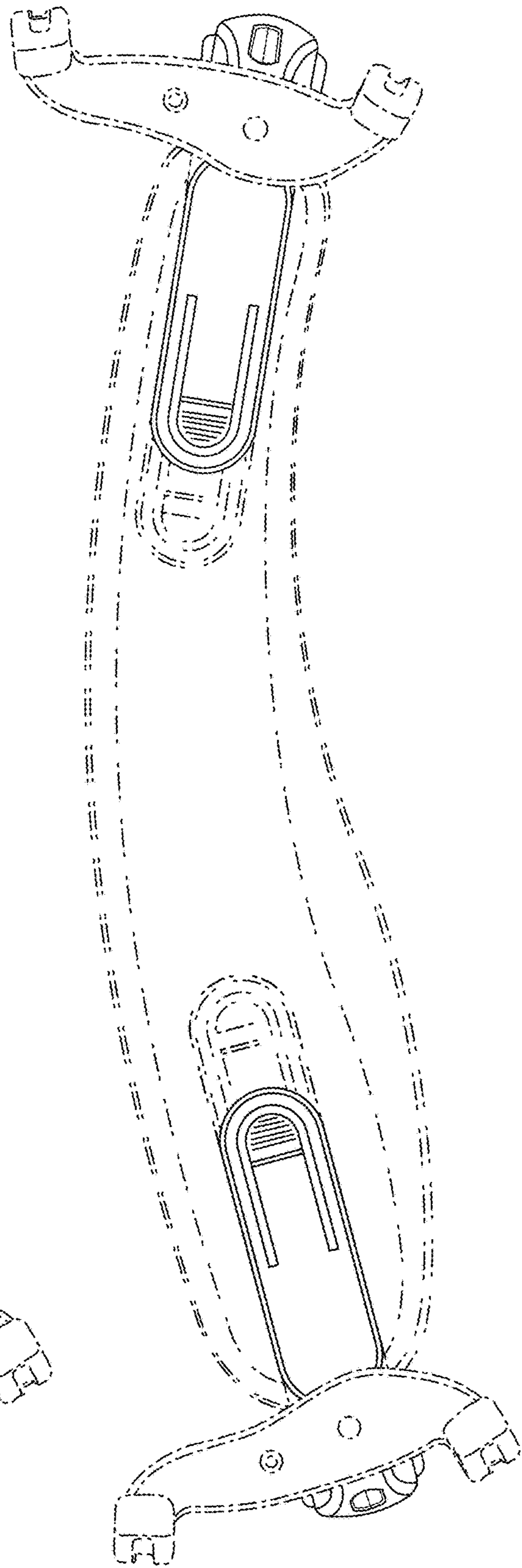

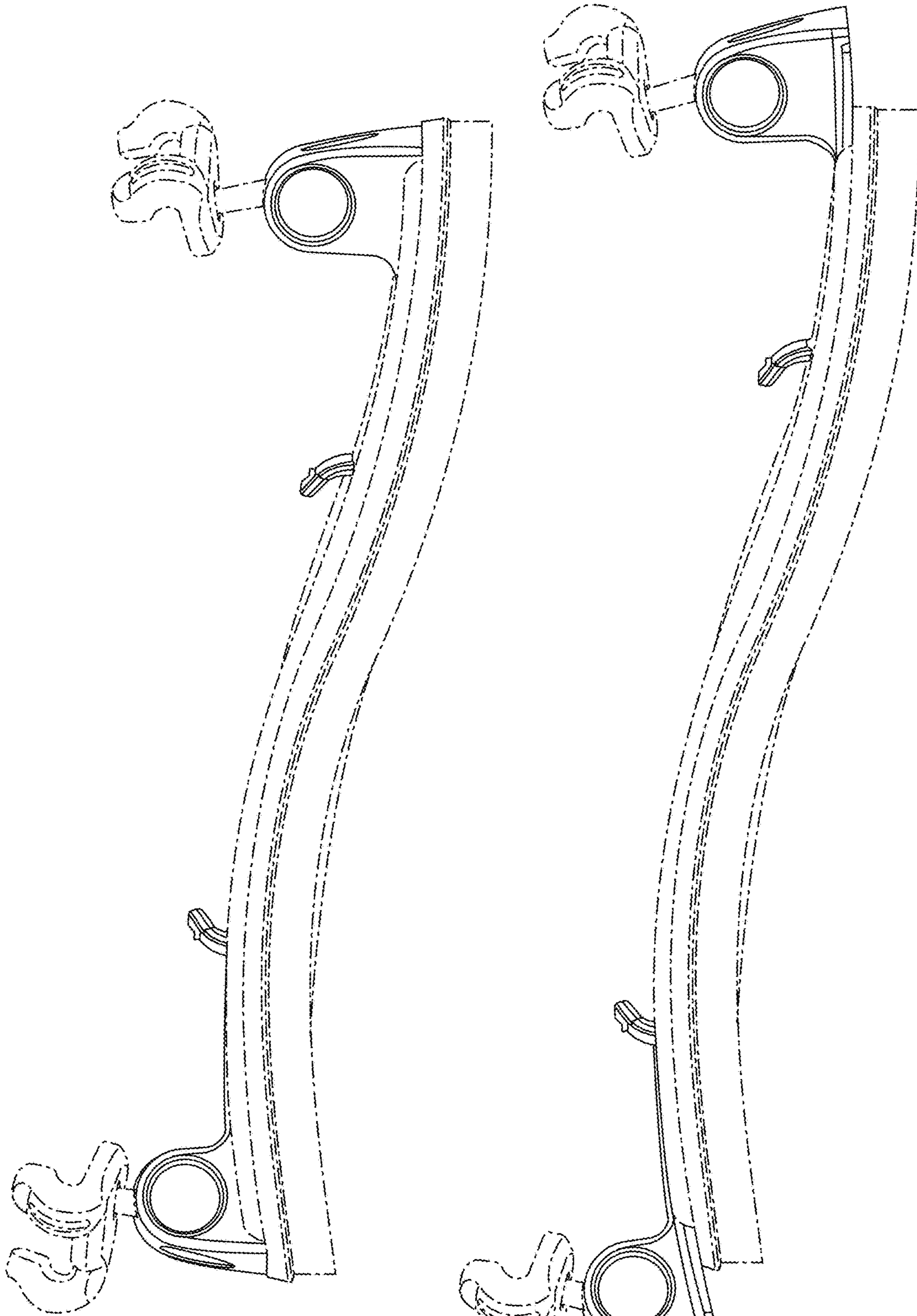

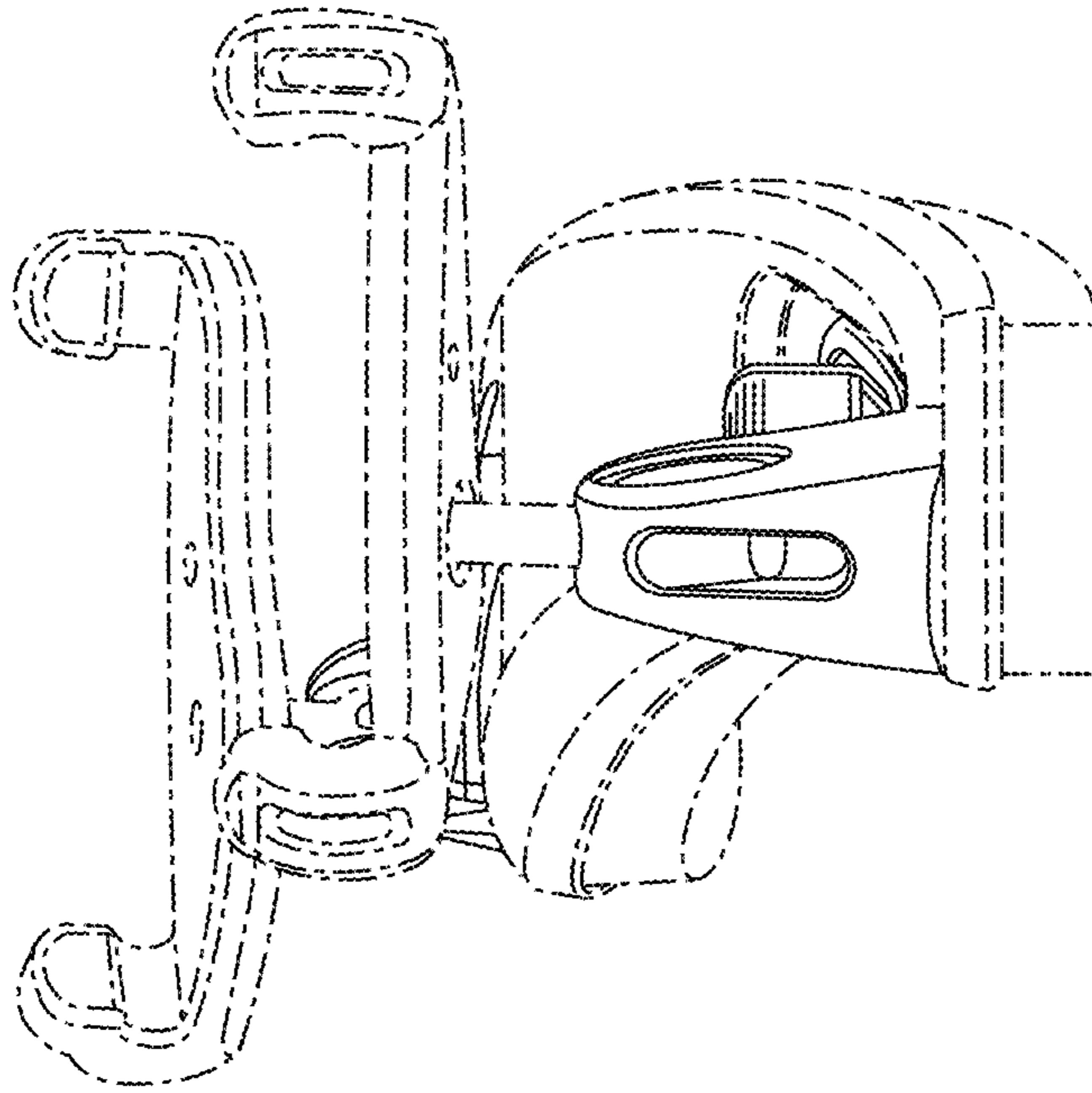

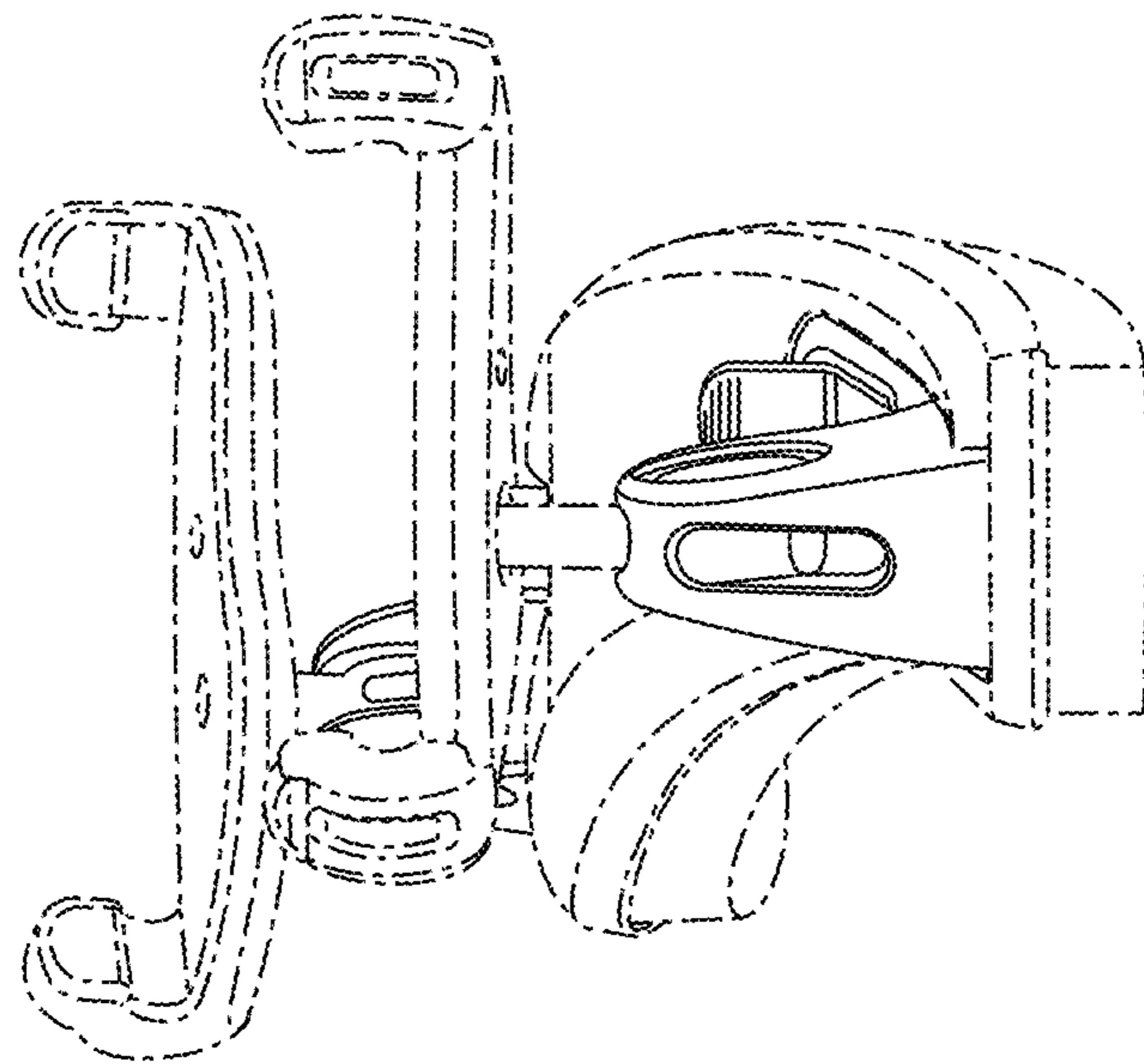

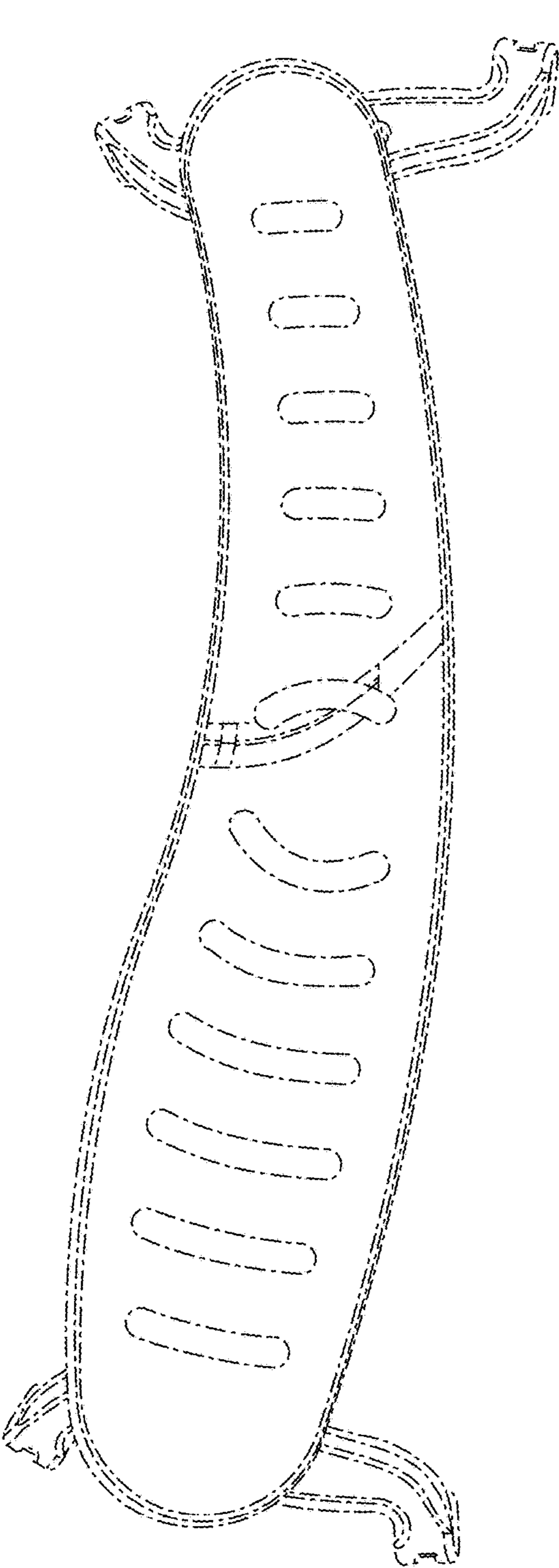

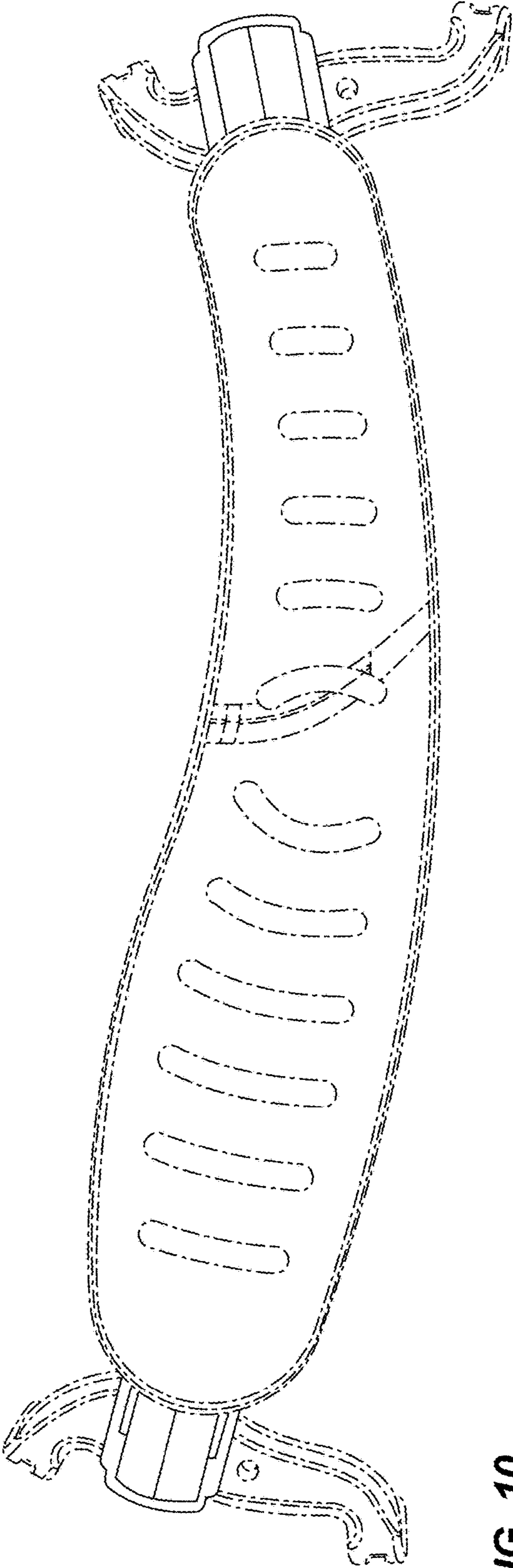

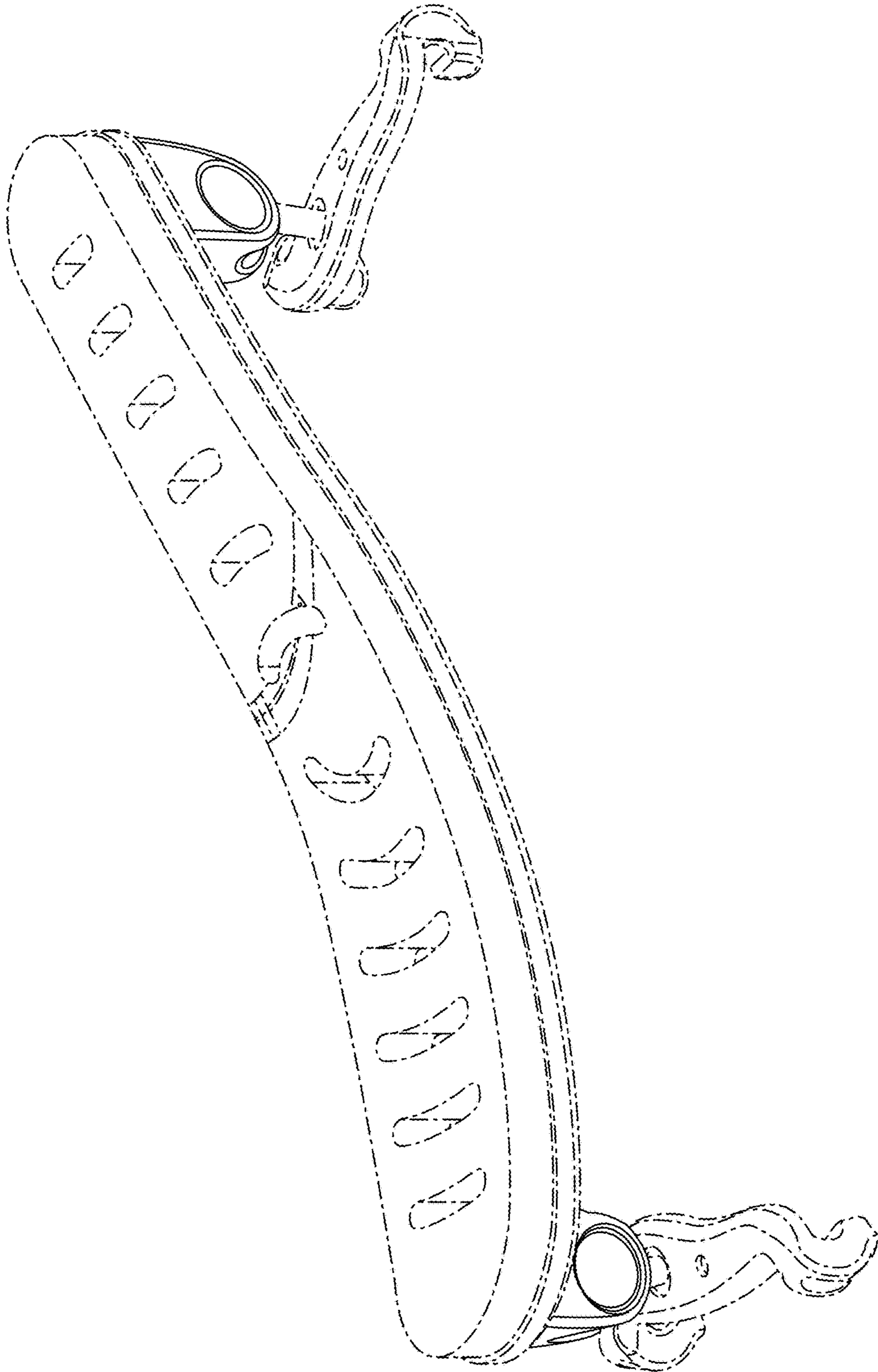

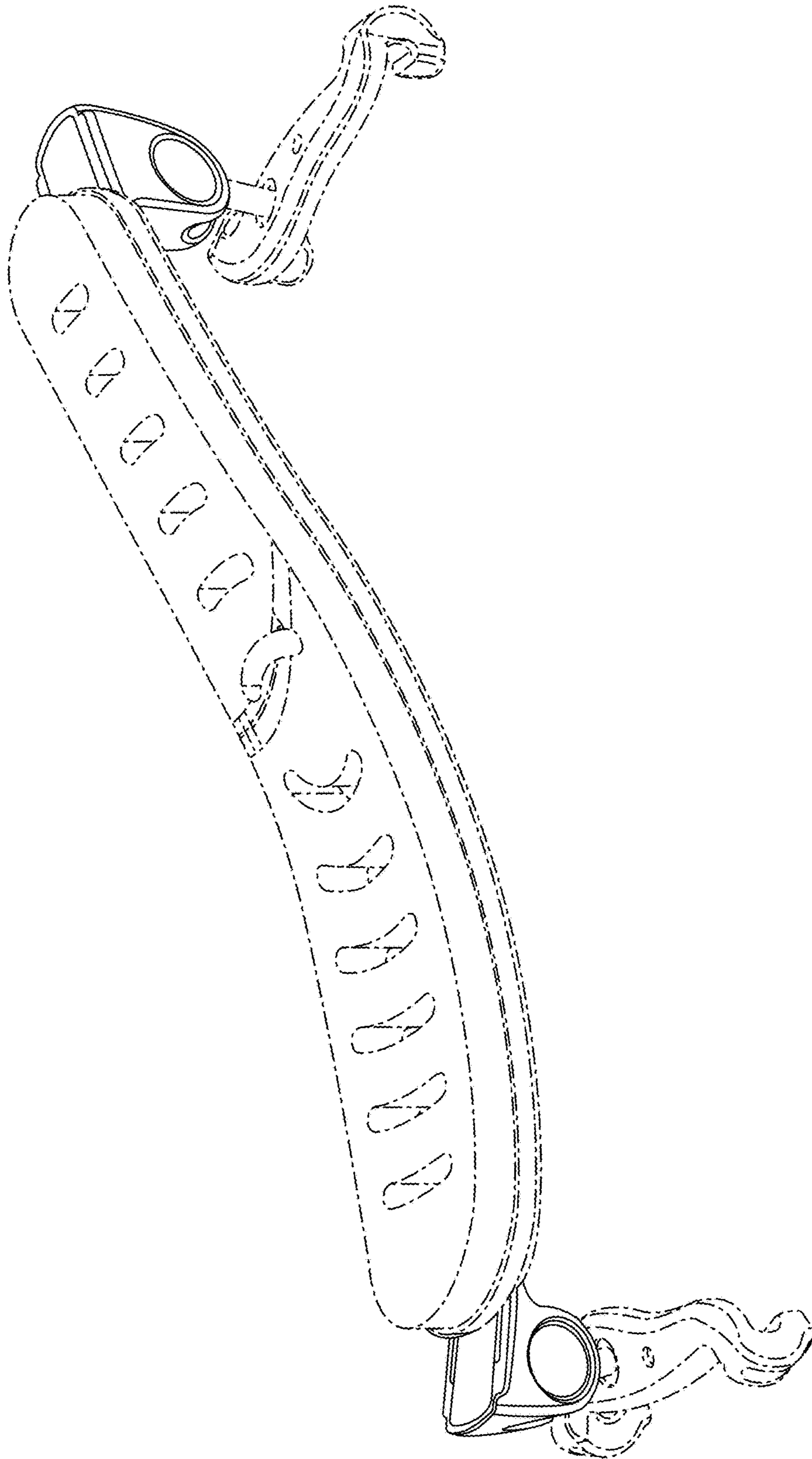

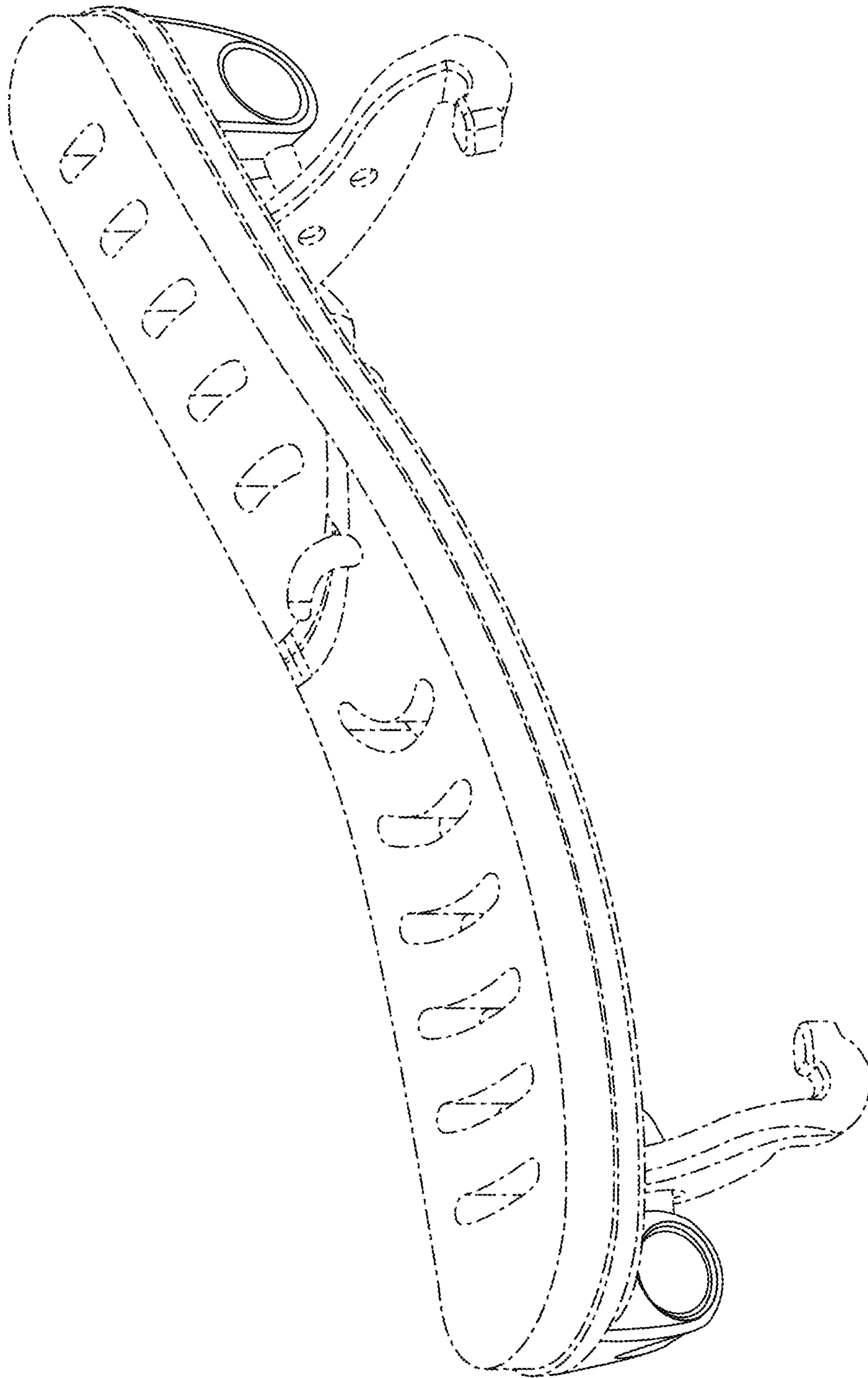

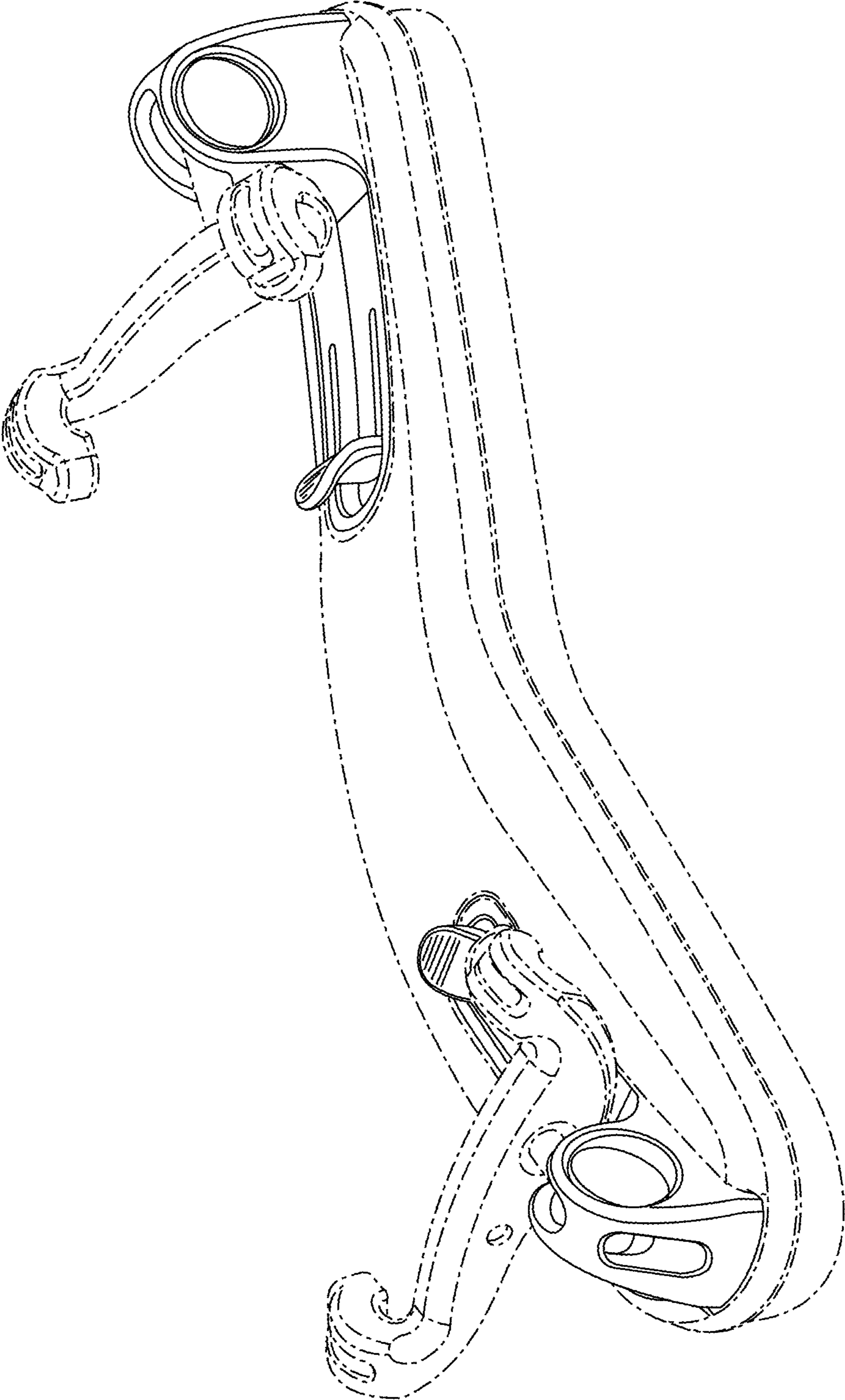

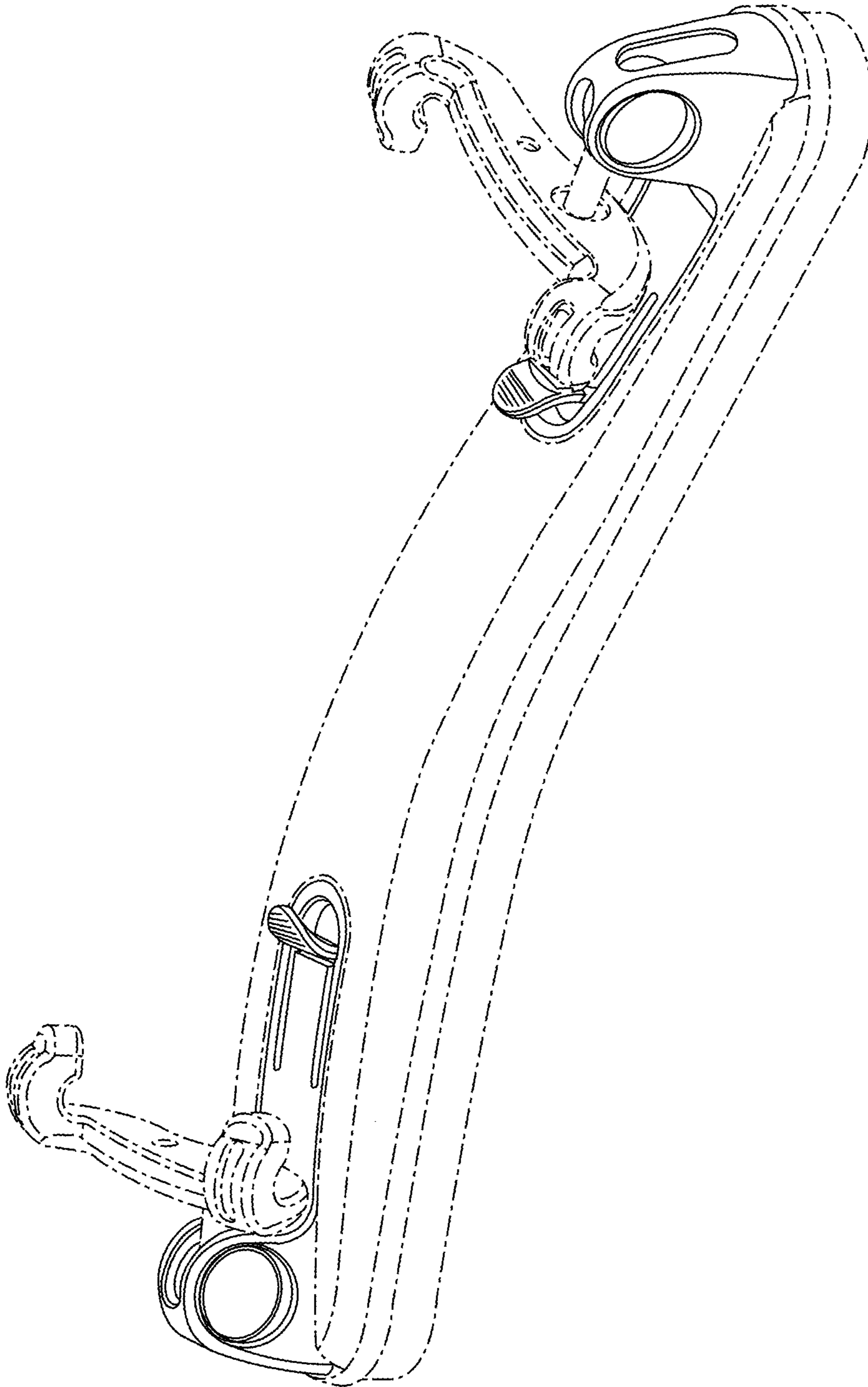
