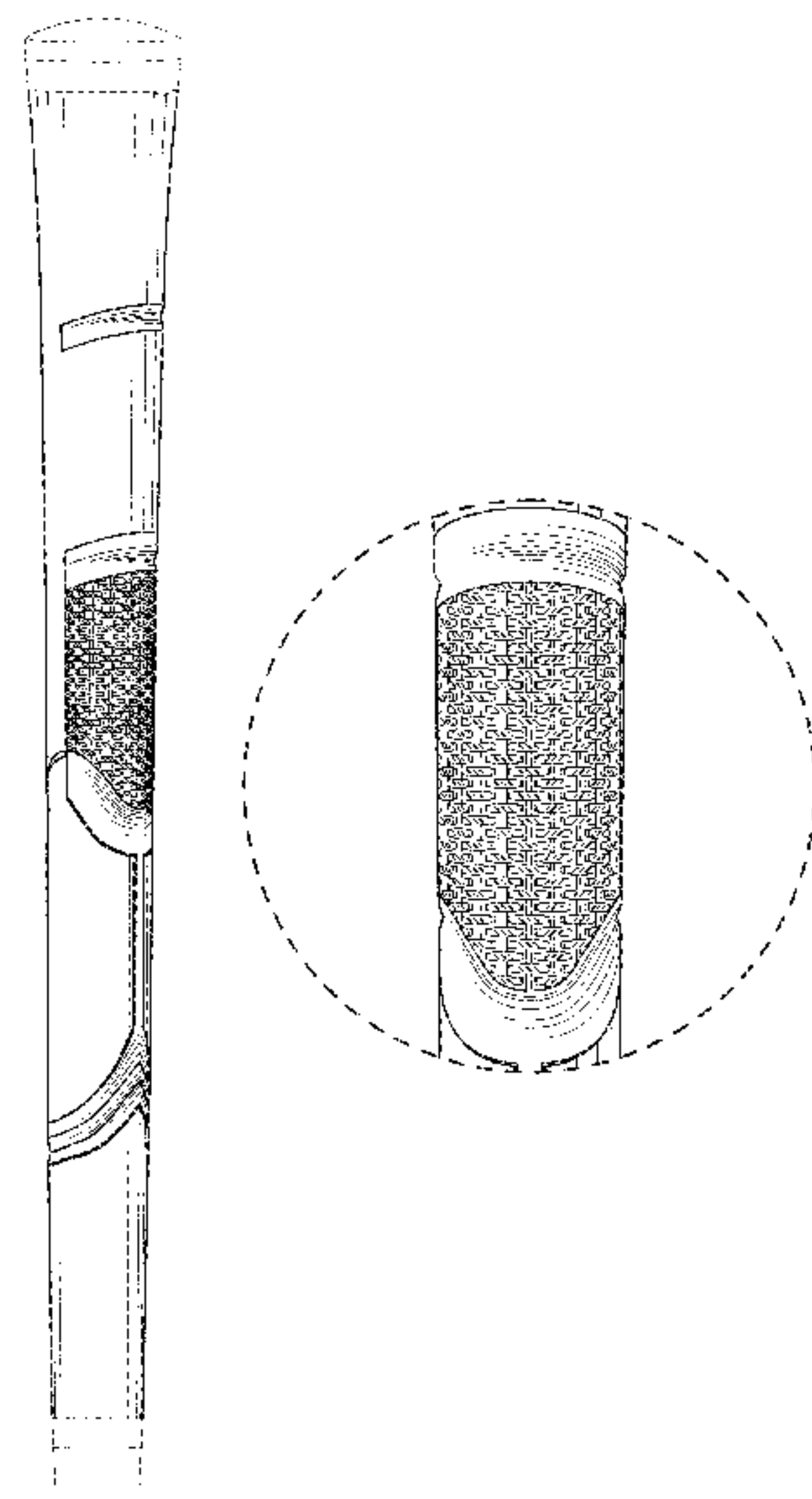
(57) **CLAIM**

The ornamental design for a golf grip, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a golf grip; FIG. 2 is a front view of the golf grip; FIG. 3 is a rear view of the golf grip; FIG. 4 is a right side view of the golf grip; FIG. 5 is a left side view of the golf grip; FIG. 6 is a top view of the golf grip; FIG. 7 is a bottom view of the golf grip; and, FIG. 8 is a detailed view of a portion of the golf grip. The broken lines shown are for the purpose of illustrating the tip and the cap of the golf grip and form no part of the claimed design.

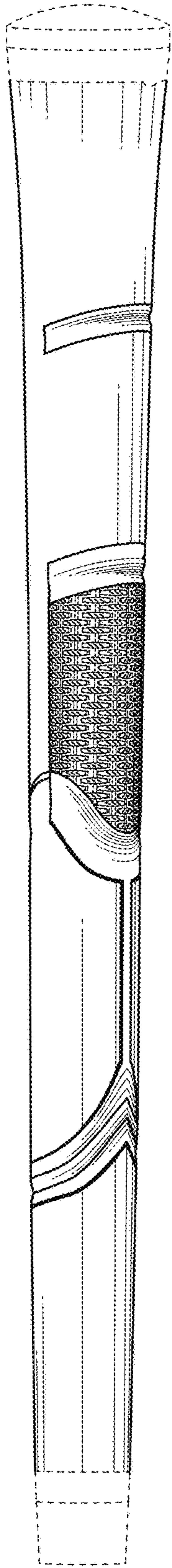

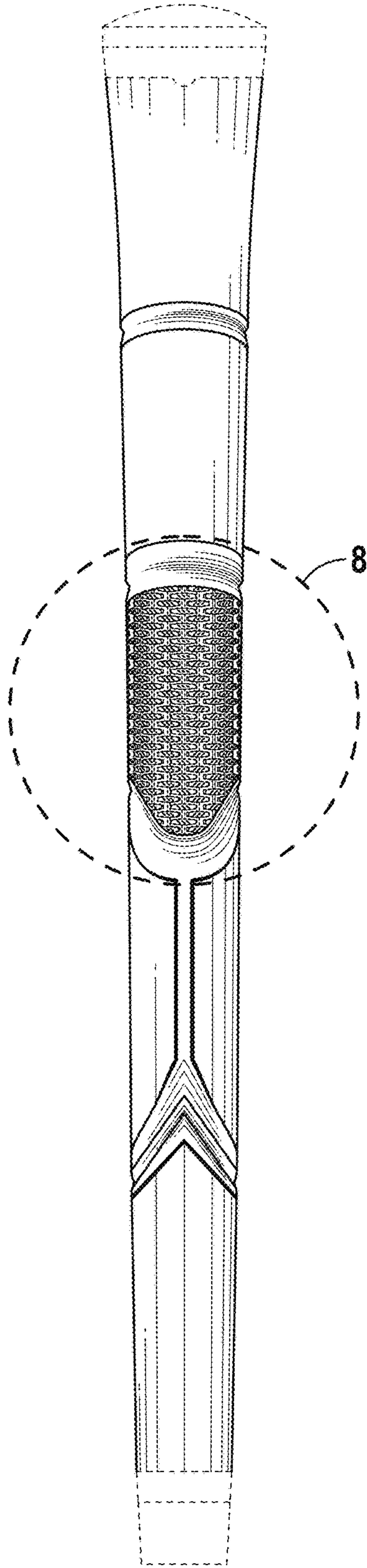

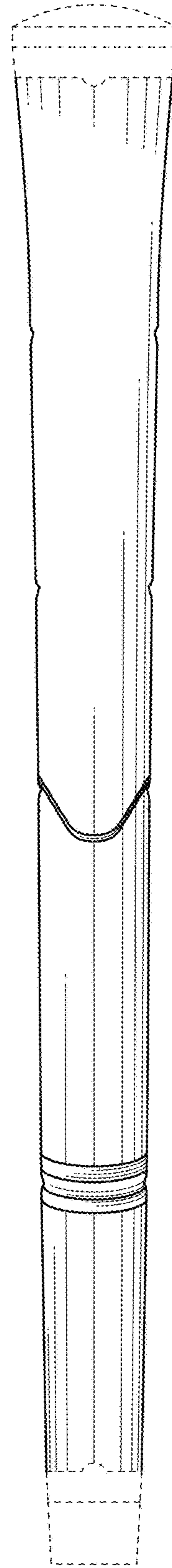

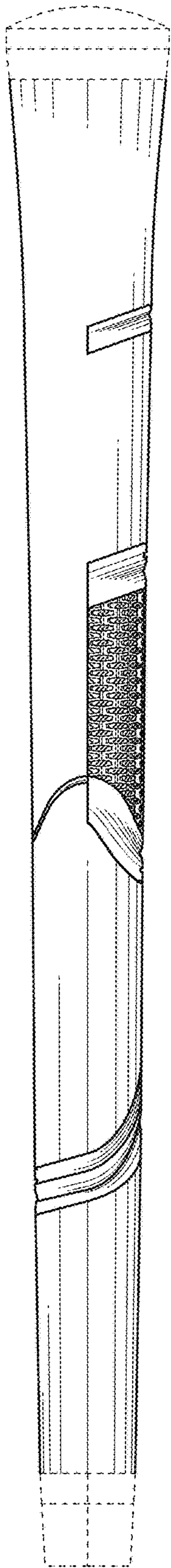

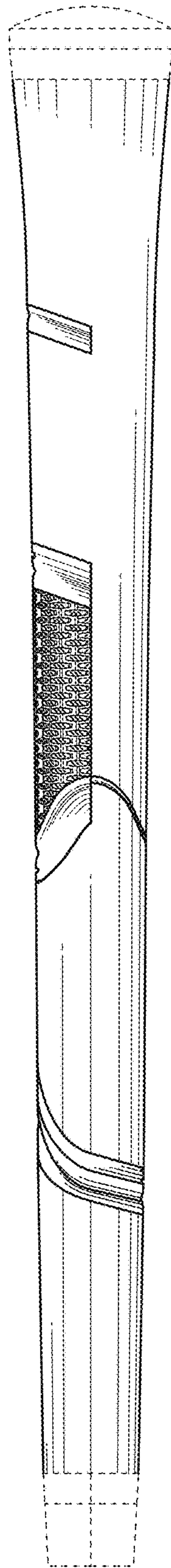

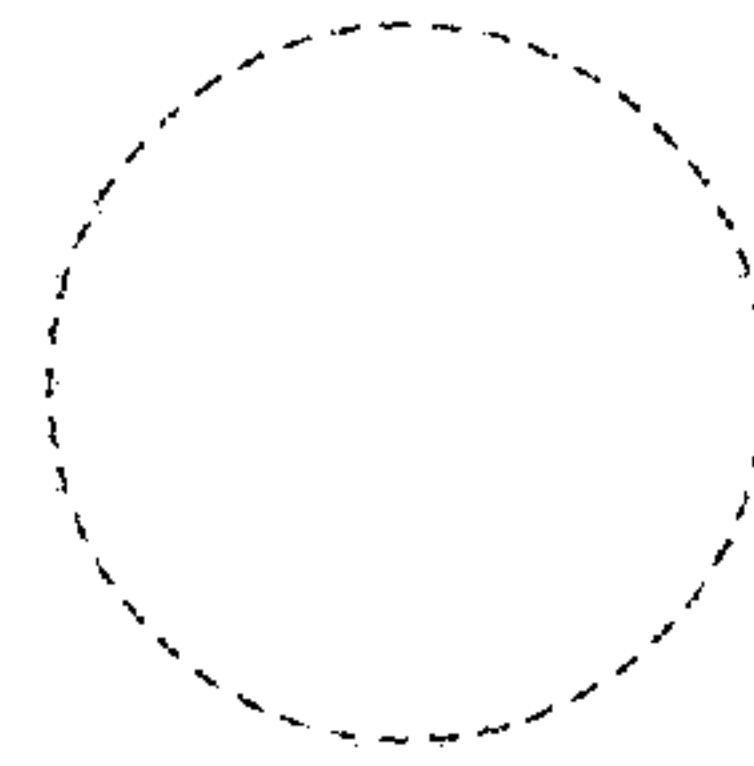

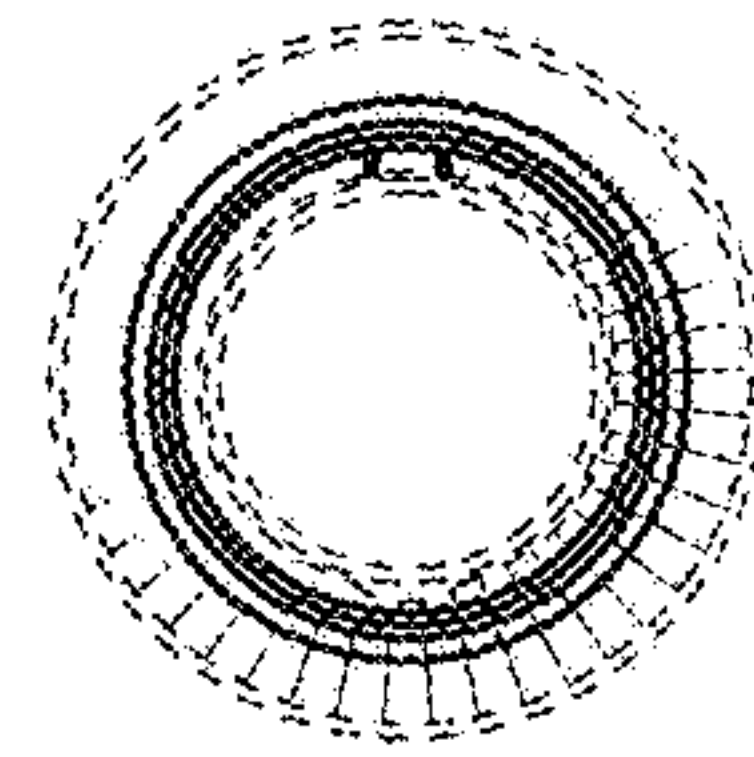

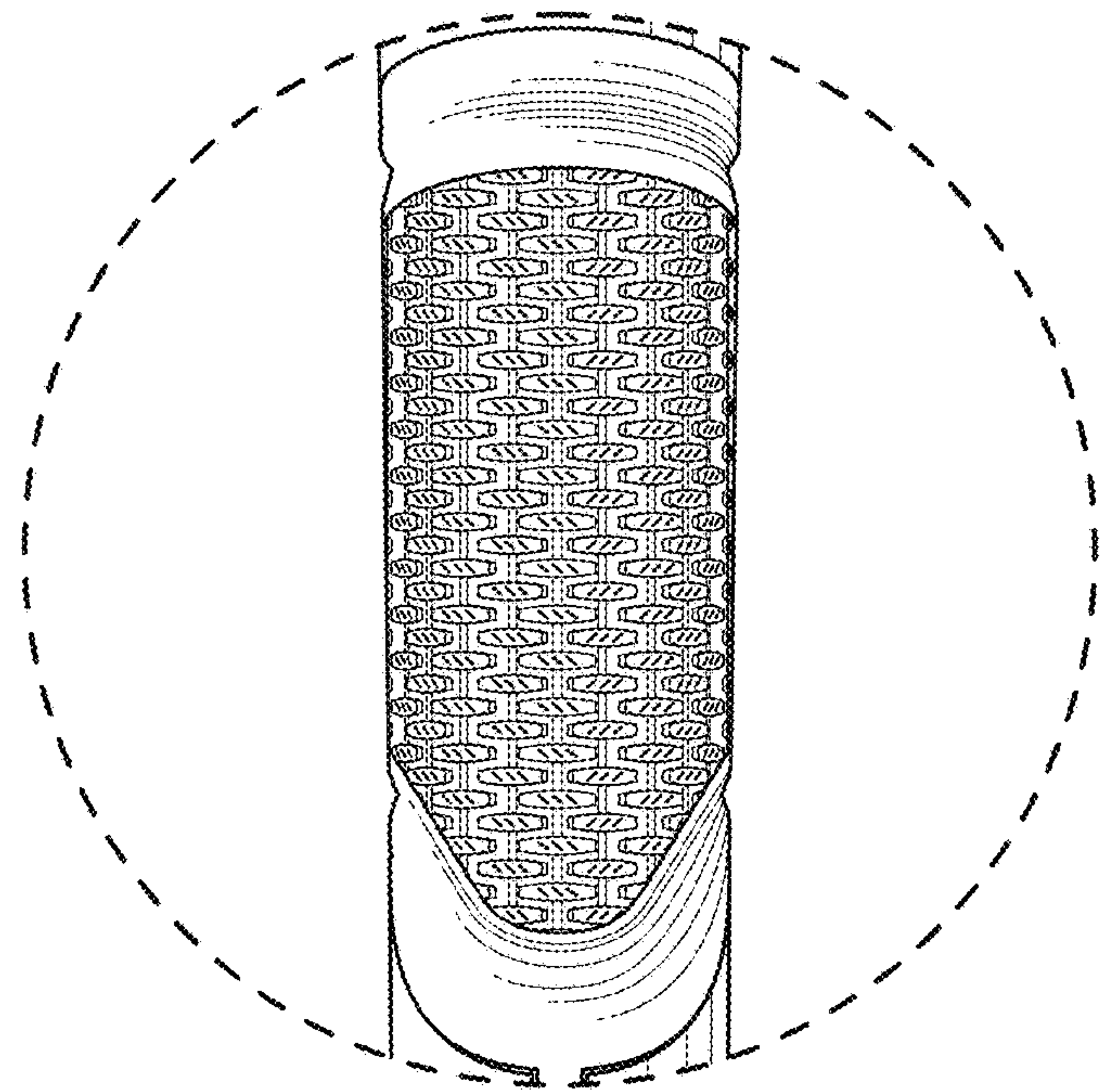
