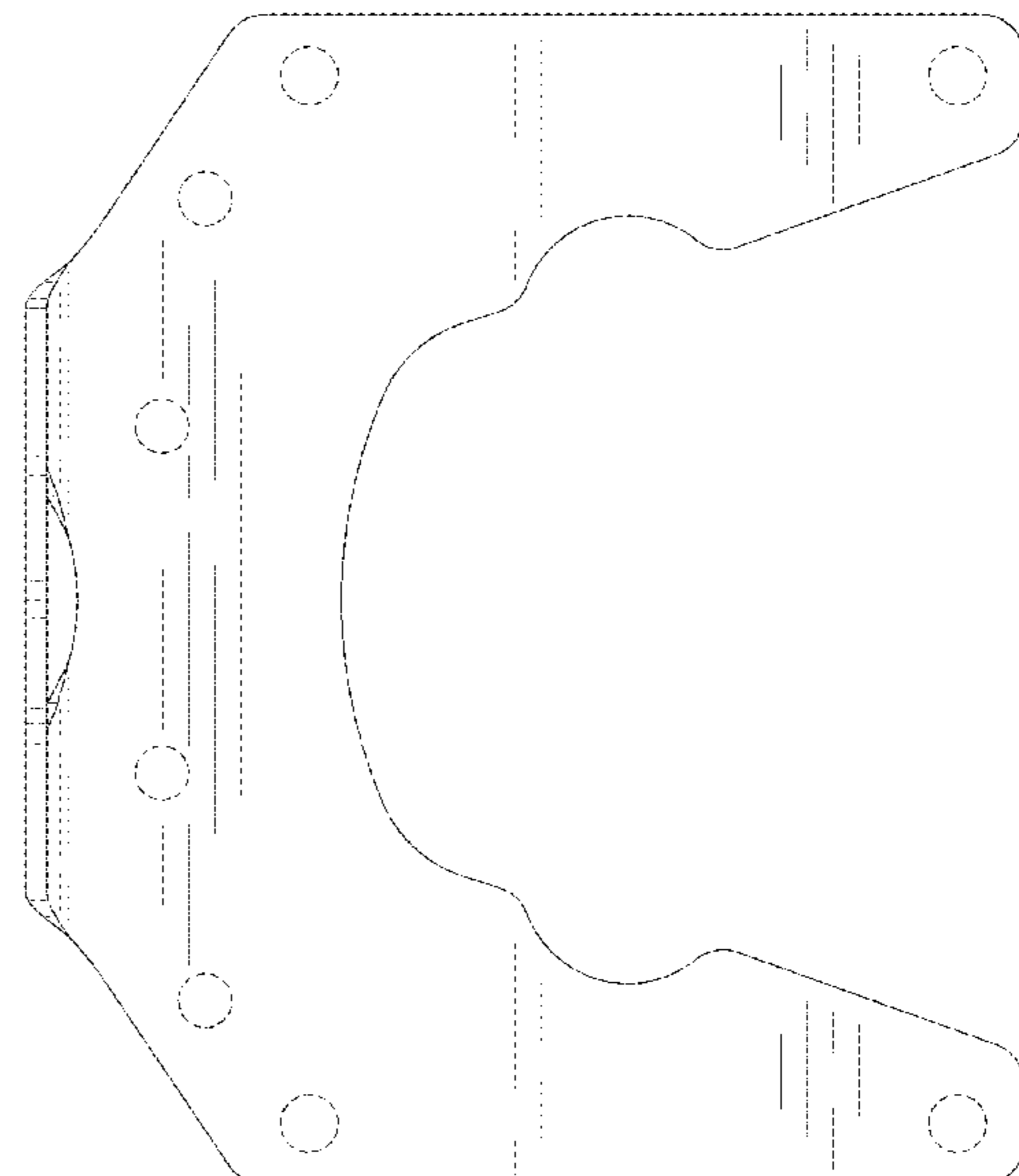
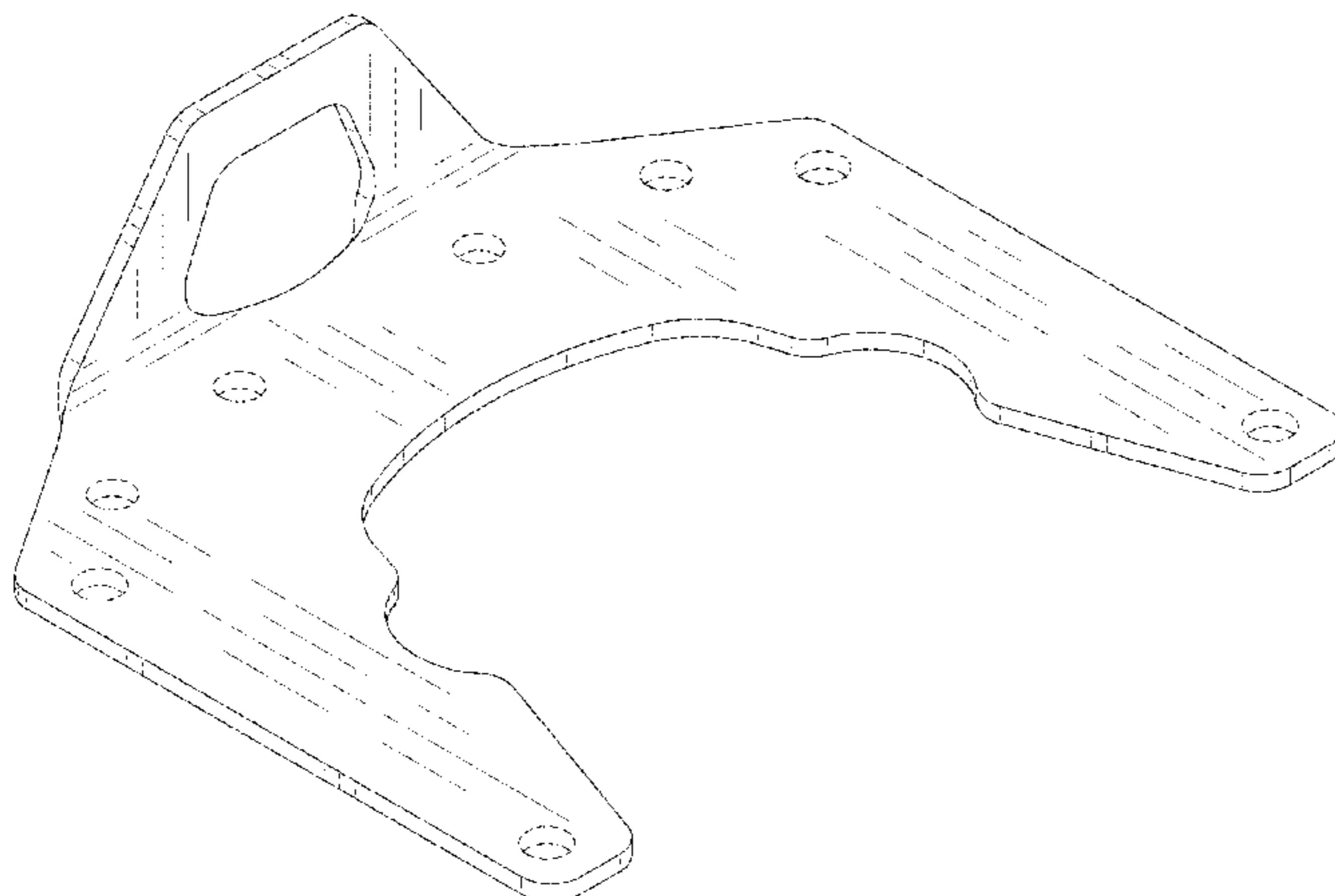
(57) **CLAIM**

The ornamental design for a roof anchor, as shown and described.

**DESCRIPTION**

FIG. 1 is an upper front right perspective view of the roof anchor;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a top plan view thereof;  
 FIG. 4 is a left side elevational view thereof;  
 FIG. 5 is a rear elevational view thereof;  
 FIG. 6 is a right side elevational view thereof; and,  
 FIG. 7 is a bottom plan view thereof.  
 The broken lines illustrate portions of the roof anchor that form no part of the claimed design.

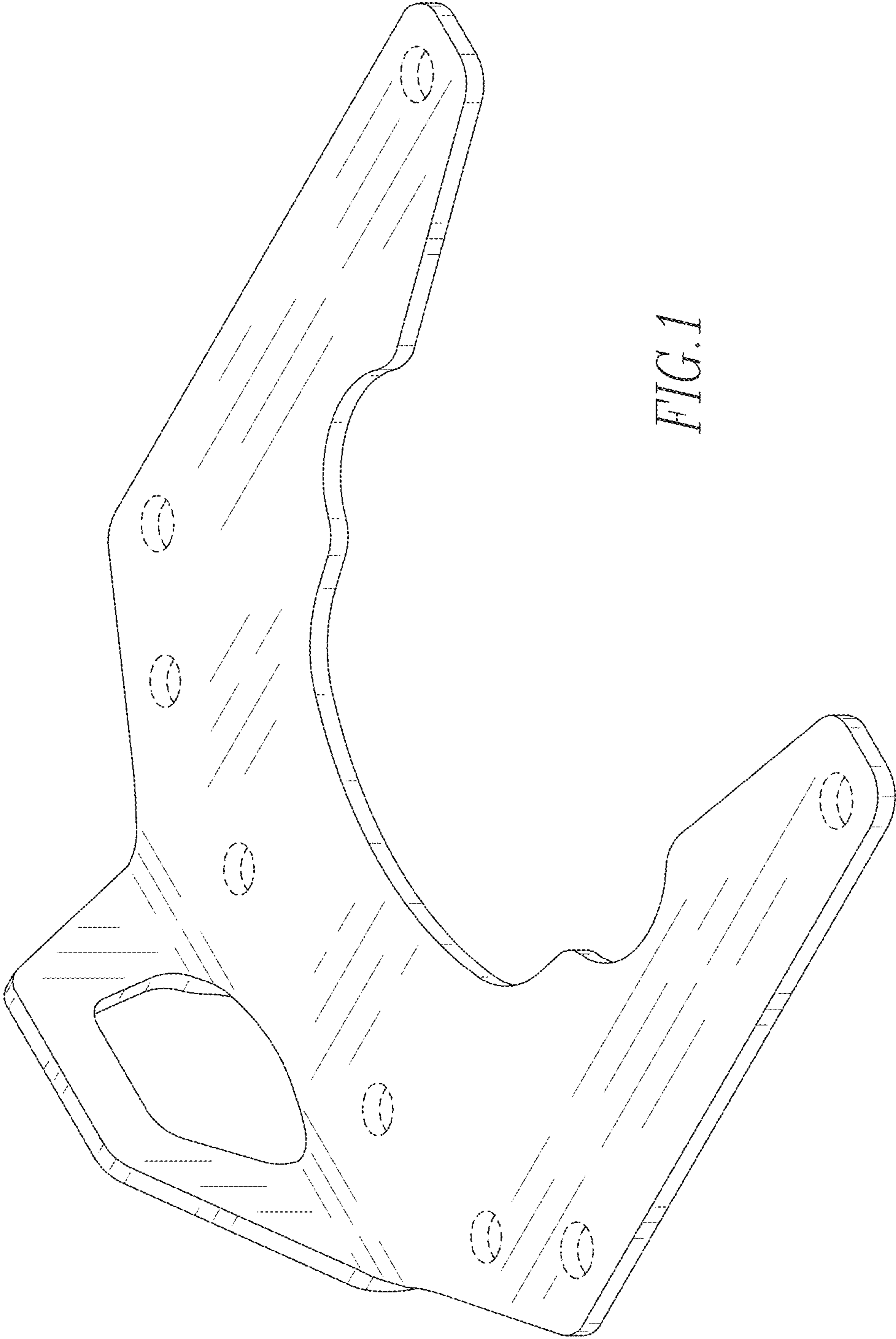
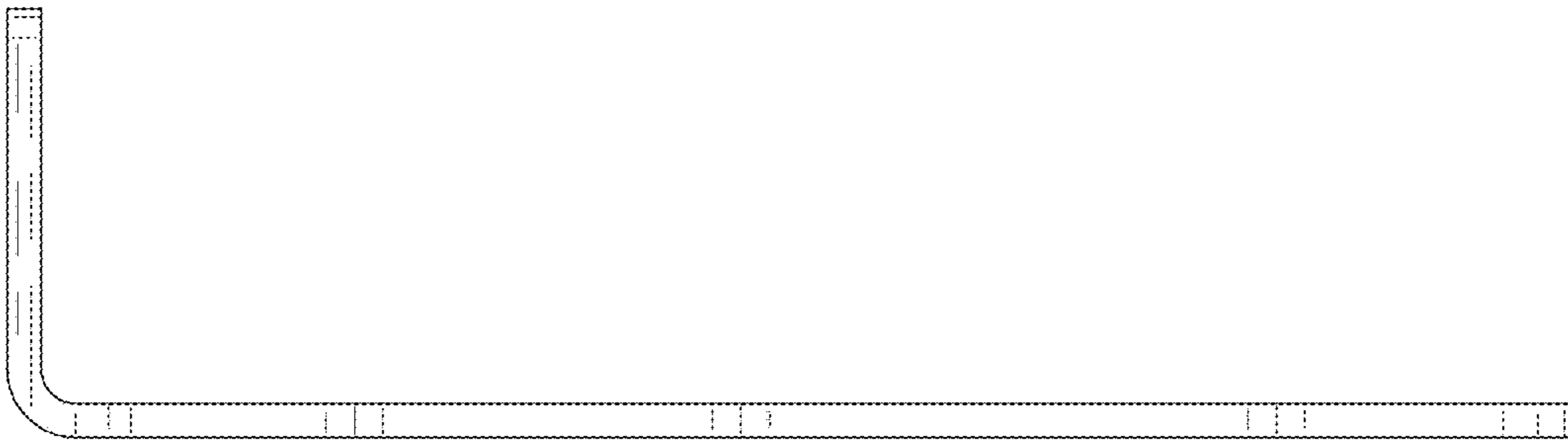

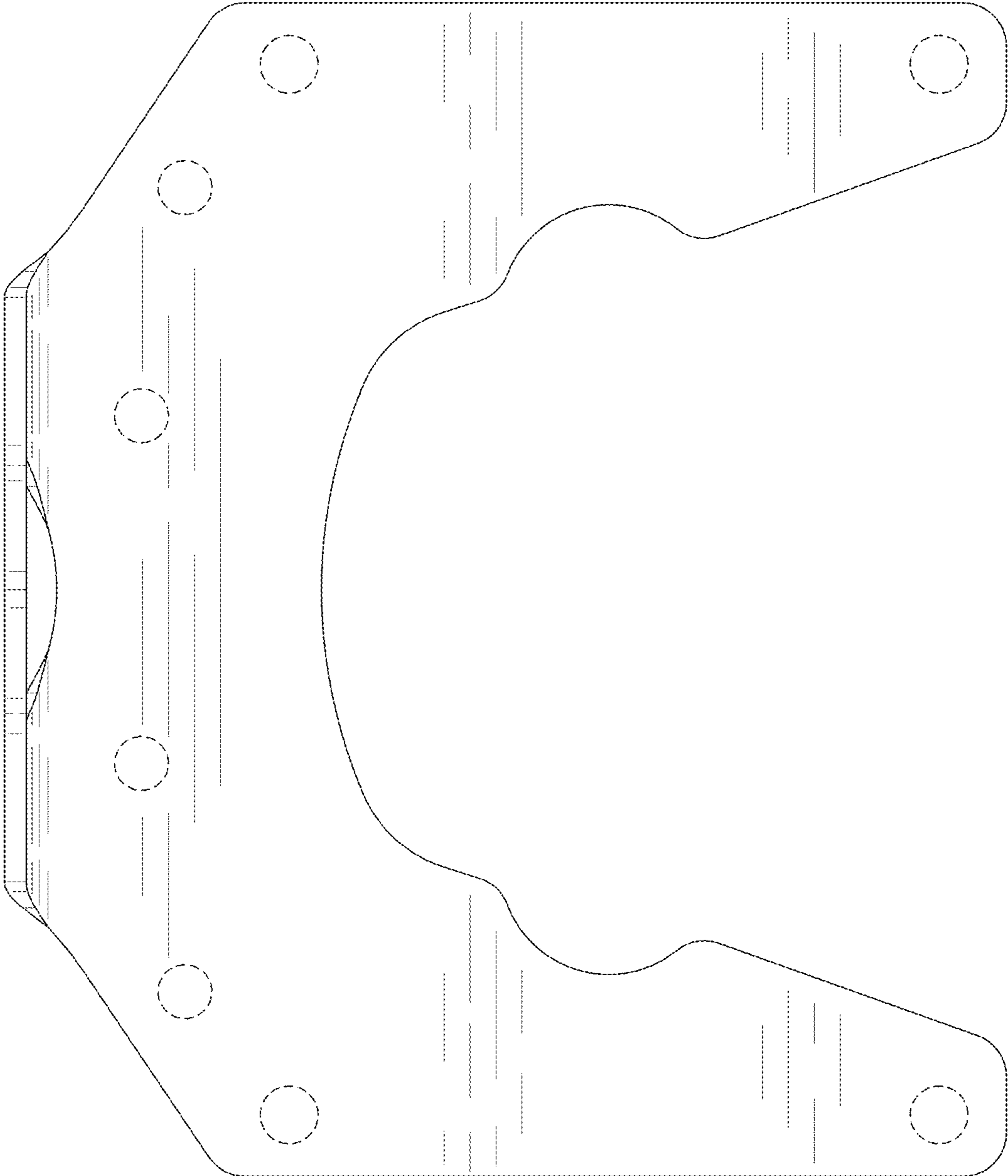

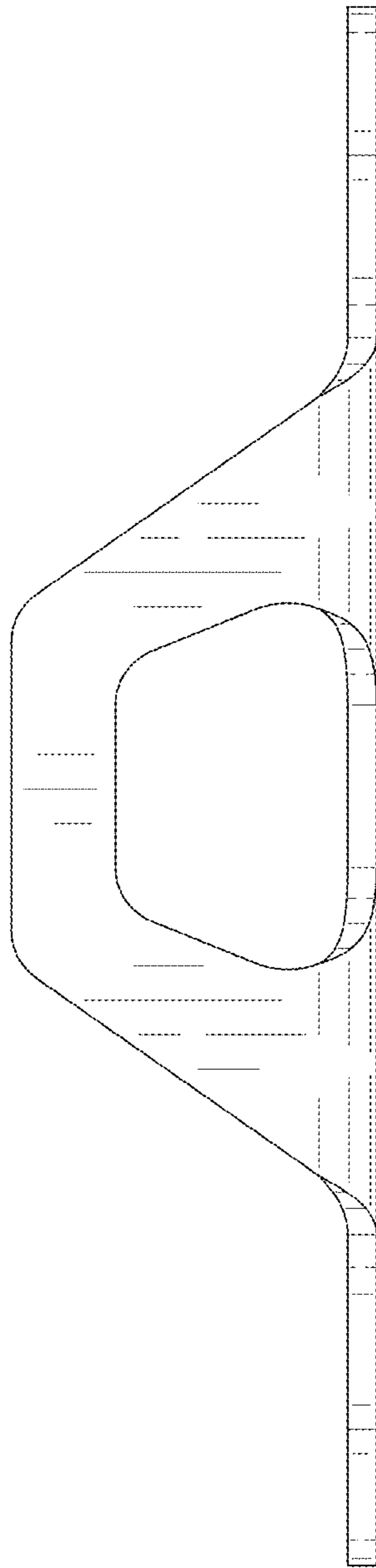
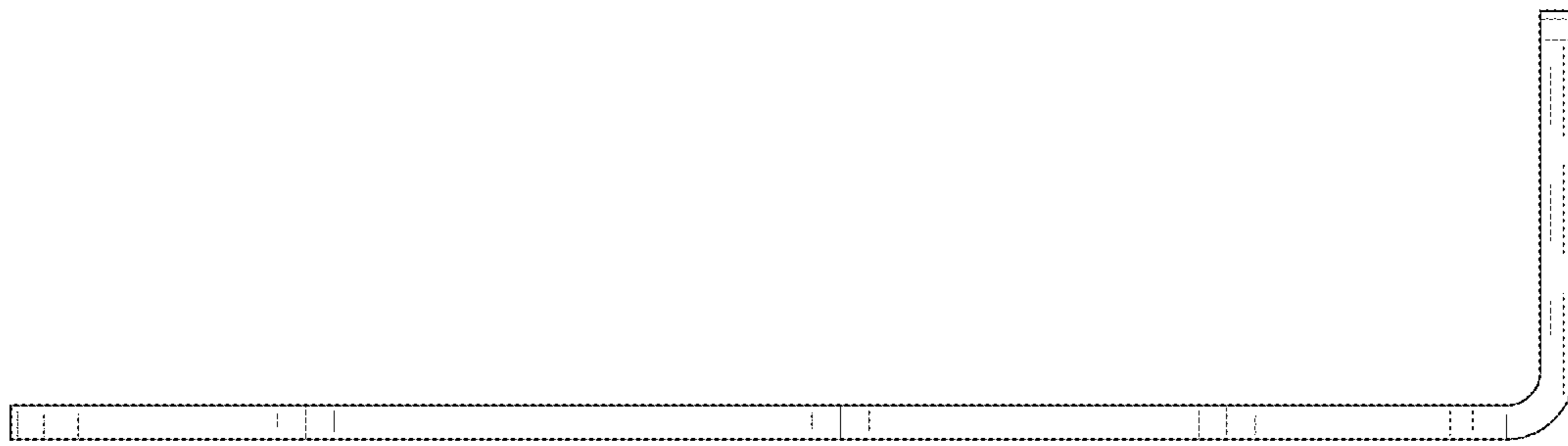

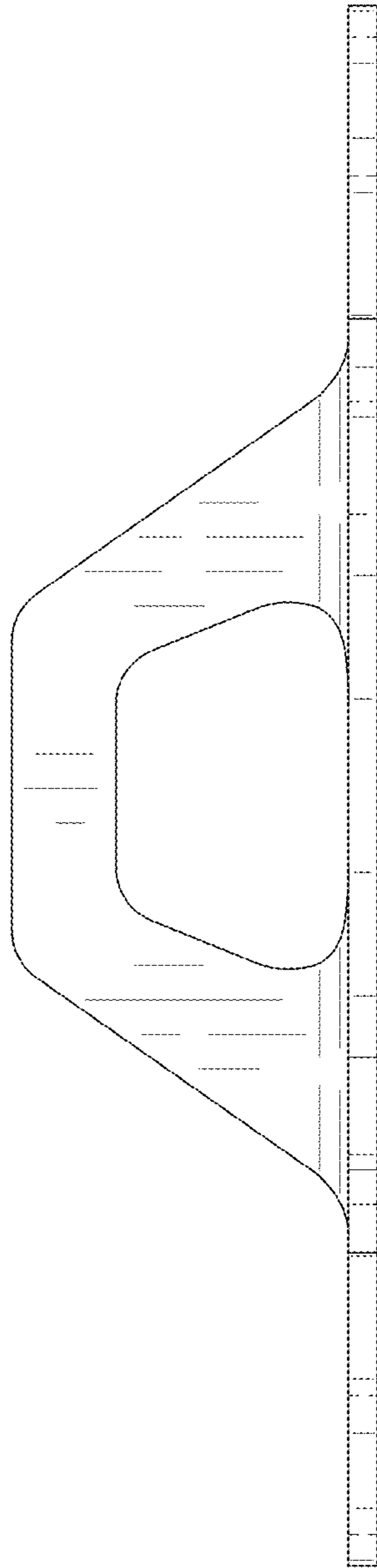
