The ornamental design for a fork lift fork, as shown and described.

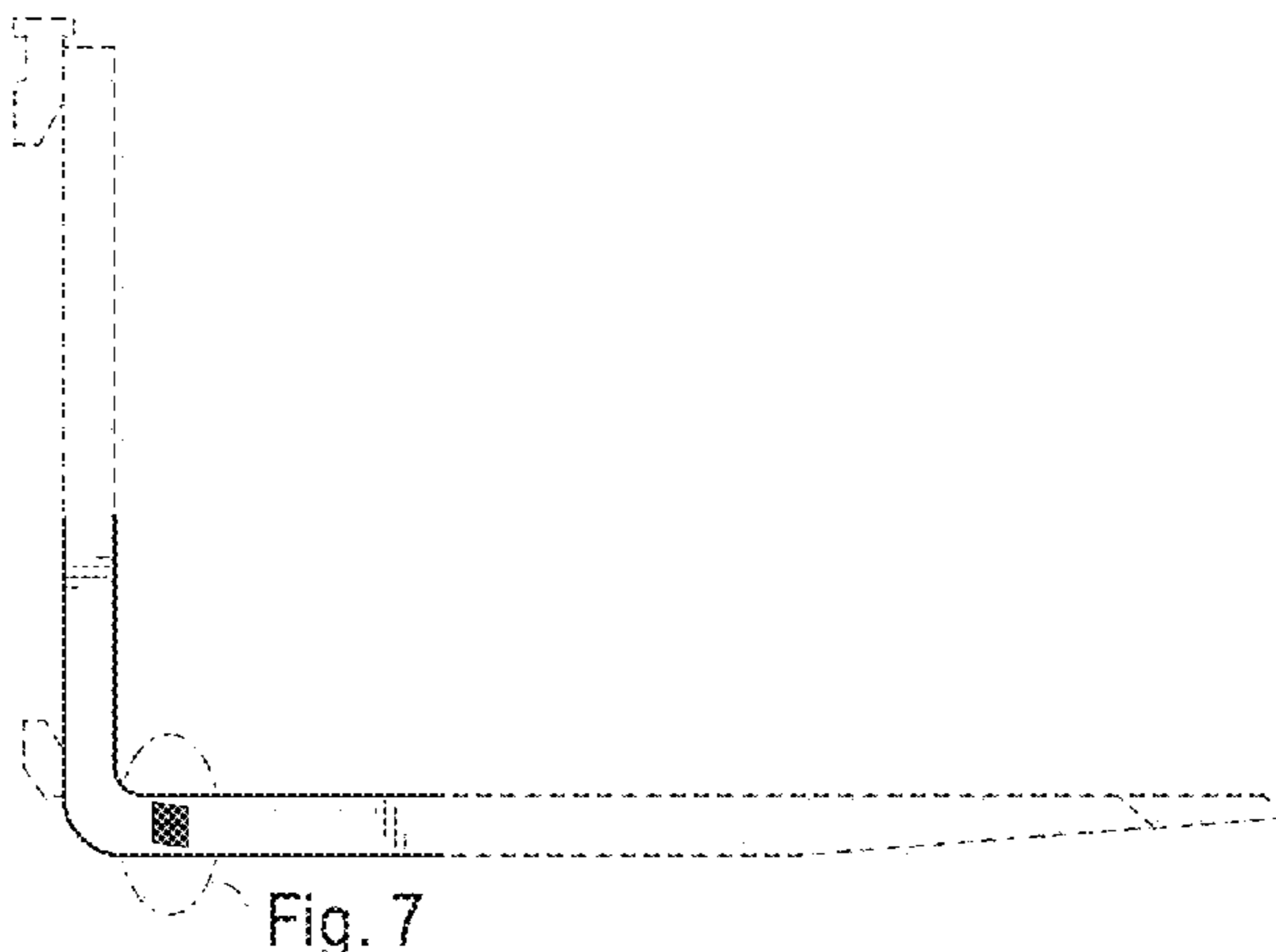


FIG. 4 is also a rear view of the third embodiment of the fork lift fork of FIG. 1;

FIG. 4 is a rear view of the first embodiment of the fork lift fork of FIG. 1;

FIG. 5 is a bottom view of the first embodiment of the fork lift fork of FIG. 1;

FIG. 6 is a left side view of the first embodiment of the fork lift fork of FIG. 1;

FIG. 7 is an enlarged view of the first embodiment of the fork lift fork of FIG. 1 showing the detail portion of the fork lift fork indicated in FIG. 1;

FIG. 8 is a left side view of a second embodiment of a fork lift fork showing the new design;

FIG. 2 is also a top view of the second embodiment of the fork lift fork of FIG. 8;

FIG. 3 is also a front view of the second embodiment of the fork lift fork of FIG. 8;

FIG. 4 is also a rear view of the second embodiment of the fork lift fork of FIG. 8;

FIG. 5 is also a bottom view of the second embodiment of the fork lift fork of FIG. 8;

FIG. 9 is a right side view of the second embodiment of the fork lift fork of FIG. 8;

FIG. 10 is an enlarged view of the second embodiment of the fork lift fork showing the detail portion of the fork lift fork indicated in FIG. 8;

FIG. 1 is also a right side view of a third embodiment of a fork lift fork showing the new design;

FIG. 2 is also a top view of the third embodiment of the fork lift fork of FIG. 1;

FIG. 3 is also a front view of the third embodiment of the fork lift fork of FIG. 1;

The second embodiment discloses a forklift fork with a marking on the left side but no marking on the right as shown in FIGS. 2 through 5 and 8 through 10. The third embodiment discloses a forklift fork with a marking on the right and left side as shown in FIGS. 1 through 5, 7, 8 and 10.

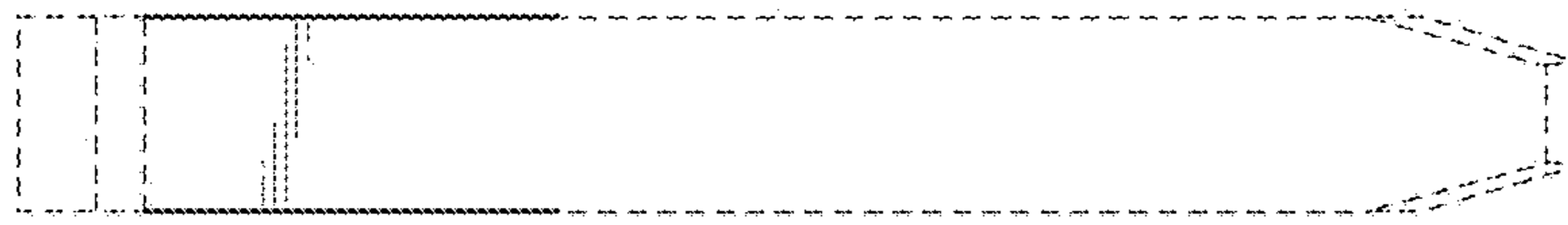

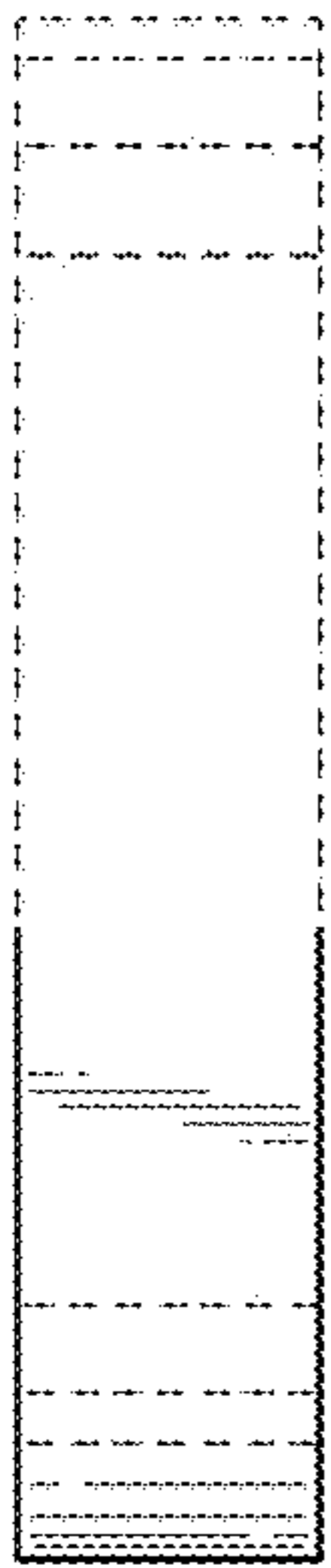

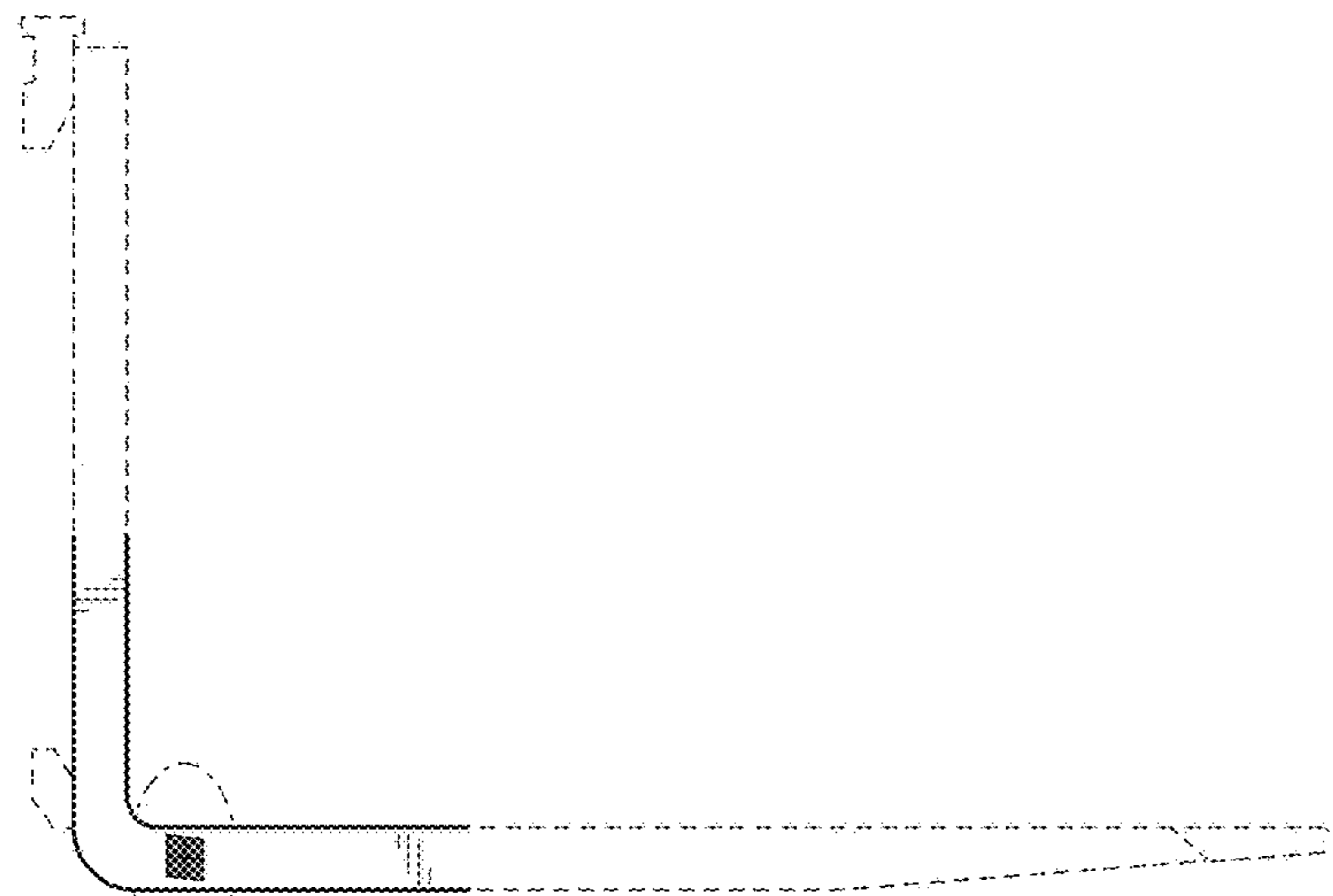

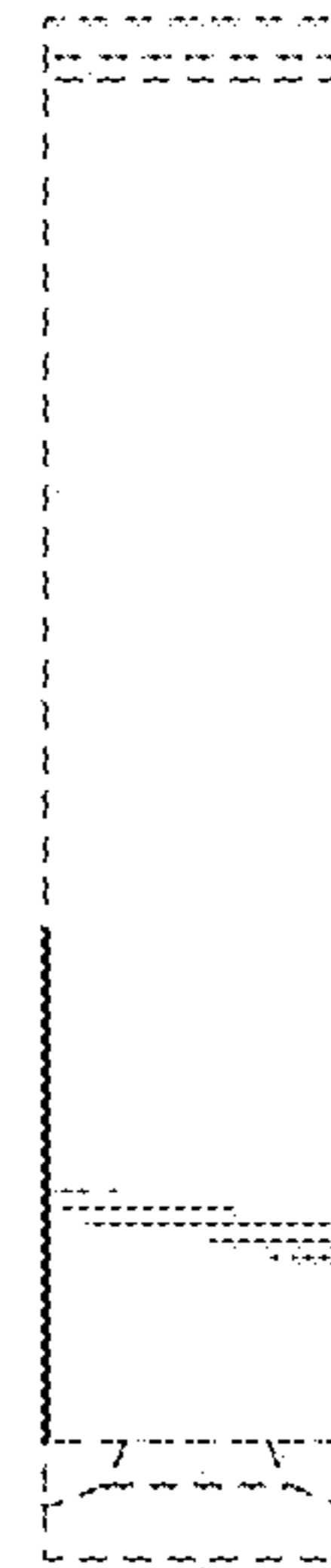

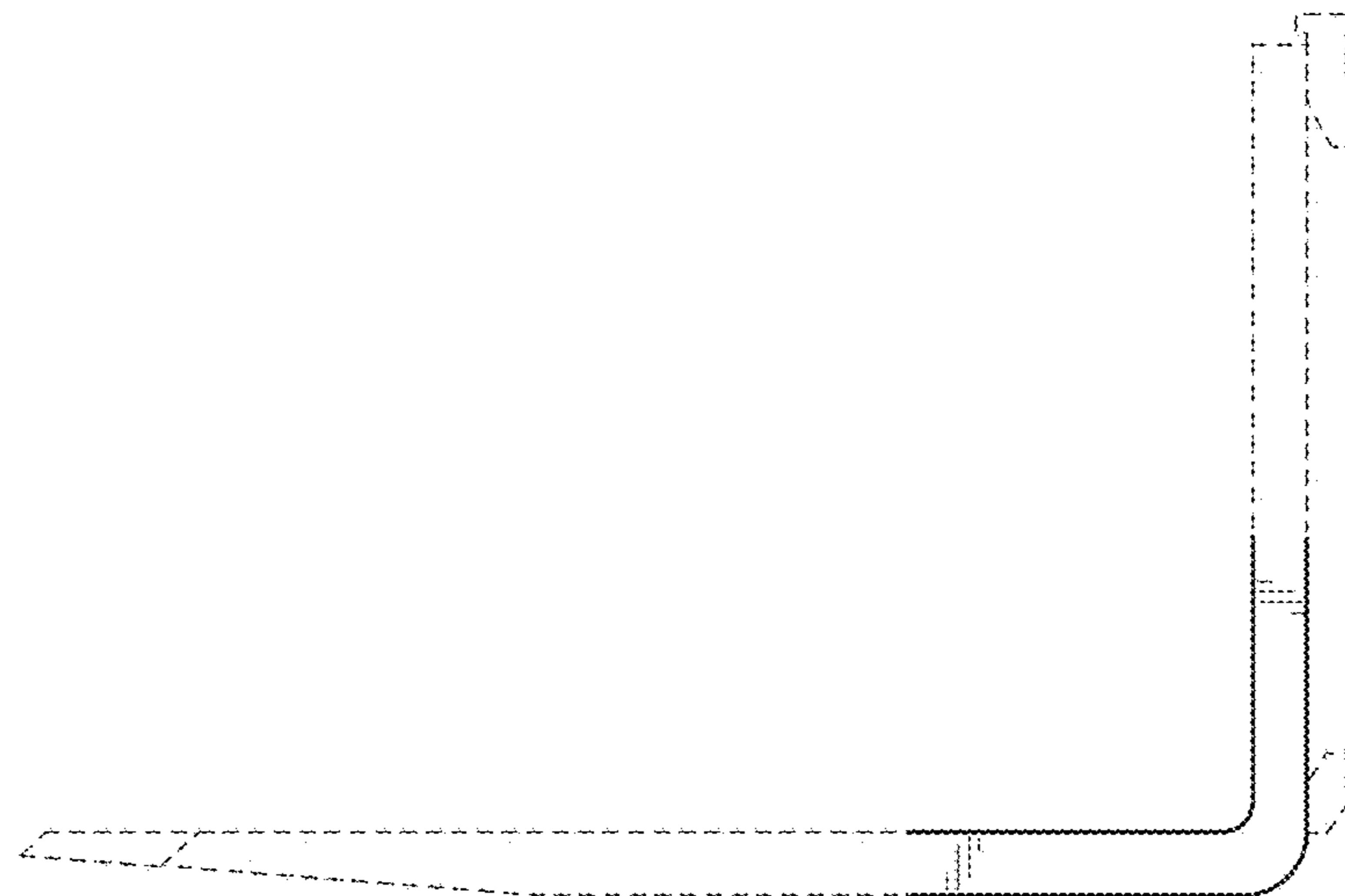

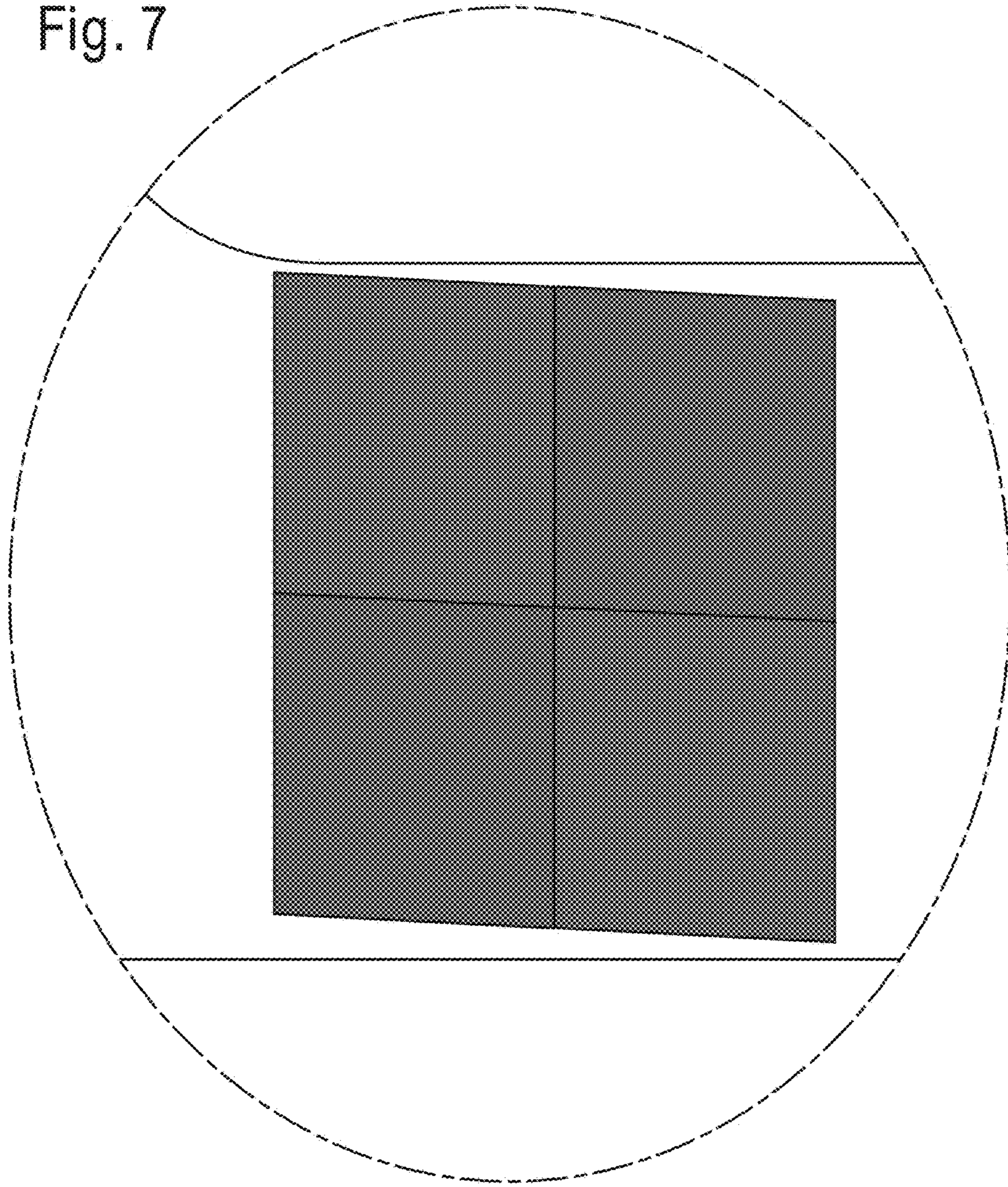

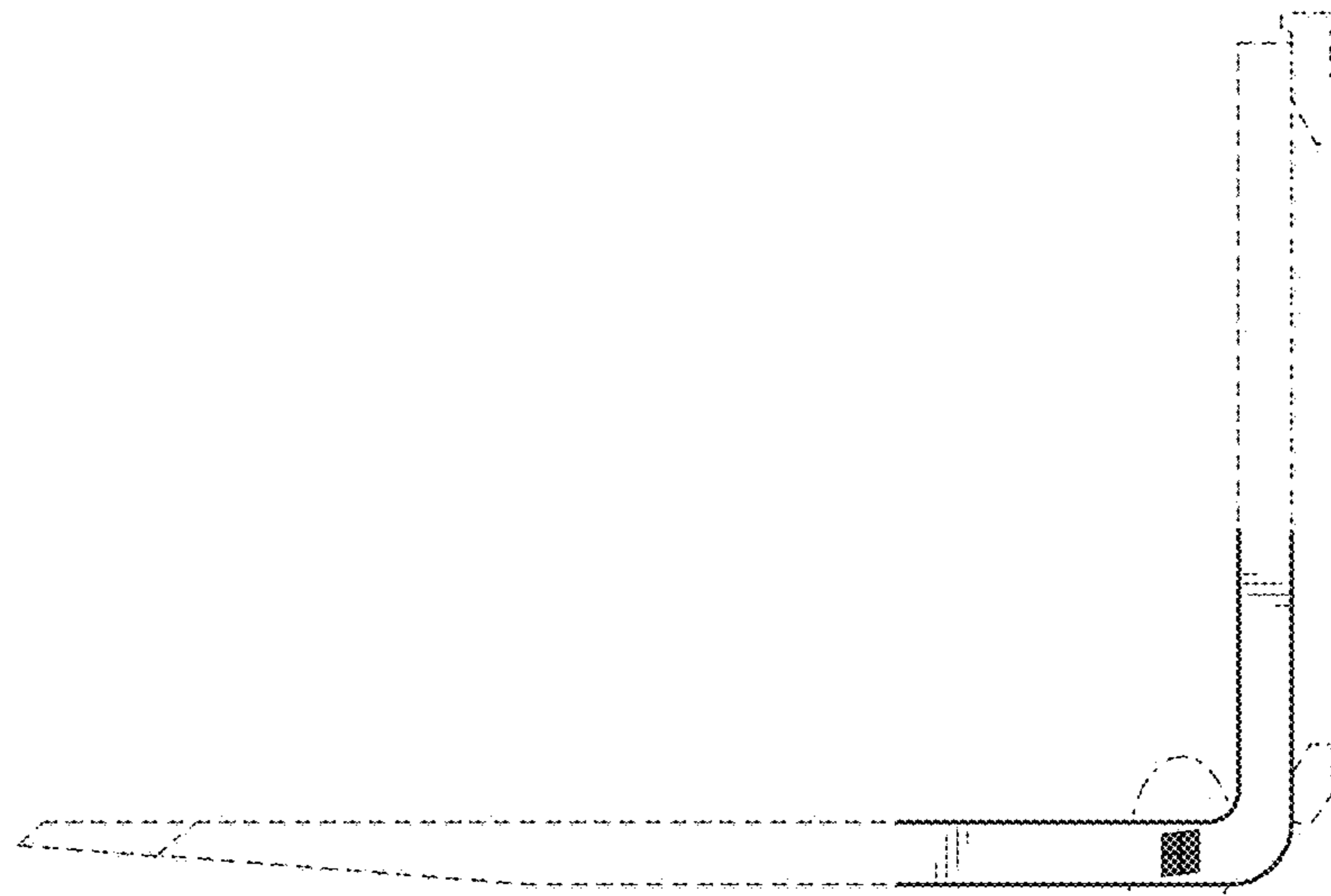

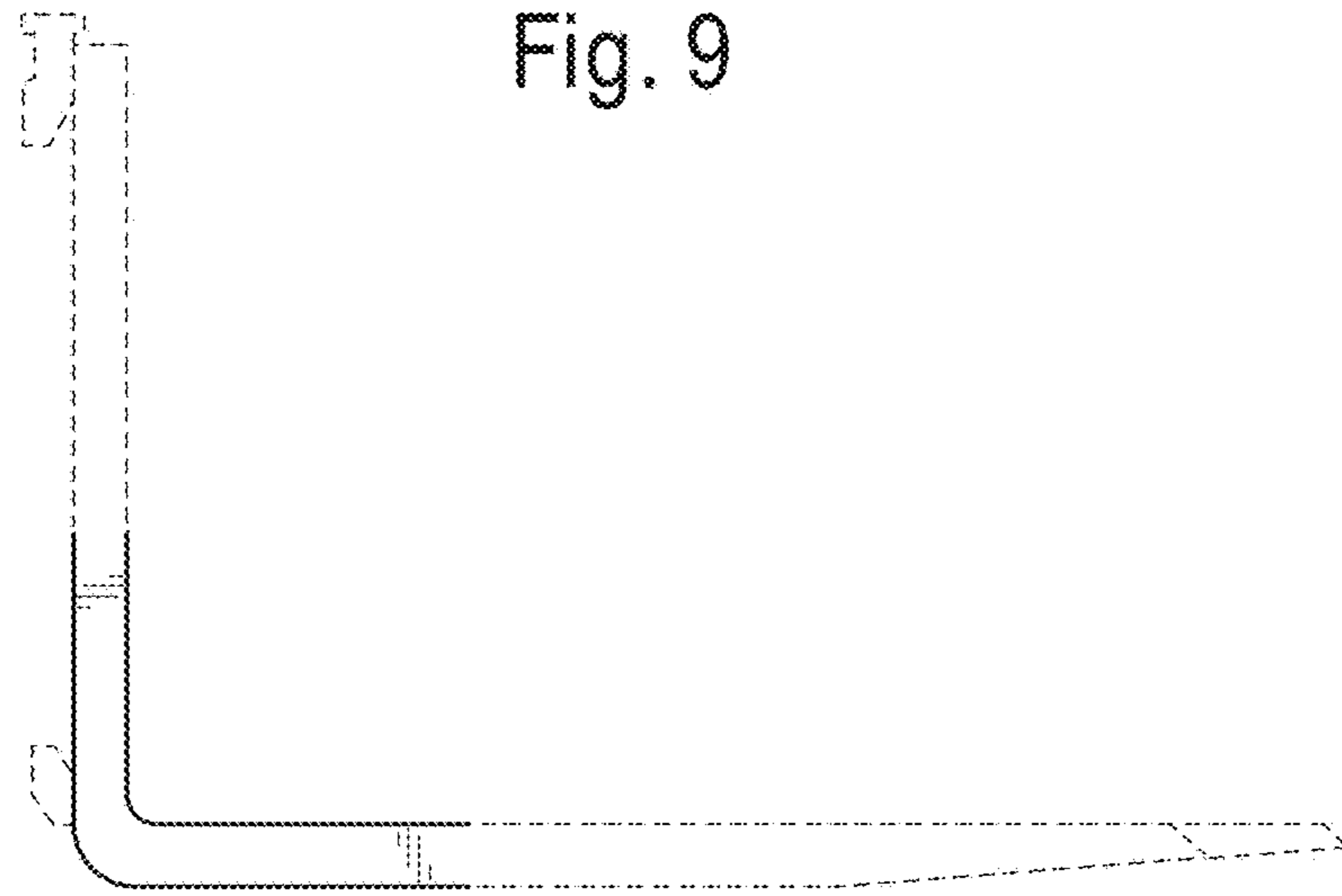
