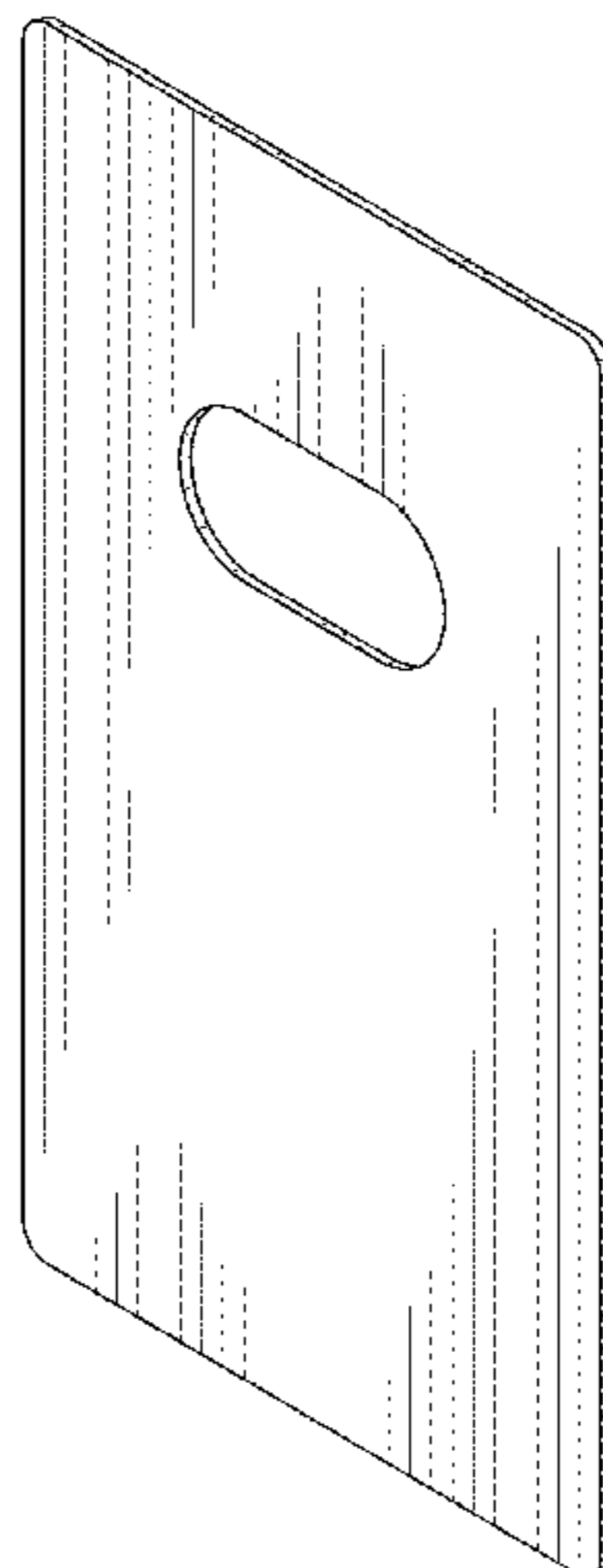
(57) **CLAIM**

The ornamental design for a pocket square retainer, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a pocket square retainer showing the new design holding a representative pocket square;
FIG. 2 is another front perspective view thereof;
FIG. 3 is a right side elevation view thereof, with the left side elevation view a mirror image thereof;
FIG. 4 is a top plan view thereof, with the bottom plan view a mirror image thereof; and,
FIG. 5 is a front elevation view thereof, with the back elevation view a mirror image thereof.
The broken lines depict environmental subject matter that form no part of the claimed design.

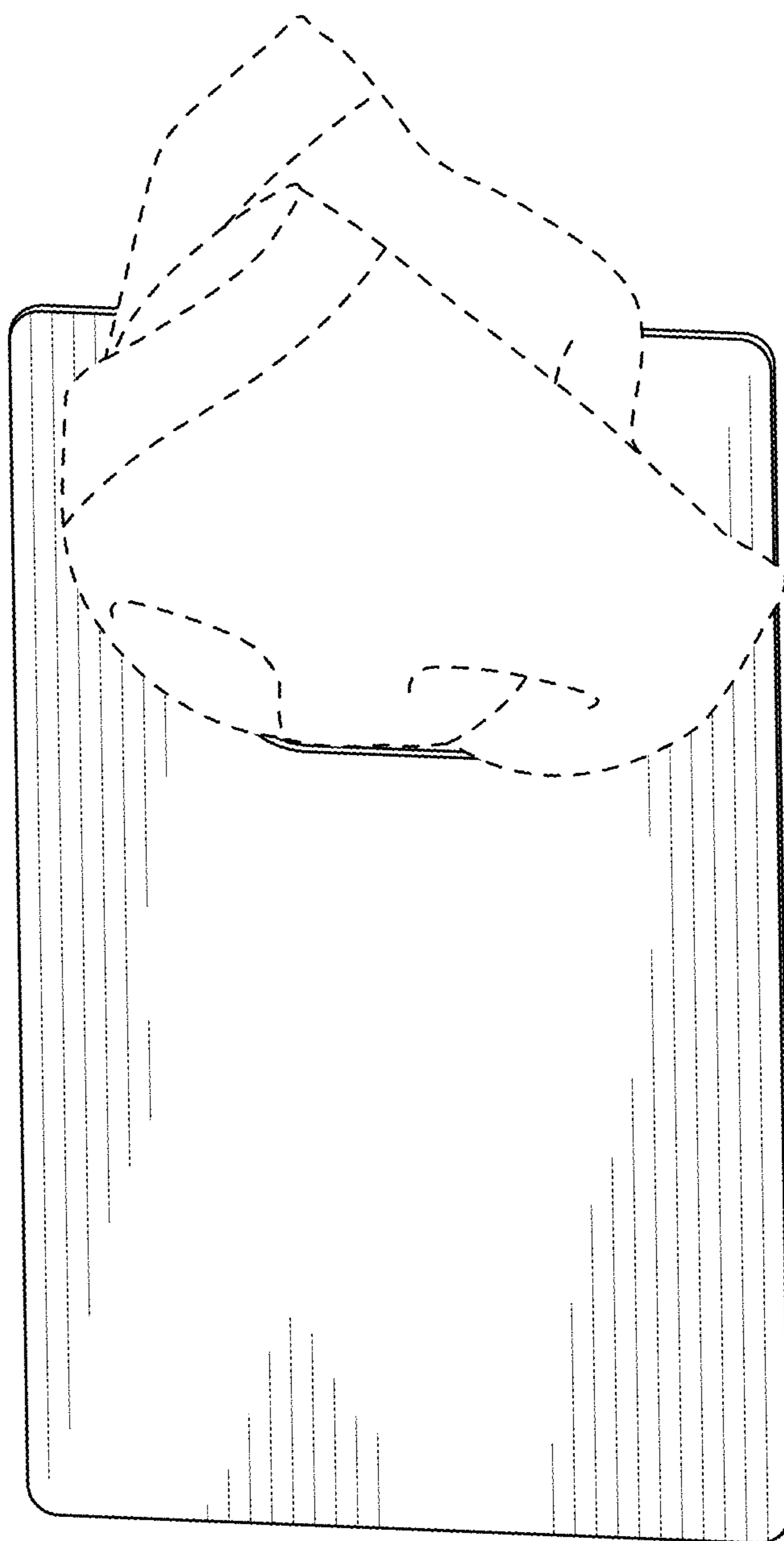

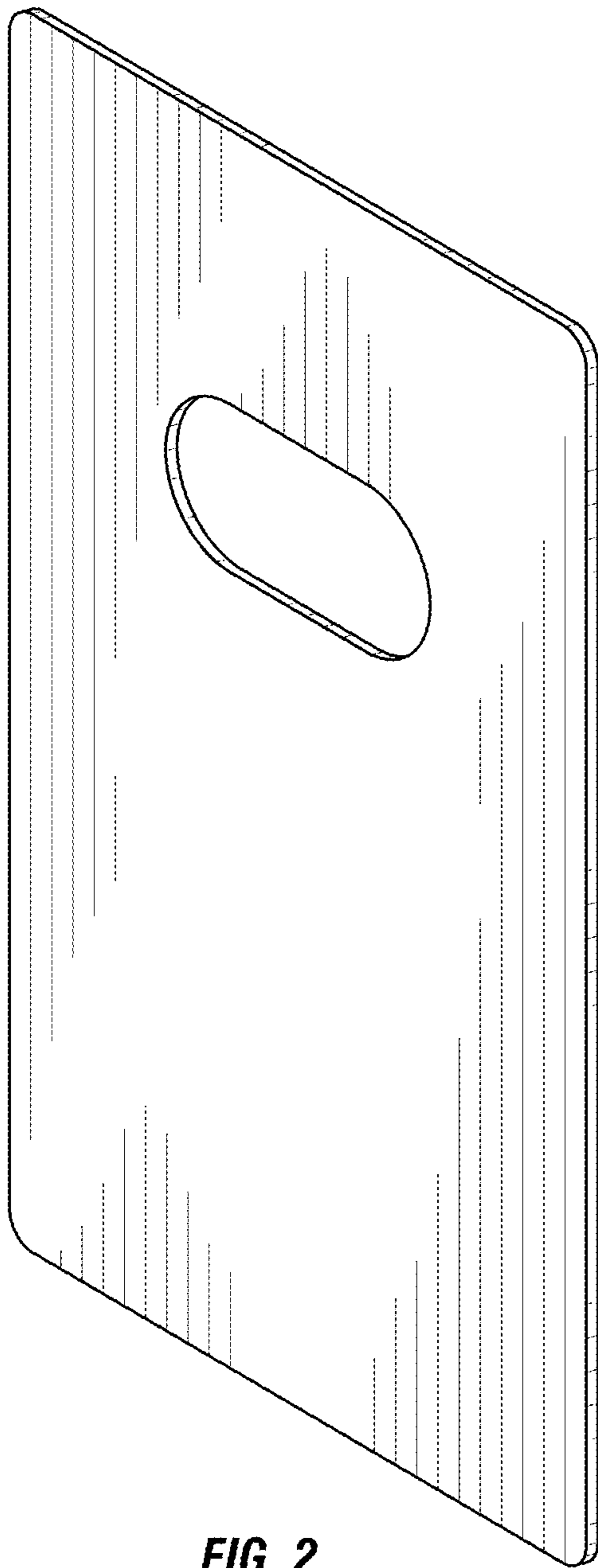

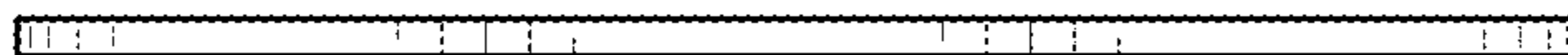

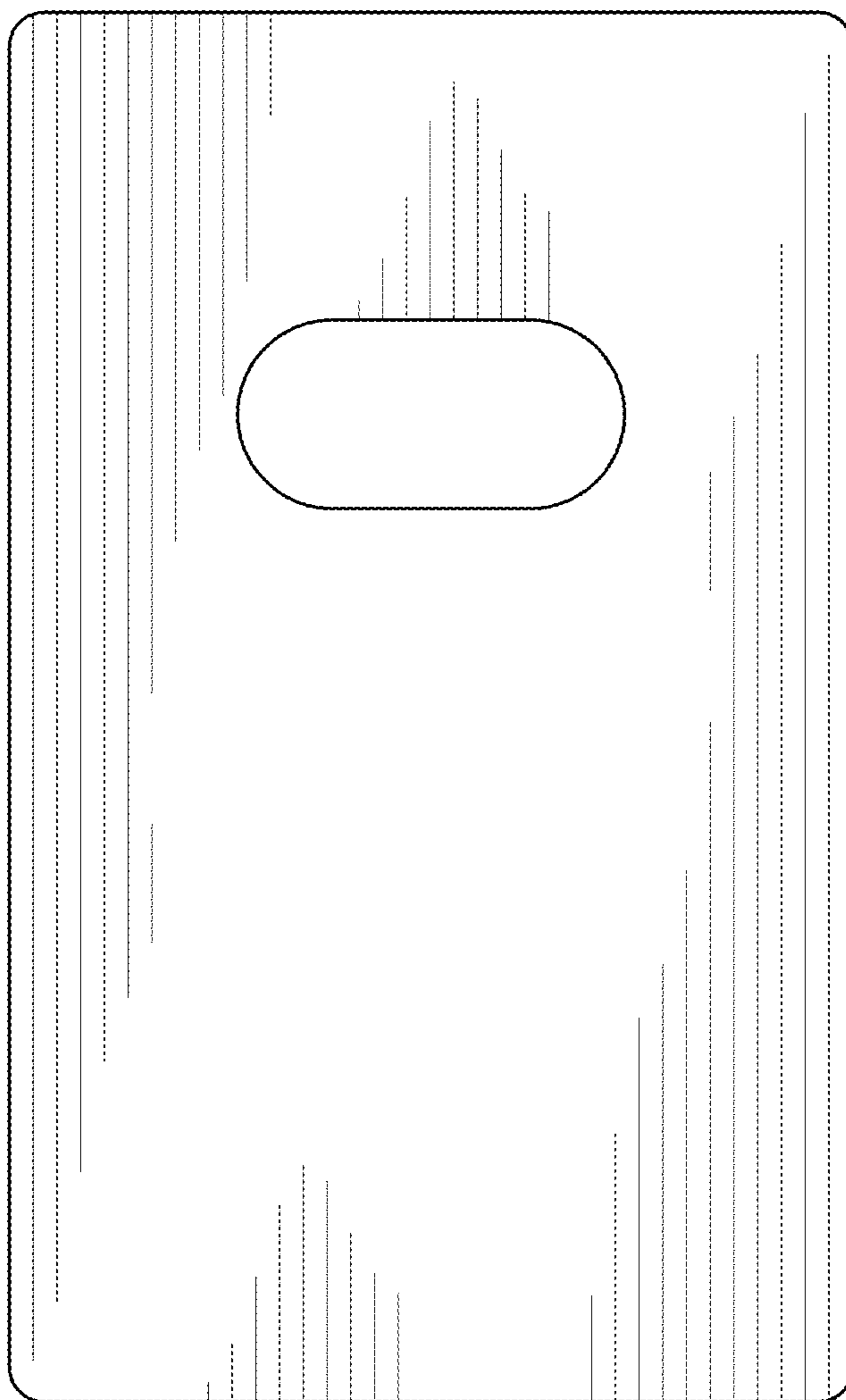
