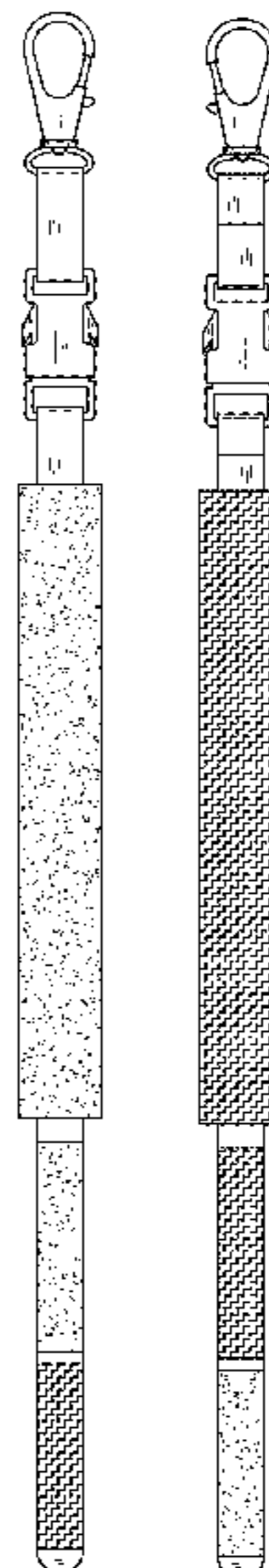
(57) **CLAIM**

The ornamental design for a glove holder, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a glove holder showing my new design;
FIG. 2 is a rear elevation view thereof;
FIG. 3 is a right side elevation view thereof;
FIG. 4 is a left side elevation view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is an in-use perspective view thereof.

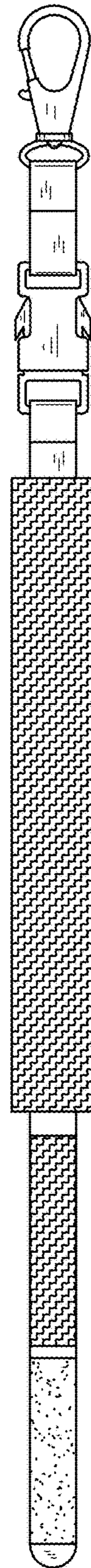

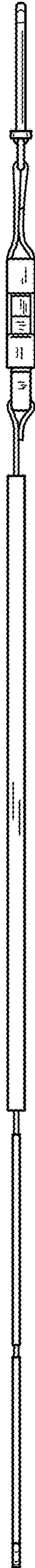

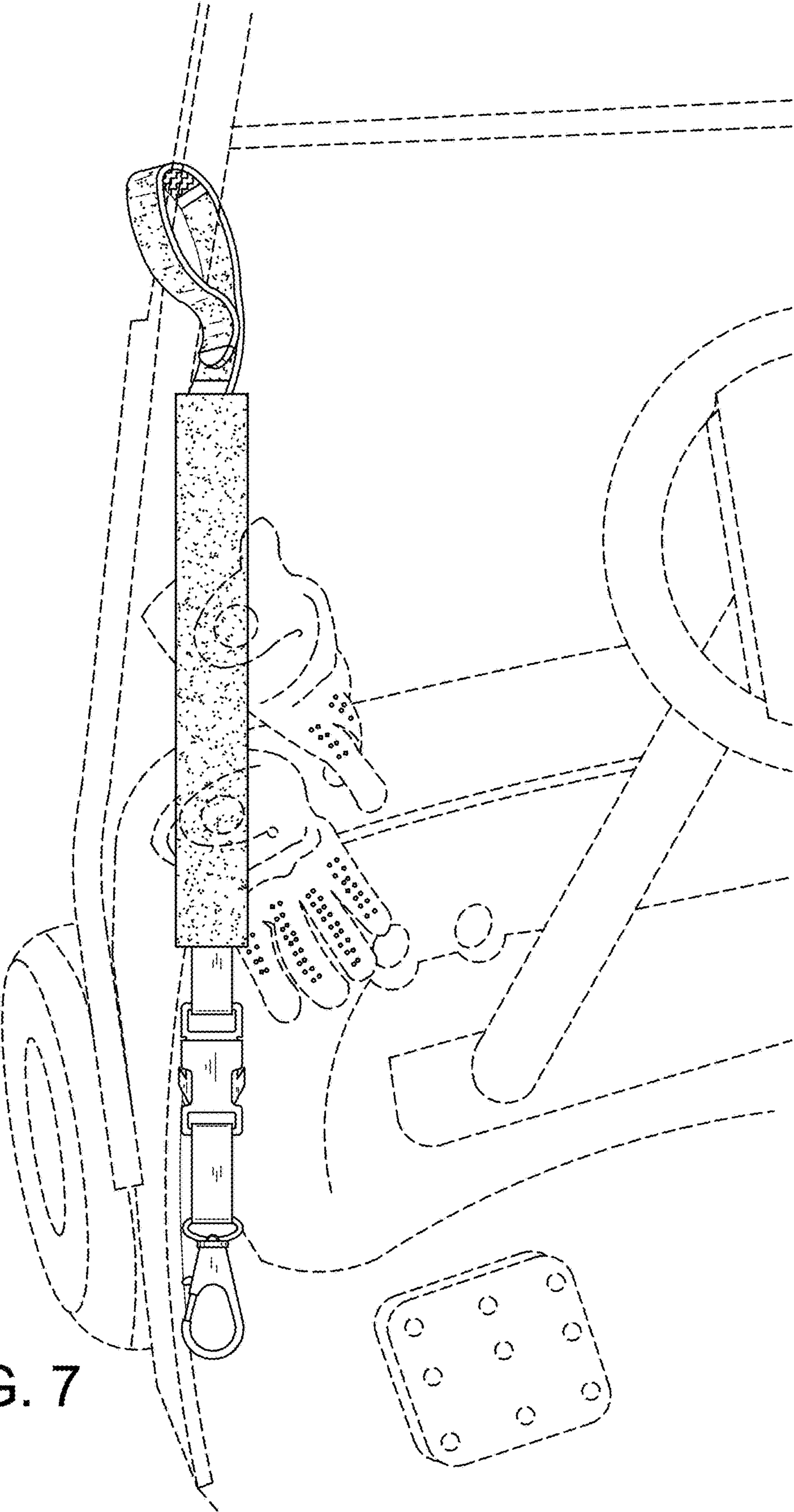
