The ornamental design for a sleeping bag, as shown and described.

DESCRIPTION

FIG. 12 a left side elevation view thereof.

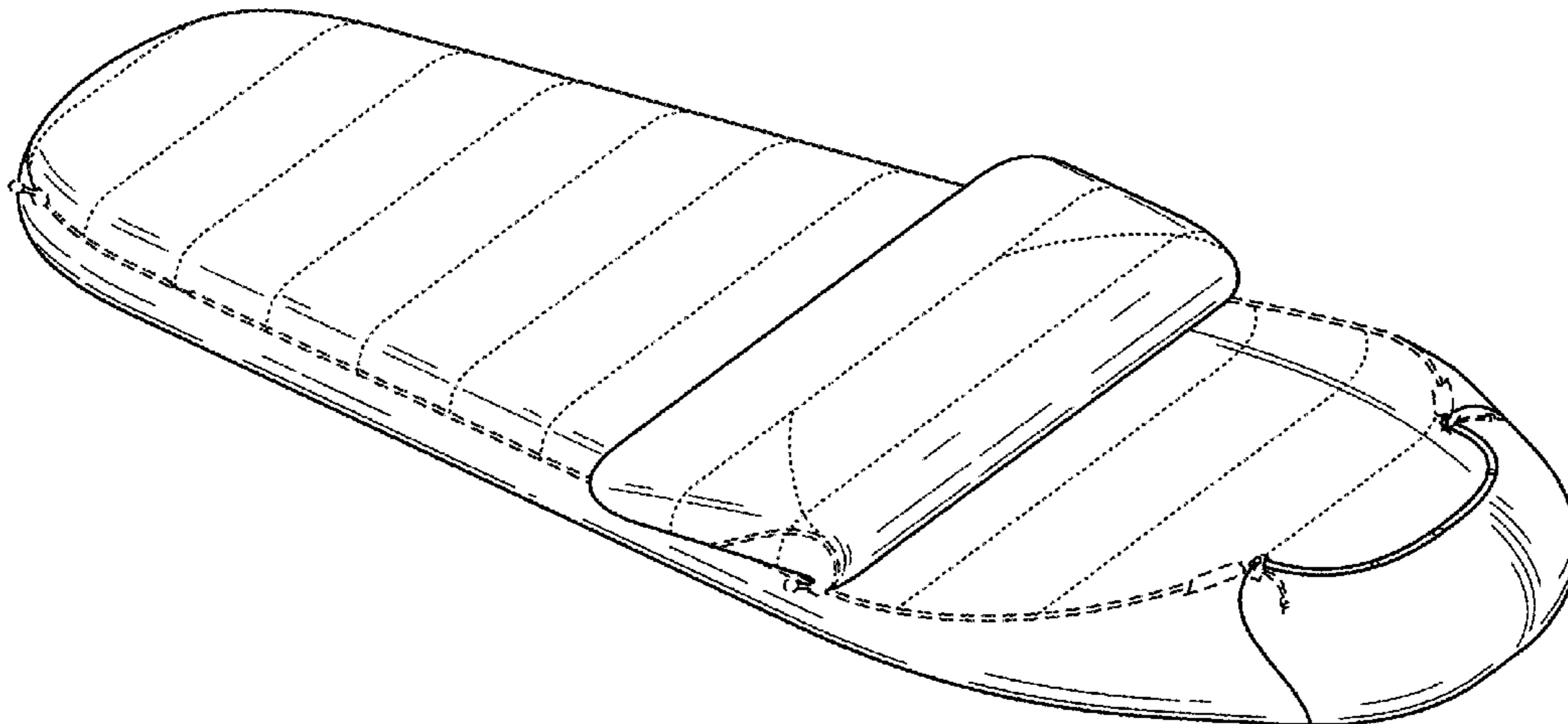
FIG. 13 is a front elevation view thereof.

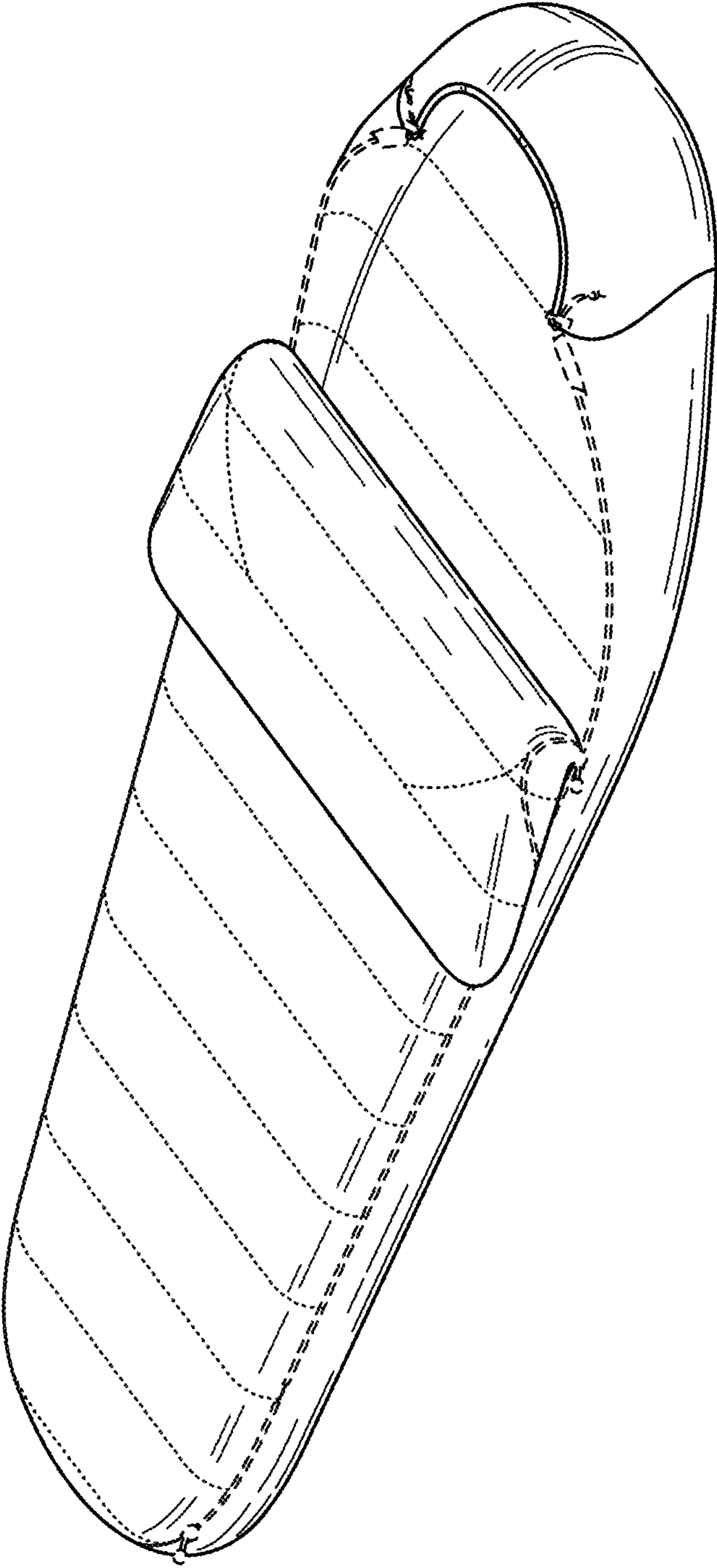

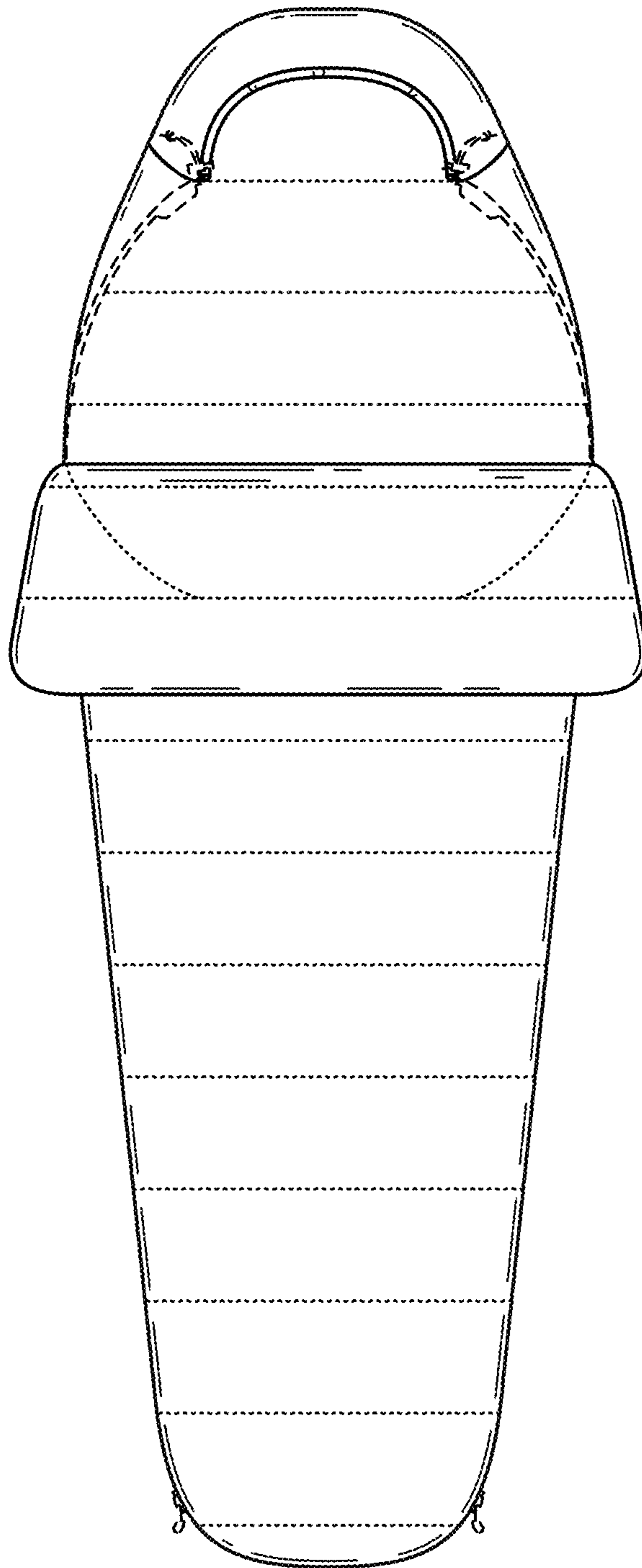

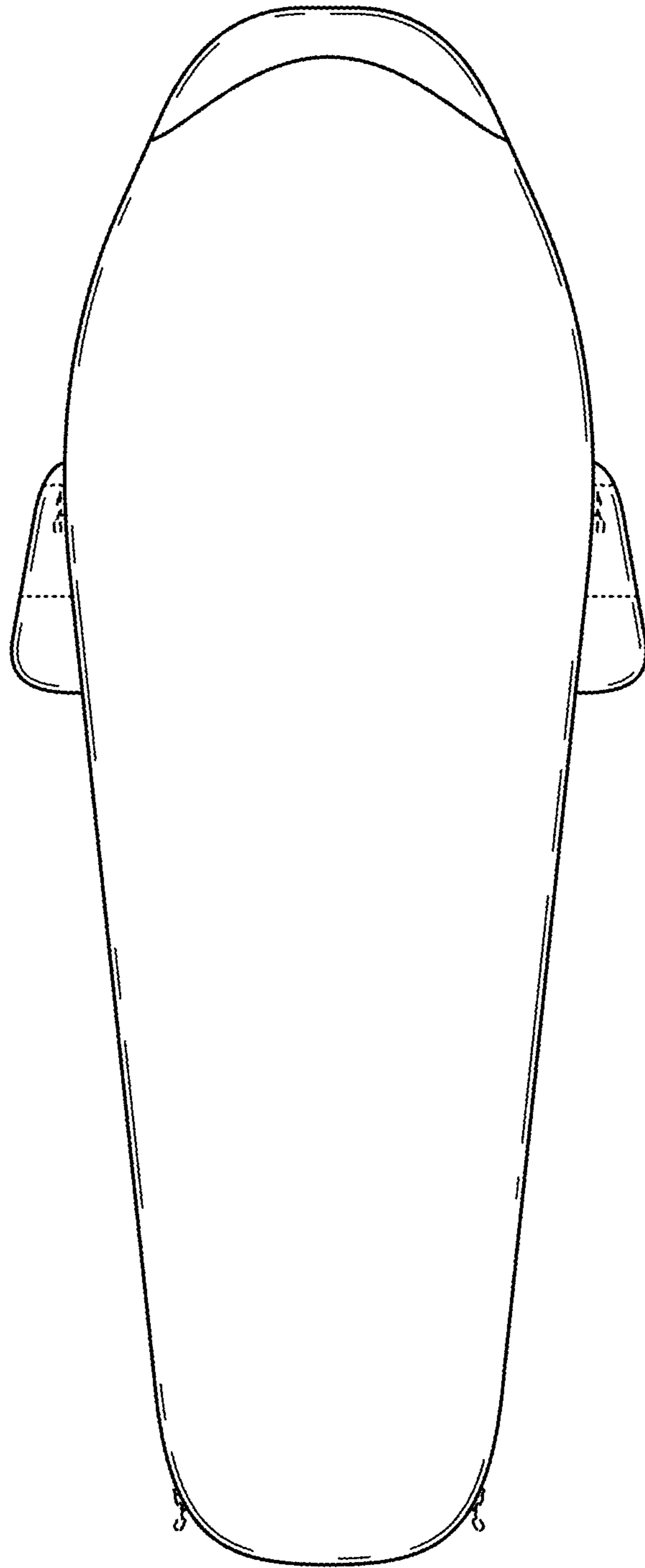

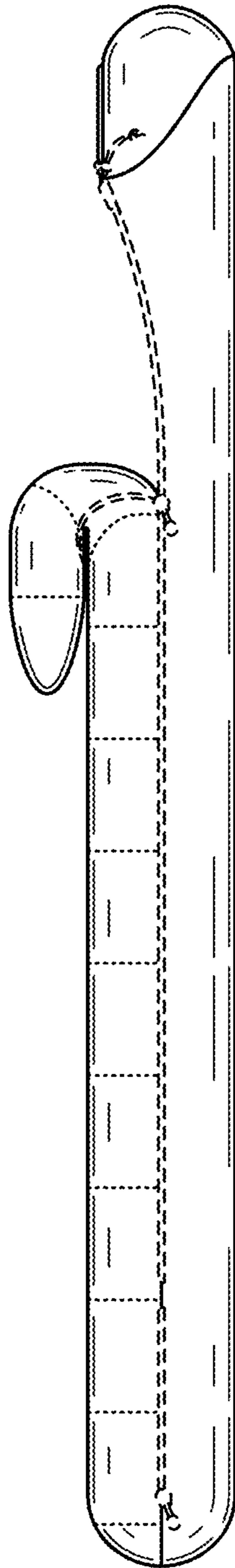

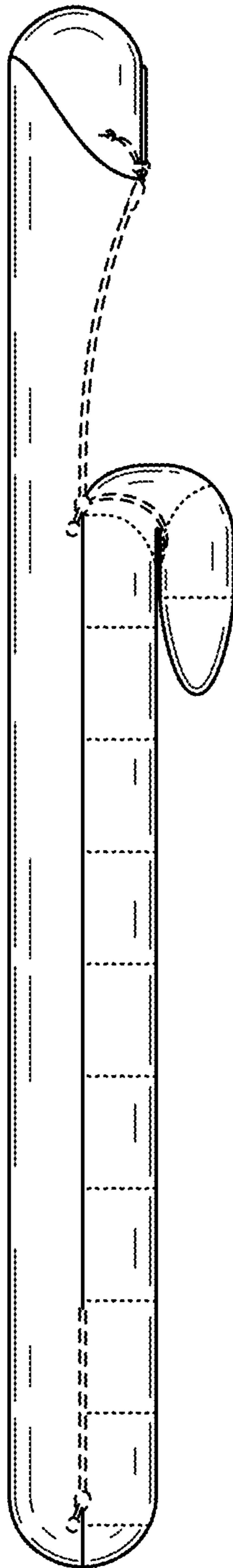

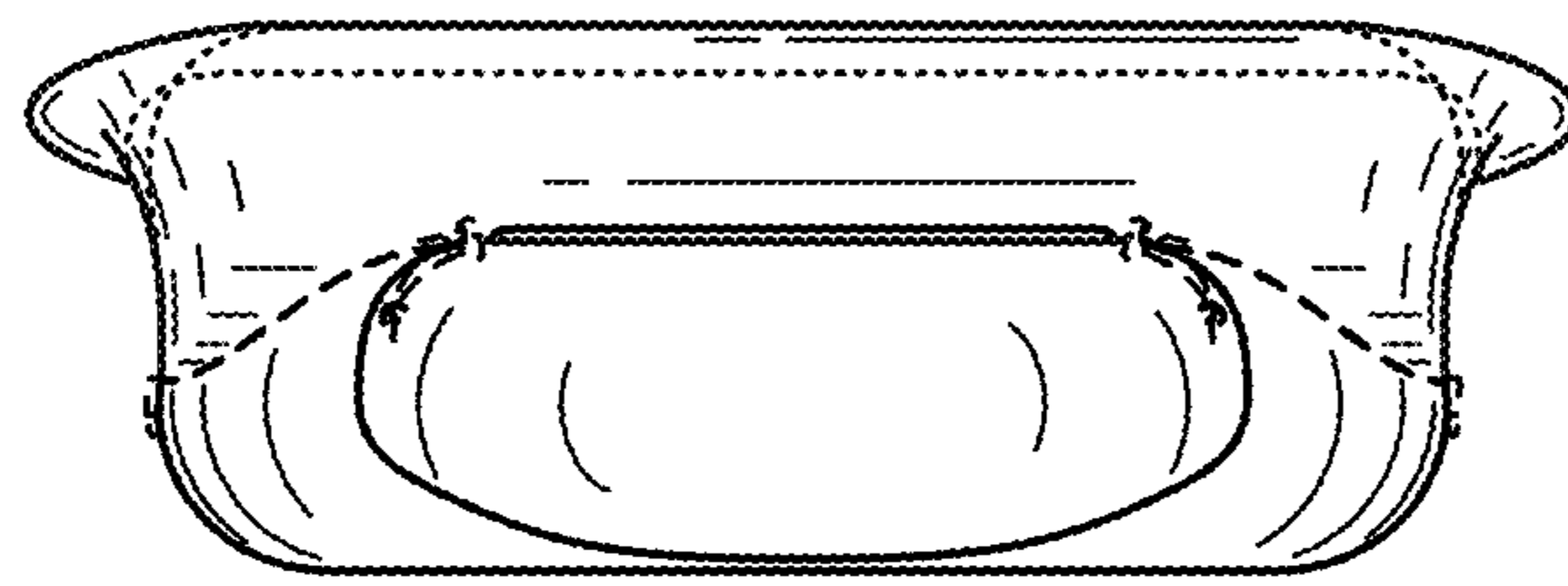

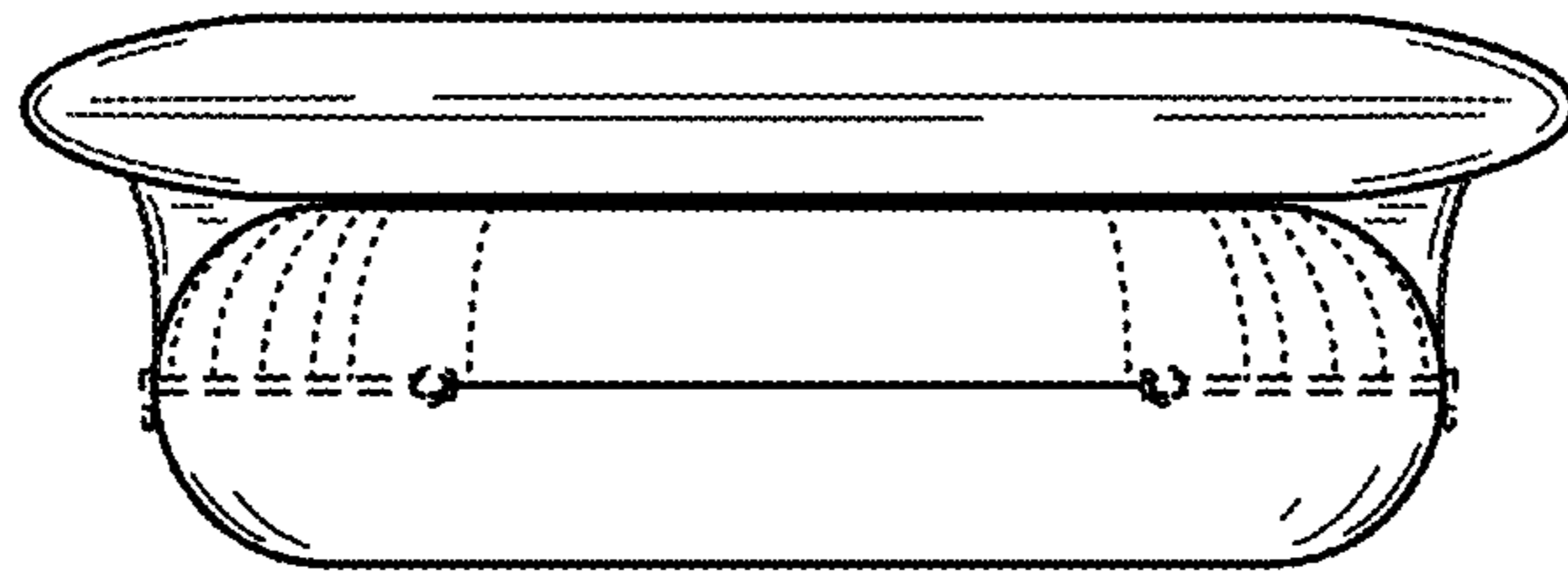

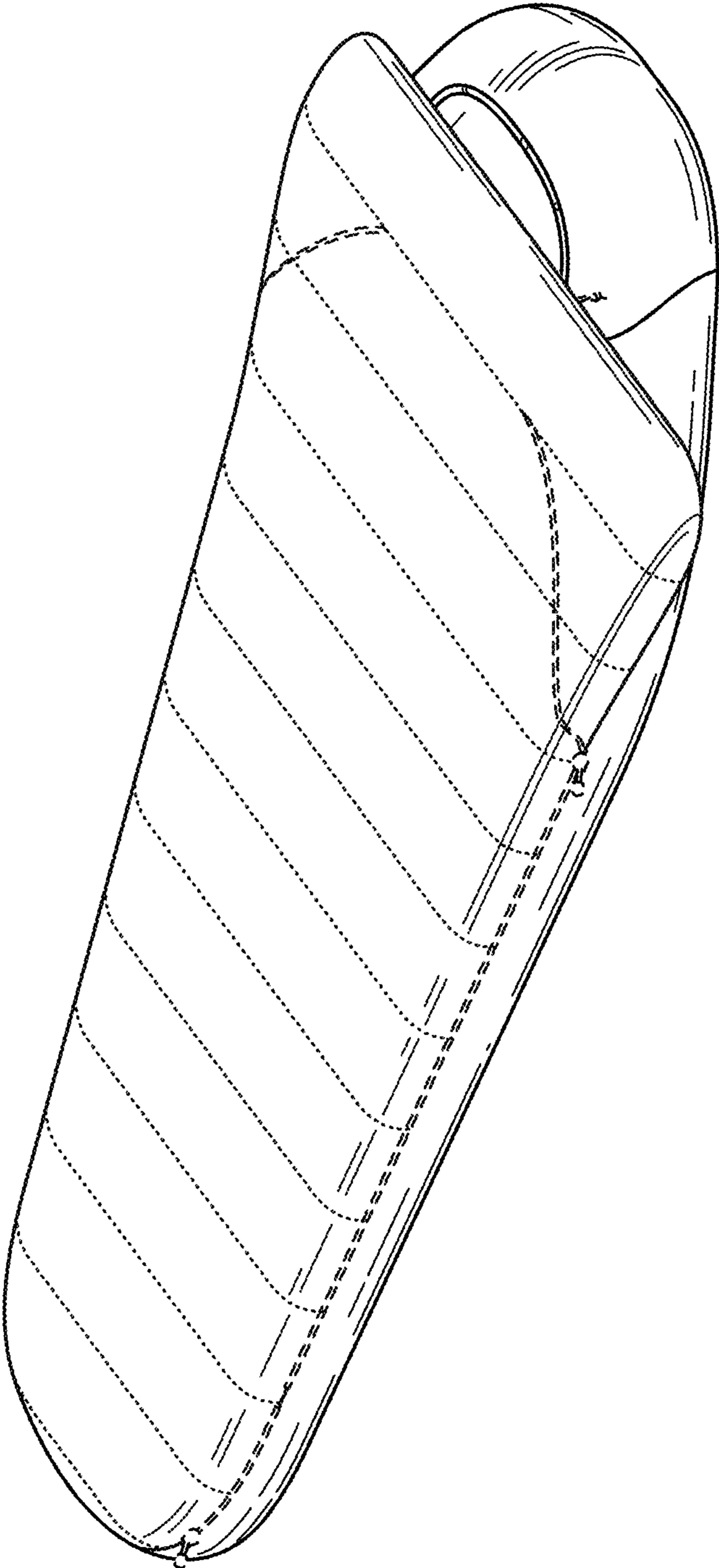

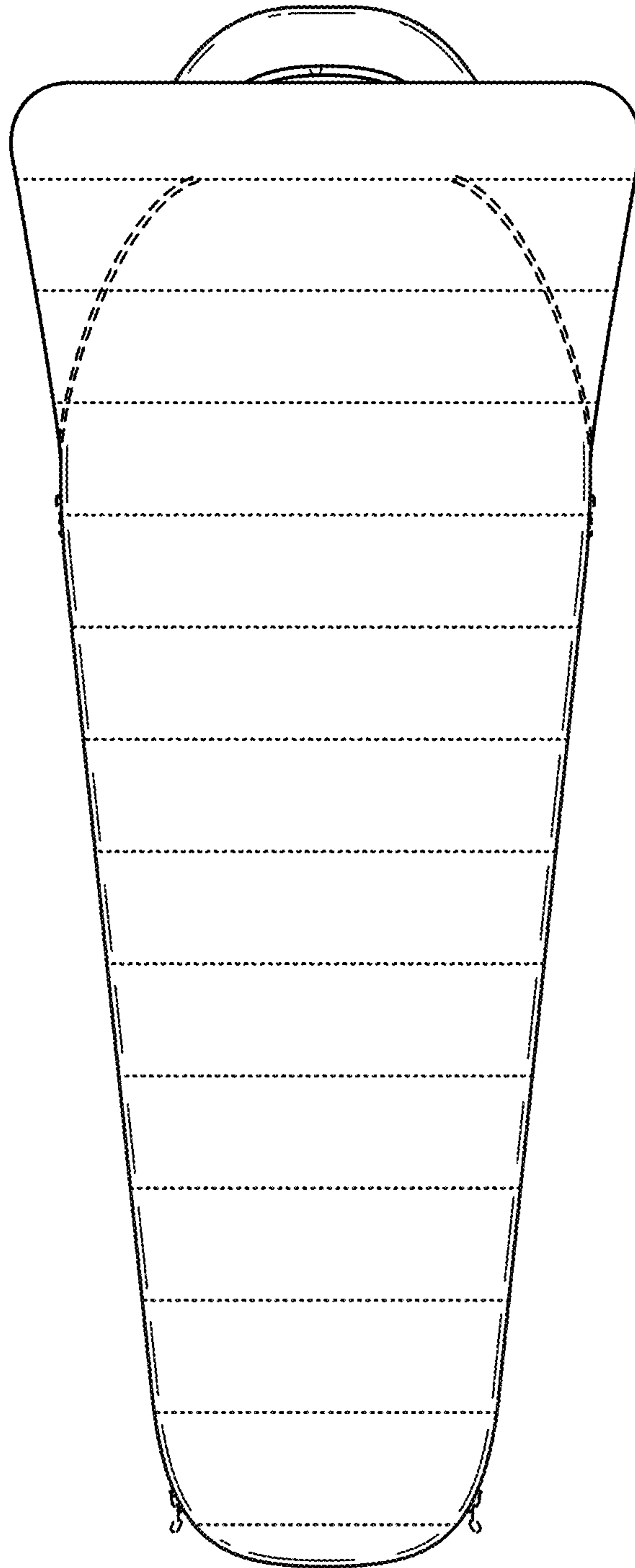

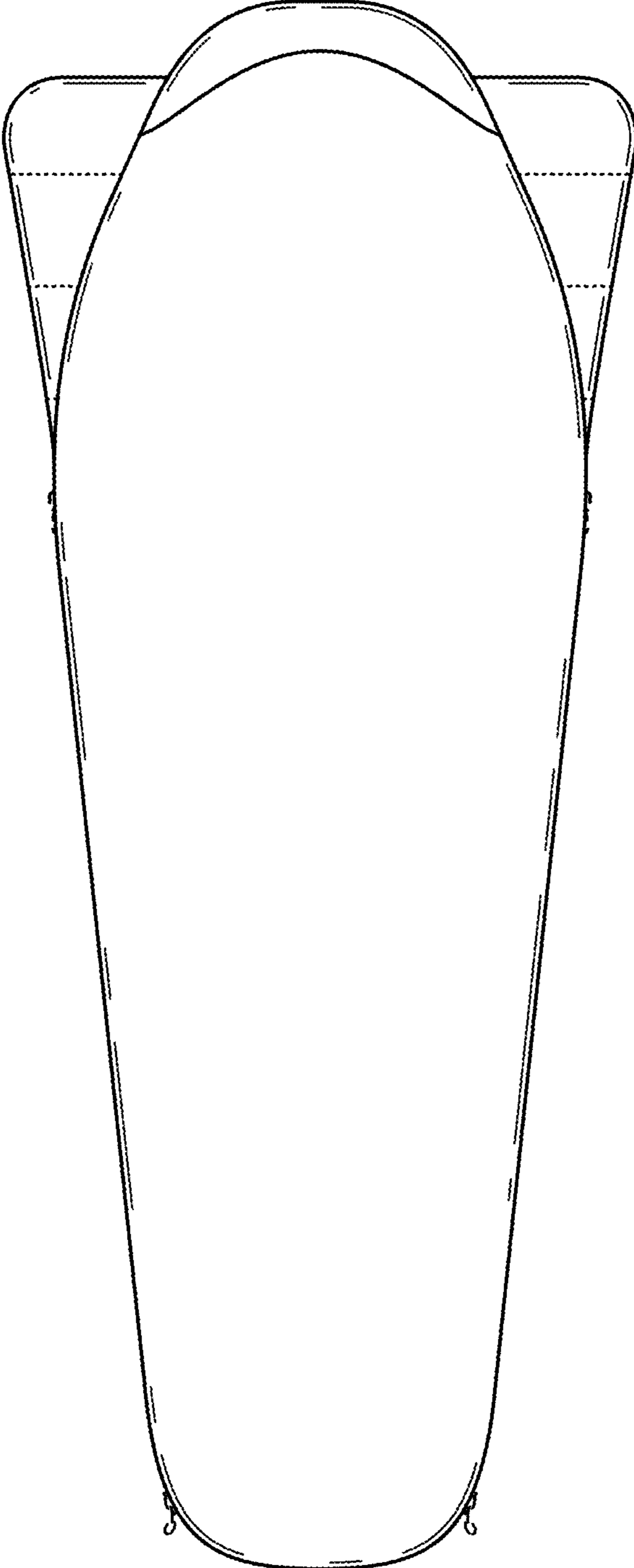

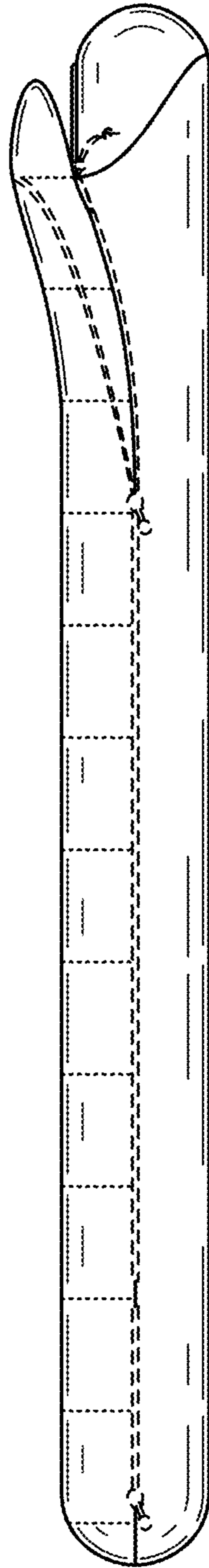

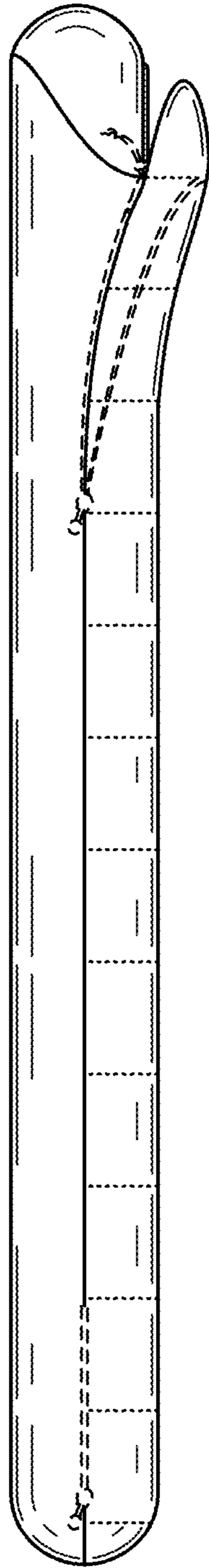

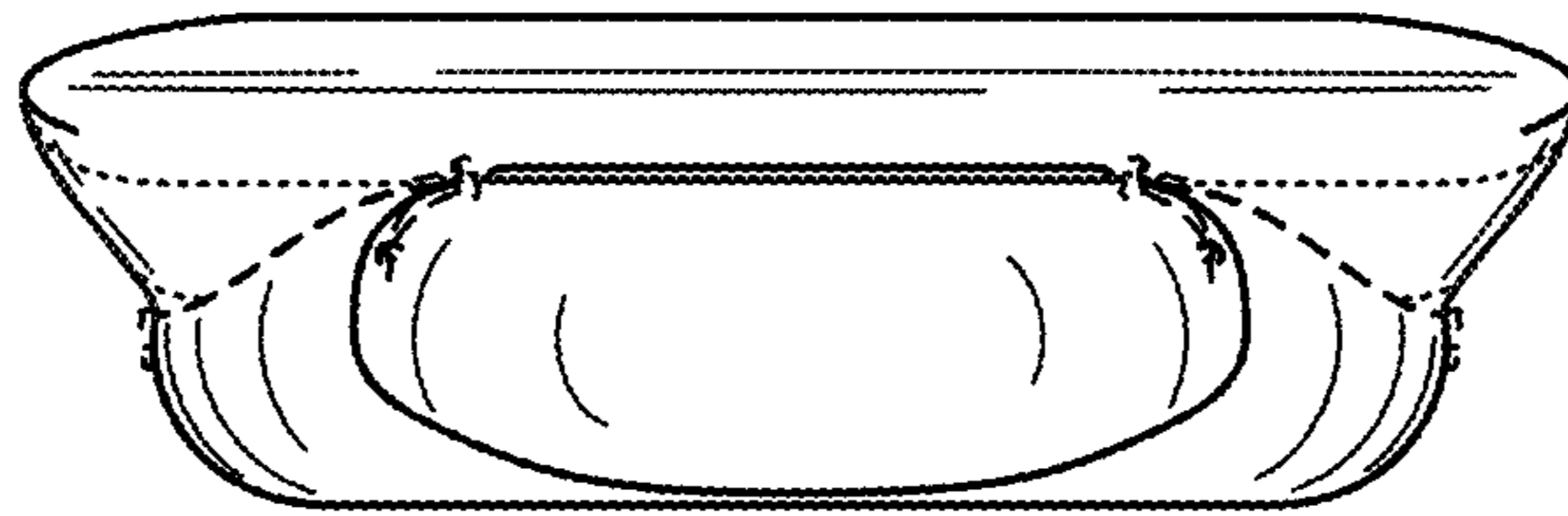

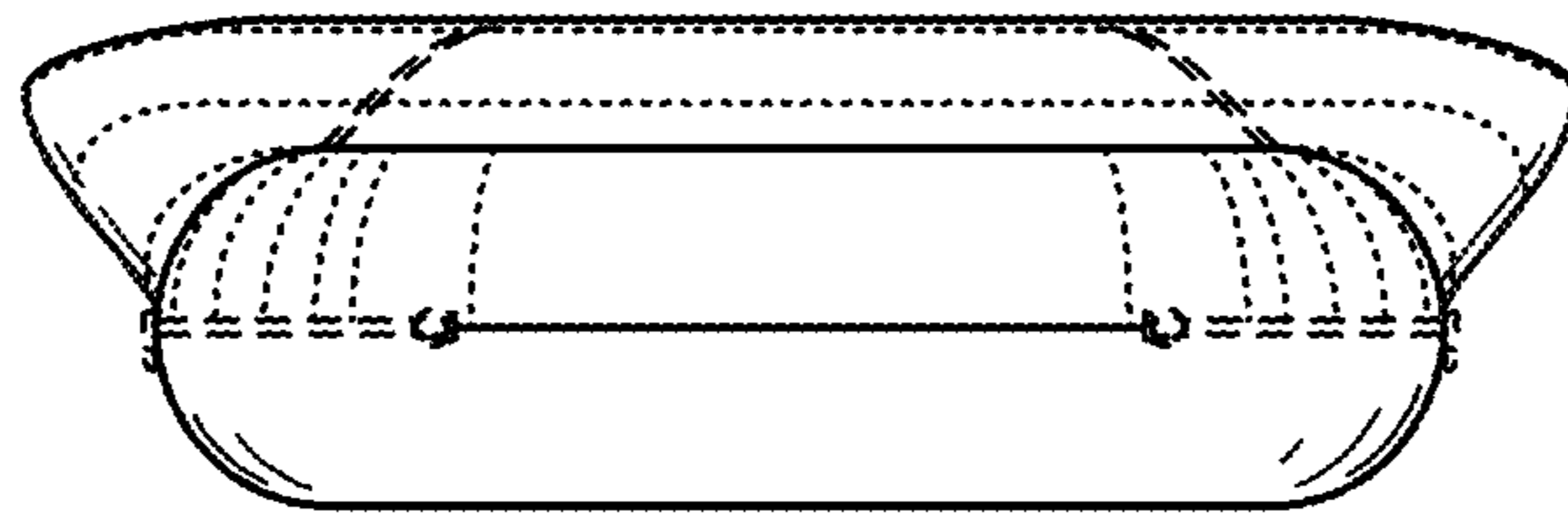

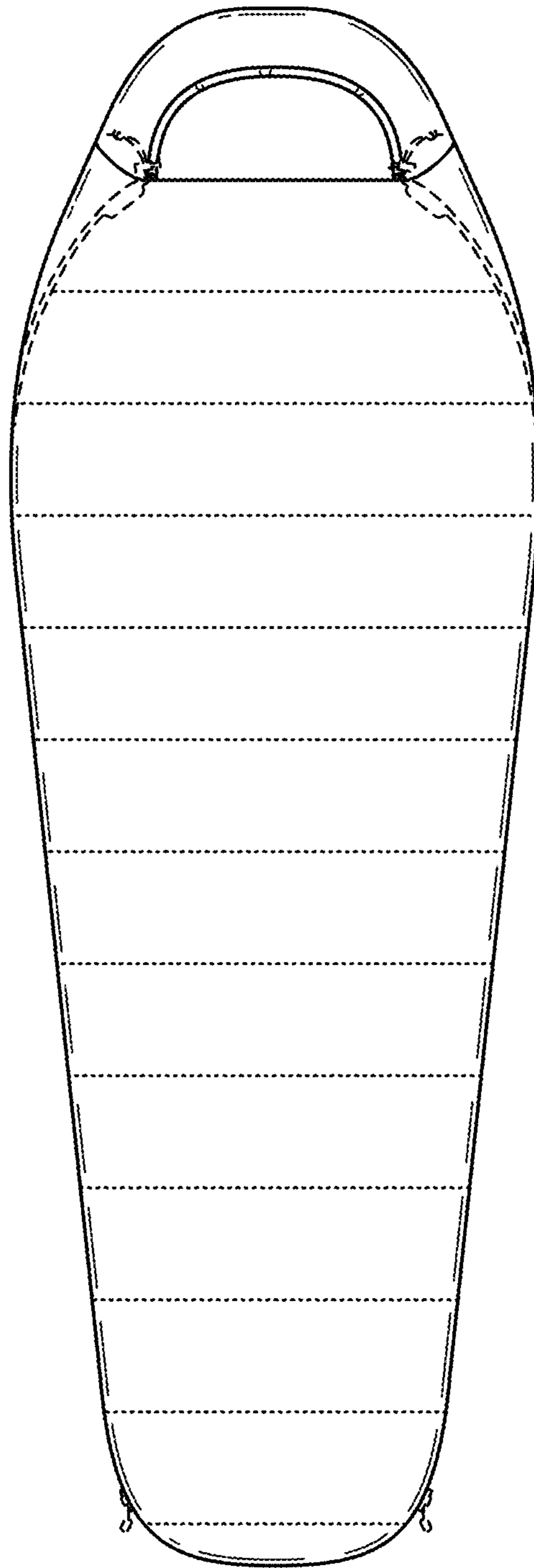
