FIG. 10 is a perspective view of the embodiment of my new swimsuit of FIG. 8, from the right side of FIG. 8;

FIG. 11 is a left side elevational view of the embodiment of my new swimsuit of FIG. 8;

FIG. 12 is a right side elevational view of the embodiment of my new swimsuit of FIG. 8, from a side opposite that of FIG. 11;

FIG. 13 is a rear perspective view of the embodiment of my new swimsuit of FIG. 8, from a side of FIG. 9; and

FIG. 14 is a top view of the embodiment of my new swimsuit of FIG. 8;

FIG. 15 is a front view of another embodiment of my swimsuit of FIG. 1 in which the color red is an integral part of the design of the swimsuit;

FIG. 16 is a rear elevational view of the embodiment of my new swimsuit of FIG. 15, opposite the view of FIG. 15;

FIG. 17 is a perspective view of the embodiment of my new swimsuit of FIG. 15, from the right side of FIG. 15;

FIG. 18 is a left side elevational view of the embodiment of my new swimsuit of FIG. 15;

FIG. 19 is a right side elevational view of the embodiment of my new swimsuit of FIG. 15, from a side opposite that of FIG. 18;

FIG. 20 is a rear perspective view of the embodiment of my new swimsuit of FIG. 15, from a side of FIG. 16; and,

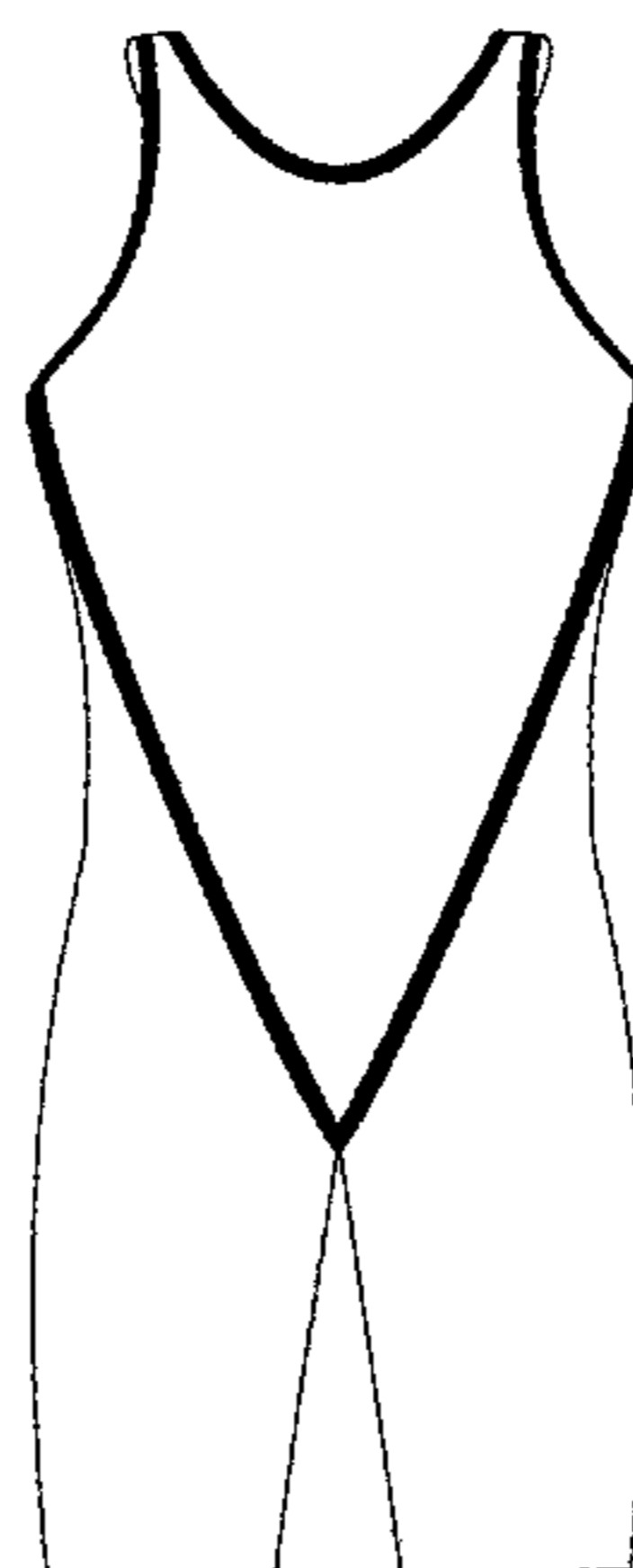


FIG. 21 is a top view of the embodiment of my new swimsuit of FIG. 15.

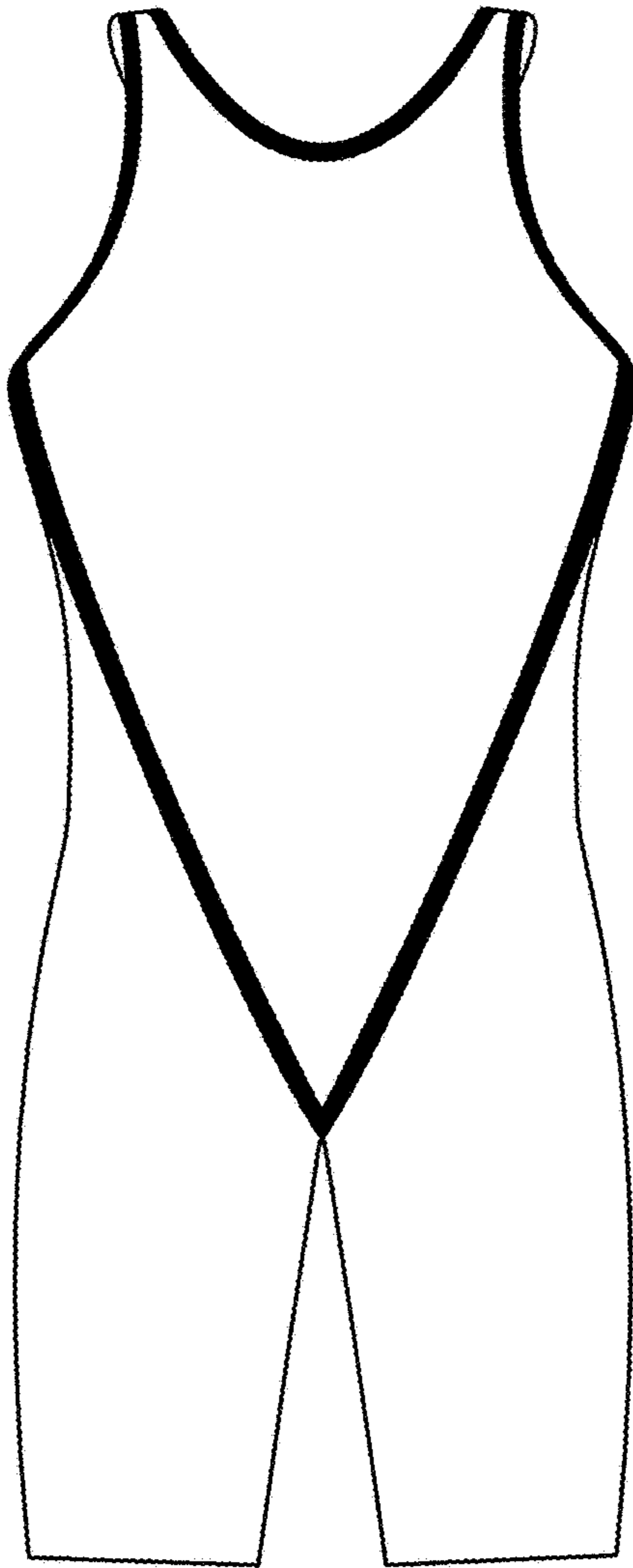
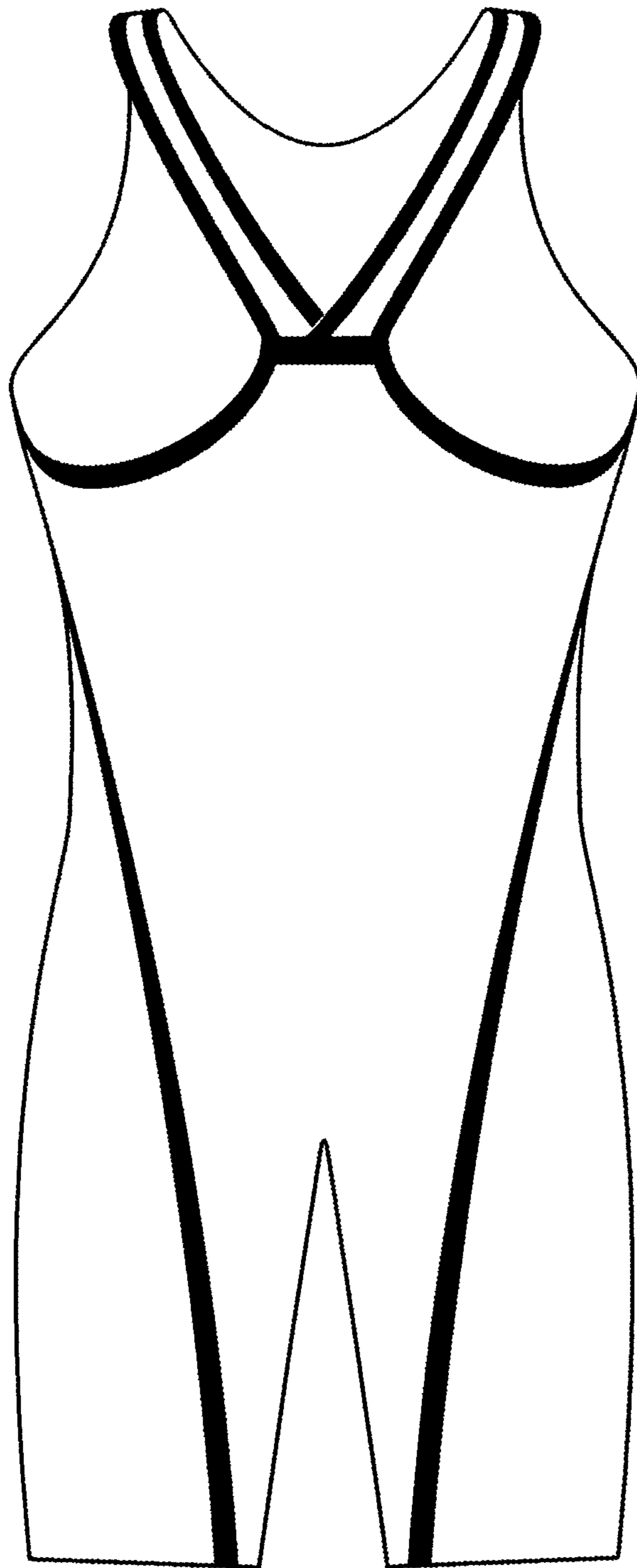
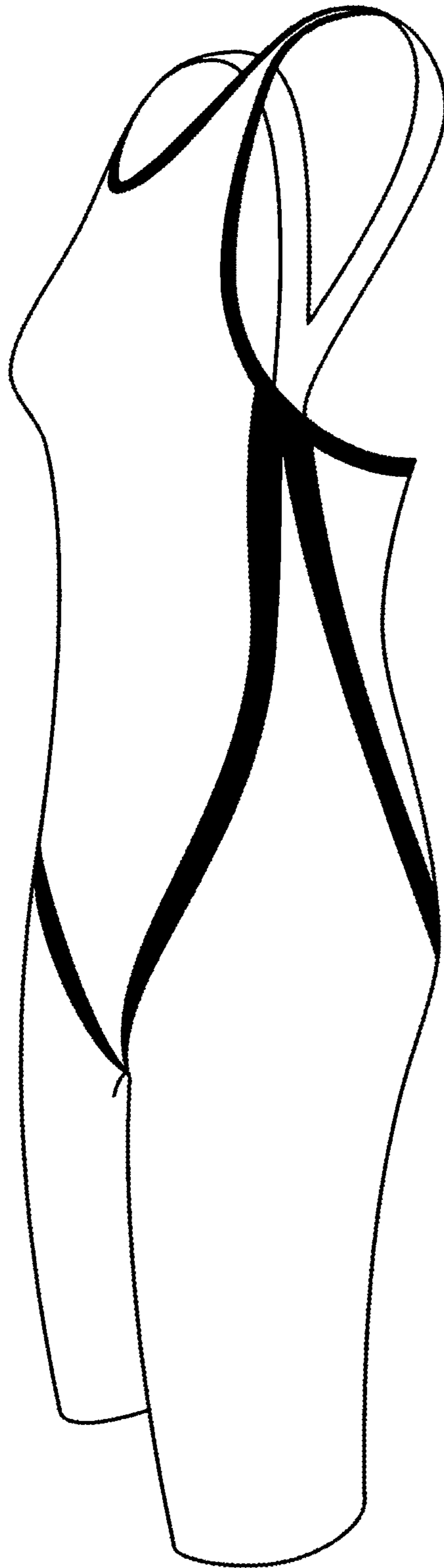


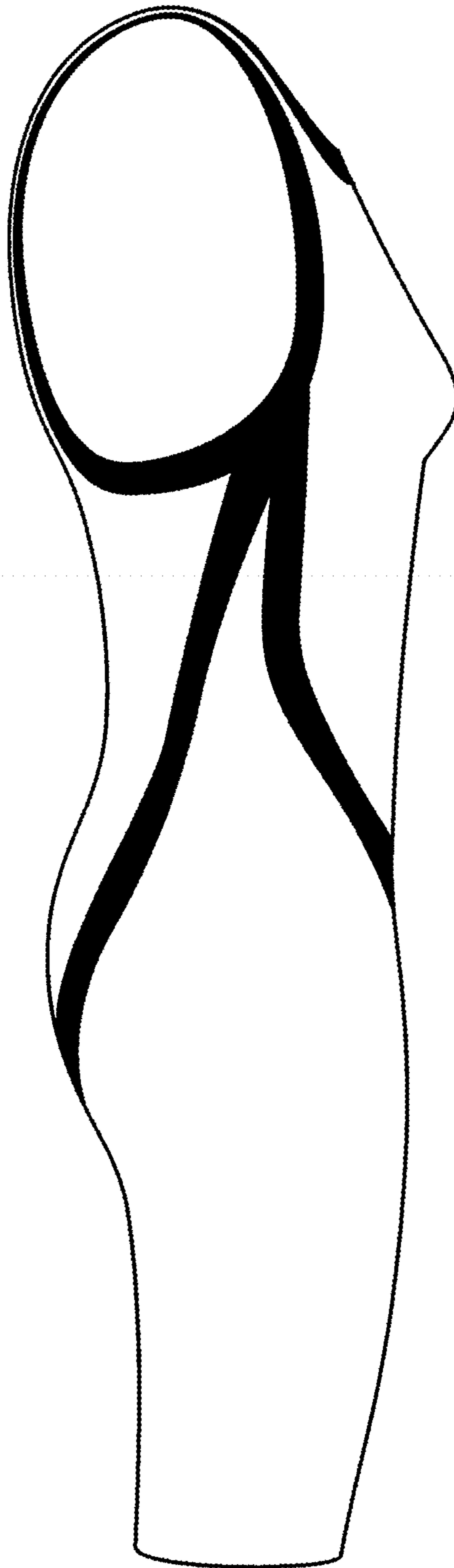

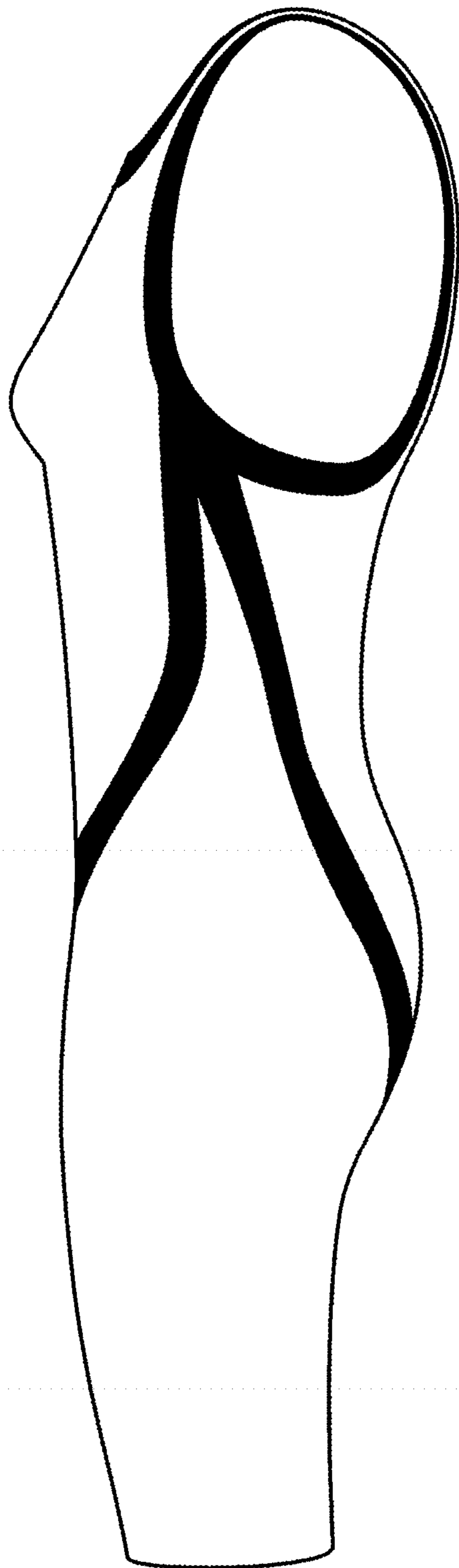

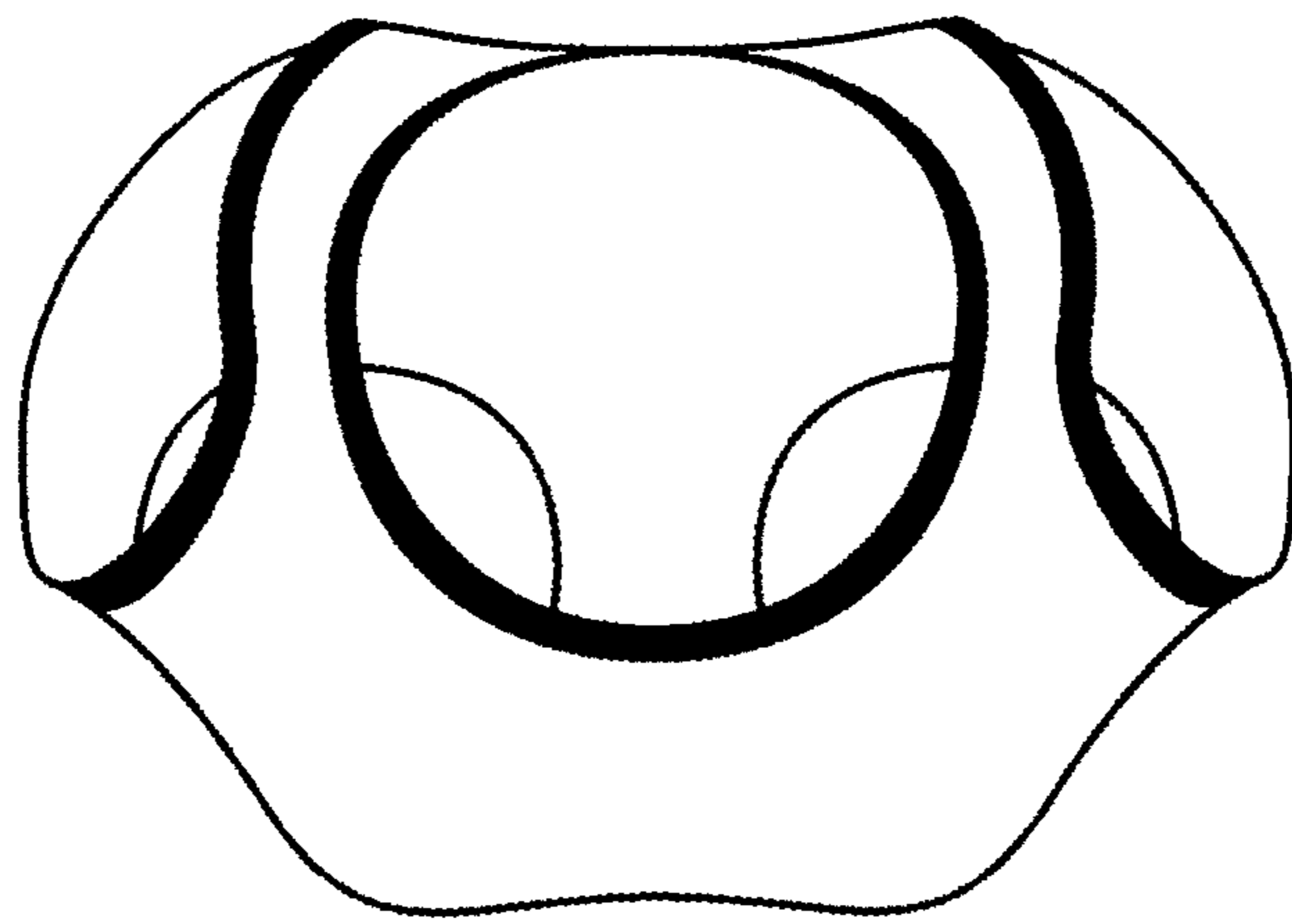

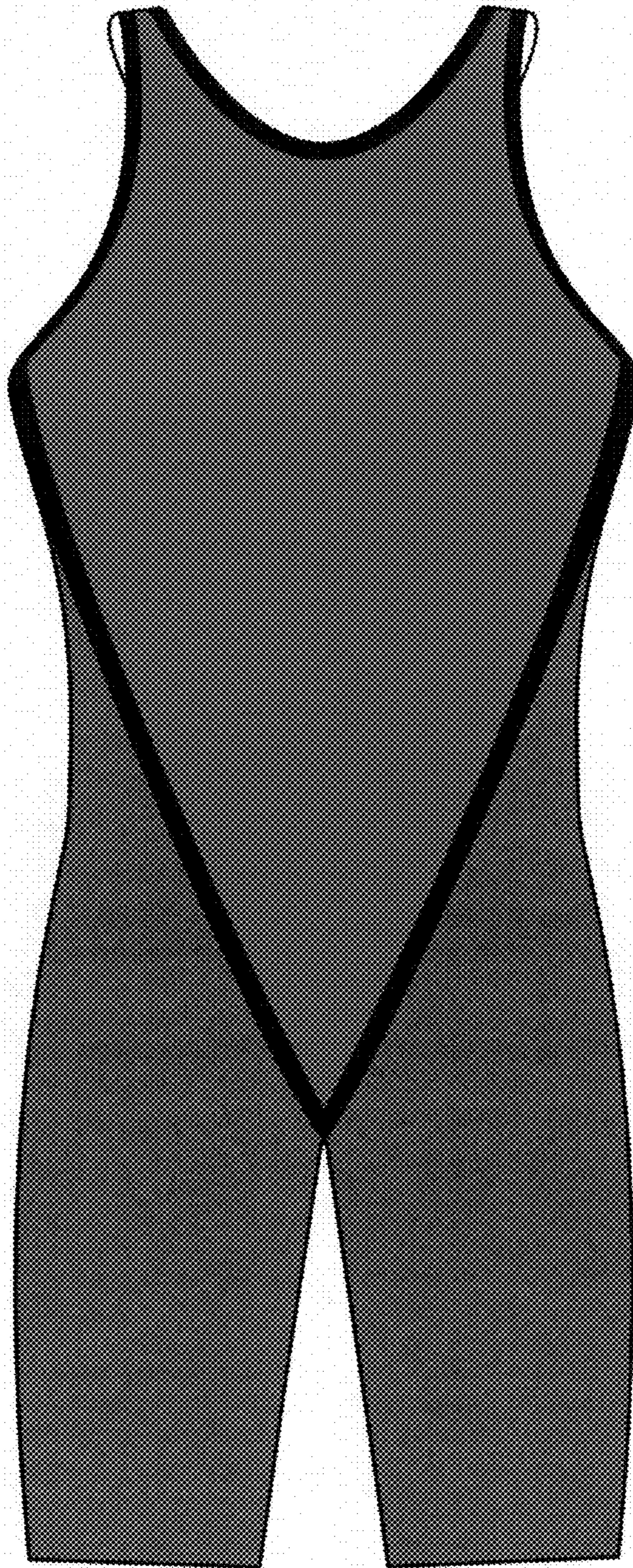

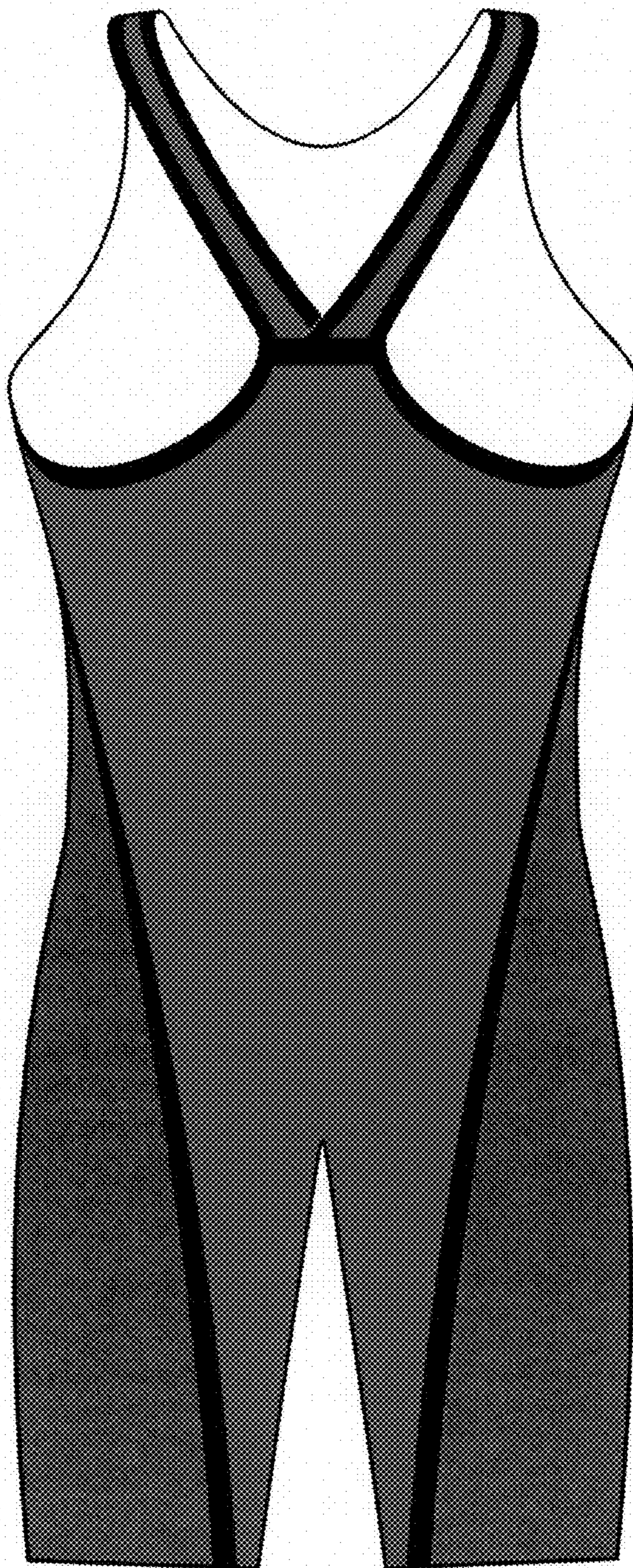

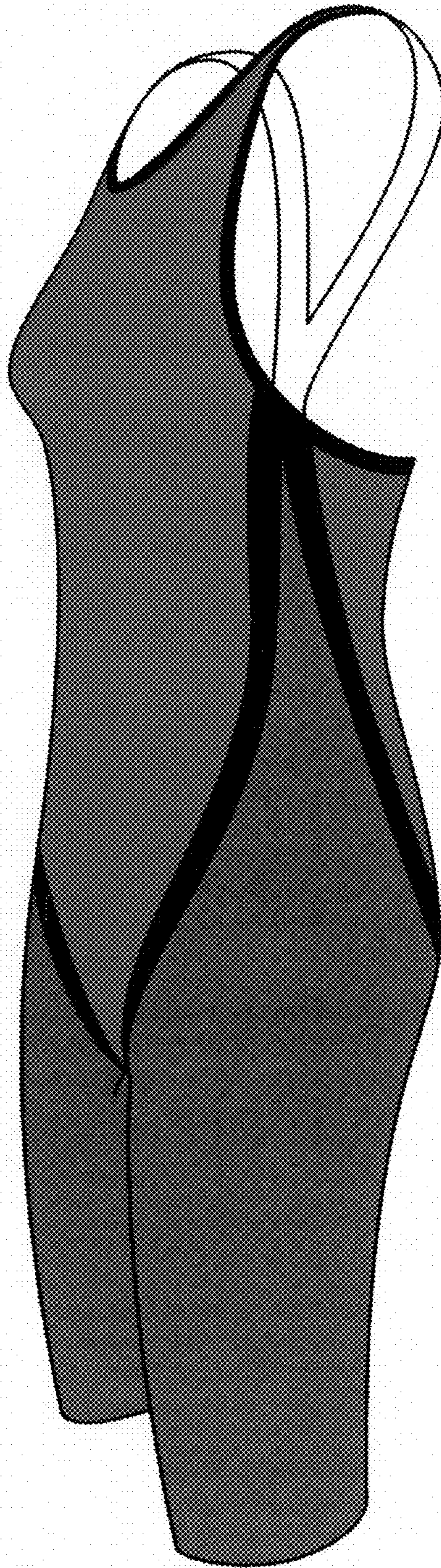

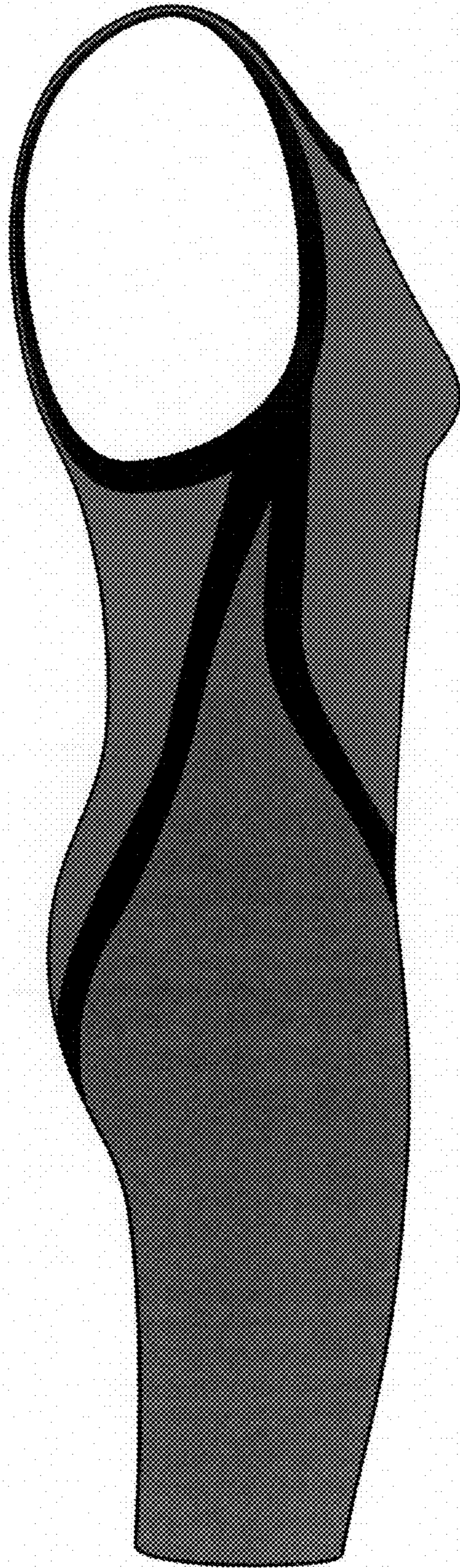

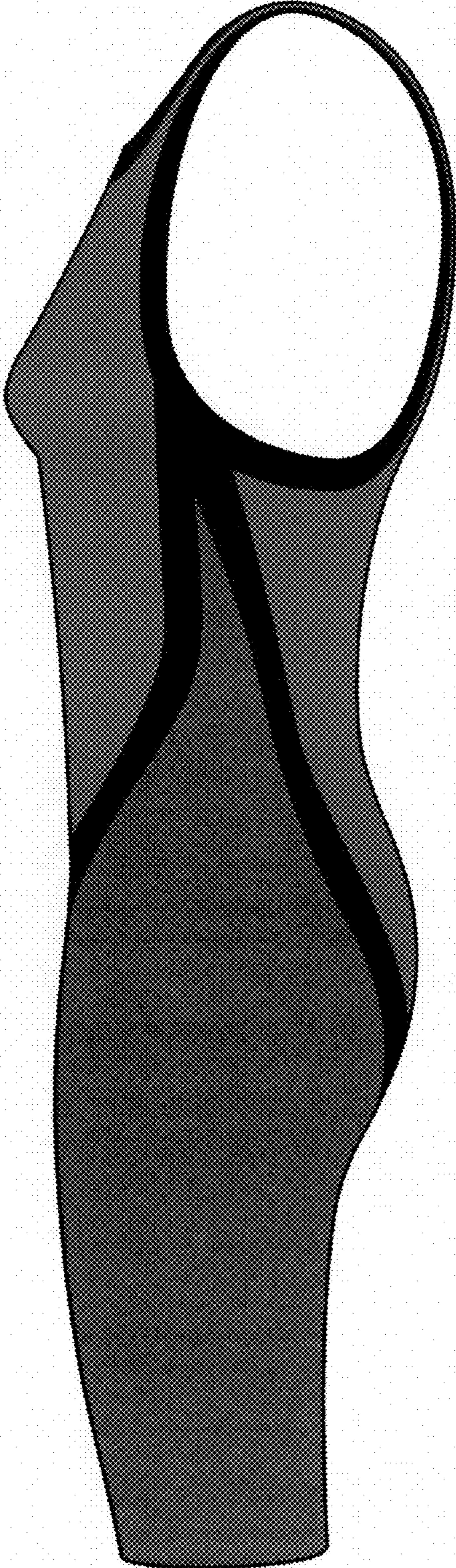

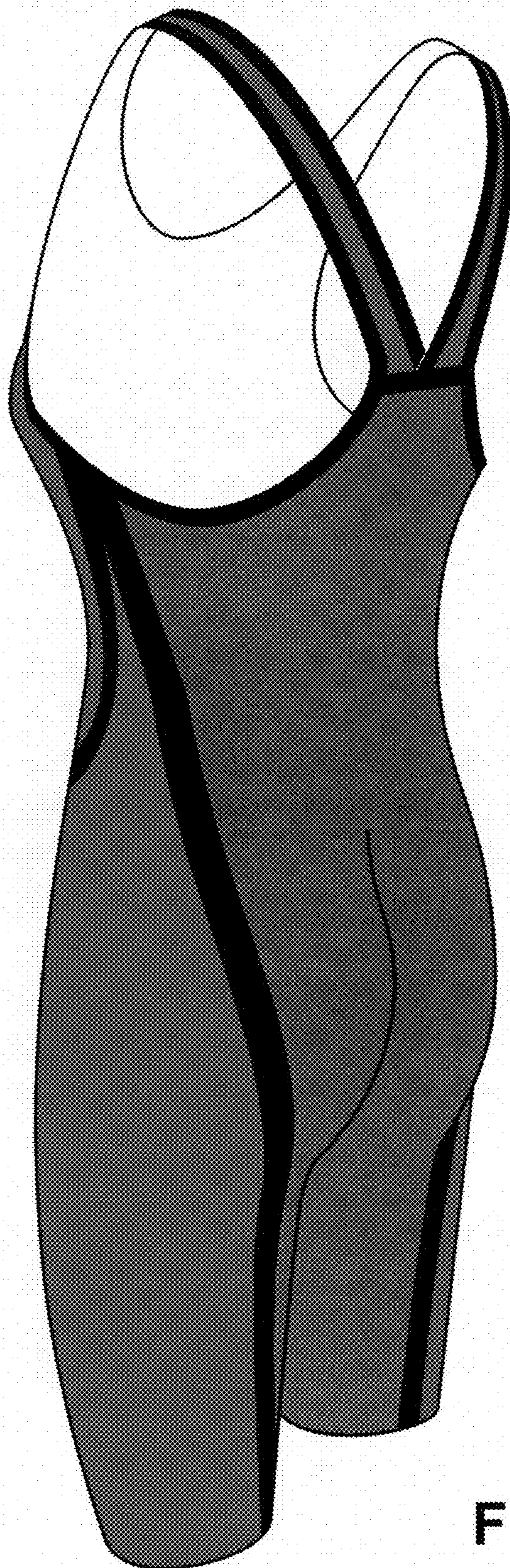
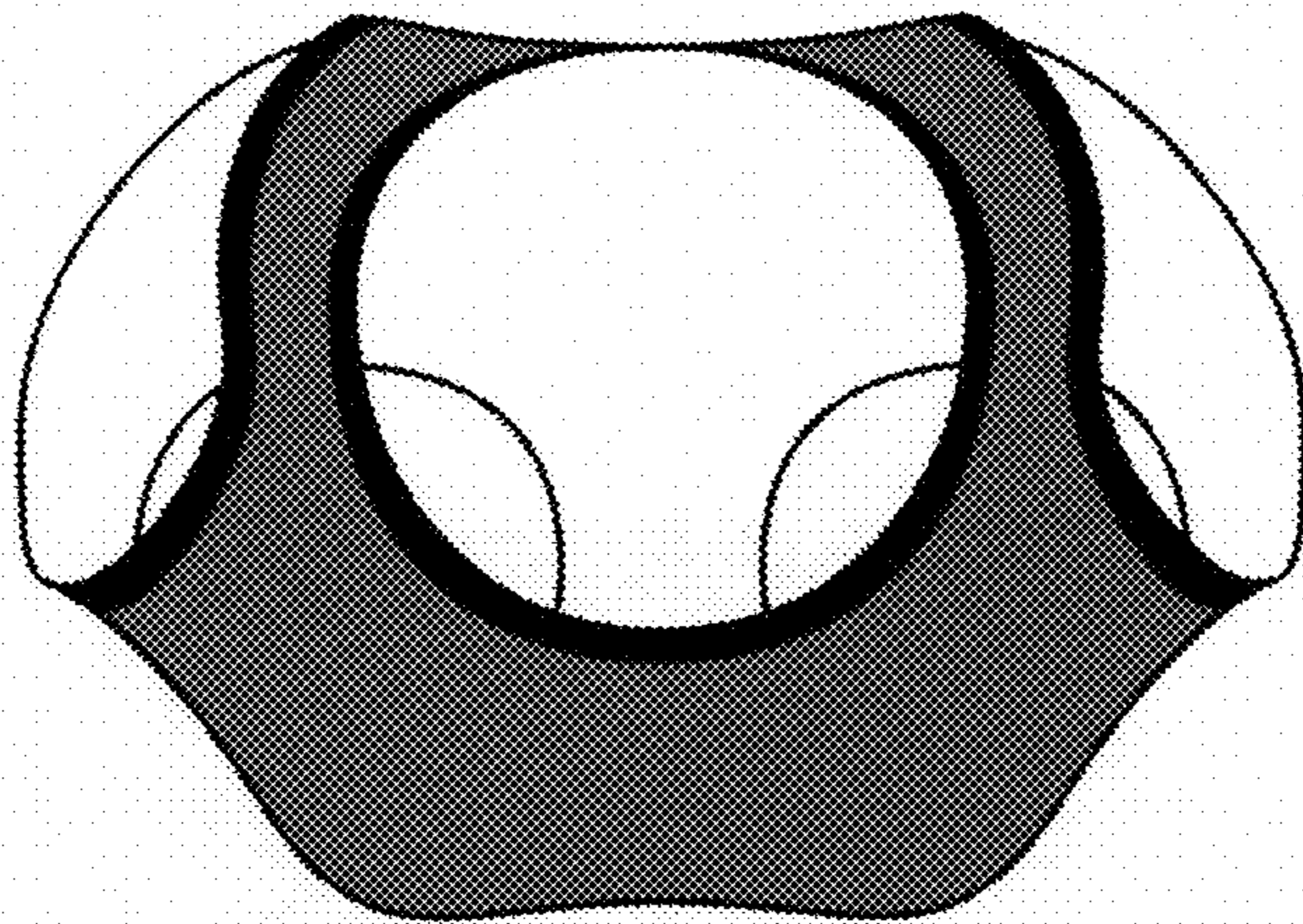
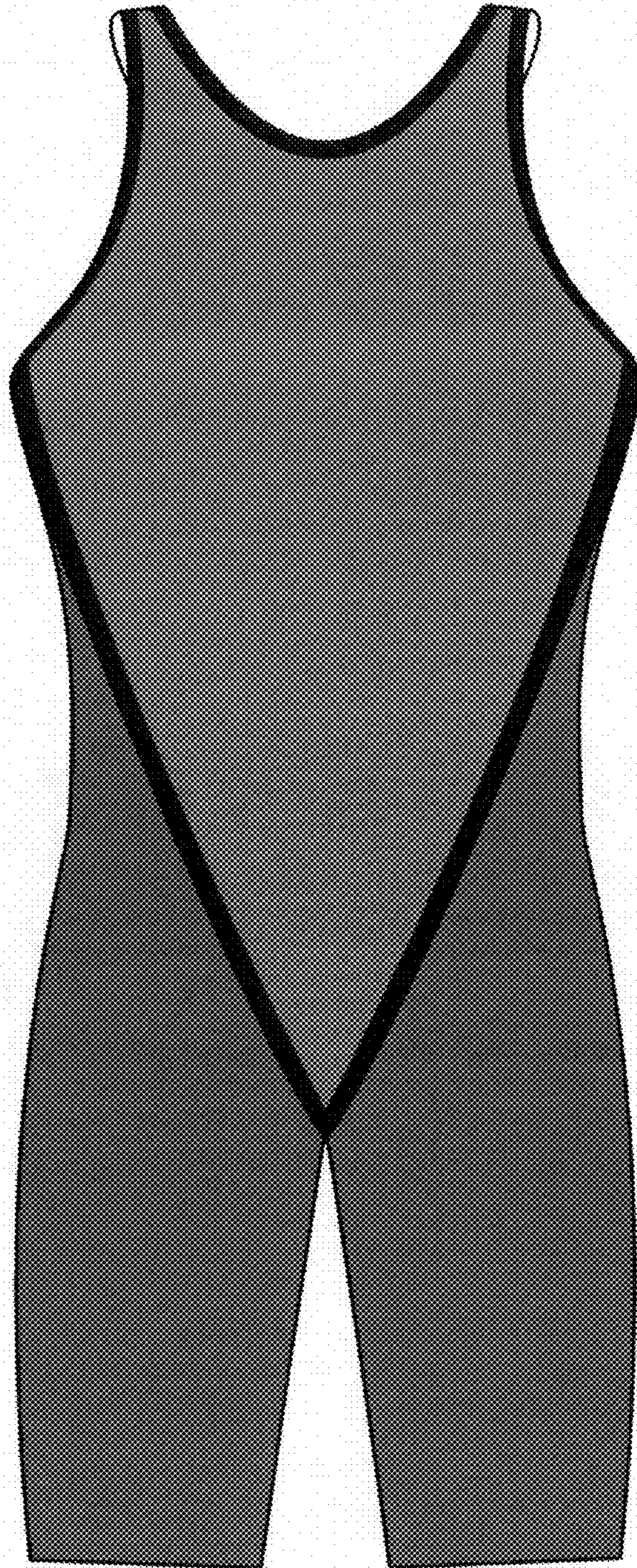

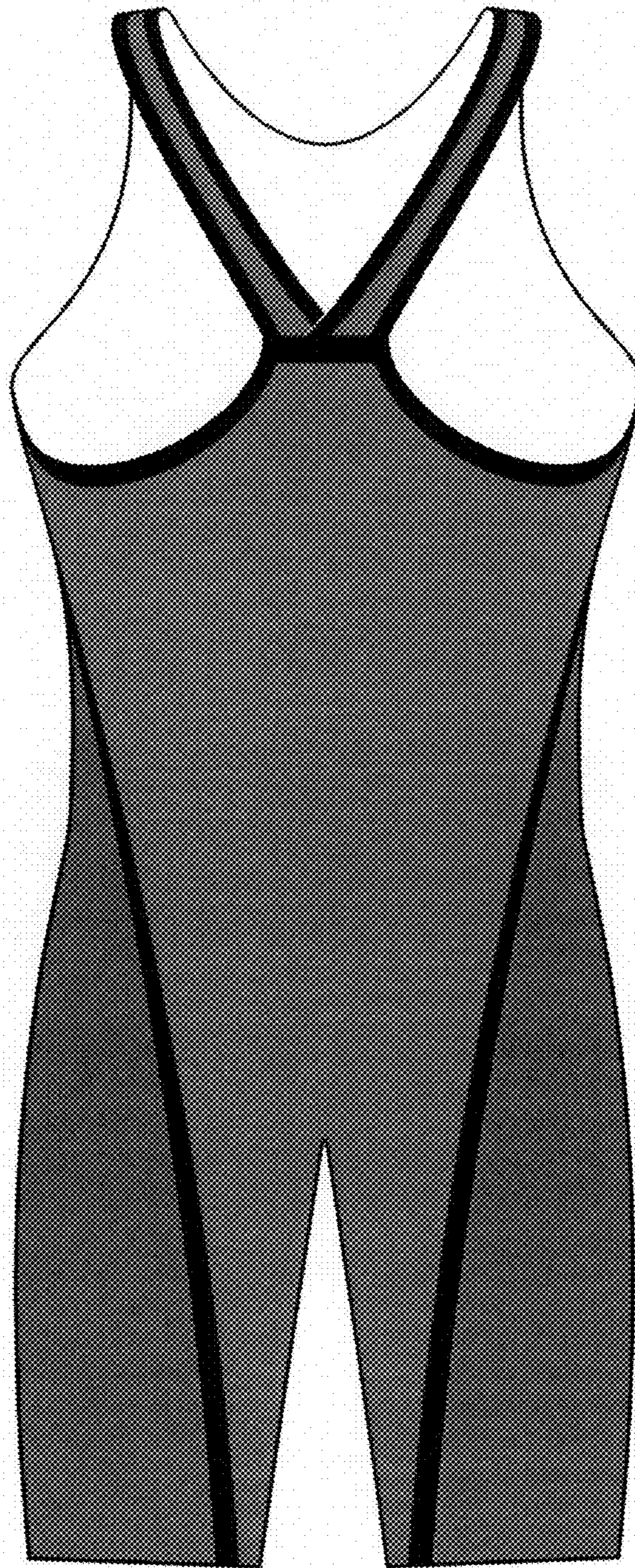

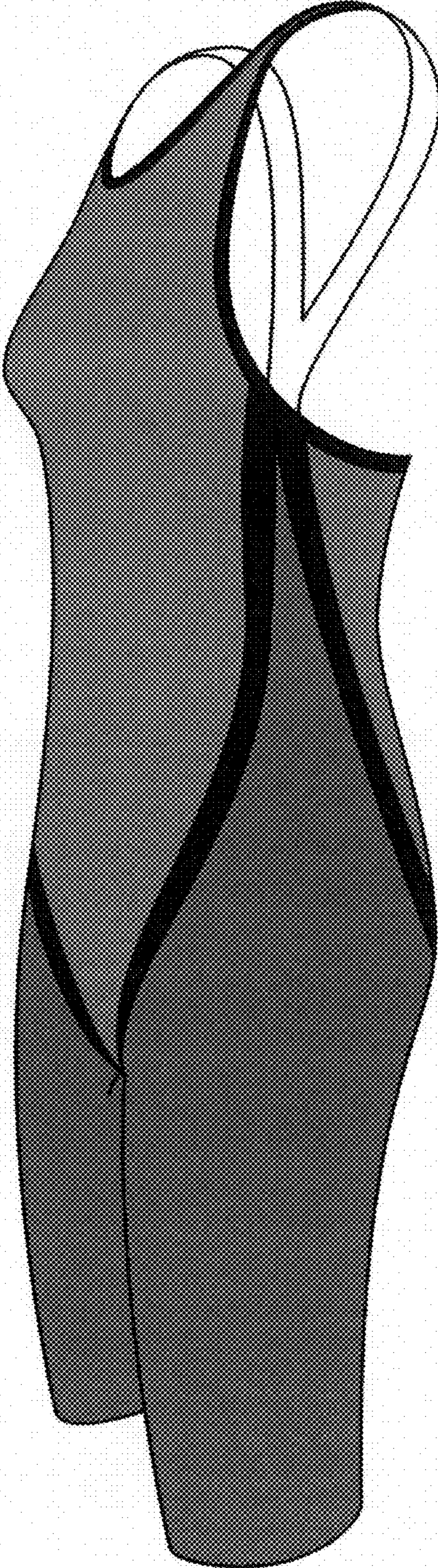
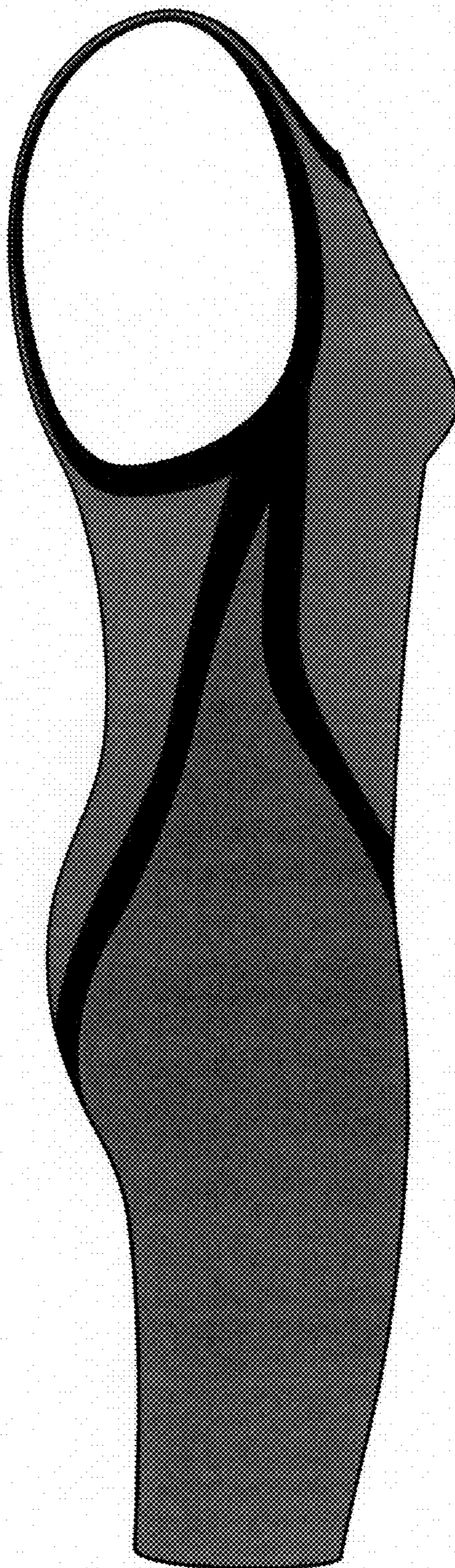
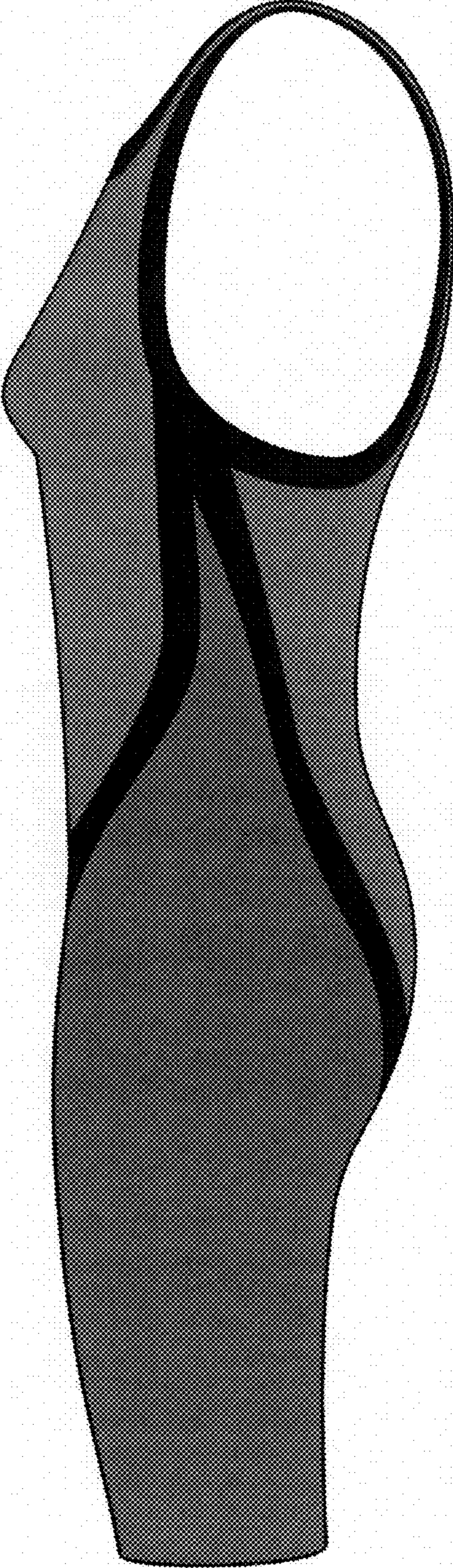

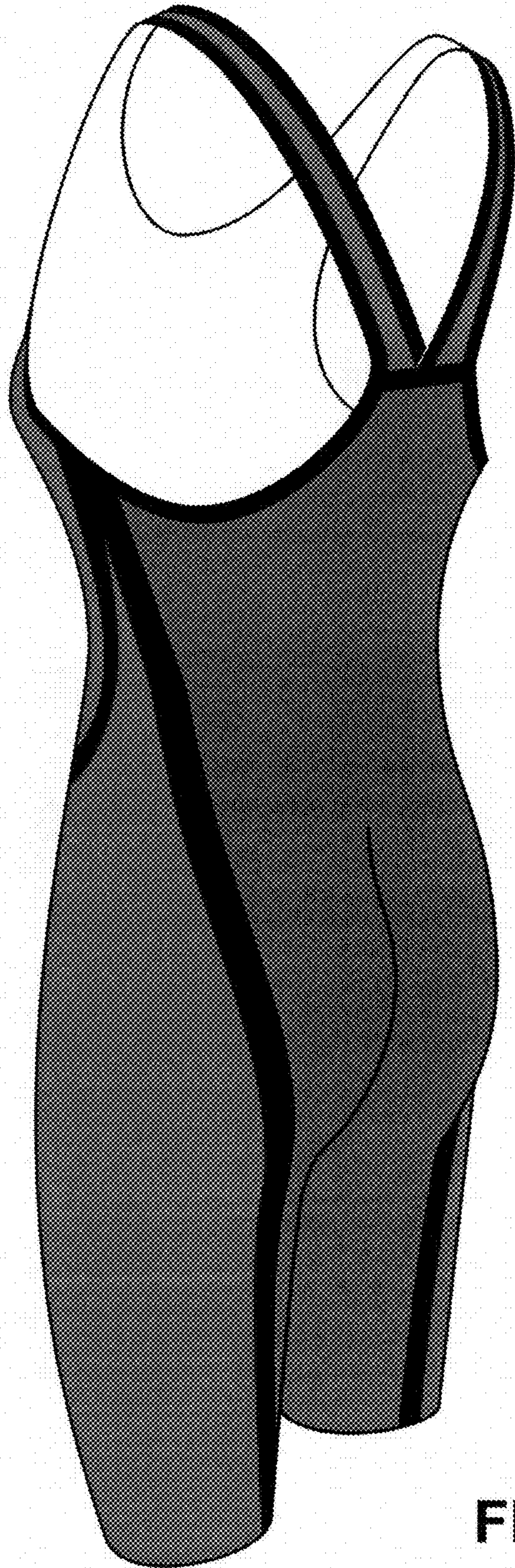

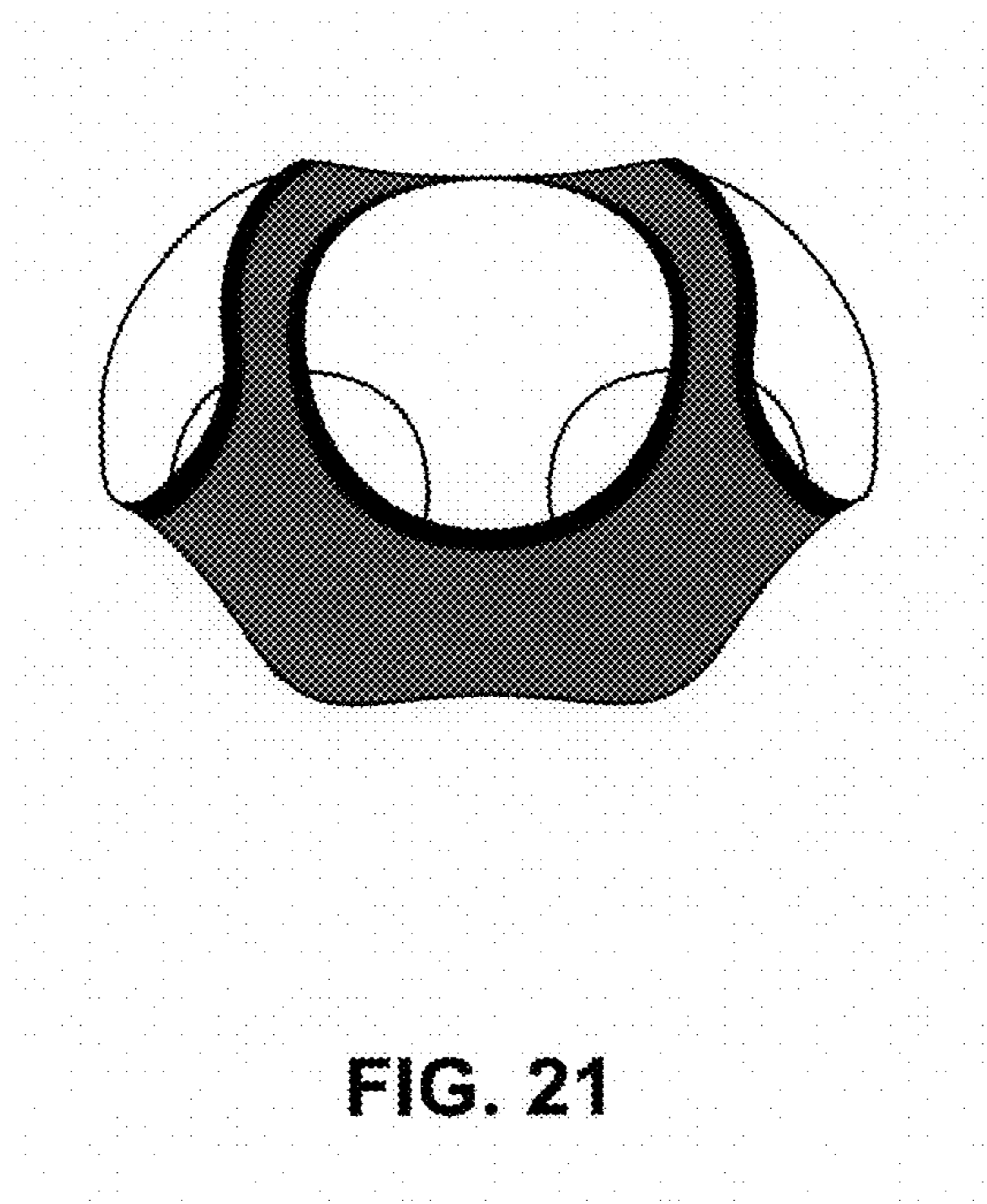
