DESCRIPTION

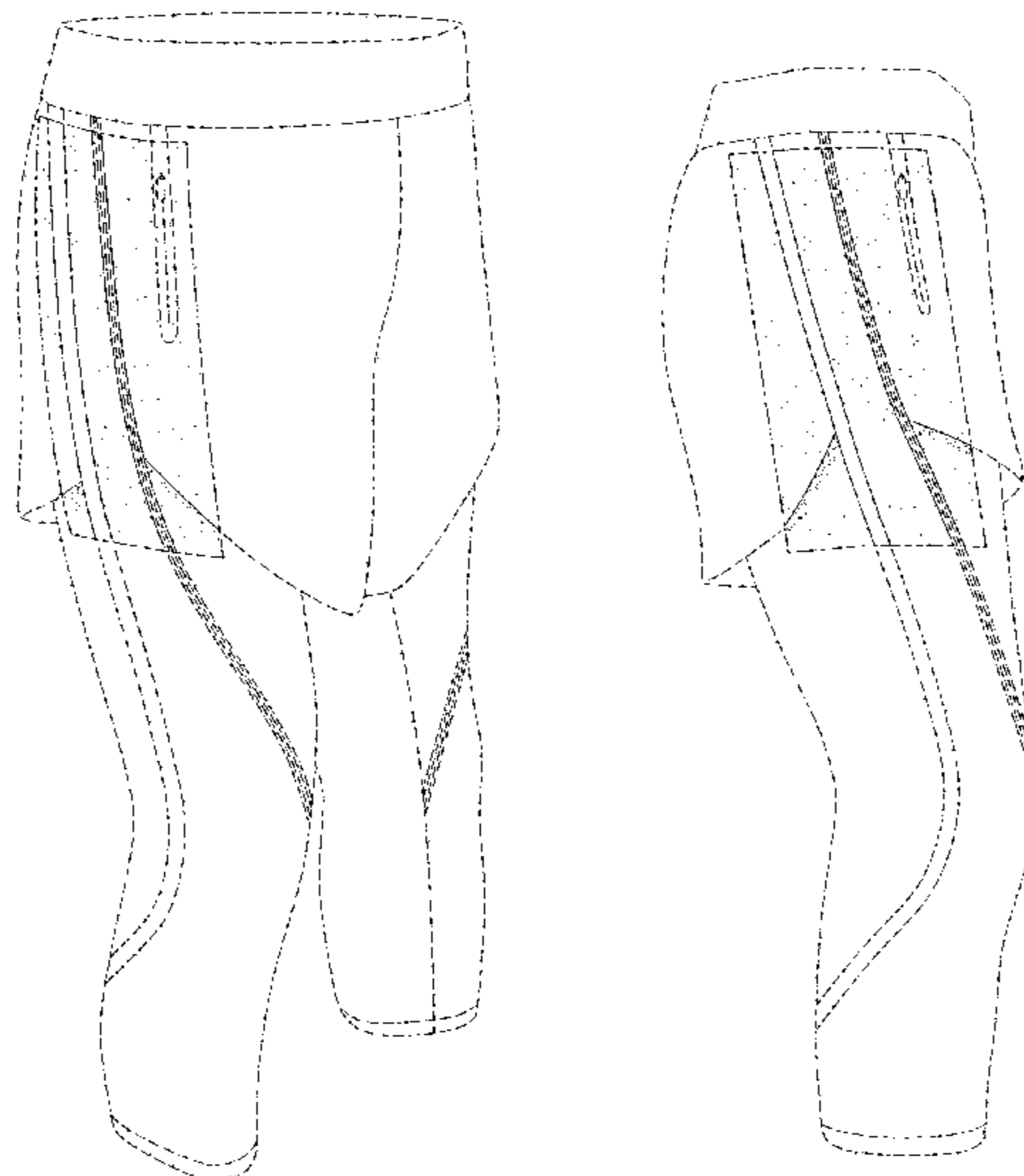
FIG. 1 is a front perspective view of a garment showing a first embodiment according to the present design; FIG. 2 is a front view thereof; FIG. 3 is a right-side view thereof; FIG. 4 is a left-side view thereof; and, FIG. 5 is a back view thereof.

The surface shading on the claimed portion is provided only to indicate the character and/or any contour or curvature of the surfaces. It does not indicate color, texture, markings that actually exist thereon, indicia, graphic representations, surface treatment, or any other ornamentation applied to the article.

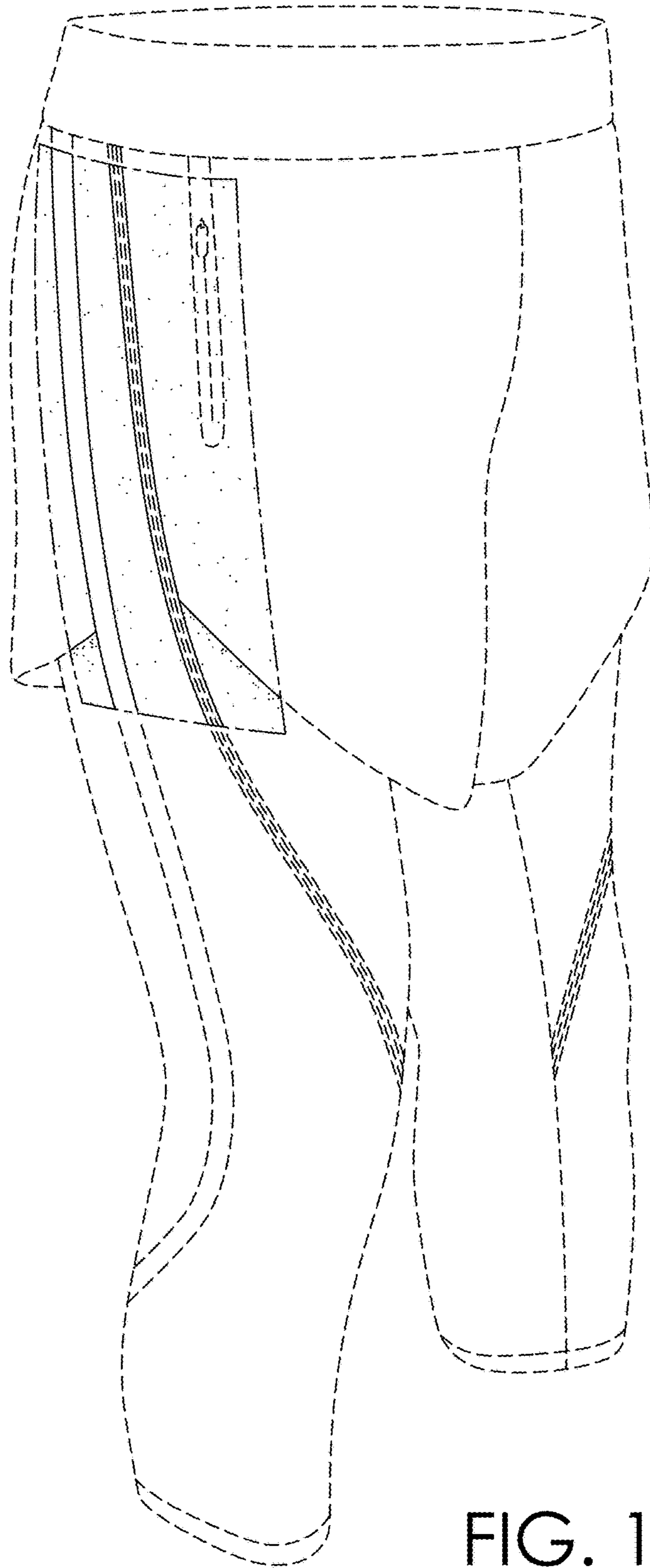

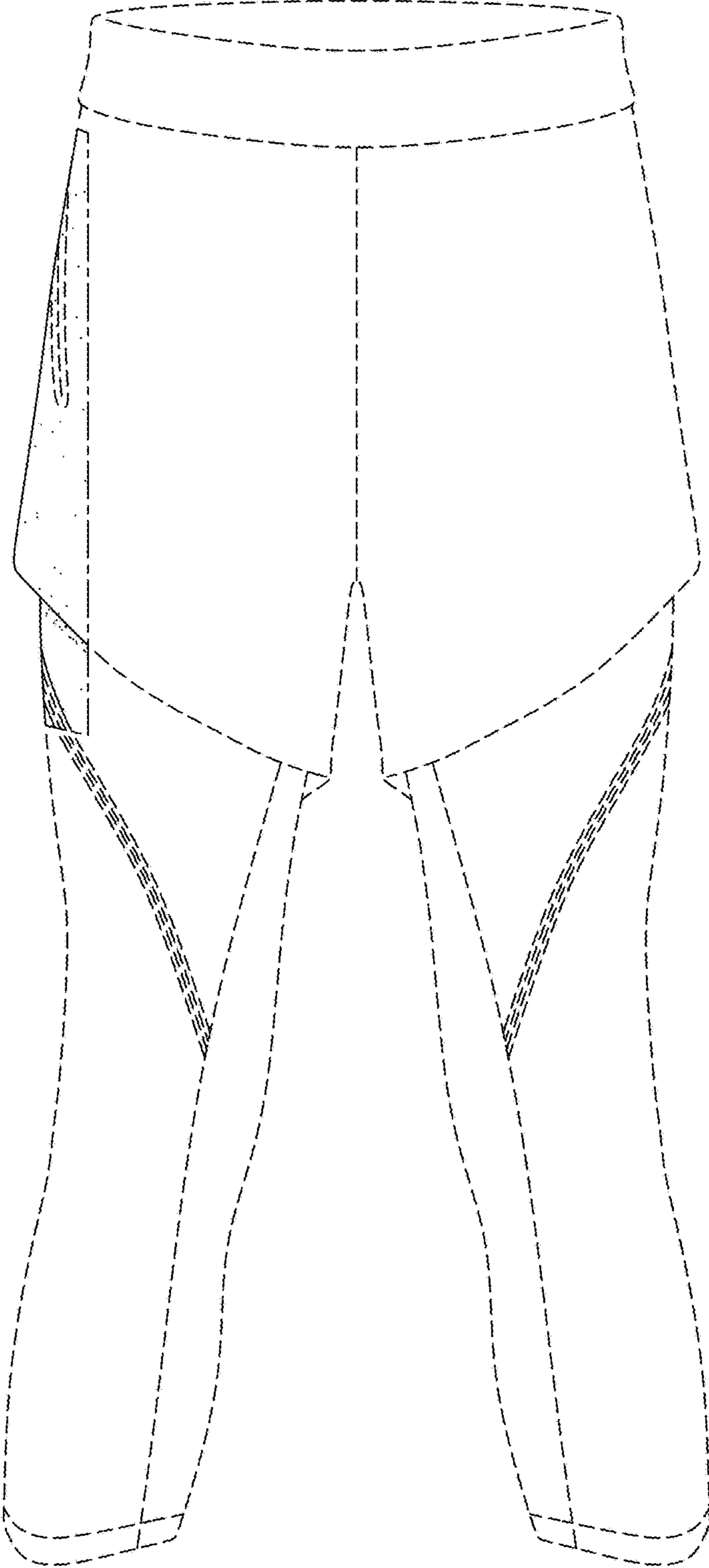

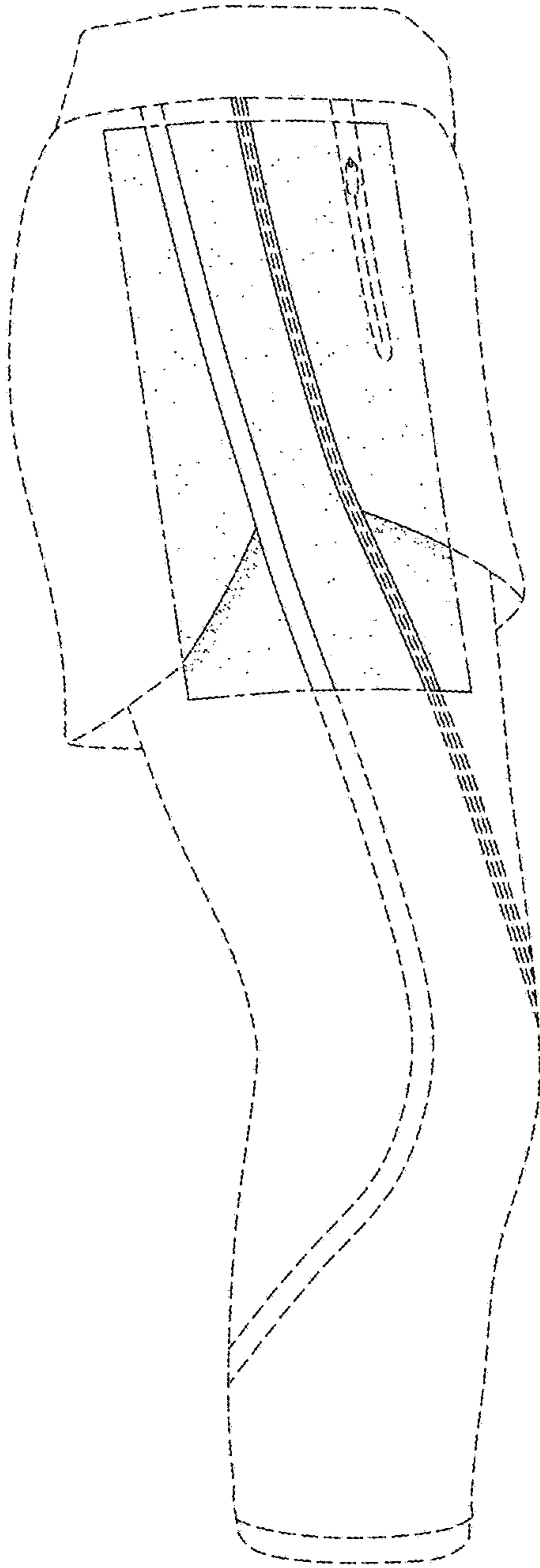

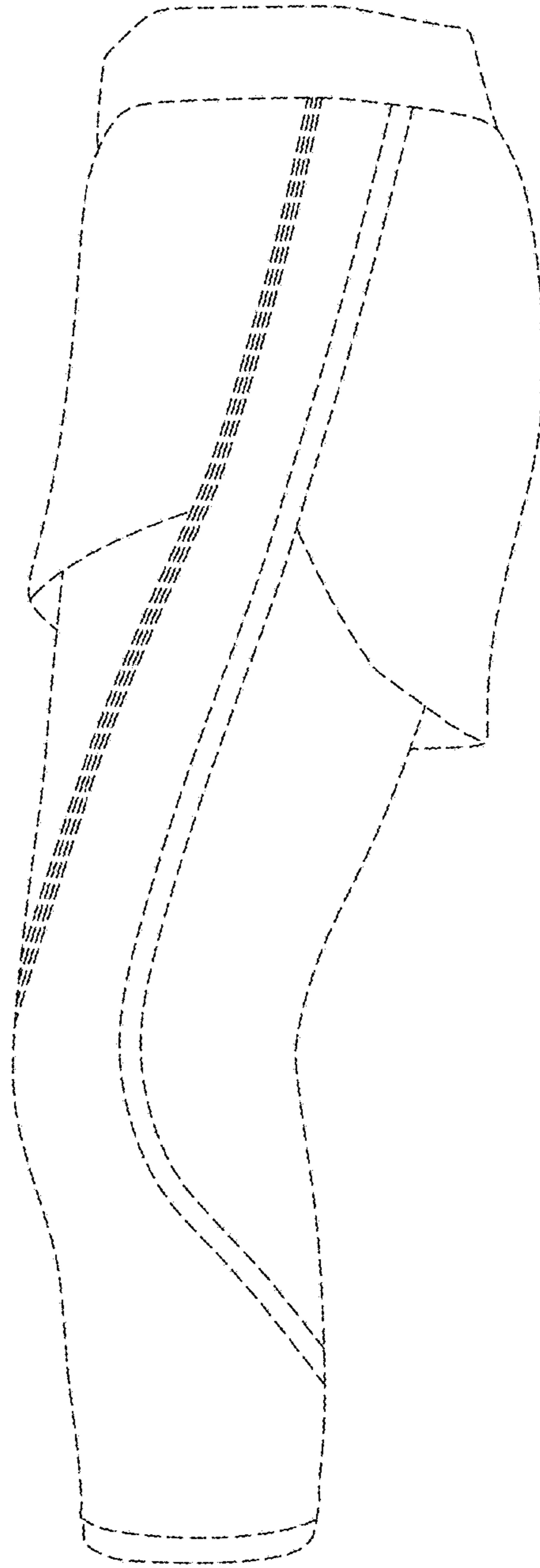

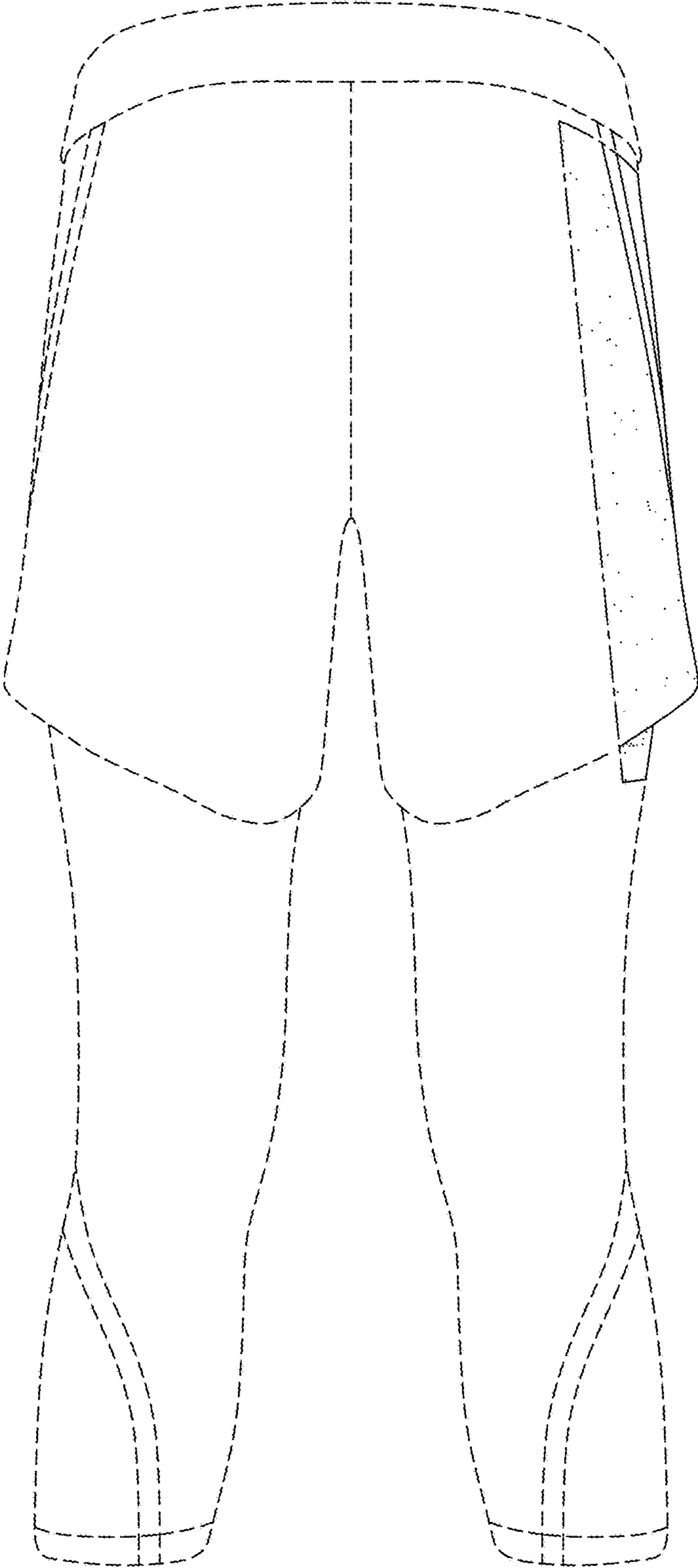
